# Archdiocese eases suicide burial rule

TACLOBAN CITY- Suicide victims within the Archdiocese of Palo in Leyte could now have their last Mass rites at the Church.

This after the priests in the archdiocese, headed by Archbishop John Du, agreed to 'relax' their rule on no person who died due to suicide would be given a Mass inside the church,

Father Chris Arthur Militante, spokesperson of the archdiocese, said.





# Women candidates square off for mayoralty post; a first in the history of the town

CAIBIRAN, Biliran-This small and remote town could be setting an election record of sort.

For the first time on its political history, three women are running for the post of mayor, squaring off with a lone man candidate.

The women mayoralty candidates are the incumbent vice mayor, Rhodessa Delante; Yolanda Maderazo, the sister of outgoing mayor Eulalio Maderazo, who is her running-mate; and Judith Go, sister of former vice mayor Naricres Go.

The lone man candidate in the crowded mayoralty race is Eddie Visbal, a retired fire officer.

Wilson Ginagate, assistant elections officer of the town, said that this is the first time that more women are gunning for the top post of Caibiran, a fifth class town (annual income: P102 million) with a voting population of 16,625 registered voters.

"This year's race is very interesting, if not (historical) as there are three women running for mayor and only one man," Ginagate said.

Based on their record, there are 8,206 women in the town who are registered voters, lower by 213 with that of their male counterparts.

According to him, the Commission on Elections (Comelec) has been encouraging more wom-

en to run for elective positions as they are also advocating GAD (gender and development) for women equality.

In Eastern Visayas, there are 836 women candidates who are seeking for elective posts up for grabs in the forthcoming May 13 elections.

The number, however, is comparatively small compare to the 2,555 men candidates in the region who are also running for posts for governor, congressman, board members, mayor, vice mayor and councilors.

For Vice Mayor Delante, she is glad that there are more women who are running for the mayor of their town.

She said that the women are now more aware that they could do what men could do, running the affair of a local government.

Delanate,34 and a mother to two young girls, said that she believes that she could get women's votes, an observation shared by Maderazo.

And obviously, the women candidates are banking on the votes of women, saying they have programs intended for them like livelihood so they would not depend so much on their husbands, in particular.

"They knew that if a woman would lead them, they could be assured that they will be in good hands. They are more comfortable to have a woman leader, I guess," Maderazo, a retired planning officer of the provincial government of Bil-

Maderazo,60, is confident that it will be a woman who will emerge as the winner in the mayoralty race.

"I'm sure of that. (He) is a weak candidate," she said, referring to Visbal.

For Vice Mayor Delante, she is also counting her young age to get the votes of young women of their town.

"I really hope to get their votes as I knew that they want to see a young leader like me who will lead our town to progress," she said.

It was learned that the town has only produced two women mayors: Erlinda Reyes, who served during the remaining years of the Marcos dictatorship, and Floresca Delante, who served from 2007 to 2010.

Incidentally, both women are relatives to Vice Mayor Delante, a former beauty queen. Reyes is an aunt while Floresca is her mother.

For Janet Go, a registered voter, said that she does not really consider the gender of the candidate when she vote.

"It's more on their programs and what they intend to do to help the people of the town," the 30-year old woman said, declining to say who will receive her precious vote among the three women mayoralty candidate.

The other candidates, Go and Visbal, were not available for their comments. (JOEY A. GABIETA)

### **PNP** in **EV** arrested 33 persons for illegal possession of firearms and other deadly weapons

TACLOBAN CITY- A total of 114 banned weapons were confiscated and 33 civilians arrested across the region covering an 11-day operations of the Philippine National Police (PNP) aimed in making the May 13 balloting peaceful and orderly.

The seized weapons were 52 ammunition, 27 bladed weapons, 13 units of firearms which includes 5 units of cal. 45 pistol, 4 units of cal. 38 revolver and 1 unit each for cal. 22 pistol and 5.56 revolver.

Also retrieved at various check points were improvised gun and homemade gun (deholen) and marbles used for 'holen' gun, four magazines, two units each for cartridge case and sling bag and one empty shell for cal. 45 pis-

"I am thankful for the continued support we had received from the community. Let us continue helping one another to achieve a safer election this coming May 13," said Police Brigadier Dionardo Carlos, the police regional director.

Of the 33 arrested civilians, 19 were from Leyte; four each from Northern Samar and Samar; two from Eastern Samar; and one each from Biliran, Southern Leyte, Tacloban

The cases of the apprehended persons include violations of BP Blg. 6 (An Act Reducing the Penalty for Illegal possession of bladed, pointed or blunt weapons, and for other purposes), RA 10591 (Comprehensive firearms and ammunition regulation act), frustrated murder, alarm and scandal, violation of Sec. 261 of Paragraph Q of Omnibus Election Code (Carrying firearms oA total of 21,010 PNP personnel along with the Philippine Army conducted the operations across the region March 29 to April 8.

### **Bong Go maintains strong** showing in survey on senatorial race



Former Special Assistant to the President Christopher Lawrence "Bong" Go maintains his strong showing in the survey on the senatorial race with barely a month to go before the May 13, 2019 elections.

Despite his strong showing, Go said he would continue to work harder and serve the people the best way he could.

orts and terminals throughout the country are now starting to swell with passengers bound to various destinations due to the holy week religious observance of this predominantly Roman

Catholic country, hence the luggage-people congestion that results in unpleasant events in these areas sometimes.

In bus terminals, some people seeking to get a ride have to spend days and nights there for being chance passengers, or to line up before the ticketing counters. Some of them end up hungry and drained of their hard-earned cash due to unexpected expenses brought about by trip delays. Those with children and elderly companions suffer the most as the latter are prone to sicknesses amid hunger and the scorching summer heat.

As the crowds flock to these terminals, the sanitation of these places eventually worsens.

Undisciplined folks just throw used plastic bags, bottles, and all everywhere, littering the place even with body wastes such as odorous urine, phlegm extracted from their coughing throats, and spitted saliva. Two reasons largely explain it: first, to avoid inhaling the toxic, dark



There was however a very touching moment before He sat down with His apostles to have their supper when he approached each of them and humbly washed their feet, an act that is only done by slaves.





thoughts and attitudes of the heart." (4,12) As one saint also said, God's word is eternal, always new while it is also old. It will always be relevant and will engage us in a meaningful way at any moment.

In short, meditating on the gospel will help us to have focus and sense of direction in life. It helps us avoid leading a scattered attention, reacting only to the passing things, to the here and now that often are mere fancies and curiosities. Let's have good control on our tendency to get distracted because of the internet, gadgets, multitasking lifestyle, etc.

It will help us to distinguish the voice of God who will always be intervening in our life. More than that, it will facilitate the continuance of our conversation with God who initiates it.

Again to be sure, God will surprise us with some overwhelming gestures from time to time to awaken us from our tendency to sleep spiritually. This happened, for example, during his transfiguration in Mt. Thabor before the three totally bewildered apostles Peter, James and John. (cfr. Mt 17,1-12)

We can expect some similar occurrences. Thus, some saints experi-

enced visions, ecstasies and other extraordinary things because of their perseverance in prayer despite all kinds of obstacles.

But, yes, it cannot be denied that given our human condition we will experience all kinds of things that will make prayer difficult for us. We should just try to comply with what Christ once said to the sleepy apostles in the Garden of Gethsemane. "Watch and pray so that you may not enter into temptation. For the spirit is willing but the body is weak." (Mt 26,41)

Indeed only in prayer can we manage to deal with temptations effectively. And that's because when we pray, we unite ourselves more and more with Christ and thereby share his powers and his ability to ward off temptations and the devil himself.

When we feel weakening in our prayer, let us take advantage of that condition itself to go closer to God, even if we have to crawl and beg. Let's assume that logic expressed once by St. Paul: "Power is perfected in weakness...for when I am weak, then I am strong." (2 Cor 12,9-10)

Let's always sharpen our dispositions for prayer. We need to make our faith alive, making it more incarnated rather than simply lingering in the abstract sphere. We have to strengthen our spirit of sacrifice and mortification. We cannot persevere in prayer if we remain weak in body and, worse, in will.

Let us always try to look for the appropriate place and time for our meditations.

the Philippine National Police issued safety tips to Eastern Visayas residents this coming observance of Holy Week and summer vacation.

In the safety tips issued by the Police Regional Office (PRO) 8, Eastern Visayas residents who are leaving their homes are reminded to always lock all doors and windows and ensure that all possible entrances are blocked.

If possible, install a burglar alarm to alert the neighbors if someone breaks in and do not leave notes outside the house indicating you will be away, the police advisory added.

Owners are also encouraged to ask a trusted neighbor to keep watch over their houses while they are away.

The police advisory also said that house owners should ensure that no candle, gas stove, leaking faucet or plugged appliance are left unattended then secure all items outside the house, such as clothes being hung out to dry and bicycles or vehicles.

For those with vehicle and traveling drivers are advised to ensure the roadworthy of their car and follow the "BLOWBAG" rule: B - Battery, L - Light, O -Oil, W - Water, B - Brakes, A – Air, and G – Gas.

Drivers must always bring the pertinent documents for the vehicle, including driver's license, vehicle registration and Insurance Certificate.

They must always make sure that car doors are locked and the windows closed especially if children are on board and must ensure control of the vehicle at

The PNP also advices drivers to avoid one-handed driving or using a mobile phone; avoid driving while drunk or sleepy.

For night driving, drivers must always use headlights and signal lights and avoid driving when they have poor eyesight.

For those who will use public transport and going to church, beaches and resort, the public are advised not to wear expensive jewelry or bring large amounts of money and always keep watch over their mobile

Do not bring too many items and always be early at airports and seaports especially in the case of women, children and senior citi-

If there are suspicious package or someone acting suspiciously immediately notify authorities and always be wary of snatchers and petty thieves, and report incidents to the nearest Police Assistance Post.

With the influx of people taking advantage of the long holiday this Holy Week and the start of summer vacation, the tourism department also issued their safety tips to vacationists and travelers in Eastern Visayas tourist destinations.

"As part of our measures to prepare for the upcoming Lenten and summer season, we would like to remind you to ensure the safety of our domestic, local and foreign tourists during the season," Karina Rosa Tiopes, regional director of the Department of Tourism (DOT), said in the travel advisory.

The tourism official also reminded tourists and visitors to always practice sustainable and responsible tourism by minimizing the use of plastic, strictly following the carrying capacity and imposition of do's and don'ts particularly in tourism site like protected areas, water and power conservations.

In the travel advisory, tourists and visitors were urged to do their research prior to visiting their chosen destination; ensure to pack important things like first aid kits, dry bag, hygiene kits, sunscreen, and flashlight; follow the warning signs for safety; and constantly drink water or juice to avoid heatstroke.

The don'ts for tourists includes traveling without life jacket when crossing ocean, swim without lifeguard, leaving or disposing trash anywhere and avoiding wasting of resources like water and power.

The DOT and PRO8 also encourages tourist and residents to save important numbers in their phones like police hotlines and tourism office hotlines for them to immediately have access to authorities if they have concern.

Meantime, Father Chris Militante, spokesperson of the Archdiocese of Palo, said that while the observance of Holy Week should not be considered as a vacation time for the Catholics.

He asked them to do some reflections and take time in commemorating the holiest time in the Catholic calendar by recalling the passion and death of Jesus Christ.

### Despite its many natural wonders

### Tourism industry of Eastern Samar not picking up, says official

TACLOBAN CITY- The tourism sector in Eastern Samar is not picking up compare to other provinces in the region.

In fact, the tourism arrivals and its receipts of the province is at the bottom, a depressing situation considering that Eastern Samar possesses natural wonders whose beauties are comparable to other major draws in the country like the Boracay and Siargao, Surigao del Sur, Mayor Mark Biong of Giporlos town, said.

Biong said that if he gets elected as a board member of the province, he want to get the chairmanship of the committee on tourism so he could help promote the tourism industry of the province.

'We have so much to offer to tourists and yet Eastern Samar's share on tourist arrivals and receipts only account five percent of the entire region," Biong said.

"It's high time to have a share equal to what we have in the province. Our islands are so pristine and clean. We have destinations comparable to popular sites in the Philippines," he added.

In 2017, for example he said, tourist receipts of the province only reached P684 million sourced from the expenses incurred by the more than 179,000 tourists who visited the different tourist spots of the province.

And this figure slipped further to 4.4 percent by 2018, Biong added.

The outgoing mayor of Giporlos said that if he becomes a board member, he would craft legislative measures that would help enhance and promote the tourism sector of the prov-

"I plan to have a massive marketing strategy (to help promote our tourism industry)," he said.

Among the tourism

destinations that Biong mentioned that could help attract tourists in the province are Calicoan Island in Guiuan town, Yolanda Beach in Salcedo, Amandaraga Falls in Lawaan, Dangkalan Pacific Beach in Taft, nature parks in Hernani and Balangkayan towns, and the historic Balangiga Bells.

Biong said that what he envisions is for the tourism sector in the province be sustainable and pro-

Admitting on the shortcomings on accommodations, Biong said that he would encourage investors to build hotels and lodging

He also said that tourists in the province can be assured of their safety saying that Eastern Samar is peaceful, contrary to public perceptions.

Presidential Communications Operations Office (PCOO) Secretary Martin Andanar called on the private media to help protect the integrity of the upcoming elections by joining the government in its intensified Dismiss Disinformation campaign.

In a phone patch interview on DyDM Maasin Radio-Southern Monday(April 15),the PCOO Chief appealed, "It is our mandate sa PCOO na ipaglaban itong ating kampanya na dismiss disinformation kaya hiling ko sa ating media na sana ay magtulungan tayo para magkaroon din tayo ng clean, fair and honest elections."

He stressed, "Tandaan niyo po sa eleksyon, isang araw lang ang botohan but most of time ito po ay kampanyahan. And in a campaign, 90 percent is basically spent on communications."

Sec. Andanar shared that he won't be joining the Philippine delegation for the second Belt and Road Initiative in Beijing, China so he can focus his efforts more on this campaign against fake news, especially as the elections draw closer.

He noted, "Tayo ay mananatili sa Pilipinas sapagkat maraming atas si Presidente sa atin na kailangan kong gawin. Dire-diretso ang trabaho. Alam mo naman, malapit na ang eleksyon so very focused tayo sa Dismiss Disinformation campaign para labanan ang fake news."

fake news sa ating bansa eh kawawa naman at maapektuhan din ang ating principles of clean, fair and honest elections. 'Pag naapektuhan 'yan eh it weakens our democracy.
