

The strongest to hit the region in 2 years OCD says quake did not cause much damage to EV JOEY A. GABIETA, ROEL T. AMAZONA

TACLOBAN CITY- The strong 6.5 magnitude earthquake that rocked the region did not result to major damages.

This was the assessment made by the regional Office of Civil Defense (OCD) which said that no major infrastructures like roads and bridges sustained serious damage due to the tremor that hit the region on Tuesday (April 23) at about 1:37 pm.

"We are thankful that we did not sustain any major damage compared to Luzon's 6.1 magnitude (tremor)," OCD Regional Director Henry Anthony Torres said.

Luzon, to include Metro Manila, sustained a 6.1 magnitude earthquake on Monday (April 22) which resulted to damages of buildings with 16 confirmed dead and still missing persons.

The Tuesday jolt was the strongest to hit the region since the 6.5 magnitude tremor on July 16, 2017 that killed four persons, injured 100 others and tumbled several buildings and houses. It also resulted to a region-wide power outage that lasted for weeks.

Torres also said that seven people sustained injuries as a result of the tremor with no casualty reported.

Of these injured people, three were from Catarman, Northern Samar-Ricky Pabroa,39; Joseph Froilan,46; and Ernesto Aseo,42; one

from Mondragon town, also in Northern Samar, William Milagros;48 and one from Catubig, also in the same province, Nikki Osal,34; one from San Jorge, Samar, Clarita Borden; and one from Tacloban City, Analyn Ibanez.

The Tacloban Rescue Team Unit (Tacru), however, said that they rescued four people, three of them students, who sustained minor injuries due to the quake.

The regional office of the Philippine National Police (PNP), meantime, reported 17 persons who sustained



2 brgy leaders killed in areas where soldiers, NPA earlier engaged in a fire fight

CATARMAN, North-

ern Samar - Still unidentified suspects killed two barangay leaders in areas where members of the government troops and the rebel group, New People's Army (NPA), earlier engaged in a firefight.

In San Barangay Miguel, Las Navas, this province, its village chairman, Apolinario Lebico, 63, was shot to death by an alleged riding-in-tandem on Thursday (April 25) afternoon.

Tayaban said that the victim was riding a motorcycle driven by his sonin-law Jeremy Capoquian as they were on their way home when two unidentified gunmen, who were also aboard a motorcycle, emerged from behind and shot Lebico several times with the use of a Cal.9mm firearm.

Lebico died on the spot from a gunshot wound on his head while his son-inlaw bore a slight wound on his right hand. The suspects reportedly fled towards the direction of barangay Quezon, the police said. Elements of the Philippine Army's 20th Battalion responded to the incident and brought the victims to the Catubig District Hospital where doctors conducted post mortem examination on Lebico. To recall, soldiers who were in Brgy. San Miguel engaged in a fire fight with alleged rebels which resulted to the death of a nine-year old boy after

the rebels lobbed improvised explosive device on April 17.

Bong Go vowed to pres Duterte's campaign against corruption; HNP stumps Kidapawan City



KIDAPAWAN CITY, North Cotabato - Former Special Assistant to the President and 2019 senatorial candidate Christopher Lawrence "Bong" Go on Monday vowed to help President Rodrigo Duterte in his campaign to rid the government of corrupt officials.

Speaking at the Hugpong ng Pagbabago (HNP) campaign rally at the Capitol Provincial Gymnasium here, Go thanked the residents of the city for their warm welcome, particularly during his motorcade earlier.

"Maraming salamat po sa mga kababayan ko dito sa Kidapawan at North Cotabato. Tulad po ng ibang lugar na pinuntahan namin, napaka-init po ng pagtanggap ninyo, sing-init ng panahon. Nakakawala po talaga ng pagod pag nakikita mo ang ganung klase ng suporta," Go said.

In his message to the people of Kidapawan and the entire province, Go reiterated his vow to support President Rodrigo Duterte's campaign against illegal drugs, criminality and corruption.

"Ipagpapatuloy ko po ang mga pagbabago ng nasimulan ni Pangulong Duterte. Yung kampanya laban sa iligal na droga, kampanya laban sa kriminalidad, at kampanya laban sa corruption isusulong ko po," Go said. dential Anti-Corruption Commission any information on corrupt officials and they can be sure it would be acted upon immediately.

"Tulungan nyo po si Pangulong Duterte sa kanyang kampanya aban sa mga corrupt na opisyal. Ibulong nyo lang po sa akin, o iparating ninyo sa Truth and Justice Coalition of Greco Belgica, o kaya sa PACC," Go had said.

As part of his legislative agenda for agriculture, Go called for improved irrigation services to curb the effects of the perennial dry spell the country experiences, noting reports that the dry spell had affected about 15,000 hectares of farmland.

Go said improved irrigation system, coupled with better management of water resources could not only help bring a bountiful harvest for the farmers but also support the operation of residents engaged in fish farming.

"Pagbutihin pa natin ang irigasyon para bukod sa patubig sa bukid ay magkaroon ng tubig ang mga fish ponds. Bigyan din natin ng binhi ng isda ang mga mangingisda para tuloy ang kabuhayan nila," said Go.

"Dapat palakasin pa natin ang suporta ng pamahalaan sa pagbibigay ng mga abono, binhi, makinarya at mga pagsasanay. Ilalayo natin ang mga magsasaka sa 5-6 dahil pahihiramin natin tion water to 9,784 hectares of agricultural lands.

There are also various farms to market road projects in the province to enable farmers to transport their products faster to the market such as the concreting of Mahongcog to SitioTagaytay road, upgrading of Bangkal Sitio Apog-Apog road, improvement of Manobisa Crossing Iwal to SitioTimodos road, and concreting of PBMA - SitioHijara-Tombao road. Proponents have been required to submit the requirements for these projects.

To mitigate the effects of flash floods that destroy properties, crops, and livestock, the Duterte administration is embarking on a P1.4-billion project to dredge and realign the Simuay River and its shoreline. The NEDA has already approved the project in February this year and civil works are expected to begin by this year.

Topmost among Go's priorities in his legislative agenda is the crusade to improve the delivery of health services in the country, particularly through the establishment of Malasakit Center. It's a one, stop shop that makes it easier and faster for indigents to avail of medical and financial assistance from the government by bringing together in one room all concerned agencies such as DOH, DSWD, PCSO, and Philhealth.

"It's a continuing program of the Duterte administration. Gusto ko po itong maisa batas pagdating ng panahon para tuloy-tuloyang programa kahit hindina pangulo si Pangulong Duterte at mas madagdagan pa ang ating mga Malasakit Center," Go said.

Group expresses opposition on 'doble plaka' law

TACLOBAN CITY – The Federation of Eastern Visayas Motorcyclist Association (FEVMA) Incorporated has thrown their support to the Motorcycle Crime Prevention Act but with some reservations.

This was disclosed by the group's president, Allan Tajarros, citing the proposal under Republic Act 11235 to have a bigger plates placed at the motorcycle as one of the reasons why they are not giving full support to the newly-enacted law authored by Senator Richard Gordon.

"We are not against this law. There are some provisions of the law that we feel we are being discriminated," Tajarros said.

He particularly cited the provision mandating for the use of a bigger, color-coded number plates that are readable from the front, back and side from a distance of at least 15 meters should be placed on the motorcycle.

Under the law, violators will be fine P50,000 up to

P100, 000 and a prison term of six months to six years.

"Every brand of motorcycle has its own design and the current design of most motorcycles we have here in the region is not suitable to comply with this law. Maybe in the future design of the manufacturers, this law is implementable," Tajarros said.

The group has 1,500 members all over the region.

Tajarros said that Sen. Gordon should have first consulted the motorcycle riders before coming up with the legislation.

But since it's already a law, they hope that the controversial provision mandating for a bigger plates would be removed.

Jobert Christian Bolaños, chairman, Motorcycle Rights Organization, for his part, said that if the law is only applicable to some motorcycles, it should not be implemented at all.

Bolaños said that there is a provision in the law stating that if a sticker or plate could not be placed in front of the motorcycle, the owner could not register it.

"It's okay to have a bigger font, but our suggestion is we should follow the European standard because they had been using that type of plates. However, our fear is this is not applicable to all because of the design of motorcycles," he said.

The implementing rules and regulations (IRR) of the law as contained under Republic Act 11235 is yet to be formulated with the assistance from the Land Transportation Office (LTO) and the motorcycle organizations are hopeful that some of the provision they deemed inappropriate for the motorcycle riders will be change.

"Definitely, when we start formulating the IRR we will consult all the stakeholders not only the region but in the whole country," Ledwino Macariola, LTO-8 operations chief. (ROEL T.AMAZONA)

Zeroing in on corruption, Go lamented that it takes a big bite out of the funds intended for projects and programs meant for the benefit of the people.

Earlier, Go had urged people to report to him, to the Truth and Justice Coalition, or to the Presisila ng puhunan na may mababang interes. Gusto ko na magkaroon sila ng alternatibong pagkakabuhayan," he added.

He also assured the people of North Cotabato that they can count on him to support the Duterte administration's infrastructure and development programs, particularly those that are directly beneficial to the people of the province.

He cited, among others, the on-going Malitubog-Maridagao Irrigation Project (Phase 11) located in North Cotabato and Maguindanaoarea, that would divert irrigation water from Maridagao River to deliver timely and adequate irrigaclude programs for education, housing for the poor, fire protection and prevention, long-term sports development, localized peace talks, barangay welfare, creation of a department of OFW and better support for senior citizens.

"Asahan nyo po, patuloy ninyo akong magiging tulay kay Pangulong Duterte. Wala po kaming ibanghangarin ni Pangulong Dutertekundiangkabutihan ng Pilipino dahilmahalnamin kayo," Go said.



China-Philippine War?

Should war erupt between China and the Philippines over the Spratley Islands row, the sure losers will be both of them, not just the latter although at a glance, the latter is certainly to lose given its weak armed forces against this military giant.

Militarily, our biggest disadvantage is the absence of hi-tech weaponry on air, water, and land in our arsenals. We don't have jet fighters that could hit enemy targets and thus deliver lethal blows from the air. We don't have sophisticated submarines to carry out offensives from underwater. We also lack tanks and armored vehicles that could confront land-based enemy patrols advancing their attacks.

For air combat, what we only have are old helicopter models that, with extremely slow flying pace and noisy engines, could already alert the enemies around. These, too, are almost stationary air targets hence vulnerable to missile launches. In fact, they are old enough that anytime, they may just fall down even no explosive hits them. They just fall apart voluntarily. Why, our fighter planes here are invisible; it's the pilots that fly, but only at nights.

Of course we do have navy boats and ships, but they are too slow for, again, being old models. Fast enemy ferries could just circle them with lightning speed, eluding attempts at hitting them. While these sea combatants enjoy quickness as

targets, our dragging ships provide ease of enemy attacks, both from above and down below. What we have in abundance are bancas/ balutos that are only good for hook-and-line fishing, with huge leaks from all sides you would have to keep emptying them of water.

And our septic tanks, I mean, armored tanks are also just surpluses from possibly World War I. They are rusty all over, dilapidated, and ready to fall apart. They are not just snail-paced in terms of mobility, they are also equally vulnerable and, being just recycled, their quality is beyond repair. 

PSA says region's economy increased by 5.9% in 2018

TACLOBAN CITY - The economy of the region expanded by 5.9 percent in 2018 as compared with the 1.8 percent growth in 2017, a report from the Philippine Statistics Authority (PSA-8) said.

Wilma Perante, PSA regional director, said that the top three industries that contributed to the growth were construction, by 1.8 percentage points; other services, by 1.4 percentage points; and transportation, storage and communication by 1.0 percentage point.

Perante, who made a presentation on the economic situation of the region on Thursday (April 25), said that services accelerated to 10.5 percent in 2018 from 6.2 percent in 2017.

She added that all the sub-industries grew faster: transportation, storage and communication grew by 9.6 percent from 2.3

percent; trade and repair of motor vehicles, motorcycles, personal and household goods grew by 7.4 percent from 4.8 percent; financial intermediation went up by 10.8 percent from 10.3 percent, and real estate, renting and business activities grew by 6.3 percent from 6.2 percent.

The PSA director further added that public administration and defense; compulsory social security expanded by 14.2 percent from 7.7 percent and other services accelerated to 13.0 percent from 8.4 percent.

"Industry rebounded from 1.8 percent contraction in 2017 to 3.5 percent growth in 2018. Industries that recovered from contractions were: mining and quarrying, which grew by 84.7 percent; construction, 17.4 percent; and electricity, gas and water supply, 6.3 percent," she said.

Meanwhile, manufacturing declined by 5.7 percent from the 13.3 percent growth in 2017. Agriculture, hunting, forestry and fishing (AHFF) declined by 0.5 percent in 2018 from the 0.1 percent growth in 2017.

Agriculture and forestry slowed down to 1.1 percent from the 2.8 percent growth in 2017. Fishing also continued to decline by 7.4 percent, although at a slower rate than the 10.1 percent contraction in 2017, Perante reported.

Services and Industry shared the bulk of the region's economy at 44.4 percent and 41.6 percent, respectively. AHFF had a share of 14.0 percent, the source said.

Among the three major industries, services contributed most to the region's overall growth rate at 4.5 percentage points, followed by industry at 1.5 percentage points. AHFF pulled down the region's growth by 0.1 percentage point, Perante said. (RESTITUTO A. CAYUBIT)

Bong Go calls for improved measures to mitigate El Niño impact to agriculture

COTABATO City – Former Special Assistant to the President and 2019 senatorial candidate Christopher Lawrence "Bong" Go on Monday called for additional government support to farmers to mitigate the impact of dry spell brought by recurring El Niño phenomenon that devastates crops.

"Malaki na ang pinsalang dala ng El Niño. Dapat mas palawakin ang cloudseeding operations at free irrigation, kasamana ang solar-powered irrigation systems," Go said in his message during the campaign rally of the Hugpong ng Pagbabago (HNP) regional party at the Notre Dame University Gym here.

Reports earlier said an estimated P605-million worth of agricultural crops in two provinces of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), namely Maguindanao and Lanao del Sur, where 10,818 hectares of rice and 11.039 hecsaka at mangingisda.

Earlier in the day, Go held a motorcade around the city where he received an enthusiastic response from the residents.

"Sobrang init po ng pagtanggap ninyo sa akin, singinit ng panahon. Nakakawala po ng pagod. Maraming salamat po sa mga kapatid natin dito sa Cotabato City at sa buong probinsya ng

Maguindanao," Go said. The former SAP and the HNP senatorial slate secured the support of Cotabato City as HNP headed by Davao Mayor Sara Duterte forged an alliance with Team One Kutawato local party headed by Cotabato City Mayor Frances Cynthia Guiani-Sayadi.

Go rallied the people of Cotabato City to support the HNP candidates as he also expressed confidence they would remember him when they troop to the polling places to vote.

"Alam ko na man hindi ninyo ako malilimutan, unang-una kapitbahay lang tayo, taga-Davao ako, di ba mga Bisaya tayo? Mahal na mahal po ni Pangulong Duterte ang mga kapatid nating Muslim sa Davao City, ipinagpatuloy po ni Mayor Sara," Go noted. Go also assured his fellow Mindanaoans, that he would continue supporting the programs and policies of President Rodrigo Duterte, whom he has served

Likewise, Go said that if elected to the Senate, he would support the implementation of the administration's "Build, Build, Build" programs that are meant to stimulate economic activities and provide as well more job and employment opportunities for the people.

Among others, Go cited the on-going P5.4-billion Malitubog-Maridagao Irrigation Project in North Cotabato and Maguindanao that would provide irrigation water to 9,784 hectares of agricultural lands in the area.

Also in the pipeline is the P39.2-billion Ambal-Simuay River and Rio Grande de Mindanao River flood control projects, meant to benefit the floodprone areas in Maguindanao. The government has conveyed on June 6, 2018 to the Chinese government the request to secure loan financing for the project. As part of government support for agriculture in the area, there are also plans for the construction of two units of solar dryer with warehouse in two sitios in Paglat, Maguindanao. In Calbayog City Calbayog Zipline and Malajog Ridge Nature Park spared from the 6.5 magnitude quake

TACLOBAN CITY-The 6.5 magnitude earthquake that hit the region on Tuesday (April 23) did not cause any damage to the Calbayog Zipline and Malajog Ridge Nature Park, both in Calbayog City.

This was disclosed by the head of its tourism office, Ronald Ricafort who said that he immediately went to the two sites to check their conditions.

"We check the platform and the foundation. There's no crack. Also the cables and the cable clip that is the mainline that holds the tension are okay," Ricafort said.

Calbayog Zipline and Malajog Ridge Nature Park is a man-made structure located about 900 meters above the ridge. Its cable spans to 750 meters from the launch pad located at the ridge and ends at Daraga Islet.

Department of Tourism Regional Director Karina Rosa Tiopes lauded the immediate action of the Calbayog Tourism Office in checking the integrity of tourism structure and facilities under its jurisdiction.

During the post-earthquake assessment lead by City Mayor Ronald Aquino, the City Engineering Office lead by Engineer Ashley Albana reported that no damage were found in some commercial establishments, medical facilities and government-owned structures in the city except from nonstructural damage that was found in Mang Inasal-Calbayog due to broken glasses and cracks on the walls of the new building of the Philippine National Police.

The assessment also found that Gaisano Grand also sustained non-structural damage with glass, wall claddings and tiles broken or falling-off, cracks on cement plastered finish, and cracks on hollow blocks walls.

The 6.5 magnitude quake, the strongest to hit the region in two years, was traced in San Julian, Eastern Samar, as its epicenter. (ROEL T. AMAZONA)

<u>Calling it as the 'saving gace'industry</u> <u>of East Visayas</u> Tourism industry help region achieve a 5.9% economic growth in 2018

TACLOBAN CITY-The tourism industry of the region was cited as its 'saving grace' after its economy posted a growth rate of 5.9 percent last year.

The 2018 growth rate was higher by 4.1 percent compared to the 1.8 percent growth in 2017.

Based on the data presented by the Philippine Statistics Authority (PSA), services related to tourism grew by 13.0 percent covering the said period.

Tourism receipts, in particular, expanded by 5.2 percent in 2018, from the 2017's P13.24 billion to P13.93 billion, PSA said.

Records from the regional office of the Department of Tourism, tourist arrivals last year reached to more than 1.77 million compare to the 1.51 million in 2017.

For this year, the tourism department in the region targets more than 2 million tourist arrivals with a tourism receipts of

over P34 billion. The increase on the number of hotels and accommodations as well as restaurants and other service establishments, particularly on its seven cities and major towns, was also cited to have buoyed the tourism sector.

The tourism department in the region, under Director Rosa Karina Tiopes, has been aggressive on their campaign to attract more tourists to come and visit Eastern Visayas, engaging both the private sectors and the local government units in coming up with their own tourism-related activities or programs.

Meylene Rosales, regional director of the National Economic Development Authority (NEDA), said that while other industries of the region saw positive growth like its service sector, composed, among others of transportation and communication, from 6.2 percent to 10.5 percent; industry (mining and quarrying and construction, among others) from 1.8 percent in 2017 to 3.5 percent, the tourism industry, classified by NEDA and PSA as 'other service' registered a better upward trajectory.

"It's the saving grace of Eastern Visayas," she said.

Rosales, however, stressed that while the region registered an increase of its economy last year, it does not mean that its poverty situation will also show a decline.

"We have an increased economic growth but the challenge is how to translate this (in addressing the poverty incidence). We want a robust and sustainable economy for the region which should be felt by the people," she said.

Based on the PSA data, the region's poverty incidence last year was at 30.4 percent, the third highest in the country next only to ARMM and Zamboanga Peninsula.

DPWH-ESDEO says no major damage of infrastructures in the wake of the 6.5 earthquake that rocked East Samar

BORONGAN CITY-There was no major damage to infrastructures in Eastern Samar with the occurrence of earthquake last April 23, a report from Department of Public Works and Highways – Eastern Samar District Engineering Office (DPWH-ES-DEO) said.

Manolo Rojas, DPWH-ESDEO district engineer, told Leyte Samar Daily Express that based on their assessment, that all national roads were passable in the province and no major damage occurred on infrastructures after the 6.5 magnitude earthquake hit the province.

The DPWH-ESDEO promptly conducted post damage assessment on national roads to assess damages after the earthquake happened, he said.

ESDEO installed also warning signages on the critical areas particularly along the damage pavement along national roads in San Julian and Sulat, to prevent motorists from accidents, he added. Rojas also reported that his office continues to conduct post damage assessment not only on national roads and bridges but also includes inspections on the government buildings, public hospitals and DepEd school buildings.

Cabong, Borongan City, Eastern Samar, Philippines where it may be served with summons and other legal processes, represented in this instance by its General Manager, ATTY. JOSE MICHAEL EDWIN S. AMANCIO, CPA, who was authorized to file, execute verification and certification relative to this Application per Board Resolution No. 01 Series of 2019 (Annex A).

2. Herein applicat is the exclusive franchise holder issued by the National Electrification Administration (NEA) to operate an electric light and power services in the Eastern part of Samar Island covering nine (22) municipalities and one (1) City namely: Lawaan, Balangiga, Giporlos, Quinapondan, Guiuan, Mercedes, Salcedo, MacArthur, Hernani, Llorente, Balangkayan, Maydolong, San Julian, Sulat, Taft, Canavid, Dolores, Oras, San Policarpio, Arteche, Jipapad, Maslog, and Borongan City. A copy of Applicant ESAMELCO's Certificate of Franchise is hereto attached as **"Annex C".**

II. THE ANTECEDENT FACTS

3. Prior to this filing, herein Applicant had undergone computation and reportorial submission to Energy Regulatory Commission on its over or under recoveries incurred in the implementation of automatic cost adjustments and true-up mechanisms on pass through costs of ESAMELCO for the period 2004 to 2011. The said submitted application of Over/Under Recoveries for 2004-2011 was approved and confirmed by Energy Regulatory Commission (ERC) through its Decision dated December 17, 2014.

4. The Over/Under Recoveries for period 2012 to 2014 was delayed because applicant ESAMELCO is still on the process of retrieving and reconstituting most of its files/records, as most of which were damaged and could no longer be found due to the incident of super typhoon Yolanda that devastated its office and all its franchise areas on November 8, 2013. Hence, this Application filed before this Honorable Commission. dated on October 18, 2010, which amended Section 4 of Article 4 and Section 1 of the Article 5 of the "Rules Governing the Automatic Cost Adjustment and True -up Mechanisms and Corresponding Confirmation Process for Distribution Utilities". Further, the computation is consistent with ERC Decision in ERC case no. 2007-520 MC which reclassified the 69kV subtransmission line of Wright-Taft-Borongan-Buenavista from connecting asset to transmission network asset.

8. Hence, this Application is pursuant to ERC Resolution No. 16, Series of 2009, as amended by ERC Resolution No. 21, Series of 2010.

On July 13, 2009, pursuant to Section 43 (f) and (t) of the Republic Act No. 9136 or the Act, Rule 7 of its implementing Rules and Regulation (IRR) and Section 10 of the Republic Act No. 7832, the ERC had resolved to approve and adopt the so called **"Rules Governing the Automatic Cost Adjustment and True-up Mechanisms and Corresponding Confirmation Process for Distribution Utilities"**, by virtue of ERC Resolution No. 16, Series of 2009.

7. However, the aforementioned rules promulgated under Resolution No. 16, series of 2009, failed to address the mismatch between meter reading periods at the wholesale and retail levels due to unequal number of billing days, which results to misalignment of kWh sales and purchase power. Recognizing the need to address and resolve the said misalignment of kWh sales and purchase power which causes spikes and dips in the computed monthly system loss and adversely affects the actual system loss of the DUs during certain billing months. <u>Ong calls it as politically motivated</u> Rep. Ong faces disqualification case over his citizenship

TACLOBAN CITY– A disqualification case has been filed against Leyte Rep. Henry Ong who is seeking for another fresh term in this year's elections.

The disqualification case against Ong was filed by one Anthony Dy who claimed to be a resident of Dagami town.

In his petition he filed before the Commission on Elections (Comelec) on April 22, Dy claimed that Ong's certificate of candidacy should be cancelled due to his not being a natural Filipino citizen.

"(Mr.) Henry Ong, a candidate running for a seat as a Member of the House of Representatives for the second district of Leyte is not a natural-born Filipino citizen but a Chinese citizen, at least according to his certificate of live birth," Dy said in his petition.

"The law defines natural-born Filipino citizens as those who are citizens of the Philippine from birth without having to perform any act to acquire or perfect their Philippine citizenship. This includes those who elect Philippine citizenship in accordance with paragraph (3), Section 1 of the 1987 Constitution which states" (3) those born before January 17, 1973, of Filipino mothers, who elect Philippine citizenship upon reach-

ing the age of majority.

Dy said that Rep. Ong was born on September 7, 1971 to a Chinese father and a Filipino mother, which consequently make him a Chinese citizen with inchoate right to acquire Philippine citizenship such that, unless he elected Philippine citizenship upon reaching the age of majority, he cannot be considered a Filipino citizen.

Dy claimed that he was able to obtain a copy of the Ong's certificate of live birth which he used as his evidence in filing the disqualification petition against the reelectionist solon.

Dy claimed that his only intention of filing the disqualification case against Ong is to 'protect' the interest of the constituents of the 2nd district by ensuring that only qualified candidates should be given mandate by the voters in the said district. "Any question as to the citizenship of a person running for high public office is far too important to ignore and therefore warrants thoughtful examination for it would be a travesty to elect and be represented by anyone other than a natural-born Filipino citizen, contrary to the express mandate of the Constitution," he said.

Reach for his comment, Rep. Ong said that he has yet to receive a copy of the disqualification case against him.

He, however, branded the petition as politically-motivated, adding that he did not commit any factual error in his certificate of candidacy.

"Everything I have stated in my COC are materially true and correct to the best of my knowledge. I appeal to all my supporters to not be easily persuaded by the things they see in social media and the stories they hear," Rep. Ong said. "I will continue to fight for my constituents

fight for my constituents in the second district. If there is speculation or allegation that I am not a Filipino citizen, they should have filed the disqualification case when I first run for congressional seat against former Representative Sergio Apostol," Ong added. (ROEL T. AMAZONA)

damage, Picardal said during a press conference on Thursday (April 25).

He said that they are recommending to the owners of these establishments to conduct repairs to ensure the stability and safety of their users.

Among those who first to comply with this order of the city government was the management of XYZ Hotel, Picardal said.

The inspection of these structures were triggered by the 6.5 magnitude earthquake that hit region with the jolt felt in Tacloban City at Intensity V.

injuries related to the earthquake.

In San Julian town, the epicenter of the 6.5 magnitude tremor, its municipal disaster risk reduction management officer, Florence Rebamontan, said that three persons sustained minor injuries.

They were Elsa Godino,67 of Brgy.3; Bonifacio Encabo, 70 of Brgy. San Miguel; and Dolly Ponbo,30 of Brgy. Nena whose house made of light materials was damaged after a firewall of their neighbor's house fell down.

Rebamontan, in a phone interview, said that six public elementary schools in the town also sustained cracks.

These are the San Isidro Elementary School; Bunacan Elementary School; San Miguel Elementary School; San Julian Central walls and ceilings.

Mayor Cristina Romualdez, in a press conference on Thursday (April 25), said that she has to create the said composite team to ensure that all public buildings and establishments in the city are safe in the wake of the tremor.

"We should ensure that these buildings are safe for our people. Otherwise, if I will not direct an inspection for these buildings and something happen, I will be held accountable being the mayor of the city," the city mayor said.

Among the buildings that was checked was the Asian Development Foundation College (ADFC).

On Wednesday (April 24), the city government issued a cease and desist order addressed to the school management after

"Our power supply was restored at 10:30 Tuesday night," she said.

Upon the order of Tacloban City Mayor Cristina Romualdez, a composite team led by the City Engineering Office immediately conducted their inspections on buildings, particularly business establishments and public offices, to ensure their safety for human use.

Among the facilities in the city that sustained damages were the Asian Development Foundation College and ACE Medical Center, whose construction is still ongoing, which sustained cracks, the OCD reported.

The regional office of the Department of Public Works and Highways (DPWH), in a separate report, said that all major roads and bridges in the region were passable.



But its president, Edward Chua, said that there is no need for such an order be issued against them.

He added that they are now undergoing some repairs on the cracks that developed in some parts of the school's buildings.

"We are already doing our part. We are also after the safety of our students. We will not open until the repairs are completed," Chua said.

CEASE AND DESIST ORDER

Republic Act No. 6541 known as "An Act to Ordain and Institute a National Building Code of the Philippines", Section 1.01.08 (b) (3) thereof provides:

Section 1.01.08: Dangerous and Ruinous Buildings or Structures

(b) Dangerous Buildings Defined. – Dangerous buildings are those which are structurally unsafe or not provided with safe egrees, or which constitute a fire hazard, or are otherwise dangerous to human life, or which in relation to existing use constitute a hazard to safety or health or public welfare, by reason of inadequate maintenance, dilapidation, obsolescence, fire hazard or abandonment; or which otherwise contribute to the pollution of the site or the community to an intolerable degree. Any building or structure which has any or all of the conditions or defects hereinafter described, or conditions or defects similar thereto, shall be deemed to be dangerous building: Provided, that such conditions or defect exists to the extent that the life, health, property, or safety of the public or its occupant are endangered:

> (3) Whenever any portion thereof has been damaged by fire, earthquake, wind, flood, or by any other cause, to such an extent that the structural strength or the stability thereof is materially less than it was before such catastrophe and is less than the minimum requirements of this Code for new buildings or similar structures, purpose or location;

Based on the actual post-earthquake initial evaluation conducted by the Building Official City Engineer's Office on 23 April 2019, the building is found to have incurred severe damages such as but not limited to the following:

- a. Major cracks on several walls at the ground floor;
- b. Debris scattered mostly on every floor of the building originating from the walls of the building;

- c. Part of the stairway on the ground floor had cracks which reached up to the second floor;
- d. Several pillars of the building had major cracks extending up to the ceilings;
- e. Ground floor columns of the building had prominent cracks.

The photos attached herein disclose that the prominent and considerable damages were still on site and fresh cracks on its walls and floors were manifestly found in the area.

School; Campidhan Elementary School and Libas Elementary School.

The portion of the belfry of the centuries-old Church of Our Lady of Seven Sorrows fell down due to the tremor.

She also said bridges located in the villages of Casoroy and Campidhan sustained some cracks though these facilities remain passable.

Roads leading to the villages of San Miguel and Bunacan also saw some cracks, Rebamontan said.

She also said that four houses were destroyed due to the tremor.

Several barangay halls, basketball courts, schools, and government offices in other parts of the region also reported of minor damages, the OCD said. The water supply in San Jorge town, Samar, was damaged due to the tremor, it added.

On the day the strong earthquake hit the city, panic ensued amid fear of a tsunami.

Mario Sy, who was just confined at Divine Word

Hotel guests were also seen coming out to the streets due to the tremor.

Artemio Caneja, regional director of the Department of Interior and Local Government, said that he was having a meeting at Hotel Alejandro when the tremor occurred, sending them to practice the hold, duck and cover.

"And after a while, we all went outside the hotel," he said.

Classes and offices were promptly suspended due to the quake, resulting to a traffic jam. Relative thereto, Asian Development Foundation College (ADFC) is **NO LONGER SAFE FOR PUBLIC USE** for the findings stated above.

Pursuant to the General Welfare Clause of Section 16 of RA 7160 otherwise known as Local Government Code of 1991, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

Hence, the City Government of Tacloban is mindful of the urgent need to protect its inhabitants from further serious dangers that said building may cause.

WHEREFORE, foregoing premises considered, you are hereby ordered to CEASE and DESIST from continuing your operations immediately from receipt hereof until further inspection by the Building Official of the City Engineer's Office.
