

# With 11 deaths and 268 persons affected DOH declares measles outbreak in E. Visayas

#### **ROEL T. AMAZONA**

GOVERNMENT CENTER, PALO, Leyte - With a rising number of deaths due to measles, the regional office of the Department of Health(DOH) now declares a measles outbreak in the region.

the region has about 11 deaths due to measles, the latest to die was a sixmonth old baby from San Miguel, Leyte on Saturday(Feb.9).

The DOH-8 has monitored that since the start of the year up to Monday, about 268 persons, mostly children, were contacted with the measles.

Areas with the most number of cases of measles are Tacloban City (64),

As of Monday (Feb.11), Palo (20), Burauen (19), Dagami (14), and Ormoc City (8).

> The 11 deaths came from Palo (4), Tacloban (3), and with each from the towns of Dagami, Pastrana and San Miguel, all in Leyte, and Gandara, Samar.

Dr. Minerva Molon, regional health director, said that with the measles outbreak, they will visit the areas with high number of

# In Eastern Samar **Health staff worries patients** may not be getting correct dietary requirements

TACLOBAN CITY- A hospital staff previously assigned at the Eastern Samar Provincial Hospital (ESPH) expressed her worry that the patients of the said provincial government-maintained health facility may not be getting their correct dietary requirements.

Irma Dolot, who was among the health personnel transferred by Governor Ferdinand Marcelo Picardal to other health centers in the province last month on the ground of 'exigency of public service,' disclosed this.

Dolot, who was detailed at the Taft District Hospital, said that while she obeyed the order of Gov. Picardal, she could not help but express her worry on the impact of her transfer.

She claimed that she is the only registered nutritionist-dietitian of the ESPH as the hospital has no fulltime nutritionist-dietitian.

Dolot said that there are only five regular employees and four contractual workers who were tasked to handle the nutrition and diet requirements of the hospital's patients.

"Those running the ESPH dietary kitchen and implementing doctors' orders on the proper balanced diet do not know how to read the doctors' prescribed food in the diet charts. They also do not know the transitions of diet," she said.

"I am afraid that they are serving the same food for all the patients without considering diet requirements or restrictions for each patient. Isn't this dangerous to the health of patients, not to mention anomalous," Dolot added.

ESPH is a 100-bed capacity being managed by the provincial government.

Dolot also said that the considering that ESPH is a second- level health facility, it is mandated to have a regular nutritionist-dietitian. (JOEY A. GABIETA)

### Church turnovers 263 houses for families displaced by super typhoon 'Yolanda'

TACLOBAN CITY-The Catholic Church and other donors turned over new housing units to the 263 families whose houses were destroyed after super typhoon 'Yolanda' hit Tacloban City in 2013 on Sunday (February 10).

"We're proud of these housing units because we also helped during its construction. From planning to the buying of housing materials and building the houses, we were part of it," said housing recipient Yolanda Sembrero.

"These houses are not only durable but also standard in terms of its size," she added.

The 566 housing units at Pope Francis Village have an up and down floor area of 40 square meters with at least three housing models. Each unit cost is totaling P300,000, to P169.8 million.

Philip Lumbre, president of the Pope Francis Village Home Owners' Association, thanked the local, national, and international donors of the housing units.

"Compared to other relocation sites which are very far, the Pope Francis Village is just within the distance from our source of livelihood. We will only spend roughly P18.00 for our fare if we go fishing,"

TACLOBAN CITY -Mayor Cristina G. Romualdez handed a check worth P 3.8 million as the contribution of the city government to the Bangko Sentral ng Pilipinas (BSP)-led Tacloban Credit Surety Fund (TCSF) that would benefit cooperatives and MSMEs in Tacloban City.

The handover ceremony was held recently at the Tacloban City Training Center with TCSF, Cooperative Development Authority (CDA), and Bangko Sentral ng Pilipinas (BSP) Officials.

The city government decided to put up the amount because it believes that cooperatives and MSMEs help spur economic activity and implement needed livelihood programs.

The program also seeks to help local cooperatives gain access to much-needed capital.

Capital-short cooperatives and micro, small and medium enterprises (MS-MEs) which has difficulty in obtaining loans from banks due to lack of acceptable collaterals, credit knowledge, and credit track records will benefit from the fund as this will serve as security, in exchange of acceptable collaterals for loans extended by banks to these MSMEs.

To avail of the CSF, a local cooperative and MSME must be registered first with the BSP.

### **Measles Outbreak**

We are alarmed over the measles outbreak across the Philippines. Reports from the Department of Health (DOH) showed there were more than 20,000 measles cases in the country as of December 2018, a 500% increase from 2017.

Measles is a serious and highly contagious disease. Unfortunately, coverage for routine immunizations in the Philippines is only 55%. If not prevented, measles can cause serious complications including infection of the brain, severe diarrhea and dehydration, pneumonia

and even death. Measles survivors are often left with life-long disabilities such as blindness, deafness and brain damage.

Vaccinations to prevent measles is available free of cost in government health centers. The measles vaccine is safe and effective and had been successfully used in the Philippines for more than 40 years now. But people are already afraid of vaccination because of the Dengvaxia fiasco. The Dengvaxia vaccine led to a decline in public confidence in vaccines and caused a rise in the cases of measles and other vaccine - preventable dis-

Parents should bring their children to the nearest health center to have their children vaccinated and ensure that they receive at least 2 doses of vaccine.

There is an urgent need to end the general feeling of distrust among parents toward the government's mandatory immunization program.

IT is often said that when one is very orderly and focused on things, he most likely will fail to consider other things that may be more important. He becomes a rigid, onetrack-minded person.

Of course, there is some truth to that observation, especially when the persons concerned precisely are too orderly and too focused that they compulsively become controlling of things and therefore end up blind to other considerations that may objectively be more important than what they are handling at the moment.

Sad to say, we have many cases like this nowadays. This may be due to the increasing complexity and complications of our life and the growing clutter not only of material things but also and especially of moral issues and concerns. As a consequence, many people react in that way as their means to cope with the situation.

But if order and focus are lived properly, they actually favor flexibility and creativity, and they can lead one to be more broad-minded, more objective and more able to tackle what is truly imand live order and focus is to inspire them with love for God and others.

Without that love and with us simply relying on our own idea of what is good and advantageous to us, our way of developing and living order and focus would be greatly limited. And that's because our own ideas of these virtues would only be self-serving and would simply depend on our own powers. We would be easy prey to the mysterious twists and turns of our life.

A self-serving motive and a self-empowerment can only do so much. They cannot go the distance. Their objectivity is hampered by a heavily subjective approach to the challenges in life. They practically cannot overcome and go beyond what their current conditionings and circumstances give them. They are like being fenced in.

But when the sense of order and focus is motivated by love of God and others, and empowered by God's grace, then it can be developed and lived calmly and with greater sensitivity to the objective reality of things in their proper hierarchy as willed by God who knows everything and sets the ultimate standard of things. We should try our best

to live always in the presence of God that would also bring about the presence of everybody else. That's because if our presence of God and love for him is real, then we would also have a vivid sense of the presence of the others and an abiding love for them.

It would be good and helpful that in developing this proper sense of order and focus, we bring things first into our prayer so we can see them more clearly under the light of God's will, and not just under our own interests and purposes. In that way, we can easily establish the priorities proper to each of the things that come our way.

There will be a good sense of purpose and direction, and any unexpected thing or surprise that can come our way can be handled better without getting confused or lost.

Besides, with this good sense of order and focus and a good sense of purpose and direction, we can easily discover and discern other possibilities that are relevant to our plans.

A well-thought-out daily strategy attracts more relevant ideas. The promptings of the Holy Spirit are more easily discerned. We become more discriminating of things, and we would know what to get and give attention to and what to ignore and discard.

In other words, we would become more prudent, our power to judge things and events properly gets sharpened, and our ability to be flexible, adaptive to the demands of the moment as well as creative is facilitated.

#### MUNICIPAL ORDINANCE NO. 02 SERIES OF 2018

#### AN ORDINANCE REGULATING THE ESTABLISHMENT, OPERATION AND MAINTENANCE OF COCKPITS, COCKFIGHTING AND IMPOS-ING FEES THEREOF, IN THE MUNICIPALITY OF JIPAPAD, EASTERN SAMAR

WHEREAS, section 458, paragraph (a), subparagraph (3) (v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the municipalities through the Sangguniang Bayan to enact ordinance granting franchise and authorizes the issuance of permits or license on the establishment, operation, and maintenance of cockpits, and regulate cockfighting and commercial breeding of gamecocks;

WHEREAS, cockfighting has been, and still is, a popular, traditional customary form of creation and entertainment among Filipino customs and traditions, it should neither be exploited as an object of commercialism or business enterprise nor made as a tool of gambling but more as a vehicle for a preservation and perpetuation of native heritage, thereby enhancing the town's national identity;

WHEREAS, the municipality needs additional sources of revenues to finance its multifarious projects and to provide basic services to the people.

**NOW THEREFORE,** for and in consideration of the forgoing premises, on motion of Honorable SB Member Jupiter A. Ver duly seconded by Honorable Alvin M Tiu, BE IT RESOLVES AS IT IS RE-SOLVED to enact the Municipal Ordinance, as follows:

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF JIPAPAD, EASTERN SAMAR ON ITS REGULAR SESSION ASSEMBLED THAT

#### ARTICLE I GENERAL PROVISIONS

SECTION I - TITLE - This Ordinance shall be known and cited as "AN ORDINANCE REGULATING THE ESTABLISHMENT, OPERA-TION AND MAINTENANCE OF COCKPITS, COCKFIGHTING AND IMPOSING FEES THEREOF, IN THE MUNICIPALITY OF JIPAPAD, EASTERN SAMAR";

**SECTION II - SCOPE** - This ordinance shall govern the regulation of the establishment, operation and maintenance of cockpits and cockfighting in the Municipality of the Jipapad, Eastrern Samar;

#### III - PURPOSE -

**a.** To effectively control and regulate the establishment, operation and maintenance of cockpits and regulate cockfighting and commercial breeding of gamecocks;

**b.** To provide wholesome recreation and amusement to our people.

c. To preserve cockfighting as a traditional and customary form of recreation and entertainment among Filipinos; and

d. To provide additional revenues for the municipality.

#### ARTICLE II

#### 4. Franchise

5. **Derby** - means a cockfight promotion with entry fees. It is an invitational cockfight participated in by gamecocks or cockfighting "afficionados" of the Philippine with "pot money" awarded to the proclaimed winning entity.

6. **Regular Cockfight** - means a cockfight held on Sundays, legal and special holidays without entry fees.

7. **Special Cockfight** - means a cockfight held on days other than Sundays, legal and special holidays and local fiestas for special pruposes, requiring a special permit.

8. **Special Cockfighting Permit** - refers to permit issued by the Municipal Mayor for the holding of a cockfight in a place, other in licensed cockpit for limited duration and for occasion only and on days other than Sundays, legal and special holidays and loca fiestas.

9. **Pit Manager** - a persons who professionally, regularly and habitually manages a cockpit and cockfight therein. He may or may not be the cockpit himself.

10. **Referee** (Sentenciador) - refers to a person who watches and oversees the proper gaffing of fighting cocks; determines the physical conditions of gamecocks while cockfighting is in progress, the injuries sustained by the cocks and their capability to continue fighting, and decides and makes known his decision either by word or gestures the result of the cockfighting by announcing the winner or deciding a tie in a contest game.

11. Bet Manager (Kasador) - a persons who calls and takes care of bets from owner or both gamecocks and those of other, better before the commencement of the cockfighting and thereafter distributes winning bets to the winners after deducting a certain commission.

12. **Bet Taker** (Kristo) - a persons who participates in cockfighting and with the use of money or other things of value, bets with bettors or through other bets takers and wins or loses his bets depending upon the result of cockfight as announced by the referee or sentenciador.

13. **Gaffer** (Paragtadi) - a persons knowledgeable in the art of arming fighting cocks with the graft on either or both legs.

14. Handler Or Starter (Soltador) - a person who personally takes physical custody and control inside the arena of a pitted game cock and who actually release the same for actual fight and combat in game fighting.

15. **Promoter** - a persons engaged in the convening, meeting, holding and celebration of specially programmed and arranged cockfighting like local derbies or competitions, special mains or matches set to or encounters, pintakasi and ordinary cockfighting and hackfights.

16. **Gamecock** - refers to domesticated fowls, specially bred, trained and conditioned for actual cockfighting.

17. **Cocker** (Aficianado) - a person who participates and bets in cockfighting as a sport, amusement, recreation or form of relaxation.

18. **Bettor** - refers to a person who participates in cockfights with the use of money bets with other bettors or through the bet taker or promoter and wins or losses his bet depending upon the cockfight as announced by the referee or sentenciador. He may be the owner of fighting cock.

19. **Cockpit Operator's Permit** (COP) - refers to documents issued to a qualified persons granting him license to operate, establish and maintain a cockpit in the place specified therein.

SECTION II - OWNERSHIP OF COCKPIT - The following persons

pits shall be constructed and operated within the appropriate areas as prescribed in the Zoning Law or ordinance. In the absence of such law or ordinance, the Municipa Mayor shall see to it that no cockpits are constructed within a radius of two hundred (200) lineal meters from any existing residential or commercial areas, hospitals, school building, public plazas, athletic stadia, chapels, churches or other public building. However. This shall not apply to already existing and/or duly licensed cockpit which are now in existence and do not conform to this requirements are required to comply with these provision within a period to be specified by the Municipal Mayor.

Approval or issuance of building permits for the construction of cockpits shall be made by the Municipal Engineer in accordance with existing National Building Code, Ordinance, Laws and practices.

In addition, the applicant must submit and comply with the following requirements before the issuance of license, to wit:

1) **New License** - For new license to establish, operate or maintain a cockpit, every applicant shall submit and comply the following requirements to the Sangguniang Bayan Committee on Games and Amusements for approval:

1. Locational clearance from the MPDC.

2. The cockpit building plan/design as approved by the Municipal Engineer to the effect that such cockpit is free from material, structural or other physical hazards.

3. An application starting therein the names of the cockpit, the name of the owner/owners, the name of the operator/ manager, the name of the license and the mailing address of the above mentioned person.

**SECTION VI - COCKFIGHTING OFFICIALS** - The following cockfighting officials are required to secure a license Fee from municipality of Jipapad, Eastern Samar.

1. Promoters/Operators/General Managers/Hosts	P500.00

#### TIME AND MANNER OF PAYMENT:

(a) The license fee of a cockpit personnel shall be paid before they participates and act in any cockpit or in any cockfights and shall paid annually upon renewal of the permit in the birth months of the permitee.

(b) The aforementioned cockfighting officials shall not act as such any cockpits or in any cockfights with Special Cockfighting Permit (SCP) in the municipality without first securing a license duly issued by the Municipal Mayor of this municipality. Only gaffer, referees, bet taker, or promoters licensed by the municipal officiate in all kinds of cockfighting authorized herein.

(c) No license shall be issued to any cockfighting officials mentioned above, unless he is at least 21 years old, of good moral character, of unquestioned integrity and shall be well versed in

#### PERMIT FEE COCKPIT OWNER/OPERATORS/LICENSES PROMOTERS AND COCKPIT PERSONNEL

**SECTION I - DEFINITION OF TERMS** - as used herein, the following terms shall be understood, applied and construed as follows:

1. **Cockpit** (Sabungan) - includes any place, compound, building or portion thereof, where cockfights are held, whether or not money bets are made on the results such cockfights;

2. **Cockfighting** (Sabong) is the sport of pitting or evenly matching gamecocks to engage in an actual fight where bets on either side are laid. Cockfighting may also be formed as "cock-fighting derby; pintakasi or tupad", hackfight (refers to fights which are not pre-matched); or its equivalent terms in different localities, including cockfighting done outside licensed cockpits when issued a SPECIAL COCKFIGHTING PERMIT (SCP).

3. **Cockfight** (Soltada) - the actual fight of physical combat of two (2) pitted or evenly - matched game cocks. Where bets on either side are laid. A "carambola", wherein the actual fight or physical combat is of more than two (2) pitted gamecocks, shall be considered a cockfight.

or entities may own, operate or manage a cockpit:

1. Filipino Citizens not otherwise inhibited by law;

2. Corporations, groups of individuals, the capitalization of which is at least sixty percent (60%) Filipino-owned and formed organized or established and licensed for such purposes;

3. Cooperatives.

#### SECTION III - ESTABLISHMENT OF COCKPIT-

a. Cockpit shall be established, maintained and operated only in specific areas or places where they are not existing and in such other places as the Sangguniang Bayan may designate by means of resolution upon application filed by qualified persons thereat. To forestall he proliferation of cockpits in the municipality, the establishment, maintenance and operation thereof shall be regulated at the ratio of one (1) cockpit to every 100,000 population or a franction thereof.

b. No two cockpits shall be established, maintained or operated between a distances of less than one thousand (1,000) lineal meters from each other.

The fees herein imposed shall be payable to the municipal Treasurer before the special cockfight and derby can be lawfully held.

**SECTION VIII - PLACE AND TIME OF HOLDING COCKFIGHTS.** Cockfight may be held only in a licensed cockpit and/or other areas designated by the Sangguniang Bayan Committee on Games and Amusement for special cockfights.

a. For Regular Cockfight - cockfight shall be allowed in this municipality only in licensed cockpits during Sundays, a legal and special holidays and loca fiestas.

No cockfighting shall be held on December 30 (Rizal Day), June 12 (Philippine Independence Day), November 30 (National Heroes Day), Holy Thursday, Good Friday, Election or Referendum day and during Registration Day for election or referendum and on such other dates which may be prohibited by law.

#### b. For Special Cockfights, other than Sundays, legal and Special Holidays

The Municipal Mayor, upon the recommendation of the Sangguniang Bayan shall issue a Special Permit and upon payment of special permit fees for the holding cockfighting events on days other than Sundays, legal and special holidays, or herein prescribe in Section 8, paragraph (a), for the support of local fund raising campaign and other local developmental purposes, provide that the period covered by the special permit shall not exceed three (3) consecutive days, and the event shall be conducted within the duly licensed cockpit.

Special cockfight shall be allowed during agricultural, commercial, or industrial fairs, carnival or exposition for a similar period of three (3) days upon resolution of the Sangguniang Bayan. No cockfighting on the occasion of such affair, carnival or exposition shall be allowed within the month if a local fiesta or for more than two occasions a year.

Cockfighting for entertainment of tourists or for charitable purposes - Subject to the preceding subsection hereof, the holding of cockfights may also be allowed for the entertainment of foreign dignitaries or for tourists, or for returning Filipinos, commonly known "Balikbayans", for the support of local fund raising campaign for charitable purposes and other local developmental purposes as may be authorized upon resolution of the Sangguniang Bayan, in licensed cockpit or on playgrounds or parks. This privilege shall be extended for only one (1) time, for a period not exceeding three (3) consecutive days, within a year.

For the purpose, the licensed cockfighting operator is mandated to accommodate and allow the use of the licensed cockpit arena upon the request of legitimate organization, barangays, and other individuals, for the purpose of holding cockfighting as a means of fund raising campaign for charitable purposes and other local developmental purposes and to finance their legitimate programs and activities, entertainment, and other legitimate purposes, subject to terms and condition that the licensed operator may impose thereon.

c. For Special Hack Fight - cockfighting shall be held in barangays to coincide with their fiesta celebrations for a period of three (3) consecutive days only, provided such are requested through a barangay resolution and provided further, that provisions of Section 8 - shall apply, provided furthermore that safety measures be adopted particularly the cockpit areas measuring 5 ms. x 5 ms of perimeter railing with height of 4 ft.

In the holding of special hack fight in the Barangays, the following requirements shall be complied with before the issuance of the Special Cockfighting Permit (SCP) by the Municipal Mayor:

barangay council's resolution requesting for the holding of hack fight in the Barangay shall be submitted to the Sangguniang Bayan fiften (15) days before the Barangay fiesta is held, with the corresponding official receipt of the Special Permit Fee, and

#### c. Net proceeds accruing to the fund raising beneficiary.

At the close of each derby and/or pintakasi for such above mentioned purposes, the owner/operator or license of the cockpit shall then turnover to the beneficiary the amount previously agreed upon. In case of disagreement or in the absence of a sharing arrangement on the proceed of the derby or pintakasi, the matter shall be submitted to the Sangguniang Bayan Committee on Games and Amusement for arbitration, whose decision shall be final.

The owner, operator, or licensee of the cockpits shall submit within seven (7) days after the holding of special hack fight to the Municipal Treasurer and the Municipal Social Welfare and Development Officer copies of the daily financial report and the financial summary thereof.

**SECTION X.** All persons maintaining, operating or concluding any cockpit, any person directly or indirectly participating in the cockfights shall abide by, and obey the following rules and regulation of cockfighting as herein below enumerated, to wit:

**Rule 1**. It is prohibited for any person to accept any bet without the corresponding money at his disposal to respond to the bet in case he loses. No check will be accepted in bets or payments of bets.

**Rule 2**. No person shall talk to interfere with, or in any way obstruct the acts of the starter while releasing their respective cock: neither shall any person talk to interfere with, or in any way hamper, the referee while a cockfight is in progress, especially when the referee is in the act of rendering his decision on any match.

**Rule 3.** Any violation of the provisions of the two preceding rules shall give the management of the cockpit the right to eject the person or persons responsible therefore. And addition to file such criminal action the management may set fit.

**Rule 4.** There shall be a referee (Sentenciador) appointed by the management of the cockpit, who shall have the following duties to wit:

a. To direct and supervise the fight of game cocks in the ring and enforce all the rules on cockfight as herein prescribed.

b. To see it before the cocks are ordered released to fight, that their gaffs are genuine, placed in the correct position, and in right angle, and properly stringed.

c. To see to it that the contending cocks are in good physical condition - holding the cocks one after another at a reasonable height from the ground and releasing cocks has been fixed (tipped), poisoned, injured, wounded or in unable to continue in fight due to any physical defects internationally inflicted upon it, in case any of the cocks suffers from any of his defects, the match shall be nullified.

d. To keep the two cock in constant fight until one is outfought in the encounter or the two cock are dead or refuse the fight any longer. And,

e. The referee has the authority to declare a draw to a match when in his position the match is fixed.

f. To decide each fight immediately and publicly and his decision is FINAL.

**Rule 5.** There shall be an assistant referee possessing the same qualification as the referee, or discharge such duties as may be assigned to him be the referee.

**Rule 6.** In case the referee needs assistance in carrying out any of the rules herein prescribed as in the act of performing the confrontation, and in the removal of the cock to the center of the ring, he shall ask the assistant referee to render to him the necessary aid.

or when their respective cocks peck on the ground or are out of position.

**Rule 11.** The starter shall not interfere with the referee by eight preventing the latter from taking the two cocks to perform the necessary confrontation (careo) or from rendering this rule shall lose the matched-money delivered by him or by the owner of the cock released by him to the bet fixe: provider, however, that the betting of the general public shall be decided in accordance with the result of the fight. The said starter shall furthermore be disqualified permanently from releasing any cock in the ring of any cockpit.

**Rule 12.** There shall be a bet fixer (casador) appointed by the management to the cockpit whose duty shall be to take possession of the match money from the starter or owners of the two contending cocks before the fight delivering the money to the corresponding winners after the fight. And after deducting cocks before the fight which the management and the onwer agree when the fight is declaging a draw.

**Rule 13.** The bet fixer shall place the matched money befor fight on a table located within the premises of any cockpit and shall advice the referee before the latter orders the release of the game cocks, that all arrangement with respect to betting have been completed.

**Rule 14.** Persons wagging a bet may at their opotion change their bet of withdraw their match money before any fight begins: but once the fight has started, no such change or withdrawal shall be permitted. Any discrepancy or shortage in the amount of bets delivered to the bet fixer shall be paid by the management.

**Rule 15.** The management of cockpits has the right and power to oust with the assistance of peace officer to bar any person who is causing nuisance or disturbance in the cockpit premises cockfights.

**Rule 16.** The ring of any cockpit shall be at least seven (7) meters wide, which shall be maintained clean at all times.

**Rule 17.** Two lines parallel with each other shall be drawn in the middle of the ring with a distance of forty (40) centimeters between them.

**Rule 18.** The game cocks shall each have a gaff of such form and lenght, and places in such manners as may be agreed upon between the opposing sides. The gaffs shall be smooth, clean, pointed at the end and sharpened at one side. During the fight the position of such gaffs shall not be change nor down or is loosened from leg.

**Rule 19.** The referee may, however, interfere in any match for the purpose allowing the contending cocks to continue to fight.

a. When the gaff of any fight cock gets entangled with one another thereby preventing the continuance of the fight.

b. When the gaff of any fighting cock gets entangled with the railing of the ring, or of any object, and its adversary does not take the initiative to attack.

c. When the gaff is embarked in any of the cocks, the same may be removed when the cocks have stopped pecking or shuf-fling.

**Rule 20.** Only four (4) persons shall remain in the ring when the contending cock are released to fight, the referee. The two starter, and the other employees, not exceeding four provided, that if it is necessary to maintain peace and order, any peace officer may enter or stay in the said premises.

**Rule 21.** After arrangement have been made with regard to bets waged on each fighting cock and after having complied with the requirements of the preceding rule, the starter upon direction of the referee shall cause their respective cocks to peck on each other, remove the sweats of the gaffs. And worthwhile release the contending cock.

1. A Sangguniang Bayan resolution approving the request by the barangay council and authorizing the Municipal Mayor to issue the Special Cockfighting Permit (SCP).

Cockfighting for Special hack fight shall be permitted to be held in the barangay expect Poblacion Barangays, which they shall be permitted only to hold their Special Hack fights in the existing duly licensed cockpit located at barangay\_\_\_\_\_, Jipapad, Eastern Samar.

### SECTION IX - FINANCIAL STATEMENT OF PROCEEDS FROM COCKFIGHT FOR CHARITABLE AND OTHER DEVELOPMENTAL PURPOSES -

In the Cockfights for the support of local fund raising campaign for charitable and other local developmental purposes, the owner, operator or license shall enter in a daily financial report.

a. Name of the beneficiary

b. The receipt from gate or entrance and ringside tickets, and a total commission (Plazada) for the day;

**Rule 7**. The contending sides may in a particular match, agree to appoint a third party to act as referee who shall, however be subject to all the rules herein prescribed.

**Rule 8.** The referee and assistant referee, including members of their immediate families are absolutely prohibited to have game cocks of their own in the cockpit where they are the referee and assistant referee, neither, shall both be allowed to place a bet or side bet during matches (soltadas). Any violation of this rules shall disqualify permanently the referee or the assistant referee. As the case may be, from acting as such in cockpit.

**Rule 9**. There shall be two starter (soltaderos) in each fight whose duties shall be to release the contending cocks have met and in actual fight. They shall not leave these places, except when their persons are endangered by the fighting cocks remaining, however, always part.

The management shall provide places where the starte shall be located after releasing their respective cock, which places shall be adjacent to the ring with free access thereto.

Rule 10. The starte shall not take back their respective cock after releasing them to fight, except when so ordered by the referee Rule 22. Any match shall be deemed terminated -a. When one or both cocks are killed in the fight and.b. When any one of them flees or runs away as sign of giving-up the fight.

The referee shall render his decision by raising the winning cock in his hand and delivering the same to the corresponding starter.

**Rule 23.** If in encounter a cock flees or runs away but not quickly or give sign that it give-up the fight it should be left undisturbed until it quickly and shown signs that it refuses to fight any longer.

The match shall be deemed terminated and considered a draw whenever any of the game cocks at the start without being attacked by its adversary, flees or runs away, and refuse to fight.

**Rule 25.** In no case shall a cockfight be allowed to last more than ten (10) minutes from the start of the fight. After ten (10) minutes, the referee shall declare the said match DRAW (Tabla). However the referee must count ten (10) seconds from termination of the ten (10) minutes from the star of the fight. The count must be made public. For this purpose, the management shall

cock. provided a time piece situated at a conspicuous place for the general public to see.

Rule 26. Confrontation shall be affected by the referee IN THE FOLLOWING CASES;

a) When neither of the contending cocks does not initiate a fight or purpose its adversary.

b) When the cock that pursues its adversary in the ring stop in its pursuit or departs from its course and fight is not resumed when seen by its adversary.

c) When the cocks seriously wounded after an encounter and cannot attack each other.

d) When one of the cock or both of them appear to be dead.

e) When one of the fighting cocks attacks the other and cannot be pull off its gaff from adversary and

f) When on of the cocks falls on top of the other and remains in this position or in any case when two cocks are close to each other that each is unable to make any movements to attack each other.

g) When one of the cocks does not fight back after receiving a blow from its adversary and it is not certain that is refuses to fight any longer.

Rule 27. Whenever a contending cock abandons its position after confrontation and takes to fights with its feathers near its head raised as an indication on giving upon the fight the said cock shall be deemed to have lost although it walks slowly in leaving such position.

Rule 28. And during the encounter one of the contending cocks falls on the ground and then flees, leaving behind its adversary, the match shall not be deemed terminated whenever the fleeing cock stop and shows signs to fight in which case confrontation shall be affected. If it retreats or refuses the match shall be declare in favour of the adversary.

Rule 29. If the cock has pecked its adversary twice clearly if an adversary refuses to do so its declared a win. If the cock makes a shuffle it will also be declared a win. If both cock makes only one peck then it will declared a draw.

Rule 30. When both cocks are seriously, and after confronting with each other are no longer in a fighting mood, the referee shall observe closely which of them show signs of dying such as twisting the head or pecking on the ground. When one or both cocks show such signs that they should be confronted and place face to face on the ground for them to peck or shuffle at each other. Victory is decided by two pecks or one shuffle or one peck and one shuffle, considering the opponent does not respond. The decision of the referee is final and unappeasable.

Rule 31. When one of the contending cocks, without being attacked by its adversary, walks away from its position and there is doubt as to it desire to fight, the referee shall effect the necessary confrontation. If in the act or performing the confrontation the cock referred to instantly dies at hands of the referee, it shall be considered the loser after it pecked twice by its opponent. Should the other cock die instead confrontation shall effected just the same and its adversary refuses to fight, it shall be considered a draw.

Rule 32. In the event the cocks referred to in the preceding rule which walks away from its position shows sign of dying in the same manner as its adversary, the referee shall immediately lift and hold it in his hand and place it in front of the other which might be lying on the ground or standing still to determine which of them shall be declared the loser in accordance with Rule 28, hereof.

Rule 36. If the cock which was not wounded by its own gaff dies the referee shall proceed to the confrontation and should its adversary peck of attack, the latter shall be declare the winner. But should it quackle and refuse to fight, the match shall be declare a draw.

The match shall likelise be declare a draw if after pulling out the guff which stuck into a cock the same dies thereafter and its adversary does not peck it.

Rule 37. In addition to the case mentioned in the preceding rule a match shall likewise be declare a draw.

a. When both cock die simultaneously.

b. When one of the cocks flees from the other which is in the act of dying and no longer pecks shuffles.

c. When both cocks show signs of dying and neither pecks nor attack the other, in this case the referee shall not held either of them.

d. When one of the cock jumps out the rallings of the ring after the first attack of its adversary and is not wounded.

e. When both cocks refuse to peck each other before the start of any fight in the absence of mutual agreement to the effect.

Rule 38. Confrontation shall be effected by the referee and the assistant referee without the intervention of the starters or other persons and shall be done precisely at the place where the cock are found without the necessity of taking them to the middle of the ring. Confrontation between the live cock and the dead one shall be effected in the same place where they are found. Loser not only loses high places be but also his cock dead or alive.

Rule 39. Questions arising from any condition not covered by these rules be decided in accordance with practices, customs and usages generally established and observe in the locality.

SECTION XI. Commercial Breeders of Fighting Cocks shall secure a license and pay an annual fee of P1,000.00 to the Municipal Treasurer, which shall be paid within the month of January, otherwise he shall be subject to a surcharge of 25% thereof, and to an interest of 2% per month of the unpaid fee, including the surcharge until such amount is fully paid, but in no case shall the total interest on the unpaid amount or portion thereof exceeds thirty-six months.

For purposes of this section COMMERCIAL BREEDER OF FIGHT-ING COCKS, shall mean an annual sale of more than five (5) fighting cock duly registered breeders.

#### **ARTICLE III FINAL PROVISIONS**

SECTION I - PROHIBITED ACTS - the following acts shall be considered a violation of this ordinance and violator thereof shall be liable to the penalty provider for in the next following section, to wit:

a) The admission of minor (17 years old and below) to a license cockpit arena to engage or participate in cockfighting activity;

b) Possession of deadly weapon, whether license or not, inside and within the vicinity of the cockpit arena;

c) Any person conducting, engaging, or participating in a cockfight held outside a licensed cockpit.

d) Any person conducting, engaging or holding a cockfight in a licensed cockpit without a valid Cockpit Operator's Permit (COP), or a Special Cockfighting Permit (SCP);

e) Any person conducting, engaging or holding a cockfight on a day which is not authorized or allowed herein;

fight any of the above-mentioned personnel unless he has registered and paid the fee herein required.

k) No gambling of any kind shall be permitted on the premises of the cockpit or within a radius of 50 meter from the place of cockfighting during cockfights. The owner, manager or lessee of such cockpit or the permittee of the SPECIAL COCKFIGHTING PERMIT and the violators shall be criminally liable under section II hereof.

#### SECTION II - PENALTIES FOR VIOLATION OF THE ORDINANCE

Any person or persons who violates any of the provisions of this ordinance or the rules or regulations promulgate by authority of this ordinance shall, upon conviction, be punished by a fine of not less than one thousand pesos (P1,000.00) nor more than Two Thousand Five Hundred Pesos (P2,500.00), or imprisonment of not less than one (1) month nor more than six (6) months, or both fine and imprisonment; or cancellation of business permit and/or license; at the discretion of the court.

If the violation is committed by any juridical entity, the President, General Manager, or the individual entrusted with the administration thereof at the same time of the commission of the violation shall be held responsible or liable therefore.

Punishment by a fine or imprisonment as herein provided for shall not relieve the offender to the payment of the tax, fee or charge imposed under this ordinance.

SECTION III - APPLICABILITY CLAUSE - The provision of PD 449, otherwise known as the Cockfight Law of 1974, PD 1802 (Creating the Philippine Game Fowl Commission), and such other pertinent laws shall apply to all matters regarding the operation of cockpits and the holding of cockfights in this Municipality.

SECTION IV - SEPARABILITY CLAUSE - If four any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other section or provision thereof.

SECTION V - REPEALING CLAUSE - All ordinance, rules and regulations, or part thereof, inconsistent with or in conflict with the provision of this ordinance shall be deemed repealed or amended accordingly.

SECTION VI - EFFECTIVITY - This Ordinance shall take effect after a period of fifteen (15) days from the date of posting in at least four (4) conspicuous places in the municipality, or after a period of fifteen (15) days from the date of posting in a newspaper of general circulation.

Rule 33. A cock which is seriously wounded shall not be considered the lose although it sticks it break on the ground.

a) When it continues to stand on its legs or

b) When it sticks its beak on the ground as a result of its attempt to rise due to an injured leg or broken wing or any wound

c) When it does so because of its having been pecked by its adversary.

Rule 34. When one of the cocks pierces itself with its own gaff and remains lying on the ground, the referee shall not disturb the cock until he satisfied that the wounded cock is already dead, in which case he shall pull out the gaff of the dead cock and shall nold it adversary in his hand. The dead cock shall be considered the loser, if on the other hand, it is found the wounded cock is alive the referee shall cause them to resume the fight.

Rule 35. If the cock which was not wounded by its own gaff dies the referee shall proceed to the confrontation shall be effected by the referee after pulling out the gaff of the wounded

Any person who acts as referee, gaffer, bet taker or prmoters, starter in any cockfight without first securing and paying the current license fee;

g) Owners, operators manager of cockpit who hire, employ, utilize person as referee, gaffer, Bet Taker or promoters, starters, in cockfighting, if those persons do not have the required license to act as such;

h) Any person who allows promoters or participate in any arrangement, combination scheme or agreement by which the result of any cockfight shall be predicted and/or unknown other than on the result of the fighting ability of the contending fighting cocks, such as but not limited to its poisoning, injuring or wounding.

i) If the person found guilty hereon is cockfighting official, aside from suffering the penalty provided for under section II hereof, he shall also be perpetually disqualified from acting as cockfighting official in any cockpit or cockfight.

j) Only duly registered and licensed promoters, referees, cashiers, bet managers, pit referees, bet takers, or gaffers shall take part in all kinds of cockfight held in this Municipality. No operator or owner of a cockpit shall employ or allow to participate in a cock-

### Humbly dreaming for a much improved Buracan Elementary School in the ensuing years...

Buracan ES, some 5 kilometers away from the p[oblacion of La Paz, Leyte ( accessible by any mode of land transportation), is a complete elementary school staffed with (7) teachers and a principal.

The enrolment is manageable at 146. For the last three (3) years, the same has significantly decreased owing to the declining number of children of school age, the opening of classes in nearby schools and justifications, like transfer of residence of certain families to Metro Manila/ Tacloban City for job opportunities.

I seem pleased with a very negligible drop- out rate of roughly 1%. The school has already taken steps to address the said issue. But, based on the recent oral reading result, about nine (9) out of (146) learners are considered frustration readers across grade levels, that is to say, they can recognize words but could hardly answer even the most basic questions about what they read.

With such result, certain interventions are being made by the concerned school head, like providing technical assistance to teachers via mentoring on certain techniques on teaching remedial reading, facilitating the implementation of the TIED and SRT programs, peer tutoring, among others.

In order to determine how much progress is being made by the struggling readers, the concerned school head has

been facilitating the administration of oral reading tests/assessment because if such issue would just be ignored, the performance of the learners in the different subjects would be affected. Further, he has encouraged teachers to print/reproduce reading passages and relevant materials suitable to the reading level of the learners.

In support of this, the school management has even provided every teacher with a printer to facilitate the reproduction/ printing of instructional materials. The school management has likewise, secured the support of the parents and stakeholders for the successful implementation of the School-initiated Free Lunch Program for the Disadvantaged Learners, the GULAYAN SA PAARALAN Program and other equally important DEPED programs and projects which have significant impact on the performance of the learners, not just on the identified struggling readers.

Certain stakeholders have shown their support by sponsoring a meal. For example, SB member Arvin G. Terado, wife of our Grade IV teacher (Mildred C. Terado) has sponsored meals for (1) week for the identified struggling readers. All of the seven (7) teachers, led by their school head, each sponsored a meal just to sustain the said school initiated program.

As regards the nutritional status of all the learners, the school management hopes that all the learners would become (without normal cases anymore of nutritionally wasted pupils in the ensuing years) because in the

last semester, the school has recorded (2) nutritionally wasted pupils, but this is still negligible compared to the previous year with twenty-five (25) pu pils considered nutritionally wasted. This issue has already been addressed by thecontinued implementation of the School-Based Feeding Program (SBFP) funded by our agency.

The school manage ment has started securing the school facilities by completing the repair of the concrete perimeter fenceand has started repairing the concrete pavement connecting to the different rooms.

The school management is planning to demolish the old Multi-purpose buildingsituated near the H.E. room because based on the initial report of the Municipal Engineer of La Paz, Leyte, the said structure is already beyond repair and the same continues to pose hazard to the stakeholders.

Hon. Noel Sia, Municipal ABC president, in his message during the oath-taking/induction of new GPTA officersat-Buracan ES grounds, has advised the concerned Brgy. Chairman to prepare and pass a resolution to facilitate the grant and construction of a multipurpose building which will serve as a multi-purpose hall and evacuation center in the event of adverse weather conditions. Mr. Volter L. Gaviola, in his stint as school head, is confident that his humble dream for the aforementioned school would be smoothly realized with the commitment of all stakeholders.

At the 'Kapihan sa PIA' live Friday, Cabanas said SAAD was a priority thrust under DA Secretary

### **Construction of Caray-Caray Bridge in Naval starts this year**

NAVAL, Biliran-The chief of the engineering district office in Biliran said the construction of the new Caray-Caray Bridge will start this year.

"Once the 2019 General Appropriations Act will be approved by President Duterte, the construction of the Caray-Caray Bridge will immediately start," District Engineer David P. Adongay, Jr., said during the PIA Biliran's "Panginsayod" at his office Wednesday, January 30.

Adongay said the project had already been bidout at the DPWH Regional Office in December 2018, and the winning bidder that will undertake the project was already identified.

He further said around P80 million was allocated for the first year of implementation of the multi-year project.

The total project cost for the construction of the bridge is around P180 million.

"If the construction will start this year, it is expected that the project will be finished in two to three years' time as the project contractor is only given one year and six months based on the new DPWH standard to finish the first phase in the construction of the project classified as big ticket project," Adongay said.

The new four-lane bridge, which measures 100 meters in length, will be more elevated compared to the existing damaged bridge, Adongay described as to how the Caray-Caray Bridge will look like after its completion.

### Volunteers conduct cleanup drives in Borongan, Catbalogan cities

TACLOBAN CITY – Obviously inspired with the Manila Bay cleanup, volunteers from Borongan and Catbalogan cities conducted their own cleanup of their respective major coastal areas.

In Borongan City, the coastal clean-up conducted last Feb.9 was led by the Borongan City Tours Guides Association with the help of the Borongan Tourism Office, joined by around 2,000 volunteers from government offices, non-government organizations, academe, church organizations, youth organizations, and business sector.

The volunteers collected trash along the two kilometer coastline of Baybay beach, a surfing and skim boarding destination in the city.

cases to conduct immunization.

"We will focus first on areas with high number of measles victims and those with high number of deaths," Molon said in a press briefing held at their regional office, here.

Molon added that with the report of a two-months old baby got infected with the measles virus, they will also consider immunizing children below 6-months old to ensure they are safe from the disease.

Children ages 6-months to 59-months are those eligible for measles vaccination.

"We are advising mothers and the general public to bring their children at the onset of fever to the nearest health center for treatment and proper case management," Molon said.

Roderick Boyd Cerro, chief of the DOH regional epidemiology and surveillance unit, said that those who died are were from

6-months old to 5-years old. "Majority of those who died did not receive measles vaccine," Cerro added.

Director Molon said that as early as November, they have been doing their immunization campaign.

"However, due to Christmas season and we focused more on the increasing dengue cases," Molon added.

The immunization campaign of the DOH was affected after the controversy generated on Dengvaxia, a vaccine intended for dengue fever.

Several parents have claimed that their children have died after they received the Dengvaxia vaccine, a claim vigorously denied by its manufacturer.

Measles is highly contagious respiratory disease

caused by a virus and can be transferred from person-toperson by sneezing, coughing, and close personal contact.

Symptoms include cough, runny nose, red eyes, fever, skin rashes that last for more than five days.

Complication includes diarrhea, middle ear infection, pneumonia, encephalitis, malnutrition, blindness which may eventually lead to death.

TANAUAN, Leyte-Two 15-year old girls died after they drowned in a private beach resort, this town, on Sunday (Feb.10), a tragic ending to a supposed to a happy gathering.

Drowned were Shanley Mae Panzo and Jess Mae de Paz who was first reported to be missing but whose lifeless body was recovered on Monday (Feb.11) morning by the members of a rescue group of this town.

Their companion, Angel Caeyas,8, survived from being drowned and is now recuperating at the Eastern Visayas Regional Medical Center (EVRMC) in Tacloban City.

It was learned that the girls were part of a big group from Santa Fe who attended a birthday party of their relative, Sylvia Suyom, at the Caunte Resort Beach in Barangay Bislig, this town.

Tanauan Rescuer Chen Anthony Salva,



said that while the celebration was ongoing, the three decided to go on swimming.

However, big waves swept the girls which resulted for them to be drowned.

Salva said that they received a call around 12:40 pm and immediately went to the beach resort.

He said two of the 5 youngsters were immediately rescued whose identities were not known while they were able to revive Cayas and recovered the body of Panzo.

The body of de Paz was recovered on Monday at about 6:45 am.

The Caunte Beach Resort, just like the other beaches in the town, is facing the Pacific Ocean reason why the seawater in that area is unpredictable.
