# In lowering criminal liability of children Governors Petilla, Tan express different views

TACLOBAN CITY- Governors Leopoldo Dominico Petilla of Leyte and Sharee Ann Tan of Samar expressed contrasting views on the issue lowering the age on the criminal liability involving children.

For Gov. Petilla, the government could just be 'pressured' why it want to lower the age on criminal liability of children who are involved in illegal activities.

"I think, while the responsibilities (in disciplining) our children rests on the shoulders of the parents, I think the government is pressured to do something," he said.

And this something, he said, could involve in ensuring that children would not fall prey to illegal activities like illegal drugs and by coming such a policy, it could serve as a deterrent.

Petilla believe that the government, in pushing this controversial policy,

is not making these minors criminals but rather it want to act as a 'responsible parent.'

But for Samar Gov. Tan, this move should not be rushed without first the government, particularly members of Congress, getting a thorough information or data involving children who figured in criminal activities.

"We should have a medical side on this issue and hard data like what age children are mostly involved in criminal cases," she said.

She, however, admitted that some minor children are now 'smart' who have understanding of the consequences of their actions.

# Relative to the May 13, 2019 midterm elections **Comelec tags 70 as EV's** areas of concern

This early, Mendros is calling all the candidates to do

MAASIN CITY- The medical scholarship program of the provincial government of Southern Leyte is starting to pay-off as some medical scholars now become professional doctors after passing the medical board examination in 2018.

One of them is Dr. Lezgard John Gonzales, 27, who now works as a professional doctor at the Salvacion Op-Yniquez Memopus rial Provincial Hospital (SOYMPH). He is now among the roster of physicians at the provincial

hospital since December 2018.

According to Dr. Gonzales, as a beneficiary, he is bound to follow the scholarship program agreements with the provincial government to serve two years for every year of financial assistance accorded to him as a medical scholar. "I have to serve six years at the provincial hospital since I have been a medical doctor scholar for my last three years in the proper medicine when the provincial government started to enlist see LGU /page 2 ... their part in making the elections peaceful and orderly.

TACLOBAN CITY-About 70 areas here in the region were tagged by the Commission on Elections (Comelec) as 'areas of concern' relative to the May 13, 2019 midterm elections.

And majority of these areas of concern are in Samar and Northern Samar, said lawyer Jose Nick Mendros, Comelec regional director.

Mendros, however, could not exactly say as to how many of the 70 areas of concern where in Samar and Northern Samar.

These areas were identi-

fied as such due mainly to intense political rivalries; presence of either a private armed groups or members of the New People's Army; and election-related violence that occurred prior the conduct of the election. The Comelec regional director declared that so far, there are no hot spots in the region relative to the conduct of the May 13 balloting.

An area is labeled as a hot spot if there are existing incidents that are cleared to be election-related. A hot spot area is a candidate for

to be placed under the control of the Comelec. "And we don't have it here in the region," Mendros said, referring to an area classified as a hot spot.

But Mendros said that there is possibility that additional forces, either police or soldiers, could be deployed in areas considered as concern areas to ensure that the conduct of the balloting will be peaceful and orderly.

"That's a possible reaction," the Comelec regional director said, referring to augmentation of security forces.

# Gov't troops preempted NPA extortion activities

CATARMAN, Northern Samar - Two separate encounters transpired in Northern Samar and Samar on January 21, 2019.

Elements of 803rd Infantry Brigade responded to separate distress calls of civilian on the New People's Army (NPA) extortion activity in Barangay Epaw, Las Navas, Northern Samar and Barangay Calundan, San Jorge, Samar.

About 12:10 pm, personnel of the 81st Division Reconnaissance Company (DRC), 8ID, PA encountered more or less 10 fully armed NPA as troops responded to the report of NPA presence in the area.

Said NPAs were members of Front Committee 1 (FC-1), Sub-Regional Committee (SRC) "Emporium" under certain Norma Ultra AKA Ka Aya, Ka Dodo and Ka Basoy. Firefight lasted for about five minutes before the NPA fled. Government troops are still on pursuit.

An hour later, about 1:32 pm, another encounter transpired between personnel of 83rd Division Reconnaissance Company (DRC), 8ID, PA and 20 fully armed NPA of Central Front Samar, SRC "Browser" under Eldie Dela Cruz AKA Ka Star and Bernabe Linay AKA Ka Payo in Brgy Calundan, San Jorge, Samar. Firefight lasted for 20

minutes before the NPA hastily fled leaving behind subversive materiel and documents, including personal belongings.

Brgy Calundan is approximately five kilometers

away from Brgy Bay-ang, San Jorge where the Eastern Visayas Regional Party Committee (EVRPC) main camp were overrun by personnel of 803rd Brigade last January 11, 2019.

B/Gen. Ramil M Bitong, commander of 803rd Infantry Brigade, said "The reports of the people that led to location of the NPA manifested the people's rejection of these armed bandits who have long been pestering isolated communities.

Gen Bitong added that he is expecting more of encounters these until these bandits are banished. "These misled NPA's still have the chance to avail the government's Enhanced-Comprehensive Local Integration Program (E-CLIP) before it becomes too late." (PR)

# 3 village road projects completed in So. Leyte

MAASIN CITY -The Department of Public Works and Highways (DPWH) field office here recently completed the construction of farm-to-market three road projects in Southern Leyte in the bid to hasten transportation of agricultural products in the province.

The DPWH concreted the three-kilometer rural roads through P15 million budget from the Department of Agriculture (DA).

These projects are located in the villages of Tawid (P5 million) and Tomoy-Tomoy (P5 million) in Maasin City. Also completed is the farm-to-market road concreting in San Vicente to Pancil to Aurora villages (P5 million) in Malitbog town. "Prior to the road concreting projects, the roads in these villages used to be dusty and bumpy making it harder for our farmers to deliver their products to the market. But now, these roads were already converted into a two-lane road which hastens transportation of goods," said DPWH Southern Leyte District

Engineer Ma. Margarita Junia.

For the entire 2018, the DPWH Southern Leyte field office implemented 10 farm-to-market road projects with seven still ongoing.

Ongoing road projects are located in the villages of San Jose to Gawisan (P8 million), Nati to Bato I (P7 million), Matin-ao to Cansirung (P5 million), Pinaskuhan to Hinapo Gamay (P7 million), Nonok Norte to San Agustin (P5 million), and Bactul I to Bactul II (P5 million), all in Maasin City. Road works also continue in the villages of Poblacion to Coot in Padre Burgos town (P5 million). "We will fast track the construction of these rural roads. It will be up for completion within the first three months of the year," Junia said.

Southern Leyte, with a land area of 1,798 square kilometers, is basically an agricultural province, complemented by the economic opportunities in the services sector. The major sources of income in the province are farming and fishing.

Improving and constructing farm-to-market roads has been tagged as priority of the government to reduce the price of farm products, make food more available to consumers, and curb high poverty incidence. (PR)

TACLOBAN CITY-In property taxes. order to facilitate local business operators who are yet to renew their business permit and licenses, the City Council adopted an ordinance extending the deadline to renew business permit and licenses from January 20 to February 28, 2019 upon the recommendation of Mayor Cristina G. Romualdez.

As of January 22, the city treasurer reported a collection of more than P165 million in taxes in the ongoing business renewal.

Meantime, the Business Permits and Licensing Division has processed 3,896 during the same period; while 1,676

business establishments were already issued mayor's permits.

The CTO targets to collect P1.4 billion in taxes this year.

Last year, CTO posted a 92 percent collection rate.

### Now under Neda **Pres. Duterte renames Popcom as Commission on Population and Development**

PALO, Leyte -Commission The on Population(Popcom) was reverted back to the National Economic Development Authority (Neda) by virtue of Executive Order No. 71 signed by President Rodrigo Duterte last December.

EO No. 71, which also renamed Popcom into Commission on Population and Development (CPD), is also expected to boost the integration of population and development to increase the country's economic growth as indicated under the Philippine Development Plan (PDP) 2017-2022.

The CPD, as a government agency, was created through Presidential Decree (PD) 79.

From 1991 until 2003, Popcom was an attached agency of Neda before its supervision was placed under the Department of Health (DOH) through EO 188 of then President Gloria Macapagal Arroyo.

Despite being renamed as CPD, it will still be popularly named as Popcom and carry on its mandate to formulate and adopt coherent, integrated and comprehensive long-term plans, programs and recommendations on population as it relates to economic and social development consistent with and implementing the population policy which shall be submitted to and approved by the President.

Under the PDP for 2017-2022, the government seeks to lay down the foundation

of an economic growth that can be further accelerated and sustained beyond the six years of the Duterte administration.

With the goal of laying down a robust foundation for a sustainable economic growth, the plan employs strategies that will help in pursuing an efficient population management to enable its citizens to be productive and engaged in economic activities.

Popcom Regional Director Elnora Pulma said that their commitment remains to fully implement the Responsible Parenthood and Reproductive Health Law and in attaining and sustaining zero unmet need as means to empower Filipino families.

### Legal service unit of PNP-8 ready to provide legal assistance to cops facing work-related problems, says officer

TACLOBAN CITY-Members of Philippine National Police in Eastern Visayas facing serviceconnected cases are assured of the support of the agency.

Thus said Superintendent Mario Abrenzosa of the regional legal service unit who said that his office will provide free legal services and counselling to the police officers.

Last year, a total of 557 police personnel availed of free legal services and counselling in various legal clinics conducted in the region in partnership with lawyer-representatives of the Public Attorney's Office, Integrated Bar amended by Section 56 of RA 8551 which called for the reorganization of the police force and provides that the PNP thru its legal service to provide prompt and timely direct legal representation and assistance to all qualified PNP personnel.

According to Abrenzosa, the extent of direct legal representation for qualified applicants will continue un-

til the decision in the case becomes final and executory.

With this, police personnel facing service-connected cases assigned at the region are advised to seek help directly with the Chief, Regional Legal Office8 while those assigned at the National Support Units (NSUs) shall file directly with the NSU Legal Officer. (LIZBETH ANN A. ABELLA)

Hapinoy is a social enterprise that partners with the sari-sari store owners through training, linkage to micro-financing, enablement on technology, and new business opportunities.

Its heart is to help micro-entrepreneurs create opportunities for them, see them grow, and provide long term sustainability specifically to sarisari stores because they believe that they play an important role in our society. Although there are existing grocery stores, they still choose to support sari-sari stores for they are iconic trademarks of the Filipino culture. After completing the training, the members are now qualified to avail loan funds from CARD, Inc., a microfinance non-government organization whose mission is to offer start-up or seed loans to help generate additional income to the beneficiaries. The beneficiaries are also given micro-insurance called Sagip Negosyo from RIMANSI, a technical service provider among association of mutual micro insurers. Sagip Negosyo was

constituted to develop and finalize a non-life calamity micro-insurance for stores.

John Rey Hecto from Dulag, Leyte has been a member of this project for about a year already.

As a person with disability, he is grateful for the assistance he was provided as it allowed him to gain income despite his disability.

Through this, he was able to have an idea on how to properly handle and grow a business.

"We have to save and not just keep on racking up debts," Hecto said.

The true mission of this project is not solely to create opportunities for them, to learn and for them to grow, but to establish and maintain good relationships with the people whom they were able to extend their help to.

Although relationships are known to be a two-way process, the program doesn't seek much in return as long as they witness improvements in the lives of the people they helped It's not about what the beneficiaries can give in return, it is about the value that this program has placed on the table and instilled in the minds of these entrepreneurs. With that being said, this project forwards the micro-entrepreneurs to enlarge their business capacity towards a more resilient micro-enterprise. ### All united in Christ

AS we culminate the Christian Unity Octave on January 25 with the celebration of the feast of the conversion of St. Paul, let us give some thought to our duty to work out this intention at the very heart of the Church, the unity of all Christians, because this was also the most fervent intention of Christ himself.

Before his passion, death and resurrection, Christ made a most ardent prayer expressing that all of us be one with him, for that was his purpose for becoming man. The redemption undertaken by Christ was meant to make us one with him, since he is the pattern of our humanity, the savior of our damaged humanity, "the way, the truth and the life" for us. We cannot be as

we ought to be unless we are one with Christ.

To be sure, the unity that Christ speaks of is not merely some natural kind of unity, achieved through social, cultural or political forces and laws, but a unity of spirit, of mind and heart, much like the unity that exists between God the Father and the Son and the Holy Spirit.

The unity spoken of here is not uniformity. It is not about building up a monolithic, rigid uniformity. It can tolerate, even encourage, a great variety of views and opinions, for these can only enrich and strengthen the unity Christ wants for us. We just have to learn how to handle this phenomenon that is somehow expressed in that American

gadgets, or resort to equally expensive toys available in department stores. But as regards playing with toys that won't require them a single penny, and with games that develop their physical, mental, and social aspects, children nowadays are no longer interested, nor inclined to even learning those. Yes, gone are the days when toys need not be that costly. Indigenous toys, we called them. Or native if we want a more localized term. Not costing any penny except for some efforts to fashion them.

Either they play with would just pick up any local item, like a stick from the bushes, and they would have a toy to play with. It is a unity of our total identification with Christ to such an extent that we can echo St. Paul's words: "It is no longer I who live, but Christ lives in me." (Gal 2,20)

And so like Christ, we have to have that driving eagerness of reaching out to everyone, whatever their condition is as well as their attitude toward us, whether friendly or not. Toward this end, we should not be afraid of the effort and the many sacrifices that will be involved.

We may have our own tastes and preferences, our own temperaments and personalities, our own views and opinions, our own charism and vocation, or whatever status we have, but we have the duty to reach out to everyone, especially those who are different from us or even are opposed to us. They can even be opposed to God.

"There were many issues during the past administrations and we could not easily download the money for the project. We are happy that local officials here really pushed for this project and offered to help in the implementation process," Lapus said.

The LWUA official expects the project to be ready to provide water to two resettlement sites before the end of March.

Late last year, LWUA agreed to delegate its authority to implement the project to the Leyte Metropolitan Water District (LMWD) after failure of biddings in Manila.

The two winning bidders were the Cebu-based Mactan Rock Industries, Inc. and the Pangasinanbased TGV Builders, Inc. The developers entered a joint venture to implement the much-awaited project.

The project includes two areas. The first is the P404.77-million project to extend water distribution pipes, develop two new sources in the city's northern villages, set up and repair old pumping stations, set up a new reservoir, and rehabilitate the existing reservoir.

The other phase is the P90-million project intended to rehabilitate the city's water pipes.

The LWUA and LMWD signed a memorandum of agreement for the transfer of funds, in response to the request of the city government to pass the responsibility of supervising the project from the national government to the local water district.

The government aims to move 14,000 families from danger zones to the resettlement sites. Thousands of housing units have been awarded, but some families have refused to stay in the relocation sites due to water supply problems.

# In Northern Samar **DPWH execs deny allegations** lodged against them by a losing contractor

TACLOBAN CITY-All five respondents from the Department of Public Works and Highways-First District Engineering Office (DPWH-NSFDEO) based in Catarman town vehemently dismissed the criminal and administrative charges filed against them before the Office of the Ombudsman-Visayas.

The multiple suits against Maritess Lucernarion, bids and awards committee(BAC) chairman of the said office, and her vice-chairman Rudelito Colona and members Edwin Table, Lucas Bacsal and Vicente Galecio were filed by Engr. Uldarico Formaran who represented the Edison Development and Construction/ Tie Builders, Inc., a construction company, last August 7,2018.

Lucer-Respondents narion and Colona denied the accusations especially for violation of the grave abuse of authority/grave misconduct, inefficiency and incompetence and to act promptly on the letters and requests.

Coloma, in his 13-page counter-affidavit, said that the DPWH-NSFDO had advertised accordingly the invitation to bid on December 8014,2018 for the road widening Catarman-Laoang Road, Northern Samar (Contract No.181H002) with an approved bid contract(ABC) of P48,999,268.

On the scheduled date for the submission and opening of bids on Jan.26, 2018, four bidders participated and found eligible to bid: CDU Construction, Edison Development and Construction, On Time Bidders, Inc.(JV) FFJJ Construction/CA Construction and Supply, and Steven Construction and Supply. All four eligible bidders passed the preliminary evaluation as to technical and financial matters. However, a detailed evaluation on the bids was conducted by the BAC with the assistance of the technical working group (TWG) from Jan.16 to Feb.1,2018, showed that the bid of CDU Construction exceeded the budget for the contract at P52,303,547.39, thus the BAC issued a notice of post-disqualification to CDU Construction.

Complainant Formaran represents the Edison Development and Construction/Tie Builders, Inc. (joint venture).

Under the joint venture agreement, the office address of Edison (EDC) is at 121 Mariche Subd. In Quezon City while the On Time Inc. is at Brgy. Poblacion Norte, San Isidro, Northern Samar.

On Feb. 5, 2018, he said that he wrote to Irrigation the National Administration(NIA) in his capacity as BAC chairman at the time inquiring, among others, information on any pending project with that office, to include the recently bid-out projects.

Based on the postqualification report dated Feb.27,2018, concerning the performance of ongoing government and nongovernment projects, the joint venture failed due to its negative slippage at 20.50%.

On March 12,2018, the BAC issued Resolution No.2018-015 unanimously declared the 2nd lowest bidder and awarded the

The resolution was signed by all the members of the BAC and was approved by OIC-District Engineer Ruel V. Umali.

In this connection, Formaran strongly invoked DPWH Department Order No.28 issued by former Secretary Rogelio Singzon which provides that no DPWH officer who has been formally charged with administrative or criminal offense shall be designated as chairperson or members of the BAC or of its secretariat and should be replaced, if he's been designated.

### The other side of basic education of DepEd Leyte: providing access to education for the Deprived, Depressed, and the Underserved (DDUs) population in the province

**MARIE JOY A. ARIAS** 

The Alternative Learning System (ALS) is a practical option to the existing formal instruction. Its programs and projects being implemented by licensed and trained ALS teachers are for learners who do not have or cannot access formal education in schools.

It is an alternate or substitute to formal schooling that targets the learning needs of school leavers and other learners from marginalized groups for them to be able to find a better job and continue their education.

This program of the Department of Education requires highly dedicated, multi-skilled and passionate teachers who have to deal with diverse types of learners every day during the conduct of learning sessions in their community learning centers.

In line with the implementation of Project Curriculum Reinforcement for Academic Dynamism for Leyte Empowered Educators for Excellence (CRA-DLE) of Leyte Division's banner Project SEEDLING, the DepEd Leyte Division ALS unit under the Curriculum Implementation Division now composed of 142 ALS Teachers from the 40 municipalities in the province of Leyte, five Education Program Specialists and a designated ALS Supervisor, is implementing various programs and projects in response to its increasing number of illiterates and the out-of-school population that reached a total of 117,134 for the year 2018.

the ALS Among DepEd's programs being implemented in the division of Leyte for the out-ofschool illiterates and dropouts are the regular Basic Literacy Program (BLP), regular Accreditation & Equivalency Program **ALS-Education** (A&E), and Skills Training Project (ALS-EST), Informal Education (InfEd), Indigenous Peoples Education (IPED) in ALS, Basic Education Madrasah Program for OSY Muslims and the Literacy Behind Bars in Leyte Regional Prison in Abuyog, Palo Provincial Jail and in Carigara, Isabel, Palompon and Palo Bureau of Jail and Management Penology (BJMP).

in Leyte are held in 518 community learning centers (CLCs) all over the province in its 40 municipalities and additional learning centers are expected this year since 18 additional ALS Mobile Teachers were hired in December 2018 and newlydesignated coordinators are already assigned in some of the newly created districts.

Hopefully, more items will be created for the ALS to be able to hire qualified teachers and to increase the quality of education in the program.

ALS education cannot succeed like any other government programs without the support of the private sector.

Right appropriation is necessary to ensure the smooth delivery of the programs and projects implementation thus the need for budget allocation from the government and to continue to build partnership with external stakeholders and the private sector.

The great support of ALS Levte from stakeholders to mention a few are from the Provincial Government of Leyte, the LGUs of the 40 municipalities and their government agencies like the MSWD, PNP, DA, the Philippine Army, TESDA, UNESCO, KOICA, Knowledge Community, Plan International, Edmund Rice Ministries, The Rotary Club of Tacloban, the Rotary Club of St. Andrew-Paranaque, The City Savings Bank, Metro Bank, Ikiko Foundation of France, Save the Children Philippines, Global Peace Foundation, USAID, INTERSOS, UNICEF, Red Cross and some religious associations.

The ALS teachers and the division personnel

Muslims, Persons-with-disabilities (PWDs),learners behind-bars and the Indigenous Peoples (IPs). With this, we can say that inclusive education indeed is evident not only in the formal system but also in ALS.

This result proves that all types of learners are given access to quality education since inclusive education is concerned with all learners, with focus on those who have traditionally been excluded from educational opportunities. ALS takes part in this mandate of providing adult citizens, the disabled and OSY the basic education they need and also training on civics, vocational efficiency and other skills.

The 2018 National Accreditation and Equivalency Test is scheduled first quarter of 2019, a total of 3,800 A&E elementary level and secondary level completers in Leyte from the total 5,635 completers in 2018 are expected to register and hopefully escalate the 79.53% passing rate result of the 2017 A&E test.

The year 2019 is considered the transition year for ALS with the implementation of the K to 12 curriculum. ALS Teachers are expected to undergo mass training throughout the year to be conducted by the central and regional offices.

The enhanced ALS curriculum 2017 edition for teachers has been issued to the field while the curriculum for the ALS Senior High School is still being developed.

ALS implementers in Leyte, from the community learning centers to the division personnel are working hard to be able to produce significant results that will address the needs of the out-of-school youth and adults in the province. The use of differentiated approach is recommended in teaching ALS so that teachers can provide each learner with experiences and tasks that will improve learning. Through ALS, education throughout the country has become more participatory and responsive to the circumstances of its learners. (About: Marie Joy A. # In Samar Families fled homes after military, NPA engaged in a firefight

TACLOBAN CITY – Families who resides in a village in San Jorge town, Samar, have fled from their homes for fear of being involved in the arm battle between the government troops and alleged members of the New People's Army(NPAs).

About 37 families, consisting of 64 individuals, from Barangay Bay-ang fled their homes on January 18, six days after an ambush incident took place in the said village.

The fleeing families have took temporary shelter to a health center, 40 kms away from their village, rights group Katungod-Sinirangan Bisayas said in a press statement.

Katungod Sinirangan Bisayas, quoting the village chairperson, Lorna Badiol, said that they were forced to abandon their homes for fear that they might be hit from any possible indiscriminate firing.

# Leyte highest fish producer in EV for third quarter 2018

TACLOBAN CITY-The province of Leyte has produced the highest volume of fish in the third quarter of 2018, a report from the regional office of the Philippine Statistics Authority(PSA-8),based here.

Wilma Perante, regional director, PSA – 8, said in a press statement that among provinces, Leyte produced the highest volume of fisheries at 9,291 metric tons (MT), comprising 30.1 percent of the total fishery production in the region.

Samar ranked second at 8,447 MT, accounting for 27.4 percent of the region's total fishery production. Southern Leyte, meanwhile, registered 1,222 MT, the lowest volume of production which shared 4.0 percent only.

Perante reported that the fishery production in Eastern Visayas dropped by 11.9 percent, from 35,029 metric tons (MT) in the third quarter of 2017 to 30,865 MT in the third quarter of 2018.

"All provinces registered

decreases in fishery production, except Biliran, the only province that recorded a slight increase of 1.8 percent from its level of production in the same quarter in 2018. Eastern Samar recorded the highest decrease of 25.7 percent, from 7,128 MT in the third quarter of 2017 to 5,294 MT during the quarter in review," Perante said.

Perante also reported that by subsector, the volume of production in commercial fishing went down by 19.5 percent, from 3,755 MT in the third quarter of 2017 to 3,024 MT in the same period in 2018. She added that all provinces registered decreases, except Leyte and Biliran, which recorded increases of 6.6 percent and 4.8 percent, respectively.

Southern Leyte recorded the highest decrease of 66.8 percent, from 264 MT in the third quarter of 2017 to

88 MT during the quarter in review.

Perante said that similarly, the volume of production in municipal fishing (marine and inland) registered a decrease of 12.0 percent, from 20,351 MT in the third quarter of 2017 to 17,919 MT in the same quarter in 2018.

Among provinces, Leyte, Southern Leyte, and Biliran registered growths in production of 5.1 percent, 4.6 percent, and 1.2 percent, respectively.

"However, the increases were negated by the decreases recorded by Eastern Samar (24.9 percent), Samar (13.4 percent), and Northern Samar (5.0 percent)," Perante said.

The volume of production in aquaculture also declined by 9.1 percent, from 10,922 MT in the third quarter of 2017 to 9,923

# DA-8's YRRP implementers to facilitate monitoring of rehab projects

TACLOBAN CITY-

Management officials and staff of the Department of Agriculture (DA) Regional Office 8 involved in carrying out the multi-million agri-fishery projects under the Yolanda Recovery and Rehabilitation Program (YRRP) attended an assessment meeting in a bid to update its newly installed Regional Executive Director on the various DA-led recovery and rehabilitation projects and hear issues and concerns as to the challenges encountered in

the last two-year YRRP program implementation.

In that meeting held on Jan. 22 at the San Miguel Experiment Station, San Miguel, Leyte, DA-8 Chief Director Milo delos Reyes said the purpose of calling the meeting is to remind all concerned to facilitate whatever remains to be done and not to wait for Yolanda Commission to check into the status of Yolandarelated projects which were undertaken by the agency in collaboration with line government

agencies, the local government units (LGUs), farmers associations as well as State Colleges and Universities.

"We should go all out in monitoring these projects, especially in the highly critical areas or provinces and municipalities where we spent the YRRP Funds. We must take this very seriously and let the people and our government know that we are not negligent in our avowed tasks," Director delos Reyes underscored in mixed English and Tagalog languages.

There were at least 73 municipalities in Region 8 severely devastated by Typhoon Yolanda, with grave consequences to its socio-political and economic wellbeing.

However, a decisive action of the government and incessant efforts of the international community enabled the Waray people to recover fast.

DA is one of the government and nongovernment agencies which launched and implemented a comprehensive rehabilitation plan initially called

# **DPWH** starts rehiring of **3.9K job orders in Region 8**

PALO, Leyte -- The Department of Public Works and Highways (DPWH) has started the process of rehiring the 3,900 job order employees after the delayed approval of 2019 budget rendered them jobless for weeks.

Virginia Talde, DPWH regional administrative division chief, said it is up to the regional directors, district engineers, and division heads if they will renew the contracts of all workers employed last year.

"There was no intention not to employ them this year. We're only following department orders. It is possible that we will hire the same number of workers, but it depends on the need as determined by concerned officials," Talde told reporters on Thursday.

She said there's no timeline to complete the rehiring process since the DPWH could hire job order workers anytime of the year as the need arises.

"We need job order because the number of projects has been increasing every year. Without them, we have to do multi-tasking," Talde added.

The regional office is tasked to implement 86 high-impact projects with a total cost of P9.29 billion initially listed in the 2019 National Expenditure Program.

In addition, the DPWH expects to implement more projects from Department of Education for school buildings, Department of Trade and Industry for roads leading to industries, and Department of Tourism for road access to tourism sites.

The regional office and 13 district engineering offices has more than 900 regular staff, four times less than the number of nonpermanent employees.

The rehiring is in compliance with DPWH Secretary Mark Villar's memorandum giving regional directors and district engineers the go-signal to renew contracts of job order workers.

Villar's directive on re-

hiring dated Jan. 7, 2019 was disseminated through a memorandum issued by Regional Director Nerie Bueno issued on January 18.

Concerned on re-enacted budget woes, Villar issued an order last Dec. 17 limiting the number of workers in 2019. The hiring should be 70 percent

# **RPOC chair and Samar Gov.** Tan hopeful elections will be peaceful and orderly

TACLOBAN CITY-Samar Governor Sharee Ann Tan, who is also the chair of the Regional Peace and Order Council (RPOC), said that she is positive that the conduct of the elections in the region would be peaceful.

She, however, stressed that to achieve this, more security forces should be deployed in areas earlier tagged by the Philippine National Police (PNP) and the Commission on Elections (Comelec) as areas of concern.

The PNP and the Comelec earlier tagged 70 villages across the region as areas of concern.

And majority of these areas are in Samar and Northern Samar provinces.

In Samar, these areas are mostly located on its first district.

Gov. Tan said that during their PROC meeting on Wednesday (Jan.23), both the PNP and the

Earlier, members of the elite force of the PNP, the Special Action Force, have been deployed to Samar primarily to battle the rebels and private armed groups.
