Rep. Javier faces falsification complaint filed before Ombudsman

TACLOBAN CITY- Newly-elected Rep. Lolita Karen Javier is facing a complaint of falsification of public document filed by the candidate she defeated during the recently held midterm elections.

The complaint was filed by former congressman Henry Ong of the second congressional district before the Office of the Ombudsman on July 5.

The case of falsification of a public document by a private individual filed by Ong against the congresswoman was in relation to what he claimed to be 'falsified' entries on the certificate of candidacy (CoC) she submitted at the provincial office of the Commission on Elections (Comelec).

In particular, the defeated congressman claimed that Javier claimed that she was a registered voter of Barangay I, Jaro town when she filed her

Javier's voter's registration has yet to be approved by the Comelec.

October 25, Ong said on a statement.



CoC and that indicated on her voter's registration.

"(She) falsely claimed to be a resident of municipality of Jaro for 44 years and two months even her husband was at that time was sitting as mayor of Javier longs to the fifth congres-

Rep. Javier, running for the first time under the banner of Partido Federal ng Pilipinas, defeated Ong during the May 13 midterm elections by more than 27,000 votes.

The newly-elected solon garnered 112,989 votes against Ong's 88,995 votes.

Ong, who ran under the administration's PDP-Laban, was then seeking for a second term.

The Chief Executive lead in the formal inauguration of the P1.5 billion facility sprawled in 8-hectare lot owned by Renucci and his wife Rachel.

Mr. Duterte, in his speech during the event, said that considering what Renucci has done to help the farmers and the agriculture sector in the country by building the state-of-the-art rice complex, he believes he deserves to become a naturalized Filipino citizen.



PPI hails Civic Journalism Community Press awardees



As the print industry continues to face challenges brought about by disruptive technology and innovation and a changing consumer landscape, the Philippine Press Institute shone the spotlight on the best of the best among the community newspapers across the country.

Cebu Daily News bagged three of five major awards for the daily newspaper category for the 2018 Civic Journalism Community Press Awards, namely the Best Edited Community Newspaper, Best Editorial Page, and Best in Photojournalism.

Edge Davao, on the other hand, garnered the Best in Business and Economic Reporting and Best in Environment Reporting awards for the daily newspaper category.

Baguio-based weekly newspapers Herald Express and Baguio Chronicle were awarded the Best Edited Newspaper and Best in Environment Reporting, respectively, for the weekly newspaper category.

Other winners were The Bohol Chronicle for the Best Editorial Page; Cagayan de Oro's Business Week Mindanao for Best in Business and Economic Reporting; and Dumaguete's Metro Post for Best in Photojournalism.

"The industry is being buffeted by dizzying winds of change. Today – as in the past – any technology that accelerates information has the power to disrupt; so it is with the internet and social media...We must adapt to the technology sooner or later if we are to survive. We have to be realistic that this world has changed and adapt to the reality on the newly-elected ground," PPI chairman and Manila Standard publisher Rolando Estabillo said.

Despite the challenges, Estabillo said newspapers, especially community papers, have the responsibil-

ity, more now than ever, to continue reporting on issues that have direct impact on Filipinos.

Speaking on behalf of the winners, Dexter See of Baguio's Herald Express acknowledged as much: "It takes hard work, and involves pure sacrifice and passion for the job. That's why we are here."

Soldier killed inside a hotel by a woman companion in Catbalogan City

TACLOBAN CITY- A soldier was shot and killed by a woman after they reportedly engaged in a fight over a gun while they were inside in a hotel room in Catbalogan City, Samar province, Sunday (July 7).

Reports reaching the regional headquarters of the Philippine National Police (PNP) based in Palo, Leyte, said that the soldier, identified as Private First Class Camelo Batoctoy, 31, married and member of the band company of the 8th Infantry Division, based in Catbalogan City, was shot by an 18year old woman, Sheila de la Cruz, whom he met in a disco bar prior the incident.

The two checked in at Fame Hotel, also in the city, at around 3 am and at about 6:20 am, de la Cruz asked

the victim that she would

like to return home in Brgy. Bagacay, Hinabangan town, also in Samar.

But the soldier, a resident of Brgy. Maulong, also in Catbalogan City, reportedly refused and instead drew his firearm towards the woman which resulted for the two to fight.

The gun reportedly went off, hitting the victim's face which resulted to his instant

The suspect immediately ran out of the room and asked help from a ho-

In turn, the hotel staff called the local police, and led by Major Romelito Sorilla, immediately went to the area of the incident.

The woman is now in the custody of the Catbalogan city police for further investigation.

Reopening of Ormoc City Airport will result to more tourists coming to the city and neighboring areas, says Tiopes

ORMOC CITY - The reopening of the Ormoc City Airport will open door for the development the tourism industry of this city and its neighboring areas which are part of the so-called Northwest Leyte Tourism Corridor.

President Rodrigo Duterte formally opened the Ormoc City Airport on July 5 and joined by Department Transportation(DoTr) Secretary Arthur Tugade, Senator Christopher 'Bong' Go, Presidential Assistant to the Visayas Michael Diño, Civil Aviation Authority of the Philippines(CAAP) Director General Captain Jim Sydiongco, Leyte Rep. Lucy Torres Gomez(4th district), and Ormoc City Mayor Richard Gomez.

Karina Rosa Tiopes, regional director of the Department of Tourism (DOT), said that with the opening of the city airport, tourists need not used the Daniel Z. Romualdez (DZR) Airport in Tacloban, about two hours away from

Thus, she said, areas within the Northwest Leyte Tourism Corridor would now be accessible to tourists, she said.

"Access and connectivity is really crucial for Philippine tourism because we are an archipelago," Tiopes

"A new airport that can service wider aircraft is a positive development for us because this means that we now develop a new connectivity with a new gateway in the other side of Leyte that will service the tourism side in part of Northwest Leyte," the tourism regional director added.

Most of the popular tourist destinations Leyte are located on its north-

Among these are the Lake Danao, Tongonan Hot Spring and Alto Peak, Kalanggaman Island, and Cu-

Except for a flying school, the airport has yet to accommodate commer-

cial airline since December, 2018 due to low traffic.

The Ormoc City Airport sustained major damages due to the devastation of super typhoon 'Yolanda' in 2013 and a major earthquake four years later.

The national government through the DOTr allocated P34-million for the rehabilitation of the terminal building and another budget worth P82-million was allocated for asphalt overlay of runway and another P55-million for runway widening project which is expected to be completed by 2020.

Sec. Tugade said that target of their agency and CAAP to make the airport a night-rated before the end of President Duterte's term.

A night-rated airport is capable of launching and receiving flights at night, allowing the facility to accommodate flights even nighttime, resulting for more travel option.

"The promise of our aviation sector is before our

President's term ends, this airport will be night-rated," Tugade said.

Rep. Gomez welcomes this announcement of Sec. Tugade saying that she is very happy for the national government action of her constant request to rehabilitate the city airport and to make the facility capable

of night flights. "That is why Sec. Tugade is one of our favorite secretaries because he is always sincere in helping and he always has good news with him," Rep. Gomez said.

Gomez added that with the reopening of the city airport, their next step is to invite airline companies to operate in Ormoc.

"It is always part of the plan. It will energize the economy and people who are from the city and its neighboring areas will no longer have to travel to Tacloban because we have an operational airport in Ormoc," the lady solon said. (ROEL T. AMAZONA)

Extant fire cases

ccording to some authorities, the proliferation nowadays of cheap electronic and electrical products from China has contributed to the unabated fire cases especially in congested

squatter areas in big towns and cities throughout the country.

We have now entered into the frequently rainy months, but these cases of fire that are swallowing residential districts still remain as though we are yet in the hot, summertime. Of course, there are the usual causes of fire like faulty electrical wiring, etc., but these cheap products that people resort to buy had likewise become a frequent cause of these fires.

Extension cords from China, to name a sample, look reliable because they look big, but if you examine the metallic content inside, it is so tiny that, when bigger and more appliances are plugged in to that thing, the cord gets burned and if no one could unplug it at once, it will eventually create fire in the house that could spread wildly to the neighbourhood.

This must caution our people. Stop buying those cheap products only for reasons of their affordability. They do not last, anyway. They are deceptive, of worst quality, and by-products of dishonesty. Besides, your house and all your appliances may all burn down to ashes if those inferior products would erupt into wild fires. Better yet, boycott all these China products; they are just capturing our cash, not at all after our consumer satisfaction.

As we continually cherish and promote these products, we do not just risk our homes with fire, we are also all the more enriching a country that is bullying us and draining our marine resources at the West Philippine Sea.



Talutang

Calling any of our family members nowadays has become easier with communication gadgets like cellphones, tablets, and laptops. All you need is a sufficient load, wifi signal, and of course, a similar gadget at the hands of the household member you are communicating to. These have become basic essentials to our daily communication.

The above title, which is a name of an object, equally served as a communication device before, or even until now, but it must sound rather strange to many, especially to urban folks. That's not surprising because talutang, for your information, was not just an ancient tool—it was also exclusive to remote areas where houses are so distant from one another, being separated by hills, valleys, and mountains.

In these locations telephone signals, and other communication advancements, people had devised means to communicate to their distant loved ones so as not to strain their vocal chords by shouting uselessly to the top of their voices when calling them. One of these indigenous inventions was the so-called talutang, which was made of huge bamboo trunks cut into smaller seg-


Talutangs didn't have keypads, or chargers. With both ends

naturally closed by that part called buko, this bamboo segment was crafted with an elongated hole about one inch wide. Then that, up to now, are a string is attached to deprived of electricity, one end from which this talutang would hang, usually outside the window. A short wooden stick would then be used to hit it so it would create a sound, just like a bell. The harder you hit it, the louder it sounds it could actually be heard even from the other side of the mountain or from the distant valley below.

Since they did not make the same pitch, each talutang in every household had a different sound. Fam-

love, everything becomes meaningful and is pursued with a passion. The small and ordinary things of the day become very significant. There is never a dull, monotonous moment in the daily routine.

And while one's usual daily task would only involve small and ordinary things, he is also ready to take on big, extraordinary things when the need arises. In fact, when one is truly in love, he will not allow himself to be trapped in some kind of routine, but will always take the initiative to look for other tasks and challenges if only to do more good to everyone. He would always be inventive and creative.

He is not afraid of the effort and sacrifice that may be involved. He would do all this without expecting any reward, or even an acknowledgment. would do them simply because he wants to do them, he wants to give himself. No special reason is needed other than sheer goodness.

Where there is true love, not even problems, difficulties and misunderstanding, failure, rejection, etc. would detain him from his total self-giving. He would just be game whatever the outcome of his love-driven initiatives would be. In fact, tackling the sacrifices and suffering involved can only mean the authenticity of his love.

Of course, to be truly in love means one should have the same attitude God has toward

WHERE there is true his creation, especially toward us. We know that God is love. (cfr. 1 Jn 4,8) He is full of goodness. He went all the way to offering his life on the cross.

> Even if his love is not reciprocated and is in fact rejected, he continues to love. It does not really matter to him if he is loved in return by us or not. He will continue to love us. Because of this kind of love, God will offer forgiveness for everyone and will do everything to bring us back to him, no matter what the cost.

This kind of love is dramatized precisely in full by Christ who offered his life on the cross for us, for our salvation. "Greater love has no one than this, that he lays down his life for his friends." (Jn 15,13)

And he wants this kind of love to be our love for him and for one another. In fact, he commands us to do so. "This is my commandment, that you love one another as I have loved you," he said. (Jn 15,13) And he continued, "You are my friends if you do what I command you." (Jn 15,14)

It's quite clear then what exactly would cement our friendship with Christ—if we know how to love one another as he himself loved us, a love that goes all the way to offering one's life for his friend. We obviously have to prepare ourselves to reach this ideal and goal, especially disciplining our thoughts, memory, imagination, emotions and passions, so that they conform to the standard set forth by Christ himself.

District Engineer Gerald Pacanan said that a total amount of P188.487 million has been allocated for these projects funded under the General Appropriations Act of 2019.

"The key messages of the month-long celebration are to have a one hour or more physical activity every day, reduce screen time to two hours or less each day, and eat the three food groups every day for variety," Dotollo said.

DPWH kicks off construction of 2019 infra projects in Leyte 2

CARIGARA, Leyte – The Department of Public Works and Highways (DPWH) Leyte second district engineering district has already started construction of the various infrastructure projects under the 2019 General Appropriations Act (GAA).

According to Gerald Pacanan, DPWH Leyte II District Engineer, implementation of the 2019 projects was delayed due to late approval of the annual budget.

President Rodrigo Duterte signed the national budget on April 15 with some vetoed items including the P75 billion insertions applied by congressmen covering public works

For this fiscal year, Leyte 2 is tasked to implement 87 projects worth P1.57 billion covering road and bridge improvement projects and construction of other government facilities.

Of which 21 of these projects are already ongoing which include 2

major road rehabilitation, 4 bridge widening, and 15 barangay road projects.

"We strictly require contractors to immediately start the project upon receiving the notice to proceed. This is because we want to avoid further delays and for them also to finish the project within its time duration," Pacanan said.

Meanwhile, among the high impact projects that the department will implement are the P50 million(M), P73.5 M, and P89.8 M road rehabilitation ects along Jaro-Dagami-Burauen-La road, P92.8 M Ibawon bridge in La Paz town, P100 M road pavement project along Burauen-Mahagnao road, P93.9 M road improvement works along Palo-Carigara-Ormoc road and also along this road network is implementation the P179 M road widening projects.(PR)

He said that in terms of agriculture development, Southern Leyte can easily be considered as one, if not, the most progressive province in the region.





In compliance of Helmet Law Mayor Uy asks traffic enforcers to also use helmet

CATBALOGAN CITY - Local traffic enforcers of this city, who are mandated in the enforcement of traffic laws, should set the example in obeying the laws.

Thus said Mayor Dexter Uy who said that he received information and complaints that there are traffic enforcers who are not following the law for motorists to use helmet.

"Under my administration, I will not tolerate law enforcers who doesn't know how to follow the law," Mayor Uy said.

The provincial office of Land Transportation Office(LTO), Samar Provincial Police Office and the Catbalogan City Police Station started the strict implementation of Republic Act (RA) 10054, or the "Motorcycle Helmet Act of 2009," mandating all motorcycle riders to use helmet.

Those apprehended for not wearing the standard protective motorcycle helmet will be fined

from P1,500 to P10,000, depending on the number of offense committed and confiscation of the driver's

"I hope that you will abide the law because there is nothing wrong with doing what the law says," Mayor Uy said.

The wearing of helmet was implemented in Catbalogan City effective July 1, this year.

Police Colonel Dante Novicio, police provincial director, said that motorcycle owners and riders should follow what the rule prescribed on what kind of helmet they should wear.

"Motorcycle should wear the prescribed helmet and not just any kind of helmet they want. A helmet used for biking should not be used when using a motorcycle. That is not allowed by law; in fact, we have the national standard," Novicio said.

"Motorcycle should be wearing the full faced helmet and not the helmet that only covers half-part of their head. Especially those who are doing long travel, they should wear that the law prescribed," the police provincial director said.

Although using a half-faced helmet will be allowed as this kind of helmet is not expensive, Novicio said that he would still suggest motorcycle riders to use what the law

EVCAA season 2 to include volleyball

TACLOBAN CITY-Buoyed by its smashing success in the inaugural season thru men's basketball, the Eastern Visayas Collegiate Athletic Association (EVCAA) gears to expand its events in Season II.

In the upcoming season, men's caging remains on board, but this time the Management Committee (ManCom) is setting its sights in a sport which is also close to the hearts of sports fans - volleyball.

Just recently, the EV-CAA ManCom held a preliminary meeting where important details and concerns for the collegiate volleyball tourney were tackled among the stakeholders.

Present during the meeting were men's hoops commissioner and incoming executive director Julius Ross Lacaba, incoming volleyball commissioner Karl Chan and sports directors of the different state colleges and universities in the region.

The schools that sent their representatives were Eastern Visayas State University, Leyte Normal University, Visayas State University, Biliran Province State University, Samar State University, Northwest Samar State University and Palompon

Institute of Technology.

Although their sports directors were not able to attend, Southern Leyte State University and University of Eastern Philippines sent a word that they are very interested to join the league.

The ManCom is also planning to meet with some private schools who are interested to join the first and only collegiate league in Region 8.

During the meeting, it was learned that in the regions, including Eastern Visayas, men's volleyball is more competitive than the women's side, contrary to the situation in Metro Manila where women's volleyball is more popular.

Thus, the ManCom is tinkering with the idea of putting up a regular volleyball tourney for men, just like with the men's basketball in season II.

However, women's volleyball will not be put in the backburner as plans have it that a tilt for them will be held also, albeit on a smaller scale.

The initial plan is for the men to have a regular tourney and a pocket competitions for women.

The 2nd season of EV-CAA is slated to open in early September with volleyball as its first offering.

On the other hand,

men's basketball blasts off on late January or early February next year wherein the EVSU Eagles will defend their crown.

Games for both volley-ball and basketball will be aired live thru PRTV-Tacloban.

Netizens may watch it via live-streaming on social media.

Tingog party-list, which copped it's first ever seat in Congress, is the principal backer of EVCAA.

Tingog envisions EV-CAA to be the premier sporting league in the region that will serve as a platform or breeding ground for future sports stars.

help my fellowmen. Kaya I feel like almost maybe sentimental now because I've seen the complex that you have built for my countrymen," he said.

And addressing to Calida, the President said:" Di ba may administrative yan? Well, kindly work on it because actually Patrick is very much willing to become a Filipino citizen. And if we can do that in a jiffy, hurry up," he said.

The President even said that he is even willing to 'cut corners' and just issue an executive order.

Then, he added that if Renucci eventually become a naturalized Filipino citizen, he might just name him at his Cabinet.

"Maye I'll try-experimental lang naman. If he becomes a naturalized citizen, then I think he is qualified to be a member of the Cabinet. Then I can maybe ask Sir Patrick that you join us and help us because it's really agriculture," the President said.

Renucci and his wife came to the country, particularly in Leyte, in 2015, two years after the province was devastated by super typhoon 'Yolanda.'

According to the couple,

whose been living in Europe, they decided to put up the facility to help farmers, in particular have sustainable livelihood, as they were the most affected by the disaster as they noticed that there were several arable lands but the farmers were lacking of assistance and skills to improve their

living condition.
