# Leyte now under state of calamity due to dengue fever

TACLOBAN CITY-The province of Leyte was placed under state of calamity on Friday (July 19) amidst the increasing number of dengue fever cases.

As this developed, the regional Department of Interior and Local Government(DILG) has called all local government unit officials down to the villages to step up their campaign against the mosquitoes-causing ailment in order to contain the increasing number of dengue fever in the region.

With the declaration, the provincial government and all its municipalities, to include Baybay City, could now use part of their calamity funds to procure needed medicines and fogging machines to combat the mosquito-causing ailment, Board Member Raissa Villasin, who sponsored the resolution, said.

The declaration was made through a resolution passed by the members of the Sangguniang Panlalawigan upon the request of Governor Leopoldo Dominico Petilla.

As of July 12, the province has about 1,747 cases of dengue fever with six deaths.

The number does not include those of Tacloban and Ormoc cities being highly urbanized and independent charter cities respectively which made them administratively independent from

# 54 Samar villages tagged as priority in anti-NPA drive

TACLOBAN CITY- The Philippine Army has initially identified 54 villages in the Samar provinces as priorities for the delivery of needed projects and services by the newly-created regional task force on ending insurgency.

Brig. Gen. Eliezer Losañes, assistant commander of the Philippine Army's 8th Infantry Division, said that government agencies should immediately address the concerns of these communities to counter the influence of the Communist Party of the Philippines - New People's Army (CPP-NPA).

"We have submitted the first batch of barangays (villages) and the corresponding issues that should be addressed by different clusters. We believe that we cannot end insurgency with just military operations. It needs whole-(of)-nation approach," Losañes told task force members during a workshop at the office of the National Economic Development Authority (NEDA).

Of the 54 areas, 28 had been threatened by the terrorist group while 26 are vulnerable to armed struggle.

These villages are located in Can-avid and Dolores in Eastern Samar; Calbiga, Pinabacdao, Basey, San Jose de Buan, Gandara, Matuguinao, and Calbayog

City in Samar; Las Navas, Mondragon, Lope de Vega, and Catarman in Northern Samar.

Government troops have come up with a list of needs through their community support program, an initiative of the military to facilitate the government's development programs by hearing issues and concerns of villagers and bringing them to the attention of concerned government offices.

Among the issues raised were land titling, poor infrastructure, absence of water and electricity, poor health services, poor irrigation system, classroom shortage, lack of livelihood opportunities, poor access of farmers to market, high farming production costs, lack of toilet facilities, absence of post-harvest facilities, political discrimination, and the very low price of copra.

The list of specific areas and issues had been provided to concerned government agencies, which are members of the regional task force on ending local communist and armed conflict.

"Resolving these issues requires more resources. We cannot execute everything since there are long-term projects where other agencies are mandated to implement. The Philippine Army has no capability to solve all of these," Losañes

said.

The army official reminded government agencies to immediately act on these concerns to completely put an end to insurgency in Samar Island.

"If the government fails to deliver what is expected, it would be an opportunity for (the) NPA to find fault and encourage people in upland areas to join the rebellion," he added.

Director of NEDA 8 (Eastern Visayas) Meylene Rosales was upbeat that through convergence efforts by the task force, the region would be able to resolve the decades-long insurgency.

"Peace and order should have tailor-made solutions with all government resources available. We were told to realign budget this year and propose a new budget for next year to attain our goals," Rosales said.

The formation of the regional task force operationalizes Executive Order 70 issued by President Rodrigo Duterte on Dec. 4, 2018. The directive also institutionalizes a whole-of-nation approach in attaining an "inclusive and sustainable peace."

Patterned after the national task force, the regional body is composed of heads of local offices of the departments of the

# Leyte residents complain on the operation of poultry farm

CAPOOCAN, Leyte – Residents of a village in this town are complaining on the operations of a poultry farm saying it's becoming a health hazard to them.

The residents of Barangay San Joaquin claimed that they have made their complaint against the owner of the A&E Farm but to no avail.

Antonio Aragon, a resident of the village whose house is located few meters away from the poultry farm, said that their health are now affected.

"It poses health risk to us. We can't eat well during harvest time because of flies swarming our houses and our food," he said.

His neighbor, Danilo Malicabul, added that the flies are even infesting his farm located in adjacent mountain.

He added that the waste water of the poultry farm pollutes the creek down the mountain that is used by residents for bathing.

The residents said that they felt that they

were deceived because when the poultry farm was being constructed two years ago, they were told by the workers that were constructing a hospital

The owner of the said poultry farm is said to be a well-known political figure in the province reason why their complaints are not being acted upon, the residents

An employee of the poultry farm, who did not gave his name, asked for an appointment from Leyte Samar Daily Express before they could answer any questions relative to the complaints of the residents.

Rosie Quilarto, village chairwoman, said that she already visited the poultry farm twice after they received complaints from the residents and were shown some mitigation measures purportedly put in place by the management, mainly to stop the fly infestation.

But obviously, the measures did not help contain the problem as the village continue to

be swarm with fly infestation, especially during harvest time.

Quilarto added that the council cannot make any action against the problem because they had not yet received a formal complaint from any of the residents.

Leyte Board Member Raissa Villasin, who represents the 2nd district of Leyte where Capoocan town is included, asked the residents that if the barangay leaders failed to take action on their problem, they should elevate their complaint to the municipal level before they in the provincial board can take action and conduct any possible investigation.

"The board cannot just supersede the power of the barangay and the mayor. That is why, the residents should file their complaint first in the barangay level and in the municipal level before we can take action by conducting an investigation in the provincial board if the two offices cannot make action," she said.

# Groups stage protests on 'failure' of the Duterte administration

TACLOBAN CITY-Various progressive groups based in the city staged their protest rally against President Rodrigo Duterte who delivered his 4th State of the Nation Address (Sona) Monday.

Serving as the highlight of the protest, attended by about 500,000 rallyists as estimated by the organizers, was the burning of the effigy of Mr. Duterte placed in a cartoon-made boat, representing the issue surrounding the dispute between the Philippines and China on the South China Sea.

The protest rally started at 1 pm at Noblejas Junction, named after a popular local radio commentator Ramon 'Monching' Noblejas who was gunned down on October 4, 1987, and ended along P. Rizal Avenue.

Speakers after speakers denounced the Duterte administration claiming its failure to deliver 'genuine and propoor' programs.

"The rice tarrifica-

tion, for example, only rendered the poor farmers poorer as rice traders now choose to buy imported rice, leaving behind the local farmers," Jun Berino, secretary-general of Sagupa(Samahan han Gugti na Parauma)-Sinirangan Bisayas said, citing one of the laws passed under the Duterte administration which they called as among the anti-poor

Berino also cited the modernization of public transportation as anti-poor measure and the administration's failure to fully enforce its anti-contractualization.

measures.

"Poverty incidence in Eastern Visayas remain to be widespread," he said.

Meantime, a full alert status was declared by the Philippine National Police (PNP) across the region on Monday as part of the security preparations as the Pres. Duterte delivered his 4th Sona.

Police Brigadier General Dionardo Carlos, police regional director, said that 900 policemen were deployed as part of the

security measures.

Carlos told reporters that in line with the declaration of full alert status, all personnel were required in attendance and be ready for any maximum deployment as Reactionary Standby Support Force (RSSF).

Police Provincial Offices (PPOs), City Police Offices (CPOs) and Regional Mobile Force Battalion were directed to intensify simultaneous checkpoint operations in all strategic areas especially to vehicles transporting significant number of persons without clear purpose.

Police Colonel Warren de Leon, force commander of Regional Force Battalion 8 said that their unit was ready for the deployment of personnel.

"We provided standby civil disturbance management platoon led by a Police Commissioned Officer and our companies are already conducting checkpoints in their respective area of responsibilities," he added.

# Couple hit in their heads in a shooting incident in Leyte town

TACLOBAN CITY-Four people, two of them were children, were shot by still unidentified armed men while they were on board a vehicle on Sunday (July 21) at about 6 pm in Jaro, Leyte.

Two of the victims, Leopoldo Po, 44 and said to be a businessman, and his wife Ailen, 40 and a teacher by profession, are now in critical conditions after they were hit in their heads, Captain Arnel Saremgumba, police chief of Jaro town, said

The other victims, Estrella Geraldo, 62 and a village chairwoman of San Pedro, Tunga town, also in Leyte, and Rachel Cuña, 27, were hit at the lower back of their bodies but are now in stable conditions.

Geraldo's husband, Wilfredo, 62, and Cuña's children, Estefanie, 6, and Sheena, 4, were unharmed.

Capt. Saregumba, in a phone interview, said that the victims, on board a Suzuki Ertega, were heading to Tacloban City from their village of San Pedro, Tunga town.

And while cruising Barangay Hibucawan, two kms away from Jaro town proper, they were chased by the still unidentified suspects who were also on board a vehicle and shot



them several times.

This resulted for the vehicle, driven by Leopoldo Po, to fell on a bridge, as he lost control of the steering wheel.

The Po couple were hit on their heads while Geraldo and Cuña were hit at the lower back of their bodies. Both are said on stable conditions.

The rescuers of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) who responded to the scene

brought all the victims to the hospital at the region's capital.

Saremguba said that they have yet to unmask the suspects and their motive.

"We are still conducting our probe on the incident," he said.

Recovered from the crime scene were two deformed fired cartridge cases that were turned over to regional police headquarters for ballistic examination. (ELVIE ROMAN ROA)

# Young Philippine eagle found in Eastern Samar forests

TACLOBAN CITY- A young Philippine eagle was rescued last month in Maslog, Eastern Samar and is now under the care of the Philippine Eagle Foundation Center in Davao City to determine its physical condition.

The Philippine eagle, believed to be just three year old, was found inside a chicken trap in a deep forest in Barangay Carayacay, Maslog town on June 17 of this year, the regional office of the Department of Environment and Natural Resources (DENR) said.

On that same day, Maslog Vice Mayor Septemio Santiago reported the discovery of the Philippine eagle (Pithecophaga jefferyi) to the Community Environment and Natural Resources Office (CENRO) based at the nearby town of Dolores, also in Eastern Samar.

Immediately, upon learning on the rescued

eagle, a team from the regional DENR office went to Dolores to conduct initial assessment on the eagle, which they named as 'Maslog E.S.,' referencing the town and the province where it was recovered.

"Sightings of the Philippine eagle is extremely rare and protecting them is a challenge," Crizaldy Barcelo, DENR regional executive director, said.

The rescued Philippine eagle, while said to be in good condition, was brought to the Davao Citybased Philippine Eagle Foundation Center on June 26 for further examination.

Maslog E.S will be released back to its natural habitat in the forests of Maslog town, a remote town in Eastern Samar, once it's declared to be in complete good physical condition.

Barcelo said that the discovery of the said eagle confirms the 'presence of

this critically endangered species in Eastern Samar.'

"Its presence in our region is a testament that we still have healthy forests which we need to sustainably manage and protect,"

he said.

A Philippine eagle was last seen in the forests of Calbiga, Samar and Taft, Eastern Samar in September 2014.

In 2013, a Philippine

eagle was spotted near the boundaries of Baybay City, Burauen and Albuera, all in Leyte province and Silago, Southern Leyte, months before super typhoon 'Yolanda' struck the region. Hunting of the Philippine eagle is strictly prohibited under the Philippine Wildlife Conservation Act of 2001 (Republic Act 9147) with penalties of up to 12 years imprisonment and a fine of up to P1 million.

The Philippine eagle was officially declared as the country's national bird in 1995 by President Fidel V. Ramos.

It is endemic to the Philippines and can be found in the islands of Eastern Luzon, Samar, Leyte and Mindanao.

The Philippine eagle is one of the DENR's priority threatened species for conservation and is listed as "critically endangered" per DENR Administrative Order No. 2004-15 on the list of terrestrial threatened species and their categories and under the International Union for Conservation (IUCN). had not absorbed powerto his head and body over those years are taking their tolls on Manny that, after a few more fights, he indeed must retire for good.



### Indigenous plants as alternative food colorant

The Philippines location in the tropics has the advantage of being home for various species of plants, animals and microorganisms. The present column shall deal mainly on the many uses of terrestrial/ land plants. While the primary and popular usage of plants are as food, both processed and unprocessed, one other use is as food and textile coloring source.

Non-tropical countries with fewer species of land plants as source of food coloring, resort to the use of artificial coloring materials, which may have toxic effect if not thoroughly tested or the process used in the usage of chemicals are not validated in the laboratory. While the use of artificial food colorants are meant to make the food "more delectaproduct ble and mouth-watering. . . . unfortunately, some of

them are actually harmful to the body.

A team of UPLB-Institute of Biological Sciences researches with funding support from the Bureau of Agricultural Research (BAR), undertook a project aimed at ". . .. Providing the public a healthy and safe alternative to artificial food coloring using indigenous plants."

The aforementioned identified study "screened over 20 indigenous plant species among them included alugbati, lipote, duhat, gumamela, roselle, butterfly pea, pandan. Turmeric, barberry, kamantigi begonia, mayana leaf, bougainvillea, talinum, oxalis, impatients, portulaca, nasturtium, and bell pepper." The researchers screened the plants using the following criteria: toxicity, tinctorial strength but with minimal or without imparting any flavor or aroma, availability

of the raw materials and ease of handling, mutagenicity and stability of the pigment under different pH, temperature, and light regimen. Also, considered were the pigments solubility in water and demand of a particular color in the market.

Going over the 20 indigenous plants would show that most of these are found in Leyte and in the 6 provinces of Eastern Visayas though known by their waraynon local names. In other words, such a research undertaking could have been easily undertaken and conducted in Region 8. All that are needed would be a plant taxonomist to identify the plants, a chemist to extract and analyze and test pigments present, a decent working laboratory and a modest library. Very importantly, too, is encouraging the younger Eastern Visayans to embrace and tow the line along science and technology. This will happen if more science teachers are research-oriented, lead in conducting research activities - it being one of CHED's four-pronged mandates.



## No Rematch for Pacquiao

Everybody saw Manny Pacquiao won his World Welterweight title against Keith Thurman by scoring a narrow but thrilling decision over the previously unbeaten Thurman at the MGM Grand, Las Vegas, Nevada.

Pacquiao proved that at 40, he still has the speed, power and stamina that made him a great boxer. He knocked down Thurman late in the 1st round with a left to the body and a right straight to the face. That knockdown proved to be the key to his victory. If not for that knockdown, the fight could have gone either way or could have ended in a draw. It was a split decision meaning, it was a close fight.

If I were Coach Freddie Roach, he will not allow anymore a rematch fight with Keith Thurman. Thurman is young and strong, he's very tough and a heavy puncher. He proved that he is tough. He is an opponent you cannot underestimate.

# NEDA panel OKs cost increases in Mindanao railway, MM bridges

MANILA - The National Economic and Development Authority Board's Investment Coordination Committee-Cabinet Committee (ICC-Cab-Com) on July 10, 2019 approved changes in two ongoing projects.

NEWS

These include the increase in cost for the Mindanao Railway Project Phase 1-Tagum-Davao-Digos Segment (MRP-TDD), and the implementation extension of the Metro Manila Priority Bridges Seismic Improvement Project.

For the MRP-TDD, the project cost increase amounting to PHP82.9 billion—from its previously approved cost of PHP35.9 billion in 2017—will cover changes in cost of structural and construction works, among others.

In terms of scope, the ICC-CabCom also approved the additional Davao Satellite Depot of the MRP-TDD.

For the Metro Manila Priority Bridges Seismic Improvement Project, the cost increases to PHP7.9 billion from PHP4.3 billion will cover the changes in construction technology to be applied to the Guadalupe Bridge, putting up of temporary detour bridges in Guadalupe, and additional work shift to reduce the construction period, among others.

In addition, the implementation extension of one year and eight months until August 2023, inclusive of a one-year defects liability period, will help the project catch up with its target completion date.

The ICC-CabCom also noted the inclusion of the Project Management Consultant with a cost of PHP14.39 billion, inclusive of VAT and contingencies, in the scope of works for the PNR South Long-Haul Project.

"We see changes in scope and cost as opportunities to optimize the project components and update the estimates. The Government aims to speed up implementation while ensuring quality," said Socioeconomic Planning Secretary Ernesto M. Pernia, who co-chaired the meeting with DOF Secretary Carlos

Meanwhile, it was reported in the same meeting that the NEDA Board confirmed ad referendum the ICC-CabCom approval of changes in three projects, namely:

Tuesday, July 23, 2019

1. Implementation of extension and loan validity extension of the Central Luzon Link Expressway (CLLEX) Project, Phase I of the Department of Public Works and Highways.

2. Change in project cost and scope of works and extension of loan validity and implementation duration of the National Irrigation Sector Rehabilitation and Improvement Project (NISRIP) of the National Irrigation Authority.

3. Change in project scope and loan validity extension of the Metro Manila Wastewater Management Project (MWMP) of the Land Bank of the Philippines.

These latter changes had been approved by the ICC-CabCom on May 17, 2019. (PR)

#### APPLICATION

APPLICANT LEYTE II ELECTRIC COOPERATIVE, INC. (LEYECO II), through counsels, unto this Honorable Commission, most respectfully alleges, that:

1. This application pertains to the emergency acquisition, installation, testing and commissioning of One (1) Unit 20 MVA Power Transformer and Accessories at the Sagkahan Substation of LEYECO II amounting to P24,890,000.00 to be financed by the LEYECO II from its existing Reinvestment Fund for Sustainable CAPEX (RFSC).

#### THE APPLICANT

- 2. LEYECO II is a non-stock, non-profit electric cooperative, duly registered, organized and existing under and by virtue of Presidential Decree No. 269, as amended, with principal office address at Real St., Sagkahan District, Tacloban City, Leyte, Philippines;
- 3. LEYECO II holds an exclusive franchise, issued by the National Electrification Commission, to operate an electric light and power distribution service in the City of Tacloban (with 138 Barangays) and in the Municipalities of Palo (with 33 Barangays) and Babatngon (with 25 Barangays), all in the Province of Leyte. A copy of the **Certificate of Franchise** is hereto attached and marked as **ANNEX** "A".
- 4. LEYECO II is duly represented by its General Manager Engr. Fernan Paul R. Tan per **Board Resolution No. 127-07-2019.** A copy of which is hereto attached and marked as **ANNEX "B"**.
- 5. LEYECO II engaged and authorized the undersigned counsels to file the instant case per **Board Resolution No. 115-07-2019.** A copy of which is hereto attached and marked as **ANNEX "C".**

#### LEGAL BASES OF THE APPLICATION

- 6. The instant application is based on the *Amended Rules for Approval of Regulated Entities' Capital Expenditure Projects (Capex Rules)* adopted per Energy Regulatory Commission (ERC) Resolution No. 26, Series of 2009.
- 7. The issuance of the foregoing rules was also based on Section 43(f) of Republic Act No. 9136 otherwise known as the Electric Power Industry Reform Act of 2001 or the EPIRA, provides that any significant operating costs or projects investment of the National Transmission Corporation (TRANSCO) and Distribution Utilities (DUs) which shall become part of the rate base shall be subject to verification by the Energy Regulatory Commission (ERC) to ensure that the contracting and procurement of the equipment, assets and services have been subjected to transparent and accepted industry procurement and purchasing practices to protect the public interest.
- 8. Section 3.4 of the aforesaid Capex Rules defines "emergency capital expenditure" as projects that require immediate implementation during an event other than those enumerated and covered by the definition of a force majeure, or fortuitous event in order to maintain safe, reliable, secure and efficient operation of the power system.

#### STATEMENT OF THE FACTS

#### LEYECO II 2018 OPERATIONAL FACTS

- As of December 2018, LEYECO II has 143 Regular Employees, classified by the National Electrification Administration (NEA) as an AAA electric cooperative, with 65,616 Consumer Base.
- 10. The *Total Membership* of the cooperative is 80,352 (Tacloban City 57,778; Babatngon, Leyte 16,853; Babatngon 5,721). The Household Connection is 70,911 (Tacloban City 50,168; Palo 14,999; Babatngon 5,744). The Growth Rate of membership is 10.9%.
- 11. Moreover, membership is composed of 90.63% Residential, 9.26% Low Voltage and 1% High Voltage Customers.
- 12. **Peak Demand** of LEYECO II already reached 49,389 kW as of December 2018. Recorded *System Loss* for 2018 is 5.95%. kWh Purchased in 2018 is 259,987,556 and kWh Sold is 243,614,280.

#### ANTECEDENT FACTS

- 13. Before the year 2018, LEYECO II and its customers recovered from the devastation caused by Super Typhoon (ST) Yolanda on November 8, 2013. After the typhoon, it was only in 2016 (or about 3 years after the typhoon) that LEYECO II was able to reach back to its pre-Yolanda peak demand of 41 MW.
- 14. The Capacity of LEYECO II is 60 MW since the year 2014. This 60 Megawatt Capacity is distributed in 3 Substations as follows: 20 MVA Campetic, 20 MVA Abucay and 2-10 MVA Sagkahan. The 20 MVA Campetic Power Transformer replaced the old 10 MVA Power Transformer in 2014.
- 15. Prior to ST Yolanda in 2013, the Peak Demand (MW) and Load Growth of LEYECO II was as follows:

16. The recovery period took time considering the extent of the devastation caused by the typhoon. As shown in the table below, the year 2014 was considered as the recovery period which extended even to 2016. It was only in the year 2016 that the 41 MW Peak Demand was reached

- 17. After reaching the 41 MW mark in 2016, LEYECO II forecasted that the growth rate would gradually slow down and return to the normal rate of 2%.
- 18. However, the growth rate in 2017 was still unusually high and even increased further in 2018. LEYECO II did not anticipate the unprecedented growth after reaching the 41 MW level of capacity. As reflected in the table above, the *peak demand's* average percentage growth from

- 2015 to 2018 is 9.59%. Apparently, this unusual growth is a reflection of the significant increase of industrial and commercial activities within the coverage area, including the establishment and operation of new malls, hotels and hospitals.
- 19. This unusual growth placed the 60 MW capacity level of LEYECO II in critical level in 2018. The following table shows the critical capacity and load levels of the 3 substations based on the May 2018 data, to wit:

- 20. Forecasting model was based on the 3 year historical data starting 2015 considering that it was in this year after the ST Yolanda that the operation of the cooperative normalized, with the exception of the load growth. It was noticed then that the usual 2% annual growth used in forecasting before is already **inapplicable** to LEYECO II.
- 21. Based on the forecast, the present demand of LEYECO II has surpassed the results and is now showing a minimum of 2 MW annual load increase. Apparently, 2 MW spot load is added to the results of the selected forecast to reflect the present demand scenario of LEYECO II.
- 22. With the fully loaded LEYECO II distribution system, one of the 10 MVA power transformer in Sagkahan Substation was permanently damaged and was immediately replaced with the standby 10 MVA power transformer. Upon replacement, the total load of the distribution system was recorded at 77.47%, which required immediate uprating.

#### **EMERGENCY CAPEX PROJECT**

- 23. This project therefore aims to install a 20 MVA Power Transformer at the LEYECO II Sagkahan Substation to augment the critical capacity of the existing distribution system. This will increase the capacity of the cooperative to 80 MW.
- 24. The abrupt increase in power consumption in the LEYECO II coverage area resulted to several unscheduled power interruptions that caused inconvenience to the consumers and hampered business operations in the areas served by the two (2) 10-MVA Sagkahan Substation. LEYECO II deemed it necessary to immediately install additional capacity to augment the power needs of the consumers.
- 25. The 25-year old 10 MVA Power Transformer installed at the LEYE-CO II Sagkahan Substation suffered a serious leak in June 19, 2018 rendering it inoperative. This was immediately replaced with the old 10 MVA Power Transformer from Campetic Substation, which was replaced in 2014 by a 20 MVA power transformer. The leaking incident caused four (4) days of rotational power interruptions in Feeders 1, 2 & 5.
- 26. To promptly address the critical capacity problem, LEYECO II decided to immediately start the procurement process of the additional power transformer that will be used to augment the capacity of the present distribution system.
- 27. In August 24, 2018 the emergency acquisition of a new 20 MVA Power Transformer started. LEYECO II considered six scenarios before deciding on the capacity of the transformer that will be acquired, which showed that a 20 MVA Power Transformer is the least cost based on the economic evaluation.
- 28. Thus, in compliance to the regulatory requirements, LEYECO II informed the ERC on December 4, 2018 about the emergency acquisition in compliance to ERC requirements on notice and report to ERC. On January 23, 2019 representatives from LEYECO II went again to the ERC to consult about the proper petition that will be filed by LEYECO II. Copies of the Certificate of Appearances are hereto attached as ANNEX "D" and ANNEX "E", respectively.

#### Actual Project Cost

29. Considering that the acquisition passed public bidding in accordance with the procurement guidelines of the NEA, the amount of the winning bid of P24,980,000.00 is lower than the NEA Price Index. This Index serves as a guide of the electric cooperatives in determining the reasonable prices of equipment and line materials. No inflation costs need to be considered since the amount indicated already showed bid cost for the power transformer with the accessories included. The table below shows the details of the costs:

30. Copies of the bidding documents will be presented during the trial of the case.

#### **Project Financing Plan**

- 31. To relieve the consumers from the burden of shouldering rate adjustments, LEYECO II will source the cost of the project from the existing RFSC which is derived from the collected ERC approved RFSC rate of 0.1518 per kWh.
- 32. Data shows that as of May 31, 2019 LEYECO II's RFSC Fund Cash Balance amounts to P63,594,952.72. The available RFSC is the result of the implementation of massive restoration and rehabilitation in 2014 to 2016 funded by the Yolanda Restoration and Rehabilitation Program (YRRP). Hence, substantial portion of the collected RFSC from 2014 to 2019 were unutilized.
- 33. The Total Forecasted Sales in kWh (e-iCPM) for 2019 is 246,590,000.00 multiplied with the ERC approved RFSC rate of 0.1518 per kWh would result to a forecasted Sales Revenue of P37,432,362.00.
- 34. The table below shows the sufficiency of the RFSC to finance the project without sacrificing other RFSC related obligations and projects.

#### **Rate Impact**

35. Considering that the project will be financed solely from the existing RFSC of LEYECO II, there will be no rate adjustment that will be proposed.

#### **Project Schedule**

36. In order to maintain safe, reliable, secure and efficient operation of the power system, LEYECO II pursued this as an Emergency CAPEX Project. Considering the time constraints in manufacturing this transformer, LEYECO II started the acquisition process and finally executed on February 26, 2019 a contract with the winning bidder Elecsys Power Corporation.

37. The completion period of the project is 180 days but requires 15% initial payment. Meaning, LEYECO II expects the project to be accomplished 180 days after payment of the 15% initial payment to the supplier.

#### **Motion for Provisional Authority**

- 38. LEYECO II respectfully re-pleads and adopts the foregoing allegations in so far as relevant and material to motion for provisional authority.
- 39. As explained earlier, there is an urgent need to implement the project considering the present state of the substations of LEYECO II. The 77.47% load level of the 60 MW capacity is alarming. With the unusual minimum spot load of 2 MW added every year, it is almost foreseeable that safety, reliability, security and efficiency of the operation is at great risk.
- 40. Attached as **ANNEX "F"** is the **Affidavit** of LEYECO II's General Manager confirming the fact that the emergency acquisition and award to the supplier was subjected to public bidding in accordance with the NEA Procurement Guidelines.

  41. Attached as **ANNEX "G"** is the **Affidavit** of LEYECO II's Technical
- Services Department Manager Engr. Gil T. Caidic, PEE, confirming the critical capacity level of the substations of LEYECO II.

  42. Attached as ANNEX "H" is the Affidavit of LEYECO II's Finance
- Services Department Manager Adelaida V. Padrigano, confirming the status of the RFSC, source of fund and no rate impact.

  43. Finally, the Executive Summary containing the detailed information
- about the applicant and the project is hereto attached as **ANNEX "I".**

has left home or brothers or sisters or mother or father or children or fields for me and the gospel will fail to receive a hundred times as much in this present age homes, brothers, sisters, mothers, children and fields—and with them, persecutions, and in the age to come, eternal life." (Mk 10, 29-30)

We need to have the conviction that it is all worthwhile to give up everything for God. We should never be afraid because he will take care of everything. "Seek first the kingdom of God and his righteousness, and all

these things will be added to you," Christ said. (Mt 6,33)

Ours is simply to correspond to his will as fully as we can, imitating the example of Christ, our way, truth and life, who gave up everything, including his life, to do his Father's will to save us. And that giving up led to the resurrection.

Like Christ, we should correspond to God's will even to the most extreme of conditions. St. Paul, another good example of how one should very generously correspond to God's will, gives us an idea of the extent to which we should be willing to correspond to God's will.

If there is someone or something that will successfully convince Manny to retire, it's going to be none other than his body. If his body will finally retire, not even Manny can oppose it amid his positivism. These are impulses that will not anymore cooperate. Time will come that the boxer in him will just linger in his mind. His foot speed, his powerful arms, his heavy fists, and even his eyesight will fail him. Should all these happen, then that means his body is already retiring, albeit against his mind.

These bodily signals, in fact, are already showing. Where was that amazing foot speed of his during yesterday's fight? Where

was his previous ability to swarm an opponent with non-stop punches? Where was his former quickness to avoid incoming punches? Where was his ability to follow-up landed shots with a flurry of combinations? I was missing much of these in that Thurman fight. I found him to be less busy. But I could not blame him because those absent ingredients were just denied him by his ageing body that must be itching to retire now.

# DOLE RO VIII capacitates child labor program implementers

TACLOBAN CITY – The Department of Labor and Employment Regional Office VIII successfully capacitated some 75 enumerators, encoders and community facilitators for the implementation of child labor program in Eastern Visayas last July 11-12, 2019 at Avenue Hotel, Marasbaras, this city.

DOLE RO VIII OIC-Assistant Regional Director, Atty. Cecilio I. Baleña welcomed all the participants coming from the seven provincial field offices of the agency namely North Leyte Field Office, West Leyte Field Office, Southern Leyte Field Office, Biliran Field Office, Samar Field Office, Eastern Samar Field Office and Northern Samar Field Office.

The two-day activity dubbed as "Capacity-Building for Child Labor Profiling Implementers" was conducted to orient all enumerators, encoders and community facilitators on the scope of work they need to deliver to effectively implement the child labor prevention and elimination program of the regional office.

For this year, DOLE RO VIII has been given a target of 10,575 child laborers in Eastern Visayas to be profiled, 30% higher than the region's target of 8,106 in 2018.

"Child Labor" is defined by DOLE as any work or economic activity performed by a child that subjects him/her to any form of exploitation or is harmful to his/her health and safety or physical, mental and psychosocial development.

Mr. Virgilio A. Doroja, Jr., Regional Child Labor Program focal and Senior Labor and Employment Officer, provided the National and Regional Child Labor Situationer.

He likewise discussed Republic Act No. 9231 or the Anti-Child Labor Law, and Department Order No.



149-16 or the Guidelines in Assessing and Determining Hazardous in the Employment of Person below 18 Years of Age.

The roles of the enumerators, encoders and community facilitators were clearly tackled by Ms. Cristina T. Longjas, Chief of the Technical Support Services Division (TSSD) of the office.

To fuel inspiration for the child labor implementers, she also presented the 2018 accomplishments of DOLE RO VIII in child labor profiling which summed up to a total of 9,715 child laborers profiled, accounting to a 120% accomplishment rate.

"We urge all of you to be passionate in doing your jobs. We need your full cooperation and support in order for us to be able to deliver our target for this year. Your contribution will be valuable to our goal of achieving a child-labor free Eastern Visayas", said Ms. Longjas.

On the second day, Engr. Mark Louie Daza and Ms. Ma. Dahlia Aseo, Child Labor Program focal persons of DOLE-NSFO and DOLE-SLFO, respectively, gave the child labor implementers orientation on the possible sources of data on child laborers as well as data gathering tips and reporting forms.

Since the task of the enumerators will involve interview with children, a topic on "How to Conduct Child-Sensitive Interview" was likewise given by guest resource speaker in the person of Mr. Edison Cinco, Social Welfare Officer II of Department of Social Welfare and Development Regional Office VIII.

The activity was capped with an open forum wherein questions relative to the implementation of child labor program were raised and clarified.

The services of the enumerators, encoders and community facilitators will be engaged by DOLE RO VIII for a period of six months through a Memorandum of Agreement.

daily from a relocation site in Suhi village to the city's downtown, where he works as a goldsmith to support his family.

"I always prefer to ride the solar jeepney because of its bigger space and comfortable seats. For a man with long legs like me, it is very uncomfortable to ride a multicab or a very crowded old jeepney," he told the Philippine News Agency (PNA).

The Department Transportation launched the PUV modernization program in this city on Jan. 23, 2018 to "overhaul" the country's public transportation system.

This is one of the priority projects of President Rodrigo Duterte to provide a more dignified commuting experience.

The program has initially deployed 45 solar-powered jeepneys supplied by the Star8 Green Technology Corp. The number of units has doubled this year.

The jeepneys initially covered the Tacloban-Palanog route, which is intended to improve accessibility to resettlement sites occupied by thousands of super typhoon Yolanda survivors.

This year, the project has launched new routes in the city.

"I wish the government will push through this modernization program for the safety and comfort of thousands of commuters. This is way better than aging jeepneys and tiny mul-

ticabs," Montellano said.

Solar jeepney driver Rodolfo Solidor, 60, said driving the modern jeepney has encouraged him to extend his working years. The old man, who earns P320 to P500 daily, has been driving the solar jeepney since its launching here early

Each unit carries 22 passengers with free Wi-Fi on board, overhead electric fan per passenger, and USB power port to charge their devices.

It has a capacity to travel approximately 100 kilometers on a full battery charge, and adding another 10-15 km from the solar production during daylight hours.

"Its power steering makes it easier for me to drive this jeepney especially for an old man like me. I can drive for as long as I can breathe," said Solidor who has been transporting commuters to the new Eastern Visayas Regional Medical Center and relocation sites in Kawayan village.

He shared that after working as a driver for over three decades, he never had social and health insurance until Star8 Green Technology Corp. hired him last

The solar jeepneys, designed to replace the aging combustion engine fleet, have initially operated in the city starting mid-December 2017.

On July 11, the company launched 20 more solar jeepneys to ply new routes from the city's downtown.

"This is really introducing better tech-

nology for the public and better jobs for the people. This will address the transportation needs of the city's one million day-time population. It's really important to provide mobility and convenience for the people," said Mayor Alfred Romualdez during the launch.

The PUV modernization is a flagship project of the Duterte administration, which aims to restructure, modernize and make an environment-friendly transport system in the country.

The program also aims to provide drivers and operators with stable, sufficient and dignified livelihoods and at the same time, to let the commuters enjoy a safe and comfortable transportation system.

"You know the machines, the engines of public utility jeepneys, are about 20 to 25 years old. We got them from other countries. The reconditioned ones were sold here and they have been pumping in so much carbon dioxide into the air, including the factories," President Duterte said during federalism forum sometime in October 2017.

State-run Land Bank of the Philippines and Development Bank of the Philippines earlier announced the availability of multi-billion loans to finance the acquisition of new PUVs to qualified prospective borrowers.

# Who's next for Pacman?

TACLOBAN CITY-At 40 and 8 division titles, it seems that hanging up his gloves for good is still far from the mind of newly-crowned World Boxing Council (WBC) super welterweight champ Manny Pacquiao.

Minutes after his split-decision title victory over Keith Thurman on Sunday, the Pacman was asked if he will continue with his boxing journey.

"No more fight this year...I have to attend to other important matters, but I'll be back next year. I will fight again next year," replied the Filipino boxing icon.

Pacquiao added that he will watch the unification match between Errol Spence Jr and Shawn Porter in September and will weigh his options depending on the result of the duel.

Spence is the International Boxing Organization welterweight supremo while Porter is WBC welterweight ruler.

Spence is undefeated in 25 fights highlighted by 21 stoppages, while Porter holds an impressive 30 wins, 17 KOs, and 2 losses slate. One of his twin defeats was on the hands of Thurman in 2016.

Any of the two top-level welterweights are worthy foe for Manny.

Of course, there is Terence Crawford, the current World Boxing Organization (WBO) welterweight kingpin, who previously held the WBA lightweight and IBF welterweight crowns, respectively.

Crawford is widely regarded as the most crafty, methodical and cerebral welterweight of his generation, aside from possessing a knockout punch.

His ring record is 35 wins, 26 by way of KOs, with zero setbacks.

In fact, several boxing observers are one in saying that Pacquiao is avoiding Crawford like a plague.

But the most logical next outing for Pacman is rematch with Thurman.

The loudmouth pugilist from Florida proved his worth in his date with Pacquiao. He walked the talk. He survived a knockdown and bravely stood toe-to-toe with the ageless Pinoy ring hero.

Pacquiao even admitted that Thurman was good and rocked him several times.

In his triumph over Thurman, it was very evident that Pacman lost steam in the middle rounds paving the way for the erstwhile champ to momentarily take control of the fight.

If not for the knockdown and the vicious left to his liver in the 10th round, Thurman could have salvaged a draw or even won by a squeaker.

But in terms of publicity and money making aspect, a second dance with the retired Floyd Mayweather Jr. is the most practical choice. It's a sure-fire mega million bucks event.
