# Lack of teachers, classrooms greet students

TACLOBAN CITY- As the more than 1.27 million students started to return to their respective schools on Monday (June 3), perennial woes continue to hound the schools.

These perennial problems that besets the public school system include lack of teachers and inadequate school rooms making students to almost squeeze with each other.

At the Guadalupe Heights Integrated School located in Barangay Suhi, this city, these woes are evident.

The school is one of the newly-established public schools in Tacloban located at its northern portion where families whose houses were destroyed due to super typhoon 'Yolanda' in November 8,2013 were resettled.

School principal Larry Peñalosa said that aside from needing new teachers, they need school buildings.

While the construction of a four-storey building is ongoing, students of the school, both in the elementary and secondary levels, are to contend with temporary school rooms made of light materials and separated only either by a wall or curtain.

"That is why, I asked the contractor if they could hasten the construction of the four-storey building consisting of 16 classrooms," Peñalosa said.

Based on the calendar of works, the project is to be completed by December of this year. It is worth P41 million funded by the Department of Education.

Peñalosa said that despite of the ongoing con-

# New farm-to-market roads to improve trade in Leyte towns

LA PAZ, Leyte - The Department of Public Works and Highways (DPWH) Leyte second district engineering office has recently completed seven farm-tomarket road projects meant to improve road access and trade in three Leyte towns.

These projects include the concrete paving of Barangay Calaghusan to Caltayan and Brgy. Cogon to Buracan roads both in La Paz budgeted at P5 million each; Brgy. Tigbao to Romualdez road in Dulag worth P6 million; and four farm-to-market (FMR) roads in Mac Arthur, Brgy. Casuntingan to Osmeña, Brgy. Liwayway to Danao, Brgy. Sta. Isabel and Brgy. Gen. Luna roads with a total worth of P21 million.

According to Engr. Gerald Pacanan, head of the Leyte 2nd engineering district office, the completion of these projects would



increase agricultural productivity, income opportunities, and provide easier access to basic social services such as health centers and educational facilities to these communities.

"These concreted roads will help our hardworking farmers transport their farm products to commercial areas easier. Eventually, it will improve the overall economic progress of these towns," he said.

For 2018, the district is

tasked to implement a total of eight FMR roads with a total length of 4.2761 kilometers, of which one is still ongoing.

FMR projects is funded under the convergence program of the DPWH and the Department of Agriculture that aims to promote inclusive growth and poverty reduction in the country's hard to reach areas through better road connectivity.

CATARMAN, Northern Samar – Two siblings have died after they were struck by lightning in the rice fields at Sitio Carugyao, Barangay Osmeña in Palapag town this province.

Police Major Joseph Quilitano, Palapag chief of police, identified the victims as Arnel Laoreno Jr,21, Grade 12 student, and his younger sister Airene, 18, a Grade 10 student both residents of Brgy. Laniwan, Palapag.

Based on police reports, at around 10am last May 30,the siblings were tilling their farm along with their father, Arnel Sr., when a heavy downpour occurred prompting the three to take shelter in a nearby nipa hut.

They barely reached the hut when a lightning struck, hitting both Arnel and Airene who died instantly. Their father, though slight- health officer Delia Chy ly injured, was in a state conducted a post mortem of shock after the incident Quilitano said.

# NTC shuts down 5 radio stations operating in the region

TACLOBAN CITY -At least five new radio stations in the region were served for cease and desist order by the National Telecommunications Commission (NTC-8).

Three of these radio stations are based in Northern Catarman, Samar, namely: 101.5 Radyo Samar Broadcasting;99.5 Brgy FM and 97.3 Omega Radio, meanwhile the other two radio stations are from Catbalogan City, 92.5 One Radio and

90.1 Sagay Broadcasting.

Lawyer Cavales, NTC-8 legal officer, said that these radio stations have no business permit to operate reason why they were served the notice for them to stop their operations.

Cavales also said that the two radio stations in Catbalogan City changed their frequency but their office made a surprise inspection.

"We can file criminal cases against them be-

cause they are violating the radio control law," Peme he said.

There are five newly promoted Master Teachers. From the English Department Salve Renomeron, Paz Posion from the Science Department, Aurora Abud from the TLE Department, May Desabille from AP Department, and Analyn Naboya from the MAPEH Department. Adelfa Juan is promoted from Teacher III to Head Teacher I. Adelfa

Juan will be in-charged for the Grade 9 and Grade 10 as well as the Senior High School Applied subjects.

Dr. Rosita Pantin-Abio, the new School Principal of Burauen National High School, designated new teacher assignment corresponding to its grade level they will be holding as well as the new room assignment and class advisory.

Among its 63 teaching staff, 32 of which are Teacher Advisers from Grade 7 - Grade 10 and the Senior High School.

There are 9 sections in the Grade 7, for the Grade 8 there are 7 sections, for the Grade 9 there are 6 sections, for the Grade 10 there are 6 sections, and for the Grade 11 there are 4 sections as well as the Grade 12 having 4 sections also.

Newly-hired teachers are designated as new teacher advisers in lieu for the newly promoted 6 Master Teachers and 2 Head Teachers.

Dr. Abio emphasized in her message during the First Teaching and Non-Teaching Staff meeting for the S.Y. 2019-2020, that each Teacher who is given new assignment should embrace change for the betterment of the student's welfare and the school as a whole to cater their needs.

# LGU-funded solar streetlight in Eastern Samar accomplished thru CDD process Government Unit, its

The Kabit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (Kalahi CIDSS) uses Community-Driven Development as an strategy wherein the people have direct control over the decisions and resources in their community.

It is through their involvement that they can become empowered citizens which leads to an improved local governance and poverty reduc-

In Barangay Poblacion 9, Llorente Eastern Samar, it has been the hope of community to lessen the unsafety the dark street brings.

According to Lisa Gade, a community volunteer, it poses fear and danger to the residents because of accounts of theft and violent incidents. Ms. Gade attested. "Before, the street was so dark that it invited theft, violence and accidents. And I have been a witness to those unfortunate situations."

Aside from that, it is accounted that 40 per cent of the labor force in the barangay was affected due to this dim place. Affected were people which 'padyak' was the source of income and those who sell barbeque and the like during night time. Only a few people patronized because they were afraid to go out at night due to theft and violent incidents in that place.

It is no doubt that the



community identified a solar street light in the Kalahi CIDSS LGU-led implementation. Only 11 of all 33 barangays were prioritized during their Municipal Development Council-Participatory Resource Allocation (MDC-PRA) to use the Kalahi CIDSS pure grant of P7, 052, 150. Brgy.Poblacion Nine was not included in the prioritization as it ranked 13th.

But the LGU Llorente allocated a fund of P1 million to be shared by the remaining barangays. Only two Brgy Poblacion 9 and Brgy Poblacion 11 were able to avail it. Barangay Pob. 9 got the P294, 473 for their identified streetlight intervention project.

Though the fund is purely from the Local

preparation and implementation followed the Community-Driven Development (CDD) pro-The local government

unit of Llorente believed so much in the CDD process because of the community from planning to implementation and maintenance.

Some 186 households are now enjoying the seven-unit solar street light which helps them have a safer place and better opportunities.

This only shows how DSWD Kalahi CIDSS heightened the partnership of community and local government unit in addressing the most pressing need of the community. (PR)

# Back to school



he Department of Education (DepEd) Region 8 revealed that yesterday, June the third, was to be the start of classes and that more than 1.27 million students were supposed to

report to school for the opening of this year's school calendar.

As such, teachers were likewise expected to be present, with their school heads and principals on the lead, and the division officials monitoring the said opening of classes. This was mandated by no less than Dr. Ramir Uytico himself, the DepEd regional director who stressed the observance of said date.

In fact, the age-old tradition of cleaning the classrooms and the surroundings first before the start of classes has been discarded. Classes

were to start at once as said clean up should have been done during the 'Brigada Eskwela, an annual activity of the DepEd aimed at cleaning up the vicinity and repairing damaged school facilities with the participation of students, parents, and volunteers.

Based on DepEd-8 records, the expected 1.27 million students who were to troop to their classes consisted of 110,845 kindergarten; 615,814 elementary; 405,521 junior high school; and 138,540 senior high school students. They are to be housed in the 4,167 public elementary/secondary schools regionwide.

It is our hope that DepEd will succeed in all its endeavors of educating children and young people in order to make them productive citizens in the near future.



# Beggars and their modus

When you look like the haves and you happen to walk along the downtown sidewalk, it's very likely hands with open palms will be extended to you, not to shake your hand or tap you on the back, but to ask for monetary help.

That's right, these hands hovering in the air come from what we call beggars. Sometimes, we can't figure them right away as the owners tend to hide behind electric posts, walls, or dirty clothing. It's just their hands that dangle, sometimes holding an empty can with which to collect the coins. If you are kind-hearted enough, you will slip your hand into your pocket to unearth those circular things. The next thing you do, you will be handing them these coins.

There is surely nothing wrong with giving a few amounts to these desperate souls. I've done that for sev-

eral times already. Especially when I see that the person is really worth-giving, like when the person is too old he can never work for a living anymore, or when disbody hence his inability to work. But when I see that the "beggar" is able-bodied, and his dirty and richly-patched outfit is just a costume, I never give.

There's another group of beggars that break my heart-those filthy, emaciated street children. But just the same, I try to scrutinize their worthiness to receive alms. If I see that they are just wasting their money on gambling among themselves; if I notice that they engage in smoking or rugby sniffing, I don't bother to give. One disqualification—if they are just being used by some syndicates to gather money. But this is rather difficult to prove.

I've had these experiences when beggars approached me, and I gave them a few pesos, only to turn their back on me and never even thanked me ability had paralyzed his for what I gave, obviously out of frustration that the amount I gave them is too small. These are the kinds of beggars that I never want to give at all, although it's understandable that, with their illiteracy, they never know anything about social manners. But gestures of gratitude are supposed to be very basic that even animals know how to express them.

In Metro Manila, there are these beggars who would embark passengerpacked jeepneys just to distribute envelopes with which they are collecting money. After distributing, they would wait for a few

Yesterday June some 23 million students trooped to 42,025 public schools all over the country, start of classes for school year 2019-2020. As usual there were reports saving that in some areas they lack school buildings – desks etc. – a perrenial problem that haunts education in our land. Having been a public elementary grades teacher I can see the difference between then and now.

At age 21, I got employed at the Department of Education, Culture and Sports (DECS), then, as a fresh graduate of the Leyte Normal School (now University) in 1960.

-000-

Here is one specific challenge I was confronted with upon assuming my first day of service in school. At that age I was assigned in a barrio school some 10 kilometers away from home, classified as extention class at Barangay Carangag (renamed Hiagsam, Barugoa river that flows along the barangay from far away Barangay Hiagsam, Jaro, Leyte).

In Barangay Carangag located on top of a hill, there was no school building. I taught a multi-grade classes of Grade I, II and III. Unbelievable?

I held my class at a barangay chapel. There were no desks – but chapel benches – no blackboards – or purely bare, the chapel for classroom use.

First move: Organized the Parents-Teacher (no "s" bcause I was alone) Association (PTA) a standard organization in elementary schools.

Through the PTA we succeeded in requesting a landed estate in poblacion Barugo who owns this estate in Hiagsam to donate



# Return to sender

Millenials may not be familiar with marks that read "return to sender" for leaps brought by information technology. # Divining the presidency on Higatangan Island

Higatangan Island is a part of Naval Municipality that is separated by a narrow channel located in the north west tip of Leyte.

The name Higatangan is derived from the word "atangan" meaning to wait for. Old folks say that the place was where the pirates ambush approaching ships laden with goods and also the place where the Moros lay in wait for their enemies going to Sumbul (Naval).

The island has several white beaches and blessed with exotic rock formations.

From the town of Mabini, which was named in memory of Apolinario Mabini, there is a 200-meter white sand bar that stretches out like a giant tongue. Because the current surrounding the sand bar is strong, some people lost their lives, some attribute this as "alay-buhay" to placate the gods.

The unnaturally beautiful rock formations along the south coast were said to be home to supernatural beings. There were cases that a sudden big wave or a gush of wind rock the boat when passengers were being noisy.

President Marcos temporarily took refuge during WWII on this little island, that's why the highest point on the island (46m) is still called Marcos Hill to this day and a light house is erected on it to guide boat men.

It is said that this is where Marcos received his divine sign that he was destined to be a president of the Philippines.

The truth behind his stay is a source of controversy for the Biliranons. The long held belief was that it was Fidel Limpiado, member of a prominent clan who hid Marcos and his companions against the Japanese patrollers.

However, Professor Rolando Borrinaga, known Philippine historian disproves that story. His long and arduous research give way to the fact that it was a simple skipper named Man Dising from Caray-Caray Biliran, who helped Marcos in

So. Leyte underway MAASIN CITY - The construction of multimillion high-rise school building in Liloan National Technical Vocational High School is now up and running in a bid to address shortage of classrooms in Liloan, Southern Leyte, the Department of Public Works and Highways (DPWH) field office here reported.

The 3-storey school building currently being constructed will have 15 classrooms equip with comfort rooms, emergency exits, and fire protection facilities. It has an allocation of P46 million funded under last year's Basic Education Facilities Fund (BEFF) of the Department of Education.

Based on the recent project inspection conducted by DPWH Southern Leyte engineers, ongoing works in the site include pouring of concrete for the tie beam as well as fabricating and placing of steel bars for the beams.

Liloan National Technical Vocational High School, with over 1,000 students, is one of the national high schools of the government carrying out the implementation of the K to 12 program.

"The school building granted to Liloan National Technical Vocational High School aims to cater the increasing number of enrollees here particularly in the Senior High School program. This new school building will be the venue for technical laboratory and workshops that

would equip students with technical and vocational skills necessary for future employment," said DPWH Southern Leyte District Engineer Ma. Margarita Junia.

Junia said the project started on December 3, 2018 and is targeted to be completed on February 3, 2020. She added, the DPWH has been regularly monitoring civil works and is optimistic that the school building will be finished earlier than the set completion date.

"The DepEd in a joint effort with the infrastructure agency will remain relentless in implementing school building projects necessary for educational development," Junia said. (PR/FMMT)

# monitors school bullying, says official

PALO, Leyte – The Philippine National Police (PNP) here in Eastern Visayas continue on their advocacy on anti-bullying in schools.

With the start of the school year on Monday(June 3), Police Regional Office 8 Deputy Regional Director for Ad-Brigadier ministration General Ariel Arcenas said that policemen are not only after ensuring that children are safe in going to their schools but

are safe while staying inside their school campuses and classrooms.

Arcenas said that they are regularly conducting their information drive among students on the negative effects of bullying to victims and even to those who are behind the bullying.

"We are asking people, especially our students, to refrain bullying others because it is not good," Arcenas said.

Under Section 2 of Re-

public Act 10627 or the "Anti-Bullying Act of 2013" it states that bullying refers to any severe or repeated use by one or more students of a written, verbal or electronic expression, or a physical act or gesture directed at another student that has the effect of actually causing or placing the latter in reasonable fear of physical or emotional harm or damage to his property; creating a hostile environment at school for the other student; infringes the

rights of the other student at school; or materially and substantially disrupts the education process or the orderly operation of a school.

"We are recommending that the school authorities should act to it first then inform us so we can also react accordingly. If this involves underage children this should be take can by schools and our social welfare workers," Arcenas said.



TACLOBAN CITY- A five-storey building that will serve as the regional office of the Bureau of Fisheries and Aquatic Resources (BFAR) in Region 8 is expected to rise in July next year, about 15 months from now or 450 calendar days.

The groundbreaking ceremony for the office building was held on May 29 at Barangay Diit, Tacloban City, the previous site of the office building which was heavily damaged by super typhoon Yolanda in November 2013.

In his message, Dr. Juan Albaladejo, BFAR regional director said, "With five years in the making, our dream of having a climate resilient and environmentfriendly office building has finally become a reality. With our Typhoon Yolanda experience, we designed our building to become storm surge-proof, safe and with state-of-the-art design."

"We want to get back to Barangay Diit because this is our original home and we want to build our dreams and hopes here, aside from being close to the sea," he said.

He added that the fivestorey building has a floor area of 5,000 square meters at 1,000 square meters per floor while the laboratory section will be located at the 5th floor and other facilities at the upper floors, making them safe from floods and other calamities.

It was learned that BFAR-8 was given a total budget of P260 million in February 2014 from the government's savings intended for the Yolanda rehabilitation projects.

"Of the total budget, P189 million is allotted for the office building construction and the remaining amount is for the rehabilitation of BFAR facilities like the surveillance and monitoring building and other facilities in Guiuan," Albaladejo said.

The BFAR official also disclosed that its office has a lot of equipment donated by the Japan International Cooperation Agency (JICA) that are temporarily housed in Guiuan, Eastern Samar.

Some of these equipment will be transferred to Tacloban upon completion of the building.

Director Albaladejo also bared that his office will be engaging more projects with JICA like tooling and post-harvest facilities, to cater to the needs of mari-

A breathing area will also be provided for the safekeeping of the boats used in law enforcement, in times of inclement weather.

struction, they still need at least 16 new classrooms to accommodate their growing population coming from Guadalupe I, II, III, and IV with a combined population of over 10,000 people.

Genrix Oliva, a Grade 4 pupil, said that he does not mind if their classrooms are just like shelter-type.

"This is just temporary, I guess. I just want to learn," the student said.

At present, the school has about 700 enrolled elementary students and about 500 secondary students being handled by a combined 27 teachers.

Peñalosa said that they expect the enrollment to balloon as enrollment is still ongoing.

At the Burauen National High School in Burauen town, Leyte province, it still need at least seven new classrooms to accommodate its increasing number of student population, said junior high teacher Angelina Wing.

At present, the school has about 45 classrooms with an enrollment of about 1,600 handled by 63 teach-

Jasmin Calzita, regional information officer of the Department of Education, said that all these inadequacies are being addressed by their office.

For one, lack of teachers are being addressed.

Their central office has allocated more than 340 new teachers for the region





# **Dormitory saves Leyte students** from dropping out of school

MACARTHUR, Leyte--Mary Ann Bren, 16, is all thankful to the dormitory set up inside Palale National High School in Mac Arthur, Leyte, saying the place has saved her from stopping on her studies.

Growing up in a family of 12, Bren said that sustaining her education has been a constant challenge of her parents who are both farmers.

'We are 10 siblings. Our parents have a hard time supporting our studies especially for our allowance and transportation needs," said Bren from the interior barangay of San Antonio in the said town.

Bren has to walk for an hour just to reach the school.

Yet after she moved into a dormitory room for the girls inside the high school premises, Bren said she found relief.

"It's much better here, because I will no longer get tired from walking everyday in going to school. I can attend to my classes every day and save my allowance, too," she said.

Bren stayed in one room along with 12 other girls in the school. Another room is also made for the 13 other boys whose houses are far from the school.

"This is the first time that I am away from my parents. But it's just fine because this will be for my own good. I was able to adjust to my new environment. This is just little sacrifices for me to finish my studies," said Bren who wanted to take up tourism degree in college.

"I really want to finish my studies and find work to help my parents," she

Eighteen-year-old Mark Sumaya, an incoming Grade 8 student, said the distance in going to school was difficult for

"We are five siblings. Only two finished Grade 6 while the others already got married. I am thankful that I've found a new home inside the school so I can finish my high school," Sumaya said.

He started staying at the dormitory in September 2018 after it opened in August.

Sumaya said that his parents have to spend P800 every month for the rental payment of a motorcycle which they used to take to the school.

"We have to resort to 'pakyaw' for our transportation. It would take about two hours if we will walk going to school from our house," said Sumaya.

The school assigned some faculty members who also resided in the barangay to serve as "managers" or in-charge of the two rooms inside the school.

The student-boarders were given respective assignments from cooking to cleaning their area.

They also eat together, like in a family. The student-boarders have one cooking area and comfort rooms, respectively.

The dormitory "managers" also instilled discipline and values to the student-boarders. their free time, they also have some form of recreations like playing chess and learning to play the guitar, among others.

On weekends, the students who chose to stay in the school also get the opportunity to earn extra money by tending to crops of some farmers in the barangay or act as "helper" to other teachers and residents in the area.

While the students do not get extra allowance from the school itself, they however get free board and lodging.

The allocated Maintenance and Other Operating Expenses (MOOE) for Palale National High School is around P38, 555 only. It is being spent for electricity, water, supportlearning programs, and other school activities.

While the school's expenditures monthly have increased due to additional consumption of water and electricity, this did not stop the school and community officials from sustaining the operation of the two-room dormitory for the sake saving the students from dropping out from school. Before the school only

paid about P1,000 for the power and P600 for the water. This time, they are paying about P2,000 for the water and P3,000 for the electricity.

But for Sumaya, he said he is now "focused" on her studies after finding a place in the dormi-

"I want to become an engineer someday, and hopefully build a bigger dormitory in the school for the next students like me," he said.

The school leaders also sought technical assistance from Raul Salano, who handled the Drop-Out Reduction Program (DORP) of the Division of Leyte, in bringing in more sponsors and coordinate with other stakeholders for the operation of the dormitory.

DORP is an adherence to the national government's program of "Education for All."

It provides intervention program to reduce the high dropout rate and improve learning outcomes among schools both private and public.

More, it increassignificantly achievement level of the Students-at-Risk of Dropping Out (SARDO).

In the case of Palale National High School, the school leaders with the help of the Division and community officials, managed to increase their capabilities to establish, implement, monitor, evaluate and continuously improve the DORP.

The innovation of putting up a dormitory served as its best practice.

With the help of the local government of Mac Arthur, the school's one story, two-rooms building became a refuge to the students in the interior villages of the town who are at risk of dropping out from their studies.

The Leyte division also envisioned that the project to counter the DORP in Palale will be replicated in all schools in the 40 towns of Leyte and to the rest of the region and the country where many students quit on their studies due to the distance and expenses in going to school

"Bernal Kalipayan Banagbanag is a hundred year old man. He was born on December 12, 1918" said Jonny Banagbanag, his son.

Bernal lived in a small house together with his wife Talina Pinao Banagbanag and his daughter.

Mano Bernal has 9 children with 5 boys and 4 girls. His family came from the province of Surigao and migrated to the mountainous part of Javier, Leyte and sooner they stayed in a mountainous barangay of Burauen now Brgy. Kagbana for about five decades now where he supported and raised his family through hunting of wild animals and fishing as their primary source of living.

During that time their family has no chance to visit the town to buy their basic needs like rice, coffee and dried fish. But instead they ate "pugahan" as a substitute to rice, they drink "dugos" honey as their coffee – they

The excess harvest are sold in the community with the proceeds going to special programs and projects of the school like reproduction of test materials, Christmas party of the pupils and school beautification, Mosquito said.

The project would free the students from the burden of finding money for their school projects and other expenses, he added, noting that the majority of their students are children of ordinary farmers.

Today, Mano Bernal is still active in exercising his beliefs and rituals and even can participate in any gathering in Barangay and school activities whenever he is invited.

His beliefs and rituals are respected by the whole community neither Mamanwa or the common people as he is consider the IP elder in barangay.

"Mano Bernal is now preparing the next "maan" as the successor of his legacy," said Mang Jonny.


