TACLOBAN CITY- Former congressman Ferdinand Martin Romualdez has confirmed that he is seeking for the speakership of the House of Representatives.

Romualdez is running for congressman in Leyte's first congressional district in this year's May 13 midterm elections.

The former solon, whose wife Rep. Yedda Marie Romualdez is the incumbent congressional representative of the district, made his interest known after his name was mentioned by presidential daughter, Mayor Sara Duterte, among those eyeing to become the successor of Speaker Gloria Macapagal Arroyo.

798 police officers face administrative cases in Eastern Visayas

TACLOBAN CITY-A total of 798 police officers from the region are facing administrative cases since 2016 up until the first semester of this year following the internal cleansing program of the Police Regional Office 8 (PRO-8).

This was disclosed by Brigadier General Dionardo Carlos, police regional director, who said that the police organization is serious on its campaign to make it more professional and free from scalawags.

"In our quest for genuine cleansing and transformation, we will go through challenges. Thus, we will more strict in implementing internal cleansing among our ranks," Carlos said. Carlos said that 494 administrative cases were filed against its personnel, 353 of these were filed before the Office of the Regional Investigation and Detective Management Division while the other 141

Perennial candidate counts Mayor Sara Duterte for an electoral victory this time

HILONGOS, Leyte- A congressional candidate for Leyte's fifth district is pinning her polls victory to presidential daughter, Mayor Sara Duterte.

Marilou Galenzoga said that she is optimistic that this time, she will prevail victorious now that she enjoys the support of the presidential daughter and by extension, President Rodrigo Duterte.

She is running for Congress under Nationalist People's Coalition (NPC) which has a coalition with Duterte-funded Hugpong ng Pagbabago (HNP). Galenzoga, a businesswoman, has attempted several times to topple the family of outgoing Baybay City Mayor Carmen Cari but lost them all.

For the forthcoming May 13 elections, Galenzoga is seeking the congressional seat to be vacated by Cari's son, Jose Cari.

Rep. Cari is running for mayor of Baybay with his son, Carl Nicholas, running for the congressional post.

Galenzoga said that she would not stop in running

for elective post so long as she could not end what she claimed the Cari dynasty.

The Caris have ruled Leyte's fifth district for more than four decades now and are relatives to Leyte Governor Leopoldo Dominico Petilla.

TACLOBAN CITY- A commissioner of the National Youth Commission (NYC) has expressed his support to release the list of candidate-politicians who are running in this midterm elections engaging in the illegal drug trade.

By releasing the socalled narco list, the young voters, in particular, would know that they should not vote these candidates as they are involved in the illicit activity, Victor del Rosario, NYC commissioner for the Visayas, said in an interview.

TACLOBAN CITY-Some 580 participants coming from different women's organizations and government agencies in this city joined the Women's walk on Friday, March 8 organized by the city government through Mayor Cristina G. Romualdez, and the Tacloban City Council of Women.

The event marked the National Women's Day Celebration and formal kick-off of the month-long Women's Month activities in Tacloban.

This year, the celebration will center on the full implementation of the Magna Carta of Women, also known as Republic Act 9710 by making known programs and services that Tacloban 2018 Cassandra Lee also took part in the annual event that highlighted a brief program with TCCW chairperson Rebecca Rosales Ada.

Mayor Romualdez will also lead city departments and offices in the following activities related to the celebration this March: sports fest for women on March 13 at the CEO Gym, orientation on the trafficking in person (TIP) Law, detection and management (March 20) at the DZR Airport, workshops on the finalization of the city ordinance on anti -trafficking, help desk guidelines and children's code (March 21, 22, and 23), women's congress and Got Talent at Robinsons North Mall (March

The police regional director said the "strict implementation" of the program has led to the dismissal from the service of 99 police personnel; 172 suspended; 373 exonerated; 12 demoted; and 4 reprimanded for various offenses.

However, the other cases remain pending for resolution.

The top recorded cases filed against these errant police officers are Absence Without Official Leave (Awol), violations against revised penal code, conduct unbecoming of a police officer, loss of issued firearm, solicitation of political patronage, violations of police operational procedure, failure to prepare and submit report, and willful violation of office regulations, PRO-8 said in a statement.

"We are developing a tour program and hope to pitch it to the Russian market with the help of the Russian embassy," said Karen Tiopes, the DOT regional director.

The tour program is also in coordination with the Eastern Samar provincial government and concerned local government units.

"We are still finalizing the needs to develop this tour program," Tiopes added, citing the collaboration of both public and private sectors for the tour program.

"Some homestay trainings are conducted by the 'Proyekto 25' program on tourism under Governor Marcelo Ferdinand Picardal administration. The other trainings were funded and facilitated by the DOT through the municipal tourism offices in some identified areas," Robedizo said.

In the spirit of Filipino hospitality, the late president Elpidio Quirino granted about 6,000 Russians, also known as white Russians for shunning communism in their country, to live at the Tubabao Island from 1949 to 1951 while they waited for other nations to grant them asylum.

The Philippines was the only nation that embraced the white Russians over their appeal for help to the international community after they fled from the communism campaign in their country to China.

The Filipinos gave a place for the white Russian refugees to stay for the next 27 months at the Islandturned US Naval Base Construction Depot despite the difficult situation in the country due to World War II devastation.

During their stay, the white Russians found "a paradise, a beach, and hope" at the Tubabao Island, courtesy of the "warmth of the Filipinos, and strength demonstrated by their people."

Humor from a confusing gender

Alejandro Roces is considered in Philippine literature as a humorist. He had of course written funny stories, aware as he must have been that such tales generate humor and, in turn, are being rewarded with social approval as any member of a group with funny stories to tell is usually the group's favorite. This article dwells on Of Cocks and Hens, one of those stories.

In this particular story, Roces draws attention to a puzzling gender identity, obviously seeing the humorous potential in it. He used the chicken, of course, but one can easily figure out he may have the human version of that gender ambiguity in mind, knowing that such phenomenon is common only among humans, not with animals. And he may have gotten it right. Hearn and Parkin believed the existence of such confusion is for real. According to them, "we only know sexuality through its unknownness, perhaps its unknowability..." This could be an honest admission regarding difficulty in understanding human sexuality.

While scholars are trying to dig deep into that psychology, people like Roces tend to make fun of it, not necessarily to offend those who are concerned, but to extract the humor from it knowing that anything which deviates from normalcy is potentially humorous. At first glance, the story may appear insignificant were it not for its literary value. But when the object of its conflict is brought to the human level, readers could see that the story, after all, proves to be a valuable document for areas like psychology, sociology, natural sciences, etc.

of entertainment as well. In today's era when issues are getting seriousclimate change, social unrest, food shortage, natural disasters, etc., stories that provide fun and entertainment are in demand as necessary ingredients for people to keep moving on in life.

In Spanish grammar, some nouns have ambiguous gender such that at times, they are treated as feminine, sometimes as masculine. What are these humorous instances, elements, and devices that can be drawn from an enigmatic gender? These are what this article had focused on, scrutinizing the story first, then drawing from it bits of information that shed light on humor, gender ambiguity, and their connection with each other.

Right in the first paragraph, Roces gets the humor rolling when he wrote, in reference to the chicken, that "no one could tell whether it was a rooster or a hen." The confusion on the part of the characters begins. And humor starts, too, traceable as to where it has been distributed and embedded in the story. In reality, the differences between a rooster and a hen are so glaring that even a young child could easily and readily spot them. To say that one cannot tell them is too much. One must be severely moronic for the inability to do so. 1. Humor from a confusing appearance From experience, we know that male and female chickens have distinct identities. We can easily tell and make distinctions since these identities are so glaring between the two of them. Roosters are bigger and taller than hens. Their combs are bigger and wider, too. They have longer, colorful feathers, and they grow elongated

spurs on their heels.

When the children Kiko and the narrator caught sight of the chicken fighting each other in the cornfield, they could already tell what gender that chicken had. Problem was, their assessments differed. Kiko said it was a rooster since it could fight well; it had a long tail; it could crow; and it had spurs. But the narrator claimed it was a hen for having no "comb or wattles."

DPWH Southern Leyte chief Ma. Margarita Junia said they are expediting works on the new district engineering office building and aims to transfer early of May this year.

"Our first plan was to transfer to our new office last year but since there were still some major improvement that needs to be done, I decided to reschedule our target. I wanted to complete the construction of our new office building first before opening it to the public," Junia said.

The district office will be slowly transferring files and furniture to the new building starting April.

The two-storey building with floor area of 525 square meters is within

A-PAD platforms as channels for private sector initiatives in mitigating calamities

MAASIN CITY-A gathering of individuals representing various organizations inside and outside of the country underscored the need for quick action against tragedy be it manmade or acts of nature.

And serving as a funnel to make sense of various efforts directed at easing the lives of those badly affected, the victims, was the Asia-Pacific Alliance for Disaster management (A-PAD), a transnational aid union established in 2012.

A-PAD works to facilitate cooperation and understanding between governments, private companies, and NGOs within the six-member countries in the Asia Pacific region that includes Indonesia, Sri Lanka, Bangladesh, South Korea, Japan, and the Philippines.

"This event shows that disaster efforts are not left to government alone," declared Undersecretary Ricardo Jalad, administrator at the Office of Civil Defense (OCD) and executive director, national disaster risk reduction and management council (NDR-RMC).

Speaking in behalf of the Philippine government at an international symposium organized by A-PAD Philippines held at Heritage Hotel in Pasay City February 28, Jalad cited the support of the private sector, saying it served as a "motivation for OCD to work better."

Jalad expressed hope A-PAD can promote coherence, collaboration, and coordination among various actors from the nationrural areas where communication is limited, towards transforming grassroots communities into disasterresilient, climate-changeadopted units.

Rene Meily, president of Philippine disaster resilience foundation (PDRF) and A-PAD Philippines coconvenor, echoed the same thought, as he emphasized the alliance's role in bringing actors together, learning from each other, and being ahead in responding to disasters.

Two other high-ranking A-PAD national officials, Kensuke Onishi, chief executive officer, and Faisal Djalad, management officer, focused on innovation, particularly in creating platforms initially in select regions of the Philippines as a key mechanism for saving lives in less time.

For his part, Atsushi Kobayashi, third secretary/ economic section of the Embassy of Japan based in Manila, reaffirmed Japan's commitment for sustainable, resilient communities, and the continuing assistance to national and regional platforms.

To date, A-PAD Philippines had created six regional platforms around the country, and these are found in Bicol, Central Visayas, Eastern Visayas, Davao, Socsargen, and Ilocos regions, where each regional platform is composed of the business sector, faith-based organizations, the academe, government, civil society, and media, represented by PIA.

Representatives of the sectors named in every regional platform attended the international sympoleaders of the six countries that bond together for the pacific alliance, who shared best practices and experiences on how they were able to address disaster issues and concerns using the A-PAD framework.

They included Faisal Djalal, chairperson for A-PAD Indonesia; Masataka Uo for A-PAD Japan; Jangwoo Lee, A-PAD Korea; Hashim Mohammed Firzan Jaward, A-PAD Sri Lanka; Quazi Quamruzzaman, A-PAD Bangladesh; and Ms. Jasmin Jerusalem, A-PAD Philippines.

At the end of the day, the messages all pointed to a future where victims can be empowered on their own, a self-survival for 72 hours or within three days after a disaster strikes - long before help arrives; a scenario where search and rescue activities can walk the talk on the ground, complementing words with actions, to save more lives in less time; and a situation in which health care can be sustainable and not be confined in rehabilitation phase at settlement sites.

The theme of the international symposium further summarized it all: strengthening community resilience and humanitarian response through localized disaster risk reduction management (DRRM) platform.

All these can be attained because the private sector has taken the lead, because the private sector in whatever capacity cared enough, with A-PAD laying the platform to make the impossible possible.

Dolphin dies after rescued in Northern Samar

TACLOBAN CITY - A spinner dolphin has died hours after it was released back to the waters in Bobon, Northern Samar.

The dolphin was first rescued after it was stranded along the shore of Mondragon, on March 3, according to Bureau of Fisheries and Aquatic Resources (BFAR) Regional Director Juan Albaladejo.

Local residents discovered the spinner dolphin who reported it to the police in Bobon town.

The BFAR Northern Samar also responded to the report and assisted in securing the carcass of the marine mammal.

A necropsy of the spinner dolphin was conducted in order to know more about the reason of its death.

The said necropsy was conducted by the College of Veterinary Medicine of the University of Eastern Philippines headed by Drs. Rey Anthony Galo and Aurelia Gajutos.

Based on initial findings, the dolphin had congested lungs and liver and had enteritis or inflammation of intestine.

The stomach was empty upon opening, possible that the dolphin was not able to eat for some time.

Tissue samples were taken for histopathologic analysis and further examination of the spinner dolphin.

Albaladejo said that the rich presence of fish in the sea water of Northern Samar makes it an ideal site for hunting of the marine

In Northern Samar 5 most wanted persons arrested in separate manhunt operations

CAMP CARLOS DEL-GADO, CATARMAN, Northern Samar- Five wanted persons were arrested in two-day manhunt operations in Northern Samar.

The recommended bail bond of the two accused is P 12,000 each. On March 4, 2019 at 6:45 am, Bruno Gomba,aka "Niger", 40, married, construction worker and resident of Brgy. Jubasan, Mapanas, also in Northern Samar, was apprehended at Phase 3 Belvirede, General Trias, Cavite. The arresting team from Mapanas MPS led by Police Captain Jose Fernandez travelled to Cavite to effect the warrant

of arrest to Gomba who was charged with rape and tagged as top 4 most wanted of Mapanas MPS. Judge Mory A. Nueva ordered his arrest and recommended no bail for his temporary liberty.

On same date, at 1:55 pm, operatives of Catarman MPS led by Police Major Eddie Esidera implemented the warrant of arrest against Rodel Dizon, 27, married, farmer and resident of Brgy. Cal-igang, Catarman, for the crime of frustrated homicide.

Few hours later, Dizon's co-accused identified as Rodel Jonel Infante,20,single, jobless and resident of same village was also arrested at Brgy. Washington, Catarman by in a joint operation of Catarman MPS and CIDG-

Northern Samar led by Police Major Glenn Aculana.

Judge Alma Consuelo-B Desales ordered their arrest and recommended each of them P24,000 bail for their temporary liberty.

preserve the sanctity of the bells by not allowing them to touch the artifacts.

He said that they have erected steel fence at the Church grounds where the

bells were put in this display. This way, the tourists could not touch them though they are still allowed to take photos with the bells serving as their background.

It was learned that since the bells were put into display at the Church's grounds after the Christmas Day celebration last year, 22,000 local and foreign tourists have visited the historic items.

Even before the three Balangiga Bells were returned to the town, the local tourism office as well as its regional office projected that these could become tourist attraction.

Tourism Regional Director Karina Rosa Tiopes said that aside from assisting the town to have funds for tourism infrastructure projects, various trainings were conducted to the stakeholders to help them know the proper way of handling tourists.

"We are here to find out and fill in the gaps because tourists are coming

in, small businesses are mushrooming, and we also want the tourists to come not only for the bells but to learn about Balangiga's significance in our history," Tiopes said.

After 117 years, the three bells were returned by the American government to the Philippines and were formally installed on December 15 last year.

President Rodrigo Duterte witnessed the turnover rite, expressing his gratitude to the American government and all other sectors responsible that led to the return of the bells.

Cops secure E. Samar island amid mining firms' row

TACLOBAN CITY lice. -- The Police Regional Office 8 (Eastern Visayas) has assured that they are closely monitoring the situation in Homonhon Island to prevent violence following the escalation of the dispute between a mining firm and its partner company.

PRO-8 Director, Police Brigadier General Dionardo Carlos, said Wednesday policemen have been deployed to the mineral-rich island to prevent violence and not to protect the interest of investors.

"We would like to assure the public that the police regional office remains steadfast in our commitment to protect the populace, and not for the gains or interest of any of the contending parties. We deemed it necessary to deploy additional PNP personnel in the island to ensure the safety of Homonhon residents for any eventuality," Carlos told reporters.

Last February 8, the police began deploying members of the Regional Mobile Force Regional Battalion, Public Safety Battalion, and Guiuan town po-

According to her, while their office has not reported of any rabies cases in the city since 2006, stray dogs roaming in the streets remain to be a concern.

Thus, she said, there is still a need to sustain the campaign and ensure the safety of the public against stray dogs which, in more cases, have not been given anti-rabies vaccine.

Tension escalated in the island after Cambayas Mining Corp. president Yan Ming went to the island to enforce the liquidation order against Tech Iron Mineral Resources, Inc. issued by the Taguig Regional Trial Court 21.

Cambayas filed a claim in court alleging its partner firm, Tech Iron is not compliant with their profit-sharing agreement.

Tech Iron defended itself, saying that sharing will come from the net income of the operation. Cambayas drafted the agreement.

In November 2018, the court issued a resolution on the complaint favoring Cambayas, which its top official wanted to enforce even without a court sheriff.

Along with the Cambayas executives were some civilians who were supposed to replace the security personnel of Tech Iron.

Cambayas officials insisted on enforcing the court order, but Tech Iron persisted in following the proper procedure by letting the court sheriff serve it. Cambayas officials agreed to

Tech Iron is one of three mining firms operating in the island. The other two are Mt. Sinai Mining Exploration and Development Corp.; and Emir Minerals Corp. As of 2017, Tech Iron has a total of 620 workers. The firm kicked off its chromite mining in December 2015, covering 1,500 hectares.

Homonhon is more than 20 km. from the mainland of Guiuan town. The island is best known as the site where Ferdinand Magellan, a Portuguese sailor under the Spanish flag first landed in the country's soil after three months sailing in the Pacific Ocean on his way to the Moluccas Islands. (PNA)
