

With over 140 measles cases and 5 deaths **Cristina appeals to parents** to have kids vaccinated

TACLOBAN CITY- City Mayor Cristina Romualdez has asked parents to have their children vaccinated, particularly on anti-measles vaccine.

The call of Mayor Romualdez came as measles cases in Tacloban City continue to increase.

As of this week, the regional office of the Department of Health (DOH) reported that out of the 767 measles cases of the region, 145 of them were from Tacloban City. Five of

them have been confirmed dead due to measles.

"Our children should be vaccinated. The (parents) should not get scared to have their children vaccinated," Romualdez said.

The city mayor said that even adults who have not received anti-measles vaccines should get one to

avoid getting the ailment.

The DOH has confirmed that while majority of those who get sick due to measles were children, there were also adults who were afflicted of the ailment.

26 Eastern Visayas towns without fire stations, trucks: BFP

TACLOBAN CITY- At least 26 towns in Eastern Visayas lack firefighting facilities and many firefighters have no personal protection equipment, the Bureau of Fire Protection (BFP) reported on Wednesday.

Senior Supt. Renato Marcial, BFP 8 (Eastern Visayas) Director, said in a press briefing they also need nearly 1,000 additional firemen to meet personnel required for the region's 136 towns and seven cities.

The official said he hopes that the need would be addressed as soon as the Department of the Interior and Local Government has laid out its modernization program.

"Although some areas have no fire stations, they are still being served by BFP through clustering, like in some parts of Samar and Eastern Samar. Our mission is that by the year 2034, we will have a modern and highly capable fire service, but we will be able to achieve that earlier," Marcial said. Samar province has the most number of areas without fire stations and fire trucks. These are the towns of Almagro, Daram, San Jose de Buan, Sto. Niño, Tagapul-an, Talalora, and Zumarraga.

In Northern Samar, these are the towns of Biri, Bobon, Lapinig, Rosario, San Vicente, and Victoria. Without fire stations in Eastern Samar are the towns of Llorente, Maydolong, Mercedes, and San Julian.

Marcial said that even the more accessible towns of Leyte, such as Julita and Macarthur, do not have any fire station. Lapaz town has a fire station, but has no fire truck, according to BFP's record.

In Biliran province, only the island town of Maripipi has no firefighting facility.

Also included in the list are the towns of Anahawan, Limasawa, Padre Burgos, Pintuyan, and Tomas Oppus in Southern Leyte.

This is already a big improvement compared to 2015 where 56 areas in the region lacked fire stations

and trucks.

Procurement concerns in the past had been the setback in BFP's goal to establish a fire station, provide one fire truck, and at least four personnel in every town.

To establish one fire station and acquire a new fire truck, the BFP needs at least PHP22 million, Marcial said.

The BFP is stepping up its fire prevention drive in Eastern Visayas, even if fire incidents in the region have not reached threatening levels in the past years.

The official said the best defense against fire is the awareness of people on how to prevent such incidents in their own houses and in the community.

This Fire Prevention Month, the BFP will distribute information materials, conduct lectures, inspect all establishments, test fire hydrants, conduct fire disaster emergency evacuation planning, conduct drills, monitor hazard operations, and identification of fireprone areas.

DPWH completes anti-landslide project in So. Leyte

MAASIN CITY – Landslide and rock fall threats along a major road section in Southern Leyte have been eliminated with the recent construction of a P58.81 million slope protection project.

The project in Barangay Kahupian in Sogod town has applied Switzerland's rock protection netting technology as a permanent solution to recurring landslide and rock fall within the road that links Southern Leyte to Leyte province.

District Engineer Ma. Margarita Junia said about 140-meter stretch of the province's highway is now covered with high tensile it is ideal to invest in longterm solutions even if it entails more cost.

The project used high tensile wire netting to decrease the possibility of erosion and landslide in the area.

Aside from rock netting, the field office also installed stone masonry crib wall and gabions to stabilize the roadside slope and prevent soil erosion from blocking the roads. The DPWH field office here is stepping up its efforts in providing solutions to curb landslide, rock fall, and soil erosion in the province. The Mines and Geosciences Bureau of the Department of Environment and Natural Resources ranked Southern Leyte province as the seventh most vulnerable to heavy landslides in the Philip-

This method of slope stabilization uses rock or soil anchors to pin the netting to the slope and the addition of an erosion control mat designed to prevent landslides.

"The Kahupian, Sogod road section has been identified as one of the sections that are prone to landslides. We prioritized the implementation of this project to ensure the safety of the travelling public since this is frequently-used road section," Junia said.

In Northern Samar San Roque to become EV's seed production center

CATARMAN, Northern Samar-No less than Secretary Manny Piñol, representing the Department of Agriculture(DA), in the signing of a memorandum of understanding on the Rice Seed Production Project with the local government of San Roque, the Philippine Rice Research Institute (PhilRice) and other stakeholders on February 22 at San Roque, this province.

Sec. Piñol emphasized that the island of Samar has great potential with its large rivers and fertile lands. Unfortunately, he added, the three provinces in this island are all in the ten poorest provinces of the country.

He puts part of the blame on the past administrations for neglecting the island. But this time around, he says that the Duterte administration will change this fact.

"We should modernize agriculture in Samar. And our intention in San Roque is to transform this town into the seed production area of the whole Region 8. Dito natin sa San Roque uumpisahan ang pagbangon ng buong isla ng Samar. Because we would like Samar to be included, not in the list of the poorest provinces of this country, but in the list of progressive provinces in the country three years from now," Sec. Piñol declared.

Under the Rice Seed

Production Project, the investors' group, represented by Samar Island Seed Producers, will be leasing 200 hectares of land from landowners at P15,000/hectare every year for five years to be used as demonstration area for seed production. They will be teaching the method to other farmers in order for them to replicate the process.

"Led by seed grower Nathanael Fabila, the experienced seed growers and farmers will serve as the onsite instructors for the local farmers. We will provide equipment, financing and technology," Sec. Piñol said.

The Agricultural Credit Policy Council of the DA will initially allocate P40 million to fund the seed production project and start an orientation program for the prospective seed producers of the town.

Sec. Piñol further said that modern farming facilities and machineries will be utilized under this project.

The project is expected to turn San Roque into one of the biggest rice seed production areas of the country and a model farming area which will use solarpowered irrigation, laserguided field leveller, drones and a computerized geotagging and data encoding for farmers participating in the program.

"They will build a German-designed, typhoonresistant, dome-type warehouse. They will also be constructing seed-processing, drying, and packing facilities so that the rice seed will be ready for distribution after it leaves San Roque," Sec. Piñol added.

The seed production project is expected to supply the rice seeds requirements of about 200,000 hectares of rice fields in Samar and Levte.

According to Sec. Piñol, San Roque has been identified as an ideal area for the project, not only because of its abundant water and fertile soil, but especially because of the support of the local officials led by Mayor Don Abalon.

In return, the local chief executive is very grateful for this project, which is expected to inject more than P200-M to the town's economic activity.

Over 9,000 families in East Samar benefit livelihood aid of the provincial government

TACLOBAN CITY--At least 9, 281 families in Eastern Samar have benefitted from various livelihood assistance under its development banner program "Proyekto 25," said the provincial government in its report. Provincial administrator George Erroba said the program serves as an inclusive poverty solution in the province. "Proyekto 25' is our platform for development. It serves as the backbone, supporting the growth of Eastern Samar for the five years. We believe that if we reached the target of lowering the 46.3 percent poverty incidence in the province into 25 percent, Eastern Samar will change its direction," said Erroba. The program focuses on the development of

agri-fishery, tourism, governance, and health in the province.

In terms of its livelihood support, the province reported that it has recently distributed 101 various anti-poverty efgilts/sows with feeds, 491 piglets, 11,695 native chickens, 982 ducks, 515 goats, 5 egg-laying machines with 50 hens, 1, 200 broiler chicks with feeds, 28 tractors, and about 4, 371 sacks of fertilizers with other data to be accounted yet. The livelihood assistance amounted to P16.5 million given to 1, 670 Household-based Organizations (HBO) beneficiaries comprising 9, 281 families.

Floro Acaba, incharge of the community development and public affairs office, said that Proyekto 25 is a social preparation for the forts of the government.

The Metro Manila Subway Project

The first underground railway system in Metro Manila is underway. The project is to be completed by 2022 with the entire project to last until 2025.

The 36 kilometer subway was recently awarded to Japanese firms. It is expected to cut travel time from Quezon City to NAIA-3 to 30 minutes. In its first year of full operation, the P357 Billion rail system is expected to serve up to 370,00 passengers per day with a capacity of 1.5 million passengers daily.

This subway project is the "project of the century" in the Philippines. It's total cost is unparalleled for a single infrastructure project. The technology to be used for the project is unprecedented. A tunnel boring machines will be tapped to excavate tunnels using a circular cross-sec-



The objective of this project is to decongest traffic in Metro Manila. A flagship project under the government's "Build, Build, Build" program, the subway rail is being constructed with a loan from the Japan International Cooperation Agency (JICA).

Once completed, it will have 15 stations from Quirino Highway in Quezon City to NAIA Terminal 3 in Pasay City. With a speed of up to 80 kilometers per hour, travel time from Quezon City to NAIA Terminal 3 is expected to be reduced to 30 minutes.

The Duterte administration deserves the credit for pushing this type of project as a way of solving the traffic problem in Metro Manila. It is a step closer to modernizing the transport system in Metro Manila at par with other modern cities in Asia like Tokyo, Osaka and Seoul.

"Once it is sown, it springs up and becomes the largest of plants and puts forth large branches, so that the birds of the sky can dwell in its shade."

It is very moving to realize that what God is asking of us is actually very little in comparison to what he will be giving and doing for us. Another gospel episode that highlights this point is that of the miraculous catch of fish. (cfr. Lk 5,1-11)

Christ himself said: "Whoever has (referring to one's faith and trust in God) will be given more, and he will have an abundance. Whoever does not have, even what he has will be taken away from him."

(Mt 13,12)

Let's not forget that when we are sparing in our self-giving to God and to others, God will take away even the little that we have. The law that should rule our life is that of love, of total self-giving no matter what it would cost, though most times, the cost is really little only.

Only to a few people would some extraordinary sacrifices would be asked by God. For most of us, we would only be asked a little. The secret is to do God's will with pure faith accompanied by the best effort we could give.

And we do not have to wait for some special occasions or for some special persons to do this. The usual, ordinary events of our day and the ordinary people as recipients of our good deeds can be the good occasion to show our faith and love for God.

Fees for marriage applications and marriage licenses were also waived for the newly-weds and a free wedding reception was also sponsored for them by the local government.

Coinciding with the event was the launching of the #iLabaYu advocacy campaign of Oxfam with celebrity influencer and actress Camille Prats. The non-government organization partnered with the City Civil Registrar's Office for the program.

In Eastern Samar **Mayors unite for sea-to**shore protection alliance

BORONGAN CITY-Eight local chief executives in Eastern Samar forged an alliance for sea-to-shore protection.

On Feb. 13, the mayors of Dolores, Can-avid, Oras, Arteche, Sulat, Taft, San Julian, and San Policarpo (Do-COASTSS), all from the northern part of the province, formalized their alliance through a memorandum of agreement (MOA) signed with the support of the army, police, fisheries bureau, and the Eastern Samar State University (ESSU) at the ESSU conference hall, ESSU, Borongan City.

They united to protect the remaining fragile coastal and fisheries resources in this part of Eastern Samar and address management issues.

Areas of cooperation of the alliance include crafting of policies and programs, implementation of activities, and sharing of resources.

With the alliance forged, the eight municipalities vowed to pursue organizational development and capacity building, coastal law enforcement, coastal and fisheries resource management, information, education and communication and social marketing and sustainable

financing.

In her presentation, Mecelinda Cepe, national team leader for Tukod Project, a nongovernment organization supporting the alliance, shared that the fisherfolks go out fishing for longer hours but they catch less.

She added that they are investing more in fishing operations but earning less. "They are vulnerable to crisis and shocks. They, too, are marginalized," Cepe said.

Tukod, which means to "support, buttress or uphold," is supporting the alliance through INGO Center for International Studies Corp. and the Center for Emergency Aid International Studies with the financial support of the Government of Canada in response to Typhoon Yolanda's devastating impacts on the Visayas region of the Philippines.

Cepe added that municipal fishing production in the province has decreased by 88 percent since 2014 due to the depletion and degradation of marine and fishery resources, thus the need for the NGO and government intervention.

Can-avid Mayor Gil Norman Germino said he did not shy away from the shared responsibility as his LGU could not do the

task alone. He said they really needed everybody on board.

Of the eight local chief executives, six mayors came to personally share their commitment.

Present were Mayor Shonny Carpeso of Dolores, Mayor Norman Gil Germino of Can-avid, Mayor Viviane Alvarez of Oras, Mayor Thelma Nicart of San Policarpo, Mayor Virginia Zacate of Sulat and Mayor Dennis Estaron of San Julian.

Mayor Alvarez, the convenor, with Germino jested that the MOA they signed "signifies lifetime commitment" much like in marriage.

"We need the extraordinary work of ordinary people," Alvarez said.

Bureau of Fisheries and Aquatic Resources (BFAR) provincial fishery officer Nelia Tomayao witnessed the MOA signing and vowed her 100% support.

After the MOA signing, with their alliance formed, the eight-member team will soon be meeting again to synchronize their municipal ordinance on marine protection to achieve their dream of preserving and protecting the coastal resources that provide their people with livelihood. (NBQ/PIA 8-E Samar)

Leyte teachers urged to adopt ICT to respond to students' needs

KANANGA, Leyte-Public school teachers in Leyte are urged to adopt Information and Communication Technology (ICT)-enriched teaching and learning experience inside their classroom to "stimulate interest" of the students.

"Teachers who are digital migrants should take extra effort to learn to integrate the positive use of ICT in their lessons to connect with our current learners who are digital natives...Technology is the language of our learners today, thus we as teachers, should be able to speak the same language, for us to better understand each other," said Marilyn Siao, the assistant schools division superintendent in Leyte.

Siao added that the positive use of ICT in the daily performance of teachers for their students is one of the strands under domain 1 of the Philippine Professional Standards for Teachers (PPST). "ICT should be integrated and maximized in all subject areas. ICT use is not a substitute for teachers but should be a tool to make learning more meaningful and engaging," Siao told teachers during the three-day division training on Literacy through ICT held this town on February 22.

She cited the use of game-based learning platforms like Kahoot and Mentimeter and other interactive online activities "that can be used in boosting student participation." According to Siao, "learning and development system" as shift from "training and development" is now being piloted to six schools in Leyte giving emphasis on 10% formal learning, 20% relationship and discussionbased learning and 70% job-embedded learning.

"We can solve issues and problems about ICT literacy of our teachers in Leyte by intensifying Inservice learning and development activities focusing on teaching ICT as a skill and as a subject and teaching pedagogy in using ICT in teaching all subjects," said Boholano, who is also a Microsoft Education ambassador in the province.

Boholano, who will be part of the team that will be representing the Philippines in the upcoming Microsoft Education Exchange in Paris, France, lauded Leyte Schools Division Superintendent Ronelo Al Firmo for his leadership in pushing ICT programs to the teachers and personnel.

"It is a chance for me to be able to gain more knowledge and get insights from other educators around the globe on the best practices that they have in terms of ICT in Education. It is with great pride that we can also share to them our best practices in DepEd Leyte and the DepEd as a whole and showcase to them what are our activities and programs that advocate the proper and responsible use of ICT in learning all other subject areas," he said.

Popcom marks golden anniversary, set sights anew for 2019

Popcom Executive Director, Undersectary Juan Antonio Perez III said during the 50th golden celebration at the Popcom grounds in Mandaluyong, the PPMP continue to face critical challenges such as low acceptance and accessibility of family planning services particularly among poor couples and individuals, inadequate budgetary support, low coverage of promotional and demand generation activities, inadequate commodities and family planning service providers and workers especially in the rural and remote areas and the slow impact to social and economic and development.

However, Usec Perez said the PPMP is backed with a strong political support by the Duterte administration with EO 12 on attaining and sustaining zero unmet need and EO 71 which renames the office as Commission on Population and Development with the directive to strengthen the development and implementation of population related plans, policies, programs and projects in the pursuit of socio-economic development reforms and programs.

Also, he added, family planning and population management is cited as a critical component and strategy of the socio-economic agenda of the Philippine Development Plan for 2017-2022.
