From its P7.9B original budget

Tide embankment project to balloon

GOVERNMENT CENTER, PALO, Leyte- The cost of work of the Leyte tide embankment project is expected to balloon from its original cost of P7.9 billion.

This was disclosed by Engr. Serafin Lago, Jr., road heightening on tide embankment project manager, who said that the increase of the project cost is intended to pay lot owners who refuses to provide temporary access road leading to the construction sites.

According to Lago, the refusal of these owners to give them access road may pose a problem for the completion of the project by 2020. "Because of the demand of the lot owners in providing us access road, we will now include it in our budget which will result to the increase of the project cost," Lago said.

He, however, could not say how much the projected increase would be. The tide embankment project involves more than 50 barangays from the towns of Palo and Tanauan and Tacloban City. And since the project started January of last year, they have about 23 to 25 percent accomplishment, Lago said.

Blast fishing kills baby dolphin in Ormoc City

TACLOBAN CITY- The stranded baby dolphin injured by blast fishing died early Wednesday morning while being treated by local fishery officials in Ormoc City, said the Bureau of Fisheries and Aquatic Resources (BFAR).

BFAR Regional Director Juan Albaladejo said the dolphin calf died two days after it was rescued.

"The male dolphin had abrasions on his body. The stranding was due to acoustic trauma caused by blast fishing since the inner ear drum was damaged," Albaladejo said in a mobile phone interview.

Acoustic trauma is an injury to the inner ear that's often caused by exposure to a very loud noise such as explosives.



"Since its rescue last Monday, there has been a clear manifestation that the baby dolphin is unstable and not due for release anytime soon," the BFAR official said.

A fishermen rescued the 131-centimeter baby dolphin on the shallow part of

Arrest of a top NPA leader a big blow to the movement in N. Samar, says Army official

TACLOBAN CITY—The recent arrest of an alleged top leader of the communist' armed group operating in Northern Samar was considered as a big blow by the government forces to the rebel movement in the province.

On July 13, Marieta Bartolo, 46, identified to be the front secretary of Metro 1, SRC Emporium, said to be a unit of the New People's Army operating in the towns of Pambujan, San Roque, Silvino Lubos, Las Navas, Mondragon, and Catarman, the provincial capital of Northern Samar by combined elements of the 803rd Infantry Brigade and the provincial police personnel.

The arrest of Bartolo came at a time that the peace negotiations between the national government and the Communist Party of the Philippines- National Democratic Front (CPP-NDF) have bogged down.

Northern Samar remains to have strong presence of NPA members.

Captain Ryann Velez, civil-military operations officer of the 803rd IB based in Catarman, said that the arrest of Bartolo was a big blow to the armed movement considering that she is considered to be a high-ranking official.

"Her arrest is a victory to us. But at the same time, we are not taking the sole credit of her eventual arrest as we received help from the police and the people in the community that led to her and her companions' arrests," Velez, in a phone interview, said.

Velez said that Bartolo was arrested on board a vehicle owned by Ruth Figueroa, former ABC (association of barangay chairmen) president of Catarman in Barangay Bankerojan of said town at about 4:30 pm.

Figueroa, who is the incumbent chairwoman of UEP Zone 3, was also identified by government forces as the provincial

leader of Bayan-Muna, tagged by Armed Forces as a front of the communist group.

Also arrested were Danny Basilyo, 36, and a resident of UEP Zone 3; Emboy Loberiano, 21, a resident of Brgy. Caligang, Catarman; and Gil Mijares, 45 of Brgy. Ipil-Ipil, Catarman and said to be the driver of the vehicle.

"They were from the house of Figueroa and were on their way to the Catarman proper when they were arrested," Velez said.

"We cannot say yet what their relationship to each other as they refused to answer questions during their interrogation by the police. But considering that Bartolo is a high-ranking leader of the movement, we can just guess that they knew each other and probably belong to the same movement," he added.

Seized from the suspects were six units of different firearms and cash worth P330,000, among others.

A complaint of illegal possession of firearms were filed against all four

suspects before the Provincial Prosecutors' Office hours after they were arrested.

A complaint of obstruction of justice was also filed against Figueroa and their three male companions.

At the time of the incident, the government forces were tailing the vehicle where the suspects were on board to serve warrants for murder, double murder, and frustrated murder, among others, against the alleged NPA leader. An informant provided a tip that Bartolo was on board of the said vehicle.

However, instead of stopping the vehicle, the suspects continued to sped off which resulted for the authorities to hit the tires of the vehicle which led to the arrest of the suspects.

Except for Figueroa who is now confined at the Northern Samar Provincial Hospital after suffering a mild stroke while undergoing mug shots, Bartolo and the three male companions are detained at the lock-up facility of the Northern Samar Provincial headquarters. (JOEY A. GABIETA)

Hands-only CPR awareness campaign, demo held in Tacloban City

TACLOBAN CITY – Some 1,616 participants took part in the Nationwide Hands-only CPR (Cardiopulmonary Resuscitation) Awareness Campaign at the Tacloban City Convention on July 16, organized by the city government of Tacloban through Mayor Cristina G. Romualdez and the Philippine Heart Association, Inc. (PHA) composed of cardiologists in the region.

City government workers and barangay residents attended the half-day event which imparted life-saving techniques.

Present during the activity to impart their expertise were the staff of the Office of Civil Defense, Tacloban City Rescue Unit (TACRU) and other volunteer medical groups.

PHA Eastern Visayas chapter president Dr. Ma. Belen Balagapo said the event is part of the advocacy to teach basic life support

skills to lay people.

"CPR is no longer limited to medical practitioners...because 70% of cardiac arrests happen at home and usually, the first responders are relatives or bystander," said Balagapo.

A quick lecture and demo on "hands-only" CPR and the use of Automatic External Defibrillators (AED) for heart attack victims highlighted the awareness campaign.

Hands-only or modified CPR do not involve mouth to mouth breathing but requires doing proper and effective cardiac compression—basic skills needed to save a life.

PHA is also advocating the use in public places and business establishments of AEDs - an electronic device which can diagnose irregular heartbeat.

AED is an essential part of the CPR Chain and can increase survival of heart attack victims

The local government of Tacloban has also already made AEDs available at the Tacloban City Rescue Unit and the Tacloban City Hall. It is currently in the process of securing additional units for other areas in the city.

Meantime, the mass CPR campaign is rooted in Republic Act 10781 or "The Basic Life Support Training in Schools Act" which mandates the teaching of CPR in schools and the grassroots level.

Special projects for health head, Dr. Gloria Fabrigas said that free mass CPR training is done yearly in Tacloban in partnership with PHA to reach as many Taclobanons as possible and help save lives.

In a similar activity last year the PHA in partnership with the City Government trained 1,270 in Tacloban.

Mayor Romualdez issues order for City Hall employees to observe waste segregation, recycling at their work stations

Specialized carton boxes that will be utilized to collect useful segregated materials were also distributed during the orientation. The collected materials are made into saleable handicrafts by the jail inmates.

TACLOBAN CITY-To advance the city government's waste management initiatives, Mayor Cristina G. Romualdez has instructed the different city government offices to practice waste segregation and recycling.

In a memorandum dated July 4, 2018, the chief executive mandated the effective use of garbage bins assigned to each office and those placed in strategic locations inside the City Hall building and its premises.

The mayor likewise, enjoined the offices to support the Clean Green and Resilient City Program and the "Basura Mo, Pakabuhi Ko" livelihood initiative which benefits the inmates at the Tacloban City Jail by collecting residual waste (e.g. junkfood/coffee wrappers, newspapers, magazines, etc.) and recyclable materials (e.g. plastic bottles, plastic utensils, used bond paper, etc.).

On June 11, administrative officers from the different city government offices attended an orientation on waste management and recycling organized by the City Environment and Natural Resources Offices (CENRO).

Ordinance No. 2017-13-37 or "An Ordinance providing for an Integrated Ecological Solid Waste Management for Tacloban City" provides for the segregation of garbage at source as one of the effective solid waste management initiatives. (CITY INFORMATION OFFICE)

Annual price changes in Alcoholic Beverages and Tobacco decreased by 2.1 percentage points, but still recorded a double digit inflation rate of 22.0 percent, the highest among all commodities. Clothing and Footwear and Housing, Water, Electricity, Gas and Other Fuels likewise shed off by 0.4 percentage point and 0.2 percentage point, settling at 0.9 percent and 5.6 percent, respectively.

Communication recorded zero inflation rate

during the month in review, while Recreation and Culture, Education, and Restaurants and Miscellaneous Goods and Services retained their previous month's rates of 0.9 percent, 3.5 percent, and 1.6 percent, respectively.

The Purchasing Power of Peso (PPP) of the region remained at P 0.81 in June 2018. This PPP implies that goods and services worth 100 pesos in June 2018 only costs 81 pesos in 2012.

Eastern Samar, Northern Samar and Southern Leyte registered a 0.01 centavo decrease in the PPP compared with their figures in May. Whereas, Biliran recorded a 0.01 centavo increase in PPP, while the rest of the

DepEd mourns teacher who killed self

TACLOBAN CITY-The Department of Education (DepEd) Leyte division has extended its "deep sympathies" to the bereaved family of a 21-year-old grade school teacher who killed herself on July 12.

"The schools division of Leyte personally extended condolences and deep sympathies to the bereaved family of teacher Emylou Malate. We are saddened and in pain over this incident," it said in a statement.

Malate, single, started her teaching job in a multi-grade class at Bagacay West Primary School, an upland school in La Paz town, just last June 21 of this year.

Senior Inspector Ernie Rocha, officer-in-charge of La Paz Police Station, said that Malate committed suicide by hanging herself as relayed by Malate's father, Rodulfo.

Based on the police interview conducted with the victim's father, it was revealed that Malate committed suicide due to depression.

Three suicide notes addressed to her mother and alleged boyfriend were recovered at the scene.

In her suicide letters, Malate mentioned the word "weak" three times.

Malate's parents also

ize that in our everyday engagement with teachers we will consider the fact that each one has different emotional stability," Edgar Tenasas, the assistant schools division superintendent, said.

Tenasas and other division officials personally visited the family of Malate to convey their condolences and inquire about the incident.

Amid the death of Malate, Tenasas also urged school administrators to consider in their yearly crafting of annual improvement plan (AIP) the regular conduct of team building and other activities that will lead to the personal development of teachers.

Meanwhile, DepEd Regional Director Ramir Uytico said that it's "still too early to judge" that Malate's work as a teacher was the reason why she committed suicide.

"Ang teacher talaga has to do his or her part. Pag mag-apply ka sa DepEd, alam mo na ang mga challenges ng DepEd," Uytico said over a radio interview.

Eastern Visayas inflation rate hits record high in June at 6.3%

TACLOBAN CITY-The annual Inflation Rate (IR) of Eastern Visayas rose to a record high of 6.3 percent in June, posting the highest since January 2018. This IR was 0.5 percentage point higher compared with the 5.8 percent IR a month ago, and 3.0 percentage points higher than the recorded 3.3 percent IR in the same period last year. The regional inflation rate was 1.1 percentage points higher than the 5.2 percent national average in June.

All provinces in the region registered higher inflation rates in June compared with their figures in the previous month, except for Biliran, the only province that has registered a decrease of 1.1 percentage points, from 6.0 percent in May to 4.9 percent in June.

Northern Samar posted the highest increase of 2.3 percentage points, from 5.5 percent in May to 7.8 percent in June. The rest of the provinces recorded increases ranging from 0.2 percentage point to 0.9 percentage point.

Northern Samar had the highest IR at 7.8 percent, while Southern Leyte posted the lowest at 1.4 percent.

Man nabbed in possession of shabu worth P170,000

TACLOBAN CITY-Anti-drug elements of the Philippine Drug Enforcement Agency (PDEA 8)-Tacloban City Office, TCPO PS2 and CIB arrested another newly-identified drug personality during the conduct of a buy-bust operation in Barangay 86, San Jose, this city, on July 13, 2018 at around 4:30 pm.

In a report submitted to PDEA Director General Aaron N. Aquino, elements of PDEA RO8-Tacloban

City Office under Director Edgar T. Jubay, TCPO PS2 and CIB identified the suspect as Renato Lavinia, alias "Jun", 43, married, driver, and a resident of Brgy. 86 San Jose, this city.

Purchased and confiscated during the said operation were seven pieces of heat-sealed transparent plastic sachet containing white crystalline substance suspected to be shabu weighing more or less 25.0 grams with an estimated

market value of P170,000 and various drug paraphernalia.

Lavinia will be facing charges for violations of Section 5 (Sale of Dangerous Drugs), Section 11 (Possession of Dangerous Drugs) and Section 12 (Possession of Drug Paraphernalia), Article II of RA 9165.



However, at 39, the greatest Asian boxer is no longer the same old fighter who used to knockout opponents. His desire to fight against elite young fighters like Crawford and Lomechenko could be a very dangerous decision. He still has the skills but for how long? He will be 40 on December 17, how long can he sustain his competitive form? It's better to stop while you are at the top than to stop a losing fighter. He has nothing more to prove. He has fought

the best fighters of his time like Mayweather, De la Hoya, Marquez, Morales and Barrera. There will be no more Pacquiao again. There is only one Manny Pacquiao in our lifetime.

President Duterte and some fellow Senators were right in calling for Pacquiao to retire. Pacquiao has nothing more to prove in his colorful career. He is already a boxing legend, a self-made man who became a billionaire and politician whose boxing skills captivated millions around the world.

His former Coach Freddie Roach was right when he told Manny “You should choose only one, a boxer or a politician you cannot have both”. Indeed, he has everything. Time to hang up his gloves. You are already enshrined as the greatest Filipino boxer with 8 world titles no boxer has ever achieved.

Remember Muhammad Ali. He never learned to retire at the right time.

Guiding souls

THIS is quite a tough job. To guide souls is indeed a very delicate job. It requires nothing less than entering into the inner life of a person with the intention of helping and of eventually leading that person to God. But how can this be?

Priests are supposed to be sacramentally configured to Christ as head of the Church and therefore as the ultimate guide of souls, the redeemer of mankind. They are supposed to have the very mind and sentiments of Christ. And if they are truly vitally identified with Christ, they will also share in the power of Christ.

But is this possible at all? If we have faith, the answer is yes. The sacrament of Holy Orders configures one to Christ with an effectivity that is called in Latin as “ex opere operato.”

It means that by the mere reception of the sac-

rament and as long as there is no formal impediment to such reception, that sacramental configuration is achieved, not so much by the qualities and dispositions of the recipient as by the power of Christ himself.

Would we think that the apostles had the qualities and dispositions of becoming the first bishops in the Church? If we are to go by our human standards, we would have serious doubts about that. But Christ made them our first bishops, and bishops they were.

The priestly ideal of being another Christ as head of the Church will certainly demand everything from them. But given that priests are men, with their own share of weaknesses and all that, that ideal will be pursued in stages at best, with its own ups and downs, its twists and turns, its drama.

We, priests, should do our part of resembling more and more like Christ

Amid suicide of teachers due to depression

DepEd official encourages support system among teachers

GOVERNMENT CENTER, PALO, Leyte- An education official here in Leyte has encouraged teachers to have a support

"They report to the school with different emotional ability. There is a need for us to be more caring, understanding, and tolerant," he said.

16 schools in S. Leyte get rainwater collectors

MAASIN CITY - The Department of Public Works and Highways (DPWH) field office here has started installing a new batch of rainwater collection systems in 16 schools in Southern Leyte aimed at curbing water shortage and promoting water conservation in the province.

Recipients of the project are national high schools (NHS) in Libhu, San Rafael, Asuncion, Ibarra, Guadalupe, Dongon, and Maasin City National High School in Maasin City; Ichon and Villa Jacinta in Macrohon town; Lungsodaan in Hinundayan town; Hinunangan in Hinunangan town, Liloan in Liloan town, Himbanagan in St. Bernard Elementary school

(ES) recipients are in Padre Burgos town and Asuncion Integrated School in Maasin City.

The P3.4 million project is part of the climate change adaptation of the administration to curb water shortage by maximizing the use of rainwater.

"With this kind of innovative initiative, we hope that in the future, the growing concern of diminishing water supply for sanitation in particular places will be fully addressed," said DPWH Southern Leyte chief Ma. Margarita Junia.

Rainwater collector system harvests, collects, and stores rainwater from the roof, groundwater catchment or multipurpose pavement to store it in tanks with capacity of 4,000 liters.

Accumulated rainwater is distributed to toilets, wash rooms, and other utilities through pipes or faucets attached to the system. In 2016, the DPWH installed 15 rainwater collection systems in Southern Leyte province.

The project aims to answer the perennial concern in water shortage in Southern Leyte due to over extraction of groundwater, water pollution, illegal connections, water pipe leakages, faulty water meters, and climate change. (PR)



Leyte's second engineering district to implement farm-to-market road projects worth P39.4 million funded by Pamana

CARIGARA, Leyte- The Department of Public Works and Highways (DPWH) - Leyte Second District Engineering Office will implement a total amount of P39.4 million road rehabilitation projects funded under Payapa at Masaganang Pamayanan (Pamana) Program.

According to District Engineer Carlos G. Veloso, the Pamana program is being implemented by the government to reduce vulnerabilities, improve governance, and empower fragile communities.

"This involves socio-economic interventions to isolated and conflict-affected areas not only to foster sustainable development but also to avoid recurrence of sources of conflict," added Veloso.

Among the three Pamana projects, two were already bid out, the rehabilitation of a farm-to-market road in Barangay Lanawan in MacArthur, Leyte in the amount of P19.7 million and the rehabilitation of the same project in Barangay Patag, Burauen, also in Leyte, worth P9.85 million.

Brgy.Lanawan is an upland community with it's mostly farmer residents are growing corn, coconut and root crops (cassava, gabi, camote) and banana.

The farmers of the village formed into a group who bought two hectares of land and developed it into an organic farm supplying high value vegetables in Tacloban City.

An organic piggery of 75 heads, a corn mill and a farm to market road was accessed by the association.

The rehabilitation of the farm-to-market will greatly help the farmers bringing their farm produce to the main city.

Meantime, the rehabilitation of Conzoilo farm-to-market road in Jaro, Leyte worth P9.85 million is awaiting for modification.

Villa Conzoilo is an upland village seven kilometers from the poblacion of Jaro, is a budding farm-tourism destination in Leyte that has attracted both foreign and local visitors since it opened in May last year.

Villa Conzoilo, the farthest village of Jaro at the foot of Mount Aman-daweng, was once a hotbed of insurgency like all its neighboring communities.

Pamana programs envisions to improve governance through partnerships with national and local institutions, building capacities or governance, and enhancement of transparency and accountability mechanisms.

It also into reducing poverty and vulnerability in conflict-affected areas through sustainable rural development, community infrastructure and focused delivery of social services.

As well as empowering communities and strengthen their capacity to address issues of conflict and peace through activities that promote social cohesion.

Veloso said that the road rehabilitation will not help reduce conflict in the area but help uplift the poor living conditions of the families. (LIZBETH ANN A. ABELLA)

There, while yet inside, I started to feel the terrible pain on my head, chest, left shoulder, and back. I could not lift my left arm anymore, my head feeling dizzy. When my neighbors came to the scene, I could not even tell them exactly what happened as I was catching my breath, my face grimaced in pain.

What a stupid mistake on my part. And what an accident. Good thing a neighbour with a car brought me to the hospital. I needed to have some x-rays, besides a necessary confinement, to determine if I had fractures on the skull and ribs. Thank God I only got bruises, muscle sprain, and torn ligaments. What a lesson to learn from.

Eastern Visayas has a new minimum wage order

TACLOBAN CITY – The Regional Tripartite Wages and Productivity Board (RTWPB) in Region 8 has released a new wage order for Eastern Visayas effective June 25, 2018.

Wage Order No. RB VIII-20 entitled “Prescribing a New Minimum Wage Rates for Eastern Visayas” specified reclassification of the industries and sectors as well as increases in basic wage and the integration of the Cost of Living Allowance (COLA) to the new basic wage.

Under Section 2 of the new wage order, there shall be an increase in the basic wage, as follows: P20 per day for non-agriculture; P30 per day for retail/service employing 11 up to 30 workers (now merged to non-agriculture); P22 per day for cottage/handicraft; P30 per day for retail/service employing 10 workers and below; P24 per day for

non-sugar farm agriculture (now collapsed under agriculture); and P30 per day for sugar farm agriculture (now collapsed under agriculture).

With above increases made, new minimum wage rates are as follows: P305 for non-agriculture including retail/service employing 11 up to 30 workers; P275 for cottage/handicraft; P275 for retail/service employing 10 workers and below; and P275 for agriculture.

Section 3 of the new wage order emphasized that the said wage increase prescribed shall be for the normal working hours, which shall not exceed eight (8) hours a day.

RTWPB VIII Board Secretary Reynaldo Soliveres said that the issuance of the new wage order was a result of different sectoral wage consultations conducted by the Board in Catarman, Northern Samar on March

14, 2018; Catbalogan, Samar on March 15, 2018; Borongan, Eastern Samar on March 16, 2018; Ormoc City on March 21, 2018 and Maasin City on March 22, 2018.

“The series of consultations and public hearing conducted in the region revealed that there is really a need to increase our minimum wage. Of course, we also took into consideration the viability of businesses in the region”, said Board Secretary Soliveres.

Wage Order No. RB VIII-20 was approved last May 7, 2018 by Orlando C. Uy (employers’ representative), Miguel T. Tezon and Efren M. Gabriola (workers’ representatives), NEDA Regional Director Bonifacio G. Uy (vice chair), DTI Regional Director Cynthia R. Nierras (vice chair) and DOLE Regional Director Cyril L. Ticao (chairman). Farmers with physical disabilities thrive in Leyte

STA.FE, Leyte- Born with a physical disability, Violeta Milar of Sitio Pulak of Barangay San Isidro, this town, did not lose any hope in life.

Her condition did not stop her from sup-

porting her family. She worked as a canteen crew despite her condition.

After super typhoon 'Yolanda' struck the province on November 8, 2013, her family was one of the very first families to be relocated in Barangay San Isidro where she became the president of the These Abled Person Teirra Esperanza Farmers' Association (TAPTEFA).



Despite her physical disability, Violeta Milar manages to deal with the hardships beyond the limits of her abilities.

TAPTEFA is an association composed of farmers who have physical disabilities.

As the president, Milar knew she had to do something for the association. So together with the other members of TAPTEFA, they went

to Governor Leopoldo Dominico Petilla and asked for a livelihood assistance.

Immediately, their association underwent a four-month season-long training for high value

vegetables and fruit crops. Despite the members' physical disabilities, they were able to grow quality agricultural products. On February 22, 2018, they started their egg-

laying project given by the governor. Through their hard work and determination, the project became successful in just a span of time. The few number of chickens that they had before grew and has now reached around 1,400 heads.

These chickens produce 45 to 45 to fifty trays of eggs every day and provide the association with enough income for each of its members.

They sell the eggs for P150 to P170 per tray depending on the size. Often times, they encounter shortage of the egg supply because of the increasing demand of orders from the customers.

According to Milar,

cooperation has led to their success. Their so-called 'rotation of duties' where some members are assigned to clean the chicken cage, some to segregate the eggs in sizes, and others to feed the chickens hasten their work.

They feed the chickens three times a day and a total of 45 jags of water. They also use organic vitamins and apply natural methods in treating their chickens.

The joy that this egg-laying program has brought to all the members of TAPTEFA is more than enough for Milar to thank everyone who gave their trust and support to them.

"As a person with disability and president of TAPTEFA, I am very happy that we (PWDs) are not being left behind in our society because Governor Petilla cares for us and helps us improve our lives," she said.

"We may not all have the same situations and there may be differences among us in other aspects of life, every one still has a role to play and nothing in this world can hinder us. As an association, TAPTEFA has endeavored the challenges that's why today, their story has proven that not even physical impairment can disable them from doing the best out of their abilities," Milar added.

Leyte upland teachers remain positive amid struggles

BURAUEN, Leyte – Public school teachers serving in upland communities here shared stories on how they stayed strong despite financial, family and work-related struggles.

Airen Modina, 39, admitted that she tries to be emotionally numb every time she notices that some of her pupils go to school barefoot, with empty stomach and only one notebook for eight subjects.

"Although I am mindful of their plight, I have my own burden to bear. My husband has been suffering kidney failure for three years now and the only way for him to survive is through dialysis, which is very costly," said the mother of two, who has been in the teaching profession for more than a decade.

Modina is a Grade 6 teacher of Catagbacan Elementary School, a small campus in a farming community nine kilometers upland from the town center.

The teacher and some family members chip in P23,400 every month for her husband's monthly dialysis. She only gets P6,900 monthly net salary, with P18,000 cut due to loan deductions.

Since she's considered as better off than other siblings, she is obliged to provide financial support to her parent and nieces.

"Yes, life is more burdensome with so many work-related problems such as paper works, class-

room maintenance, poor performing pupils, but I have to be strong to see my children live a better life in the future. I have been very prayerful and positive that the best is yet to come," Modina shared.

New high school campus revives hope in upland Leyte communities

BURAUEN, Leyte – The local government here has established a high school in an upland farming community in a bid to encourage more elementary graduates to proceed with secondary education.

School head Adolfo Raga said they have to start classes in makeshift classrooms at the Buraburon National High School this school year as 90 students have signified their interest to study in the new campus closer to their homes.

"Since we don't have



many children stopped going to school after Grade 6. The campus is projecting about 200 enrollees every year.

The local government had set aside P3.2 million for the site development and construction of a three-classroom building in Brgy. Tagadtaran, some 13 kilometers upland from the town center. Completion of the new building is set early next month.

"The new high school will bring hope to hundreds of elementary graduates who have been discouraged by distance to continue learning," Raga said. One of the student is

a 21-year-old father who graduated elementary nine years ago, according to the school official.

"Many of our enrollees have been out of school for years. We're planning to come up with a way to help them catch up with classroom learning," Raga added.

The farthest barangay covered by the new campus is Villa Corazon where children have to spend P120 daily for transportation to study in the nearest campus in town.

Christian Caca, 14, a Grade student from Tagadtaran said his family saved a lot after he trans-

ferred to the new campus. "Last year, I spent P60 daily for fare alone, but now P12 is just enough daily for my refreshment," the aspiring professional basketball player said.

The Department of Education regional office in Palo, Leyte approved the school opening through a memorandum issued on May 17, 2018, but have not yet provided maintenance funds pending some documentary requirements. Due to high number of dengue fever cases

Baybay City under state of health emergency

TACLOBAN CITY- Due to rising number of dengue cases, the city government of Baybay City is now under a state of health emergency, hastening the procurement of needed medicines and a fogging machine.

Dr. Norberto Oja, city health officer, said that as of Thursday (July 19), there were 193 confirmed dengue cases in Baybay covering from the start of the year.

Last year, there were more than 200 dengue fever cases in Baybay with no death recorded.

But for this year, the mosquito-causing ailment has already killed one child each from the villages of Hipusngo, Zones 5 and 6.

Oja said that dengue fever cases were monitored

to have detected in almost all of the city's 92 barangays with the villages of Hipusngo, Guadalupe, San Isidro, and Zone 5 having the highest number of cases.

"We are addressing the problem with the help from the regional office of the Department of Health (DOH) as well as from the provincial health office," Oja, in a phone interview, said.

According to Oja, Mayor Carmen Cari, upon the recommendation of the City Health Office, declared a state of health emergency in the city on July 10.

The declaration would mean that the city government could now fast track in the procurement of needed medicines and equipment like a fogging machine to address the rising number of dengue fever cases.

Oja, however, could not say how much the city government would allocate for this purpose.

The city government is to buy a fogging machine as of its two current fogging machines, one has bogged down. A fogging machine cost around P50,000, the health officer said.

It was learned from Oja, that they are now conducting massive 'search and destroy' operations on breeding places of dengue-causing mosquitos as well as fogging operations.

Based on the monitoring of dengue fever cases in the region by the DOH-8, as of this week, 16 people have died and about 1,179 others were afflicted due to dengue fever.

DSWD start releasing pay out for UCT beneficiaries in the region

TACLOBAN CITY- The regional office of the Department of Social Welfare and Development (DSWD) is targeting to complete the pay out of social pensioners under the its uncondi-

tional cash transfer (UCT) program by the end of this month.

The distribution of UCT to social pension beneficiaries is a government intervention after implementing the Tax Reform for Acceleration and Inclusion or TRAIN Law that affects fuel prices triggering for the increase of prices of basic commodities.

Each social pensioners will be receiving additional P200 cash grant every month.

DSWD Regional Director Restituto Macuto said that the simultaneous pay-out started last Friday (July 20) and will end on July 31.

However, this target may be extended considering the large number of beneficiaries that are expected to receive the cash grant.

The request of local chief executives to bring the pay-out in their respective localities is also a problem considering that Landbank of the Philippines has only 15 branches in the region covering its seven cities and 136 municipalities.

Macuto said that lack of Land Bank outlets was the reason why they were

not able to meet the original deadline, which is this month, in the distribution of the UCT.

He added that bank personnel could not also handle the influx of beneficiaries going to their bank during banking hours.

Here in the city, a total of 4,902 social pensioners are to receive the cash grant from the DSWD which will be divided into two batches, half of the total beneficiaries will receive the cash grant that is to be distributed at Balyuan Park in the morning while the remaining half receive their share in the afternoon.

Macuto said they consider the conditions of the social pensioners who have delicate conditions and may not be able to withstand severe weather and standing for hours reason why they have to do it at the Balyuan Park.

Macuto added that aside from the UCT for social pensioners, beneficiaries of the Pantawid Family-ang Pilipino Program will also receive additional P200 a month.

Tacloban council to approve P9 as MCH fare

TACLOBAN CITY- The committee on transportation and terminal administration of the Sangguniang Panlungsod here has endorsed a P9 fare hike for motorcycle-for-hire (MCH) during a public hearing conducted on Thursday (July 19).

The P9 fare agreed by the committee, which is chaired by Councilor Edward Frederick Chua, however, is lower by P1 compare to the demand of the Tacloban Federation of MCH Drivers and Operators, Inc. (TAFEMADO).

The group, headed by

its president Joseph Tangel, had earlier passed their position paper demanding that the current P8 MCH fare be increased to P10 covering within the city's main streets.

The group cited the rising cost of gasoline, the implementation of a rerouting scheme by the city government which is taking longer routes, and the enforcement of the TRAIN (Tax Reformation and Acceleration and Inclusion) Law as reasons why they were demanding for a fare increase.

"Due to these circumstances, we appeal to the

honorable Sangguniang Panlungsod (members) and the honorable Mayor Cristina Romualdez for fare increase to MCH from the current P7 for the two kilometers to P10 for the first one kilometer and additional P1 for succeeding kilometer," the group on their May 7 petition submitted to the city council said.

They also asked for a fare for a 'special trip' which means routes outside the main streets of the city.

The group, cited as an example, that a ride from downtown area to Abucaay bus terminal would have a fare of P48.

They used the current fare of public utility jeeps at P8 multiplied by 3 (seating capacity) and multiply again by 2 (round trip).

But during Thursday's public hearing held at the Legislative Building, the Chua committee agreed with a proposal made by a commuter to just put the fare hike at P9, Councilor Jerry Uy, member of the committee, said.

Councilor Uy said that a P9 MCH fare within the city streets is 'reasonable' reason why the committee would endorse it to the entire city council for approval.
