# Pres. Duterte ask locals to preserve the bells

BALANGIGA, Eastern Samar- President Rodrigo Duterte witnessed the turnover of the three historic bells named after this town as he urged the townfolks to secure the historic bells.

The President arrived at the venue of the turnover rites about an hour late from his 4 pm schedule which was attended by US officials, Filipino and American veterans, Cabinet members led by Defense Sec. Delfin Lorenzana, and Church officials led by the papal nuncio, Archbishop Gabrielle Caccia and Davao Archbishop and president of the Catholic Bishops Conference of the Philippines, Romulo Valles.


"I am sure that our ancestors are celebrating with

us here on this remarkable victory. And that it does not only bring back the glory of the town, but also contributes to the full restoration of our dignity as a Filipino," Mr. Duterte said on his six-minute speech he read during the rites held at the town's covered court which is adjacent to the St. Lawrence The Martyr Church where the bells were turned over immediately after the civilian rites.

"I therefore trust that our kababayans in Balangiga and the rest of our country would ensure the

protection of these gems are continued to preserve and promote our culture and history," the President added.

## DepEd's Uytico to region's campus journo: Be competitive for the national press conference

TACLOBAN CITY- Department of Education (DepEd) Regional Director Ramir Uytico urged student journalists and performers to excel in their chosen field.

## Want to coordinate with her E. Samar counterpart Samar Gov. Tan sees big tourism potential of Balangiga Bells

BALANGIGA, Eastern Samar - Boost in tourism arrivals in this town is projected with the return and installation of the historic bells, 117 years after these artifacts were carted away by the American troops during the Filipino-American War.

And with this, Samar Governor Sharee Ann Tan said that she would just be glad to coordinate with her counterpart in Eastern Samar, Governor Ferdinand Marcelo Picardal, to cash in on the Balangiga Bells as a tourist attraction.

Tan disclosed that she already had an initial meeting with the Department of Tourism on this regards.

"I hope that Eastern Samar will be glad to collaborate with Samar regarding the tourism program," the Samar governor, who was among those invited during the turnover of the three Balangiga Bells on Decem-

ber 16 witnessed by President Rodrigo Duterte.

Tan is vigorous in promoting the tourism industry of Samar through her Spark Samar campaign.

Meantime, Gov. Tan said that the much anticipated lighting of the San Juanico Bridge, another iconic structure in the region which connects Leyte and Samar islands, will happen next year.

The San Juanico Bridge lighting is also projected to draw tourists.

Tourism Regional Director Karina Rosa Tiopes

said that their office has allocated for the improvement of the Balangiga Incident Marker worth P9.7 million and acquisition of livelihood gadgets worth more than P600,000.

The DOT will also conduct assessment of residents of the town who are willing to be part of the homestay program as accommodation facilities are one of the top problems in Balangiga which has no such facility available.

"Enhancing other tourist destinations in Balangiga will make visitors stay longer, giving them the opportunity to get to know our people, experience our culture, taste our cuisine and discover the infinite escapes in Eastern Visayas," DOT Regional Director Karina Rosa Tiopes said.

## Retrieved at last

**T**he return of the historic Balangiga Bells after more than a century of staying outside the country had sparked so much jubilation among the Filipino people that, acting like overjoyed children in the homecoming site and in front of televisions and the internet, they sounded as though they had received the greatest Christmas present from Uncle Sam.

Why these bells are in demand could be explained partly by their symbolic existence. They actually stand for courage, heroism, and death. Used by the natives as signals to synchronize attacks, these bells are witnesses as to how the lowly and persecuted people of Balangiga and its neighboring villages attacked the abusive American forces stationed in the area. The heroic act led to massive deaths from both sides.

Furious over this incident, which the Americans considered as a cowardly act of treachery, as a massacre (but is refuted by Filipinos as an

encounter since the Americans, being combatants, were soldiers who could battle at all times), the US forces took these "deadly tools" and brought them home as war relics. In retaliation, moreover, they mercilessly murdered thousands of male inhabitants in the island of Samar, from ten years old above.

But while the Americans despised these bells as treacherous devices, the people of Balangiga took them for treasures, hence their consequent demand, with the support of the entire Filipino people, to have those bells returned. But it was not easy trying to convince the American government. Decades and a century passed but nothing happened. Then negotiations luckily progressed until finally, last December 15 this year, these bells made it to Balangiga again, their place of origin.

This was history in the making, and closure of this historical chapter as well. We could only thank all those who, in one way or another, had contributed to making this event a reality. At last, the efforts from both sides paid off.

### Avoid tempting God

IT was nice to learn about Blessed Bartolo Longo (1841-1926) who, as the Wikipedia puts it, "was an Italian lawyer who has been beatified by the Roman Catholic Church. He was a former satanist who returned to the Christian faith and became a third order Dominican, dedicating his life to the Rosary and the Virgin Mary."

Other sources provided some more information about him: he was orphaned early in life, he was involved in the nationalist movement of the time that was anti-Catholic, he became a Satanist in his 20's, he went into the occult, attended in séances, experimented on drugs, participated in orgies... There's a lot more, but let's spare ourselves from more unpleasant things.

But since all these did not give him peace, but rather a lot of problems including psychological and emotional ones, leading him to depression, he sought some relief and eventually was led back to the Catholic faith. Later, he became so deep a devotee of the Holy Rosary that St. John Paul described him as a man of the Rosary during his beatification.

His story, for sure, will elicit very reassuring responses from us who often wonder how we can become a saint as we should when we are hounded always by our weaknesses, temptations and sin itself. Sometimes, we think that to become a saint is impossible and that stories of saints are more fantasy and fiction than real. Or at best, saints are very special people who never went into really bad things.

Somehow, his story reminds us that God and his grace can take on anything we can mess ourselves in. There is always hope. As St. Paul said, "where sin has abounded, the grace of God has abounded more." (Rom 5,20) His story calls to mind that as said in the

Book of Ezekiel, God does not take delight in the death of the wicked but in his salvation. (33,11).

The writer Oscar Wilde also put it so succinctly: "Every saint has a past, every sinner has a future." In other words, we really have no reason to fear and to worry too much over our delicate condition here in this world.

But for all that, we should also be careful not to fall into the opposite side, which is presumption, or tempting God. That is to say, we can fall into the trick of the devil who can suggest to us that since God is very powerfully merciful and can forgive us our sins no matter how grave they are, then we can just go on sinning, or exert no adequate effort



## Gov. Tan says she is not behind on the arrest of murder suspect who named her opponents as masterminds

TACLOBAN CITY- Samar Governor Sharee Ann Tan dismissed allegation that she is behind on the arrest of the son of a mayor who named her opponents as responsible on the killing of a village official.

Tan, in an interview, said that the arrest of Francis Grey, 38 and son of San Jorge Mayor Joseph Grey, was by virtue of a police operation and not because of her.

"The arrest of Grey was a police operation and whoever is behind a crime should be answerable to the law," the Samar governor said.

Grey is accused to be behind on the killing of Romulo Barcoma in February, 2013. He was arrested on December 7 in a raid at his house in Bali Hai Subdivision in Imus City,

Cavite.

His arrest was by virtue of a warrant issued by Judge Feliciano Aguilar of the Regional Trial Court of Gandara, Samar.

Grey was transported back to Samar on December 14.

In an interview, Grey mentioned the names of Calbayog City Mayor Ronald Aquino and Emil Zosa to have allegedly ordered to kill the brother of Barcoma who was said to be involved in the illegal drugs.

However, it was Barcoma who was killed instead as he was mistaken to be the target, Grey claimed.

Gov. Tan said that she personally saw the media interview of Grey making the confession. She said that he should be held answerable for the crime he committed.

Tan added that considering that Grey named both Aquino and Zosa, her political opponents, as the alleged masterminds on the murder of Barcoma, her name would be linked to the incident.

"Our family and our party was never involved in any other way for the capture of Grey. My only hope is that the death of village chair Barcoma will be given justice," she said.

"We have been calling for the killings to stop in Calbayog and in the first district. It is high time that the killings be given justice. It is my ardent call for all the politicians to campaign without resorting to violence," Tan added.

The Samar governor said that the candidates should respect the voice of the people instead of killing them

## PNP conducts probe on the killing of a cop by still 2 unidentified suspects

CAMP RUPERTO KANGLEON, PALO, Leyte- A member of the regional Philippine National Police (PNP) assigned at the Regional Headquarter Support Group (RHSG), based here, was shot and killed by still unidentified suspects on December 16.

Reports reaching at the PNP regional headquarters indicated that at about 2:30 am, a shooting incident transpired in Barangay Salvacion which resulted in the killing of

SPO2 Andres Vijuan Gonzaga, 43, married, and resident of Brgy. Looc, Caibiran, Biliran.

Members of the municipal police station (MPS) of Palo went to the area wherein they discovered the victim's lifeless body lying on the concrete pavement on the side of the highway particularly near the recreation and amusement center (LRAC).

Initial investigation disclosed that the victim was about to board on his vehi-

cle when the unidentified two suspects approached and shot him, hitting him on the different parts of his body.

Suspects then boarded on a color white sedan and a dark color pick-up vehicle and fled towards the direction of Brgy. Cogon, this town.

Elements of Palo MPS requested for SOCO (scene of the crimes operatives) team to process the crime scene.

An ongoing investiga-

## Calbayog City Mayor Aquino also denies allegation Mayor Grey questions statements of his son linking his 2 political allies to a murder case

CALBAYOG CITY- Mayor Joseph Grey of San Jorge, Samar refutes the statement of his son Francis pointing Calbayog City Mayor Ronald Aquino and retired Army official Emil Zosa as behind on the killing of a village official two years ago.

The younger Grey was arrested by the police in Imus City, Cavite thru a warrant of arrest on December 7 by virtue of a warrant issued by Judge Feliciano Aguilar of the Regional Trial Court of Gandara, Samar.

In a media interview in Tacloban City on Dec. 14, Grey named both Aquino and Zosa, who is running for governor of Samar in next year's elections, as the alleged mastermind on the killing of Romulo Barcoma, barangay chairman of Barangay Sapinet, San Jorge on February 13,

But Grey admitted to have killed the barangay leader. Witnesses in the said incident pointed to Grey as to have shot Barcoma.

He also admitted to be hooked on illegal drugs as he accused both Aquino and Zosa to be reportedly drug protectors.

But Mayor Joseph Grey dismissed the allegations made by his son.

"I don't know what happened to my son but I want to clear this. Emil (Emil Zosa) and Mayor Onald (Ronald Aquino) were not behind or involved in the said murder case," the town mayor said in a press interview.

He then said that

politics could be behind why his son pointed to Aquino and Zosa, his political allies.

"Election is coming. The three of us are friends. We belong to the same party and these people behind all of this is doing everything for us to fight and will no longer trust each other," the elder Grey said.

Grey further added that he has a feeling that his son is being threatened to issue said statements.

For his part, Mayor Aquino was puzzled why he was involved to the killing of a barangay official outside Calbayog City.

He further questioned the statement of Francis linking them to drugs.

"He should show proof on how we are link to drugs and why would they involved us in their political problem just because he is being pressured," Aquino said.

## 8th ID headquarters named after Gen. Vicente Lukban EV soldiers rejoice on the return of the bells

BALANGIGA, Eastern Samar – The return of the historic bells to the town was also a cause for celebration among soldiers in the region.

Thus said Capt. Francis Agno, spokesperson of the 8th Infantry Division whose main camp was named after General Vicente Lukban who served as the top military official of Samar Island at that time.

Samar, under Lukban's leadership, remained one of the few areas of Filipino resistance during the American occupation.

"It was Gen. Lukban who led the attack during the Balangiga Encounter on September 28, 1901 and because of his heroism, the 8th Division headquarters was named after him,"

Agno shared.

Camp Vicente Lukban is located in Barangay Maulong, Catbalogan City.

Cyril Lukban, a great-grandson of General Lukban, also expressed pride that his ancestor was part of the Filipino guerillas responsible on the worst single defeat by the American troops during the Filipino-American War.

The 52-year old Lukban personally visited Balangiga to witness the momentous turnover of the revered bells on Saturday (December 15).

"The bells are back to unite the people in Balangiga. We are very much happy to be here," he said.

The bells were returned to the country 117 years after these artifacts were forcibly removed by the American soldiers from the belfry

of the church of the town.

The three bells were repatriated back to the country on December 11 and were formally turned over to the parish of St. Lawrence the Martyr Parish on Dec.15.

Gen. Lukban's name is inscribed along with 113 Filipino soldiers who fought during the September 28, 1901 attack against the American soldiers assigned at that time in this town at the Balangiga Incident Marker, located within the town plaza.

The Balangiga Incident Marker is the work of National Artist Napoleon Abueva which was inaugurated during the 102nd Balangiga Incident anniversary on September 28, 2003. (LIZBETH ANN A. ABELLA)

## Son of a town mayor arrested for the murder of a Samar village official

TACLOBAN CITY – A son of a town mayor in Samar was arrested by police authorities for the crime of murder but linked some of the province's prominent political leaders as the alleged masterminds.

Francis Grey, son of San Jorge Mayor Joseph Grey, was arrested for the killing of Romulo Barcoma, chairman of Barangay Sapinet, San Jorge town, on February 13, 2016 by police personnel in Cavite and Samar Provincial Police Office last December 7, 2018 in Baliyai Subdivision, Buhay na Tubig, Imus, Cavite.

His arrest was by virtue of a warrant issued by Judge Feliciano Aguilar, presiding judge Regional

Trial Court Branch 41 in Gandara, Samar.

In his media interview, Grey claimed that the masterminds on the killing of Barcoma were Calbayog City Mayor Ronald Aquino and gubernatorial candidate Emil Zosa.

He also named one Jopas Gonzaga as the other one who ordered to kill Barcoma due to illegal drug trade.

Grey claimed that Aquino, Zosa and Gonzaga are into illegal drug trade and admitted that he uses illegal drugs.

"Nobody forced me to testify. All I want is for this issue to be finished," Grey said.

When asked if his parents knew of his decision to testify against Aquino

and Zosa, Grey said that his parents have no idea of his action.

"I just want to reveal the truth that I did not kill Romulo Barcoma. I was there on the planning but I don't want to execute the plan because Romulo and Lando Barcoma are my friends," Grey added.

He added that his parents were mad at him with his involvement to the murdered village official and his brother, Lando, who was said to be engaged in the illegal drugs.

Mayor Grey, in a press conference on December 15, debunked the statement of his son which he said is part of plan to destroy his good relationship with see Son /page 10 ...

## Local volunteers join Samar 1st district engineering office's coastal clean-up drive

# 47 city gov't workers undergo random drug testing

TACLOBAN CITY - Some 47 city government workers have undergone an unannounced random drug testing on December 10.

This is the second time that the city government under the administration of Mayor Cristina Romualdez has initiated a drug test this year.

Last October, 49 employees were randomly

subjected to drug testing but none tested positive.

The random drug testing is part of the hardline stance of the city government under the leadership of Mayor Cristina G. Romualdez on illegal drugs.

The New Beginnings Drug Rehabilitation Program of the local government unit spearheaded the drug testing activity in partnership with the Philippine

Drug Enforcement Agency and the Department of Interior and Local Government.

Mr. Duterte also said that no single individual could claim on the responsibility for the return of the bell carted away by the Americans 117 years ago.

"The bells are returned and it was really because of the fervent prayers of the entire Filipino nation, period," he said.

The bells, two of them were displayed at F.E. Warren Air Base in Wyoming, USA while the other one was displayed at Camp Red Cloud located in Uijeongbu City, South Korea, were used to signal the attack of the local guerillas against the US troops which resulted to the death of 48 American soldiers.

This, in turn, resulted for the American troops, led by General Jacob Smith, ordered to kill the locals, to include boys 10 and above, and turned Samar into a 'howling wilderness.'

During the program, US Deputy Assistant Secretary of Defense Joseph Felter, who represented US Defense Chief James Mattis, greeted the villagers "Merry Christmas" as he presented the bells to the ecstatic and tearful crowd gathered at the venue.

"We hope you will ring in the church of Balangiga once again uplifting and gracing us all with the voices of our better angels," he said.

The three bells arrived in Manila on December 11, after it was transported by "The Spirit of MacArthur," a plane named after the legendary American General Douglas MacArthur who led the liberation of the Philippines from the Japanese occupation during World War II.

"MacArthur famously kept his promise to return to the Philippines. This week, MacArthur returned again this time with the bells," Felter said.

For his part, John Law, chief of mission of the US Embassy to the Philippines, said that the return of the bells underscores the enduring friendship of the two nations.

"Many Filipinos of good heart and good will work tirelessly for decades for the return of the bells. The bells are home now in Balangiga where they belong. These bells are yours," he said.

He also thanked the American veteran groups who lobbied hard on the return of the bells.

While Law admitted that the bells "regrettably caught up in the conflict" during the Philippine-American war, he said two countries have now become partners and allies.

"Our relationship has withstood difficulty and it flourishes today," Law said.

Church leaders in the Diocese of Borongan also expressed gratitude to both US and Philippine government officials who lobbied on the repatriation of the bells.

"Please be assured that we will return the bells to their original purpose, and care and cherish them for its precious legacy," said Bishop Crispin Varquez of the Borongan Diocese, in his speech during the rites, said.

"We courageously express our commitment that we will do everything we can that these bells will not be separated from us again. They will remain in this church. Never again, Balangiga, these bells will be taken away from you," the bishop said.

Archbishop Valles, for his part, said that the bells' repatriation "underlines deeper appreciation of respect and friendship."

Valles referred to the hand-over ceremony as "a very joyful event."

Town Mayor Randy Graza, who received the bells from Defense Sec. Lorenzana, said that they are just too glad that the

bells were finally returned to them.

"The Balangiga Bells have returned because of goodwill. The Balangiga Bells will not ring again for what it tolled 117 years ago," Graza said.

To honor the heroism and legacy of the "brave sons" of Balangiga, Leyte Rep. Yedda Marie Romualdez filed a resolution calling for the recognition and commendation of the "bravery, courage, and sacrifice of the unarmed heroes of Balangiga and the Parish of Saint Lawrence, Deacon and Martyr."

Meanwhile, Rolando Borrinaga, historian and one of the campaigners of the bell, said that the repatriation of the bells should paved the way for an unapologetic manner of celebrating the Balangiga Encounter.

"We will celebrate as a victor. We won against a powerful enemy, we won against ourselves and our limitations," Borrinaga said.

He was also hopeful that because of Balangiga is now in the limelight, this can also "generate tourism" to the town.

The Church used the just returned Balangiga Bells signaling the start of the dawn masses which was clearly heard, at least within the town center.

At 4:15 am, the smallest of the three historic bells, which were mounted in a movable platform made of gold-painted steel and specially built by the Department of National Defense, was pealed five times to signal the start of the mass.

About 900 faithful attended the two-hour mass which was marred by a power failure. The church used its power generator all throughout the proceeding.

"This is a very special mass because the bells are now with us. The pealing of the bells is so distinctive that could not be described in words," Fr. Tybaco said during an interview after he presided the mass.

He hopes that with the returned of the bells, the

already religious Balangiganos will "further deepen their faith."

Severa Duran, 80, said that she was heartened to see that the church was filled with the faithful.

"While there were times that the church is filled up with people, today's number of Churchgoers is bigger. Perhaps, it's because we have the bells already," she said.

Duran said that what made her doubly excited to see the bells is that it happened 'in my lifetime.'

"There were efforts before for the bells be returned to us but all failed until now. At least it happened in my lifetime," the retired school teacher said.

The three bells, which was officially turned over to the parish Saturday by town Mayor Randy Graza after a ceremony held at the town's gymnasium or covered court and witnessed by President Rodrigo Duterte and US officials led by John Law, chief of mission of the

US Embassy, and Defense Assistant Secretary Joseph Filter.

Just after the mass ended, the bells were immediately surrounded by those who attended mass.

And as expected, they took photos with the bells as their backdrop.

Several children were seen touching the bells.

Melody Lumagbas, 13, said that she, just like the rest of the people of Balangiga, is happy to see the bells up close and personal.

"I just saw the bells on television and now, the bells are in our Church. I am happy to see them myself," she said, giggling.

The bells are temporarily placed inside the Church due to 'security concern,' Fr. Tybaco said.

He could not say when these bells are to be placed back to the church's belfry or at the church's grounds where three concrete stands were earlier constructed.
