said on Wednesday. Affected by the orders

were S/Supt. Dante Novicio of Leyte who was reassigned to Samar province; S/Supt. Nicholas Torre III,Samar police director who was assigned as chief of the regional operations division; and S/Supt. Felix

was replaced by S/Supt. Lito Bigoy.

The new police provincial director for Leyte is S/ Supt. Rolando Bade whose previous post is now occupied by Torre.

Diloy, meantime, was temporarily assigned at the Regional Personnel Holding and Accounting Unit.

Of the three affected police provincial directors, the most controversial was Torre who engaged Calbayog City Mayor Ronald Aquino of verbal tussle, accusing him of favoring Samar Governor Sharee Ann Tan.

Questioned incident happened in 2009 Eastern Samar Rep. Evardone faces graft charges before the Ombudsman

TACLOBAN CITY-For an act that happened about 10 years ago, Eastern Samar Rep. Ben Evardone is now facing a graft complaint before the Office of the Ombudsman.

Evardone, who was governor at that time, was accused by Edilberto Grata, Jr., for violation of section 3(e) of Republic Act 3019, otherwise known as the Anti-Graft and Corrupt Practices Act as his questioned acts allegedly resulted to 'undue injury' to the provincial government of Eastern Samar.

Grata, who is a resident of Can-avid, also in Eastern Samar, in his complaint he filed before the anti-graft court on Jan.14, stated that Evardone committed graft involving P5.37 million by extending financial assistance to the Liga ng mga Barangay- Eastern Samar which was used for a Lakbay Aral involving barangay leaders of the province for a seminar on good governance in Baguio City on

February,2009.

He also said that during the seminar, Evardone, who was on his last term as governor at that time and had expressed his desire to run for congressman during the 2010 elections, also handed P1,000 each to the barangay leaders who attended the seminar.

The provincial government, under Evardone, also entered an agreement with SEAIR to transport the participants, Grata said on his complaint.

Grata said that part of the 'overall design of the seminar workshop was a commitment made by the governor and the participants.

"In this situation, each barangay chairperson would be made to express his/her commitment of support to then Governor Evardone who made known his intentions to run for Congress in 2010 elections," he said.

And by giving their support on his congressional bid, Evardone then gave P1,000 each to them, Grata added.

But Evardone, who is now on his last term as congressman of the lone district of Eastern Samar and is seeking for the gubernatorial post in this year's elections, dismissed the complaint as nothing but 'purely politically motivated.'

"The fund in questions were aid to barangays transferred to the Liga ng mga Barangays through a memorandum of understanding. It was the liga that disbursed the funds, which were fully liquidated and supported by official receipts and airline tickets. So not a single centavo passed through me," Evardone, in a press statement, said.

"This happened a decade ago and the timing is suspect. Why only now? There is no doubt that the filing of the case is purely politically motivated," the congressman said. (JOEY A. GABIETA)

City Treasurer Office optimistic it will achieve collection target for 2019

TACLOBAN CITY -The City Treasurer's Office expressed optimism that they would be able to achieve their collection target of more than P1 billion pesos this year.

City Treasurer Zosima Cordaño made the statement during the last week of the ongoing business renewal and Real Property Tax (RPT) in this City.

In an interview over Radio Program "Sumat Tacloban," Cordaño disclosed that the city government targets to collect P1.4 billion for 2019; the majority of the targeted revenue will come from local sources such as real property and business taxes, and economic enterprise which includes the market, slaughterhouse, and terminal collections.

"The revenue target for this year is higher than last year's P1.2 billion, but ful that we will be able to hit the target with the cooperation of our taxpayers," she said.

As part of the revenue generation initiatives of Mayor Cristina G. Romualdez, the Kanhuraw Business Center (KBC) came up with innovations that would give taxpayers more ease in paying their taxes such that assessment and payment of real property taxes can now be had in one location, while business renewal have been streamlined into three steps.

The online payment system of the local government dubbed Electronic Payment Portal (EPP) also went full blast this year allowing taxpayers to pay their taxes right at the comfort of their home or business establishment.

January 20, 2019 to renew their business permits and licenses per City Revenue Ordinance 99-58 or be penalized with a 25 percent surcharge and a 2 percent interest per month.

Since the last day of business renewal falls on a Sunday, the KBC has extended its business hours until 7 pm, which started last January 14 to 18.

However, cash transactions will only be accepted until 6 pm. On Saturday, January 19, the KBC will be open to serve clients starting 8 am until 5 p.m.

On the other hand, real property taxpayers will have until January 31 to avail of the 20 percent maximum discount on real property taxes.

In Southern Leyte Students get exposed on consumer rights, responsibilities

SAINT BERNARD, Southern Leyte- Fiftyeight students from Tambis National High School (TNHS) in this Pacific town attended a seminar on basic consumer rights and responsibilities recently.

The activity was spearheaded by the Department of Trade and Industry (DTI) provincial office.

"Republic Act 7394, otherwise known as the Consumer Act of Philippines, states the that the Department of Education, Culture, and Sports, now DepEd, shall develop and adopt a consumer education program that will be integrated into the existing curricula for both private and public schools," said Erwin Remojo, technical industry development specialist (TIDS).

Towards this aim, the DTI provides consumer

education to Grade 10, junior and senior high school students in their economics class, Remojo added.

Discussed during the seminar were the seven types of consumers, such as the wasteful, closefisted, spendthrift, impulsive buyer, bargain addict, panic buyer, and intelligent consumer.

Remojo disclosed that it was the late U.S. President John Kennedy who first introduced the concept of consumer rights as a safeguard from harm by unscrupulous businessmen.

These include the right to safety, to choose, to be informed, and to be heard.

In 1985, the United Nations expanded these rights to include basic needs, right to redress, to consumer education, and to a healthy environment, Remojo reported.

Rina Ligaya Merquita, principal of TNHS, heartily appreciated the efforts of DTI for holding the seminar which she described as eyeopener and informative not just for the students but also to the teachers who were present.

"This seminar is an on-going activity by the DTI, which is given to schools and other interested groups who would like to learn about their rights and responsibilities as consumers," Remojo said.

The Chief Justice we never had

I am so impressed of the integrity of Supreme Court Justice Antonio Carpio. First, when then Chief Justice Lourdes Sereno was removed through a Quo Warranto ruling of the Supreme Court, he did not apply for the position of Chief Justice even if he is the most senior member of the SC reasoning out that he does not want to benefit from such erroneous ruling stressing that Sereno should be removed only by impeachment process.

Carpio has been by-

passed thrice for the top post in the Supreme Court – first in favor of Renato Corona and for the second time to Lourdes Sereno and now to Lucas Bersamin.

The main reason for his non appointment as Chief Justice of the SC is his stand on the West Philippine Sea. Carpio is among those at the forefront of efforts to make China respect the Philippines sovereign rights and maritime control of the West Philippine Sea.

Carpio has made clear that his bid to be named



Universal apostolate

LET us always keep in mind that mandate Christ gave to his apostles before he ascended into heaven. "Go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you." (Mt 28,19-20) It's a mandate that is actually meant for all the disciples of Christ and believers of God. We have to have a universal sense of apostolate. As one saint would put it, of 100 souls we should be interested in 100. We have to avoid falling into a parochial or tribal attitude toward our apostolic duty. While it's true that because of our personal

conditions, each one of us will have a particular niche in his apostolic activity, everyone should try to have a universal apostolic concern.

We have to be ready

Chief Justice shouldn't come at the expense of gagging him on his stand on the West Philippine Sea. He believes that the navies of the world including the United States could enforce the UN-Permanent Court of Arbitration ruling in the West Philippine Sea disputing Duterte's claim that no power in earth can enforce the arbitral rulings and that we cannot fight China.

Carpio said the Chief Justice position is a small price to pay for defending our maritime zones. If we do not defend our maritme area, we may lose it forever. He said "if we lose this huge maritine area in the West Philippine Sea, we lose it forever. This generation and future generations of Filipinos will never be able to recover this vast area with all its rich natural resources."

Carpio's stand on the West Philippine Sea reflects on his integrity, seldom seen nowadays from our national leaders. This is the stand that cost him the Chief Justice position of the Supreme Court.

worldly purposes and categories. We simply are not interested in them for some practical reasons alone. We should avoid getting entangled in the subordinate reasons for our apostolic interest in everyone.

The main reason for our apostolic interest in everyone should be that everyone gets back to God from whom all of us came and to whom we all belong. We have to be most interested in everyone achieving his spiritual and supernatural goal in life, in his holiness, in his becoming 'another Christ, who is the pattern of our humanity and the redeemer of our damaged humanity. For this, we need to be patient, persevering, creative and versatile. We have to learn how to "waste time" with everyone, especially those who may be very different from us in terms of temperament, social and economic status, etc. We should not wait for some favorable circumstances before we do apostolate. To do apostolate should be like our heartbeat. We should feel its urge the way we feel the urge to breathe, eat and drink.

The farmers behind the kaingin method are good examples for this. They would cut the weeds, including the trees standing in the area, and then

Of course, to do apostolate is not a biological urge, but a spiritual one, to be triggered by an act of our will that is animated by God's grace. We have to learn to adapt ourselves to everyone, dealing with each one as he is as well as he ought to be. Let's remember St. Augustine saying, "Who can map out the various forces at play in one's soul? Man is a great depth, O Lord. The hairs of his head are easier by far to count than his feeling, the movements of his heart."

burn everything to the ground later. This is a practice that remains rampant in rural areas due to the belief that the ashes contribute to the soil's enrichment and fertility.

The clearing may prove yet fertile during the first planting season. But the soil, given this cut-and-burn procedure, becomes barren in the long run as the cut grasses and all that could have been allowed to decay to enhance soil fertility, are being burned instead, depriving the soil of natural fertilizers.

In an agricultural country like ours, such farming practices should have been corrected long ago. Agricultural experts, backed by the Department of Agriculture, should intervene through information dissemination that may be followed by constant monitoring to confirm the farmers' implementation of what they learn.

Authorities should ensure this knowing that some unlettered farmers are so stubborn enough they just

stick to conventional farming that they have learned from their forbears. They tend to reject modern methods that prove alien to them.

To reach these farmers, local radio stations may be tapped. All sorts of gimmicks may be employed to get their attention to a radio program that could help them become effective farmers through various methods. Moreover, their particular problems encountered in their respective areas must be addressed to ensure the relevance of discussions.

Lastly, such information drive must observe consistency, if not perpetuated on air so that farmers who operate on fallacies and ancient practices would become more productive and well off. One-time airing of such educational radio program will not suffice as majority of farmers may not be able to hear it. A repetition of the same may prove better.

This could be the most appropriate empowerment we could give to our lowly farmers now when everything seems to have been modernized. It would be ironic for farmers to remain ancient with their farming strategies when better techniques can make them more productive, hence assets that the country can count on.

PSA starts survey on labor force and family income and expenditure

TACLOBAN CITY-The regional office of the Philippine Statistics Authority (PSA-8) has started the 2019 labor force survey and the 2018 family income and expenditure Survey (FIES) - Visit 2 on Monday (January 14).

A total of 10,663 systematically and randomly selected sample households across the region were identified as respondents.

The PSA has deployed 364 statistical researchers and team supervisors for these surveys to conduct the interviews among the selected respondents.

In a statement, the regional head of PSA, Wilma Perante, said that the labor force survey is a quarterly nationwide survey of households which aims to gather data on the demographic and socio-economic characteristics of the population, and to provide a quantitative framework for the preparation of plans and formulation of policies affecting the labor market.

She added that specifically the LFS serves as a tool in measuring the distribution of household population 15 years old and over by employment statusemployed, unemployed or under employed.

It is also used to determine various employment characteristics such as industry, class of worker, nature of employment and basis of payment, Perante added.

Meanwhile, the 2018 FIES Visit-2, is the second of two rounds covering the second semester of the 2018 (July-December) as reference period.

It is a nationwide survey of households conducted every three years which aims to gather data on family income and expenditure to include among others, levels of consumption by item of expenditure as well as sources of income in cash and in kind. The result of FIES provide inputs in the estimation of poverty threshold and incidence.

It also determines the levels and disparities in income of Filipino families, as well as their spending patterns.

Perante assures that all information gathered will be held strictly confidential and would not be used as evidence in court for purposes of taxation, regulation of investigation as provided for in Republic Act 10625

She said that data gathered from these surveys will be disseminated in statistical summaries without reference to any individual person or household. (LIZBETH ANN A. ABELLA)

The prestigious list, called the Carbon Clean 200, ranks companies according to the size of their revenues from clean energy sources.

Based on the latest list, First Gen ranked 113rd with estimated clean energy revenues of US\$632 million in 2017; while EDC occupied the 139th slot with estimated clean energy revenues of US\$494.72 million.

The latest ranking (for the third quarter of 2018) marked the third time for EDC -- and the first time for First Gen -- to make it to the Carbon Clean 200.

First Gen is the Philippines' leading clean and renewable energy producer with 3,490 megawatts in installed capacity. Subsidiary EDC is one of the world's largest geothermal producers and the country's leading renewable energy company with an installed capacity of 1,471.8 MW. Its 711.4MW geo-

To qualify for inclusion in the list, a company must have over \$1 billion in market capitalization and generate more than 10 percent of its total revenues from clean energy sources.

The Carbon Clean 200 list excludes all oil and gas companies and utilities that generate less than 50 percent of their power from renewable sources. Also excluded are the world's top 100 coal companies, measured in terms of reserves. Coal is considered a major source of CO2, one of the greenhouse gases being blamed in various studies for adverse climate change.

Carbon Clean 200 likewise disqualifies companies that profit from weapons manufacturing, tropical deforestation, the use of child and/or forced labor, and those engaged in negative climate lobbying.

Thirty-tree countries were represented in the latest Carbon Clean 200. Fifty two companies were based in China, 34 from the US and 19 from Japan. (PR)

PSA says EV's inflation rate for December posted at 4.4%

TACLOBAN CITY -Eastern Visayas closed 2018 with a 4.4 percent inflation rate, a report from a report from the Philippine Statistics Authority - Regional Statistical Service Office 8 (PSA - RSSO 8) said here.

Wilma Perante, PSA-RSSO regional director, said that the inflation rate was 0.8 percentage point lower compared with the 5.2 percent inflation rate a month ago, but 1.1 percentage points higher than the recorded 3.3 percent

the same period last year. "The regional inflation rate was 0.7 percentage point lower than the 5.1 percent national average in December 2018," Perante said.

Perante reported that all provinces registered lower inflation rates in December 2018 compared with their figures in the previous month.

Samar posted the highest decrease at 1.8 percentage points, from 7.4 percent in November 2018 to 5.6 percent in December 2018.

The rest of the provinces registered decreases ranging from 0.2 to 1.6 percentage points.

Eastern Samar recorded the highest inflation rate at 7.6 percent, while Biliran posted the lowest at 1.7 percent, Perante said.

Perante claims that among the commodity groups, transport registered the highest decrease of 3.7 percentage points. It was posted at 3.0 percent in December 2018 from 6.7 percent in November 2018.

This can be attributed to the huge decrease in the index of operation of personal transport equipment.

She added that the heavily weighted food and non-alcoholic beverages eased down to 6.0 percent in December 2018 from its previous month's rate of 7.4 percent, a decrease of 1.4

percentage points. This can be traced to slower price increases of majority of the food items.

"Rice index registered the highest decrease at 3.2 percentage points, from 8.4 percent in November 2018 to 5.2 percent in December 2018. Fish index continued to have a double-digit inflation rate at 10.2 percent, despite shedding off 2.0 percentage points from its figure a month ago. It also posted the highest among all food items.

Inflation rate for alcoholic beverages and tobacco also went down by 0.2 percentage point but still recorded double digit at 20.4 percent, the highest among all commodities, she said.

DAR Sec.Castriciones distributes farm equipment to 18 ARBOs in the region

TACLOBAN CITY – The Department of Agrarian Reform in Eastern Visayas distributed 18 heavy-duty dump trucks to 18 agrarian reform beneficiary organizations (ARBOs) worth P81-million.

The distribution was led by DAR Secretary John Castriciones, Undersecretary Atty. Emily Padilla and Leyte Governor Leopoldo Dominico Petilla on Thursday (Jan.17).

Six units are given to six ARBOs in the province of Leyte, four in Eastern Samar, four in Northern Samar, two in Samar, and one in Biliran.

Sec. Castriciones said that the dump trucks are important to the beneficiaries to make it easier and cheaper for farmers to deliver their product to the market.

"This is like an incentive to well-performing ARBOs. But eventually the agency will also provide assistance to small AR-BOs but this will depend on what the organization needs," Castriciones said.

Among the recipients of the dump truck is Maalsada Fisco, an ARBO from Alangalang, Leyte.

Reynaldo Peja, president of the organization said that the dump truck is helpful for their members who are mostly rice farmers in delivering their harvest to traders.

"This dump truck can help us in transporting our palay to traders who will buy it in higher price," Peja said.

Peja shares that their town has many rice traders but most of them buy palay at a lower price that makes it hard for them to earn enough from their crops. and Fisherfolks Association in Marabut and Villahermosa Oriental Farmers and Fisherfolks Association from Samar province.

Other recipients were the San Gabriel ARB Association in Borongan City, San Pablo AR Cooperative in Taft, Growers Integrated FA in Salcedo and Canloterio Farmers Association in Maydolong all in Eastern Samar province; Centralized FA in Mondragon, Victoria Agrarian Reform Community Cooperative in Victoria, San Jose Farmers Association in San Jose and Northern Samar Rice Producers MPC in Palapag all in Northern Samar province.

The DAR chief also led the inauguration of the new office building of the agency located at the back of the old regional office building worth P25.5 million.

The building, which was formerly owned by Home Guaranty Corporation, was rented before by the agency to serve as office for Operations Office, PDB office and dormitory.

The building was badly damage by super typhoon 'Yolanda' and was bought by DAR forP375, 000 in December 2014.

DAR also entered into a memorandum of usufruct with the provincial government for the use of the land where the building is situated for 25 years and renewable for another 25 years.

In his message for the inauguration of the new regional office building, Sec. Castriciones urged personnel of the department to a team worker for the agency to achieve their goal and mandate and the order from President Rodrigo Duterte to help all farmers in the country have their own land.
