# Rep. Veloso mulls of filing legal action against PDEA, PNP

TACLOBAN CITY-Leyte Rep. Vicente 'Ching' Veloso strongly denied that he is involved in the illegal drug trade, adding that the inclusion of his name in the so-called 'narco-list politicians' not only destroys his reputation but his life is now at stake.

Veloso, who is seeking for a second term in this year's midterm elections for Leyte's third congressional district, was surprised why his name was included in the list of alleged narco-politicians.

On Thursday night, President Rodrigo Duterte named Veloso, a former justice of the Court of Appeals before entering politics, named Veloso among the 46 elected officials in the narco-list.

"I am not blaming the President. He is just like a father doing what his children asked him to do. He is just doing his work. He said that (the list) is veri-

fied but I am far from that," Veloso, in a phone interview, said.

"I have been known here (in the third congressional district) as a performing politician and not as a narco-politician. I don't smoke, drink, gamble. I don't have any vices. This is the kind of discipline that I impose to my children," the solon said.

Veloso added that one of his thrusts as a lawmaker is to eliminate the proliferation of illegal drugs in his district and has been extending support to the campaign of the Philippine Drug Enforcement Agency (PDEA) like joining them on their anti-illegal drug

campaign and donating motorcycle for their use on their operations.

But Veloso admitted that with his inclusion to the dreaded list resulted for his reputation under question and worst, his life could be put in line.

"I am concerned now with my security. After this baka ma-tokhang na ako," he said.

Tokhang refers to the manner how the police and members of the anti-drug enforcers carry out their anti-illegal drug campaign which, some human rights groups say result to death of some drug suspects.

## BFAR, groups launch activity on red tide detection and mitigation

JIABONG, Samar-The Bureau of Fisheries and Aquatic Resources (BFAR) partnered with the local government unit of this town for the regional launching of hazard detection and mitigation for algal blooms in changing marine environment held on Thursday (March 14).

The program, funded by the Department of Science and Technology, is implemented by University of the Philippines Marine Science Institute (UP-MSI) together with the Community Alliance for the Sustainability of our Threatened Seas (Coasts).

The overall goal of the activity is to promote an early warning system

that would help address problems related to the occurrence of harmful algal blooms (HABs).

According to BFAR Regional Director Juan Albaladejo, red tide poses threats to the health and

safety of shellfish consumers.

He added that paralytic shellfish poisoning or PSP have caused illnesses and several mortality incidents through the years.

## Group urges ban on selling cigarettes near Tacloban schools, playgrounds

TACLOBAN CITY- A cause-oriented group has urged the city government here to enforce its ordinance banning the selling of cigarettes within 100 meters from schools and public playgrounds.

"(The)City Hall should enforce the law prohibiting stores from selling cigarettes if they are located near schools and areas that minors regularly visit," said Vince Basiano of the Rural Poor Institute for Land and Human Rights Services, Inc. (Rights Inc.) for Tacloban.

"Children should be insulated from the dangers of tobacco as much as possible so that they won't be exposed to the highly addictive nature of nicotine and take up dangerous habit of smoking," he added.

Basiano said they have observed that cigarettes and other tobacco products continue to be freely sold by stores in the city despite being located near schools and places that children frequent.

"Moreover, smokers continue to light up in public places without regard for the environment and the health of their fellow residents," he said.


Meanwhile, City Vice Mayor Jerry "Sambo" Yaokasin said that concerted effort is needed to educate the public regarding the ill effects of smoking to health.

"We have asked the Traffic Operation Management Enforcement and Control Office (Tomeco) to remove billboards of cigarette brands from sarisari stores," Yaokasin said in an interview.

According to Cynthia Esquillo, heads of Rights' anti-tobacco advocacy program, the full implementation of the said ordinance "will protect the health of its children and enhance the reputation of the city as a child-friendly city."

Rights cited Tacloban City Ordinance No. 2009-10-160 which was enacted to "protect the populace from hazardous products

and therapeutic sessions handled by trained doctors and nurses of the city government for the well-being of Persons Who Used Drugs (PWUDs).

PWUDs also undergo lectures on Basic Life Support and First Aid, the prevention of diseases and promotion of healthy lifestyle, as part of the program's holistic approach to rehabilitation.

TACLOBAN CITY-Tacloban's homegrown drug rehabilitation program was given due recognition recently by the Department of Health (DOH) Eastern Visayas when it was included in the regional awarding of health achievers.

Aptly named "New Beginnings" - the drug rehab program being implemented by the city government under the leadership of Mayor Cristina G.

Romualdez was one of the first local-government-initiated programs implemented in support of the national government's war on drugs.

It was also instrumental in the declaration of the city in 2017 as the first

drug-cleared highly urbanized city (HUC) in the Visayas by the Local Dangerous Drug Board.

The six-month wellness and recovery program is a multi-stakeholder initiative that implements several recovery modules, coaching

As of March 13, 2019, some 1,235 PWUDs coming from 40 barangays are currently undergoing the program, while 352 have already undergone rehabilitation. **(CITY INFORMATION OFFICE)**

**DPWH in Eastern Samar conducts inspection on infra projects after series of earthquakes hit the province**

BORONGAN CITY-The Department of Public Works and Highways-Eastern Samar District Engineering Office (DPWH-ESDEO) has conducted inspections on infrastructure projects after a series of earthquakes were felt in this province.

Manolo Rojas, district engineer of the ESDEO, said in an interview that he directed all project engineers to conduct post disaster damage assessment on all on-going infrastructure projects due

to recent earthquakes that hit the province.

A magnitude 5.1 earthquake hit the town of Hernani on January 27, 2019 and another magnitude 4.8 jolt struck the same town on January 30.

The recent earthquake, a magnitude 6.2 earthquake that jolted Surigao del Norte last Friday night, March 8, reported by Philippine Institute of Volcanology and Seismology (Phivolcs) was felt at intensity 3 in Borongan City, the provincial capital.

Rojas said that DPWH's disaster response team is automatically activated when there is calamity.

"Our maintenance crew and heavy equipment are on standby and ready for possible quick response to any eventualities," added Rojas.

Rojas disclosed that no infrastructures were affected by the earthquakes based on the report of the project engineers. **(RESTITUTO A. CAYUBIT)**

**Gonzales fights suspension order as new Guiuan mayor assumes post**

GUIUAN, Eastern Samar - The suspended mayor of this town continue to question the decision of the Office of the Ombudsman removing him from office for six months.

On Wednesday (March 13), Vice Mayor Susana Lourdes Gaylon formally assumed the mayoralty post after the regional office of the Department of Interior and Local Government formally served the notice to suspended mayor, Christopher Sheen Gonzales.

The anti-graft issued a preventive suspension order against Gonzales on February 12 for corruption related to alleged misuse of funds intended for the rehabilitation of public markets and barangay halls destroyed when the town was hit by super typhoon 'Yolanda.'

This complaint was contested by Gonzales, who is serving on his second term as mayor of the town, calling it 'political harassment.'

He also disputed the complaint saying it's base-

less as he insisted that the rehabilitation of these facilities were done above board.

Gonzales' lawyer, Christopher Coles, said that there was a grave abuse of discretion committed by the anti-graft court when it handed down the suspension order as it was released during the election period.

"There was a grave abuse of discretion on the part of the Ombudsman to issue a suspension order against Mayor Gonzales because they issue the suspension order during the prohibited period," Coles said.

"(The) suspension order is not a penalty but since they are enforcing it during election period, there is still a grave abuse of discretion because of its timing," the lawyer added.

Gonzales, in his letter to Interior Sec. Eduardo Año on March 8, he cited that under Section 261 (x) of the Omnibus Election Code, suspension of an elective

provincial, city, municipal or barangay official during the election period requires prior approval from the Commission on Elections unless the suspension will be for the purpose of applying the anti-graft and corrupt practices act.

Coles stressed that the complaint filed against his client is administrative in nature and not criminal.

Prior to the serving of the order, thousands of Gonzales' supporters went into a vigil to show their support to him.

In his message to his supporters, Gonzales cried political harassment with the complaint instigated by his rivals.

Gonzales is running for the lone congressional district of Eastern Samar against Borongan City Mayor Ma. Fe Abunda and Vice Mayor Conrado Nicart III of San Policarpio in this year's May 13 elections. **(ROEL T. AMAZONA)**

## Re-enacted budget? Whose fault?

**W**e have no one to blame why there is this unusual delay in the passage of the 2019 annual appropriations act or budget but these "law-makers-breakers" in Congress.


As of now government operations will just be based on the re-enacted budget of 2018.

What is the effect? According to National Economic Development Authority (NEDA) Chief Ernesto Pernia it delays the on-going and new implementation of infrastructure projects, delays the delivery of social services, such as the unconditional cash transfer, Pantawid Pamilya Pilipino Program for indigent households and others. The plan to create of about 200,000 more jobs and to lift as much as 400,000 Filipinos out of poverty is held in abeyance.

Whose fault? These are our dishonest representatives in congress.

When the 2019 budget was approved by the bicameral committee on appropriations ready for Malacañang signature these greedy congressmen inserted millions of funds to their districts especially those close to Speaker Gloria Arroyo which according to legal experts are illegal.

We sincerely commend and thank Senator Panfilo "Ping" Lacson for exposing these unlawful insertions by these greedy legislators. Voters in the coming May 2019 midterm elections must demand explanations-clarifications from candidates for re-election about this burning issue now. And we should vote accordingly. Reject them if they will not give us a credible explanation, worse if they will avoid the demand to explain.



### The 2019 National Budget Impasse

President Rodrigo Duterte failed to break the budget impasse among lawmakers. There is a budget impasse due to some constitutional questions raised by both chambers of the legislative body.

The House and the

Senate has been accusing each other of making last-minute amendments to the P3.75 trillion budget right after its approval by the bicameral conference committee. Several House members have complained about their district alloca-

tions being "hijacked" and given to favored congressmen. One of these is our own congressman in Region 8, Rep. Raul Daza of Northern Samar.

If the government operates on a re-enacted budget based on 2018, economic growth may slow down to 4.2% based on the estimates of NEDA. This is below the government growth target between 7% to 80% for 2019. A re-enacted budget would delay their implementation of new and on-going infrastructure projects as well as the implementation of public social services such as the unconditional cash transfer and Pantawid Pasada Programs for the masses. The government would not be able to quickly execute programs and projects. This

means the government will miss the opportunity to create as much as 180,000 more jobs and fail to lift as much as 500,000 more Filipinos out of poverty this year.

There will be a possible delay in the release of compensation for teachers and state workers as well as the increase of salaries of government employees under the salary standardization law for the year 2019.

Lawmakers are representatives of the people. They are mandated to pass their vital legislation that is based on the needs of the Filipinos. They should be transparent and accountable forgetting their personnel greed and caprices.

### Piñol left his heart in San Roque town in Northern Samar? Agriculture chief Emmanuel F. Piñol is taking to heart his SAAD

Yes, the Special Area for Agricultural Development(SAAD); his personally crafted productivity intervention for the country's top twenty poorest provinces (T2P2). Piñol has been observed combing the archipelago not to party though, or to hobnob with the country's who's who, but to visit farms, see the farmers in flesh, and hear their pulse and complaints.

In the case of Samar Island, Piñol's predilections are not without reasons. Let me venture some: firstly, Samar Island is host to three (3) of the country's poorest provinces in the upper crust of the T2P2; secondly, Samar is the 3rd biggest island of the Philippine archipelago; thirdly, the country's 3rd biggest in terms of land area is basically agricultural; and, fourthly, his maternal root is reportedly from the

plains of San Roque town, in Northern Samar—yes, he left part of his heart in San Roque!

The agriculture chief has been noticed to have a special liking for Northern Samar essentially because of the province's potential for agricultural productivity—both for rice production and the richness of its municipal fishing grounds. He has frequented the country's Pacific towns where tuna is abundant, and Catubig Valley which used to be one of Samar Island's rice granaries.

Of late, Piñol has invested P100M for rice production in San Roque town, on top of the small farm tractors that he has given to the local government unit (LGU) of San Roque, and the six solar irrigation facilities in that locality which apply Israel's fertilization technology. This is

part of Piñol's Rice Production Program in Northern Samar. He also directed his Fisheries and Aquatic bureau to distribute P30M worth of small bancas to the fisherfolks of the Pacific towns.

It will be recalled that even before assuming office as Agriculture chief, just as soon as he was tasked by then President-in-waiting Rodrigo Roa Duterte to handle the agriculture portfolio, Piñol immediately motored to Samar to see what the plains can offer in terms of agricultural productivity. And, rightly so, together with Mindoro, Samar Island was included in his priority areas for agricultural productivity.

He lamented though that even his politician friends in Samar were not successful in lifting the locals from the quagmire of poverty, even as he noted that the potentials of the island were just too great to have been ignored.

He thus called Samar a "sleeping giant" that he wanted awaken with his SAAD intervention. The Agriculture chief will however need the militancy and vigilance of the NGOs and POs in the area, if he wants an effective compliance monitoring mechanism for his program.

Without a dispassionate feedback, his special love affair with the potential of Samar Island might be prejudiced by reports of accomplishments that exist only in papers—rosy reportage,

When they walked around the house while their parents were asleep, they had to catwalk here and there to avoid rousing the latter from slumber. At the slight noise created that may awaken them, these oldies could hit the offender with anything in hand, such as a stick, a broom, or heavy shoes.

Minor offense, heavy punishment—that was the rule. Thus, children then were tamed, timid, and shy, not much out of respect, but due to trauma. They became too suppressed that they lost confidence of themselves, of their ideas. Their social behavior became such that they no

longer wanted to mingle with people, particularly adults. They became awkward and hesitant to contribute even their brightest ideas during social gatherings. They thought less of themselves, their insights unimportant. Such deprivation took its tolls on them.

Today, such arrangement no longer works. Children now could even predominate in conversations with adults, a gesture that the people of old could characterize with disrespect. In fact, kids are more expressive and talkative than adults to the point of monopolizing discussions, at times. And they are left alone to do that. No one is rebuking them anymore for that, more so if their ideas are excellent. They seem to have achieved that freedom of expression. Open-minded this time, adults could only welcome children's verbal contributions.

Along with this 'freedom of speech', however, came the children's abusive behavior towards adults. Sometimes, they just utter anything offensive against the elders, with disrespectful attitude, without fear at all. It's now the adults who fear the kids for becoming so liberated and powerful, with back up from the laws that overprotect them, that eventually spoil them.

Listen to the conversation of children nowadays and you'd realize it's now the adults who can't join them. Well, not because they are not allowed. It's more because children now have plenty of technological discussions to tackle that adults can no longer catch up and understand. No wonder adults could only keep quiet when children converse among themselves.



And that's because we first of all received the greatest gift from God freely, and that is God himself in Christ through the Holy Spirit. We have to give ourselves to God and to others as well. We need to be a gift also to God and to the others. "Freely you have received, freely you have to give," Christ told the apostles. (Mt 10,8)

## My Dream, Your Dream, Our Dream

A dream is a part of the human nature. It flows in every person's being to desire for something pleasant in life. He or she may pursue to acquire something that his heart really longs to have- be it a college education, a degree, a happy married life, etc. It is something that pushes someone to focus and achieve his goals. It is already incorporated in every individual's unique system of life.

### THE LEARNER AS A DREAMER

Every learner has a special dream. Someone once asked one of our learners: "Why do you tend to go to school?" "I want to finish my studies and to help my family when I get a stable job." A learner's special dream is not for himself alone but mainly for his family. He wants to help lift them out of poverty. He wants to give back in return what his parents have done for him. He wants to prove that "poverty is not hindrance" instead, it is an encouragement to strive hard and become a successful individual in the future.

What can hinder the learner's achievement of his dreams? Some learners struggled for lack of parental moral support. It is believed that the teenage years is the most crucial period in a person's life. During this time, a person is more sensitive. Some learners would admit that they think their parents do not love them and they don't care about them. They feel alone in their journey of making their dreams come true. It makes them decide to stop schooling because they think they are not appreciated. Lack of financial support from their parents is a great challenge. Going to school every day needs to be assisted with money to support their baon and other expenses such as fares. It is sometimes the reason why some learners would be forced to be in and out of school from time to time because they still need to work for themselves in or-

der to sustain their needs in going back to school. Distance from home to school is another problem. KNHS-Libertad Annex is the most accessible High School to Bagabao, Margen, Tapol, Bertulfo, and Sto. Domingo. Most of the learners are coming from these sitios and barangays. The learners need to walk an average of 7 kilometers every day in order to reach school. Health is a problem, too. In most cases, the learners are forced to drop out from school due to some illness. It is very difficult for them to go to school regularly especially when they do not feel well about their health. Child-labor is also one that challenges the learners. The learners are hooked by the influence of getting a money from working in the farm. It makes them want to rather work and earn money than go to school. But some of these learners if not most are just forced to work because of their family situations that needs help from them to work in the rice fields especially during planting and harvesting season to raise money for family's financial shortage to support for their daily consumptions.

### A TEACHER AS A DREAMER

A teacher is also a dreamer. The learner's dreams are like seeds. These seeds are sown in the fertile ground which is the school. The cultivators are the teachers who are also the dreamers. The teachers dream to see their learners finish their education, earn a degree and become a successful individual who can face every challenges in life without fear and hesitation.

Alarmed by the high dropout rate from last school year, the KANANGA NHS-LIBERTAD ANNEX school head together with the teachers came up with a program called TASK-SARDO (Technical Assistance and Solutions for Keeping Students Against Risks of Dropping Out). Through this, the school is able to

come up with certain interventions to save the learners who are under the SARDO (Students At Risk of Dropping Out). As of this school year, the school has 6 number of learners who are considered at risk of dropping out due to the same reasons already mentioned. The following are the interventions:

a. Home Visitation-In this activity, advisers of each Grade level started by identifying the learners who are at risk of dropping out. Then, the schedule to visit the child was set. During the conduct of home visits, the teachers will be able to realize and understand the child's situation and possible can apply interventions in order to help the learner.

b. Counselling-In this activity, the advisers help the learners to realize their potentials to achieve their dreams by enhancing their confidence and self-esteem.

c. Feeding Program- This activity is done to support the health and nutritional status of the learners so that they can concentrate in their studies and soon reach their dreams.

In addition, the government's program is also a big help to the learners. Through the 4P's or Pantawid Pamilyang Pilipino Program, their financial needs are somehow being supported. With the allowances they receive from the government, the learners are able to buy the things they need including their food which is basic needs

Dreams are worth achieving. In the process, it can be difficult due to many hindrances. But nothing or no one can stop anyone who has a powerful desire to achieve those dreams. Just like the learners who area dreamer can achieve what they conceive about themselves. The teachers will do every possible thing to help the learners achieve their dreams in life because the learner's dream is a teacher's dream.

will see patients with nearly any issue and refer them to hospitals and other medical services for urgent and specialist treatment.

Level 2 accreditation also requires a DOH licensed tertiary clinical laboratory and level 2 imaging facility, and the provision of respiratory therapy services.

“We need to upgrade our secondary clinical laboratory and to procure an arterial blood gas (ABG) machine [for respiratory therapy] and a portable X-ray machine,” Dr. Estanislao enumerated.

As to the level of competitiveness of NSPH as compared to other private hospitals in Northern Samar, the chief of hospital believes that they are still the best hospital in the province, debunking the notion that private hospitals are better than those government-run health facilities.

Dr. Estanislao announced that the hospital is waiting for the arrival of a new ambulance and that NSPH is a candidate recipient for a CT scan machine from DOH.

On concerns regarding the shortage of drugs, medicines and supplies available at the hospital pharmacy, he mentioned that the provincial government is procuring medicines through consignments and outsourcing agreements with pharmacies for the benefit of NSPH and other district hospitals.

NSPH, instituted in 1956, offers outpatient consultations, in-patient services in pediatrics, internal medicine, OB-gynecology, emergency and elective surgery, dentistry, optom-

etry, radiology and physical therapy.

It maintains a clinical laboratory, pharmacy and blood bank, in addition to its operating room, delivery room, and emergency room. It operates both free and private wards.

It also has a TB-DOTS/PMDT Satellite Treatment Center for the management of tuberculosis and it is the only hospital in the region outside of Tacloban City with an HIV-AIDS treatment hub.



## In Northern Samar Norsamelco lowers power rates; Gov. Ong commends coop management

CATARMAN, Northern Samar- The Northern Samar Electric Cooperative (Norsamelco) has lowered its electricity rates from P12.27 per kilowatt hour (kwh) to P9.38/kwh effective February this year.

The downward adjustment means a decrease of P578 in the bill of a typical household consuming 200 kwh per month. On households and commercial establishments consuming 500 kwh, a reduction of P1,445 is expected.

Engr. Hector Tabilisma, project supervisor and acting general manager of Norsamelco, attributed the decrease of P2.85/kWh to the commencement of a long-term power supply contract procured through Competitive Selection Process (CSP) conducted in 2015 including the 10 electric cooperatives in the region.

Tabilisma hopes that this development will attract more investors to do business in the province.

“The rate reduction will greatly enhance the investment climate in Northern Samar. At present, power rate in Manila is higher compare to our power rate,” he said.

Tabilisma expressed his utmost thanks to the leadership of the provincial government of Northern Samar for their support in making Norsamelco a stable electric cooperative.

“Governor Jun Ong has been very supportive, as well as Vice Governor Gary Lavin and all the board members. All our initiatives are being supported by them. They even passed a resolution regarding our restructuring plan,” he said.

From being an ailing D-rated cooperative, Norsamelco has greatly improved since 2013 and is now rated A by the National Electrification Administration (NEA), two notches away from the highest rating of AAA.

It can be recalled that the debt of the cooperative to the Power Sector Assets and Liabilities Management Corporation (PSALM) rose to more than P641 million in 2013, prompting NEA to intervene and took over the management and operations.

NEA installed Engr. Hector Tabilisma as acting general manager in July 2013 while allegations of mismanagement and corruption led to the resignation of its board of directors in August of that year.

Gov. Ong is glad of the improvement and stability that Norsamelco now enjoys, and hopes that somehow it will help improve the quality of lives of the people of the province.

“We are so proud of the gains of Norsamelco. At the start of my term as governor, I was one of many who opposed of having a board of directors, and turning over the management of the cooperative to them. I commend the leadership of Engr. Tabilisma for having resuscitated the cooperative

from near dissolution,” the governor said.

Recently, the proposal to elect a new set of board of directors was again raised but Gov. Ong expressed his opposition on this.

“I believe that rushing to elect a new set of board of directors at this crucial time where Norsamelco is just rebuilding is counterproductive and something the cooperative can do without for now. In fact, this sentiment has also been expressed by our Sangguniang Panlalawigan through a resolution. The many businesses coming to invest in the province is a good indication of the current strong leadership at the cooperative’s helm,” Gov. Ong stressed.

Tabilisma also expressed gratitude to Representatives Edwin Ong and Raul Daza for personally lobbying to PSALM to approve the restructured loan payment plan of the cooperative which led to the signing of a restructuring agreement last November 26, 2018.

He added that the long-term power supply contract with GN Power Dingenin Ltd. Company which started this year will ensure a secure and dependable electric power supply for the province.

“Our investors can be assured of a stable power supply in the province at a low power rate,” Tabilisma said. **(JENNIFER SUMAGANG ALLEGADO)**

## NMP passes ISO 9001: 2015 surveillance audit

The National Maritime Polytechnic Quality Management System (NMP QMS) maintains its ISO 9001:2015 Certification after passing the Surveillance Audit conducted by the Anglo Japanese American (AJA) Registrar Limited, simultaneously at its main office in Tacloban City and liaison office in Makati City on 6 March 2019.

Eugene Herradura and Capt. Nicanor Altares, AJA auditors, reviewed NMP’s quality procedures, quality manuals, and other systems documentation as against the standards.

The areas that were examined include registration and certification procedures; course delivery; assessment / examination; documentation, conduct of maritime researches; performance monitoring and

assessment; provision of resources; and other administrative support services during the audit.

During the exit meeting, Herradura, audit team leader, expressed his appreciation for the NMP’s established QMS, proper documentation as well as the support and commitment of the top management for the continual improvement of its QMS. But somehow the audit report raised some observations and a minor non-conformity.

Thirty calendar days is given to NMP to submit the plan of action together with the objective evidence

in addressing the non-conformance.

Nonetheless, the NMP QMS was recommended for continued certification.

NMP Executive Director Joel Maglunsod also acknowledged the contributions of all NMP employees for the continual improvement of the Agency’s QMS.

“Thank you for all that you do, this was made possible through the concerted efforts of everyone,” he said.

## All Filipino citizens now entitled to health care coverage-PhilHealth8 RVP

TACLOBAN CITY- It is here. It has come.

The Universal Health Care (UHC) is now in Region 8, and as the whole country enforces the law in government hospitals, Eastern Visayas region is likewise set to provide sooner the “health care coverage” to all its citizens.

As an initial step, a series of information caravan will be held with PhilHealth8 leading, as told to media by Regional Vice President (RVP), Dr. Leo

Douglas Cardona, Jr. on March 11, 2019.

According to Cardona, they are set to hold Information Education Campaign (IEC) in rural health units and government hospitals in the region, starting off with Samar Island’s health facilities down to the Leyte provinces.

“However, UHC will not be limited to government hospitals only,” he added. “This is precisely the main focus of PhilHealth8 in particular, to innovate, that private hospitals may soon

support or cooperate, after all, it is a law”, Cardona pointed out.

“When President Rodrigo Duterte signed the law, it was his main agendum to provide quality, accessible and affordable health care to all Filipino citizens, thus, invitation is being made to private hospitals,” he added.

UHC grants every citizen eligibility with no ID required as they can access to preventive, promotive, curative and rehabilitative health service delivery.

‘No Balance Billing’

(NBB) is the word, when a patient can expect non-payment of hospital bills, only to some extent however, because when a patient opts to stay in a private room, that cannot be free of charge,” Cardona stressed.

NBB provides that “no other fees or expenses shall be charged or be paid for, by the indigent patient, above and beyond the “packaged rates” during their confinement period”.

## Councilor Villasin eyes political harassment Rivals file perjury rap against Tacloban city councilor who is seeking for a provincial seat in this year's polls

TACLOBAN CITY-- A councilor of this city is facing perjury complaint filed by her political opponents claiming she is not qualified to run as board member for Leyte's second district.

But Raissa Villasin, serving on her second term as a member of Tacloban's Sangguniang Panlungsod, dismissed the perjury complaint as nothing but political harassment.

On their complaint, Nestor Abrematea, Benjamin Villegas, and Florante Ygana alleged that

Villasin committed perjury when she declared that since September 11, 2018, she has been residing in Barangay Cuta, Barugo town or for two years now while on her certificate of candidacy she has been living in the said village for two years and seven months.

The complainants, who filed their complaint Tuesday (March 12) before the City Prosecutor's Office and at the Provincial Prosecutor's Office based in Carigara town, secured a certification from Tacloban City elections officer Ma. Goritti

Caña stating that Villasin still casted her vote in the May 14, 2018 election in Tacloban City.

Tacloban City is a highly urbanized city whose residents are not qualified to vote or be voted upon for any provincial elective posts.

The three claimed that Villasin is guilty of perjury under Article 183 of the Revised Penal Code or a willful and corrupt assertion of falsehood under oath or affirmation administered by authority of law on a material matter.

Veloso said that he also fears for his family's security, adding that they want him to withdraw on his reelection bid after his name was included among the country's narco-politicians.

"But I told them that if I will do that, this will only allow the evil ones to prevail. I will not run against a fight, especially if my reputation is being besmirched," he added.

The lawmaker said that he would go on with his reelection bid as he con-

tinued to enjoy the support of the people in the district. "They told me never to surrender and give up," he said.

Veloso recalled that in one of the Senate hearings conducted by its committee on public order and illegal drugs, he personally attended it to confront Kerwin Espinosa, alleged drug kingpin of Eastern Visayas.

Veloso said that Espinosa denied and even apologized to him that his name was dragged among politicians that he allegedly dealt for his anti-drug activity.

"I thought this is over.

This is just a rehash of previous accusation. Its election time," he said.

Still, the solon said that he will face the allegation as he vowed to clear his name, adding that he will ask for a congressional inquiry once their session resumes on May 22 as to why his name was included.

He also said that he would file criminal case against some personnel of the Philippine Drug Enforcement Agency, Philippine National Police, and the Department of Interior and Local Government for including his name without any basis.

## Eastern Samar highlights native cuisine, delicacies in food lab

TACLOBAN CITY-- A food service sector laboratory (FSSL) in Eastern Samar has turned into a tourism learning facility, promoting the province's authentic local cuisine and delicacies for its visitors.

"It provides food service to locals and tourists. Those who wish to engage in a small food business may come to learn how the basic of food service dynamics, local cuisine preparation, and others at par with tourism standards," said provincial tourism officer Franklin Robedizo.

At least six stalls and one "Pasalubong" Center were established at the provincial capitol's grounds to showcase locally manufactured food and non-food products.

"The FSSL is a platform to encourage local tourism stakeholders to engage in livelihood, purposely to achieve additional income for the family and eventually help reduce poverty in the province," added Robedizo.

According to Robedizo, the laboratory's tenants are the ones who teach those who would like to learn the local cuisine.

People will learn to cook easily because all food of-

Local menu includes ginataang manok (chicken stewed in coconut milk), grilled fish, seafood and

meat, sinigang (stew), tinola na isda (fish in ginger broth), Borongan express, aroz caldo, and fruit juices, among others.

The food laboratory started its operation last Dec 16, 2018.

According to Robedizo, the establishment of the laboratory is "in pursuance with the 'Proyekto 25' on tourism program of Governor Marcelino Ferdinand Picardal." **(RONALD O. REYES)**

## Leyte tops chicken production in Eastern Visayas for 4<sup>th</sup> quarter 2018

with 693,208 birds accounting for 27.5 percent of the region's total chicken inventory. Eastern Samar, meanwhile, registered the lowest inventory of chicken with 4.7 percent share or 117,668 birds.

By package rate means that there are certain items provided in the UHC which are granted to direct and indirect members, which is why the team will go around the region to explain UHC to implementers.

Further, UHC adheres to the Magsaysay maxim, that those who have less in life, should have more in law; that in the spirit of solidarity, those who can better afford, will have lesser discounts while the indigent ones would have more.

As to the professional health workers, they cannot

be left out, contrary to some apprehensions with the implementation of UHC.

Asked what will happen to some monetary benefits that doctors and nurses used to get, out of their passion and hard work in caring for the sick, Cardona said, they will still receive in order to incentivize them.

"They should stay put in their hospital service and render the much needed health service," he said.

"Give to Juan what is due him," the head doctor of PhilHealth said. "Health workers in the rural areas, particularly those in geographically isolated areas

will still get additional benefits as may be determined by local health boards, others by DOH.

Cardona detailed to media that funds for UHC implementation will be sourced from the Philippine Gaming Corp. (Pagcor) (50%), Philippine Charity Sweepstakes Office (40%) the rest from members' contribution and subsidies from sin taxes.

Lastly, he proudly shared that part of PhilHealth's innovation is to tie up with Philippine Statistics Office, LGUs and private hospitals soonest. **(PIA-08/ANicart)**

the chicken industry in Eastern Visayas posted 20.0 percent increase in production during the fourth quarter of 2018.

Based on the preliminary data, the total chicken production in the region went up to

15,602 metric tons (MT) in the 4th quarter of 2018 from 13,006 MT in the same quarter of 2017.

“Eastern Visayas accounted for 3.1 percent of the country’s total chicken production during the 4th quarter of 2018. It ranked eighth among the regions with low chicken pro-

duction in the country,” Perante said.

Meanwhile, chicken inventory showed that chicken population here in the region as of 1 January 2019 stood at 2,524,559 birds or an increase of 2.5 percent from its 2,463,777 inventory on 1 January 2018. **(RESTITUTO A. CAYUBIT)**

**DPWH completes road leading to Leyte’s top tourism farm school**

CARIGARA, Leyte – A major access road leading to Villaconzoilo Agri and Eco Tourism Farm in Jaro, Leyte is now serving tourists and motorists, the Department of Public Works and Highways (DPWH) Leyte Second District Engineering Office reported.

The department poured out a total of P85 million for the concreting of the 3.5-km long and 6.1-meter wide road including its drainage system.

According to Engr. Gerald Pacanan, district engineer of the DPWH- Leyte Second District Engineering Office, the completion of the project is sure to boost tourism in the area and provide more opportunities to the community.

“Through better road connectivity, we are promoting inclusive growth and poverty reduction, especially in rural areas,” he added.

Villaconzoilo is an upland village seven kilometers away from the town proper of Jaro and lies 600 meters above sea level, known for its cool and natural atmosphere.

It is the first farm tourism in Leyte accredited by the Department of Tourism (DOT) offering various high-value products including strawberries, grapes, watermelons, lettuce, broccoli, carrots, cauliflowers, rambutan, radish, and asparagus.

The farm is not just known as rich agricultural plantation, but also as a learning site on practical agriculture accredited by the Agricultural Training Institute.

Meanwhile, as part of the government’s effort to extend development programs in hard to reach communities, the district is currently implementing a P9.85 million road con-

creting project leading to Silawan Falls in this village under Payapa at Masaganang Pamayan (Pamana) fund.

gressively pursued for the establishment of its QMS in compliance with the requirements of the Standards of Training, Certification and Watch keeping Convention (STCW) 1978.

Its first ISO Registration Certificate was obtained in April 2000. Since then, the NMP QMS has undergone

continuous certification and surveillance audits, passed and was eventually re-certified over the years under ISO 9001: 1994, ISO 9001: 2000, ISO 9001: 2008, and the latest in 2018 under ISO 9001:2015.

The implementation of the NMP QMS is also in adherence to Executive Order (EO) No. 161 dated 05 October 2006 as amended by EO No. 605 dated 23 February 2007, which directs the institutionalization of quality management system in the government.
