Current provincial hospital has a 'Malasakit Center' Biliran soon to have a bigger, spacious provincial hospital

NAVAL, Biliran- A modern and spacious provincial hospital is soon to be constructed in this town that can accommodate more people who need medical care.

This after a bill principally sponsored by Biliran Rep. Rogelio Espina was signed into law by President Rodrigo Duterte not only expanding the current bed capacity of the provincial hospital but relocating it to a safer place. The expansion and relocation of the Biliran Provincial Hospital (BPH) is contained under Republic Act 111671 which was signed into law by Pres. Duterte on January 3, this year. Rep. Espina, who is now on his third and last term and running for governor in the province in this year's midterm elections, said that he is happy that finally his dream for Biliran to have a better provincial hospital is now

realized.

According to him, the proposed new BPH will now have a 200-bed capacity or an increase of 125 beds

from the current bed capacity of the current provincial hospital.

Stranded dolphin brutally speared in Northern Samar

TACLOBAN CITY- A stranded spinner dolphin was brutally speared with a bamboo pole by river-goers in Victoria, Northern Samar.

In a video sent by a concerned citizen to the regional office of the Bureau of Fisheries and Aquatic Resources (BFAR), it showed how the spinner dolphin locally known as lumba-lumba tried to swim away from the river but was mercilessly speared instead.

The bureau said the incident occurred on April 5.

The municipal agriculturist and AT-fisheries initially responded to the site, but they were not able to see the spinner dolphin in Bangon River anymore, according to the BFAR.

Leyte Rep.Ong says completion of a bridge construction in Barugo town to bring in economic development

TACLOBAN CITY-Leyte Rep. Henry Ong (2nd district) has expressed his optimism that the construction of a concrete bridge that will connect three villages in Barugo town will bring in development and faster delivery of goods and services.

The reelectionist solon was referring to the ongoing construction of a concrete bridge connecting the interior villages of Minuhang, Balud and Duka, all in Barugo town.

The bridge is constructed in the amount of P190 million and is expected to be completed within this year.

"Currently, transporting agricultural and marine products to the public market is very costly and inconvenient since the existing footbridge is only passable to single motorcycles. Students also skipped classes during high tide, when the bridge is submerged," Ong said, citing the burdens being experienced by the residents of these villages.

Aside from providing convenience to the villagers, the bridge can also be used as an alternate route in the event



the Tacloban-Palo-Carigara-Ormoc road will be rendered impassable.

"I am particularly proud of this project. The foot bridge has been there long before I became a congressman and its only now during my term that this was given attention for the bridge construction and concreting," Ong said.

SPES workers' deployment set on April 16

TACLOBAN CITY-The Public Employment Service Office (PESO) has announced that it will start the deployment on April 16, 2019, of the Special Program for the Employment of Students (SPES) workers to the different departments of the city government.

Prior to their deployment, the first batch consisting of 85 SPES workers will attend a pre-deployment orientation at the Tacloban City Training Center on April 16.

Some 145 slots are available under the SPES of the city government of Tacloban under Mayor Cristina G. Romualdez the Department of Labor and Employment (DOLE) for this summer break.

PESO started accepting applications for the program last January to facilitate the processing time required by DOLE.

Aside from being assigned regular office work, SPES workers will also undergo several activities like livelihood orientation and other socio-civic activities as part of the holistic approach of the city government to the program.

The SPES workers will work for 20 days and will be paid a wage of P477.73 per day.

Sixty percent of the total wage of students is shouldered by the city government while the other 40% is paid by the Department of Labor and Employment (DOLE).

Abbie Montablan, 21, says he is sure of what he is going to do with his life after venerating the National Youth Cross and blood relic of the late pope, Saint John Paul II.

"It's a good, heartwarming experience seeing the relic of St. John Paul II for the first time. I am now more inspired. I want to be a priest," said Montablan, a seminarian at Sacred Heart Seminary in the central Philippines. "I have never met Pope John Paul II in person. The arrival of the (late) pope's relic is an inspiration to the youth whom he always addressed when he was still alive," said Montablan.

the life of Pope John Paul II who was later canonized as saint in 2014 "showed an example to the church 'not to be afraid' to serve others and meet other people."

"It is a blessing that his blood relic is visiting. I have never gone deeper in my studies about him, but mined "to let Christ in" in his message to the youth to open our hearts to let Christ enter our lives has served as my inspiration," he said.

The blood relic of the late and wildly popular pontiff arrived in Leyte last month visiting several churches like the Santo Nino Church in Tacloban City.

Originally, then Archbishop of Kraków His Eminence Stanisław Cardinal Dziwisz, a long-time personal secretary to Pope John Paul II, gifted the blood relic to Supreme Knight Carl A. Anderson.

"By venerating the relics of St. John Paul II, pilgrims seek his intercession, receive spiritual graces for their families and loved ones, and obtain the courage and spiritual strength to imitate his saintly life and persevere in their Chris-

St. John Paul II once held a mass at the cathedral during his visit in the country in February 1981.

A Filipino nun based in Poland carried the still liquefied blood of the saint to the Philippines in December.

There were only seven vials containing the blood relic from St John Paul that are venerated across the globe.

In the Philippines, the blood relic placed in a reliquary will be under the custody of the Archdiocese of Manila.

"Let those who have special intentions and petitions come in veneration and prayer," the Manila Archdiocese said in statement.

The veneration in Manila started in April 7.

Human Rights Victims

Victims of human rights violation during Martial Law deserve to be compensated for their suffering. The victims should receive compensation for their suffering.

It is in the best interest of the victims if the government would provide support such as security during the distribution that will begin next month.

The New York Federal Judge ordered \$13.75 million to membesr of the class suit translating to about \$1,500 to each of the estimated 6,500 victims of human rights violation. Most of the members of the class action are already old and in dire need of assistance.

The Office of the Solicitor General (OSG) claimed that the settlement agreement is grossly disadvantageous to the Philippines. The settlement agreement stemmed from negotiations conducted by various parties including the victims and the Philippine government on how to divide the proceeds from the sale of the paintings seized from Vilma Bautista, an aide of former First Lady, Imelda Marcos. In the agreement, the victims will receive \$13.75 million while the government will get \$4 million.

The distribution will begin on May 1 in Butuan City followed by sequential distributions in 15 other cities until July.

The government should stop opposing the release of the funds as it is the rights and benefits of the victims to receive whatever is due for them.

A compassionate government should be more than willing to protect and make sure that these funds should be released as this is what the poor victims need. It should support a ruling of a foreign court that is actually helping the poor.



For LGUs' route plan needs

As stipulated in the manual of Local Public Transport Route Plan (LP-TRP), Local Government Units (LGUs) are mandated by the Department of Transportation (DOTr) to issue certifications confirming the necessity for public transport services to be in consonance with the LGU's development plans prior to designation and enforcement of public transport routes. This scheme is in recognition of the LGUs' mastery of their own mobility and accessibility needs, as well as their policies and ordinances that were established to address challenges on local transportation. Thus, LPTRP empowers the LGUs to develop the route-oriented transport plans.

tiate and plan the local, regional, and national transportation systems and, in effect, gradually eliminate their dependence on the private sector. The active role of LGUs in local transportation planning strengthens the DOTr and its associated agencies' mandate as the main government agency that authorizes, provides, and promotes adequate safe, reliable, efficient, and environment-friendly public transportation for every Filipino. The public transportation route planning through the office of DOTr aims to reduce the reliance on private vehicle use and adopt an environmentally sound mobility solutions. It also develops and promotes high-quality public transportation systems, and ensures the prioritization of the movement of people and goods instead of vehicles in order to realize these goals. The office further promulgates, administers, enforces, and monitors compliance

with public land transportation policies, laws, and regulations, which promote mobility as a basic human need. Lastly, it tries to address the various challenges, such as limited number of PUVs, illegal parking, traffic signage, long passengers' waiting time, exorbitant prices, arrogant crews, etc., which are directly experienced by commuters.

To realize these objectives mentioned, the LGUs have to construct the LP-TRP which primarily offers an efficient and responsive public transportation system anchored basically on the needs of all commuters. They should provide public transportation in underserved areas, and rationalize areas with oversupply of public transportation modes. Moreover, LGUs must address legitimate issues which are identified by town/city residents. Expectedly, LPTRPs must be integrated into the CLUP and the Comprehensive Development Plan (CDP). LPTRPs should regularly be monitored and evaluated following the same cycle of CLUP review. But LGUs should hire a company that is capable of conducting research surveys whose data could be used to craft the LPTR Plans. In Tacloban, there is Alta Sofia Learning Institute that LGUs throughout the region could hire for this research purpose. This company with excellent



Our need for silence

WE have to realize this more deeply. With all the hustle and bustles of our world today, with all the noise and distractions that we have, we have to exert tremendous effort to maintain silence, both inside and outside us, if only to manage to pray.

Prayer, as we all know, is our basic way of connecting with our father God, the source of all good things. We have to do everything to be able to pray, for without it we would be detaching ourselves from the very foundation of our life.

But given the conditions nowadays, prayer is practically ignored and neglected, and even considered as a nuisance, irrelevant and useless. Thus, many people are now trapped in a world of activism and all forms of self-seeking and selfabsorption.

We have to recover the appreciation of prayer and the need for silence and recollection to be able to pray. Christ himself, who is already God, needed to pray. And in spite of the very demanding redemptive work he had to do, he always exerted the effort to find time and the appropriate place to pray.

Many times, he had to wake up early, way before morning, and to go to a deserted place to pray. There were even times when he had to spend the whole night praying. And let's not forget that before he launched his public life, he spent forty days in a desert to pray and fast. Christ withdrew from the crowd to have silence and recollection, so in-

dispensable for him to pray. We should also realize that we need to have silence and recollection to keep our relation with God strong and vibrant.

We cannot deny that it is when we manage to have silence and recollection that we can listen more to the voice of God who is actually always intervening in our life. We would become more discerning of God's will and ways, and more able to be docile to him.

We obviously have to do a lot of self-denial to achieve this ideal condition for prayer. But we should not be surprised by this and should be eager to go through them. Among the things we can do in this regard are to always give priority to a time of prayer and meditation and to look for the appropriate place and time for it.

Ideally, it should be in a place of prayer like a church or chapel and before the Blessed Sacrament. The time is whenever we can be most at peace with God. We have to learn how to get away

for the meantime from our usual activities. More than this, we have to know how to silence our passions, and to focus our inner faculties—intelligence, will, imagination, memory, etc.—on God alone.

That's when we can start to hear and feel the promptings of God. Let's remember that more than us, it is God who directs our prayer. He is the one who will show us things.

Many times we have to force ourselves to go through this process of attaining silence and recollection for our prayer. We have to convince ourselves that for us to be able to pray, and to persevere in it, we should feel the need for prayer more deeply. We can only pray when we feel that need rather than when we depend on our wanting to pray.

That is part of the selfdenial Christ is asking of us. We should go beyond feelings and wanting. With our will, always supported by God's grace, we can manage to pray in spite of contradicting or uncooperative feelings.

When we manage to have silence and recollection in our moments of meditation, it is likely also that we can manage to have them when we get immersed in our daily routine of work and other concerns. This is an art and skill that is so badly needed these days.

TACLOBAN CITY The Commission on Population and Development (Popcom) partners with the Department of Agriculture (DA) in bringing Responsible Parenthood and Family Planning (RPFP) to communities in the region under the Special Areas for Agricultural Development (SAAD) Program of the agriculture office.

The SAAD Program is a comprehensive strategy that provides livelihood opportunities for farmers and fisherfolks in the top ten poorest provinces in the country, which include Samar island areas and Southern Leyte province in Region 8.

"Saad" is a Visayan word for promise and the program is anchored on two major components: social preparation, and food production and livelihood.

The partnership with DA comes under this strategy where farmers and fisherfolk beneficiaries of the program will become the target for RPFP classes by Popcom.

Identified areas for this joint undertaking are Lawaan, Balangiga, Hernani, Quinapondan in Eastern Samar and Sogod, Bontoc, Malitbog and St. Bernard, all in Southern Leyte. number, timing and spacing of their children, and to contribute in improving the maternal, neonatal and child health, and nutrition (MNCHN).

Andrew Rodolfo Orais, DA-8 assistant regional director for operation and extension, said the partnership is "very timely" as they are looking to fill in the gap on the social preparation component of the SAAD program.

For the initial allocation per province, the food production and livelihood component of SAAD provides interventions such as production support services; extension or training support and technology demonstration; and, provision of other agricultural equipment or facilities. "The production and livelihood component is very well served while it is in the social preparation that we need partnerships such as this so as to provide a holistic approach to this program," Orais said.

Meanwhile, as an initial step, Popcom has entered into a joint agreement with the National Economic and Development Authority and the Department of Health last February 15 aimed at addressing the needs of the country's growing population and its impact on

CALABARZON gubs, execs vowed to support Bong Go

Governors of the voterich CALABARZON (Cavite, Laguna, Batangas, Rizal, and Quezon) on Sunday declared former Special Assistant to the President and senatorial candidate Christopher Lawrence "Bong" Go an adopted son of the region and vowed to support his candidacy.

"Nangangako kami na pangunahan ang mga mamamayan sa aming mga probinsya para dahin sa Senado si Bong Go. Kaugnay sa ganitong layunin, buong karangalan naming idinedeklara si Bong Go, na isa ring Batangueno, bilang anak ng buong CALABARZON region," the governors said in a two-page "Manifesto of Support" dated 10 February 2019.

For his part, Go thanked the CALABAR-ZON governors for their support, saying it will inspire him to work harder to serve the people.

"Unanguna, maramingsalamat sa inyong assurances, sa inyong tulong at sa inyong commitment," Go said.

Go noted that while he had no political plans, President Duterte prodded him to run for the Senate to serve the people in a greater capacity.

"Ipinagbilin niya sa akin, sabi niya: Di ka magkakamali Bong gawin mo lahat para sa Pilipino. Serve the Filipino first, hindi ka magkakamali," he added. "Asahan nyo pareho kami ni Pang. Duterte, interes ng Pilipino po ang uunahin namin bago ang lahat."

Quezon Gov. David "Jayjay" Suarez said the gathering is historic since the region has never had any unified stand and a unified voice in supporting any candidate in the previous elections. Bong "SAP Go makakaasa po kayo na ang probinsya ng Quezon is behind you 110 percent," Suarez said, noting Go was instrumental in the realization of many development projects in his province. Speaking for Laguna, Gov. Ramil Hernandez said: "Tataya po ang Laguna sa inyo at ang inyong panalo ay panalo narin namin."

"Ang buong Rizal ay maaasahan ninyo sa darating na halalan," said Rizal Gov. Rebecca Ynares, noting the former SAP has always provided assistance every time the province is in need.

Noting that Go is also a Batangueno, Batangas Gov. HermilandoMandanassid the province has not asked anything from Duterte but the Chief Executive has given them a very big favor through the service of a fellow Batangueño.

"Ang una at pinakamahalagang ibinigay sa atin ni Pangulong Duterte ay payagan ang kapwa naming Batangueño, ang ating SAP Bong Go na kumandidatong senador," Mandanas said.

For his part, Cavite Gov. Crispin Remulla committed his province's support for the candidacy of Bong Go, saying, "Ang sisikapin naming gawin, top three po ang hahabulin namin (para sa inyo) sa lalawigan ng Cavite."

Go's legislative agenda include the improvement of the delivery of health services, including the establishment of Malasakit Centers in all provinces and urban centers of the country. The center makes it easier and faster for poor patients to avail of medical and financial assistance from the government by bringing together in one room all concerned government agencies such as the DOH, DSWD, PCSO, and Philhealth. In addition, Go's legislative priorities include programs for agriculture, anti-illegal drugs, and criminality, education, housing, long-term sports development, fire prevention and protection, anti-corruption, localized peace talks, creation of Department of OFW, barangay welfare and improved benefits for senior citizens.

In the 2016 elections, CALABARZON has the highest number of registered voters nationwide with 7.6 million. It is estimated that voters in the region for the 2019 elections has reached around 8.8 million.

Catbalogan residents warned as heat index hit dangerous level

TACLOBAN CITY-The Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa) has asked residents of Catbalogan City in Samar to stay indoors during midday this dry season as the city's heat index soared Tuesday to 42.6 degrees Celsius, the highest this year.

The state weather bureau reported that among the six provincial capitals in Eastern Visayas, only Catbalogan registered a heat index above 41 degrees Celsius, considered a "danger" level. The city is among the 14 areas in the country with high heat index recorded on April 9.

Residents of "danger" level areas are likely to experience cramps and heat exhaustion while heat stroke is probable for individuals with continued activity, said PAGASA Tacloban station chief Mario Peñaranda.

"Our advice to the public is to stay indoors as much as possible from 10 a.m. to 3 p.m. and drink eight to 10 glasses of water daily since the body needs water to keep cool. We expect the heat index to increase due to dry season," Peñaranda said.

Heat index are human discomfort index that gives the "apparent" temperature or what human perceive or feel as the temperature

affecting their body. High air temperatures and high relative humidity will give high apparent temperatures or indices. Full exposure to sunshine can increase the heat index by eight degrees Celsius.

Other provinces in the region posted a lower heat index such as Borongan City in Eastern Samar (36.2), Catarman in Northern Samar (38.7), Maasin City in Southern Leyte (28.2), and Tacloban City in Leyte (32.7).

Peñaranda said despite the high heat index in Samar province, some parts of Eastern Visayas experience rains due to easterlies. (SARWELL Q. MENIANO/ PNA)

Go pushes for legislation to address water shortage

SAN PEDRO CITY,

Laguna -- Former Special Assistant to the President Christopher Lawrence "Bong" Go on Monday pushed for vital legislations to address water shortage and scarcity of water source in Metro Manila as well as communal impounding water supply facilities in far-flung areas of the country.

In a media interview, Go said he and local political stalwarts barnstormed around Calamba City proper and rural areas in Laguna, especially the depressed areas and Laguna de Bay coastal communities to see the real situation on the ground.

His motorcade trailed through congested areas and slums from Calamba to the highly-populated villages in Cabuyao City, Barangay Sinalhan in Sta. Rosa City, BarangayMalaban in Biñan City and San Pedro City in Laguna's first and second districts.

He proposed for more validated studies to tap more sustainable water sources from the Calabarzon Region like the Kaliwa Dam in the hinterlands of Quezon and Rizal provinces; Cardona treatment facility in Rizal and Laguna water supply sources, including plans on filtration and treatment facilities from the country's biggest living lake, Laguna de Bay.

"Silipin nating mabuti yan. Yung Calabarzon nga po isa sa mga sources ng tubig, isa po yan sa ating sisilipin pagdating ng panahon if these need legislation (We have to look into that closely. Calabarzon is one of the water sources, and we have to conduct timely studies that need legislation). I will take a look on it," Go said, assuring protection and conservation of water sources for sustainable development.

President prompting Rodrigo Duterte to meet with water officials and executives of concessionaires Manila Water and Maynilad Water Services. Subsequently, the Senate called for a probe which delved into Metro Manila Waterworks and Sewerage System (MWSS) being caught flat-footed when it fell short of its mandate in monitoring concession agreement, enforcing rates and service standards and on reporting regularly performance of the concessioners and infrastructure assets to the public.

Go mulled for legislation and review of the water agencies on enhancing water sources like the establishment of communal and local government-owned water supply system to address water shortage. *"Sa ngayon tulungan* natin ang ating LWUA (Local Water Utilities Administration), upang masolusyunan ang problema sa tubig at hindi lang po sa Metro Manila kundi pati narin sa ibatibang lugar na malalayo na kailangan po talaga ng pasilidad para magkaroonna po sila ng maayos at malinis na tubig (for now, let us help the LWUA to solve the water problem not only in Metro Manila but also in other far-flung areas needing

access to facilities for safe and clean water)," he said.

Village folks welcomed Go and the local candidates' motorcade in whistle-stops at depressed areas, saying "this is the first time a Senatorial bet has visited their barangays."

Go's sortie stretched to almost five hours, spelling out the needed services for constituents as "special assistant for the people (SAP)" and as the "President's bridge" to them in his mid-afternoon address before the multisectoral assembly at a San Pablo City multipurpose hall.

He told the crowd that early on before the campaign season, there are already some 34 Malasakit Centers established in government hospitals across the country to set up a one-stop-shop for the expeditious health care delivery system, free medical services and medicines for the poor. "Lahat po ng ating mga plano, tulungan po natin sa murang pabahay, scholarship sa mga estudyante, serbisyong medical, Malasakit Centers bilang bahagi sa mas pinaigting na health services sa ating mga kababayang may mga karamdaman (all our plans, let's help them on affordable housing, students' scholarship, medical services, Malasaki Centers as part of our intensified health services for our sick compatriots)," he said, citing the need for affordable and decent housing and basic services for those living in the slums.

He said the President's signing into law of the Universal Health Care for all Filipinos has complemented the Malasakit Center's goals with PhilHealth tasked as lead agency for the fund allocations and these health services hubs shall ensure the zero-balance billing under the hassle-free scheme.

He thanked the Lagunenses for their overwhelming warm welcome amid the summer heat and vowed "to continue his people-centered, service-oriented advocacies, especially the poor Filipinos in every nook and corner" where these services are mostly needed. Go spelled out his 12-point legislative agenda which support the President's relentless war against illegal drugs, criminality, corruption and on the Magna Carta for barangay officials, medical services and the Malasakit Center, affordable housing, agriculture, education, senior citizens, localized peace talks, sports development and the establishment of Department of Overа seas Filipino Workers' Affairs. PRDP-PPMIU highlights Gamay FMR on its April meeting

CATARMAN, Northern in Pambujan. Samar - Members of the Philippine Rural Development Project - Provincial Project Management and Implementing Unit (PRDP-PPMIU) held their monthly meeting on April 10.

Projects under the I-BUILD component of the PRDP were given focus during the meeting.

While the rehabilitation/improvement of Bantayan-Malobago-Pagsangan farm-to-market road (FMR) in San Roque is nearing completion, the concreting of Burabod-Cadac-an FMR in Gamay continues to miss monthly targets resulting in slippage of -43.71% as of March 31.

The body advised the contractor of the latter FMR project to directly report to the regional office of the Department of Agriculture-PRDP to seek advice on how to resolve this problem.

They continue to highlight the importance of completing this project as failure to do so may still compromise the construction/improvement of Camparanga-Manahaw-San Ramon-Canjumadal FMR

Under the I-REAP component, six out of 13 Small Livelihood Projects (SLPs) for super typhoons 'Yolanda' and 'Nona' have already been satisfactorily completed and complied with all the required processes and procedures stipulated in their signed enterprise implementation agreements (EIAs) with the provincial government of

Northern Samar. These completed SLPs consist of hog fattening and trading (Allen, Mondragon and San Jose); goat production and marketing (Catarman); bio-organic and vermin-culture project (Allen); and duck egg production and processing enterprise (Catarman).

The financial grant for each SLP is worth P1 million.

Finally, no LGU has yet submitted a proposal under the potable water system project of the PRDP.

Training on detailed engineering design and program of works can still be conducted in the province but LGUs must first signify their intent to avail of this project. (PR)

the performance rating of her immediate superior and gave her unsatisfactory rating which could be used as basis for her eventual dismissal from service.

Godes claimed that Reveldez, who is running for vice governor in this year's midterm elections, tampered her individual performance commitment and review (IPCR) covering the periods of the first semester and second semester of 2017 and the first semester of 2018, giving her failing marks.

Godes said that for the first semester of last year, for example, she received an overall performance rating from immediate superior, Dr. Estrella Pedrosa, of 4.33 percent with 5 percent as the highest rating.

But she alleged that Mayor Reveldez revised the rating and made it just at 2.96 percent.

"That on the 1st week January,2019, of (I)was told by the HRMO that my rating was unsatisfactory based on mayor's rating and was told to submit means of ve

porting documents to justify (my performance)," she said in her letter.

"The HRMO handed to us our IPCR/OPCR with the notation of Mayor Reveldez dated Nov.26, 2018 regarding submission of MOVs. Upon browsing, there were corrections on the rating of our immediate superior, the Municipal Health Officer in the mark/ rating on a red pen. No dialogue nor meeting was conducted to justify, not even the Performance Management Team," Godes said on her March 25 letter.

She said that Mayor Reveldez also made the same alleged tampering on the performance rating of two other employees.

This act of the mayor resulted to sleepless nights as the unsatisfactory rating she received from the mayor could lead to her dismissal from service, Godes said.

Reached for his comment, Mayor Reveldez dismissed the allegation of Godes saying that as the mayor and head of the Performance Management Team (PMT), he has the final say in giving ratings to the employees of the municipal government.

rating is being used by him as a basis in giving performance bonus to the employees.

"I am the mayor of the town and chairperson of the PMT of which I created. I have the final say," he said.

He added that all employees of the municipal government is given the opportunity to rate their own performance which is then forwarded to the PMT, which, in turn, submit their ratings for his review.

"I have to evaluate why they rate themselves five, for example. These selfratings are submitted to the PMT which endorse these to me as its chair for my own evaluation," he said.

He then conduct his own evaluation by asking them mode of verification which include mostly supporting documents.

"These ratings should be supported with documents and not just hearsays," Reveldez said.

Reveldez said that he has already submitted his reply to the Ombudsman on March 23.

The Ombudsman has yet to issue its decision on this complaint against the outgoing Culaba town mayor.

...from Page 3 the relic is the National Youth Cross, the first cross ever made for the Philippine Catholic youth minis-

try. The Cross had its first nationwide pilgrimage during the 25th anniversary of Episcopal Commission on Youth in 2011.

According to Militante, the visit of the relic and the Cross is a "continued preparation" for the Filipino youth to the 500th year celebration on the arrival of Christianity in the country in 1521.

"St. John Paul II is very close to the youth. His teaching involved encouraging the youth and help them to grow up in God. This is very timely because the youth today are facing plenty of forces that would drive their spirituality away from the church," Militante said.

During his papacy, St John Paul II launched the World Youth Day in 1985.

In the 1995 World Youth Day hosted in the Philippines, the pope witnessed the record-breaking crowd of youth gathered in Manila numbering to over 5 million. While Militante admitted that he only saw the late

pope in television and magazines, he could easily recall the teachings of St. John Paul II every time he hears the 1995 World Youth Day theme song "Tell the World of His Love."

"I was drawn by his simplicity, charisma, and his spirituality. Since my seminary years until I became a priest today, I am inspired by Pope John Paul II's 'Totus Tuus' apostolic motto which mean "totally yours" as an expression of his total commitment and consecration," he added.

"He became an inspiration for me to totally give my life to God and to the service for others," said the 35-year-old priest.

Angela Ruby Tiozon, 16, said that venerating the relic has convinced her that she is right in volunteering for the church activities at the Sto Nino Parish in Tacloban City.

"This is a big opportunity for me to live up on the teaching I learned from St John Paul II," Tiozon said.

"The words 'Don't be afraid' by St John Paul II brings a big impact to my

life to also do voluntary works in the parish," added Samantha Cuero, 16.

According to Militante, the blood relic and the Youth Cross will tour in the Central and Eastern Visayas until May 3.

"The pilgrimage seeks to be a meaningful moment to gather the entire Church communities and pray with and for the youth," said Fr. DPWH takes down unlawful campaign materials in Southern Leyte

MAASIN CITY - The Department of Public Works and Highways (DPWH) Southern Leyte field office dismantled more than a thousand prohibited campaign materials in compliance to the Commission on Election (Comelec) rules.

Assistant District Engineer Allan Eway said their office deployed nine teams with at least four members that joined Comelec and the Philippine National Police (PNP) in the lawful campaign drive dubbed as 'Oplan Baklas'.

"Aside from the campaign paraphernalia posted outside the authorized common poster areas, we also removed those election materials installed within the government's road right-of-way. This is done to ensure safety of the motorists and travelling public plying our major highways," Eway said.

The official cited the decree stating that it is illegal to usurp or obstruct any portion of the road right-of-way by installing private or permanent structures such as stalls, sheds, billboards, signages, and advertisements.

"We asked the candidates and their supporters to put up their election paraphernalia in the proper posting area and comply with Comelec's designated poster size. Having unable

to follow these guidelines is a violation of the election rules that would result to removal of those materials or worst, disqualification of candidates," Eway said.

The Comelec has allowed the following sizes for the materials in common poster areas: 12 feet x 16 feet, (for political parties and party list groups), 4 feet and 6 feet, (for independent candidate), and 2 feet x 3 feet (for individual posters).

During public rallies and meetings, considered as lawful are streamers not exceeding 3 feet by 8 feet in size displayed at the site and on the occasion of a public meeting or rally.

According to Comelec rules, said streamers maybe displayed five days before the date of the meeting or rally and should be removed within 24 hours after said meeting or rally.

Candidates may not put up campaign materials at highways, bridges, center islands, flyover, sky walks, under pass, trees and other public places not designated as common poster areas.

Display or exhibit of any election campaign or propaganda material outside of authorized common poster areas, in public places, or in private properties without the consent of the owner is deemed illegal.

In headquarters or residence of candidates, only lawful campaign paraphernalia may be displayed.

The election period for candidates running for national positions has started on February 12. For local candidates, the campaign period has kicked off on March 29. (PR/FMMT)

"A visit to Eastern Samar will not only enhance awareness conservation on bio-diverse resources and sustain ecological balance on eco-tourism sites, it will also provide livelihood to guides, boatmen, and small entrepreneurs," Franklin Robedizo, provincial tourism officer, said.

With the pro-development program launched by the provincial government, Robedizo said that the service industry has already increased in Eastern Samar.

"It also motivates local leaders to prioritize community driven tourism development," he said.

Positioning itself as the next playground of Eastern Visayas, the tourism officer picked the top destinations in the province offering eco-adventure, historical, religious and nature tours.

According to Robedizo, the seven top spots for summer escapade in Eastern Samar are Calicoan Surfing Area in Guiuan; Canhugas Nature Park, Hernani; Mi-

nasangay Marine Eco-Park, Balangkayan; Ando Island Bantayan Cliff, Borongan City; Apiton Island, San Policarpo; Balangiga Incident (Monument, Church and Bells), Balangiga and Hilangagan Beach, Punta

Maria, Borongan City. "Best things to do in Eastern Samar includes experiencing historical, religious and nature tour in Balangiga, Sulangan Church in Guiuan, and beaches and rock formations in Hernani and San Policarpo," Robedizo said.

"Explore adventure tour at Bantayan Cliff, waterfalls and caving. Surfing in Guiuan and Borongan and kayaking at Binaloan, Taft and Binogawan Beach in San Policarpo," he added.

Earlier, Robedizo said they are preparing for the arrival of Russian tourists to mark this year's 70th commemoration of the odyssey of "White Russians" to Tubabao Island in Guiuan.

Dubbed as "Debrota Tur" or "Kindness Tour", the tour program invites Russian tourists to retrace the steps of the "White Rus-

sians who stayed in Tubabao Island in 1949.

Courtesy of the hospitality of the Filipinos and local residents, some 6, 000 "White Russians" were accommodated in the said Island after they plead for help due to political crisis in their country during the post-World War II era.

The regional office of Department of Tourism and private stakeholders have also crafted another tour program to serve the influx of tourists in Balangiga after the three historic bells seized by the US forces during the Philippine-American War in 1901 were returned to the town in December last year.

Karen Tiopes, regional tourism officer, said that over 20,000 people have already visited Balangiga since the handover of the bells in December 15, 2018.

To complement the accommodation facilities in the province, Eastern Samar Governor Marcelo Picardal has pushed for the homestay program being accredited by the tourism office. (RONALD O. REYES)
