Local candidates start their campaign

TACLOBAN CITY- Candidates seeking for local posts in this year's midterm elections officially kicked off their grueling,45-day campaign on Friday (March 29).

This early, the Commission on Elections (Comelec) has renewed their call for candidates to follow the elections law and conduct their campaign without resorting to mudslinging or violence.

Here in the city, former mayor Alfred Romualdez led his team on their initial barnstorming by attending a Mass at the Santo Niño Church, followed with a motorcade going to Barangay Suhi, a resettlement site for families who

lost their houses during the onslaught of super typhoon 'Yolanda' in 2013.

And during his speech before their supporters and media, Romualdez, who was the mayor at the time Tacloban was pummeled by Yolanda, vowed to fully continue the rehabilitation of the city.

In particular, he said, this would include transfer of families who have yet to be relocated to the housing units constructed for them see Local /page 11 ...



Tacloban city gov't spearheads

PNP promotes 'Kabataan Kontra Droga at Terorismo'

Brigadier Gen. Carlos says youth should be engaged in the fight against criminalities

PALO,Leyte-The Philippine National Police (PNP) here in the region is pushing for "Kabataan Kontra Droga at Terorismo" (Youth Against Drugs and Terrorism) training to educate the young people against the ill-effects of illegal drugs and prevent them from joining any terrorist groups.

This was disclosed by Brigadier Gen. Dionardo Carlos, police regional director, who said that young people should also be engaged in the fight against criminalities, to include terrorism.

"These young people have the potential to be our forefront for peace and stability in the society. We need their involvement to sit down and tackle the most serious challenges that we are facing nowadays," he said in a state-

"That is the main purpose of this activity considering that they are the ones most vulnerable to

the lure of illicit substances and against terroristic ideologies," Carlos added.

According to the police director, they will conduct the training on March 28 at the regional headquarters, based this town.

Police Lt. Col. Ma. Bella Rentuaya, the regional police spokesperson, said that activity also aims to "inflame the spirit of volunteerism among the youth and student sectors through platforms and programs designed to empower the said

Rentuaya added they want the youth to become "proactive partners of government in the nationwide cascading of advocates relative to anti-terrorism and anti-illegal drugs, particularly on Recovery and Wellness Program (RWP) and in social reintegration for reformed illegal drug personalities."

The training will be attended by presidents from the provincial Sangguniang Kabataan (SK) Federation and Student Body Organizations, along with leaders from Commission on Higher Education, Department of Education, State Colleges and Universities, and the Philippine National Police. Heated argument ended to the stabbing of a construction worker

TACLOBAN CITY-A 52-year construction worker was stabbed by his 27-year old co-worker after they engaged in a heated argument inside a construction site at the Greendale Village, one of the resettlement sites for families whose houses were totally destroyed due to super typhoon 'Yolanda,' located in Barangay Suhi.

Based on a police report, the victim and the suspect together with their other co-workers were having their drinking spree on March 23 at about 8:30 pm when the two suddenly engaged in a heated argument.

This resulted for suspect Ryan Aba, a resident of Barangay Roxas, Palo, Leyte, to stab Lito Rosales, 52 and a native of Pinabacdao, Samar, hitting him at his upper left

The suspect immediately fled from the scene, throwing the knife he used on his way to escape, police report said.

Perception of NMP female trainees towards seafaring career evaluated



Participants of the NMP Research Forum on "Perception of NMP Female Trainees towards the Seafaring Profession".

In answer to the resounding call of the International Maritime Organization (IMO) for empowering women in the maritime industry, the National Maritime Polytechnic (NMP) being a gender and development (GAD) advocate and a maritime training and research institution, conducted in CY 2018 through its Maritime Research Section (MRS) a research study entitled "Perception of NMP Female Trainees towards the Seafaring Profession".

The study aimed to determine the attitudes and views of women, specifically NMP female trainees who had already shipboard experience and those who are planning to go on board, towards the seafaring career. Respondents of the study were all NMP female trainees enrolled during the data-gathering period, 16 July 2018 to 11 October 2018.

The research was conducted to evaluate how NMP female trainees perceive the seafaring profession. Specifically, it aims to: (a) determine the motivating factors why women choose a seafaring career; (b) determine problems/challenges countered or most likely to be encountered onboard; (c) determine the length of time women are willing to stay on shipboard jobs; (d) determine the reasons why women tend to quit their shipboard jobs; (e) determine other maritimerelated occupations which women are interested in; and (f) recommend priority actions.

Findings of the said research advocacy found venue through the conduct of Research Forum on 14 March 2019 at Room 109, NMP Training Building, Cabalawan Tacloban City which was attended by forty-six (46) trainee-partici-

Bomb threat results to suspension of classes, work at VSU in Baybay City

TACLOBAN Classes and work were suspended at the Visayas State University (VSU) in Baybay City after text messages circulated that a bomb was planted inside the sprawling campus.

Immediately, police from the Baybay City Police together with the personnel of the 93rd Infantry Battalion, Bureau of Fire Protection, Coast Guard and the Baybay emergency response unit responded to the scene and scoured every nook and cranny of the college' campus which has over 5,000 students.

As of press time, they have yet to discover any bombs allegedly planted inside the 61.6 hectares campus, considered one of the country's premier agricultural schools.

Police Lieutenant Colonel Ricky Reli, city police chief, said that said two university employees received text messages written in the local dialect on Wednesday (March 27) saying a bomb was planted inside the compound by a new recruit of the sparrow unit of the New People's

The bomb, the text message said, would explode on that day.

And while the university administrators were informed about the text, they asked the teachers to disperse their students peacefully and were asked to proceed to an open space for a 'fire drill.'

Reli, in a phone interview said, that it would take two days to conduct the extensive bomb search prioritizing the administration building and dormitories.

They utilized four K9 dogs for which he said can only sustain a maximum of six hours and had to pause for a while to take a rest.

The police requested the public to refrain disseminating false information in the social media to avoid panic instead cooperate with the authorities and share vital information to topple down the evil intentions of those who want to inflict harm.

"We requested all the students and employees of VSU to immediately inform us if they notice anything unusual at the school premises while EOD personnel are conducting

sweeping and paneling at the university grounds", Reli said.

Reli said that the bomb scare was a handiwork by some unscrupulous persons but still searched the entire campus just to make sure that VSU is safe from any bomb threat.

Because of the threat, VSU president Edgardo Tulin issued an order suspending the classes for two days with classes to resume on April 1.

Tulin also asked the public not to spread text messages that could only result to panic among students and personnel.

Meantime, Reli said that they have already a suspect responsible for the text message that created chaos across the campus. He, however, declined to provide more information as they still continue with their investigation.

"We are closely coordinating with the intelligence units tracking down the unscrupulous person who made the text message so proper charges will be filed in court if identified", Reli added.

JICA visits projects in Ormoc City

ORMOC CITY-As part of the Project "Disaster Risk Reduction by Integrating Climate Change Projection into Flood and Landslide Risk Assessment", under the lead and guidance of the ASEAN Committee on Disaster Management (ACDM) Working Group on Prevention and Mitigation, the members and delegates from various countries of Southeast Asia of the said committee conducted a case visit on flood Philippines from March 18 to 21, 2019.

Comelec suspends congressional polls in Southern Leyte

CITY-TACLOBAN Commission Elections (Comelec) has suspended the election for members of House of Representatives in Southern Leyte following the signing of Republic Act 11198 by President Rodrigo Duterte last February 1.

The law, which di-

vided the province into two congressional districts, took effect Feb. 19, 15 days after it was published in the Official Gazette on Feb. 4.

However, the Comelec has still to issue the necessary implementing rules and regulations (IRR) within 30 days after its effectivity.

Considering the "operational and logistical constraints" in modifying or revising its electoral data in the automated election system, the Comelec issued Resolution No. 10513 on March 25, saying a special elections for the two districts will be held in six time months from May 13,

2019 elections.

With this order, Rep. Roger Mercado will continue to represent the district until the new congressmen of the two districts would be elected.

However, elections for senators, party-list representatives, provincial, city, and municipal offices will not be affected with

his Comelec order as these would push though on May 13 as scheduled.

"That is what it is. We should respect the Comelec en banc decision," said Maasin City Mayor Nacional "Nikko" Mercado, son of Rep. Mercado.





As of this writing, some public places in the region are under red alert against bomb threats. These are places that people frequent everyday, by the hundreds, by the thousands. So when the terrorists succeed with their threats, it results in numerous casualties, in-

And so, authorities are placing such spots under close watch, fielding bomb experts there to scrutinize anything that might explode in the people's midst. Trained dogs, too, are being utilized for their ability to detect the presence of explosives. All this inconvenience the public in one way or another, but it's all for their safety and security. In fact, not just loss of lives but even damage to properties is being avoided with these actions by the authorities.

You see, with a huge blast, anything close to it could fall apart-buildings, cars, stalls-everything, including, of course, humans and animals. The impact of huge explosions is just devastating, depending on what explosives are used. Again, lives and properties are at risk, these being the main targets of terrorist attacks.

doubt. We do have plenty of Muslims now residing in our towns and cities, but most of them are just engaged in business, and they too are peace lovers. Many of them have been here for decades yet they have not been linked to terroristic activities because, perhaps, they themselves are against such.

Could these bomb scares be election-related? You know, just to create chaos and ruin the peace and order of a place. Perhaps, to put the administration of incumbent officials in bad shape, and to usher in "promising" candidates

who could implement peace and order. All these are possible in the socalled dirty politics. More so that the mid-year election is getting closer than we might realize, heating up as it reaches its climax.

If our criterion for ending the day well is that there should be no problem at day's end, then we will never end our day well. We need to be more realistic about


this and consider the

Of course, the underlying problem here is that many of us do not know how to deal with God, how to refer everything to him. We often think that our earthly affairs and concerns are simply ours. If we ever go to God, it is only when we have some difficult or unsolvable problems.

Many of us have for-(The family that prays together stays together) gotten that our life,

whether we are aware of it or not, is actually a shared life with God. The ideal, of course, is that we should always be constantly aware of that basic truth, so that whatever happens, even in our worst scenario, we still can feel secure that everything will just turn out right.

There would be no real reason to feel disturbed or to fall into sadness, anxiety and even depression. Even in our worst situation, like when we really have committed a big, stupid blunder, things can still be made right, because we can always say, Sorry, and God will always understand and forgive us.

Remember the parable of the prodigal son. (cfr. Lk 15,11-32) The spoiled brat in the end decided to go back to his father. And the father was very happy to have him back.

Let's strengthen our faith in the all-powerful providence of God who is always in control of whatever happens in our life. As the Book of Ecclesiastes would put it, "To every thing there is a season, and a time to every purpose under the heaven..." (3,1-8)

Among the 45 mayors charged by DILG Mayor Abunda says Borongan has an active anti-drug council

TACLOBAN CITY-The mayor of Borongan City, Maria Fe Abunda, expressed her surprise why she was included on the list of 45 mayors charged by the Department of Interior and Local Government (DILG) for not organizing a local anti-drug council.

Abunda said that she is fully supportive of the campaign of President Rodrigo Duterte on illegal drugs, thus, she organized the city anti-illegal drug council down to all the 61 barangays of the city.

"That is why I was really surprised why I was included among the 45 mayors who have not organized a local anti-drug council. We have not only organized an anti-drug council but it is functional," she said in a phone interview.

To recall, Interior Sec. Eduardo Año disclosed that 45 mayors in the country were charged before the Office of Ombudsman for

their alleged failure or refusal to create their respective anti-illegal drug abuse council (ADAC).

Abunda, who is on her third term as mayor and running for the lone congressional district of Eastern Samar in this year's elections, said that their own ADAC have been holding meetings aim how to address the illegal drug problem in Borongan with her presiding the meetings.

She said that they have documents and even photos to show that they have a functional ADAC and these were all submitted to the provincial DILG office.

Abunda said that the DILG may have just 'overlooked' on the documents that they have submitted to them reason why she was included on the complaint.

According to her, about 743 drug users and pushers in the city have surrendered under the Oplan: Tokhang initiated by the city police

BORONGAN CITY-The Department of Public Works and Highways-Eastern Samar District Engineering Office (DPWH-ESDEO) conducted its first quarter earthquake drill on March 15, 2019 as part of its disaster and risk management program.

Manolo Rojas, DPWH-ESDEO district engineer, told Leyte Samar Daily Express in an interview that his district regularly conducts shake drills every quarter of the year to boost disaster awareness and preparedness to all employees to avoid injuries and casualties during sudden occurrence of an earthquake or fire.

Rojas said that to help with this activity, the Bureau of Fire Protection (BFP) was invited to assess the performance of the entire process for further improvement.

He added that at the time the emergency alarm rang, all employees performed the drop, cover and hold in which it lasted for almost three minutes.

"When the sound stopped, appointed team leaders per offices assessed the safety of the route leading towards the exit then instructed other members to calmly leave the building," Rojas said.

All employees proceeded at the open space which was designated as the evacuation area, followed with the headcounts and assessment of 'wounded' employees was also executed during the drill.

After the drill, the BFP officers gave comments and said that the drill was properly executed and gave suggestion to add situation like rescuing victims trapped inside the buildings.

South Korean officials renew ties with 'Yolanda' survivors; praise Leyteños for fast recovery on the disaster

PALO, Leyte - The top official of the "Araw Contingent" of the South Korean government visited schools which they helped rebuild which were destroyed during the onslaught of super typhoon 'Yolanda' six years

Commander Colonel Chul Won Lee led a contingent from South Korea on their short visit to 13 public schools in Leyte, to include Tacloban City, considered the ground zero of the world's strongest typhoon to hit inland.

In each visit to these schools, the South Korean leader gave cash assistance to 10 students and their teachers and principals as he expressed his surprise on the fast recovery of the province after it was pummeled by Yolanda in 2013.

"I was so happy to see all of you studying in the school we have rebuilt," Col. Lee said.

"I am extremely proud to see that the region has overcome the typhoon and is continuing its development," he added.

Lee then urged the students to study seriously and be good and

He reminded his young students that their country is forever grateful to the Philippines who sided with them during the Korean War in the 1950's.

"We saw this as repaying the favor we received from your grandfathers who fought alongside with us in the Korean War against communist forces," he said.

The Philippines was the first Asian country to send combat troops to the Korean War that began on June 25, 1950 until 1955 with over 7,400 men of the Philippine Army served in Korea.

South Korea among the countries in the world to extend assistance to Leyte, in particular, in the rehabilitation efforts after the onslaught of Yolanda.

MUNICIPAL ORDINANCE NO. 03

Series of 2017

AN ORDINANCE REGULATING THE ESTABLISHMENT, OPERATION AND MAINTENANCE OF A COCKFIGHTING ARENA WITHIN THE MUNICIPALITY OF TUNGA, LEYTE.

Author: Hon. Juanito G. Fallorina, Jr. Hon, Valero O. Obseguio Co-Authors: Hon. Samuel O. Ongbit Hon. Ma. Evelyn P. Avila

BE IT ORDAINED by the Sangguniang Bayan of Tunga, Leyte in session assembled

SECTION 1. TITLE. This ordinance shall be known as. "An Ordinance Regulating the Establishment Operation and Maintenance of a Cockfighting Arena within the Municipality of Tunga, Levte."

SECTION 2. SCOPE. The ordinance shall govern to regulate the establishment, operation and maintenance of a cockfighting arena in the Municipality of Tunga, Leyte.

SECTION 3. DEFINITION OF TERMS. When used in this article

Amusement - is a pleasurable diversion and entertainment.

Bet Caller (Maciador) - refers to a person who alone or with another initiates a cockfight and/or calls and take care of bets from owners of both gamecocks and other bettors.

Bet Taker/Promoter - a person who calls and take care of bets from owners of both gamecocks and those of other bettors before he orders commencement of the cockfight and thereafter distributes won bets to the winners after deducting a certain commission.

Bettor - a person who undertakes to bet money or things of value for and in consideration of the winning outcome of the cockfight.

Cockpit - a place, compound, and building or portion thereof, where cockfights are held, whether or not money bets are made on the results of such cockfights.

Cockfighting (Bulang) - shall mean the commonly known game or term cockfighting, derby, pintakasi, topada, sabong or its equivalent terms in different Philippine

Derby, Local - is an invitational cockfight participated in by local cockfighting aficionados with pot money awarded to the proclaimed winner.

Derby, Panta - shall mean a proper matching of one's cock with another cock by way of determining the physical appearance of both cocks with pot money awarded to the winning entry.

Derby, International - refers to an invitational cockfight participated in by local and foreign game cockers with pot money awarded to the proclaimed winning entry.

Franchise - is an authorization or special privilege, right or license granted to an individual or group to market its goods on services in a particular territory.

Gaffer (taga-tari) - is a person knowledgeable in the art of arming fighting cocks with gaffs on one or both legs.

Licensed Cockpit Arena - pertains to the place duly authorized by the Municipality of Tunga to conduct cockfighting activities.

Pit Manager - refers to the person who manages or takes charge of the pit or ring, which orders or signals to start actual cockfighting after bets are agreed on. He calls for the conduct of cockfighting activity.

Promoter and/or Owner - refers to any person, natural or juridical, who initiates cockfighting activity, order the commencement of a cockfighting and thereafter distributes won bets to the winners after deducting a certain commission.

Receipt - a written acknowledgment of something received from admission for

Referee (Sentenciador) - refers to a person who watches and oversees the proper gaffing of fighting cocks; determines the physical condition of gamecocks while cockfighting is in progress, the injuries sustained by the cocks and their capability to continue fighting, and decides and makes known his decision either by word or gesture the result of the cockfighting by announcing the winner or deciding a tie in a contest game.

Regular Permit Holders - refers to those operators/owners/licensees who are granted permit/license/franchise to regularly operate a cockpit within days as may be allowed by law or ordinance after complying with all the requirements and payments of corresponding fees appurtenant to the operation/management of the cockpit within the territorial jurisdiction of the Municipality of Tunga.

Special Permit Holder - refers to those operators and promoter who are not Regular Permit Holders but are granted a special permit to promote, operate and conduct cockfighting activities in accordance with the provision of this ordinance.

SECTION 4. ADMINISTRATIVE PROVISION

4.1. Only Filipino citizens, natural or juridical who are otherwise not prohibited by existing ordinances or laws, shall be allowed to own, operate and manage cockpits, preferably by cooperative capitalization.

4.2. The Sangguniang Bayan in accordance with the law, shall determine the number of cockpits to be allowed to operate in this Municipality. Where the population of the municipality does not exceed One Hundred Thousand (100,000), no two (2) cockpits shall be allowed to operate.

4.3. Cockpits shall be constructed and operated within the appropriate areas as prescribed by the Zoning Law or ordinance of the Municipality of Tunga. In the absence of such law or ordinance, the Municipality shall see to it that no cockpits are constructed within 200 meters from existing residential or commercial areas, hospitals, school buildings, churches or public buildings.

No cockpit construction shall be allowed without first securing the necessary requirements such as; Building Permit, Sanitary Permit, ECC from the Department of Environment and Natural Resources (DENR) or Department of Agrarian Reform if it needs land conversion. Approval or issuances of building permits for the construction of cockpits shall be made through the Building Official of the municipality and the MPDC in accordance with the existing ordinances, laws and practices. Construction of cockpits shall be gender responsive and disaster risk free.

A special parking space commensurate with the Arena's capacity is required in accordance with the Building Code of the Philippines duly approved by the Municipal Building Official.

4.4. No promoter/owner shall be allowed to operate or conduct any cockfighting activity without securing necessary franchise from the Sangguniang Bayan, license to operate and mayor's permit from the Mayor's Office and payment of the required fees and charges from the Treasurer's Office herein provided.

4.5. Only registered and licensed promoters and cockpit or cockfighting personnel shall take part in all kinds of cockfighting activity held in this Municipality. No operator or owner of a cockpit shall employ or allow personnel who is not registered and paid the fees herein required.

4.6. Cockfighting shall be allowed only in licensed cockpits during Sundays and legal holidays and during local fiestas for not more than three days.

4.7. Any request to hold cockfighting activities shall be filed with the Mayor's Office Secretary at least seven (7) working days before the intended date requested. The number of days shall be counted from the time such request is stamped and received. Failure to comply with this provision shall result in the disapproval of such request.

4.8. All fees shall be paid to the Municipal Treasurer.

4.9. All regular permits or licenses granted under this ordinance shall be valid for one (1) year, unless otherwise disqualified by law or ordinance or revoked for cause by the issuing authority.

4.10. All special permits and licenses granted under this ordinance shall be valid within the number of days so provided in the special permit and shall automatically cease upon the expiration of the period unless earlier revoked or cancelled for cause by the issuing authority.

4.11. Minors are not allowed within the premises of the cockpit arena in whatever capacity.

SECTION 5. IMPOSITION OF FEES. There shall be collected the following corresponding fees:

I. Owners/Operators/Licensees:

a. For Owners/Operators/Licensees of Regular Cockpit

* Filing Fee 1,000.00/year * Franchise Fee P 10,000.00/year * Annual Cockpit Permit Fee P 12,000.00

b. For Operators and Promoters under Special Permit for three (3) days.

* Application Fee:

Barangay Fiesta P 250.00/day Others P 500.00/day * Mayor's Permit Fee P 1,500.00

c. Fees in all cases (Regular and Special Permit)

* Environmental Fee P 300.00

* Amusement Tax (Gate Receipts) 10% of the total Gross Receipt

d. For registration of cockpit personnel (annually)

* Operator, general manager, promoters, host or such other terms applied to person

promoting or hosting a cockfight 500.00 * Pit Manager 400.00 * Referee (Sentenciador) 300.00 * Cashier 200.00 * Derby Matchmaker * Bet Taker/Manager 300.00 * Bet Caller (Kristo) 200.00 * Gaffer 100.00

e. For promoter of Derbies in the Municipality (Special Cockfights)

Panta Derby 1,000.00 2-cock derby 3,000.00 3-cock derby 5,000.00 4-cock derby 6,000.00 5-cock derby 8,000.00 6-cock derby or more P 10,000.00

f. Municipal Amusement Tax:

Pintakasi 50.00/sultada Derby 200.00/sultada 50.00/sultada Promotion Barangay Fiesta 20.00/sultada

Payment of Fees and dues required for the operation and maintenance of cockpit shall be in accordance with the Revenue Code of Tunga, Leyte and other ordinances duly promulgated for the purpose (Mayor's Permit, Sanitary Permit and other tax ordinances.)

SECTION 6. Holding of Cockfights. Cockfights shall only be allowed in a duly licensed cockpit arena and during Sundays, legal holidays and three (3) days before a barangay fiesta, EXCEPT on the following days when no cockfighting shall be held:

- * Holy Thursday
- * Good Friday
- * Philippine Independence Day June 12
- * Bonifacio Day November 30
- * Rizal Day December 30
- * Election/Referendum Day

SECTION 7. Book of Accounts and Record Keeping. Franchisee is required to maintain a book of accounts and records with regards to their operation. Tickets to the cockpit arena must be registered with the Municipal Treasurer's Office. The Municipal Treasurer or its duly authorized representative shall have the power to inspect at all times the said book of accounts and records.

SECTION 8. Time of Payment. The fees imposed shall be payable to the Municipal Treasurer of this Municipality before any cockfighting can be lawfully held.

SECTION 9. Mandatory Payment of Taxes and Fees Provision. The Franchisee shall be liable to pay all taxes and other fees prescribed by the Revenue Code of the Municipality of Tunga, Leyte, to the Office of the Municipal Treasurer. Failure on the part of the franchisee to comply with said tax obligation shall be ground for the automatic revocation or cancellation of his franchise.

SECTION 10. Declaration of Franchise. The franchise shall be valid for a period of five (5) years commencing from its effectivity date.

SECTION 11. Prohibition on Sale, Lease, Usufruct and Transfer of Franchise. Franchise is non-transferable in character. As such, the Franchisee shall not sell, assign, lease, grant the usufruct of, or transfer this franchise including any rights and privileges acquired to any person, natural or juridical, firm or other entities, nor merge with any corporation or individual without the prior notice and approval of the Sangguniang

SECTION 12. Penal Provisions. Any person found violating any of the provisions of this ordinance shall be meted a penalty of:

First Offense: P1,500.00 Second Offense: P2,000.00

P2,500.00 or imprisonment of not more than six (6) Third Offense: months or both at the discretion of the court.

SECTION 13. Revocatory Clause. Franchise, including the complimenting business permit to operate shall be revoked or cancelled upon showing of non-compliance and/ or gross violation of the conditions set forth therein, and for any violation of the provisions of PD 449 and other pertinent ordinances, rules and regulations.

SECTION 14. Repealing Clause. All existing ordinances inconsistent with the provisions of this ordinance are hereby considered repealed.

SECTION 15. Separability Clause. If, for any reason, any provision of this ordinance shall be revoked or suspended or shall be held to be unconstitutional, other provisions hereof not affected shall remain to be in full force and effect.

SECTION 16. Applicability Clause. The provisions of PD 449 and RA 7160 shall apply to all matters regarding the establishment, operation and regulation of cockpits and the holding of cockpits in the Municipality of Tunga.

SECTION 17. Effectivity - This ordinance shall take effect upon its approval.




