Over 3.05 million voters are to cast their votes

Comelec says its ready for the May 13 polls

TACLOBAN CITY-As the region's more than 3.05 million voters are to troop at their respective polling precincts on Monday(May 10), the Commission on Elections (Comelec) assures of a peaceful, honest and orderly elections.

On Wednesday (May 8), the Philippine National Police (PNP) deployed 1,380 personnel with the Army augmenting the security personnel to help secure the balloting with another 2,000 forces.

Officials of both the PNP and the Army asked their personnel not to engage acts that could taint the image of their organizations and always remain neutral.

Transportation Sec. Tugade vows to complete rehab of Ormoc Airport by 2020

ORMOC CITY-Transportation Secretary Arthur Tugade personally inspected the ongoing repair of the airport of this city on Thursday (May 9) saying the national government is committed to finish the project and make the facility operational.

The airport of this city sustained major damages when it was hit by super typhoon 'Yolanda' in 2013 and by a major earthquake in 2017.

While its passenger terminal building, repaired at a cost of P34 million, is already completed, improvements on its other facilities like asphalt overlay and strip grade correction project and runway widening are still ongoing.

The Department of Transportation has allocated P137 million for




The Ormoc Airport is expected to be fully operational by 2020 after its repair works are completed.

these improvements which are expected to be finished by 2020.

At present, the Ormoc airport, located in Barangay Airport, is not operational from commercial airlines except of a Mactan-based flying school which uses it for training of its

students. (The national government) is very, very committed to finish this project. We'll ensure that there will be commercial flights here," Tugade said in a brief interview.

# Tingog party-list to empower Yolanda-hit regions

Tingog party-list commits itself to taking on the mission of enabling and empowering families and communities who were devastated by the 2013 Super Typhoon Yolanda to get back on its feet.

The party-list which is based in Eastern Visayas is “inspired by the challenge of building back a better region,” said Tingog Second Nominee Jude Acidre.

Located at the very heart of the Philippines, with the islands of Samar and Leyte serving as island bridges between the country’s northern island of Luzon and the southern region of Mindanao, Eastern Visayas is one of the most ecologically diverse regions of the country, the three islands of Samar, Leyte, and Biliran are blessed with land, mineral, energy, and marine resources, making it favorable for agricultural, fishery, and industrial potentials.

“Our geothermal resources have also been tapped, producing electricity for the national power grid. Our coconut, abaca, and other agricultural produce have contributed toward increasing the national economic supply,” Acidre said.

When Yolanda struck on November 8, 2013, the world’s strongest typhoon in recorded human history flattened parts of Eastern Visayas, leaving behind a trail of devastation that has tragically resulted in the loss of lives, livelihood, and property.

“But even as we rise from the typhoon, our region continues to be caught up in the vicious cycle of poverty. With the worsening economic conditions in the region, especially in the aftermath of the record-breaking disaster, Eastern Visayas has become the poorest in the country,” recalled Acidre.

Even before Yolanda struck, the incidence of poverty has already been on declining trend while the nation’s overall economic situation has been improving on the average, poverty in the region worsened from 2006 to 2012, he added.

“In 2014, poverty incidence was at 54.9 percent; more than half of the region’s population of 4.10

million live below the poverty line and unable to earn the minimum amount necessary to address their basic needs. The recent typhoon has aggravated this already deplorable situation, with the poor becoming desperately poorer,” said the Tingog nominee who also headed post-Yolanda humanitarian assistance in the region.

According to Acidre, the creation of Tingog as a regional political party, “seeks to articulate the principles, hopes, and aspirations of the people of Eastern Visayas in their common pursuit towards transformational politics, genuinely shared governance and the full development of the country’s social, geographic and economic peripheries.”

“Our core advocacies are rightly encapsulated in our party motto: change, hope, and progress,” he said.

“As the name of our party suggests, Tingog, a Visayan term for ‘voice,’ amplify their often unheard aspirations of the people of Eastern Visayas for inclusive progress and sustainable change. Going beyond the task of rebuilding those communities damaged by typhoon Yolanda, Tingog is geared towards engaging and empowering the people themselves to work together rebuilding better communities,” added Acidre, former youth leader, community volunteer and political consultant from Barugo, Leyte.

In this greater vision of rebuilding a better Eastern Visayas, Acidre said that Tingog intends to focus on the social, economic, policy and governance development of the region: Social development, which focuses on improving the social condition of affected communities through the provision of basic social services particularly in education, healthcare and housing; Economic development which aims to increase productivity by providing livelihood programs and supporting economic recovery from the loss and damage caused by the disaster and other mitigating conditions.

Also, policy development which involves engaging with public policy stakeholders in order to push for policy interventions that would not only ensure the effective management of

rehabilitation and reconstruction efforts, but also strengthen the capability and capacity of the government to mitigate the effects of such disasters in the future; and Governance development aims to mainstream good governance into disaster management and strengthen the capacity and capability of public sector stakeholders, especially local governments affected by the disaster in the implementation of rehabilitation and reconstruction efforts

To do this, Acidre said that Tingog is committed to “establish, promote, foster and preserve the political, legal, social and economic foundations of a truly just, free and democratic Filipino society through this three-point approach, namely transformational politics, shared governance, and development of the peripheries that embraces everyone and leaves no Filipino behind.”

Founded in October 2012 as Tingog Leytehon, a provincial political party based Leyte, Tingog was officially accredited by the Commission on Elections (Comelec) as a party-list organization through a Resolution promulgated in August 2015 and is qualified to run under the party-list elections beginning with the May 2016 national and local elections

Currently, Tingog is being led by young, dynamic, and competent community leaders from Eastern Visayas, figures who have already made significant individual and professional accomplishments and have now bonded together with a new vision of political leadership, seeking to contribute their collective skills for the development of the region.

Tingog is led by Leyte First District Representative Yedda Marie K. Romualdez, a registered nurse from Tacloban City, as first nominee; Jaime “Boy” Go, entrepreneur and community volunteer from Javier, Leyte, as third nominee; Alexis V. Yu, pharmacist and community leader from Basey, Samar, as fourth nominee; and Jennifer C. Padual, community leader and human resource management professional from Guiuan, Eastern Samar, as fifth nominee.

## 50 complete livelihood training in Tacloban North Resettlement site

TACLOBAN CITY-Fifty residents of the Pope Francis Village in Brgy. 99 Diit, this city, finished the free training on bread and pastry production and cookery of the “Consuelo on Wheels” Program on May 7, 2019.

The program in partnership with the Consuelo Foundation, the city government of Tacloban through Mayor Cristina G. Romualdez, and the Provincial Office of the Technical Education Skills Development Authority (TESDA) started last February in the resettlement site located in the northern part of Tacloban.

Consuelo on Wheels is one of the programs of CF in which a mobile wing van

fitted with training equipment and materials goes to a chosen community to provide onsite livelihood training.

According to TESDA Provincial Director Loreta D. Banario, it is a unique program which started through partnership agreements with different agencies such as DOLE, DTI (Negosyo Center), Center for Community Transformation PESO, City Cooperative and the CCDLAO to provide help to the residents of Pope Francis village.

The graduates will be subjected to competency assessment and certification in order for them to receive a national certificate or certificate of competency, said Banario.

Meanwhile, post-training assistance from CF, and the different livelihood assistance offices of the City Government will be given the graduates to ensure the sustainability of the livelihood assistance.

“To make this program very valuable at the same time sustainable for the graduates of the program and... make clients feel na hindi natin sila pinapabayaan until they become sustainable that’s our goal,” assured CF project officer Janette B. Borac.

## Gunmen shot dead Leyte town administrator

TACLOBAN CITY-Unidentified gunmen onboard a gray color Ford Ranger Wildcard vehicle shot dead the municipal administrator of San Isidro town, Leyte, on Wednesday (May 8).

Based on a police report, Levi Mabini, 42, was on board of his motorcycle with a companion when the assailants open fired upon them several times when they reached a gas station at Barangay Capiñahan.

Mabini sustained multiple gunshot wounds on the different parts of his body which resulted to his instant death while his companion managed to escape.

The gunmen hit the victim’s companion Joseph

Misa, 26, and another 19-year old bystander who were immediately brought to a hospital.

Police recovered four pieces empty shell M16, one piece empty shell 9mm, one unfired ammunition of Ca-

liber 45 at the crime scene.

**'Yolanda' debacle haunts the former DILG chief**

**An Waray debunks 'association' with Mar Roxas**

TACLOBAN CITY - The An Waray party-list group dismissed as black propaganda linking the group with that of former Interior Secretary Mar Roxas who is running in this year's midterm elections for senator.

Former congressman Florencio 'Bem' Noel said that while he respects Roxas both as a person and a politician, it is not fair to link him or to An Waray any affiliation.

"We are not political friends. We've never been (politically) aligned and that's a fact," Noel said in an interview.

The former congressman, who is the first nominee of the An Waray party-list group, was reacting to various posts in social media showing a photo of the party-list with that of Roxas.

Noel reminded the public when Roxas ran

unsuccessfully for president in 2010, he supported the candidacy of Senator Grace Poe who both lost to eventual mayor, then Davao City Mayor Rodrigo Duterte.

Both Poe and Roxas are running in this Monday's elections for senators with the former appears heading for a polls victory based on various surveys. Roxas, meanwhile, is out of the probable winners, surveys have indicated.

Roxas was largely blamed on his mishandling on the management after Tacloban City and the rest of the region was pummeled by super typhoon 'Yolanda' in November 8, 2013.

Noel lamented that their rivals are spinning baseless stories out to destroy the image of the An Waray party-list which is among the probable winners among party-list groups seeking for seats at the House of

Representatives based on various surveys.

Meantime, Noel said that while they are happy with the surveys showing them as among the probable winners, they remain not be complacent until the counting of the votes on Monday.

"While we are happy with the results of the surveys, we are not depending on them as they just serve as a gauge," he said.

Meantime, Noel said that they will focus on the aspect of providing livelihood to the families in the village as one of their priorities once reelected.

**Bong Go tells new doctors of 7th Day Adventists: we are kindred spirits united by our passion to serve the people**

Former Special Assistant to the President and 2019 senatorial aspirant Christopher Lawrence "Bong" Go on Monday congratulated new doctors belonging to the Seventh Day Adventist Church, saying they are kindred spirits united by their dedication to serve the people.

In his message before the new doctors during the recognition rites held at the Vikings in Mall of Asia in Pasay City, Go also urged them to value service above all, noting that service to the people is also service to God.

"Unang-una gusto kong batiin ang mga miyembro ng Seventh Day Adventist Church na nakapasa ng Physician Licensure Examination at ngayon ay ganap nang mga doktor. Nagbigay karangalan kayo sa inyong pamilya, simbahan at pamayanan," Go said.

Among the new doctors who belong to the Seventh Day Adventists are three of the top 10 in the 2019 Physician's Board Exams for March 2019, namely Clinton Rosita Rabadon of West Visayas State University-La Paz (1st place), Dale Ivan Aurigue Bruel of the University of the East-Ramon Magsaysay Memorial Medical Center (7th), and Wilma Cleo Yvonne Borja Dapog of Cebu Doctor's University-College of Medicine.

"Galingan po ninyo ang inyong propesyon dahil kailangan kayo ng ating bayan. Alam ko bilang mga miyembro ng inyong simbahan malakas ang pananampalataya ninyo sa Diyos at inaalay ninyo sa kanya ang bawat tagumpay na inyong nakakamit. Sana lagi ninyong isa-isip ang paglilingkod sa kapwa ay paglilingkod sa Diyos," he added.

Go said doctors and health workers are close to his heart because they share a common advocacy, noting that among his top priorities is the improvement in the delivery of medical services.

"Malapit sa puso ko ang mga doktor at iba pang health care professionals dahil kalusugan po ang isa sa mga prayoridad ko," Go said.

"Iisa po ang ating misyon, and we have the same passion—to serve the community and to serve the people, because for us, tayong lahat, para sa atin



ang serbisyo sa tao ay serbisyo po sa Diyos," he added.

Go lamented that in going around the country, he noticed that many public hospitals lack enough facilities and equipment to handle the number of patients.

"Isang kama, dalawa o tatlong bata. Paano gagaling ang mga pasyente kung ganun po ang kanilang kalagayan?" said Go, who is pushing for additional funding for public health institutions.

He also pointed out that during his stint as SAP, he had helped President Rodrigo Duterte in establishing Malasakit Centers as part of their shared vision to help poor patients.

A brainchild of Go, the Malasakit Center is a program of the Duterte administration meant to make it easier and faster for indigent patients to avail of medical and financial assistance from the government by bringing together in one room concerned agencies such as the DOH, DSWD, PCSO and Philhealth.

Go is pushing for a law that would institutionalize Malasakit Center and enable the establishment of such centers in more provinces and key urban areas in the country.

Meanwhile, Go also thanked the leadership of the Seventh Day Adventist Church for giving him the

opportunity to meet and address their congregation during their gathering.

"Masaya po ako na binigyan ako ng pagkakataon na makapagsalita po dito...Salamat po sa pagkakataong ibinigay ninyo sa akin na makahalubilo at makapagsalita sa inyo at maibahagi ko po ang pareho nating layunin," Go said.

He also thanked the church for their support to President Duterte and his campaign against criminality, illegal drugs, and corruption.

"Salamat po sa tulong at suporta ninyo kay Pangulong Duterte sa kanyang kampanya," Go said.

The former SAP had been consistently saying that he fully supports the programs and policies of President Duterte, particularly the campaign against criminality, corruption and illegal drugs.

"Ipapagpatuloy ko po ang mga pagbabagong nasimulan ni Pangulong Duterte," Go said.

Other priority concerns under Go's legislative agenda include programs for agriculture, education, housing for the poor, long-term sports development, localized peace talks, fire protection and prevention, barangay welfare, creation of a Department of OFW and improved benefits for senior citizens.

**LSA-trained athletes save Eastern Visayas in hauling medals during the recently-concluded Palarong Pambansa**

TACLOBAN CITY - The athletes from the Leyte Sport Academy (LSA) saved the Eastern Visayas delegation from landing at the cellars at the recently finished Palarong Pambansa held in Davao City.

Leyte Governor Leopoldo Dominico Petilla told Leyte Samar Daily Express that there were 26 athletes from the LSA who joined the Eastern Visayas Regional Athletic Association (EVRAA) delegation that participated in this year's Palarong Pambansa in Davao City held last April 27-May 4.

Gov. Petilla said that the LSA athletes won 6

golds, 6 silvers and 7 bronzes from athletics (100, 200 meter dash, 110-meter hurdles, javelin throw and another two from wrestling.

Based on the final and official tally of the 2019 Palarong Pambansa, the region got 11 gold, 8 silver and 19 bronze medals and landed 13th in the regional medal ranking.

Petilla pointed out that if the LSA athletes did not garner the number of medals won, the EVRAA would have only obtained 5 gold, 2 silver and 11 bronze medals and landed in the 14th rank.

Petilla recalled that in 2018 Palarong Pambansa held in Vigan City,

LSA-trained athletes also did something in saving EVRAA from finishing in the 17th (lowest rank) in the medal ranking.

He added that out of the 9 gold, 10 silver, and 9 bronze medals won of EVRAA, 8 golds, 5 silver and 6 bronzes were harvested by LSA athletes.

Petilla said LSA athletes have been the main contributor for the EVRAA gold output in the past six years of the Palarong Pambansa tournaments.

The LSA delegation have also won gold medals in international tournaments in the past. **(RESTITUTO A. CAYUBIT)**



for its rich iodine content), instead of the red seaweed *Gelidiella acerosa*, whose gelose content has long been reported in food preparations and is popular among Biliranons for their home-made gelatine dessert! This wiry red seaweed grow abundantly in the Carigara Bay, specifically in the intertidal waters of Barugo, San Miguel and Babatngon. The sensory acceptability of the popular pastry empanada would have been much higher.

These type of researches should be encouraged not only by the fishery students and faculties of EVSU-Carigara Campus, as these are deemed sustainable types and livelihood generating for the fisherfolks in the five coastal towns of Carigara Bay. Incidentally, two student papers on Tikog Weaving Industry of Basey, Samar and the Bokhayo-making, Burauen's best delicacy from Barangay Arado, were contributed by the EVSU-Burauen Campus BSED-Science senior students.

It's important—in fact, indispensable—that we


touch base with God always because without him we are nothing, even if we manage to show ourselves to be something or to have done something great for a while.

## Two Science-related student research papers at National Students R&D Congress


In the recently concluded First National DABEST Student Research and Development Congress hosted by the Eastern Visayas State University System, may well be considered a success if the number of student researches is the barometer. The Congress, drew researches from mostly Visayas and Palawan based SUCs an HEIs secondary students, had a total of 71 participating research papers dominated by the Science-Engineering Sector with 37 numbers. Two of the science-related papers were on aquaculture of mud crab (*Scylla serrata*) feed with trash fish and blue mussels as well as empanada pastry preparation of 'empanada' using tuna (*Thunnus alba-*

*cores*) as base and enhanced with puree extracts from the green seaweed 'lato' (*Caulerpa racemosa*), attracted my attention.

On the mud crab aquaculture: the use of trash fish as culture feed was recommended by the students-researchers to future aquaculturists of this high-value aquatic resource showing growth of 75.87 percent after 70 days.

On the sensory acceptability level of 8.86 on the Hedonic 9-point Scale, empanadapastry stuffed mainly with tuna and nutriently enriched with puree from lato in different concentration, was reported the students-researchers

My comment on the second paper was the choice of lato puree (known only



## Counted off

Dark clouds are hovering over the upcoming midterm elections on Monday, 13 May 2019, following the withdrawal of the National Citizens' Movement for Free Elections (Namfrel) as watchdog of the polls. This quick turn of events came after Namfrel was accredited by the poll body in an en banc minute resolution numbered 19-0351 dated 29 March 2019 for the forthcoming midterm elections.

The shocking decision of Namfrel was purportedly due to Comelec's denial of its request for its official website to receive information from the poll body, chiefly, election returns, information on candidates' spending, the voters' list, the number of precincts and related precinct statis-

tics. Namfrel's request was not granted by Comelec was purportedly grounded on the fear that information on election results from two different sources.

The poll body's perception of a situation that having two election results may cause confusion on the

public was cited as reason for not granting Namfrel's request. Such ratiocination appears weak considering that there is only one source of election results, the Vote Counting Machines (VCMs) in the polling precincts. It is the one source of election results that will be brought to the public. Such information being reported to the public by Comelec on one hand and Namfrel, the supposed citizens' arm of the poll body on the other hand, would allow a transparent cross-check.

The feared scenario of discrepancies arising from the election results between the poll body

## Mayorality bet condemns search operation conducted by the San Isidro police

SAN ISIDRO, Leyte—The family of Remedio 'Bebot' Veloso, a mayorality candidate of this town, decried the manner of the local police in treating them as the suspects in the killing of the town's administrator.

According to Veloso's elder brother, Emmanuel, the local police joined by members of the Philippine Army, searched their house located in Barangay Paril without any search warrant issued by a court just after the killing incident happened.

To recall, the town administrator, Levi Mabini, was shot dead last May 8 in Barangay Capiñahan after a still unidentified armed men strafed the house of Mayor Susan Ang.

Ang is seeking for another term with Remedio Veloso, running under the

UNA (United Nationalist Alliance), as her main opponent for the post.

Based on a police report, the suspects on the killing of Mabini were seen to have entered the compound of the Velosos reason why they went there and conducted their search operation.

Emmanuel Veloso also claimed that the police and the Army blocked their way and asked them not to go out from their compound.

"They directed us not to go out from our property where they conducted their search operation even they were not armed with a search warrant," he said.

"We are of course disappointed with their actions. Just because my brother is running against the mayor, they will treat us as the suspects," Veloso added.

Veloso serves as the campaign manager of may-

orality bet Remedio Veloso.

The brothers insisted that they were innocent and have nothing to do with the killing of Mabini.

It was learned that the police and the Army were not able to found the alleged suspects or any evidence that could link them to the killing of Mabini.

Veloso said that the incident made them fear of their lives and they are contemplating of filing legal actions against the police and the Army.

The local police declined to issue any statement on their search on the Veloso property saying it's the National Bureau of Investigation which will conduct further probe over the incident.

Reports have said that money ranging from P20 up to P3,000 were being dangled by candidates just to ensure their poll victories.

Brigadier General Ariel Arcenas, police regional deputy director for administration, said that the primary goal why they have deployed security personnel is to ensure that the conduct of elections on their respective areas of assignment would be orderly and peaceful.

This way, the voters could exercise their right of suffrage without fear.

For his Brigadier Gen. Eliezer Losañes, deputy commanding general of the 8th Infantry Division, said that soldiers deployed for election duties were also committed to ensure that the conduct of the elections in the region would be smooth and violent-free.

"We also remind them to remain apolitical to avoid violence and not to side (any candidate)," Losañes said. **(with reports from RESTITUTO A.**

## Installed ARBs now live a better life

ORMOC CITY – Regional Director Sheila Enciso of the Department of Agrarian Reform (DAR) was amazed how the agrarian reform beneficiaries (ARBs) have improved their quality of lives.

Last week, Enciso, accompanied by Assistant Regional Director for Administration and Land Tenure Security Program, Ma. Fe Malinao, together with the Municipal Agrarian Reform Program Officers of Ormoc and Tacloban, and Chief Agrarian Reform Program Officer Tomas Martinez, visited seven ARB organizations who were installed into their awarded lots under the Comprehensive Agrarian Reform Program (CARP) from 2016 to 2018 in different areas here and in adjacent Kananga town with the help of KAISAHAN, a non-government organization.

She was surprised to see the big difference in the ARBs faces and stories they tell before and at present.

These ARBs received their certificates of land ownership award (CLOAs) many years ago, but struggled for 16 to 20 years before they were able to take possession of the awarded lots either due to strong resistance from the previous landowners or conflict between two contending groups of farmers.

Enciso was happy to see these farmers, who once stared fiercely due to frustrations, now smiling and full of inspiring stories to tell, because aside from the support services extended by DAR, they also get as-

sistance from other government agencies.

In Barangay Sumangga, Pablo Silva, 56, president of the Sumangga United Farmers Association (SUFA), installed in 2016, showed to Enciso their livelihood project, a mushroom production they started in December last year through the assistance extended by the Department of Science and Technology (DOST).

Silva disclosed that mushroom production is one of their sources of livelihood now. Mushroom grows fast and are sold at P300 for every kilo, Silva shared.

He added that in a day they could harvest nine kilos.

In Barangay Dolores, Benedicto Taneo, president of the Dolores Farmers Association (DOLFA), brought Enciso to their demo farm and shared that they will soon be graduating from the Farmer Field School (FFS) facilitated by the City Agriculturist's Office.

He disclosed that after FFS, they will be venturing in upland rice (locally known as calinayan) production and marketing.

In Barangay Salvacion, Bienvenido Matuguina shared that he invested part of his income, derived from the sugarland awarded to him, in calamansi production. At present, he has more than 100 calamansi-bearing trees planted in another lot.

He also disclosed that their organization, the Salvacion Farmers Association, has likewise 300

calamansi trees planted in preparation for the calamansi processing project they are planning to venture once the project proposal they submitted to DOST is approved.

In Barangay Sabang Bao, Enciso was caught by surprise when the ARBs, who were installed in April last year, were already harvesting rice in their awarded lots when she arrived; while in Barangay Montebello, the ARBs were peacefully preparing their once contested land to be planted with corn.

Meanwhile, Arnulfo Perez whom we had interviewed two years ago, proudly announced that he is now the president of their organization, the Valencia Small Farmers Association (VASFA).

In the afternoon of the same day, all concerned ARBs gathered in Barangay Montebello for a dialogue with Enciso.

During the said occasion, Enciso expressed her happiness upon seeing them living an improved quality of life as envisioned under CARP.

She likewise reminded the ARBs to continue keeping the land productive. Further, she encouraged those who have children entering college this coming school year to avail of the DAR Scholarship Program for the Dependents of Agrarian Reform Beneficiaries (DSP-DARBs), a new assistance program extended by the agency to its ARBs. **(JOSE ALSMITH L. Lawyer Rafael Olaño, Comelec regional director, said that they are ready with the Monday's midterm elections as all the elections paraphernalias now ready to be delivered to all the region's 3,771 polling centers which are mostly public schools.

The poll body, with the concurrence of both the police and the Army, declared 11 areas in the region, four in Samar and seven in Northern Samar, 'category red' or grave areas of concern.

Killings, mostly in Samar province, have occurred during the election period involving political supporters or barangay officials. Members of the rebel New People's Army have also conducted ambushes on these areas, particularly in Northern Samar.

"We will closely monitor these areas and we are ready to deploy additional troops if needed on these areas to ensure that any possible violence could be thwarted," Olaño said.

## Eastern Samar Gov. Picardal faces vote-buying charge

TACLOBAN CITY—The incumbent governor of Eastern Samar who is running for the same post in next Monday's elections was charged for vote-buying before the Commission on Elections (Comelec).

Charged for alleged vote-buying is Governor Marcelo Ferdinand Picardal who is seeking for his first term in office.

Picardal, then the vice governor, assumed as governor of the province after the demise of Governor Conrado Nicart on April 16 due to a lingering illness.

In their petition, Nelson Cortez and Cyril Jesus Alzate, residents of Brgy.5 in Dolores town, and Brgy. Hindang, Borongan City, alleged that Picardal extended financial assistance to a family accompanied with a photo and tarpaulin bearing his name and face.

The act of Picardal, the petitioners alleged, constitute vote-buying as it happened within the election period, and thus, he should be disqualified for committing an election offense.

The complaint for vote-

buying and disqualification filed against the Eastern Samar governor was based on the affidavit executed by Ma. Nelía Rose Belas who narrated that she sought assistance from Gov. Picardal when her son was confined at the Eastern Samar Provincial Hospital sometimes on September 4, 2018 who was suffering from severe fever and urinary tract infection (UTI).

However, Belas claimed that they did not get any help from Picardal until only sometimes on April of this year, or about seven months after they first asked assistance from the governor or his office.

According to Belas, an aide of Picardal went to their house and handed her

an envelope containing the amount of P800 and photo of the governor. They were also handed a tarpaulin bearing the face and name of the governor, Belas said.

This act of Picardal constitute vote-buying as it was meant to influence Belas and her family to vote him, Cortez and Alzate alleged.

"The acts of Gov. Picardal through his agents in giving money to the Belas family for their hospital expenses when they were not even issued any official receipt except the envelope containing the money and the small calendar with picture of Gov. Picardal...violates the Omnibus Election Code," Cortez and Alzate said on their petition filed before the Comelec-Manila on May 3.

Picardal, they said, particularly violated sections 104 of the said law, referring to prohibitive acts for candidates, and 261 which refers on vote-buying and vote-selling.

The Leyte Samar Daily Express reached out to Picardal and his provincial administrator, George Erroba but has not received any response. **(JOEY A. GABIETA)**

The BEFF is an annual budget of the Department for its School Building Program, which covers the improvement and maintenance of school facilities.

Meantime, under its FY 2018 BEFF, the district has programmed a total of 25 school building projects with an allocation of P 371.39 million. **(LIZBETH ANN A.ABELLA)**

## Metro Manila urban poor groups join hands to back Bong Go's candidacy

Metro Manila's urban poor groups joined hands to express their support for the senatorial bid of former Special Assistant to the President Christopher Lawrence "Bong" Go.

This developed as leaders of urban groups comprising the National Capital Region Urban Poor Council of Leaders (NCR-UCPL) adopted a resolution on May 3, 2019 manifesting their support for Go, saying they believe he could be their voice in the Senate to articulate their concerns.

"...Kaming mga opisyal ng Council of Leaders, sampu ng aming mga kasama at miyembro, ay sumusupporta kay Mr. Christopher Lawrence Tesoro Go, o mas kilala namin sa tawag na Bong Go," the resolution read.

"...Kami ay naniniwala na kanyang susupportahan at bibigyan ng pansin sa pamamagitan ng polisiya at batas na kanyang isusulong sa Senado ang karapatan naming mahihirap para magkaroon ng kaseguruhan sa palupa at pabahay, programang kabuhayan," it added.

The urban poor leaders said they trust that Go would promote their welfare.

"...Kami ay naniniwala na kanyang isusulong ang karapatan ng mahihirap upang maitaas ang antas ng aming pamumuhay," the urban poor leaders said.

The resolution was signed by Bong Latonero, president of the NCR-UCPL, and other leaders of urban poor groups in the 16 cities and one municipality comprising Metro Manila area. Each urban poor group has around 50,000 members.

"Hindi pa man siya naluluklok sa Senado, may mga programa na siya tulad ng Malasakit Center na lubos na nakatutulong sa tulad naming mahihirap na walang maipambayad sa pagpapaospital. Ito ang pinaka pumukaw sa aming atensyon upang buong pusong suportahan ang kaniyang kandidatura," Latonero said.

A brainchild of Go, adopted by the Duterte administration as its own program, the Malasakit Center makes it easier and faster, particularly for poor



patients to avail of medical and financial assistance from the government by bringing together in one room concerned agencies such as the DOH, DSWD, PCSO and Philhealth.

"Gusto ko pong maisabatas ito para tuloy-tuloy ang programa at madagdagan pa natin ang Malasakit



Center sa iba pang mga probinsya at pangunahing lungsod para mas maraming makinabang," said Go, who has vowed to pursue efforts to improve delivery of medical services in the country.

It could be recalled that long before he has signified his intention to run for the Senate, Go has been going around the country, visiting victims of fire and other calamity to provide assistance and cheer them up.

"Wala pa man sa Senado pero may nagagawa na, paano pa kaya kung mabigyan ng pagkakataon na maging Senador? Natitiyak ko na marami pa siyang programa na maisasabatas na kaming mga urban poor ang unang-unang manginginabang," Latonero added.

"Nabuo ang aming samahan upang itaguyod ang mga pangangailangan ng bawat maralitang naninirahan sa buong Metro Manila at base sa aming obserbasyon, si SAP Bong Go ang tunay na magsisilbing tulay para kaginhawaan ng aming buhay," he added.

For his part, Go thanked

the urban leaders for their support. He assured them that they can count on him to bring to the attention of President Duterte any concerns that they want the President to know.

"Maraming salamat po sa inyong suporta, nakakataba po ng puso. Asahan nyo po na patuloy ninyo

akang magiging tulay kay Pangulong Duterte. Wala kaming ibang hangarin ni Pangulong Duterte kundi kabutihan ng bawat Pilipino dahil mahal namin kayo," Go said.

Go is pushing for improved housing program for the poor. He is proposing the establishment of relocation sites for urban poor modelled after townships---complete with basic facilities, such as markets, terminals, health center, day care center and even livelihood assistance centers—before allowing people to settle in.

He is also proposing to strengthen the National Housing Authority to better respond to growing demands for quality and cheap housing and provide as well assistance to fire victims to allow them to recover from the tragedy, among others.

The urban poor will also benefit from Go's proposal to increase the budget of the Department of Education to enable the department to provide free uniforms, school supplies and *see Metro /page 16 ...*



other school needs of students in public elementary and secondary schools.

He is also seeking to amend the Local Government Code of 1991 to allow local government units to provide similar support to public school students in their area of jurisdiction.

In going around the country, Go has promised to reach out to the ordinary citizens—especially the poor—to hear their concerns and find out how he could be of help.

“Kahit saang eskinita papasukin ko para marinig ang hinaing ninyo,” Go had said.

Aside from health and education, Go said he would support President Duterte’s campaign against criminality, corruption and illegal drugs.

Other priority concerns under Go’s legislative agenda include programs to boost agriculture, long-term sports development, localized peace talks, barangay welfare, creation of a Department of OFW, and improved benefits for senior citizens.

and its citizens’ arm could be explained by making the reports transparent to the public. It would be easy for the public to understand that differences in the figures are merely due to variance in the precincts where the figures are emanating. Such setup would enhance the acceptability of the results and eliminate all doubts in the public mind. The process would establish the integrity, transparency and accountability of the elections against all accusations of automated poll rigging and cheating.

The partnership of Comelec and Namfrel is precisely laid on the foundation of providing the necessary check and balance in the elections. The role of Namfrel would reinforce believability of the election results by the public. The quick-count that Namfrel would have undertaken aims to attest to the correctness of the count by the Comelec.

Namfrel proved significant in the snap elections on 07 February 1986 where this writer was a volunteer, as the disparity in the results between the Comelec and its quick-count led to serious doubts on the public mind. The quick-count were emanating from the precincts that Namfrel obtained from its copy of the election tally at the precinct level. The transmittal to the municipal, provincial and national Namfrel headquarters was even by means of the fastest transportation that could carry the results physically.

It is more convenient under the present setup with the availability of the internet as an efficient information highway. But with the withdrawal of Namfrel from its accreditation as Comelec’s citizens’ arm, the poll results will remain as coming solely from the Comelec without any support from a credible poll watchdog for it opted to be counted off.
