Despite Sandiganbayan decision

Samar Rep. Tan wins gubernatorial race

TACLOBAN CITY- Samar Rep. Milagrosa Tan was elected as governor of the province, defeating a former military intelligence officer.

Tan received 211,764 votes against her rival, Emil Zosa.

March 1 of this year, the Fourth Division of Sandiganbayan found Tan guilty for graft involving P16.1 million in the procurement of emergency supplies back in 2001 when she was the governor of the province.

Tan immediately posted bail and sought for motion for reconsideration.

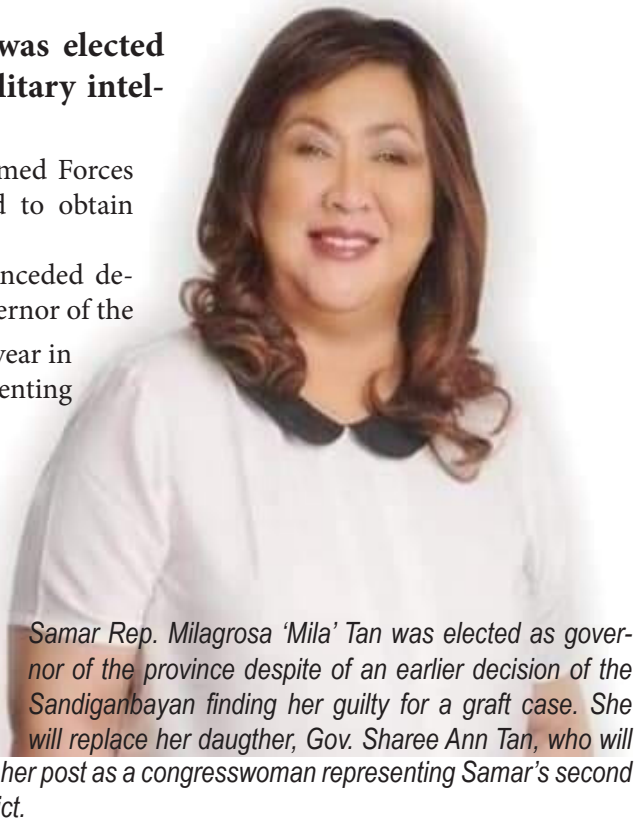
Zosa, who was once the head of the intelligence and operations division of

the Intelligence Service of the Armed Forces of the Philippines, only managed to obtain 204,118 votes.

In his Facebook post, Zosa conceded defeat to Tan who is returning as governor of the province as she is to end her nine-year in office as a congresswoman representing Samar's second district.

The governor-elect is to switch position with her daughter, Gov. Sharee Ann Tan, who also won on her congressional race.

The younger Tan received a total votes of 124,459 or higher by 27,223 votes against her rival, Christopher Bolastig, once connected with the Bureau of

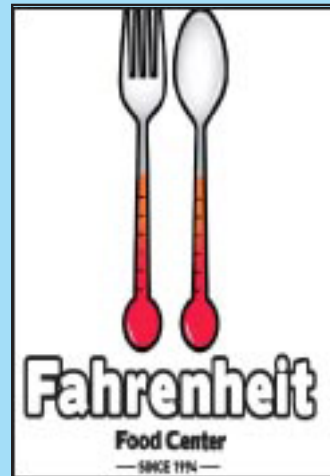

"You are our unsung heroes. We turned the impossible into possible thru our combined efforts. Without your cooperation and dedication, we could



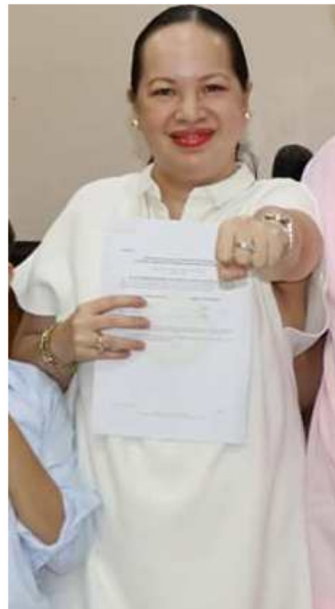
More women to join Leyte's Sangguniang Panlalawigan

Paul Daza takes father's seat as congressman for N. Samar's first congressional district

TACLOBAN CITY- Former Northern Samar governor, Paul Daza, was elected as congressman of the province' first congressional district.

Daza clobbered an old political rival, Harlin Abayon, to win the congressional race by almost 60,000 votes.

Daza, who was the governor of the province from 2010 to 2013, obtained 116,209 votes against former congressman Abayon (Nationalista Party) who only garnered 59,685 votes.

Daza together with Samar Rep. Edgar Mary Sarmiento (1st district) were the only members of the Liberal Party in the region to get elected during the May 13 balloting.

Abayon was defeated by Daza's father Raul during the 2016 elections as congressman.

The elder Daza is on his third and last term as congressman representing

Northern Samar's first congressional district which covers 14 towns which include Catarman, the provincial capital.

Meantime, Abayon's son, Rep. Harlin Neil Abayon III also lost on his reelection bid as their party-list group Aangat Tayo failed to gather votes to earn a seat at the House of Representatives.

Also elected were Rep. Edwin Ongchuan as gov-

ernor of the province, Vice Governor Gary Lavin who was reelected and outgoing Gov. Jose Ong who was elected as congressman representing the province's second district.

The newly-elected officials of the province were proclaimed by the members of the Provincial Board of Canvassers as winners on May 16. **(JOEY A. GABIETA/PETER D. PAREDES)**

Bloody Friday road accidents: 9 dead, 20 injured

TACLOBAN CITY- It was a very tragic Friday (May 17) as separate vehicular accidents resulted to the death of nine passengers and the injury of 20 others.

The first accident took place at about 6:15 in the morning along sitio Tabang of Barangay District III in Babatngon Leyte when a passenger van loaded with 21 passengers collided with a six-wheeler truck loaded with hogs.

The said incident resulted to the immediate death of the eight passengers identified as Evelyn Hodder, 49; Emily Elorde, 46; Marilyn Saringan, 46; Alden Camuen, 23, and his sister Remylyn, 21; Jackson Casarigo, 24; Rogelio Piscos, 57; and Laila Cobilla, 54.

Bryan Bechachino, 18, later died while being treated at the Eastern Visayas Regional Medical

Center (EVRMC).

Injured during this incident were Fritz Asis, 28; Roel Iglesias, 36; Ethel Erine, 28; Helen Cañas, 40; Renz Ezekiel Cajepo, 4; Abundio Cajepo, 27; Thelma Aguilar, 42; Regine Abucay; Remegio Dalut; Robert Milado; Armando Solayao; and Rodel Ecat, the driver of the passenger vehicle.

Majority of the passengers were from Brgy. Tatabunan, Talalora, Samar, and Babatngon town.

Reports reaching the regional headquarters of the Philippine National Police said that the passenger van, with plate number 084403 and bound for Tacloban City, appeared to be running fast and while maneuvering at the site incident directly hit the six-wheeler truck which has four passengers and 10 hogs and driven by Erwin de Leon, a

resident of Brgy. Carmen, North Cotabato.

The six-wheeler was to deliver the swine to the public market in Babatngon.

And on the same day, at about 10 pm similar accident happened along Brgy. San Isidro, Biliran town in Biliran province.

It was learned that a passenger van, with plate number HVT 959 fell on the side of the road after its driver, Windelle Bacho, 36 and a resident of Brgy. Libog, Maasin City, fell asleep.

Injured were Jose Sindanga, 50 and his common-law wife Josephine, 42 and their two children Jared, 5, and Jade Danille, 13; Conchita Vilato, 51; Edward Vilato, 54; and Regan Mercader, 31 and a village councilor of Iyusan, Almeria, also in Biliran. **(JOEY A. GABIETA/ RONALD O. REYES)**

Cop shot to death by NPA rebels in E. Samar town

TACLOBAN CITY- A policeman was shot dead by alleged members of the New People's Army in Quinapondan, Eastern Samar on May 18.

Reports reaching the regional headquarters of the Philippine National Police disclosed that the killed policeman was identified as Patrolman Michael Felipe Ribo, member of the police mobile force company of the PNP-Eastern Samar.

The killing of Ribo

took place in Barangay Cambella of the said town at around 2:25 pm by three NPA members.

It was learned the killing of Ribo, who was from Balangiga, also in Eastern Samar, was related to a shooting incident in Brgy. Bagte, also in Quinapondan.

The slain police officer, who was assigned at the intelligence unit of the provincial PNP headquarters, was in Cambella on his way to Brgy. Bagte

to gather information regarding to an earlier incident when his path was blocked by the perpetrators and shot him several times that resulted in his instant death.

The recovery of the remains of the slain police officer found some difficulties as there were information that NPA members were still in the area and ready to stage an ambush against the authorities.

Gov. Tan leads PDP-Laban winners in the province

TACLOBAN CITY – The candidates who ran under the ruling Partido Demokratiko Pilipino-Lakas ng Bayan (PDP-Laban) emerged as victorious in Samar during the recently-held May 13 midterm elections.

Leading among the PDP-Laban winners in the province was outgoing Governor Sharee Ann Tan who was elected as a congresswoman representing the province's second congressional district.

About 19 of the elected mayors in the province are affiliated with the PDP-Laban.

These areas were the city of Catbalogan and towns of

Jiabong, Motiong, Paranas, Calbiga, San Jose de Buan, Villareal, Pinabacdao, Sta. Rita, Basey, Daram, Talalora, and Marabut, all in the second district of Samar.

However, PDP-Laban's mayoralty candidates from the towns of Hinabangan and Zumarraga were defeated.

In the first district of Samar, mayoralty bets of the party won in the towns of Tarangnan, San Jorge, Pagsanghan, Matuguinao, and the island towns of Tagapul-an and Sto Nino.

Meantime, the candidates of the Liberal Party (LP) won in Calbayog City, Gandara, Almagro and Sta. Margarita.

The PDP-Laban had its biggest political victory in the province in San Jorge and Matuguinao.

In San Jorge, incumbent Mayor Nancy Grey and her husband, Jojo, who both belong to the Liberal Party, lost on their respective bids.

Mayor Grey lost to Leo de Guiua while Jojo was defeated by Jay Bisnar.

Meantime, former Matuguinao mayor Aran Boller reclaimed his post by trouncing outgoing Vice Mayor Carmel de la Cruz and her sister, incumbent Mayor Melissa de la Cruz, was also defeated by Boller's running-mate, Cleofe Belonio.

One-on-one tutorial to a non-reader 7 year-old boy

A parent of a non-reader 7 year-old boy, Evelyn D. Tacugue, enrolled her son this summer 2019 with Dr. Teofilo O. Montallana, who was the previous tutor and owner of Dr. Montallana's Tutorial Center (DMTC) at Kristina Heights Subdivision, Tacloban City.

The parent was already worried of her son, Janville D. Tacugue, who is a grade-1 pupil from a public school in Tacloban City and could not read.

Thus, she decided to enroll him on a one-on-one tutorial with Dr. Montallana.

The tutorial session started on April 13, 2019 up to May 10, 2019, which totaled 30 hours. Each session lasts 1.5 hours.

A diagnostic test was conducted during their first meeting. The result shows that the non-reader pupil is still in the kindergarten level. A beginning reader, who can just decipher few alphabets, but doesn't know completely how to make sounds of each letter.

Dr. Montallana when asked, "What reading techniques did you employ the child was able to read?" answered that "before every session starts, they pray and offer it to God that the child will pay attention to him and develop an interest to read". After every session, he requests the pupil to lead a "thank you prayer" to God for continued guidance and protection and giving of wisdom to read."

Moreover, Montallana said that it is very important to develop rapport with the tutee, so that he will trust you as a friend. He did this by telling short stories before the start of every session as part of his motivation.

Specifically, in order that the child will be able to read, he employed the following reading techniques: 1) introduce each letter of the alphabet in an English language and "waray-waray" dialect; 2) teach him how to decipher consonants and vowel letters; 3) teach him how to make sound of

each letter of the alphabet; 4) let him pinpoint each letter using a pencil when making the sound; 5) teach him to read a two-letter combination by saying each letter-sound; 6) after he masters the two-letter combination, proceed to the three-letter or four-letter combination depending on his own pace of understanding or learning; 7) make a personalized short story (5 lines/sentences) of his own interest such as words that he usually uttered during informal conversations; and 8) let him read the short story using a pencil pinpointing the letter and saying each letter-sound, two-letter, three-letter, or four-letter sound combination depending on the length of each word being read, said Montallana.

So far, he said that the preceding reading technique he employed was very effective and that the child was able to read

TACLOBAN CITY- A minor explosion hit the Seminario de Jesus Nazareno in Borongan City Sunday night.

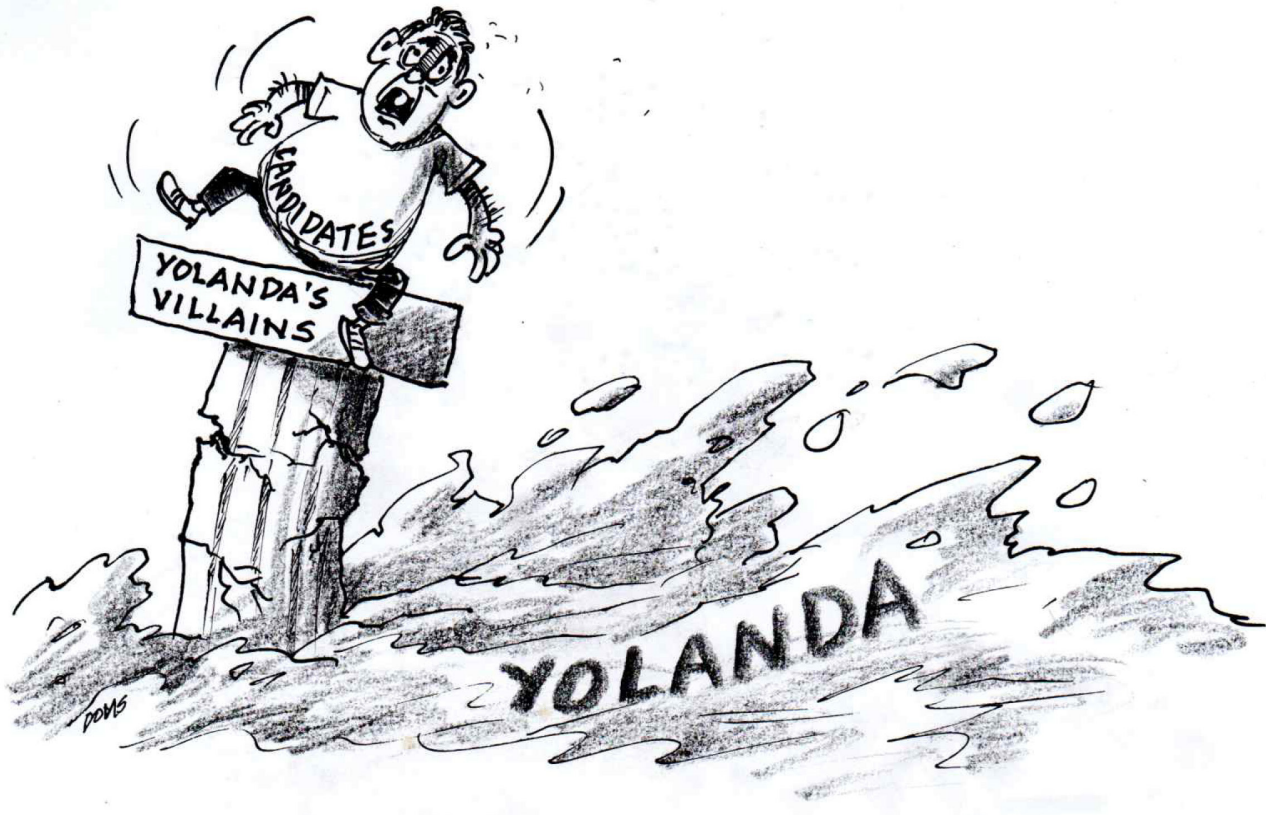

side, which means that it is totally helpless without this bridge. It's an embarrassing truth but true. This being the case, the country has yet to find other means that the government could employ in order to graduate from its total reliance on dollar remittances, knowing that outside factors could hamper this monetary flow and thus paralyze the country's economy.

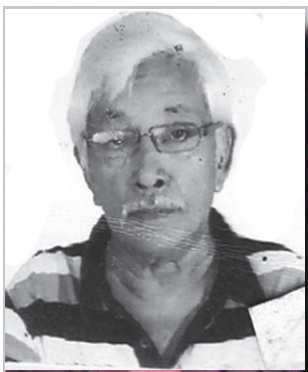

The Duterte administration, aware of this need, turned to foreign and domestic loans to finance its rather ambitious projects under the build-build-build program. This brings us to the new era of borrowing from rich countries, particularly China, further ballooning our foreign debts whose mandatory repayments would extend to our future generations.

Stuning

Dizziness struck a bewildered people of our nation the morning after the May 13, 2019 midterm elections. Relying on Comelec's assurances to the public of its readiness to conduct the elections, people took the statement on its face value despite some issues concerning transparency and integrity. In the days before the midterm elections, Comelec did not approve the request of the National Citizens Movement for Free Elections (Namfrel) to directly access certificates of canvass and statement of votes, Such rejection by Comelec of Namfrel's request led to its decision to withdraw from its accreditation as poll watchdog of the midterm elections. Without

access to vital information, it cannot perform its task of running a quick count on results emanating from the polling precincts.

It cannot be gainsaid that Namfrel could have actually served as strong buttress to Comelec's official count. Whatever results it could receive from the precinct level are reliable since its sources are the official election returns. The subtle exclusion of Namfrel led to more shocking developments towards the day of the elections. The ejection of Namfrel from its vital role as watchdog of elections would now appear in hindsight as a prelude of things to come. Indeed, what happened next was the designation of the National-

ista Party as minority party notwithstanding its being part of the majority party. Such move of the Comelec resulted in the exclusion of the real minority party from obtaining a copy of the election returns.

The series of actions by the Comelec placed the midterm elections under wraps beyond sight of the public. With elections results available to the majority party and the minority which is part of the majority coalition, the public was kept blind of what had been dubbed as automated counting. Reports of vote counting machines (VCMs) bugged by glitches during voting time were alarming. Problems of ballot rejection, mismatch between the actual vote and the receipt were serious concerns that hampered the voting process. The occurrence of such glitches placed precinct watchers helpless as voting continued while problems are merely recorded in the minutes.

Unresolved issues seemed overtaken by

Agri-tourism adds to tourists influx to the Philippines

Relatively considered still in its infantile age among tourists attractions is what is known known as **Agri-Tourism**. I remember having written about this in an earlier issue of the LSDE, recognizing the idea of Senator Cynthia Villar, Chair of the Senate Committee on Agriculture. Easily, the most prominent among the present crop of elective officials, It was from Sen. Villarwhom I first heard about agri-tourism, in her desire to give livelihood to the lowly farmers. She suggested on the conversion of some farms into tourist attractions. Her efforts are ably supported by the SEARCA or Southeast Asian Study and Research in Agriculture based in UPLB, Laguna. Searca believes that farm tourism will create "multiple revenue streams for the farmers, thereby improving the profitability

of small and medium enterprises (SMEs)."

Some provinces, especially La Union, have established 23 farm tourism sites bannered by its popular grape farms. Accordingly, average income of farm tourism sites is P25K – 60K per month. There were 18,000 visitors to its farm tourism sites in 2017.

I still believe that in Region 8, if only the LGU officials could pull their ideas together should be able to put smiles to the sun-burned lowly farmers by identifying farm tourism areas and help put more money into their earnings. In Leyte alone, we have been hearing about one farm area in Palo Town oftentimes visited by agriculture officials and scientists.

More specifically, is the effort of the Provincial LGU officials in introducing high-end vegetables (Lettuce, cauliflower, broccoli)

Espinas of Biliran continue dominance; winning all posts contested together with their allies

TACLOBAN CITY- The Espinas of the island province of Biliran continue their stronghold winning all the positions they contested together with their allies down to the municipal councils.

Elected as governor is outgoing Rep. Rogelio Espina who ran under the Nacionalista Party, changing places with his younger brother, Gov. Gerry Boy Espina (PDP-Laban), for the lone congressional district of the province.

Also winning within their group, known as Bando Espina, was Brigido Canejas III as governor and all eight provincial board members.

The elected governor received 55,836 votes against his rival, Edwin Masbang, incumbent mayor of Cabucgayan, who only obtained 29,039

votes.

Meanwhile, the elected congressman defeated Romulo Bernardes by close to 8,000 votes.

The outgoing governor obtained 46,772 votes compared to Bernardes' 38,833 votes.

And except for the town of Cabucgayan, all the winning mayors also belong to Bando Espina.

The elected mayor of Cabucgayan was Marisol Masbang, wife of Edwin Masbang who unsuccessfully ran for governor.

Among the seven mayors who won and part of the Bando Espina is Gerard Espina, who was reelected as mayor of Naval, the provincial capital.

The reelected Naval town mayor is the son of Rep. Espina.

Also elected as mayors during the recently-con-

cluded May 13 were Richard Jagoros of Almeria; Grace Casil of Biliran town; Rhodessa Delante of Caibiran; Humphrey Olimba of Culaba; Joseph Caingcoy of Maripipi and Rudy Espina of Kawayan, twin brother of Rep. Espina.

Majority of all elected councilors of the eight towns also belong to the Bando Espina.

The Espinas has ruled the island province of Biliran for more than two decades already since their patriarch, the late Gerardo Espina Sr. was elected as a congressman in 1995.

Elected-Gov. Espina, in a previous interview, said that among his priorities is to promote the tourism industry and encourage more investors to come to the province of Biliran.
