TACLOBAN CITY-There is now a local transmission of the dreaded coronavirus disease 2019 (COVID-19) here in the region.

This was confirmed no less than the regional director of the Department of Health (DOH), Dr. Minerva Molon in a press confer-

Molon made this disclosure after two women, aged 32 and 56, were confirmed to have been infected of the virus by their co-worker in a health facility in Tarangnan, Samar, raising the region's confirmed COVID-19 cases to three.

Molon, in a press conference on Tuesday (April 7), said that the two women are to be transported to the Eastern Visayas Regional Medical Center (EVMRC), based this city, for their

confinement.

there is now a local transmission in Eastern Visayas, particularly in Tarangnan. But we are doing our best to control the spread of the virus by transporting them to the EVRMC," she said, referring to the identified referral hospital in Eastern Visayas for COVID-19 patients and patients under monitoring (PUIs) having severe symptoms of the ail-

Molon also underscored the importance of home stay, practicing personal hygiene and observe social distancing as a way to contain the spread of the virus.

She added that they "It is now established that have immediately conducted contract tracing whom the two women have interacted to ensure that the virus could be contain.

"It is further encouraged that the possible contacts to come out in the open and not be ashamed since their cooperation is of utmost importance to stop wider spread of the virus in the community," she added.

Amid temporary closure of establishments due to COVID-19 pandemic **Mayor Romualdez signs** ordinances aimed to ease financial burden of business owners

TACLOBAN CITY-The mayor of this city, Alfred Romualdez, has signed ordinances to help ease the financial burden being suffered by local businessmen as a result of the impacts caused by the coronavirus disease 2019(COVID-19)

On Friday (April 3), Mayor Romualdez signed the ordinances enacted by the members of the Sangguniang Panlungsod extending the deadline for the payment of taxes and charges for all types of businesses covering the first quarter of the year from March 31 to April 30 and waiving the rental payment for all stallholders at the city's public mar-

ket, new bus terminal, and lessees at the convention center(astrodome).

Also approved by the city mayor was on ordinance extending the deadline for the payment of the first installment of real property taxes from March 31 to end of this month,

without interest or penalty.

The city council, headed by Vice Mayor Jerry Yaokasin, enacted these three ordinances on March 25, with the aim of helping the businessmen and real property owners during this time of difficulties caused by COVID-19 pandemic.

Romualdez earlier placed the entire city under restrictive community quarantine effective March 21 to April 12 to contain possible entry of COVID-19 in the city of more than 240,000 people.

This resulted for the temporary closure of business establishments except those in the food and essential outlets, among oth-

Calbayog violators on home quarantine to be lock up in jails, says Mayor Aquino

CALBAYOG CITY- In order to stop the spread of the coronavirus disease 2019 (COVID-19), persons under monitoring (PUMs) and patients under investigation (PUIs) of this city who will not follow the mandatory 14-day voluntary quarantine will be apprehended and put in a detention facility of the police.

This was declared by City Mayor Ronaldo Aquino as he described the COVID-19 outbreak as a worrying situation that requires drastic but necessary measures in order to stop the transmission among residents of the city.

Calbayog has recorded its first confirmed COVID-19 patient involving a 63-year old man who is now confined at the Eastern Visayas Regional Medi-

cal Center (EVRMC)in Tacloban City.

And as of April 5, the city has about 81 PUIs and2,448 PUMs.

As per recommendation by the city's Inter-Agency Task Force on COVID-19, the following measures is now being implemented in the entire city of Calbayog.

-Any person arriving in the city, whether a resident or non-resident should undergo home quarantine.

- PUIs or PUMs who will resist the 14-day voluntary quarantine will be apprehended and put in a detention facility of the Philippine National Police.

-A curfew is now imposed from 6 pm to 6 00 am for minors and 9 pm to 5 am for adults. Adults and parents or guardian of children caught breaking the curfew will be required to render 2 hours of community work as sanction. - Motorboats from

inces are prohibited to dock in Calbayog except those transporting food products and other basic goods. - All internet cafés,

clubs and beerhouses, swimming pools open to the public, and cock fighting arena are now temporarily closed.

-All business establishments like grocery stores, pharmacies, hotels are required to provide their personnel with appropriate personal protective equipment.

- Graduations are cancelled. Classes all levels both public and private are suspended since March 16.

-Events and social gatherings and any religious celebrations are being discouraged to prevent the spread of the virus.

-People are encouraged to practice social distancing and the city government of Calbayog urged

Leyte SP seeks help from Cebu officials to provide assistance to stranded Leyteños in the province

TACLOBAN CITY-The Leyte provincial board recently passed separate resolutions addressed to Cebu Governor Gwendolyn Garcia and Cebu City Mayor Edgardo Labella seeking help for them to provide necessary assistance to Leyteños stranded there due to the lockdown imposed as a result of the coronavirus disease 2019(COVID-19).

According to the separate resolutions passed and approved by the Sangguniang Panlalawigan during their regular session on March 30, there are people

who are residing or working in Cebu who were stranded when the province was placed under lockdown.

And unfortunately, there is a big chance that they would not be included in the listing for them to be provided with assistance, particularly food.

Thus, they are seeking the help both from the provincial and city governments of Cebu for them to provide assistance to the stranded Leyteños while the lockdown is still in effect.

DOLE-8 to assist informal sector workers affected by COVID-19 pandemic through TUPAD #BKBK

TACLOBAN CITY-The Department of Labor and Employment Regional Office 8 (DOLE 8) will be implementing emergency employment program for the workers in the informal sector in Eastern Visayas.

DOLE Regional Director Yahya Centi told Leyte Samar Daily Express that the purpose of the program to mitigate the economic impacts of the coronavirus disease-2019 (COVID-19) in the region.

Centi said that per Department Order No. 210 signed by Secretary Silvestre Bello III on March 18, qualified beneficiaries or those underemployed, self-employed and displaced marginalized workers who have lost their livelihood or earnings due to enhanced community quarantine against COVID-19 may avail of the Tulong Panghanapbuhay

para sa Ating Disadvantaged/Displaced Workers #Barangay Ko/Bahay Ko (TUPAD #BKBK) Disinfection/Sanitation Project.

The DOLE regional director explained that under the TUPAD #BKBK, beneficiaries will work for a period of ten days for the disinfection/sanitation of their houses/dwellings and immediate vicinity of their houses.

Beneficiaries will receive wages equivalent to 100% of the prevailing highest minimum wage in Eastern Visayas, which is P325 per day.

He further explained that aside from the payment of wages, the package of assistance under TUPAD will also include enrolment of beneficiaries to group micro-insurance and conduct of Basic

Nearby towns of Calbayog City now under community quarantine after city confirms one COVID-19 patient

The towns of Sta. Margarita and Gandara, both in Samar province, were placed under enhanced community quarantine effective April 2.

The mayors of these towns made the declaration after a man from the nearby city of Calbayog was tested and confirmed positive with the coronavirus disease 2019 (COVID-19).

In Sta Margarita, the declaration will last until April 14 based on Executive Order 9 signed by Mayor Gemma Zosa who also imposed a stay-athome order and a 24-hour

Only one person is allowed to go out the house to buy the family essential needs.

Workers or employees in business establishments must present certification or identification card when going to work.

Only those who are working in health care and security forces are exempted on the curfew as liquor ban was also imposed across the town.

Those who are delivering goods coming from other areas must present certification that they are not consider as patients under investigation (PUIs) and persons under monitoring (PUMs).

The town mayor still allow business to operate but under limited hours only

The EO mandates that drivers and passengers must always wear face masks.

Coastal village officials are also ordered not to allow docking of any boats in their area.

Gandara Meanwhile, town Mayor Eufemio Oliva signed EO 2020-04 prohibiting its residents to travel to Calbayog City and Catarman in Northern Samar, areas where are there confirmed COVID-19 cases.

Under the order, those who will pass the quarantine checkpoints in the town must present an identification card and certification of employment, if one

Residents and traders from coastal villages will have to do their transaction at the port area located at the town market but they are not allowed to leave their boat.

And villagers residing outside the town proper as well as those coming from other towns must follow designated schedule for them to be allowed entry to the town proper.

Residents of Tarangnan town could enter Gandara every Monday and Wednesday; for San Jorge residents, Tuesday and Thursday; for residents of Sta Margarita and Pagsanghan, and Wednesday; and Friday for residents of Matuguinao.

A 63-year-old male Calbayog City was confirmed to have been infected with the COVID-19, becoming the second case of the region.

The man is now confined at the Eastern Visayas Regional Medical Center (EVMRC)while the first COVID-19 patient, a 5-year old woman from Northern Samar, has already been discharged from the hospital after being cleared of the virus.

"The second patient

has a recent travel history to Metro Manila where he contracted the virus before returning to his hometown in Calbayog City on March 8.

Because of this, I am requesting all our residents not to go out and stay home," Rep. Tan said in a statement.

She urged the local government units in the province to strictly impose the implementation of the enhance community quarantine to avoid the further spread of the disease.

Rep. Tan also discour-

aged everyone not to spread fake news in the social media since it will not help to alleviate the situation and may only cause unnecessary panic.

"Let us listen the advisories of the Department of Health (DOH) and the quarantine guidelines" she said.

The entire Samar province is under a 15day enhanced community quarantine as right after the DOH confirmed the first case of COVID-19 in the province.

Public warned vs. fake solicitations amid health crisis

TACLOBAN The Department of Social Welfare and Development (DSWD) field office here warned the public on Thursday against groups or individuals that may take advantage of the current health crisis through fake solicitations.

"We want to ensure that the real intentions of the fundraising campaign will really be for the welfare of the intended recipients," DSWD Eastern Visavas regional director Marie Angela Gopalan said in a state-

The official urged the public to be careful in giving donations, whether in cash or in-kind and donate only to legitimate and recognized charity groups or individuals.

Gopalan said any person, corporation, or association should apply first for a solicitation permit before undertaking fundraising drives to be filed at the regional office here.

Presidential Decree 1564 or the Solicitation Permit Law, mandates the DSWD to regulate the solicitation

of donations or receiving of contributions for charitable or public welfare purposes.

The department said this is to ensure efficient facilitation of funds, safeguard the public from scams and illegal schemes, and promote accountability and transparency.

Any person violating any provision stipulated under the law, upon conviction, suffer the penalty of imprisonment of not more than a year or a fine of not more than P1,000.

Meanwhile, the DSWD, as the food and non-food items cluster head of the National Disaster Risk Reduction and Management Council, has already prepositioned relief items for communities under quarantine due to the threat of the coronavirus disease 2019 (Covid-19).

As of March 23, relief items on standby for the region include 2,084 family food packs (FFP), 41,554 cans of sardines, 18,236 cans of corned beef, 194,403 sachets of coffee, 166 blankets, and 3,529 malongs

(tube skirts). Each FFP contains six

kilograms of rice, four cans of corned beef, four cans of meatloaf, and six sachets of coffee, good for three to five days for a family of five members.

The regional office also currently has a standby fund of PHP3 million which can be used to purchase additional relief items.

The DSWD assured they will continue to provide the delivery of "maagap at mapagkalingang serbisyo"

(prompt and nurturing service) to the poor, vulnerable, and disadvantaged while putting premium to health and safety of its beneficiaries and personnel in this time of health crisis.

The region has one confirmed case of Covid-19 and 280 patients under investigation as of Wednesday, according to the Department of Health.



country, but it's not something to be so happy about this time; it's a thing to be scared of topping the South East Asia in terms of COVID 19 infections.

And the number rapidly increases every day. With this, the number of fatalities likewise soars. Expectedly, of course. The saddest part of which is that, the number of casualties is consistently bigger than those who recover. This is not the case in other countries as their recoveries are more than those who perish. And in case of contagion, may we fight the virus to the death through a combination of faith, prayer, and available remedies.

WHEREAS, Section 16 of the Local Government Code of 1991 or Republic Act No. 7160, also known as the General Welfare Clause provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of general welfare.

WHEREAS, Section 447 and 458 of the said Republic Act 7160 provide in part, that the Sangguniang bayan shall enact ordinances for the general welfare of the municipality and its inhabitants pursuant to the abovementioned Section 16 of said law, and in this regard, enact and approve ordinances relative to the (i) maintenance of peace and order in the municipality, (ii) suppresssion of lawlessness therein, and (iii) authorization of the issuance of permits or licenses upon conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality, regulating thereby any business which does not require government examination within the municipality and the conditions under which the license for said business may be issued or revoked.

WHEREAS, DILG Memorandum Circular No. 2014-119, dated September 14, 2014, directs cities and capital towns to require the installation of CCTVs for certain business establishments in accordance with Section 16 (General Welfare Clause) of the RA 7160 to support the maintenance of peace and order and public safety;

WHEREAS, law enforcement agencies in the country have already proven that Closed Circuit Televisions (CCTV) are among the most effective tools in crime deterrence prevention, detection and solution since tere is a video recording which can be used in addition to the testimonies of witnesses:

WHEREAS, in order to intensify the Municipality's drive to deter, prevent detect and solve criminality and to preserve video recording as evidence, the Sangguniang Bayan of Catarman deems if proper to require the use of CCTV systems in business establishments within the jurisdiction of the Municipality of Catarman;

WHEREAS, minimum technical specifications of CCTVs to be in stalled shall be prescribed so as not to defeat its purpose.

NOW THEREFORE -

BE IT ORDAINED by the Sangguniang Bayan in a session duly assembled that:

SECTION 1. TITLE OF ORDINANCE - This ordinance shall be known as: AN ORDINANCE MANDATING BUSINESS ESTABLISHMENTS OPER-ATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPAL-ITY OF CATARMAN TO INSTALL CLOSED CIRCUIT TELEVISION (CCTV) SYSTEM AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

SECTION 2. SCOPE AND APPLICATION - The following business

establishments are required to install CCTVs:

a. Banks, Financial institutions, pawnshops, money lenders, money remittance services, money changers, and the like;

ORDINANCE

- b. Business establishments that are part of a national chain or have several branches in other parts of the country, such as restaurants/fast food chains, 24 hour convenience stores, drug stores, and the like;
- c. Shopping malls, shopping centers, supermarkets, movie houses theaters, hospitals and medical facilities, ports/airports/public transport terminals, places of entertainments, hotels, and the like which draw a considerable number of customers/patrons;
 - d. Car dealerships, gasoline/fuel refilling/service stations;
- e. Other Business establishments with capitalization of not less than Php1.0 Million or gross sales of Php2.0 Million or more, or as the Sanggunian deems proper considering the type of busiess and potential risks in their respective areas; and
 - f. All component Barangays.

The CCTV shall be maintained in proper working order at all times, shall be in continuous operations, and shall meet the minimum technical specifications set by this ordinance.

SECTION 3. PRESERVATION OF VIDEO RECORDINGS - The owner(s) of the business establishments shall preserve the camera recording for at least seventy-two (72) hours, or such period as the LGU

SECTION 4. MINIMUM TECHNICAL SPECIFICATIONS - The CCTV system to be installed must meet the following minimum specifica-

- -Minimum 600 TVL Camera Resolution;
- -Must be able to capture video footages at 0.1 Lux Illumination;
- Should have auto-iris (either fixed or vari-focal);
- Should have infrared LEDs enough to reach a distance of at least 20 meters for clear recording at 0 Lux (for areas where there is no continued sufficient lighting);
 - Must have at least 70 degrees Lens Angle;
- The Outdoor Camera must be vandal-proof or 1P 66 Weatherproof Casing

b. Video Recorder:

- Minimum of four (4) camera input;
- Minimum of 640 x 480 video resolution;
- 30 frames per second (FPS) recording per camera;
- Should have Hard Disk Drive/s enough to store video recording for all cameras for at least 1 month;
 - Must have Time Stamping Feature;
 - Must have an interface for storage back-up.

c. Other Components:

- At least four (4) cameras covering the areas of transaction and

Provided that, at least one camera must be facing the street from the entrance (when applicable), with the actual number of cameras to depend on the size of the establishment and nature of business, as determined by the LGU concerned;

- Should have centralized power supply for the DVR and cameras;
- Should have appropriate Uninterruptible Power Supply (UPS) to provide standard and reasonable back-up to the Video Recorder and

SECTION 5. INSTALLATION GUIDE - The following Installation Guide is recommended to be followe:

- Cameras must be installed at a secured location with maximum area of coverage;
- The Video Recorder must be mounted on a secured/concealed location to protect the video footages from theft and/or deliberate destruction:
- Whenever possible, a back-up file stored in the DVD disk (on-site or remotely) shall be recorded for archiving purposes;
- Whenever possible, a dummy CCTV camera shall be installed in a conspicuous area in order to deter possible criminal acts and to protect

SECTION 6. MINIMUM COVERAGE - All the establishments mentioned under Section 2 hereof shall be required to install CCTVs as to afford a full coverage of the following:

- a. From the interior of the establishment:
- (ii) The center of business activity in the establishment (including the tellers, cashiers, cash registrars, sales counters, or areas leading to the vault/sale) according to the nature of business/operations of the
- b. From the exterior of the establishment (when the establishment is not located inside a mall or building which has its own exterior cameras);
 - (i) All entrances/exits;
- (ii) From the entrances/exits, a clear view of the area to and from the street(s) abutting the establishment, including the frontage thereof, taking into particular consideration the clarity of shots in relation to the angles thereof;
 - (iii) Parking lots and drive-through lanes (when applicable).

SECTION 7. IMPLEMENTING OFFICES - The Municipal Public Or-

der and Safety (MPOSO) shall be responsible for the verification and determination of the relevant establishments' compliance with the requirements of this Ordinance. The MPOSO shall specify when compulsory inspection of the installed CCTVs shall be conducted before the necessary clearance or certification therefor may be issued, which clearance or certification shall be a mandatory requirement for the issuance or renewal by the Business Permits and Licensing Office (BPLO) of a business permit or license. The MPOSO may thereafter conduct inspections during reasonable business hours, to determine continued compliance with this Ordinance post-issuance or renewal of such establishments' business permit or license by the BPLO. For all these purposes, the MPOSO shall seek the advice and assistance of the Chief of Police or his duly authorized representative.

Where practicable, the MPOSO shall recommend interconnectivity of available CCTV cameras, including those which the other agencies or

offices of the government, such as, the local disaster risk reduction management office and the PNP, may subsequently install.

SECTION 8. ACCESS TO RECORDINGS - If a crime has been committed, or the operator, employee, or owner of the establishment has reason to believe that a crime has been committed and has been recorded by the CCTV, the operator, employee, or owner of the establishment shall immediately contact the nearest police station, and shall provide access to the pertinent recordings to the police and other investigators.

The operator, employee or owner of the business establishment shall also make available the camera recordings to the law enforcement authorities engaged in criminal investigation upon written request of the authorized or designated officer thereof with the particular time and day covered by the request therein specified.

SECTION 10. PENALTIES - No business permit or permit to op-

erate shall be issued to or renewed for the business establishments mentioned in Section 2 hereof unless the CCTVs as herein specified are installed and fully operational. Further, a fine amounting to Two Thousand Five Hundred Pesos

(PhP2,500.00) shall be imposed on any business establishment in operation found to be in violation of this Ordinance.

For purposes of this Ordinance, each day that a violation continues shall be a separate violation.

SECTION 11. APPEAL PROCESS – Any establishment found to be in violation of this Ordinance by the MPOSO may appeal the findings thereof to the Office of the Mayor within five (5) working days from receipt of the copy of the appeal, the MPOSO shall submit its answer to the Office of the Mayor, furnishing the business establishment a copy of the same on even date. Should the OPOS fail to file its answer to the appeal within the given period, it shall be deemed to have opposed the appeal on all its material points. The Office of the Mayor shall decide on the matter within five (5) working days from receipt of the answer of the OPOS or from the day the period of filing thereof has lapsed, giving due notice to the parties involved. The decision of the Mayor shall be final, and no motion for reconsideration shall be entertained thereafter, subject to such remedial measures as may be then available under the law or Rules of Court.

SECTION 12. COMPLIANCE - Businesses covered by the scope of this Ordinance shall be given until the immediate succeeding period for renewal of business permit to comply with the directives hereof.

Component Barangays, within the poblacion, shall be given a period of one (1) year from effectivity of this Ordinance to comply with the CCTV requirements. Barangays outside poblacion, shall be given a period of two (2) years.

SECTION 7. PENAL PROVISIONS. Any person who shall violate Sections 6 hereof shall be penalized as follows:

- a. Penalty of cancellation of reservation and forfeiture of the previous payments shall be imposed for failure to comply with the term of payments as provided in Section 6 hereof;
- b. Any person found to have used the ossuary space other than what is prescribed in the preceding Sections shall be fined the amount of Five Hundred Pesos (Php500.00) or an imprisonment of ten (10) days at the discretion of the Court.

SECTION 8. REPEALING CLAUSE. Ordinances and issuances, or any part thereof, that are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

BE IT ENACTED by Sannguniang Bayan in a session duly assembled that:

Section 1. ESTABLISHMENT OF OSSUARY SECTION. An ossuary section is hereby established in the Catarman Public Cemetery to provide services and spaces that skeletal remains of persons that have been exhumed from other sections of the Cemetery or other burial grounds after having been buried of at least three (3) years or as may required by law.

Section 2. WHO MAY AVAIL OF THE OSSUARY SERVICES. The ossuary services of the Catarman Public Cemetery shall be open for the reinterment of skeletal remains of deceased residents of the Municipality of Catarman regardless of place of death or

Section 3. DIMENSION, QUANTITY AND RATE OF OSSUARY CONTAINER OR RECEPTACLE. The dimension and initial quantity of ossuary containers or receptacles shall be as herein designed by Municipal Engineering Office (MEO) and sold as follows;

a. Dimension of each container or receptacle,

per box

- 40cm x 40cm x 60cm

b. Initial Number of Containers or

Receptacle 588 boxes

c. Rate of each Container or Receptacle

- Php 10,000.00 per box

Reinterment Service fee and Burial Permit fee included

The additional containers or receptacles shall be constructed in such quantity as there are demand for ossuary spaces and services.

Section 4. GENERAL REQUIREMENT. The transfer of remains to the ossuary shall require issuance of Disinterment or Exhumation Permit, Reburial Permit and supervision of the Municipal Health

a. For disinterment of exhumation of remains of persons who died of non-communicable diseases, permission shall be granted only after such bodies have been buried for a period of three (3) vears.

Upon exhumation the remains shall be disinfected and placed in a sealed coffin case or box, and properly identified as to the name of the deceased, date and cause of death and place of reinterment;

b. For disinterment and exhumation of remains of persons who died of dangerous communicable disease, permission shall be granted only after the lapse of five (5) year burial period.

The remains shall be disinfected then placed in hermetically sealed container, properly identified as to the name of the deceased, date and cause of death and place of origin;

- c. For remains coming from burial grounds outside the jurisdiction of the Municipality of Catarman, exhumation and transfer shall be secured from the point of origin and reburial permit from the Municipality Government of Catarman; and,
 - d. Copy of Death Certificate of the deceased.

Section 5. REINTERMENT PROCEDURE. No reinterment in the ossuary of the Catarman Public Cemetery shall be allowed at without of permit duly issued for the purpose.

The following shall govern the procedure for reinterment of remains in the ossuary:

- a. Applicants shall submit the following documents to the Municipal Engineering Office (MEO):
 - 1. Death Certificate: and
- 2. Health Certificate from the Municipal Health Officer (MHO) attesting to the fact that the deceased is free from any dangerous diseases;
- b. Accomplish Application for Reburial Permit from the MEO and chose from the list of available containers/receptacles, with corresponding number and location, to be presented by the staff;
- c. The MEO shall assess the amount due and endorse the same to the Office of the Municipal Treasurer for payment.
- d. Upon payment, the applicant shall go back to the MEO for execution of the Deed of Sale;
- The following shall be presented to the Cemetery Administrator/Facility Manager who shall schedule the date of reinter-
 - 1. Death Certificate;
 - Deed of Sale (proof of ownership of container/receptacle);
 - Exhumation and Transfer Permit; and

Reinterment/Reburial Permit approved by Municipal Mayor.

Section 6. RESERVATION FOR OSSUARY SPACES. Reservation

a. Fifty percent (50%) of the total amount due shall be paid

of ossuary spaces shall be subject to the following;

- b. The remaining balance shall be paid within one (1) year from the date of the first payment, provided that no reinterment or improvement shall be allowed unless the ossuary space is fully
- c. Thirty (30) days extension may be granted on meritorious grounds, provided that an additional Twenty-Five percent (25%) of the total amount shall be paid;
 - d. Spaces shall be sold on "first come, first serve" basis;
- e. Only one skeletal remain is allowed per one (1) ossuary container: and.
 - f. Purchase thereof shall be sequential.

Section 7. PENAL PROVISIONS. Any person who shall violate hereof shall be penalized as follows:

- Penalty of cancellation of reservation and forfeiture of the previous payment shall be imposed for failure to comply with the term of payment as provided in Section 6 hereof;
- b. Any person found to have used the ossuary space other than what is prescribed in the preceding Sections shall be fined the amount of Five Hundred Pesos (Php500.00) or an imprisonment of ten (10) days at the discretion of the Court.

Section 8. REPEALING CLAUSE. Ordinances and issuances, or any part thereof, that are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accord-

Section 9. EFFECTIVITY. This ordinance shall take effect upon approval.

Leyte town issues medical hotlines for teleconsultation

TANAUAN, Leyte Residents here with influenza-like symptoms will get medical help through telephone consultation while under community quarantine due to coronavirus disease 2019 (Covid-19).

Mayor Pelagio Tecson on Friday signed Executive Order No. 15 requiring all residents with fever, cough, and colds to seek medical consultation for immediate and proper management.

Three physicians here will man the teleconsultation hotlines including the town vice mayor, Dr. Ronald Flores (0916-601-7770/0908-586-2065); Dr. Arlene Santo (0917-321-7760), the municipal health officer; and Dr. Rhodora Angulo (0966-398-7496/0928-500-3453), private doctor.

The local government here said the hotlines were activated on Friday.

Residents can consult anytime, depending on the availability of the physician.

"This is also to protect our professional health workers and minimize the risk of exposure with the

use of technology like cellular phones," Tecson said.

As part of the preparedness measures here, a three-story school building with 12 classrooms was converted into a quarantine center for suspected carriers of the highly-contagious Covid-19.

The center will be utilized for patients under investigation (PUI) with mild symptoms and whose respective residences have no space for 14-day home quarantine.

The confinement facility has two specially adapted ambulances and will only have one patient per isolation room.

Each isolation room has a plastic acetate separator, beddings, and other personal effects, including food provision for the pa-

Tecson said Flores will head the center, to be assisted by the local police and personnel from the municipal health, disaster risk reduction management, general services, and engineering offices.

"The team will provide the necessary personnel and equipment and is authorized to expand the capacity of the said center when necessary," he added.

As of Friday, the town has recorded 14 PUIs - two currently admitted, four cleared, and eight under strict home quarantine.

There is also a total of 364 persons under monitoring, of whom 134 were cleared after completing the 14-day isolation period with no symptoms.

Meanwhile, the region has one confirmed case of Covid-19, a 51-year-old female from Catarman, Northern Samar.

62,000 households in Ormoc City receives a sack of rice as part of relief assistance due to COVID-19 pandemic

Ormoc Mayor Richard Gomez started the rice distribution for every home in the 110 villages in the city on April 4.

"I would like to thank all the Ormocanons for cooperating and banding together with the local government in our fight to keep Ormoc COVID-19free," Gomez said on his Facebook account.

The households who first received their rice supply were from the villages of Tambulilid, Linao, Lao, Catmon, District 29, Batuan, Alegria, and Ipil.

The city may have earned the "enmity" of the neighboring municipalities for its anti-COVID-19 measures by closing its borders earlier than others, yet for Marcos, the decision has proven to be a good one.

In the meantime, we are drawing strength from Ormoc's very cooperative private and civilian sector. We have to prepare for the worst," Mar-

According to the councilor, Ormoc's COVID-19 isolation facility is being ran by three private hospi-

"We have various volunteers in our borders who do not only help guard our borders but buy and deliver goods and medicines for those from other towns who are not allowed to enter. Civic organizations are spearheading the sanitation of our streets. Ormoc, I may say, is the epitome of Bayanihan and is showing the will to heal as one," Marcos added.

As of April 6, Ormoc has 45 remaining PUIs from the 125 total recorded PUIs, and 269 remaining PUMs from the total 2, 143 recorded PUMs.

Meanwhile, the city will strictly implement it's "no mask, no entry, no business around Ormoc" policy effective April 8, as preemptive measure against the disease.

In a public advisory posted at the entrance says: "This is to inform the public that Guinhangdan Hill will be temporarily closed for pilgrimage on April 5-12, 2020, per Executive Order Number 12 which encourage the community to avoid attending and organizing events for any public gatherings that tends to draw huge number of crowds to contain the potential spread of COVID-19."

Mayor Petilla said that Guinhangdan Hill is a favorite pilgrimage site of Roman Catholic devotees in Leyte and Samar in the observance of Holy Week.

It has been observed in the past years that at least 30,000 pilgrims visits or climbs the Hill on Good Friday alone for religious rites or sacrifices and to offer flowers or light candles.

Mayor Petilla added that Guinhangdan Hill, which is also known as "Hill 522," has been declared as a municipal park under the institutional category and developed

into 'all-in' destination making the hill into a historical, tourism and religious, site "rolled into one."

The hill has a historical significance as it offers a panoramic view of the municipality and the site where American General Douglas MacArthur landed in Leyte Gulf on October 20, 1944 in Palo.

Fierce fighting was fought in this hill between the Allied Forces and the Japanese Imperial Army during the World War II. The two-day fighting which lasted from October 20-21, 1944 claimed the lives of at least three Americans and about 50 Japanese soldiers.




