





20 soldiers tested positive

COVID-19 shuts

down military camp

TACLOBAN CITY- A military camp based in Kananga town, Leyte has been placed under lockdown after 20 of its soldiers were tested positive of the coronavirus disease (COVID-19).

Lt.Col. Roberto Beatisula, commanding officer of the 93rd Infantry Battalion based in Barangay Aguiting of the said town, however, was quick to say that despite of this incident, they still continue to function in ensuring security within their area would not be affected. Beatisula, in a phone interview, said that one of his soldiers was said to have suffered from dengue fever and was brought to a hospital in Ormoc City on Oct.11. And as part of the protocol, he was swabbed whose result turned positive of the virus. The entire camp was placed under lockdown on Oct.14. All 11 close contacts were also tested of which seven turned positive. All belong to the same platoon who returned to their head-quarters after their security patrol mission in San Isidro, also in Leyte, on October 10. On October 22, 84 other soldiers of the battalion were swabbed of which 12 were tested positive based on the result released by the Department of Health on Monday (Oct. 26). see COVID-19 /page 2 ...

"The public has nothing to worry as we're able to contain the situation. They don't have any contacts (from the community). All those tested positive were immediately isolated and all are asymptomatic," Beatusula, who is scheduled for his own swab test on Thursday (Oct.29), said.

As part of their precautionary measures, the entire military camp was placed under lockdown which means all those

inside the camp could not go out and no outsider would be allowed entry.

"We will be under lockdown until we will be cleared by the local government unit, by the municipal health office. We are closely coordinating with the mayor (Matt Torres)," he said.

The entire camp has already been disinfected by the members of the Bureau of Fire personnel of Kananga.

Beatusula assured the public that their security operations continue as three of the battalion's

Leyte town residents visit departed loved ones ahead of 'Undas'

TANAUAN, Leyte - Residents here have started paying respects to their departed loved ones ahead of All Saints' Day and All Souls' Day observance, shunning family gathering traditions in compliance with restrictions due to the coronavirus disease (COVID-19) crisis.

For Nenita Saballa, 59, of Pago village, the celebration is strange with her being alone visiting the grave of her husband and son, who both died in 2011.

"It has become a family tradition during All Saints' Day and All Souls' Day (Undas) that we share food together here as a way of spending time with our relatives who passed away. But this won't happen this time. I have to come here earlier, without other family members due to some restrictions," Saballa said in an interview Wednesday.

The lone cemetery would be closed from Oct. 29 to Nov. 4 in compliance with Resolution No. 72 issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID), regulating all activities related to 'Undas' amid the threat of Covid-19.

However, the local government has allowed a 30-percent visitor capacity in the cemetery from Oct. 24 to 28 and from Nov. 5 to

companies are still doing their security operations.

Meantime, the regional office of the Department of Health (DOH) reported that Eastern Visayas has now 6,586 COVID-19 cases of which 46 new cases were added on Monday.

The new cases were from Leyte with 32 cases; Samar, with eight cases; Northern Samar, three; Eastern Samar, two; and one from Southern Leyte.

15 and prohibited the consumption and sale of food, installation of tents, tables, chairs, and entertainment equipment, which are common sights inside the cemetery during this period.

Thelma Cinco, 47, also visited the grave of her mother who died a year ago.

She said despite limitations, it is important to fulfill this tradition, where candles are lit up and prayers are offered as respect for the departed.

"We just have to follow the health protocols, wear

a face mask, and observe physical distancing for everyone's safety. Hopefully, next year, when times are better, we could observe Undas according to our usual practices" Cinco said.

As directed, gatherings in individual graves or markers at the public cemetery must be limited to only five persons at a given time.

Janine Maceda, 23, said although they can visit the graves of her grandparents anytime of the year, 'Undas' is one of the few opportunities to get reunited with

relatives from other places.

"Just like most families, it would only be the time for us to pray for the departed souls of our relatives together. Since the cemetery would be closed during Undas, we will commemorate our departed loved ones at the comfort and safety of our homes through prayers," she said.

To date, the town has 12 active cases of Covid-19, based on the monitoring report of the local government.

122 MSEs in Southern Leyte benefit DTI's P3-CARES program

MAASIN CITY-A total of 122 micro and small enterprises (MSEs) throughout Southern Leyte are beneficiaries of the "Pondo sa Pagbabago at Pag-asenso" - COVID-19 Assistance to Restart Enterprises (P3-CARES), said Michael B. Nuñez, Provincial Director of the Department of Trade and Industry in Southern Leyte.

From the total number of beneficiaries, 40 are from the municipality of Sogod; 39 from Maasin City; 13 from Liloan; 12 from Saint Bernard; five (5) each from Malitbog and Silago towns; and one (1) each from the municipalities of San Francisco, Macrohon, Padre Burgos, Tomas Oppus, Libagon, San Ricardo, Hinundayan and Hinunangan.

Funds released were as follows: P2.935-M for Maasin City; P2.33-M for Sogod; P955,000 for Saint Bernard.

For other municipalities mentioned, the allocation were as follows: Macrohon - P500,000; Padre Burgos - P20,000; Malitbog - P290,000; Tomas Oppus - P100,000; Libagon - P70,000; Liloan - P520,000; San Francisco - P10,000; San Ricardo - P50,000; Hinundayan - P20,000; Hinunangan - P100,000; and Silago - P460,000.

Report revealed that the P3-CARES is a P11.5 billion funds under RA 11469 or known as the Bayanhihan to Heal as One Act lodged by the DTI through the Small Business Corporation intended to provide assis-

tance to enterprises affected by COVID-19 pandemic either by helping them stabilize businesses or recover from its losses.

For the P3-CARES expansion, Tourism Rehabilitation and Vitalization of Enterprises and Livelihood (CARES for Travel) Program are also included, Nuñez stated.

He informed that enterprises are qualified to apply for the CARES Program if the business is in existence for at least one year prior to March 16, 2020, with an asset size of not more the P15 million.

A minimum of P10,000 to a maximum of P500,000 can be borrowed under the said program with zero in-

Region's deaths due to COVID-19: 61

Man from Catarman latest to succumb due to the deadly virus

TACLOBAN CITY- A 67-year old man from Catarman, Northern Samar is the latest person in Eastern Visayas to have died due to coronavirus disease (COVID-19).

The said man died on Tuesday (Oct.27) while he was confined in a private hospital as he was also suffering from respiratory illness, sepsis secondary to COVID pneumonia.

This brings to five on the number of total deaths in Northern Samar province and 61 for the entire region.

Meanwhile, the Department of Health (DOH) in the region reported that about 5,549 COVID-19 patients from the region have recovered from said ailment as of Wednesday (Oct. 28).

Of the 5,549 number of recovered patients, 2,744 were from Leyte;1,928 from Samar province; 321 from Northern Samar;106 from Biliran province; and 55 from Eastern Samar.

The DOH also announced that as of Wednesday, 5,010 COVID-19 patients are asymptomatic;1,400 with mild symptoms; 38 considered as severe cases and 33 at critical condition.

As of Friday (Oct. 30), the region has 6,586 total COVID-19 cases with 46 additional new cases coming from Leyte with 32 new cases; eight from Samar province; three from Northern Samar; two from Eastern Samar; and one from Southern Leyte.

In Palo town, Leyte,

Mayor Frances Ann Petilla has announced on Wednesday that all municipal employees will be required to disclose their current health condition.

This way, any possible transmission of COVID-19 patients in the town would be contained.

Palo has about total 214 COVID-19 with three deaths. Its active cases are now down to 36.

The town is the only area in the region which does not resort to any barangay lockdown despite of its cases as those COVID-19 patients and their immediate close contacts are right away brought to isolation and quarantine facility of the town.

NPA leader faces rape charge by a former teener recruit

TACLOBAN CITY-An alleged leader of the New People's Army (NPA) has been charged of rape by a 17-year old girl who reportedly recruited her to their armed group.

The teener, who was said to be only 15-year old when she was raped by Paterno Opo, leader of the sub-regional committee 'Levox' which operates in Leyte and Biliran provinces, filed the complaint on Thursday (Oct.29) at the Provincial Prosecutor's Office in Calubian town, Leyte.

According to the complainant, she was raped sometimes on July,2018 just months after she was recruited to the NPA by Opong in one of their stays at the hinterland barangays in Calubian town.

During her involvement at the armed group, she served as a 'medical officer' with her elder sister acting as a finance officer.

Being a minor, it was her 20-year old elder sister who filed the rape case against Opong, who is said to be on his 50s.

Once the prosecutor's office sees a probable cause, it will issue a warrant against the alleged NPA leader.

The two sisters were rescued by the members of the 14th Infantry Battalion last July 12 of this year in Barangay Pinamunuan of Mahaplag town also in Leyte while they were on their way to escape from their group.

It was during an 'interview' by the military that she disclosed that she was raped by Opong whom she said told her not to surrender to the soldiers for she

would be tortured and raped.

The two are now under the custody of the 802nd Infantry Brigade, based in Ormoc City.

"I admire her courage in confessing her horrible experience though it may degrade her reputation and dignity as a woman. With her revelation, she exposes the evils of joining the CPP-NPA-NDF. This confirms the blatant and persistent recruitment of minors within the communist terrorist organization," B/Gen. Zosimo Oliveros, the commanding officer of the 802nd IB.

DPWH Northern Samar First DEO undergone Internal Quality Audit

CATARMAN, Northern Samar - In line with the Department's continuous implementation of ISO 9001:2015 standards, the Department of Public Works and Highways Northern Samar First DEO undergone Internal Quality Audit on October 1-2, 2020 at District Office.

The Internal Quality Auditors (IQA) was led by Lissette Therese R. Sususco with team members, Engr. Irish Jane S. Rodriguez, Engr. Maxilee Vanebel Q. Serafin, and Mr. Rommel P. Mumar, all from DPWH Region 7.

During the entrance conference, Sususco presented the IQA objectives and processes covered by the audit, underpinning the important role of the IQA in the continuous implementation of the ISO 9001: 2015. Specifically, the conduct of IQA as stated in section 7.1.3 of the DPWH Quality Management System Manual issued under the Department Order 43 series of 2019. The audit methodology and audit strategy



were also presented.

Northern Samar DEO has been scrutinized according to the availability of information in different areas of processes including the District management process, infrastructure development process form planning and design, construction, maintenance, and support processes to financial management, human resources management, information management, procurement management & public information management.

During the exit conference, the IQA presented their findings, wherein they have identified 36 opportu-

nity for improvements, 5 units/sections with no OFI observed, and no non-conformity was identified.

District Engineer Mario Villena noted the recommendations and suggestions made by the IQA team. He further assured the auditors that the office will immediately comply and will take actions to the findings observed during the audit.

Finally, he extended his heartfelt thanks to the IQA team for being accommodating and for the time spent for the success of the audit.

ed her appreciation to the district for the smooth audit undertaken and revealed that they also observed good practices of the office in conformance with the requirements of ISO 9001:2015.

The Public Attorney's Office, headed by PAO head Persida Rueda-Acosta is set to file before the Dept. of Justice (DOJ) ONE HUNDRED TWO (102) Criminal Cases against former Health Secretary Francisco Duque III, & former Health Secretary Janette Loreto-Garin and several other government officials for the death of 101 school children who were inoculated with Dengvaxia

vaccines.

Other former & active officers of the Dept. of Health, Food & Drug Administration, Research Institute for Tropical Medicine and the Philippine Children's Medical Center are also included in the charges.

Officials and representatives of the SANOFI PASTEUR, Inc. of Paris, France have been included in the charges and they will also face multiple counts of reckless imprudence, resulting in homicide and frustrated homicide.

The Public Attorney's

Office also declared that charges will also be filed against Duque, Garin and other officials for violation of Republic Act 9745, also known as the Anti-Torture Act of 2009.

Atty. Persida Rueda-Acosta, a known candidate for the soon-to-be-vacated position of Associate Justice of the Supreme Court, declared before reporters that --

"This Anti-Torture law is non-bailable; so we hope to have all the accused jailed for the torture and deaths of hapless school children after they were injected with Dengvaxia vaccines, during Duque's and Garin's terms as Health Department secretaries.

As researched by this Columnist, in a Senate hearing on 24 JAN 2018, then Senate Majority Leader Vicente Tito Sotto III declared that P4.5 Billion was released by the Dept. of Budget to the Dept. of Health (DOH) for the Dengvaxia Vaccines and part of the funds "went to pay for expenses in imple-

Who does not "Okra" or Lady Finger Veggie?

Yet another vegetable grown all over the country has been included among the country's export commodities. Thanks to the truly agriculture-founded person at the helm of the Department of Agriculture, Secretary William Dar. He recently announced the start of the exportation of Okra to neighboring Japan. Also, known by its English name "lady finger" vegetable, is an accepted part of the Japanese diet.

Okra is rich in magnesium and other antioxidants that maintain heart health, control blood sugar, including its anti-stress properties. While it strengthens human immune system this is due to the "good bacte-

ria that is in our intestines" - indeed, a healthy and versatile, easy to plant and maintain vegetable. These attributes have goaded Sec. Dar another source of livelihood for our lowly farmers, beset by low and unstable price of palay. At peak season, the Philippines will be able to export an average of 13-15 tons, mainly to Japan.

Matured seeds are planted directly, preferably semi-dry soil or even along "pilapil" of rice paddies. The short variety of 0.5-1 meter tall is ready to produce flowers and shoots out the lady-finger like fruits. Freshly harvested Okra easily becomes part of a Filipino meal after washing

and few minutes boiling and eaten by deeping it in home-made "sawsawan" of bagoong (to Ilokanos) or vinegar-patis combine(-to Bisayans). It is always a main veggie in the Ilokanos "pakbet" or Bisayan "pinakbet" preparation.

In one visit to Singapore (where our son's family works and lives), I devoted my free time planting few seeds of the tall variety Okra, that produced fruits from waist height upwardly of its almost 8-10 feet tall slender plant body. The few stands of okra left with them continued to provide my son's family with fresh healthy vegetable.

At this pandemic time when food is expensive and some items are rare, vegetables included, we should turn our unproductive back and front yards, (even in urban areas), by planting fast growing Okra seeds for food security reason.

Cops net 3 drug suspects in Eastern Visayas

TACLOBAN CITY- Police arrested three suspected drug pushers, including two street-level individuals (SLIs), in separate buy-bust operations in Eastern Visayas.

Southern Leyte Police Provincial Office-Provincial Drug Enforcement Unit (PDEU), led by Major Ariel Major Ariel Nuñez, along with operatives from Maasin City Police Station and Philippine Drug Enforcement Agency (PDEA), arrested Leo Yutina, 29, in Maasin City on Thursday (October 29).

Purchased from Yutina were four sachets containing suspected shabu.

Confiscated from his possession were six sachets containing suspected 'shabu' with an estimated value of P6,000 and buy-bust money.

In Alangalang, Leyte, joint police operatives also arrested Antonio Rosaldo, a 'habal-habal' driver, also on the same day.

Purchased from the suspect was one sachet containing suspected shabu, while confiscated from his possession were nine sachets containing suspected shabu and P500 used as buy-bust money.

The suspected illegal drugs have an estimated worth of P5,000, according to the police.

The anti-drug operation was conducted by the drug enforcement unit of the Leyte Police Provincial

Police led by Captain Dennis Gatela and Alangalang Municipal Police Station led by Captain Arturo Salvacion Jr., acting chief of police, in coordination with PDEA in the region.

On October 28, personnel from Northern Samar Police Provincial Office-PDEU, led by Captain Jim Balase, PDEA, and Victoria Municipal Police arrested 38-year-old Fritz Tan.

Purchased from Tan were three sachets containing suspected shabu.

Police also confiscated from his possession three sachets containing suspected shabu weighing 0.20 grams and with a street value of P3,000, buy-bust money, and motorcycle.

The suspects will be facing charges for violation of Section 5 and 11, Article II of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002.

E. Samar town QR code system boosts contact tracing

TACLOBAN CITY - The town of Hernani in Eastern Samar is the first local government in the province to implement the quick response (QR) code system that would facilitate contact tracing amid the threat of coronavirus disease 2019 (COVID-19).

Local tourism officer and project focal person Carlo Yabora said all persons entering any public and private establishments, churches, and tourist destinations operating within its borders would be required to present QR codes starting Oct. 28.

"This is meant to enhance our contact tracing activity. The common practice here is that individuals will manually log their names and other contact

information before entry in establishments, but the said procedure poses a greater risk to virus exposure," Yab-

ora said in a phone interview on Tuesday.

Persons residing within or outside Hernani must

download the MYQR mobile application and register using their phone numbers.

Yabora said they have conducted a mass registration in all its 13 villages and provided SIM cards to residents with no mobile phones last week.

"For those who have not yet secured their QR codes, our registration would continue at the town hall, prioritizing authorized persons outside residence or the APORs. We also have oriented different establishments on the use of the mobile scanner, and some of them have already started implementing the QR code system," he added.

District Engineer Mario Villena said that the facility is constructed to provide enough infrastructure support in our fight against COVID-19.

This quarantine zone is intended for the isolation COVID-19 positive patients and the health care professionals; this will serve as their temporary Shelter after their exposure to hazards in performing their duties and will ease their challenge in transportation after hospital duty.

“These facilities are provided with luxurious equipment ready for occupancy”, DE Villena added.

The said structure is consist of 9 units (18 rooms with 18 double deck-beds) - 20 footers container van (for patients), 2 units (4 rooms with 4 double deck-beds) - 20 footers container van (nurse quarter), 1 unit-20 footers containers van (nurse station), 4-2000 L water tank on flat form.

The said facility can housed a total of 44 COVID-19 positive patients and healthcare workers.

According to DE Villena, the 18-room facility with double-decker beds are intended for the convenience of COVID-19 patients.

Each room is air-conditioned, can accommodate two patients and provided with own beddings, floor tiles, comfort room with

water facility and bath heater.

While the other two units (four rooms) will serve as nurse quarter and the remaining one unit will serve as nurse station. All rooms will be provided with the same equipment for comfortable stay.

The structures were designed using modular containers for easy fabrication and disassembly when no longer needed.

The said facility is constructed within the Northern Samar Provincial Hospital compound and is funded under quick response fund.

press statement released by the provincial information office.

He said that the provincial government has extended P50,000 financial assistance to the family of Bolok.

For his part, B/Gen. Ronaldo De Jesus, police regional director, also honored the fallen police officer as he vowed that no similar incident would happen again.

“I will make sure that the gallantry of PLt. Bolok shall not be put in vain. Apprehended violators shall be made responsible under the law. I have ordered my men to further intensify its operations against illegal gambling and other law-related offenses no matter how small scale they are,” he said in a statement.

“I will see to it that no similar unfortunate incident shall ever happen again. Justice will be served,” De Jesus added.

Northern Samar police director Col. Arnel Apud said that the entire police organization in the province grieves on the ‘untimely’ death of Bolok.

“I have a heavy heart as we have lost a brother who sacrificed his own life in the name of service,” Apud, in a statement, said.

“I already instructed the personnel and record section to immediately facilitate the needed documents to release the benefits for the bereaved family of Lt. Bolok,” Apud added.

For his part, Mayor Clarence Dato said that the local government has also provided financial assistance to the family of Bolok.

“We mourn the loss of our chief of police, Chris-

tian Bolok, who died in the performance of his duties. A dedicated law enforcer, he is a big loss not only to the PNP but to our community,” Dato said.

Bolok just served as the town police chief for just two weeks. He was succeeded by Lt. Eleazar Arancillo as town police chief.

Meantime, Gov. Ongchuan reiterated his warning against those who are engaging in cockfight of ‘tupada’ and other forms of illegal gambling activities during this time of pandemic.

Ongchuan had earlier banned tupada in the entire province after some men who were arrested later turned positive of COVID-19.

Bolok, 38, led an operation in Barangay Manduyang, nine kms away from the town proper of San

Jose, of an illegal cockfight on Oct. 26.

But when he tried to collect one of the cockfights, he was accidentally hit on his left thigh by a metal spur or tari, which is usually laced with poison.

He died due to loss of blood while being transported to the Northern Samar Provincial Hospital in Catarman town.

His body was transported to his native town of Laoang on Wednesday (Oct.28) where he will be buried.

Palo town shows how it contain spread of COVID-19

PALO, Leyte- This municipality, despite having a high number of people infected of the coronavirus disease (COVID-19) never lockdown an 'infected area' in contrast to the common practice of almost all local government units in the region and other parts of the country.

Instead, they just 'secure' the house of the confirmed COVID-19 patients and right away identify their close contacts for contact tracing purposes.

And in a matter of hours after one is confirmed to have been infected of the virus, the person is immediately brought to their isolation facility with their close contacts are quarantined.

At present, the town has 214 confirmed COVID-19 cases since March of this year and with three deaths.

Former Leyte governor Jericho 'Icot' Petilla who also serves as consultant of the Leyte mayors league on the management of COVID-19, stressed that unlike in other areas, a repeat swabbing is being conducted to a person earlier confirmed to have been infected by COVID-19 but has completed the mandatory 14-day isolation period.

This way, Petilla who is the husband of town Mayor Frances Ann Petilla, they are guaranteed that indeed the patient or 'client' as they call them, is totally free of the virus and really safe and ready for his reintegration to his or her community.

Last October 22, Petilla

NGCP continues restoration works in Typhoon Quinta-affected areas

NGCP continues with the restoration activities of all areas affected by Typhoon Quinta, given the large areas of land devastated by the typhoon. Mobilization of line personnel and equipment continue, and simultaneous restoration activities are being conducted on the areas already accessible.

A total of 33 line gangs, or 264 personnel, working 24/7 when weather and safety conditions permit, have been deployed to the affected areas to expedite restoration works. Additional 12 line gangs were activated from North Luzon, NCR, and Visayas to augment the 20 line gangs originally deployed from South Luzon.

As of 5PM today, 27 October, two 500kV lines, one 230kV line, and five

69kV lines are still de-energized.

Assessment and restoration efforts began as soon as weather permitted, even while the typhoon was still within the Philippine area of responsibility. NGCP has so far fully restored transmission services to the affected provinces of Pampanga, Laguna, Quezon, Albay, and Sorsogon.

NGCP commits to restore the remaining areas of Batangas and Camarines Sur at the soonest possible time, barring unforeseen circumstances. NGCP restoration targets are as follows:

- BATANGAS: BATELEC I and II - October 28
- CAMARINES SUR: CASURECO 1 - October 31
- CASURECO 2 - October 31



- CASURECO 3 - October 29
- CASURECO 4 - October 31

Please note that this schedule refers only to transmission services, and not to distribution services or generating capacity. For complete restoration

of power, all distribution and transmission facilities and sufficient generating capacity must be available. We defer to the Department of Energy and/or the National Electrification Authority for information on distribution and generation restoration. (PR)

by the South Korean contingent when they came to Leyte as part of their humanitarian mission in the aftermath of Super typhoon 'Yolanda' back in 2013.

Among the more than 30 clients confined at the town's isolation facility was 16-year old Ishie whose been in the facility for almost two months now.

She arrived in the facility with her parents who were already sent home after confirmatory tests on their second swab turned negative.

Ishie is the longest staying client inside the facility.

"I miss eating foods that I want, and cold drinks of course, because here, we're not allowed to drink anything with ice," the teenager said when asked what she misses the most aside from her family since she was isolated in the facility.

"I also miss my friends and hanging out with them," she added.

To make her stay productive, Ishie shares that she devout her time in answering the modules and activity sheets.

Her parents gets the modules for her at the Leyte National High School in Tacloban City where she is a Grade 10 student and deliver them to her every Monday.

Since classes started last October 5, she has finished three modules already which she will submit to her adviser once she is discharged from the isolation facility.

Ishie has a smartphone with her but studying inside the isolation center including doing research is not a problem for her because the local government unit provided her with a desktop computer and free internet connection.

In fact, in the building where Ishie is staying some foldable tents has computer that can be used of students like her for their studies.

Longing to be outside and be with her family, Ishie said that she always hope and pray every time a swab specimen is taken from her would have a negative result.

But because of her condition, where the re-swab always turn positive, she said that she is willing to wait until such time she will have a negative result to tell people that she survive and already free from the virus.

Petilla, who once served as Energy Secretary, said that although they can allow clients like Ishie to go home, they are not doing it to avoid stigma from the community.

Petilla shares that fami-

lies of those who continues to be positive on re-swab are supporting this policy.

Re-swab is no longer encourage by the Department of Health as recommended by the World Health Organization due to limited laboratory supply but the province with its partner private hospital and under the Leyte Integrated Health protocol continue to do re-swabbing to confirmed patients until they are tested negative.

He added that most of those who are inside the facility has one common factor when asked if where they think they get or got infected by the disease.

"Most of them answer that they think they got it from Tacloban," Petilla said during the tour inside the COVID-19 isolation facility.

In the case of Ishie, she said that before she found out that she was positive with COVID-19, her family attended a family gathering in her grandmother's house in Tacloban.

Another client, Josephine, 27, said that she suspected that it's in her work in Tacloban where she got the virus.

Josephine who works in a bakery in Tacloban said that a village close to her workplace was placed under lockdown due to cases of Covid-19. Some residents of the village would buy bread in them.

Another positive patient, a uniformed personnel who is with his son, who is a college student in a well-known university in Manila said that before testing positive with Covid-19, he went to Tacloban and visited some offices to process documents along with his son.

But despite these problem where most of the cases are local, Petilla said that they are able to contain the spread of the virus because of the guidelines and policy in place created by the local government.

"We cannot control it if the infection comes from outside the town, but can you imagine what will happened if we don't have protocol. This problem may get worst," he said.

"It's not the perfect facility and protocol but it resolves the problem. It maybe unorthodox, it may not following a certain standards that everybody is used to but at the end of the day, if this virus spread, we the residents of Palo are the one to be affected and I think we have the very right to make sure that this will not spread in our own way," he said.
