

<u>COVID-19 death toll in EV rises to 63</u> 5 pregnant women tested positive JOEY A. GABIETA/LIZBETH ANN A. ABELLA

TACLOBAN CITY- Five pregnant women from the town of Carigara in Leyte tested positive of the coronavirus disease (COVID-19).

And two of them are scheduled to deliver their babies today(Nov.2) with the three others anytime this month, Maricel Pores, one of the members of swabbing testing group of the local government said in a phone interview, said.

According to Pores, as part of the protocols, the five women were swabbed on October 29 with the positive result released the following day by the Department of Health (DOH).

"As per protocol, these pregnant women were swabbed on October 29. Unfortunately, their results, which were released the following day, turned positive. Immediately, they were brought to our isolation facility together with their husbands," Pores

said. She, however, could not say how these women, whose ages ranged from early 20s to 30s, acquired the virus.

"Contact tracing is now being done for us to determine where they acquired the virus," Pores added.

She also assured that the doctors and other medical staff at the Carigara District Hospital who will help these women deliver their babies would be protected from possibly acquiring the COVID-19 virus.

She could not also say if the babies of these pregnant women would be tested or be isolated from their mothers.

Pores said that this is the first case in their town wherein pregnant women were tested positive of the virus.

"The last time we conducted swab test to pregnant women last October 19, all the results were negative. This is the first time that we have this kind of situation," she added.

Meantime, the DOH announced that Eastern Visayas has now 6,775 COVID-19 cases since March of this year.

The region posted 24 new cases coming from the provinces of Leyte with 19; Northern Samar, four; and one from Samar province.

The region's death toll due to COVID-19 has now reached to 63 with the latest deaths involving a 51year old man from Kananga town, Leyte and a 68-year old woman from Las Navas in Northern Samar.

The two died on October 31.

TACLOBAN CITY -The council members of this city approved a resolution endorsing two proposed projects to the Department of Budget and Management (DBM).

These projects are the Tacloban City Urban Bike Lane, and the development of Green Spaces in Tacloban North. However, the DBM will only choose one of the two proposed projects for funding.

Northern Samar extends GCQ for 2 weeks, suspend LSI arrivals

TACLOBAN CITY-Northern Samar Governor Edwin Ongchuan has extended the implementation of the general community quarantine (GCQ) in the entire province for another two weeks, or from November 4-17, 2020, due to the continuing spike of coronavirus disease (COVID-19) cases.

The provincial government also suspended the acceptance of locally stranded individuals (LSIs) for the same period of 14 days or until November 17.

"It will help contain and prevent the spread of the disease and guarantee that our LSIs would receive adequate medical attention when they finally return to the province," Ongchuan said in a press statement.

The moratorium "will necessarily give the province and the municipal local government units (MLGUs) time to fully attend to those currently under isolation or quarantine for having contracted COVID-19 or for having been exposed to confirmed cases."

Cops nab 3 'most wanted' in Eastern Visayas

TACLOBAN CITY-Three most wanted persons were arrested in the region last November 1.

In Biliran, Biliran, police arrested Deolito Abrigo, 68, for the crime of murder and Frederick Estancia, 29, for the crime of rape.

Abrigo is identified as rank number 2 most Court (RTC) Branch 16 in Naval, Biliran.

In Matag-ob, Leyte, police also arrested the top 1 most wanted person-municipal level for the crime of rape.

The accused was identified as Aljon Precillas, 20, and a resident of Brgy.Sto Rosario in the said town.

Presiding Judge Mario Quinit, of RTC-Branch 12 GCQ will take effect starting November 4 until November 17 or when lifted by the Regional Inter-Agency Task Force for Covid-19 (RIATF).

As of Monday, the province has 696 total COVID-19 cases with 306 recoveries and seven deaths.

Due to COVID-19 pandemic, activities for next year's 500 First Easter Mass to be reviewed, says Tiopes

TACLOBAN CITY – The lined-up activities for the 500 years celebration of the First Easter Mass in Limasawa, Southern Leyte will undergo some review amid the coronavirus disease (COVID-19) pandemic.

This was disclosed by Karena Rosa Tiopes, the regional director of the Department of Tourism (DOT).

"Unfortunately, the local government unit, the province of Southern Leyte and the Diocese of Maasin will have to review their program because one, we are not sure if next year, people can attend the celebration because we have to consider that probably that time we still have health protocols, and two, we have prepared tours but we are not sure if we have visitors who can enter the province because, as of this time, Southern Leyte is still close to all people from other parts of the region because of the Covid-19 situation," she said.

Before the onset of the pandemic, the Diocese of Maasin sought help from the DOT and stakeholders in the creation of tours under its jurisdiction for peo-

ple who will be visiting the province and Limasawa Island for the quincentennial celebration of the First Easter Mass.

The tour was dubbed as "Sinugdan," a local term for beginning.

"As far as Limasawa is concern, definitely, yes we will be celebrating in Limasawa because we cannot really totally separate that this is the religious part of our history; this also the story of our lives which is not religious in nature. Actually they are part of our story," Tiopes said.

Tiopes added that if other activities will not push through due to restrictions, virtual activities will replace the faceto-face events such as virtual lecture series, online exhibition of Guiuan and Limasawa history.

For the second time, PSA office in Catarman shut down due to COVID-19 threat

TACLOBAN CITY – The office of the Philippine Statistics Authority (PSA) in Northern Samar has closed its operations for the second time due to coronavirus (COVID-19).

PSA-Regional Director Wilma Perante told reporters that the temporary closure of their office in Catarman town was due to exposure of some of its employees to COVID-19 patients.

The shutdown of the office started last October 28 until November 8. With the temporary clo-

sure, its workers would be adopting the work-fromhome arrangement, Perante said

Provincial Office has temporarily closed its operation due to COVID-19. The first was from October 14 - 16 2020 when an employee of the office became positive of the COVID-19 virus.

She informed reporters that at present all PSA – Northern Samar employees, with close contacts up to third degree to the confirmed COVID-19 positive case, are in home quarantine after they immediately reported to their respective Barangay Health Emergency Response Team

(BHERT) for proper monitoring.

Perante said that PSA-Northern Samar is currently conducting "disinfection of all its service vehicles and also in coordination with the Municipal Health Office for proper contact tracing." She further said that PSA would like to assure the public that precautionary measures have been implemented to prevent virus transmission.

Northern Samar, business groups in Tacloban extend assistance to victims of Super Typhoon 'Rolly'

TACLOBAN CITY-The provincial government of Northern Samar will be extending assistance to victims of Super Typhoon 'Rolly' in Bicol Region.

Governor Edwin Ongchuan said that food aid coming from their province, which itself also suffered minor damages due to Rolly, will be delivered in particular to the provinces of Albay and Catanduanes.

According to the governor, the people of Northern Samar will be paying the good deeds of the Bicolanos who are always among the first to extend assistance every time the province is placed in a calamity situation.

"It is during these difficult times that we must exhibit solidarity with

other provinces," Ongchuan said in a statement.

The aid will mostly consist of food, water, clothes and other essential damaged on these calamity-stricken areas.

Ongchuan encourages the people of the province to also do their share and help the people of Bicol recover from the wrath of Rolly, considered to be the strongest typhoon in

the world this year.

Meantime, various business groups from Tacloban City are now conducting their own fund drives to help the typhoon victims.

Rhoel Ladrera, one of the organizers of the 'Ride for a Cause: From Yolanda survivors to the people of Bicol,' said that they will deliver their aids consisting of foods, water, canned goods and clothing.

Ladrera said that they hope to deliver their items on Nov.8, in time for the seventh anniversary of Yolanda, considered to be the strongest typhoon to hit inland.

Tacloban City was considered to be the ground zero of Yolanda with more than 2,200 people dead.

They will undergo the mandatory six-month training of Public Safety Basic Recruit Course (PSBRC) at the Regional Training Center 8 in San Jose, Tacloban City.

It will be followed by another six-month Field Training Program (FTP).

TACLOBAN CITY-Several houses located in a coastal barangay in Catarman, Northern Samar were destroyed after Super Typhoon 'Rolly' hit the town and some parts of Eastern Visayas on Sunday.

Based on the initial report of the Catarman's information office, 50 houses mostly made of light materials were destroyed in Barangay Baybay due to the strong waves and heavy rains spawned by Rolly.

Cops arrest 6 for alleged illegal cockfighting

TACLOBAN CITY-Six persons were arrested in two separate operations against illegal cockfighting or "tupada" in the different areas here in the region.

In Silvino Lubos, Northern Samar, police nabbed two violators who were caught in the act of engaging in an illegal cockfighting at 1pm Sunday (November 1), in Barangay Camayaan of the said town.

Confiscated from the violators possession were two dead fighting cocks, two pieces gaffs and bet money amounting to P450.

On October 31, police in Kawayan, Biliran arrested four suspects while engaging in illegal cockfighting activity. Also confiscated from

their possession and control were two dead fighting cocks, one wounded fighting cock, two pieces of gaffs, and P500 bet money.

The arrested violators were brought to their respective police stations for documentation and for proper filing of charges in connection with Presidential Decree 449, or Illegal Cockfighting Law, as amended by Presidential Decree 1602, which prescribes stiffer penalties for illegal gambling.

Social Security System (SSS) is set to credit the first batch of November 2020 pension beginning October 30, 2020, through its new disbursement method using the Philippine Electronics Fund Transfer System and Operations Network (PE-SONet) and other checkless disbursement chan-

SSS President and CEO Aurora C. Ignacio said that those covered by the first batch of crediting are pensioners whose date of

contingency is from the first to the 15th day of the month and are receiving their monthly pensions through PESONet participating banks, e-wallets such as PayMaya, or the Development Bank of the Philippines (DBP) accredited Remittance Transfer nacio said. Company (RTC)/Cash Payout Outlet (CPO), currently with M Lhuillier.

"For November 2020, given that its first day is a weekend and a declared holiday, we have completed the funding of the first batch of pension for November 2020 yesterday, October 29. Upon receipt of the funds, our government partner bank - DBP will release them to other PE-SONet participating banks, e-wallets, and M Lhuillier before 12 noon today," Ig-

"These PESONet participating banks, e-wallets, and RTC/CPO are expected to make the fund available to pensioners staring this afternoon," she added. The first batch of No-

vember 2020 pension re-

lease covers more than 1.46 million pensioners with combined pensions for the month amounting to over P6.22 billion.

Ignacio said the new pension crediting schedule for PESONet participating banks and other checkless disbursement channels is aligned with SSS Circular No. 2020-024, which was implemented starting October 2020.

The circular states that there will be two pension crediting batches for the new disbursement method every month. The first batch will be on the first day of the pension month, covering pensioners with dates of contingency from the 1st day to the 15th day of the month.

The second batch will be on the 16th day of the pension month, which covers pensioners whose date of contingency is from the 16th to the last day of the month.

or storms to frequently come our way is not surprising given our location next to the Pacific Ocean, the birthplace of these typhoons. What is sad is that these storms come

in a row in time when we are struggling from a global pandemic. Just last weekend, in fact, a destructive super typhoon hammered its way through selected towns, cities, and villages along its path, causing so much damage in the southern Luzon areas.

Our country is barely able to survive from the plague, the budgetary allocations already running dry after releasing billions of relief funds to various sectors stuck in quarantines and lockdowns. Our country is not that rich to be able to afford simultaneous demands for relief funds, unlike other countries with plenty of savings and resources. We live in handto-mouth existence, so to speak. At times, we can only make it through calamities when other generous donor countries extend their



help, like what happened during typhoon Yolanda's onslaught.

But this time, we cannot expect much from donor countries as they, too, have been victims of the killer virus, and should attend to their own needs in the midst of pandemic. It follows, then, that we ourselves should stand on our own, or else we will never be able to recover but go down instead to the threshold of poverty and suffering. Right now, in fact, many places in the typhoon-ravaged localities are begging for help due to the massive devastation they suffered.

The question is, how can the government address all this? Which one to prioritize? This is where the problem lies because the question really is, where would the government source its calamity funds this time when business and other resources are paralyzed by quarantines? Better if disasters come alternately, but if they plague us at the same time, that's a different story. May we hurdle these calamities victoriously.

Whether we like it or don't, any violent confrontation erupting in the West Philippine Sea could potentially drag us into the conflict. Recent development has it that India, Australia, Japan, and the United States are forming a regional alliance to stand up against China's aggressive behavior in recent years.

Philippine needs to diversify banana industry

Amidst threat of strong competition with other Bananas exported from other countries, the Philippines is challenged to diversify its banana industry.

The call of the PCCI or Philippine Chamber of Commerce and Industry for the Philippine government diversify local banana industry "in order to keep up with an increasingly competitive market." The PCCI director Roberto Amores has urged the government to arrest the "slow and stagnating" growth and development of agriculture, by accelerating its modernization and industrialization programs, especially for banana "to cope with

the growing market competition. " He (Amores) said "we need to encourage farmers to intercrop and grow Saba (Cardaba bananas) due to growing demand for frozen banana and banana chips."

The Philippines, acknowledged among world's top Cavendish banana exporter, is facing stiff competition from Vietnam (with 27.7 million boxes export), Cambodia (6.7 million boxes) and even Laos at 360,000 boxes - these countries are producing the same Cavendish banana variety and quality at a much lower price. Not to mention the stiff competition from Ecuador, even the Philippines has a much wider agricul-

On the downside, is that the Philippines suffers from a high 30 percent tariff in South Korea and 18 percent in Japan. We are still waiting for the Australian market to include Philippine banana products.

Likewise, our agricultural sector is facing competitiveness problem, demand-supply availability, product development, post-harvest facilities, and access to credit and financing - awaiting solution from the DA management.

In the Philippines, bananas especially Saba, are staple food to marginalized sector side by side with root crops like sweet potato (camoteng baging) and (camoteng kahoy). Banana is one of the agricultural products that helps perk up Philippine economy the more that we must take good care of saving the banana industry, through diversification!

Ordinance No. 17 Series of 2020

Sponsor: Hon. Harlan A. Tomenio, Sr.

Be it ordained by the Sangguniang Bayan of San Jose, Northern Samar in session assembled that:

AN ORDINANCE PROHIBITING THE PRESENCE OF ASTRAY ANIMALS IN ALL PUBLIC PLACES WITHIN THE MUNICIPALITY OF SAN JOSE, NORTHERN SAMAR, AUTHORIZING FOR THIS PURPOSE THE ESTABLISHMENT OF CARANGIAN POUND AND THE COLLECTION OF FEES FOR THE USE THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that: Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things the xxx promotion of health and safety xxx;

WHEREAS, the Municipal Government of San Jose, Northern Samar is committed to protect the health and well-being of its citizens, while at the same time ensure that responsible ownership and humane treatment of animals be practiced;

WHEREAS, improper and irresponsible care and protection of domesticated animals pose a grave threat to the safety and security of our constituents;

NOW THEREFORE, after thorough deliberations and discussions and upon motion of **HON. ELECTORADO P. SOMORAY, JR.** with secondment of **HON. HARLAN A. TOMENIO, SR.**, this Sangguniang Bayan in session assembled hereby ordains that –

SECTION 1. Title – This ordinance shall be known and cited as "Anti-Astray Animal Ordinance of the Municipality of San Jose, Northern Samar".

SECTION 2. Definition of Terms – As used in this Ordinance, the following definition of terms shall apply, to wit:

a. **Astray animal** – refers to any domesticated animals such as dogs, cats, goats, poultry, rabbits, carabaos, cows, horses and the like without being accompanied by an owner or tamer at loose elsewhere roaming freely in public places within the municipality.

b. **Carangian pound** – a fixed enclosure complete with some personnel and facilities where animals found to be astray in public places within the municipality are kept or seized for the time being.

c. Domesticated - tamed or trained for household use.

d. Public Places – areas designated solely for public use such

also do the capturing and commit the same to the Carangian Pound;

b.) Immediately after such animal has been committed to the Carangian Pound, the Municipal Agriculture Office shall cause the finding of the whereabouts of its owner and/or tamer. S/he shall cause such owner and/or tamer to be formally notified of the capture and detention of his/her animal and thereby direct such person to forthwith claim the same. Said owner and/or tamer shall be made to pay the prescribed fees required for the release of his/her detained animal as provided for under Section 7(d) hereof;

c.) It shall be unlawful for any person charged with the custody of captured astray animals to maltreat, torture, poison or inflict any suffering or harm to such animals. This prohibition applied to any private person. This prohibited act is penalized under Section 9 hereof;

d.) No farmer or non-governmental organization, people's organization who was chosen as beneficiary of the astray animals as provided for under Section 5© hereof shall dispose of, sell, maltreat, torture or kill such animal, except if the killing/slaughtering is permitted under the law;

e.) It shall be unlawful for an owner/tamer even if s/he accompanied the said animal/s to urinate or poop in public places.

SECTION 5. Disposal of unclaimed animals

a.) All animals found to be astray shall be seized and impounded at the Carangian Pound until such time that the said animal is properly claimed by person(s) purporting to be its owner and/or tamer or until time that such animal is sold to any interested parties after seven (7) days following notice to the owner of its capture or after seven days from notice as provided under Section 5 (e);

b.) All unclaimed astray animals at the Carangian Pound are entitled to proper custody, care, shelter and sustenance;

c.) No such animal shall stay detained at the Carangian Pound for more than fifteen (15) days after notice to the owner or notice to the public as provided under Section 5 (e) hereof. If astray dogs, cats are not sold to any interested party within the same period, the same shall be offered to any duly accredited Non-Government Organization (NGO)/People Organization (PO) or animal lovers for care and proper disposition. In the case of poultry, rabbits, horses, cows, carabaos, goats, the same shall be turned-over to the Municipal Agriculture Office for proper disposition to deserving farmers for this purpose, if there be any. The beneficiary NGO/PO or farmer, as the case maybe, is prohibited from disposing, selling, maltreating, torturing or killing of the said animal, except if killing/slaughtering is permitted under the law;

d.) The Municipality of San Jose, Northern Samar shall have the right to auction any unclaimed animals detained at the Carangian Pound, the proceeds of which shall accrue to the coffers thereof. After seven (7) days following notice to the owner or tamer thereof or notice as posted in accordance with Section 5(e), the animals detained at the Carangian Pound shall become eligible for auction to any interested parties if the same remained to be unclaimed by the owner and/or tamer, or that no person purports to be its owner or tamer;

e.) The Municipal Agriculture Office which has charge of administering the Carangian Pound shall make public the list and picture of all unclaimed animals and their corresponding general description which shall include their kind, breed, color, markings if any, and their characteristics for the information and interest of all concerned. The list and picture shall be posted at said office, lobby of the municipal hall and other barangay halls of all barangays of the municipality. Upon the capture of the astray animal, it shall likewise immediately post a written notice on the aforesaid places which notice shall contain the kind, breed, color, markings, if any, and other characteristics and requiring the owner or tamer thereof the claim the astray animal within seven (7) days from date of notice. For proper identification of animals, the Municipal Agriculture Office in coordination with the Barangay should conduct an animal survey for every household and consequently inform the owners to register their respective animal.

SECTION 6. Establishment of Carangian Pound and Purchase of Impounding Cage/Vehicle

a.) There shall be established as Carangian Pound at which captured astray animals shall be kept for the time being;

b.) There shall be an Impounding Vehicle that will carry the impounded animal/s to the Carangian Pound;

c.) The Barangay is encouraged to have an Impounding Cage to serve as temporary Impounding area while waiting for the impounded

of the Provincial Veterinarian, after conducting regular diagnosis to each, shall have the exclusive discretion to order the segregation and seclusion of any such animals found to have afflicted by contagious diseases either at the time of its findings or during detention. Should an animal die during detention, the same shall be buried in a place and manner that the health and safety of the public are not endangered;

c.) The Municipal Agriculture Office shall prescribed for the regular/daily dietary consumption and supplements of all animals detained at the Carangian Pound, taking into consideration the capacity of the Municipal Government to provide of such necessities and requirements. Should an animal due during detention, the same shall be buried in a manner and place that it should not endanger the health and safety of the public;

d.) All animals at the Carangian Pound shall be released to their respective claimants only upon showing of proof that they are owners or tamers and upon payment of an Impounding Fee in the amount of Three Hundred Pesos (Php 300.00) per day of detention per animal, regardless of kind, breed or size.

SECTION 8. Disbursement of Impounding Fee – Fees collected and accumulated as a consequence of the enforcement of this Ordinance shall be held in trust by the Municipal Government of to be allocated only for the purpose of financing the maintenance and operation of the Carangian Pound, or other activities relative thereto.

SECTION 9. Penalty – Any person found to have violated this Ordinance shall pay a fine of:

First Offense – Fine of One Thousand Pesos (Php 1,000.00);

Second Offense - Fine of Two Thousand Pesos (Php 2,000.00); and

Third Offense – Two Thousand Five Hundred Pesos (Php 2,500.00) and/or imprisonment of not less than one (1) month but not more than six (6) months depending upon the discretion of the court.

SECTION 10. Repealing Clause – All ordinances, rules and regulations, or part thereof, provisions of which are in conflict with, or contrary to the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 11. Separability Clause – If, for any reason or reasons, any part or provisions of this Ordinance shall be held to be unconstitutional or invalid, other part of provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 12. Effectivity Clause – This Ordinance shall take effect after posting in a public and conspicuous place in all sixteen (16) barangays of San Jose, Northern Samar.

SECTION 3. Declaration – Pursuant to Article 100 paragraph (a), of the Implementing Rules and Regulations of the Local Government Code, it is hereby declared that:

a) All municipal streets and other public places within the municipality shall be free from astray animals;

b) Owners of dogs, cats, goats, poultry, rabbits, carabaos, cows, horses and other domesticated animals shall keep such animals within their household; and

c) Any violation hereof shall be penalized as prescribed hereto or in accordance with other applicable laws.

SECTION 4. Prohibited Acts

a.) No person shall allow or neglect his/her animal to wander or go astray in all public places within the municipality of San Jose, Northern Samar. If his/her astray animal is captured and kept in the Carangian Pound, and s/he fails to claim it within seven (7) days from notice for such purpose, s/he is liable for the penalty provided for under Section 9 hereof. Relative to this, the Police assigned in San Jose Police Station, Barangay Officials and Tanods are hereby deputized to capture any animal found to be astray and to immediately commit such animal to the Carangian Pound. Any other person may

animal/s to be carried to Carangian Pound wherein the said animal/s shall be transferred by the Municipal Agriculture Office within the day of impoundment;

d.) The Carangian Pound shall be situated at a definite site within the Municipality which environment is conductive and not harmful to animal health and safety. Such site shall be determined and designated by the Municipal Mayor and shall not be contrary to the Zoning Plan or Zoning Ordinance of the Municipality;

e.) The Carangian Pound shall be administered by the Municipal Agriculture Office and shall consists of facilities necessary to properly carry-out the purpose and functions of an animal pound;

f.) Fund necessary for the establishment and operation of the Carangian pound and purchase of Impounding Vehicle shall be appropriated in the Municipal Annual Fund Budget or any appropriation ordinance, subject to the pertinent provisions of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, and other applicable, laws, rules and regulations.

SECTION 7. Custody and Release of Astray Animals



Leyte SP approves P3.14 billion 2021 budget, fund allocated for COVID-19 response

TACLOBAN CITY -The members of the provincial board of Leyte has unanimously approved the annual budget of the province for next year in the total amount of P3.14 billion which is almost the exact amount of the current budget.

Based on the budget submitted by the office Governor Leopoldo of Dominico Petilla to the provincial board, 27.4 percent of the budget will be allocated to the development fund, 25.21 percent to the special purpose appropriate, 18.81 percent to health which covers hospitals, nutrition, population development and social welfare, 15.19 percent to general public service, 8.04 percent to economic ser-



The retiree-pensioners' date of contingency is the date of their operation, sickness, or disability, as evaluated by the SSS. In contrast, for survivor (death) pensioners, this is the date of death of the deceased member.

On the other hand, the schedule of crediting of accrued pensions for the resumption of suspended pension due to non-compliance with the Annual Confirmation of Pensioners (ACOP) program is on the 16th day of the following month after compliance with the ACOP has been received and encoded. The pension run for the resumption is done every 20th day of the month.

Meanwhile, pensioners who are still receiving their pensions through non-PESONet participating banks or checks will continue to receive their pensions through their accounts until further notice. Their pensioners' crediting schedule will follow the previous disbursement schedule, based on their date of contingency.

N. Samar town execs request their area be placed under MECQ due to spike of COVID-19 cases

TACLOBAN CITY -The municipal inter-agency task force (MIATF) in Mondragon, Northern Samar had requested the Regional Inter-Agency Task Force to place six of its villages under Modified Enhanced Quarantine Community (MECQ) from November 2 until November 15.

The request, signed by Mayor Mario Madera as head of the council, is due to the spike of coronavirus disease (COVID-19) in their town.

The MIATF agreed to declare the six barangays that have active cases to be placed under MECQ, thereby imposing stricter protocols on the movement of persons within the respective barangays," the resolution said.

The municipality has recorded 53 COVID-19 cases of which 40 are still active cases while 13 are already classified as recovered.

Villages to be placed under 14-day MECQ are Bugko, Chitongco, Eco, Imelda, Makiwalo, and Nenita.

"This will help ensure that prevention of the spread of the virus and the delivery of essential health care services to the affected residents," Mayor Madera said, citing the reason why

these barangays are to be placed under MECQ.

"This will also allow the local government unit to better manage and implement its COVID-19 response and mitigation mechanisms, "he added.

Based on the data of the LGU, in Bugko village, 17 residents are confirmed infected by the disease where they have 104 identified close contacts and 12 secondary contacts.

often relegated as something trivial and not so important. But taken away from the daily lives of people, it's without a doubt that life will be hard. It will even be catastrophic because these are little things that are vital to the way of doing things.

While the locale of that Velsberg study is Estonia, the concept of Smart Public Service is viable and applicable here in the Philippines. And while many of our public officials this is the exception and rarity and not the rule.

Having innovations harnessing the power of the internet and mainstreaming access and involvement of the people using available technology is an innovative and inclusive governance mechanism that would not only be advantageous but would create the impact it needs. In a nutshell, Smart Public Service is an idea whose time has come.
