With surging of COVID-19 cases

DOH renews appeal against mass gatherings

TACLOBAN CITY-The Department of Health (DOH) renewed its appeal for the public to avoid mass gatherings as it noted continued increase of coronavirus disease (COVID-19) in the region.

As of Thursday, 72 new COVID-1 cases were added to the region's cases, raising its total cases to 8,089.

the region, 38 were from mass gathering of people Leyte; 15 from Samar; 10 from Northern Samar; and nine from Eastern Samar.

The DOH, in particular, cited the increasing COVID-19 cases in the provinces of Northern Samar and Eastern Samar.

Mass gathering of people, to include family gathering involving more than 10 people, were cited by the DOH as the most common reason why there is now a surge of

COVID-19 cases on these two Samar provinces.

Dr. Exuperia Sabalberino, officer-in-charge Of the 72 new cases of of the DOH-8, said that is considered to be a 'super spreader' of COVID-19 which makes the transmission of the dreaded virus faster.

> "So, we appeal to our people to avoid any mass gatherings or other highrisk gatherings. Please avoid going to) parties during this time," she said during a virtual press conference Wednesday.

In MacArthur, Leyte

Fr. Alvero appeals mining company, officials to stop mining activity amid massive Luzon flooding

TACLOBAN CITY- The parish priest of the town of MacArthur in Leyte province has issued an appeal to a mining company to stop its black sand operation in the said town.

Fr. Amadeo Alvero, in his open letter issued on Thursday (Nov. 19), said that his appeal stemmed on the massive flooding incident that hit several parts in Metro Manila and in Cagayan Valley in the wake of typhoon 'Ulysses.'

"In view of what happened to the tremendous and great flooding in Cagayan, Manila, Marikina and many other places, I am pleading with my bended knees to stop the blank sand mining here in MacArthur, Leyte. This appeal I made in behalf of those who love and want to protect our environment," the priest said on his appeal hi posted on his Facebook account.

"And so I am humbly appealing to the deepest of their hearts to help us stop this black sand mining here in MacArthur, Leyte for the sake of those who have died and those who are still suffering because of the great flooding in Cagayan and many other places, and for the sake of those who will suffer and die in the future if we do not protect our environment," Alvero added.

Region's death toll due to COVID-19 now at 79

Two new deaths related to the coronavirus disease (COVID-19) were reported by health authorities here in the region on Thursday(Nov.19).

With the two new deaths, the region's death toll due to COVID-19 now stand at 79.

As this developed, the region's total COVID-19 cases has now reached 8,089 with the additional 72 new cases as reported by the Department of Health (DOH).

The two latest fatalities of the region due to COVID-19 complications involved a 42-year old woman from Guiuan town, Eastern Samar who died last Nov.14 while an 83year old man from Catarman, Northern Samar died on Nov. 17.

The DOH in the region reported that as of Wednesday, 7,296 COVID-19 patients have recovered from the ailment.

Of this number, 3,342 were from Leyte province; Samar, 2,337; 809 from Northern Samar; 483 from Southern Leyte; 216 from

Eastern Samar; and 109 from Biliran province.

Meantime, Palo Mayor Frances Ann Petilla, who is the president of the mayors league in Leyte province, said that the provincial inter-agency task force has recommended for a moratorium on the return to the province of the locally stranded individuals (LSIs) for the entire month of December.

This is to give way all local government units time to prepare their quarantine facilities as most of these facilities are already occupied.

They also asked the Department of Education to allow them to use public schools as quarantine facilities 'beyond December 31,

In Sulat town, Eastern Samar, its mayor Javier Zacate placed under hard lockdown for 48-hours the villages of Abucay, Baybay and Loyola Heights starting Nov.19 for contact tracing purposes as the town logged in five new COVID-19 cases. (JOEY A. GABIETA)

DOH-8 turns over P200 million hospital building to Leyte province

PALO, Leyte - The Department of Health (DOH) here in the region has turned over a hospital building to Leyte provincial government.

disclosed was by Governor Leopoldo Dominico "Mic" Petilla who told reporters in an interview that the new hospital building was subsequently turned over to Western Leyte Provincial Hospital (WLPH) in Baybay City.

The building, constructed by the Department of Public Works and Highways (DPWH-8) in the amount of P200 million, is located inside the WLPH compound.

Petilla received the symbolic key from Dr. Exuperia Sabalberino, the officer-in-charge of the DOH-8 last November 11, 2020 during the ceremonial turnover held at the conference room of the DOH office.

Man arrested for possession of agar woods

CALBIGA, Samar - The Philippine National Police, on its intensified campaign on illegal logging, has arrested a man who was in possession of an endangered woad species through a joint entrapment operation.

On Tuesday (November 17, 2020(, Police Operatives from 802nd Maneuver Company led by Police Captain Proven Troy T. Castro, Regional Special Operations Group 8, PIU ESSPO led by Major Herbert Joey G. Grata and Taft Municipal Police Station led by Silvano S. Soteraña, nabbed Rogelio Abarondo, 51, farmer, for the violation of PD 705, otherwise known as " Revised Forestry Code of the Philippines" and RA 9147 or the "Wildlife Resources and Protection Act."

The team was able to seize from the suspect a more or less 400 grams of agar woods with an estimated market value of P 12,000 that is extracted from the host trees locally known as 'Lanete' and 'Lapnisan'.

Both are included in the national list of the endangered Philippine Plants as per DENR Administrative Order 2007-01.

The arrested person was brought to Taft MPS for documentation and proper disposition.

Further, the Police Station coordinated CEN-RO-Dolores, E. Samar for the identification and scaling of the recovered items.

"Despite the quarantine restrictions and other measures imposed to contain the spread of COVID-19, the PNP remains unrelenting to go after for the environmental violators." -says Cpt. Castro. (PR)



There once a story told by my grandfathers Marcelo and Gregorio (not the del Pilars), where they tell of a story when warring British and German soldiers had to pause the ensuing battle for and in honor of Christmas. Fact checking this story, I found an article What happened when World War 1 Paused for Christmas, written by A.J. Boime and Volker Jannsen appearing at the History Channel website.

It came to be called the Christmas Truce. And it remains one of the most storied and strangest moments of the Great War—or of any war in history. At about 10 p.m., Bairnsfather noticed a noise. "I listened," he recalled. "Away across the field, among the dark shadows beyond, I could hear the murmur of voices." He turned to a fellow soldier in his trench and said, "Do you hear the Boches [Germans] kicking up that racket over there?"

"Yes," came the reply.

"They've been at it sometime!"

The Germans were singing carols, as it was Christmas Eve. In the darkness, some of the British soldiers began to sing back. "Suddenly," Bairnsfather recalled, "we heard a confused shouting from the other side. We all stopped to listen. The shout came again." The voice was from an enemy soldier, speaking in English with a strong German accent. He was saying, "Come over here."

One of the British sergeants answered: "You come half-way. I come half-way."

The account of the event had been corroborated by the many surviving protagonists although they had departed the Earth nowadays. The point however is simple after a protracted conflict with thousands of deaths on that part of the world alone, the Brits and the Germans had the audacity to pause and observe Christmas in the battlefield.

The very same spirit can be adopted by our officials, the administration and opposition, they must have a pause because the house is burning, the boat is sinking or better yet the country is under water. There must be a mature attempt on bothe side to put differences aside and confront the real enemy. To uplift, help, care and rebuild a land and people needing its collective strength. Our countrymen can be proud and happy if this would be the central theme of the efforts to help. We must always remember that we are all in this together!

visiting around business establishments due to the rising COVID-19 of the city.

"While on record we have only 227 number of workers who lost their jobs during this time of pandemic, we can say the number could be higher, even in thousands as our survey only covered the July to August period," she said.

She cited that based on their survey for those who were rendered unemployed during this time of pandemic in the different barangays of the city, 570 individuals were identified to have lost their jobs.

And only 12 barangays out of the city's 138 responded on their survey. Also, the survey, which started last July 15, was temporarily suspended due to the rising number of COVID-19 cases of the city.

City Mayor Alfred Romualdez said that there could be 'thousands' of workers from the city who lost their jobs during the quarantine period as there were business establishments have stopped their operations or chose to continue to operate but at the same time, cut down the number of their workers as the local economy was severely hurt by the COVID-19 pandemic.

But Peliño said that their office tries to help these unemployed people through referral system saying there were still establishments despite of the current health problem which looked for workers.

"But those retrenched during this COVID-19 pandemic were given assurance by their employers that they would be rehired once everything return to normal," she said.

Shut down for eight months due to COVID-19 pandemic Tour guides rejoice return of extreme boat ride

in Samar town

PARANAS, Samar-The tour guides and boatmen who are members of Torpedo (Tour guides and boat Operators for River Protection and Environmental Development Organization) from this town are excited that after almost eight months, they can now resume their work as tour guides.

Eugene Igdalino, Torpedo president, said that due to travel restrictions imposed in the wake of the coronavirus (COVID-19) pandemic, they were rendered jobless.

The provincial government of Samar and the regional office of the Department of ism(DOT) has reopened several tourism sites in the province to include the torpedo extreme boat ride in this town last November 16.

"Before the imposition of the lockdown, we have source of income which help us provide our daily needs to include sending our children to school," he

He and the more than 60 members of their group serves as tour guides to visitors that frequent their town, particularly at the Olot River, the site of an extreme boat ride.

Igdalino said that during the time that they have no jobs, some have resorted to farming while others chose to engage in illegal poaching.

Incidentally, before the men of Tenani and neighboring villages were trained as boat drivers or guides, many of them engaged in timber poaching at the Samar Island Natural Park (SINP), a protected area.

SINP is the only remaining lowland forest in the country and is considered to be the country's largest terrestrial protected area covering an area of 333,300Â hectares which present travel authority spreads to the three prov- and medical certificate inces on Samar Island.

With the resumption of their operation and to follow health protocols imposed by the government to stop any spread of the virus, Igdalino said that from the previous five passengers per boat they reduces it to just three passengers.

This means that from the former 50 tourists, they can only accommodate 30 tourists. Although the number of boat passengers is reduced to three persons, the amount they will be paying is still the same rate at P1,865 per

Those who wanted to be served with foods have to pay additional cost of P250 per head and they can ask for their meal to be served either at the newly-constructed tourism center or at Deni's Point where tourists may do swimming and jumping off from the boulder that raging current of Ulot River.

"We are thankful to all agencies who trusted and trained us. This is really a big help for our family,"

A closer look of farm-to-market road in Barangays Imelda to Avelino



CALBAYOG Farm-to-market roads (FMRs) constructed from the fund allotted by the Department of Agriculture paved the way for the concreting of FMR in Barangays Imelda through Bana-o to Avelino located in the municipality of Sta. Margarita, Samar with a total allocation of P50 million.

A concreted road which spans 900 meters is constructed on most part of Brgy. Imelda. The rest is an opening with a length of 1.780 kilometers. With a width of 5.3 meters, a riprap was also infused in the project to avoid collapse of structure and protect soil from erosion since the structure is located in the mountains.

Copra, rice, banana, corn and other root crops such as taro, cassava and sweet potato are products that are usually being delivered to the local markets in Calbayog City from the said barangays.

Residents and farmers alike, who are living in Brgys. Imelda, Bana-o and

Avelino would have to walk for 3-4 hours on foot on a footpath to reach Brgy. Napuro and from there, they will need to ride a motor vehicle to reach the city proper for another 30 minutes.

Income is strenuous for farmers since they need to bribe someone depending on the product that they are selling aside from the fare that they pay for the motor vehicle from Napuro to the city proper.

A resident and farmer of Brgy. Bana-ao, Day-Day Tolibat have these to say:"Amon la ginkakarga amon produkto pareho san saging o kopra sa amon kalugaringon na lawas tapos mano-mano la ngadto sa dalan tapos pag abot namon sa Napuro, ginsasakay na namon ngadto sa Calbayog. Tikang sa Bana-o maglalakat kami sa Napuro tapos sa Napuro karga na namon tikadto sa Calbayog na. Naglalakat kami danay upat ka oras, naabot lima, danay tulo liwat depende la san imo kalakat ngadto. Wara pa dida an tikang sa Napuro tikadto sa Calbayog. (We carry our own products in our backs like bananas or copra and trudge the footpath to Barangay Napuro, then we load it on a motor vehicle that passes the said barangay to the city proper. We walk for four hours, sometimes five or three depending on our pace, excluding the time-travel from Barangay Napuro to the city proper.)

A resident and barangay chairman of Imelda attested saying, "mahirap talaga noon na hindi pa kalsada ang aming barangay dahil sa mga produkto na lang na aming dinadala papunta sa car line dahil upland itong aming lugar, mahirap talaga. Kung mayroon kaming produktong copra na dinadala namin sa Napuro, galing dito, ang pagdala, binubuhat lang ng tao at yan ay kada sako binigbyan ng suhol ng seven pesos kada kilo o five pesos depende sa presyo ng kopra. Kaya sobrang hirap na wala pang kalsada noon". (When the road is non-existent, it is so hard for us to deliver our goods to where motor vehicles are available because we come from an upland. If we have products to send to the market, we need to go walk on foot and load it on a make-shift basket carried at the back to Barangay Napuro and bribe them with seven or five pesos per kilo depending on the price of copra. That is why it is hard when there is no road.)

With the completion of this farm-to-market road, farmers' income is much better since travel of their goods are directly delivered to the public markets. Travel time was reduced from 15-10 minutes to Barangay Napuro where they can get hold of vehicles to Calbayog City.

Farmers won't have to bribe just to get their products to the local markets since public transportations can now reach their barangays because of the completed roads.

Furthermore, issues such as problems in carrying their sick or those who are pregnant, can now be transported to the nearest hospitals immediately unlike before that that they have to carry them and travel on foot for hours.

"Pag-abot naman san mga may sakit amon la iton ginkakarga ngadto kay wara man natukad ngadi sa amon nga ma check-up. Tapos kun may mga burod, nanganganak, amon iton gnbababa liwat, lakat na liwat. Pag abot sa Napuro mao na masakay ngadto sa Calbayog.Pero yana madali na kay didi na la masakay deretso na an byahe kay may ada na man sarakyan", said Mr Tolibat. (when it comes to those who are sick and pregnant, we carry them in our backs since no one can come here for check-ups. But now, it is easier since any vehicle can now reach our place.)

In the communities where the primary source of livelihood is farming, the concrete road is a welcome respite from the inconvenience of travelling to the Poblacion and back, and able to get their produce to the market cheaper and faster.

Farmers have better opportunities ahead of them now. Basic infrastructure paves the way for a future that holds an abundance of promise, heightened productivity and accessibility. (GISSELLE G. PARUN-
