# <u>All are said to be asymptomatic</u> 22 cop trainees tested nositive

TACLOBAN CITY-At least 22 police trainees at the Regional Police Training Center, based this city, were quarantined after they were tested positive of the coronavirus disease (COVID-19).

The trainees were part of the 241 newly-recruit police of the regional Philippine National Police (PNP) said S/Sgt.Lalaine Rosales, the information officer of the training center located in San Jose district.

According to Rosales, the 22 police trainees are now isolated in a facility identified by the PNP regional headquarters and all are asymptomatic.

Aside from the police trainees, two personnel and one mess hall server of the training facility also tested positive of the

dreaded virus.

Rosales said that last October 30, the 241 police trainees were turned over to their facility by the PNP-8 headquarters for further police training.

But five of them showed some symptoms like colds and sore throats. They were swabbed on November 13 with four of them tested positive.

Their 40 close contacts, also police trainees, were also swabbed on Nov.19 of which 19 of them tested positive, to include the mess see 22 cop /page 12 ...

## 180 families from San Jose district soon to transfer at the northern resettlement site

TACLOBAN CITY-About 180 families coming from Barangay 88 San Jose may now move to their new homes, in Aeroville Subdivision, soon as the selection on who will occupy in what unit number was made through a raffle ceremony on Thursday afternoon (November 26).

## Leyte SP approves province-wide bike lane ordinance

TACLOBAN CITY - The members of the Sangguniang Panlalawigan(SP) of Leyte approved on the third and final reading the proposed Leyte Bike Lane Ordinance of 2020 during their regular session last November 20.

The ordinance was approved two days before the celebration of the National Bike Day which is observed every fourth Sunday of November as approved by President Rodrigo Duterte through Presidential Proclamation 1052 which he signed on November 18.

"Basically this reinforces the mandate that we impose through our Environmental Code ordering local government units to come up with a different networks of bicycle lanes in their respective municipalities," Vice Governor Carlo Loreto said.

"In this ordinance it does not only requires them to put up bike lanes but also activity areas which can be used under the new normal like areas for jogging or walking provided that they still follow the minimum health protocols such as wearing of face masks to prevent virus transmission," he added. Under the ordinance,

authored by the vice governor, the province through the Active Mobility Committee which is chaired by Governor Leopoldo Dominico Petilla with Loreto as his vice chair, shall review all roads within its jurisdiction and determine sections that may be developed into a continuous bike lane network.

The committee also includes the provincial legal officer as secretary and members are representative from the provincial engineering office, planning and development office, budget office, disaster risk reduction and management office, health office, SP chairman on committee on infrastructure, representative from local cycling group, persons with disability, women's group, senior citizens, and the Department of Public Works and Highways (DPWH).

The committee is also mandated to adopt traffic engineering solutions that will prioritize, complement, and support safe and efficient biking and walking.

The measure mandates that all bike lane designs and sidewalks must comply with the design standard by the Department of Trans-

portation and the DPWH and must also take into account for the safety, social distancing measures, operating speed, volume and composition of traffic and the carriageway width of the road.

Signages that indicate bike lane and motor vehicle lane are also need to be installed including speed limits, and other traffic rules to ensure safety of all road users.

The traffic management office of the city and the municipality is also task to maintain the bicycle lane network from use of motorized transport vehicles, and illegal road obstruction such as illegal parked cars.

The ordinance also mandates that every bikers or cyclists must use personal protective gear for their safety such as helmets, closed shoes, head gear, bicycle lights or reflectors, while minor or those below age 18 years old are required to use additional appropriate protective gear as determined by the committee.

The municipality or city under Leyte province will have to adapt the ordinance and include a penalty provisions to be impose against violators. (ROEL T. AMAZONA)

### In Eastern Samar Oras town exec raise concern over incident involving a patient who died due to COVID-19 complication

TACLOBAN CITY-The mayor of Oras town in Eastern Samar raised her concern over an incident involving a man who died reportedly due to complications related to coronavirus disease (COVID-19).

Mayor Viviane Alvarez said that the local government unit as well as the Provincial Health Office (PHO) were not informed by the regional office of the Department of Health (DOH) that the man died due to the dreaded virus.

She said that the positive swab result of the patient was released on Nov. 23 while his family and relatives were holding a wake at their residence.

This incident has put in danger the health of those who attended the wake, the town mayor said.

The patient died on Nov.21 due to COVID-19 complications while he was confined at the Eastern Visayas Regional Medical Center (EVRMC), this city.

"Sadly, there was no proper coordination and information to the PHO nor to the rural health unit nor to the family on the handling of the cadaver," Alvarez said on her Facebook account.

The man is the first COVID-19 related death of the town which has posted 50 cases due to the dreaded virus.

It was learned that the man was first brought at the Maulong Hospital in Catbalogan City last Oct.14 as he was suffering from ulcer.

Five days later or on Oct.19, he was transferred to EVRMC in Magsaysay Boulevard, this city. A swab test on him yielded a negative result.

On Oct.22, he was transferred at the new EVRMC located in Brgy. Bagacay where he died due to respiratory problem last Nov. 21.

His remains were returned to his hometown on Nov.23 where his family held a wake. It is during this time that his swab result was released by the DOH.

Alvarez said that their task force immediately conducted contact tracing to the primary contacts as she disclosed that she urged the second and third generations contact to undergo isolation.

The town mayor said that she ordered that lockdown be put into effect in the villages of Paypayon, San Roque, Balocawe and Agsam until the contact tracing is over.

"Please stay home, follow health protocols and cooperate.We need the help of everyone in this trying time," Alvarez said. (LIZBETH ANN A. ABELLA)

## **Continuous improvement of Riverdrive Project** to ease flooding, traffic woes in Las Piñas


Senator Cynthia Villar, the proponent of the Las Piñas Zapote River Drive project, is confident that its completion is preventing flooding and solving the traffic problem in Las Piñas City.

So far, 24 kilometers have been completed for the last 9 years starting in 2012 until 2020 and five (5) kms more is slated to be built in the next two years (2021 & 2022).

"The project is being completed in phases and we have seen the improvements so far in terms of flood prevention and traffic flow in the river drive areas. So, we will continue to extend the coverage of the project to 29 kilometers in next two years," (2021-2022) said Villar.

For next two years (2021-2022), the Molino Riverdrive phase will be built, stretching a total of 5kms, from Daanghari road to the river along Barangay Molino III & Molino VI until it connects to Zapote River.

The very first phase of the Riverdrive Project was the 18-km Zapote Riverdrive along Zapote River aimed at preventing flooding in the city and solve the traffic congestion along Zapote-Alabang Road because it serves as alternate road

The Riverdrive Project started at the end of C-5 Extension Road in Barangay Pulanglupa I to Alido Bridge and continuing to an underpass in Zapote Bridge in Barangay Zapote on to Barangays Pamplona I, Pamplona II, Talon II, Moonwalk, Talon I, Almanza II then to Daang Hari Road connected to the MCX Expressway.

The second phase was the 6-km Las Piñas Riverdrive which started at C-5 Extension Road in BaranZapote Riverdrive to Manila Bay area.

The Zapote and Las Pinas Riverdrive as well as the Molino Riverdrive, according to Villar, do not only ease flooding and traffic woes.

"With the river drive, we also closely maintain the cleanliness of the river, which can be considered as the 'artery' of the city and nearby areas too. The people living along the river cannot throw their wastes anymore into the rivers because there



## Senate inquiry on red-tagging



he series of senate hearings on the issue of red-tagging has been an effective tool to clarify matters that most of our countrymen do not fully understand. It is also an opportunity for those coming from all sectors involved to express their stand on the issue, especially for

the accused, the Makabayan bloc representatives in congress who deserve to clear their names.

This issue on red-tagging linking the Makabayan bloc and their legal fronts/organizations to the CPP-NPA-NDF stemmed partly from the anguish of protesting parents who lost their sons and daughters to what they call 'deceptive recruitment' in school campuses. Carried out rampantly by these organizations such as the LFS, Bayan Muna, Anakbayan, ACT, Gabriela, etc. as alleged by the military, this massive recruitment in schools and other sectors of society is being denied by their party leaders in congress. 

## Pa put house in fire: 2 kids die, one injured

TACLOBAN CITY-Two minors died after their father reportedly burned their house in Catarman town, Northern Samar Friday early morning.

The victims, aged 16 and 11 and both boys, died after they were trapped inside their burning house located in Barangay Dalakit in the said town at around 4:30 am.

A 13-year old cousin of the two minors who was also with them managed to get out from the blazing house but sustained injuries, town police chief, Captain Russel Calubag said in a phone interview.

Based on their initial information, the suspect, Fernando Ford Frigillana,39, used a gasoline he took from a park vehicle in burning their house made of light materials.

The three victims who were sleeping at that time were trapped inside their house as the blaze turned so fast.

The two brothers were not able to escape inside their house which resulted to their death while their cousin managed to run out but sustained minor injuries, Calubag said.

"The incident is still under investigation so I cannot give more information regarding the incident. But the suspect is now under our custody and we have him drug tested while the two minors who died are still with our crime laboratory for autopsy. The 13year old is now in a hospital," the town police chief said.(JOEY A. GABIETA)

A non-profit local community radio is now operating in San Miguel, Leyte keeping its constituents abreast of latest developments the local government unit is undertaking to address especially concerns related to the COVID-19 pandemic.

Mayor Norman Sabdao, however, hinted that he personally pursued the establishment of the local community radio to aid in the delivery of basic education to the elementary and secondary students in San Miguel town.

"This project primarily aims to help our students in this pandemic. It was Sir Vernon Barraza, the principal of San Miguel National High School who requested that we establish a school-on-air to supplement the modules being distributed to students so that students will be properly assisted and guided in their learning activities," Sabdao said.

Hence, the Project Learning Modality-On-Air in the New Normal or "Project Learning MAN" was launched in the municipality even before classes were formally opened last October 5.

The town mayor disclosed that this idea was presented to him last June 2020 and he immediately acted on it being a radio aficionado himself. "It just happened that radio is close to my heart. I've always wanted to be a radio announcer or a mass com graduate ever since. I did apply in radio stations in Tacloban before just to get the feel of becoming a radio announcer that I even bought a block time in one of the stations there before. This is how close to my heart radio is," explained. Because of limited time between the conceptualization of the project and the need for it to operate or become functional, Sabdao said he was forced to tap friends and other acquaintances to help him immediately establish the station to meet the



need of students in the town whose opening of classes started last October 5.

"I asked my friends to help me put this up in time of the need our students. If I would insist that this be funded by the LGU, the bidding and other procurement processes would just consume all the time and possibly not be able to operate even until the end of this year. Likewise, because of regulations in place due to pandemic, my friends recommended that this station be placed in a readily available area, thus, its location near my house which I also own," he said.

The radio station is named HOPE FM at 88.9 frequency.

## DPWH Leyte 2 completes rainwater collection system project

CARIGARA, Leyte – At least 12 recipient schools in the second district of Leyte benefited the Rainwater Collection System (RWCS) project implemented by the Department of Public Works and Highways (DPWH) – Leyte Second District Engineering District Office.

According to OIC-District Engineer Leo Edward Oppura, the department allocates a total of P4.34 million worth for the installation of 15 units of RCWS in different schools that do not have adequate access to water and sanitation facilities.

"Rainwater are collected and stored in a 4,000-liter capacity tank for sanitation and other adequate purposes to augment the continuous need for water supply," he added.

Two units each were installed in Sta. Rosa NHS,

Kaya po ngayon ang aking gagawin, gagawa po tayo ng administrative order in relation to sections 6, 7, and 14 or RA 6657 so that all agriculture graduates will have their own piece of land, so they can put into practice their wealth of experience and the knowledge they gain from their agricultural studies," he said.

RA 6657 refers to the Comprehensive Agrarian Reform Program (CARP) of 1988.

"Some of them even have masteral degrees, some of them even have doctorate in agriculture. But the only problem is they don't have a piece of land that they can use as a laboratory in order to implement what they have learned as experts in agriculture," Castriciones said.

According to the DAR Secretary, there is around 200,000 hectares of government-owned idle lands that could be used for this purpose, adding that there is also around 500,000 hectares of lots could be distributed to potential CARP beneficiaries.

Other than agriculture graduates, retiring or retired uniformed personnel from the Armed Forces of the Philippines and the Philippine National Police who are landless will also be entitled to receive a portion from the government-owned idle lands, according to Castriciones. Rebel returnees are also included in this program he added. Under the proposed administrative order that he will issue next week, agri-graduates and retired AFP and PNP personnel will receive 3-hectares of land for them to till and nourish. "Definitely this will be a bold steps in order to see to it that agriculture will really take the lead when it comes to the development of our country,"he said.

Castriciones, in his visit to this town, lead in the ceremonial distribution of CLOAS to 1,031 Agrarian Reform Beneficiaries (ARB) from the towns of Alangalang, Barugo, Burauen, Capoocan, Carigara, Dagami, Jaro, Kananga, and Pastrana, all in Leyte.

Farm machineries were also distributed to ARBs from Alangalang town.

The event was also graced by Vice-Governor Carlo Loreto, Mayor Lovell Yu, and national government agency heads.

Castriciones also lead the launching of the Support for Parcelization of Lands for Individual Titling (SPLIT), a

program in partnership and funded by the World Bank worth PhP24 billion.

This project, which will be implemented for three years, seeks to improve land-tenure security and stabilize property rights through fast-tracking of land subdivision of collective CLOA and generate individual titles on lands awarded under CARP.

The program is targeting a total of 63, 373 ARBs for CLOA subdivision, 36, 287 ARBS for CCLOA redocumentation, a total of 114,661 hectares for CCLOA subdivision and 92, 644 hectares for CCLOA redocumentations. (ROEL T. AMAZONA)

Service upon defendant whose identity or whereabouts are unknown. – In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendars days from the commencement of the action, service may, by leave of court, be effected upon him or her by publication in a newspaper of general circulation and in such places and for such time

as the court may order. Any order granting such leave shall specify a reasonable time, which shall not be less than sixty (60) calendars days after notice, within which the defendant must answer."

"Since petitioner could not be personally served with summons despite diligent efforts to locate his whereabouts, respondent sought and was granted leave of court to effect service of summons upon him by publication in a newspaper of general circulation. Thus, petitioner was properly served with summons by publication." (Santos, Jr. vs. PNOC Exploration Corporation, G.R. No. 170943, September 23, 2008)

On July 5, 2020, Plaintiff Republic of the Philippines, represented by the Department of Public Works and Highways (DPWH) through the Office of the Solicitor General filed an Ex-Parte Motion for Leave of Court to Serve Summons by Publication.

The Motion is anchored on the ground that per Sheriff's Return of Service, despite diligent efforts to serve Summons to herein Defendant, attempts proved futile.

On October 2, 2020 videoconferencing hearing, the Ex-Parte Motion for Leave of Court to Serve Summons by Publication with Manifestation and Motion to Admit was submitted for the resolution of the said owner- no occupant was observed. Upon inquiry with random residents near the said property, no useful information has been solicited which could possibly help them in locating Defendants; 2. In the Sheriff's Re-

turn of Service dated July 18, 2019, Sheriff Danilo Obediencia certified that he made an attempt to serve Summons to herein Defendant at the address given in the Complaint but was not served as no one knows the identity of herein Defendant; and 3. In the same return,

it revealed that on July 16, 2018, Hon. Leo S. Bahin, Punong Barangay of Barangay 87, San Jose, Tacloban City, the given address of the Defendant issued a Certification that per recent survey conducted by the Barangay Service Point Officer (BSPO), Defendant Canuto Abres is not a resident of the said Barangay.

Gleaning from these narration, the Court is convinced that, indeed, herein Plaintiff made diligent efforts to give notice to herein Defendant even before the Court took efforts to effect valid service of Summons to the same Defendant, but all of which proved to no avail

Hence, the Court finds Section 16, Rule 14 of the Rules of Court (as amended) favorably availing in this instance:

"Section 16. Service upon defendant whose identity or whereabouts are unknown. In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendar days from the commencement of the action, <u>service may, by leave of court,</u> be effected upon him or her by publication in a newspaper of general circulation and in such places and for such time <u>as the court may order.</u>

Any order granting such leave shall specify a reasonable time, which shall not be less than sixty (60) calendar days after notice, within which the defendant must answer."

This matter is abundant in jurisprudential anchored, as in the case of Santos, Jr. vs. **PNOC** Exploration Corporation (G.R. No. 170943, September 23, 2008), the Court ruled: "Section 14, Rule 14 (on

Summons) of the Rules of Court provides: SEC. 14. Service upon

defendant whose identity or whereabouts are unknown. In any action where the defendant is designated as an unknown owner, or the like. or whenever his whereabouts are unknown and cannot be ascertained by diligent inquiry, service may, by leave of court, be effected upon him by publication in a newspaper of general circulation and in such places and for such times as the court may order. (Underscoring supplied) Since petitioner could not be personally served with summons despite diligent efforts to locate his whereabouts, respondent sought and was granted leave of court to effect service of summons upon him by publication in a newspaper of general circulation. Thus, petitioner was properly served with summons by publication." (Santos, Jr. vs. PNOC Exploration Corporation, G.R., No. 170943, September 23, 2008)

meritorious grounds of having exerted diligent efforts of effecting personal service of Summons was duly complied by the Plaintiff in this case.

WHEREFORE, premises considered, the Motion for Leave to Issue Summons by Publication is hereby **GRANTED.** 

Thus, let Summons be published once week for three (3) consecutive weeks in a newspaper of general circulation in Tacloban City and in the Province of Leyte. Likewise, let a copy of the summons and this Order be furnished to Defendant CA-**NUTO ARBES** by registered mail to his last known address, all at the expense of Plaintiff.

Defendant Canuto Arbes is hereby ordered to file his Answer within Sixty (60) calendar days after notice thereof. Let copies of this Order

Plaintiff REPUBLIC OF THE PHILIPPINES represented by the Department of Public Works and Highways (DPWH), through the OFFICE OF THE SOLICI-TOR GENERAL (OSG), to this Honorable Trial Court, respectfully states:

1. Plaintiff REPUBLIC **OF THE PHILIPPINES** is a sovereign political entity with capacity to sue and is vested with the power and authority to condemn private property for public use upon payment of just compensation. It is represented by the DPWH, the engineering and construction arm of the Government tasked with the planning, design, construction, and maintenance of national highways in accordance with national development objectives. Plaintiff may be served with notices and other court processes through its statutory counsel, the OSG, at 134 Amorsolo Street, Legaspi Village, Makati City.

2. Defendant Canuto Arbes ("Defendant," for brevity) is a Filipino, of legal age, and with residential address at San Jose Street, Brgv. 87. Tacloban City, Province of Leyte, where he may be served with summons and other court processes 3. To provide a heightened road and tide embankment in Palo, Leyte, Plaintiff is implementing the construction of the "Storm Surge Protection: Heightened Road and **Tide Embankment Project"** ("STORM SURGE PRO-**TECTION PROJECT").** 4. The lot containing the area sought to be expropriated (subject lot), covered by Tax Declaration No. 2012-01-0015-08572, is in the name of Defendant. It is located in Brgy. 87, Tacloban City, Leyte and within the jurisdiction of the Honorable Trial Court. The details of the subject lot are as follows:

(Agricultural; Bureau of Internal Revenue (BIR) Zonal Value of the subject lot per sq.m. (in Pesos): 100; Zonal Value of the Affected Areas (in Pesos): 73,600.00; TOTAL 73,600.00

6. The relative location of the affected area of the subject lot is indicated by the shaded portion on the Parcellary Plan and the Subdivision Plan. which are attached hereto as Annexes "D" and 'E", respectively. More particularly, the technical description of the affected portion thereof is indicated in the Subdivision Plan.

7. The subject lot will be traversed by the construction of the STORM SURGE **PROTECTION PROJECT.** a government infrastructure project vested with a public purpose. In compliance with the requirements of Presidential Decree (P.D.) No. 1586, as amended, an Environmental Compliance Certificate (ECC) has been secured from the DENR, a copy of which is attached hereto as Annex "F".

8. The subject lot has neither been devoted to nor expropriated for any public use, and indispensable in implementing the project. It was selected by the Plaintiff in a manner compatible with the greatest public good and with the least injury to private property.

9. The determination of just compensation in expropriation cases is a judicial function to be discharged during trial, pursuant to Section 5 to 8 of Rule 67 of the Revised Rules of Court and Section 6 of R.A. No. 10752.

10. A DPWH Modified Disbursement System/Treasury Check (MDS treasury check) in the amount of Seventy Three Thousand Six Hundred Pesos (Php 73,600.00) representing one hundred percent (100%) of the BIR zonal COMMENTS ON THE

(2) The replacement cost at current market value of the improvements and structures as determined by:

(i) The implementing agency

(ii) A government financial institution with adequate experience in property appraisal; and

(iii) An independent property appraiser accredited by the BSP.

(3) The current market value of crops and trees located within the property as determined by a government financial institution or an independent property appraiser to be

ing of instruments relating to unregistered lands. No deed, conveyance, mortgage, lease, or other voluntary instrument affecting land not registered under the Torrents system shall be valid, except as between the parties thereto, unless such instrument shall have been recorded in the manner herein prescribed in the office of the Register of Deeds for the province or city where the land lies.

(a) The Register of Deeds for each province or city shall keep a Primary Entry Book and a Registration Book. The Primary Entry Book shall contain, among other particulars, the entry number, the names of the parties, the nature of the document, the date, hour and minute it was presented and received. The recording of the deed and other instruments relating to unregistered lands shall be affected by any of annotation on the space provided therefor in the Registration Book, after the same shall have been entered

in the Primary Entry Book. (b) If on the face of the Instrument, it appears that it is sufficient in law, the Register of Deeds shall forthwith record the instrument in the manner provided herein. In case the Register of Deeds refuses its administration to record, said official shall advise the party in interest in writing of the ground or grounds for his refusal and the latter may appeal the matter to the Commissioner of Land Registration in accordance with the provisions of Section 117 of this Decree. It shall be understood that any recording made under this section shall be without prejudice to a third party with a better right.

(c) After recording on the Record Book, the Register of Deeds shall endorse among other things, upon the original of the recorded instruments, the file number and the date as well as the hour and minute when the document was received for recording as shown in the Primary Entry Book, returning to the registrant or person in interest the duplicate of the instrument, with appropriate annotation, certifying that he has recorded the instrument after reserving one copy thereof to be furnished the provincial or city assessor as required by existing law.



## **EV police officers tested positive** for COVID-19 rise to 235

PALO, Leyte - The number of policemen from the region that have been infected with the coronavirus disease (COVID-19) is now 190, a report from the Regional Office 8 (PRO8) based in Camp Ruperto Kangleon, Campetic, this town, said.

PRO8 Regional Information Officer Lieutenant Colonel Ma. Bella Rentuaya told reporters that as of November 27, the total number of the members of the Philippine National Police (PNP) is now 235

in the region since March 17 when the first policeman was infected with the virus.

Rentuaya reported that with this number of infected law enforcers the active cases is only 63 while 172 of them have already recovered and with zero death.

Rentuaya said that all of the 144 police officers with active cases are now confined at the isolation facilities of their respective local government units.

Rentuaya added that the infected police officers are asymptomatic.

They are being closely monitored by the headquarters of PRO8, she added.

She said that the infected police officers could have caught the virus while performing their duties considering that most of them are detailed at various checkpoints established by the local government units in the region. MUNICIPAL ORDINANCE NO. 05

AN ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION, HARASSMENT OR OTHERWISE DISCRIMINATING AGAINST A PER-SON INFECTED, UNDER MONITORING OR INVESTIGATION DUE TO THE COVID-19 VIRUS INCLUDING PUBLIC AND PRIVATE DOCTORS, NURSES, HEALTH WORKERS, EMERGENCY PERSONNEL AND VOLUN-TEERS, SERVICE WORKERS WHO ARE ASSIGNED TO HOSPITALS OR OTHER CENTERS WHERE THESE PERSONS ARE BEING TREATED, AND IMPOSING PENALTIES THEREIN. HEREIN OTHERWISE KNOWN AS THE "ANTI CORONA VIRUS DISCRIMINATON ORDINANCE OF 2020".

THE "ANTI CORONA VIRUS DISCRIMINATON ORDINANCE OF 2020".
 WHEREAS, the 1987 Philippines Constitution under Article III, Section 1 provides that every person has the right to life, liberty, security of person and privacy and the right to be free from discrimination. Furthermore, under Section II thereof, the State values the dignity of every person and guarantees full respect for human rights;
 WHEREAS, the 2019-2020 corona virus pandemic was confirmed to have spread to the Philippines on January 30, 2020, when the first case of corona virus disease 2019 (COVID-19) was confirmed in Metro Manila. As of April 5, 2020, there have been 3,246 confirmed cases of the disease in the country. Out of this case, 152 deaths and 64 recoveries were recorded;
 WHEREAS since the emergence of COVID-19 we have seen instances of public stigmatization among persons who have contacted the disease including PUIs and PUINs and the rise of harmful stereotypes. This means that people are being labeled stereotyped, separated and/or experience loss of status and discrimination because of a potential negative affiliation with the disease. Stigmatization could drive people to hide the illness to avoid discrimination people from seeking health care immediately and discourage them from adopting healthy behaviors;
 WHEREAS, the Department of Health (DOH) recently warned the public against discrimination because of 2001D-19 as well as PUIs and PUINs including health workers and emergency workers who are among those in the frontliner of the battle against the rapidly spreading COVID-19. The DOH stated" that with the world confronted with a virus with little information known, it is human to be afraid. But we must not allow hysteria and paranoia to result in irrational treatment of people;
 WHEREAS, the Deveral recovered from the illness were prevented from returning back to their residences, while some were evenal dous of people baig exicted out of their residences, while s

over fears of infection. Some were snumed by local stores, boarding increase and the combat the perva-rangays and homes. WHEREAS, considering the gravity of the situation, there is an urgent need to combat the perva-sive stigmatization on the basis of one's medical condition. There is a need for the Municipality to bring normalcy and order amids the crisis, and protect its constituency from unjust discrimination brought on by fear and panic by public; SECTION 1. TITLE: This ordinance shall be known as "ANTI CORONA VIRUS DISCRMINATION OR-DINANCE OF 2020" SECTION 2. DEFINITIONS – PERSONS INFECTED, PATIENTS UNDER INVESTIGATION (PUIs) and PERSONS UNDER MONITORING (PUMs) are those defined by the protocols and guidelines of the De-partment of Health.

partment of Health. HEALTH WORKERS – are those who deliver care and services to the sick and ailing either directly or indirectly. Health workers include, among others, doctors, nurses, hospital and clinic aides, and lab-

oratory technicians. FRONTLINERS – include officers and members of the PNP, AFP and instrumentalities of the gov-ernment rendering emergency frontline services, border control and other critical services. Frontliners also include service workers who are working in private establishments providing basic necessities and such activities related to food and medicine productions, i.e. public markets, supermarkets, groceries, convenience stores, hospitals, medical clinics, pharmacies and drugs stores, food preparation and de-livery services, water refilling stations, manufacturing and processing plants of basic food products and medicines, banks, money transfer services, power, energy, telecommunications and water supplies and other related facilities.

other related facilities. SECTION 3. UNLAWFUL ACTS – It shall be unlawful for any person, whether natural or juridical, to commit any or make utterances which cause or tend to cause stigma, disgrace, shame, humiliation, harassment or otherwise discriminating against a person's infected, under investigation or monitoring due to COVID-19. It is also prohibited to un

harassment or otherwise discriminating against a person's infected, under investigation or monitoring due to COVID-19. It is also prohibited to utter or post online "slanderous or abusive" statements discriminates the health workers and frontiners; subject any health workers and frontliners to any harassment or any threat of physical, mental and verbal violence, intimidation or other threatening disruptive behavior; or any other act of discrimination which nullifies the exercise of a frontliners to any harassment or any threat of physical, mental and verbal violence, intimidation or other threatening disruptive behavior; or any other act of discrimination which nullifies the exercise of a frontliners to use of private and basic freedom. It is also unlawful, for the health workers and frontliners to be denied access to or use of private and public establishments facilities, utilities transportation services that are open to the general public. If any public officer refuses or fails to give assistance to a person infected, under investigation or monitoring due to COVID-19, health worker or frontliner who intends to return to his place of residence or domicile, after obtaining clearance of the Covid-19 infection from the proper health officials, he/she shall be equally liable under this section. Any person who shall publicly claim, post on social media, spread or announce that person is infected, is under investigation or monitoring due to Covid-19 whether or not same has been confirmed or validated from the list given by authorized proper health officials, agency or department shall also be liable under this section. If the person violating is a public officer, the penalty imposed shall be in the maximum and can also be a ground for filing of an administrative case against said official EXCEPT when the patient concerned waived his/her right to privacy and for purposes of contact tracing and other medical purposes. SEFCTION 4\_PENANTES – Any person caught in violating in Serion 3 hereof shall be

question is a part of a public use hence beyond the commerce of man"; WHEREAS, President Rodrigo Roa Duterte, has directed, local government units, law enforcement agencies and public officials to exercise their full authority to remove all street and sidewalks obstructions ncluding but not limited to makeshifts stalls, basketball courts, and other illegal structures, in order to effect th smooth flow of traffic and pedestrians. WHEREAS, DILG Secretary Eduardo M. Año issued DILG Memorandum Circular No. 2019-121 direct-

ing Local Government Units to implement and enforce the directive of the President and that non-compli-ant local chief executives shall be meted out with appropriate administrative sanctions/cases.

## Man shot dead by SUV-riding gunmen in Maasin City

TACLOBAN CITY-A 35-year old man was shot dead by still unidentified gunmen onboard a sports utility vehicle (SUV) in Maasin City, Southern Leyte last November 17, 2020.

Police identified the victim as Nhiel Sansan, married, self-employed, and a resident of Barangay Ibarra, Maasin City.

In an initial investigation, Sansan was waiting for the mechanics to repair his driven tricycle inside a vulcanizing shop in Barangay Ibarra around 9:30 am when two unidentified male suspects alighted from an SUV and shot him using long firearms.

The victim was hit several times in his head, shoulder, arm, chest, and left foot that resulted in his instantaneous death, police said in the report.

The gunmen immediately fled towards the direction of Macrohon town, it added.

Police collected 28 pieces of fired cartridges and one slug fragment in the scene.

A post mortem examination was also conducted.

Police are investigating the incident. (RONALD O. REYES)
