TACLOBAN CITY- Caroling and parties during this Christmas season have been banned in Leyte and Northern Samar provinces due to the pandemic caused by coronavirus disease (COVID-19). caroling and other Christ-

This was announced by Palo town Mayor Frances Ann Petilla, president of the Leyte Mayors' League, who said that the move is to address any further spread of COVID-19 across the province.

"We are expecting every Leyteño to understand and to follow the protocols as we continue our fight against the coronavirus," Petilla said.

Here in Tacloban City, the provincial capital of Leyte though not under the administrative control of the provincial government being a highly urbanized city, Mayor Alfred Romualdez issued an executive order which also prohibits

mas-related activities that could attract mass gatherings.

Tacloban is the only area in the region to be placed under a strict general community quarantine status until the end of the year due to its high number of COVID-19 cas-

Romualdez, however, said that COVID-19 cases in the city is now under control and declining for the past weeks now.

Other areas in the region have also made similar move like in Northern Samar where Governor Edwin Marino Ongchuan issued Executive Order 12see Leyte /page 14 ..

EDC-sponsored COVID-19 testing facility in Ormoc City gets green light from DOH

After months of anticipation and practice testing, Ormoc City's first own molecular diagnostic center at the **OSPA** Farmers Medical Center (OSPA-FMC) that was sponsored by Lopez-led geothermal leader Energy Development Corporation (EDC) is finally open to serve Ormocanons and nearby residents who need to get a COVID-19 **RT-PCR** test.

The center earned its accreditation from the Department of Health-Research Institute for Tropical Medicine and Philippine Health Insurance Corporation after passing all the necessary proficiency tests late last week.

The testing facility will now enable more timely reverse transcription polymerase chain reaction (RT-PCR) testing of COVID-19 swab samples to help stem its transmission, with results released within the day unlike before when it took up to ten days for Ormocanons to get them

from the nearest testing centers in Tacloban City.

OSPA-FMC is in charge of operating and maintaining the facility with the RT-PCR equipment worth almost P27 million that EDC has donated.

"We are glad that our joint project with the Ormoc City local government is finally operational and ready to help our fellow Ormocanons who badly need this testing facility to have a fighting chance against COVID-19," said Erwin

B. Magallanes, head of EDC's Corporate Social Responsibility team in Leyte. "Through our regenerative partnership and with everyone's observance of all the necessary health and safety protocols, we believe that our city of beautiful people will soon be COVID-19 free even before the release of a vaccine."

For EDC, regenerative partnerships are elevating about the state of everything they touch-whether iťs the environment, their communities, or other co-creators. It is crucial to fulfilling EDC and the Lopez Group's mission of forging collaborative pathways for a decarbonized and regenerative future.

EDC owns and operates the 714-megawatt Leyte geothermal facility, the company's biggest site that straddles between Ormoc City and the Municipality of Kananga and utilizes the largest known geothermal wet steamfield

in the world. In total, EDC generates over 40% of the Philippines' renewable energy output and serves about 10% of the country's overall electricity demand with its installed capacity of 1,499MW. Its 1,200MW geothermal portfolio accounts for 62% of the country's total installed geothermal capacity and has put the Philippines on the map as the world's third largest geothermal power producer. Yaokasin assures approval of P1.8 billion Tacloban budget for 2021 before the year ends

TACLOBAN CITY -The proposed P1.8 billion 2021 budget of this city would be approved before the end of this year.

This was assured by Vice Mayor Jerry 'Sambo' Yaokasin, presiding officer of the city council, who said that they will tackle the possible approval of the proposed city budget this Wednesday during their regular session.

During their last regular session last Dec. 3, the council deferred the approval of the city budget due to some discrepancies of some figures as well as with that of the annual investment plan (AIP) for 2021 amounting to P1.8 billion.

"Previously, we had received letter from the Department of Budget and Management on discrepancies on AIP and annual budget, and we don't want to commit the same mistakes again," Yaokasin said. Although, it may looks like the city council are already late in deliberating the budget, Yaokasin said that they will make sure to approve it before the year ends.

Once the AIP is approved, the city council will then deliberate on the floor the approval of the city's budget next year which also has the same figure of more than PhP1.8 billion.

Yaokasin said that they are optimistic that the budget will be approved before the end of this year because

the city council has not adapted a recess in their internal rule which means they will conduct session in the whole month of December.

The council has two to three remaining regular sessions before the end of 2021.

"We will need to deliberate the budget in the hall because the committee hearing for it was only done for a half-day," Yaokasin explained.

Under the proposed 2021 city budget of P1.8 billion, P498.76 was allocated to personnel services; P642.13 million for maintenance and operating expenses; P243.27 million for capital outlay; P80.85 million for debt servicing;P73.07 million for calamity funds; and P138,000 for aid to the barangays. Agreement on road safety advocacy campaign signed by Sirakwaraynon, IBP, LTO and PNP

TACLOBAN CITY -The Integrated Bar of the Philippines (IBP) - Levte Chapter, Land Transportation Office (LTO-8), Levte Police Provincial Office (LPPO), and the Sirakwaraynon Eagles Club, have joined forces to conduct a road safety campaign in the province.

A memorandum of agreement (MOA) was held Monday (Dec.7) by representatives of these entities held at the headquarters of the Leyte Police Provincial in San Jose district.

Present during the signing of the agreement were Police Lt. Guillermo Melo, Leyte police deputy director for administration; Edgar Octa, president of IBP-Leyte Chapter; Lidwino Macariola, assistant re-

gional director of LTO; LTO for the cancellation and Atty. Neil Sia, Sirakwaraynon Eagles Club president.

Under the MOA, Sirakwaraynon as the private sector lead convenor will be tasked to file complaints against traffic violators.

The list of violators will be provided by the LPPO and the LTO8 while the IBP-Leyte will provide legal assistance in filing complaints.

First to face complaint on traffic violation was the driver of the eight-wheeler wing van, identified by Tacloban City Police Office as Daniel Bulan, that was involved in a multiple vehicular accident last week in Sabang district of this city.

The group files a complaint against Bula at the of his driver's license.

'As a transportation lawyer, in the 1,000 vehicular accidents that happened in the past ten years, there are only five to 10 drivers whose license were cancelled or suspended after the victims filed a complaint," Sia said.

Sia added that even with the present problem on corona virus disease (COVID-19) pandemic, vehicular accident or road crash continue to happen because of reckless driving.

"Now with this MOA, the private sector will initiate move in filing complaints against irresponsible drivers,"he said.

Deaths due to COVID-19 in EV now at 96; latest to die from San Sebastian town

TACLOBAN CITY- Another patient of the coronavirus from Eastern Visayas had died due to the infection, raising its total deaths to 96.

The regional office of the Department of Health (DOH) said that the latest to have died due to complication of COVID-19 involved a 31-year old woman from San Sebastian in Samar province.

The woman died last December 6, the health agency said on Monday (Dec.7).

As this developed, San Sebastian Mayor Eleuterio Mabag issued a memorandum order on Monday stating for the temporary closure of their municipal building.

This after one of the employees was tested positive of coronavirus disease.

Mabag also said that the closure of the entire municipal building would be in effect until all the swab tests taken from direct contacts of the patients would be released.

The town has 19 COVID-19 cases since March of this year.

In Northern Samar, Governor Edwin Marino Ongchuan has also issued an order banning Christmas gatherings or parties in all government offices or agencies and local government to include barangays in the province as a way to avoid further spread of COVID-19.

Meantime, the DoH announced on Monday that the region has now 9,016 COVID-19 cases with 15 additional cases.

This change of attitude among our people is explained by so many reasons, one of which is the decline of excitement. Nothing about the virus surprises them anymore. It's not anymore big news, or talk of the town when someone is confirmed to be infected though that person is a celebrity or prominent enough. In other words, people no longer pay so much attention to the pandemic as something to dread about.

Another thing that has affected the people's vigilance and caution is the proliferation of alleged discrepancies in swab testing and other laboratory results. These include testimonies of people who had been swabbed twice in a few days



with differing results, of those who turned positive with no symptoms at all, of those who died of other ailments yet were declared to be positive, etc. Add to these the allegations that testing activities that eventually yield positive results are given cash incentives and the people just doubted all the more.

While people are starting to lose trust in legitimate results after learning further that attending health workers and hospitals receive more benefits when there are COVID 19 deaths, they are also developing confidence on what they've heard are effective antidotes for the virus. The warm water with salt used for gurgling or mouth wash, the steam inhalation for breathing, the lemon juice squeezed into an itchy or coughing throat, and some other home treatments have accordingly been working for them.

So now, whether the new number of cases is high or low doesn't matter to many people anymore because, in the first place, they no longer believe those results that much, nor scared of the prevalent virus. What they want is the normalcy of situations in society so they can restore their heavily paralyzed activities.

Duterte Anti-Red Task Force Seeking Ouster of Makabayan Bloc

What started as President Rodrigo Duterte's pronouncement on television, saying that "We not **Red-Tagging** are you; we are identifying you as "Communist Fronts...!"

The president continued by saying "the Armed Forces of the Philippines (AFP) is correct in identifying the left-wing groups as such -- as members in the grand conspiracy comprising all the legal (above-ground) fronts headed by the National Democratic Front or NDF.

Duterte added "Itong mga legal fronts ng mga komunista, lahat yan (These legal fronts of the communists, all of them) -- Makabayan Bloc etc, they are all legal fronts of communists!

On the other hand, National Security Adviser Hermogenes Esperon, vice-chair of the National Task Force to End Local Communist Armed Conflicts (NTF-ECLAC) declared that "as congressmen, the Makabayan Bloc members are government employees, who must be able to condemn the New Peoples Army or NPA; so they don't belong in Congress! But now, with the pronouncement from Malacanang, the governanti-communist ment's task force is now seeking the disqualification by the Commission on Elections (Comelec) of the left-wing Makabayan Bloc of lawmakers in the House of Representatives in future elections. Esperon added, "Our belief became stronger in that they should be gone and disqualified by Comelec, because of

their admission that they do not believe the New Peoples Army, which is the armed wing of the Communist Party of the Philippines (CPP) should be condemned for its violent actions against government forces.

The Makabayan Bloc at the House of Representatives is composed of Bayan Muna Representatives Carlos Zarate, Ferdinand Gaite and Eufemia Cullamat. ACT Teachers Representative France Castro, Gabriela Women's Party Representative Arlene Brosas and Kabataan Representative Sarah Elago.

At his weekly address a few days ago, President Rodrigo Duterte accused the activist party-list groups of being communist rebels themselves.

Duterte likewise questioned the ideology of communists; saying they no longer have any ideology.

He added, "these communists are nothing. They are only out to grab power. Yet they're stupidly following Sison," referring to exiled CPP founder Jose Maria "Joma" Sison.

Continuing, he said "You, Left-Wing groups are accusing us of red-tagging you? No!!!

The Armed Forces of the Philippines is correct. You are being identified as members of the Communist Party of the Philippines! We know, and that's the truth and we are not red-tagging." said the president.

His statements came after the daughter of Bayan Muna Representative Eufemia Cullamat, Jevilyn Cullamat, whom the military said was an NPA medic, was killed in an encounter between government soldiers and communist rebels in the hinterlands of Marihatag, Surigao del Sur province a few days ago.

3 women nabbed for selling agarwood in Leyte

TACLOBAN CITY-Three women were arrested after they allegedly sold agarwood wedges, locally known as "lanete/lapnisan," to an undercover police operative in Abuyog, Leyte last December 4.

Police said the suspects, aged 45, 40, and 28, were residents of Barangay New Taligue, Abuyog.

Two of the suspects are plain housewives while the other is self-employed, police said.

Recovered from suspects' possession were agarwood wedges weighing around 1.2 kilograms with an estimated market value of P70,000, and boodle money composed of 50 pieces of P1,000 bill and one original P1,000 bill used in the entrapment operation.

The arrested suspects were brought to Abuyog Municipal Police Station for proper documentation.

Police also coordinated with the Municipal Environment and Natural Resources Office (Menro) in Abuyog for the identification of the recovered wood species.

ORDINANCE NO. 11 Series of 2019

AN ORDINANCE PROVIDING FOR A COMPREHENSIVE CHILDREN'S WEL-FARE CODE IN THE MUNICIPALITY OF MONDRAGON, PROVINCE OF NORTHERN SAMAR.

WHEREAS, the Philippine Government is a signatory to the United Nation Convention on the Rights of the Child (UNCRC). World Declaration on the Survival, Development, Protection and Participation of the Children; thus the state shall defend the rights of the children to assistance including special protection from all forms of neglect, abuse, exploitation and other conditions prejudicial to their development, proper care, nutrition and education;

WHEREAS, the Local Government Code of 1991 states that municipalities shall exercise and discharge its powers, functions and responsibilities appropriate or incidental to the efficient and effective provision of basic services and facilities, which includes among others, programs and projects on child and youth welfare.

WHEREAS, the Municipality of Mondragon recognizes that children are important assets of our society and there is a need to coordinate existing government agencies and non-government agencies in providing quality life to children of Mondragon.

WHEREAS, the passage of this ordinance will strengthen the child-sensitive and child friendly programs and services being implemented in the municipality and eventually improve the present state of the children and eliminate traditional practices which tend to violate children's rights;

WHEREAS, in keeping with its duties and commitment to uphold the rights and well-being of children, the Municipality of Mondragon deems it necessary to adopt measures and address these needs.

NOW THEREFORE, BE IT ENACTED by the Sangguniang Bayan of Mondragon in Session assembled that:

ARTICLE I

TITLE, POLICY, PRINCIPLES AND DEFINITION OF TERMS

SECTION 1. - TITLE. - This ordinance shall be known as the "Mondragon Comprehensive Children's Welfare Code";

SECTION 2. DECLARATION OF POLICY AND PRINCIPLES.

(a) Mondragon is hereby declared as a Child Friendly Municipality. As such it is the policy of the Municipal Government that the rights of the children for survival, protection, participation and development of their full potentials be given priority. It shall support the role of the family in providing for their children, and promote the efforts of parents, other child care and development workers, POs, NGOs and communities to nurture and care of children. Consistent herewith the Municipal Government shall endeavor to strengthen the establishment of a comprehensive children and family support system in the entire municipality and enjoin all the efforts of both the public. POs. NGOs and the private sector to achieve the goals for the survival. protection, development and participation of children.

Furthermore, it shall ensure that all programs aimed at achieving the goals for survival, protection, development and participation of children are given priority when resources are allocated, thus exerting all efforts to ascertain that these programs are protected in times of economic austerity and tructural adjustments

SECTION 3. - DEFINITION OF TERMS. - The following terms used and defined in this Ordinance shall mean:

ORDINANCE

a. "CHILDREN" refer to persons below eighteen (18) years of age or persons over eighteen years of age but are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation and discrimination because of physical or mental disability or condition;

b. "CHILD ABUSE" refers to the maltreatment, whether habitual or not, of the child, which includes any, of the following:

(1) Psychological and physical abuse, neglect, cruelty, sexual abuse and emotional maltreatment;

(2) Any act by deeds or words which debases, degrades or demeans the intrinsic worth and dignity of a child as a human being;

(3) Unreasonable deprivation of his/her basic needs for survival, such as food and shelter. or

(4) Failure to immediately give medical treatment to an injured child resulting in serious impairment of his/her growth and development or his/her permanent capacity or death.

c. "SURVIVAL RIGHTS" the rights of the children to demand from the state, their parents or legal guardians for adequate living standard, access to basic health services and social security:

d. "DEVELOPMENTAL RIGHTS" pertain to the access of the child to educational opportunities, relevant information, play, leisure, cultural activities and the right to freedom of thought, conscience and religion;

e. "PROTECTION RIGHTS" are those rights of children to be protected against all forms of child abuse, exploitation and discrimination in situations where the children are considered in extremely difficult circumstance;

f. "PARTICIPATION RIGHTS" are those rights the children asserts as described in the 1989 UN Convention for the Rights of Children which says that the children have the freedom to express themselves on matters affecting his or her life.

g. "SPECIAL CONCERN" are circumstances which gravely threaten or endanger the survival and normal development of children include, but are not limited to the following:

1. Being in a community where there is armed conflict or being affected by armed conflict-related activities;

2. Working under conditions hazardous to life and morals which unduly interfere with their normal development or working without provisions for their education;

3. Living in or fending for themselves in the streets without the care of parents or guardians or any adult supervision needed for their welfare;

4. Being a member of an indigenous cultural community and/or living under conditions of extreme poverty or in an area which is underdeveloped and lacks or has inadequate access to basic services needed for a normal guality of life:

5. Being with family members or guardians having psychological problems grave enough for them to commit incest, siblings" rape, lascivious acts and other forms of physical and mental abuse;

6. Being a victim of man-made or natural disaster or calamity;

7. Being a victim of an illegal transnational union or child trafficking;

8. Recruitment of children in the Armed Forces of the Philippines, its civilian units or OTHER ARMED GROUPS:

9. Circumstances analogous to those above stated circumstances that endanger the life, safety or normal development of children.

h. "COMPREHENSIVE CHILDREN'S SUPPORT SYSTEM AGAINST CHILD ABUSE, EXPLOITATION AND DISCRIMINATION" refers to the coordinated program of services and facilities to protect the children against:

- 1. Child prostitution and other sexual abuse;
- 2. Child trafficking;
- Obscene publications and indecent shows;
- Exploitation; 4.
- 5. Other acts of abuse;

6. Circumstances that treated or endanger the survival and normal development of children as prescribed in the 1989 UN Convention of the Rights of the Child.

i. "Child At risk" refers to a child who is vulnerable to and at risk of committing criminal offenses because of personal, family and social circumstances, such as, but not limited to, the following:

(1) Being abused by any person through sexual, physical, psychological, mental, economic or any other means and the parents or guardian refuse, are ng, or unable provide protection for the child

3. Selling or distribution of lewd/obscene reading materials;

4. Pimping for young and adult prostitutes, sexual perversions and doing or participating in obscene shows;

- 5. Gambling of any form;
- 6. Rape and incest: and

7. All other circumstances as defined in the existing laws.

I. "BENEFIT DANCE" refers to the exploitative dance promoted in the locality wherein young girls or boys who are tagged as benefit dancers are being offered to dance with any partner upon payment of a certain price.

m. "CULTURALLY RELATED ACTIVITIES" refer to activities showcasing the Filipino culture and tradition such as but not limited to the following:

- 1. Ethnic Dance
- 2. Historical drama
- 3. Folk dancers and
- 4. Others

n. "DAY CARE" is the provision of substitute parental care and stimulating activities for the total development of children up to five(0-5) years old when their parents are unable to take care of them during part of the day because of work and some other situation.

o. " CHILD DEVELOPMENT CENTER" is a facility where day care services are provided by an accredited child development worker particularly for children in form three to five(3-5) year of age brackets;

p. "CHILD IN CONFLICT WITH THE LAW" refers to a child who is alleged as, accused of, or adjudged as having committed an offense under Philippine laws:

q. "JUVENILE JUSTICE AND WELFARE SYSTEM" refers to a system dealing with children at risk and children in conflict with the law, which provides child appropriate proceedings, including programs and services for prevention, diversion, rehabilitation, re-integration and aftercare to ensure their normal growth and development.

r. "DIVERSION" refers to an alternative, child-appropriate process of determining the responsibility and treatment of a child in conflict with the law on the basis of his/her social, cultural, economic, psychological or educational background without resorting to formal court proceedings.

s. 'DIVERSION PROGRAM" refers to the program that the child in conflict with the law is required to undergo after he/she is found responsible for an offense without resorting to formal court proceedings.

t. "BAHAY PAG-ASA" refers to a 24-hour child-caring institution, funded and managed by local government units(LGUs) and licensed and/or accredited non-government organizations(NGOs) providing short term residential care for children in conflict with the law who are above fifteen(15) but below eighteen(18) years of age who are awaiting court disposition of their cases or transfer to other agencies or jurisdiction.

u. "MULTI-DISCIPLINARY TEAM(MDT)" shall refer to a team composed of social worker, a psychologist/mental health professional, medical doctor, an educational/ guidance counselor and a Barangay Council for the Protection of Children(BCPC) member. The team will work on the individualized intervention plan with the child and the child's family.

v. "CHILD TRAFFICKING" shall refer to the recruitment, transfer or deployment of a child and/or harboring or receipt of a child with or without the victim's consent or knowledge, through legal or illegal means, fraud or deceit, violence, coercion, intimidation, abuse of position or authority;

w. "CHILD PORNOGRAPHY" refers to any representation, whether visual, audio or written combination thereof, by electronic, mechanical, digital, optical, magnetic or any other means, of child engaged or involved in real or simulated explicit sexual activities.

x. "BULLYING" refers to any severe or repeated use by one or more students of a written, verbal or electronic expression, or a physical act or gesture, or any combination thereof, directed at another student that has the effect of actual

y. "SPECIAL EDUCATION" refers to the education of persons who are gifted or talented and those who have physical, mental, social or sensory impairment and cultural differences so as to require modification of the school curricula, programs and special services and physical facilities to develop them to their maximum capacity.

ARTICLE II

RIGHTS AND RESPONSIBILITIES OF THE CHILD

SECTION 4: All children shall be entitled to the rights herein set forth without distinction as to legitimacy or illegitimacy, sex, social status, religion,

Reiterates its adherence to the general principles provided for in (b) the 1987 Constitution that lays down in broad stroke the State's responsibility to the rights and welfare of children in favor of their development, and as such, the local government of Mondragon shall give utmost priority for its local execution in terms of programs and projects for that purposes;

Adheres to the general framework the 1989 UN Convention of the Rights of the Child which provides among others four general principles as follows:

c.1 In all actions concerning children, whether undertaken by the public or private social welfare institutions, courts of law, administrative authorities or legislative bodies, the best interests of the child shall be a primary consideration;

c. 2 The States parties are required to "assure the child who is capable of forming his or her own views the right to express those views freely in all matters affecting the child, the views of the child being given weight in accordance with the age of maturity of the child";

c. 3 The third principle is that of the survival and development of the child. "Survival" is an amplification of the right to life. The term "development" relates to the individual child and should be interpreted in broad sense. It adds a qualitative aspect to the right to life and implies that law, policy and administrative action must look beyond the physical survival of the child to issues of cognitive, emotional, social and cultural development;

c.4 The fourth principle is the non-discrimination of children.

(2) Being exploited through online sexual exploitation (3) Coming from a dysfunctional family (4) Being an out of school youth (5) Being a street child (6) Being member of a gang; (7) Living in a community with high level of criminality or drug abuse; and

j. "COMPREHENSIVE PROGRAM FOR CHILDREN IN NEED OF SPECIAL PRO-TECTION (CNDP)" refers to the coordinated program of services and facilities to protect children:

1. Children in worst form of child labor

(8) Living in a situation of armed conflict.

2. neglected and abandoned children

3. Child prostitution and other sexual abuse;

4. Child trafficking and or commercial sexual exploitation of children

3. Obscene publications and indecent shows;

4. Children in various forms of disability;

5. children in situation of armed conflict

6. victim of child abuse

7. circumstances which threaten or endanger the survival and normal development of children.

k. "ANTI-SOCIAL RELATED ACTIVITIES are those acts against property, chastity and person which include but are not limited to the following:

1. Petty crimes such as snatching, shoplifting, misrepresentations;

2. Using and pushing prohibited drugs;

1. Every child is endowed with the dignity and worth of a human being from the moment of his conception, and therefore has the right to be protected from this time.

2. Every child has the right to a family life that will provide him with love care, understanding, guidance and material security.

3. Every child has the right to a well-rounded development of his personality to the end that he may become a happy, useful and active member of society

4. Every child has the right to a balanced diet, adequate clothing, sufficient shelter, proper medical attention, and all the basic physical requirements of a healthy and vigorous life.

5. Every child has the right to be brought up in an atmosphere of morality and rectitude for the enrichment and the strengthening of his character.

6. Every child has the right to an education commensurate with his abilities and to the development of his skills for the improvement of his capacity for service to himself and to his fellowmen.

7. Every child has the right to full opportunities for safe and wholesome recreation and activities, individual as well as social, for the wholesome use of his leisure hours.

8. Every child has the right to protection against exploitation, improper influences, hazards, and other conditions or circumstances prejudicial to his

physical, mental, emotional, social and moral development.

9. Every child has the right to live in a community and society that can offer him an environment free from pernicious influences and conductive to the promotion of his health and the cultivation of his desirable traits and attributes.

10. Every child has the right to care, assistance, and protection of the State, particularly when his parents or guardians fail or are unable to provide him with his fundamental needs for growth, development and improvement.

11. Every child has the right to an efficient and honest government that will deepen his faith in democracy and inspire him with the morality of the constituted authorities both in their public and private lives.

12. Every child has the right to grow up as a free individual, in an atmosphere of peace, understanding, tolerance, and universal brotherhood, and with the determination to contribute his share in the building of a better world.

13. In no case, shall those exercising parental authority, inflict corporal punishment over the child (Art. 233, FC).

SECTION 5: Responsibilities of the Child: Every child regardless of the circumstances of birth, sex, religion, social status, political antecedents and other factors, shall:

a. Strive to lead an upright and virtuous life in accordance with the tenets of his/her religion, the teaching of his/her elders and mentors, and the bidding of a clean conscience;

b. Love, respect and obey his/her parents and cooperate with them in the strengthening of the family;

c. Extend to his/her brothers and sisters love, thoughtfulness and helpfulness and endeavor with them to keep the family harmonious and united:

d. Exert his/her utmost effort to develop his/her potentials for services; particularly by undergoing a formal education suited to his/her abilities, in order that he/she may become an asset to himself/herself and to society; Respect not only his/her elders but also the traditions and costumes of his/her people, the memory of his/her people's heroes the duly constituted authorities, the laws of the country and the principles and the institutions of democracy;

e. Actively participate in the civil affairs and in the promotion of the general welfare, recognizing that it is the youth who will eventually be called to discharged the responsibility of leadership in shaping the nation's future' and

f. Help in the observance of the individual human rights, strengthening of freedom everywhere, the fostering of cooperation among nations in the pursuit of their common aspiration for unity and prosperity and the furtherance of world peace

ARTICLE III

SURVIVAL AND DEVELOPMENT RIGHTS OF CHILDREN

SECTION 6. - GENERAL FRAMEWORK. - The development and survival of children are determined by both external and internal factors, so that, it is the shared responsibility of the parents, siblings, and relatives which shall be known as the internal factor and the State, civil society, and community which shall be known as the external factor to provide the necessary environment, support, assistance and other initiatives to make children responsive and productive members of the society.

SECTION 7. - The local government of Mondragon, representing the State, shall ensure, to the maximum extent possible, the survival and development of the child by providing facilities, programs and projects for the purpose and at the same time facilitate and mobilize the civil society and the community to reinforce and strengthen the initiatives for the general welfare of the children.

SECTION 8. - The local government of Mondragon shall establish the following programs, projects and initiatives to contribute to the survival and development of the children.

a. **Maintain monitoring of registration of births.** The parents shall cause the early shall cause the early registration of the child with the Office of the Local Civil Registrar of the Municipality. In coordination with the barangays, the municipality shall implement Barangay Civil registration System(BCRS) pursuant to Act Number 3753 of the Civil Registry law in order to promote effective and efficient registration of births and other vital events.

b. **Implement Maternal and Child Health Care and Nutrition Program.** The Local Government of Mondragon shall strengthen the implementation of primary health care and nutrition program that cater to the health of the mother in her pre-natal period to ensure the healthy delivery of a child; and after post-natal period as the same program be provided throughout the early childhood years. The following programs may include in the implementation:

b.1 WOMEN'S HEALTH AND SAFE MOTHERHOOD PROGRAM.

The program shall ensure development with the proper nutrition, health and well-being of the pregnant mother. It may also include a program that would improve access to health facilities with basic emergency obstetric care.

depend on the population level of the community as prescribed under the act.

The Local Government Unit of Mondragon shall adopt Republic Act 8980 otherwise known as the Early Childhood Care and Development Programs (ECCD) and provides funds to initiate care and development programs of children below six (6) years old through the establishment of home based ECCD Programs in the form of, but not limited to SUPERVISED NEIGHBORHOOD PLAY in all barangays such as Barangay Day Care Service Program and the National Pre-School Education Program.

c.1) Day Care Worker. A day care worker or child development worker who have rendered ten(10) years and above in the service with good standing shall not be removed from the service unless he/she voluntarily resigned from the position or has committed unlawful act which can prejudice his/her integrity as Day Care Worker/Child Development worker.

d) Role of Primary Health Care Program in Children's Health. - The promotion of primary health care program in the barangays shall give specific emphasis on monitoring the children's health, as such, a barangay child health officer shall be employed of which a salary commensurate to the assigned task will be paid.

To ensure the implementation of the Primary Health Care Program gives specific emphasis on children's health, the following strategies shall be pursued:

d.1. Apply readily available technology and provide adequate nutritious food and safe drinking water in connection with the health programs intended for the children.

d.2. Establish a comprehensive Parent's Orientation Development Program which include courses on reproductive health, child health and child rearing practices in the context of Filipino psychology;

d.3. Conduct massive information and education campaign on breast-feeding at the community level, school and LGU level. Whenever possible, the students in all levels shall be required to take breastfeeding course which shall be integrated in the curricula.

e.) Parenting Orientation Course a Requirement for Marriage License-Marriage license applicants shall be required to attend in the Parenting Orientation Course I, among other requirements, prior to the issuance of marriage license by the Civil Registrar. This course becomes an integral part of existing Family Training Seminar on Reproductive Course Council, in close coordination with the Municipal Health Office and the Civil Registry Office, shall upgrade the Family Planning Seminar in cognizance of this ordinance.

Parent-applicants for birth certificates of their first-born child(ren) shall be required to participate in Parenting Orientation course II, as a follow-up to the first course, before issuance of Certificate of Live Birth by the civil Registrar without prejudice to the early registration of birth requirement under existing laws.

Modules for these courses shall be designed by the Municipal Social Welfare and Development Office in close coordination with an NGO child focused program.

f.) Family and Community Welfare Support. The Municipal government shall implement and sustain Family Community Welfare Support system for children. The following programs shall form part of the Family and Community Welfare Program which this government shall zealously support;

f.1. Child and Youth Welfare Program. The Municipal government shall establish and support the program which shall include the services such as peer group service, community based services for street children, community based services for child in conflict with the law and services for children in especially difficult circumstances and among other,

f.2. Women Welfare Program. The Municipal government shall recognize the roles of women in the formation of the society as well as the child hence, it shall establish and support a Women Welfare and Development Program, which shall include courses and services such as self-enhancement skills development, maternal and child care, skills training for employment and livelihood support, among other.

f.3. Nutrition Program. The Municipal government shall establish a growth and nutritional monitoring and nutritional feeding and supervision of nutritional intake of children at home and in school. This program shall be under the administration and supervision of the Municipal Health Office. The program on nutrition shall include a monitoring and evaluation system, which shall be established by the said office.

g.) Female Functional Literacy and Enhanced Child Growth.

The program shall improve the health caring and seeking behaviour among families of the poor, vulnerable and hard to reach population with the aim to empower women by improving literacy among them as mothers and caregivers.

h.) Foster Care Program

The Local Government Unit of Mondragon shall adopt R.A. 10165 for the best interest of the child who is neglected, abandoned, orphaned and victim of other circumstances to be under the care of a licensed foster home and foster family or an alternative family care. LGU Mondragon in its effort to established a community based strategy for the protection of child shall endeavor to institutionalize the foster homes for children with the technical assistance of the Department of Social Welfare and Development Regional Office VIII.

SECTION 10. – PROGRAM ON CHILD ABUSE, EXPLOITATION AND DIS-CRIMINATION There shall be a comprehensive program to be formulated by the Municipal Social Welfare and Development Office and the Local Council for the Protection of Children after consultation with other government agencies, private sector, non-government organizations and child welfare institutions that are concerned with protection and development of children's rights and welfare.

g

SECTION 11. - CHILD PROSTITUTION AND OTHER SEXUAL ABUSE. - Children, whether male or female, who for money, profit or any other consideration or due to the coercion or influence of any adult, syndicate or groups, indulge in sexual intercourse or lascivious conduct, are deemed to be children exploited in prostitution and other sexual abuse.

The penalty as prescribed in Section 5 of RA 7610 shall be imposed upon the following:

a. Those engage in or promote, facilitate or induce prostitution which include, but are not limited to the following:

1. Acting as procurer of a child prostitute by means of written or oral advertisements or other similar means;

Inducing a person to be a client of a child prostitute by means of written or oral advertisements or other similar means;

3. Entering into relationship with or taking advantage of a child as prostitute;

4. Threatening or using violence towards a child to engage him or her as a prostitute or participants in indecent shows;

5. Giving monetary consideration, goods or other pecuniary benefit to a child with the intent to engage in child prostitution.

b. Those persons who commit the act as stated in Article III of republic Act 7610 shall be penalized accordingly as prescribed therein.

SECTION 12. - OBSCENE PUBLICATION AND INDECENT SHOWS. - Any person who shall hire, employ, use, persuade, coerce or force a child, whether live or in video, to pose or model in obscene publications or pornographic materials shall suffer the penalty prescribed in RA 7610 in so far or it is applicable.

SECTION 13. Sanctions for Establishment or Enterprises which Promote, Facilitate or Conduct Activities Constituting Child Prostitution and Other Sexual Abuse, Child Trafficking, Obscene Publications and Indecent Shows.

All establishments or enterprises that promote, facilitate child prostitution and sexual abuse and exploitation, trafficking, obscene publications and indecent shows, and other acts of abuse shall be immediately closed and their authority or license to operate cancelled, without prejudice to the owner or manager thereof being prosecuted under the ordinance. A sign that says: "CHILD RIGHTS VIOLATOR" will be conspicuously posted outside the establishment(s) or enterprise(s).

SECTION 13-A. - REQUIREMENT OF ESTABLISHMENT TO POST NOTICES AGAINST CHILD ABUSE. - All establishments such as Hotels, Sauna Baths, Motels and Nightclubs shall be required to post notices against child abuse as requisite to renewal/approval of business license.

SECTION 14. - CHILD TRAFFICKING. - Any person who shall engage in trading and dealing with children including, but not limited to, the act of buying and selling of a child for money, or for any other consideration or barter, shall suffer the penalty as prescribed in Article IV of the Republic Act No. 7610.

SECTION 15. - ATTEMPT TO COMMIT CHILD TRAFFICKING. - There is an attempt to commit child trafficking under Section 8 of this Ordinance:

a. When a child, below 15 years old, travel alone to or from Mondragon without clearance issued by the Municipal Social Welfare and Development Office of Mondragon or written permit or justification from the child's parents or legal guardian; Written permits issued should be attested by the Punong Barangay.

b. When a pregnant mother, father or guardian executes an affidavit of consent for adoption for a consideration; or consents, participates or in any manner causes the registration of the birth of such child in the name of another with or without consideration;

c. When a person, agency, establishment or child-caring institution recruits women or couples to bear children for the purpose of child trafficking;

d. When a doctor, hospital or clinic official or employee, nurse, midwife, local civil registrar or any other person stimulates birth for the purpose of child trafficking;

e. When a person engages in the act of finding children among low-income families, hospitals, clinics, nurseries, day-care centers or other caring institutions who can be offered for the purpose of child trafficking; or

b.2 CHILD HEALTH AND NUTRITION PROGRAM.

This program shall provide proper nutrition and complete timely immunization, as safe as safe water for the under-five children for their proper growth and development.

b.3 MALNUTRITION/UNDERNUTRITION AND MICRONUTRIENTS DEFI-CIENCY PROGRAM.

The program shall be implemented to protect women and children from the dangers and consequences of the dreaded micronutrients deficiency, particularly Vitamin A deficiency, iron deficiency, anemia and iodine deficiency. The implementation of R.A. 8976 "THE PHILIPPINE FOOD FORTIFICATION ACT of 2000" be enforced to address the problem of micronutrients deficiency. As well, the SUPPLEMENTAL FEEDING program be one of the priority programs of the local government to address the malnutrition problem in the locality.

c) Early Childhood Care and Development Program and Day Care Service Program

The R.A. 6972, an act establishing a DAY CARE CENTER and instituting a total development and protection of children program be sustained its implementation. Thus, DAY CARE CENTERS shall be set up in 24 barangay to serve children from two (2) to four (4) years and 11 months old which shall

i.) Out-of-School Youth Program.

The Local Government Unit of Mondragon shall develop programs such as youth camps, leadership training, disaster related activities, alternative literacy programs and technical skills training for the out-of-school youth and other disadvantaged youth in coordination with the Department of Education, Technical Education Skills Development Authority and other national government and non-government agencies and organizations. This aims to help and assist youths re-integrate to the regular school programs and for them to acquire skills and knowledge that would help them become self-reliant, economically productive and socially responsible citizens.

SECTION 9. TRAINING PROGRAMS FOR SERVICE PROVIDERS FOR THE SPE-CIAL PROGRAM ON CHILDREN WITH SPECIAL NEEDS.

The training program shall be part of the priority program of the Local Government for the service providers of the special programs, projects and activities for children and to be funded locally, and or in partnership with other national agencies, provincial government and non-government organizations.

ARTICLE IV

PROTECTION RIGHTS OF CHILDREN

f. When any person, authority, agency or institution witnesses who have knowledge but fails to report, transactions related to circumstances in child trafficking.

The penalty prescribed in Article IV of Republic Act No. 7610 in so far as it is applicable shall be imposed upon the principals of the attempt to commit child trafficking under this ordinance. In addition, a one-month community service shall be imposed for the commission and omission of acts under Section 8. Such service shall be defined by the Municipal Council for the Protection of Children.

SECTION 16. - OTHER ACTS AND/OR CONDITIONS PREJUDICIAL TO THE CHILD'S DEVELOPMENT. - It shall be unlawful for any person to sell liquor, cigarette, illegal drugs and other items detrimental to the development of the child.

For the purpose of this ordinance, the penalty for commission of such act as prescribed in Article IV of Republic Act No. 7610 in so far as it is applicable shall be entrusted to the care of the Municipal Social Welfare and Development.

SECTION 17. All establishment selling liquors or cigarettes shall be required to post notices or warning signs that ban selling of liquor and cigarettes to children as a condition for the approval/renewal of their business license.

SECTION 18 - REGULATION ON CHILDREN'S EXPOSURE TO COMMER-

CIAL VIDEO GAMES. - Commercial establishments which business involved renting of electronic video games are prohibited from catering to children

during school days from 7:00 o'clock in the morning to 5:00 o'clock in the afternoon. Business permit(s) concerned commercial establishment(s) who violate the prohibition shall subjected to suspension for fifteen (15) days during the first offense and one (1) month suspension of the same for the second offense.

SECTION 19: CHILD PORNOGRAPHY.—The following are prohibited acts enumerated under RA. 9775 or the Anti-Child Pornography Act of 2009.

1.) To hire, employ, use, persuade, induce or coerce a child to perform in the creation or production of any form of child pornography;

2.) To produce, direct, manufacture or create any form of child pornography

 To publish offer, transmit, sell, distribute, broadcast, advertise, promote, export or import any form of child pornography;

4.) To possess any form of child pornography with the intent to sell, distribute, publish, or broadcast: Provided: that possession of three(3) or more articles of child pornography of the same form shall be prima facie evidence of the intent to sell, distribute, publish or broadcast

5.) To knowingly, willfully, and intentionally provide a venue for the commission of prohibited act as, but not limited to, dens, private rooms, cubicles, cinemas, houses or in establishments purporting to be legitimate business

6.) For film distributors, theaters and telecommunications companies, by themselves or in cooperation with other entities, to distribute any form of child pornography;

7.) For a parent, legal guardian or person having custody or control of a child to knowingly permit the child to engage, participate or assist in any form of child pornography

8.) To engage in the luring or grooming of child

9.) To engage in pandering of any form of child pornography

10.) To willfully access any form of child pornography

11.) To conspire to commit any of the prohibited acts stated in this section. Conspiracy to commit any form of child pornography shall be commit-

ted when two(2) or more persons come to an agreement concerning the commission of any of the said prohibited acts and decide to commit it; and 12.) To possess any form of child pornography.

SECTION 20. EMPLOYMENT OF CHILDREN.- No child below fifteen (15) years of age shall be employed or allowed to work, except when he works directly under the sole responsibility of his parents or guardian, and his employment or work does not in any way interfere with his schooling, or is non-hazardous to him/her. In any of these exceptions, the employer, parent or guardian shall secure first the working child permit before such child is allowed commence work, usually on a short term and per project basis in a family undertaking or business establishment.

A *non-hazardous work* is one where the employee or worker is not exposed to any risk which constitutes an imminent danger to his life, safety, health and morals.

a.) Cases involving working children shall be dealt with pursuant to Republic Act 9231 and other pertinent national statues;

b.) Children found working in violation of the above provision shall immediately be rescued and provided with appropriate intervention as provided in the Comprehensive Program for Children in Need of Special Protection(CNSP).

SECTION 21. The Local Government Unit of Mondragon through the Municipal Social Welfare and Development Office shall intervene in behalf of the child when the parent, guardian, or person having custody of the child fails or is unable to protect the child against abuse, exploitation and or any form of violence.

SECTION 22.- ESTABLISHMENT OF CHILD PROTECTION UNIT (CPU)- To provide child-friendly facility where forensic interview and medical examination/treatment are conducted. This facility can be the site for team meetings. The CPU will be managed by the Local Multi-Disciplinary Team(MDT). This is a team of caring people who will plan, organize and initiate delivery of appropriate services to CNSP in an integrated and systematic manner. The management of the cases are done in a multidisciplinary team approach, that is collaborative assessment, collaborative planning, implementation, monitoring, evaluation, termination, advocacy and resource mobilization. The MDT shall be composed of LGU trained and experienced social worker that specializes on child abuse cases, trained Municipal Health Officer, trained Women and Children Protection Desk(WCPD) Officer , other relevant stakeholders.

SECTION 23. - CHILDREN INVOLVED IN ANTI-SOCIAL AND RELATED AC-TIVITIES. - Children who are involved in anti-social or related activities shall be registered in the rehabilitation program that shall assist the children to rebuild themselves and reintegrate them to the mainstream of society.

SECTION 24. BULLYING- As enumerated under R.A. 10627 or the Anti-Bullying Act of 2013, the following are acts of bullying:

 Any unwanted physical contact between the bully and the victim like punching, pushing, shoving, kicking, slapping, tickling, headlocks, inflicting school pranks, teasing, fighting and the use of available objects as weapons:

2.) Any act that causes damage to a victim's psyche and/or emotional

SECTION 28. REPORTING AND COVERING OF CASES INVOLVING CHILDREN.

The media practitioners have the duty to maintain the highest and ethical and professional standards in reporting and covering cases of children and should observe that in publicity concerning, the best interest of the child shall be thee primordial and paramount concern.

Media practitioners shall at all times adhere to the Department of Justice Guidelines for Media Practitioners on the Reporting and Coverage of Cases Involving Children.

SECTION 29. - CURFEW FOR MINORS. - To protect the children from harm, exploitation and criminal elements, a curfew shall be imposed on them from 9:00 p.m. to 4:00 a.m. During these hours, the children are prohibited from loitering around the town or sleeping in public places. Unless justified and accompanied by parents, legal guardian(s) or adults and the condition in which the presence of the children does not constitute child trafficking, prostitution and other unlawful activities, this provision will not apply.

The penalty for violating this provision for the first offense shall be imposed on the parents and legal guardians that will constitute of a one-day seminar on the duties and responsibilities in child rearing and caring.

For second-time offender(s), a 15-day community service or as determined by the court shall be imposed on parents and legal guardians.

SECTION 30. OTHER ACTS OF NEGLECT, ABUSE, CRUELTY OR EXPLOITATION AND OTHER CONDITIONS PREJUDICIAL TO THE CHILD'S DEVELOPMENT-Any person including the parents of a child who shall use, coerce, force or intimidate a child or any other child to:

(a) conceal or abandon the child with intent to make such child lose his/ her civil status

(b) abandon the child under such circumstances as to deprive him/her of the love, care and protection he/she needs;

(c) sell or abandon the child to another person for valuable consideration (d) neglect the child by not giving him/her the education by which the family's status in life and financial condition permit

(e) fail or refuse, without justifiable grounds to enroll the child as required by law;

(f) cause, abate or permit the truancy of the child from the school where he/she is enrolled, "truancy" as used here means absence without cause for more than twenty(20) school days, not necessarily consecutive

(g) exploit the child by using her/him, directly or indirectly such as for purposes of begging and other acts which are inimical to his/her interest and welfare:

(h) inflict cruel and unusual punishment upon the child or deliberately subject him/her to indignations and other excessive chastisement that embarrass or humiliate him/her.

(i) cause or encourage the child to lead the immoral or dissolute life

(j) permit the child to posses, handle or carry a deadly weapon, regardless of its ownership

(k) allow require the child to drive without license or with a license which the parent knows to have been illegally procured;

(I) cause or allow a child to act as conduit or middlemen in drug trafficking or pushing, and cause the child to participate directly in the conduct of illegal activities shall be penalized.

ARTICLE V

PARTICIPATION RIGHTS

SECTION 31. The Local Government Unit of Mondragon shall encourage and promote the participation of children and youth in socio-cultural and community development activities. It shall also support culturally-relevant activities that will showcase the province and municipality culture and tradition thereby making the children and youth aware of the history.

SECTION 32. - PARTICIPATION OF CHILDREN IN DECISION-MAKING PRO-CESS. - In deciding what is in a child's best interests, the child's own views must be considered where the child is able to express these. Thus, this ordinance reiterates the second principle stated in 1989 UN Convention on the Rights of the Child that the State' assure to the child who is capable of forming his or her own views the right to express those views freely in all matters affecting the child, the views of the child being given due weight in accordance with the age and maturity of the child'. This principle tends to be viewed somewhat simplistically, and it will be important for any new legislation pertaining to children in Mondragon to ensure that ample opportunity is given for children to participate meaningfully in decisions affecting them.

SECTION 33. MONDRAGON YOUNG ARTISTS ORGANIZATION

The Municipal Office of Tourism shall initiate the formation of the Mondragon Young Artist s Organization that will serve as venue of talented and gifted children to hone their skills and make them excel in their chosen fields. Relative to this a periodic workshop on theatre arts shall be conducted to enhance their inherent talent and skills. A Culture and the Arts Officer shall be designated as a focal person in charge of trainings and similar activities relative to the promotion of the Mondragon culture and heritage, and shall prepare the necessary plans, programs and activities for inclusion in the annual investment SECTION 37-A MEMBERSHIP OF THE LOCAL COUNCIL FOR THE PROTEC-TION OF CHILDREN. SECTION 38. FUNCTIONS OF THE LCPC. The following shall be the functions of the LCPC of Mondragon.

1. Formulate the Municipal Action Plan for Children, incorporating the projects and programs needing assistance by the barangay, and ensure its integration into the Municipal Development Plan.

 Monitor and Evaluate the Municipal and Barangay development plans
 Submit semi-annual status report on the plan and implementation to the Provincial Council for the Protection of Children(PCPC)

4. Promptly address issues and concerns affecting children and youth

SECTION 39. POLICIES, PLANS AND BUDGET.

(a) Policies shall be formulated and recommended for executive or legislative action through resolutions and shall be needs based/demand driven.

(b) The LCPC shall pass a resolution adopting the PPAs on children for integration to the LGU development plan.

(c) LCPC's Annual Work and Financial Plan(AWFP) shall be submitted to the LCE before the schedule of budget preparation to ensure funding of the Council's PPAs. It shall be incorporated in the Local Development Investment Plan/Annual Investment Program.

SECTION 40. CHILDREN'S MONTH CELEBRATION. Pursuant to RA 10661 declaring the month of November every year as National Children's Month,

The Municipal Council for the Protection of Children shall conduct child-focused activities promoting the rights and responsibilities of Filipino children specifically in the Municipality of Mondragon.

ARTICLE VII

PROHIBITED ACTS

SECTION 41. Prohibited Acts. In addition to all acts defined and penalized under Republic Act Number 7610 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act), Republic Act No. 7658 (Act Prohibiting the Employment of Children Below 15 years of Age), Republic Act No. 9208 (Anti-Trafficking in Persons Act of 2003), Republic Act No. 9262 (Anti-Violence Against Women and Their Children Act of 2004), Republic Act No. 9344 (Act Establishing a Comprehensive Juvenile Justice and Welfare System, Creating the Juvenile Justice and Welfare Council under the Department of Justice, Appropriating Funds therefore and for Other Purposes), and

SECTION 25. ADOPTION OF ANTI-BULLYING POLICIES.- All elementary and secondary schools are hereby directed to adopt policies to address the existence of bullying in their respective institutions. Such policies shall be updated regularly.

SECTION 26. DIVERSION PROGRAM

The Local Government Unit of Mondragon through the Municipal Social Welfare and Development Office shall establish a system of diversion or a diversion program wherein children at risk and children in conflict with the law shall be referred to alternative measures without undergoing court proceedings. The Municipal Social Welfare and Development Office and/or the Barangay Council for the Protection of Children as the case may be shall be responsible for the development of a diversion program and shall spearhead the implementation and application of the program.

SECTION 27: PROTECTION OF CHILDREN DURING EMERGENCIES. The municipality of Mondragon shall implement appropriate programs and services to protect children during emergencies such as but not limited to child friendly spaces and psycho-social support or psychological first aid.

SECTION 34. ORGANIZATION OF BARANGAY YOUTH ASSOCIATION

The Local Government Unit of Mondragon shall help and sustain out-ofschool youth organizations to enhance their capabilities and potentials to transform themselves into self-reliant, economically productive and socially responsible citizens able to contribute to the development of their families and communities.

SECTION 35. ORGANIZATION OF CHILDREN'S ASSOCIATION.

The Local Government Unit of Mondragon shall encourage the organization of children's association in the community and in school and promote their participation in productive activities.

SECTION 36. CHILDREN'S CONGRESS- There shall be a Children's Congress to be held every November every year to be participated in by the Children's representative from all barangays of the local government unit.

ARTICLE VI

SPECIAL CONCERN

SECTION 37. ORGANIZATION OF LOCAL COUNCIL FOR THE PROTECTION

OF CHILDREN (LCPC)- The Local Council for the Protection of Children is hereby institutionalized. It shall become the consultative assembly of Municipal Government of Mondragon for its periodic planning and programming assessment and evaluation. It shall act as a regulatory body for operations of all programs and projects designed for children.

a. Directing a child to kneel on salt and other similar granular objects b. Shaving the head of the child

c. Whipping the child with stick, belt and other similar object

d. Tying up the child, placing him/her inside a sack or the like that would result to asphyxiation, locking him/her up in a cabinet or any enclosed struc-

ture, otherwise detaining him/her

e. Pulling the hair of the child f. Throwing objects at the child such as, but not limited to, erasers, chalk

and notebooks.

g. Causing the child to stand under the heat of the sun

h. Directing the child to stand in front of the class as punishment of an act or omission.

i. Defamatory utterances directed to the child.

i. Disallowing latecomers the entrance to school premises and denving attendance in class.

Any person who commits any of the above-mentioned prohibited acts shall be penalized with a fine of not less than One Thousand Pesos (P1,000.00) and not more than Two Thousand Five Hundred Pesos (P2.500.00), or an imprisonment of not less than six (6) months and not more than one (1) year, or both such fine and imprisonment, at the discretion of the court.

SECTION 42. It is also prohibited for all schools in the municipality of Mondragon, elementary or secondary, government or private, to conduct school-related activities at night involving the attendance of its minor students. All schools are encouraged to conduct all activities only during daytime.

SECTION 43. Prohibiting the student's entry to Internet Café or Computer Shops.

43.1 Students are prohibited to enter Internet Café/Computer Shop and the likes to its premises to make computer works, during school days and school hours. Students shall be allowed only to make research and other school-related works between 4:00 o'clock in the afternoon and 9:00 o'clock in the evening.

43.2 Students in school uniform are strictly prohibited to enter internet café, computer shops, to do computer related works during school days and school hours, provided with a written consent or permit from the school authorities or parents shall be presented for their research and other related online needs.

43.3 Internet Café/Computer Shops shall not offer online and network gaming services during school days & class hours to students.

43.4 Internet Café/Computer Shops shall post a signage at the entrance of their premises with the oriented words "ELEMENTARY AND HIGH SCHOOL STUDENTS ARE NOT ALLOWED DURING CLASS HOURS".

43.5 Display necessary warning against access to pornographic and online gambling sites, "INTERNET PORNOGRAPHY AND ONLINE GAMBLING ARE PROHIB-ITED".

Penalty Clause - Violators of this section shall be subjected to the following penalties.

• For Internet Café/Computer Shop owners

A. A fine of 1.000 for 1st Offense B. A fine of 2,000 for 2nd Offense C. A fine of 2,500 for 3rd Offense

For minor student

A. 1st offense: reprimand/guidance counseling

B. 2nd offense: parents needed for further counseling

C. 3rd offense: the parents will be liable and will be meted a fine of Two Thousand Pesos (P2.000.00).

SECTION 44. DISCRIMINATION OF CHILDREN TO ENROLL IN ANY GOV-ERNMENT AND NON-GOVERNMENT SCHOOLS OR INSTITUTIONS IN THE MUNICIPALITY.

Discrimination of children by prohibiting and depriving them of formal education, non-formal education and vocational courses under the following conditions:

a. Discrimination of Illegitimate Children – For schools to discriminate illegitimate children including, but not limited to, the following:

· Refusal to accept enrolment of illegitimate children in the school by reason of one's illegitimacy.

Requiring the marriage contract of parents in the enrolment of the child.

b. Expulsion by Reason of Pregnancy – For schools to impose a penalty of expulsion by reason of pregnancy against a child who has complied with all academic requirements.

c. Refusing a Child to Graduate by Reason of Pregnancy - For schools to refuse a child to graduate by reason of pregnancy after complying with the ATTESTED: academic and all other requirements for graduation.

PENALTY CLAUSE

Purposes); the Revised Penal Code or any other law as well as this Code, the offended party and/or any party so authorized may file a complaint under the national law, and the penalty in such national law shall be imposed.

ARTICLE VIII

FINAL PROVISIONS

SECTION 46. IMPLEMENTATION RULES AND REGULATIONS (IRR).

Within six (6) months after the approval of this Code, the Local Chief Executive, assisted by the Municipal Legal Officer and the Municipal Prosecutor shall formulate and issue rules and regulations if necessary for the effective implementation of this Ordinance.

This Ordinance shall take effect pending issuance of any rules and regulations.

SECTION 47. PENALTY FOR REFUSAL OR NEGLECT OF ANY GOVERNMENT OFFICIAL OR EMPLOYEE TO IMPLEMENT THIS ORDINANCE.

Any government official or employee, charged with the duty to implement this Ordinance; and who refuses or neglects his duty, shall be punished with six (6) months suspension from the service without pay, provided that due process on administrative discipline as established under the Civil Service Law and other pertinent laws shall be strictly observed before said penalty is imposed to such offender.

SECTION 48. APPROPRIATIONS FOR CHILDREN'S PROGRAMS.

The Local Government Unit of Mondragon shall appropriate funds, as part of its annual budget, for the implementation of children's programs. The municipality shall allocate funds necessary for the implementation of this Code, including the drafting and publication of the IRR, training and orientation of stakeholders and promotion of this Code to the general public.

SECTION 49. SUPPLETORY APPLICATION.

The applicable provisions of President Decree No. 603 (Child and Youth Welfare Code), Republic Act No. 7610 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act, as Amended by Republic Act No. 9231), Republic Act No. 7658 (An Act Prohibiting the Employment of Children Below 15 Years of Age, Amending Section 12 of R.A. 7610), Republic Act No. 9208 (Anti-Trafficking in Persons Act of 2003), Republic Act No. 9262 (Anti-Violence Against Women and Their Children Act of 2004), Republic Act No. 10821 (An Act Mandating the Provision of Emergency Situations), Republic Act No. 9344 (an Act Establishing a Comprehensive Juvenile Justice and Welfare System, Creating the Juvenile Justice and Welfare Council under the Department of Justice, Appropriating funds therefore and for Other Purposes), the Revised Penal Code and other pertinent laws shall be suppletory to this Ordinance.

SECTION 50. SEPARABILITY CLAUSE.

If for any reason a provision of this Ordinance is declared invalid or unconstitutional, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 51. REPEALING CLAUSE.

All Ordinance, Resolutions, Executive Orders and other Local Issuances which are inconsistent with any of the provisions of this Code are hereby repealed or modified accordingly.

SECTION 52. EFFECTIVITY CLAUSE.

This Code shall take effect fifteen (15) days after its full publication in a newspaper circulation within the Municipality of Mondragon, Province of Northern Samar

SECTION 53. APPLICABILITY CLAUSE

This people shall apply to all person within the territorial jurisdiction of the Municipality of Mondragon and to all persons who may be subjected to the provisions of this Code.

ORDINANCE NO. 03 Series of 2019

AN ORDINANCE PRESCRIBING THE OPERATION AND MANAGEMENT OF THE COMMUNITY FISH LANDING CENTER OF THE MUNICIPALITY OF MONDRAG ON, NORTHERN SAMAR.

WHEREAS, the Local Government of Mondragon in collaboration with the Bureau of Fisheries and Aquatic Resources Regional Office 8, and in consultation with the Municipal Fisheries and Aquatic Resource Management Council, has established and constructed a Community Fish Landing Center with endin-view of:

a. Providing support to the fishery sector primarily the municipal fisherfolk, with post-harvest facilities, marketing assistance and other services such as cold storage and fish processing etc.

b. Poverty alleviation and the provision of supplementary livelihood to municipal fisherfolk and ensure food security thru self-sufficiency and self-reliance.

c. Development and strengthening of marketing facilities and activities including the pricing system with emphasis in collective marketing and minimize middlemen intervention.

WHEREAS, Article I, Section 16, of the Implementing Rules and Regulations, pursuant to R.A. 8550 as amended by R.A. 10654, tasked the Municipal government, in consultation with the MFARMC to be responsible for the management, conservation, development, protection, utilization and disposition of all fish and fishery/ aquatic resources within their respective municipal jurisdiction. Hence, must enact appropriate ordinances for this purpose.

WHEREAS, Chapter I, Section 2, of the Fisheries Administrative Order No. 78 s. 2015, Objectives. The establishment of Community Fish Landing Centers is intended to improve the lives and livelihood of municipal fisherfolk through:

a. Providing better post-harvest handling and processing systems, and faster access to markets to reduce post-harvest losses and increase incomes;

b. Sharing of knowledge and information, to improve the quality of the products and increase the fisherfolk's fair share in the value of the products;

c. Providing access to vital services to ensure clean, safe and legitimate fishing practices, including post-harvest handling and processing technologies, registration and licensing, weather and disaster warning, and the like;

d. Enhancing sustainable fisheries management with the help of science-based monitoring of the condition of the fishing grounds and fish stocks;

e. Facilitating organizational development and strengthening of Fisherfolks, including women so they can effectively participate in decision-making processes and avail of the services that affect their welfare;

f. Providing incentives for aggregating the harvests of small-scale fishers to increase market value and market access.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Mondragon, Northern Samar on its session assembled:

ARTICLE I

TITLE, DEFINITION OF TERMS AND SCOPE OF COVERAGE

Section 1. SHORT TITLE - This Ordinance shall be known and referred to as the "Operations and Management of Community Fish Landing Center of the Municipality of Mondragon, Northern Samar"

2.1 Accreditation – is the process of officially recognizing individual/group of individuals to transact business at the Community Fish Landing Center.

2.2 Auxiliary Invoice - issued by the LGUs or their duly authorized representatives prior to their transport of fish and fishery products from their point of origin to their point of destination in the Philippines and/or export purposes upon payment of s fee to be determined by the LGUs to defray administrative costs therefore.

2.3 BFAR RO8 – Bureau of fisheries and Aquatic Resources Regional Office No. 8

2.4 CFLC - Community Fish Landing Center

2.5 DTI - Department of Trade and Industry

2.6 Electrofishing - the use of electricity generated by batteries, electric generator and other source of electric powers to kill, stupefy, disable, or render unconscious fisheries species.

2.11 Fishing - the taking of fishery species from their wild state or habitat.

2.14 FFO or Fisherfolk Organizations – An organized group, association. federation, alliance or an institution of Fisherfolk which has at least fifteen (15) members, as a set of officers, a constitution and by-laws, an organizational structure and a program of action.

2.15 Gross Tonnage - the vessels closed - in spaces expressed in volume terms on the bases of one hundred cubic feet equals on gross ton. (100cuft = 1gt)

2.16 LGU – Local Government Unit

2.17 LTFRB – Land Transportation Franchising and Regulatory Board

2.18 Local Transport Permit (LTP) - permit for domestic movement or authorizing an individual to bring, carry or ship aquatic wildlife, by-products or derivatives acquired from legal sources from the point of origin to the final destination within the country, which is different from the auxiliary invoice issued by the local governments and/or BFAR for the transport and domestic movement of fish and aquatic products derived from aquaculture or conventional fishing:

ARTICLE IV

RULES AND REGULATIONS COVERING THE COMMUNITY **FISH LANDING CENTER**

RULE I – MANAGEMENT AND ADMINISTRATION

A. TRANSITORY PROVISIONS:

Section 1. The community Fish Landing Center shall be jointly managed and operated by the Municipality of Mondragon thru the Office of the Municipal Agriculturist, the Barangay where the Community Fish Landing is situated, and the FFO who shall implement the following Rules and Regulations covering the operation of the CFLC such time that the FFO is fully capable of operating on their own or until the Municipal Agriculturist shall recommend to the Municipal Mayor the capability of the FFO to manage, operate, and develop on a sustain able basis the CFLC based on the following personnel capability and financial capability:

ARTICLE V FINAL PROVISIONS

Section 1. Administrative Provisions – The following administrative pro cedures shall be observed for the effective implementation of this ordinance

1.1 During the transitory stage of the operation of the CFLC, the Municipal Mayor shall designate from among the Municipal Agriculturists employees who shall assist, teach/train member of the basic procedures, principles and techniques in the operation of the CFLC. After which, when he/ she is convinced that the officers/members of the organization are declared capable to run their business, he/she shall recommend to the Chief Executive the names of the persons to manage the CFLC independently but with the supervision of the Municipal Agriculture Officer.

1.3 Requirement in the Monitoring Control and Surveillance of the Philippine Water - The management of the CFLC shall consolidate reports, upon demand by the BFAR, submit these report of fish catch and spoilage quantity and value of fish landed, and off loaded for transshipment, sale and/ or other means of disposal. The report shall be duly certified by the manager or person in-charge of the CFLC which shall be entitled as CFLC report.

1.4 Appropriations - the amount necessary for the initial implemen tation of this Ordinance shall be taken from any available funds of the LGU or any line agencies or any financial institutions.

1.5 Supervision and Issuance of IRR. The Municipal Mayor thru the Municipal Agriculturist shall monitor, administer and issue the necessary rules and regulations for the effective and efficient implementation of this ordinance.

1.6 Where to Pay. The fee imposed in this ordinance shall be paid to the Municipal Treasurer's office or the duly authorized representative.

National and Local Officials and employees charged with the duties under this ordinance or who by the nature of their positions, have the duty to uphold this ordinance but failed or refused to do so shall be subjected to disciplinary actions under the Section 60, Paragraph 1 of RA 7160 for effective government officials and under the civil service law and rules for non - elective government employee.

Section 4. SUPPLETORY CLAUSE - Applicable provisions of the implementing rules and regulations pursuant to R.A. 8550 as amended by R.A. 10654, and other laws related hereto, shall be suppletory to this ordinance.

Section 5. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid by competent authorities, the remaining provisions hereof

NOW THEREFORE, BE IT ENACTED by the Sangguniang Bayan of Mondragon in Session assembled that:

SECTION 1. SHORT TITLE - This Ordinance shall be known as the STREET REGULATION ORDINANCE OF THE MUNICIPALITY OF MONDRAGON.

SECTION 2. PURPOSES - This Ordinance has the following purposes:

a) To make all public roads and sidewalks safe and convenient for the use of pedestrians;

- To improve the flow of traffic; and b)
- To minimize illegal vendors on streets. c)

SECTION 3. DEFINITION OF TERMS - for purposes of this Ordinance, the following terms shall have the corresponding meaning:

a) Public Roads means all streets, roads, bridges, highways and other thoroughfares constructed and maintained by the national government or by any Local government unit: provided, that any road or sidewalk not falling under this definition but which upon determination by Municipality of Mondragon Local Government Unit, deemed vital to pedestrian access or safety, shall be deemed a public road sidewalk for the purposes of this ordinance.

b) Sidewalk Obstruction means any structures, whether permanent or temporary, immovable or movable, erected along, standing on, adjoining, or in any manner impeding safe and convenient passage through any public road and or sidewalk; the conduct of business by sidewalk vendors; and any belonging or thing found therein, which shall all be deemed nuisance per se and treated as trash, subject to summary abatement and/or disposal, as provided for under this Ordinance. Provided, that the property of the government , including road signs and structures erected and installed, for the purpose of regulating the flow of traffic, shall not be considered as such.

c) Sidewalk Vendor means any person who sells or offers for sell any consumer products, whether agricultural or manufactured, cooked foods and/or dry goods, items or articles, including any person who attends to these products intended to be sold at any temporary location, sidewalk, alley vacant space or portion thereof.

d) Setback is the horizontal distance, measured from the utmost face of the building/structure to the property lines that must be absolutely free of all forms of physical obstructions, that can negatively affect natural light and ventilation, or that can impede access to the sides and near area.

SECTION 4. RULES AND REGULATIONS - The use of streets, sidewalks, avenues, alleys, bridges, parks and other public places in the Municipality of Mondragon for commercial and personal purposes shall be prohibited except tiang ge during fiesta. Such prohibited acts include but not limited to the following:

a) Selling of goods by sidewalk 'vendors of offering for sale of foods, beverages, magazines, newspaper, cigarettes, jewellery, shoes and other foot wear and other analogous items;

b) Use of sidewalks, portion of streets, setback for storage of construction materials, equipment, sand and gravels and other materials for private use. Must be cleared within 24 hours upon delivery;

c) Installation of sign or signboards on or above sidewalks and detached from the business establishment;

d) Putting of tarpaulin, posters and business signages on trees along the streets

e) Storing of household appliances and furniture, as well as junks and recyclable materials along sidewalks;

f) Use of sidewalks and portion of streets for vehicle garage or for the conduct of vehicle repair/cleaning business;

g) House extension or store extension, including extension of roofs and canopies, awnings and the like along sidewalks;

h) Installation of permanent fence or gate along sidewalks;

i) Use of sidewalk in constructing pens or cages of animals or animals on leash;

j) Dumping garbage and litter along sidewalks and portion of streets;

k) Parking of vehicles on sidewalks;

I) Drying of Palay, Copra and other agricultural products along the streets, and sidewalks; and

m) Playing types of sport games on the street.

SECTION 5. EXISTING PERMANENT ROOFS ON SIDEWALKS - Any permanent roofs or coverings either detached by the violator from buildings existing on any public roads and sidewalks should be removed. Retention maybe allowed, provided that there is a permit secured from the office of the Municipal Mayor in accordance with the specifications set forth in the Implementing Rules and Regulations (IRR) of this ordinance

SECTION 9. EXEMPTION - Tiangge shall be exempted provided that, necessary permit has been obtained and only for a maximum of 2 weeks and only during fiesta or special occasion or activity of the LGU.

SECTION 10. PENALTIES - Any person, firm, association or entity, found violating this Ordinance or its implementing rules, shall be imposed a fine, which shall accrue to the Local Treasury, as follows:

2nd Offense: Confiscation of items (for donation to DSWD, PNP, or other institutions upon decision of Municipal Mayor); and 3rd Offense: 2,500.00 fine.

Installation of permanent fence or gate along sidewalks/House extension: 1st Offense: Written warning.

2nd Offense: 1,000.00

3rd Offense: 2,500.00 fine and demolition of fence or gate/ house extension.

Dumping of garbage and littering along sidewalks and portion of streets; and playing sport games on the street.

1st Offense: P1.000.00 or 8 hours community service

2nd Offense: P2.000.00 or 16 hours community service

3rd Offense: P2.500.00 or 40 hours community service

SECTION 11. IMPLEMENTING RULES AND REGULATIONS - The Municipal Mayor through the Municipal Treasurer, Municipal PNP, and the MLGOO shall promulgate the rules and regulations to carry out the provisions of this Ordinance, within sixty (60) days from its effectivity.

SECTION 12. SEPARABILITY/REPEALING CLAUSE - If any provision of this Ordinance is held invalid or unconstitutional, other provision not affected shall continue to be in full force and effect, or inconsistent with national law, rules and regulations, the same shall prevail and all previous ordinances, rules, regulations, executive order or memoranda are hereby superseded and modified.

SECTION 13. EFFECTIVITY - This Ordinances shall take effect upon approval and compliance with the mandatory posting and publication requirement, prescribed under R.A. 7160, otherwise known as the Local Government Code of 1991.

ORDINANCE NO. 14 Series of 2019

REGULATING THE USE OF STREETS, SIDEWALKS, ALLEYS AND BRIDGES AND THE USE AND DISPLAY OF BUSINESS SIGNAGES ALONG THE STREETS IN THE MUNICIPALITY OF MONDRAGON, NORTHERN SAMAR

WHEREAS, the Department of the Interior and Local Government (DILG), pursuant to the directive of His Excellency President Rodrigo Roa Duterte during the 2019 State of the Nation Address, had issued a Memorandum Circular No. 2019-121, enjoining all local officials to exercise their power to reclaim public road which are being used for private ends;

WHEREAS, despite the effort made by the local officials to implement the Memorandum Circular of the DILG, there are still continuous construction of illegal infrastructures along the public roads in the Municipality of Mondragon including those illegal vendors and placing of signages in front of business establishment that is considered part of public roads and which block the pathways for pedestrians and affecting the flow of traffic;

WHEREAS, it is a declared policy of the state to safeguard life, health, property and public welfare, consistent with the principles of environment management and control; and to this end, make it purpose of this Ordinance to regulate the use and maintenance of sidewalks and setbacks and to clear the same of illegal commercial and private structures, in order to facilitate the safe and convenient use thereof, pursuant to Book I, Chapter 2, Section 16 and Chapters 3, Article I, Section 455, paragraph (b) (3) (VI) of the Local Government Code;

WHEREAS, to solve the pressing problem of improper use of streets,

SECTION 6. OBSTRUCTION AS TO NUISANCE PER SE - All obstructions along public roads and sidewalks are hereby presumed or declared nuisances per se and, as such are subjects to summary abatement without need of judicial proceedings

SECTION 7. SUMMARY ABATEMENT - The Municipal Mayor is hereby authorized to donate the confiscated items to the Municipal Philippine National Police, Municipal Social Welfare and Development Office. Also the Municipality and its component Barangays are hereby authorized to summarily abate, forfeit and dispose any obstruction, found within their respective territorial jurisdiction.

PROVIDED, that, enforcers of the local government unit and barangay tanods shall be free from any liability, arising from the lawful forfeiture and disposal of sidewalk and setback obstructions and prescribe herein.

PROVIDED, further, that all the costs, related to the abovementioned forfeiture and disposal, shall be charged at the expense of the violator of this Ordinance.

SECTION 8. ADDITIONAL RESPONSIBILITIES OF THE VIOLATOR - The violators either the owner or lessee or occupant of both residential or commercial establishments are mandated to clean and clear from obstructions the sidewalks, passageway and setbacks, fronting their establishments.

It shall be the responsibility of the above-cited persons to place their garbage and litter in sanitary garbage, placed inside their yards and/or building and bring the same out only when the garbage collector passes by. Failure to do so shall make the violator liable under this Ordinance.

saw personally its bad effects. He asked me to oppose any such activity and he has given me his support on this," Alvero said on Monday during a press conference.

On Monday, Alvero led a motorcade from MacArthur to the offices of DENR-MGB (Department of Environment and Natural Resources-Mines and Geosciences Bureau) to express their protest on the mining activity in MacArthur.

The DENR-MGB has granted MacArthur Iron Project Corp. (MIPC) a mining claims of 2,000 hectares September of this year.

The 2,000 mining claims covers the towns of MacArthur, Javier and Abuyog. In MacArthur, MIPC mining claims is around 500 hectares located in Barangay Maya.

Alvero said that he is opposing the mining activity as this could lead to the destruction of the environment like flooding in Maya, which he described as a 'prime agricultural area.'

Januar Ong, community relation manager of the MIPC, said that their company is not yet engaging in commercial operation but still on a 'test run' of their equipment.

Ong said that while they were granted the

MPSA or the mineral production sharing agreement by the Department of Environment and Natural Resources (DENR) back in 2007, they have not actually conducted their commercial operations.

"What we have right now is test run and debugging activity of our equipment and in our plant. We have not started or conducted any mining activity or actual commercial operations," he said.

The company also asserted that they have all the necessary permits from concerned government agencies.

Ong also said that there is no possibility that flooding could result to their mining activity saying that a creek located nearby has been dredged by the company to ensure that in case of heavy rains, it would not overflow.

Also, they have planted bamboos along the creek as part of their river bank stabilization program.

Ong, however, could not say as when they could actually conduct their business operation except to say that China is one of their markets.

Snubbed on first invite, Tacloban council to invite again Leyte Prime Waters execs, says Yaokasin

Apparently exasperated over the failure of the officials of the Leyte Prime Water to attend before the members of the Sangguniang Panlungsod, Vice Mayor Jerry 'Sambo' Yaokasin disclosed that they will be inviting them again during their next regular session.

The vice mayor said that no officials from the Leyte Prime have showed up on grounds that they were 'busy' of their field works

"We wanted them to share the update on their pipeline project in the city as well as updates on the water system to the northern part of the city especially to the resettlement site,"Yaokasin said. "They should explain, clarify update so we will know. My office received information that accidents happened because of the unfinished road repairs in some areas of the city being implemented by the water district," he added.

The vice mayor said that the officials of Leyte Prime have obligation to explain to the people of Tacloban what they are currently doing considering that they are involved that is of public interest.

Yaokasin also said that they would like also to ask the Leyte Prime officials on the update of the P42 million worth of aid from the national government intended for providing water supply in the northern part of the city.

During his visit in 2018, Pres. Rodrigo Duterte directed the water agency and the National Housing Authority to provide water supply to residents living at the resettlement sites located in the northern part of the city.

"We really wanted to know when this pipe laying will be finished," he said. (LIZBETH ANN A. ABEL-

TANAUAN, Leyte – For the first time since its establishment 39 years ago, children in conflict with the law (CICL) can now attend formal classes inside the Regional Rehabilitation Center for Youth (RRCY) here.

This after the Department of Education (DepEd), in partnership with the Department of Social Welfare and Development (DSWD) and the local government of Tanauan, opened formal classes for regular junior and senior high school programs inside the facility in October.

RRCY is a residential facility that provides intensive treatment for the rehabilitation of male CICL, whose sentences have been suspended and serves as a nurturing out-of-home placement to enhance their psychological, emotional, and psychosocial well-being. Georgina Bulasa, RRCY Eastern Visayas officer-in-charge, said 38 out of 48 CICL under its care are enrolled in Grades 7 to 11 for the school year 2020-2021.

"This is the first time that we have an in-house formal class and we are so happy for this opportunity. Before our CICL attend classes in nearby high schools but it was difficult," she said in a virtual press conference on Friday. The DepEd Leyte division has assigned six teachers for the regular high school program inside the rehabilita-

Borongan City boosts contact tracing via QR code system

TACLOBAN CITY -The city of Borongan in Eastern Samar is requiring all persons within its borders transacting at any public and private establishment to present a QR (quick response) code to boost contact tracing.

After a series of technical reviews, name encoding, and data sorting, the city government officially implemented the QR code system on November 30 with more than 103,000 registered names as of December 4.

"This will boost our contact tracing to mitigate the spread of (the) coronavirus disease 2019 (Covid-19). The border control, business establishments, churches, schools, and government and private offices shall deny entry of those who do not have a QR code, valid identification card, and face mask and shield," Mayor Jose Ivan Dayan Agda said in a statement on Friday.

Agda said everyone could generate a unique QR code through the SAFE Borongan mobile application for free.

Village officials have been directed to assist residents in activating their

The local government will impose a PHP5,000 fine on establishments that fail to register and implement the QR code system and another PHP5,000 fine plus revocation of business permit for the second offense.

Meanwhile, Agda assured that all information stored in the QR code system would be solely used for contact tracing.
