Since start of the pandemic

Jipapad the only area in EV without COVID case

TACLOBAN CITY-The town of Jipapad in Eastern Samar province remains to be the only area in the region to report a zero case of the coronavirus disease (COVID-19).

And they hope to maintain their clean record even until vaccines against the ailment would be available, Neil Norambaba, local disaster risk reduction management officer, said.

"We really hope that we can maintain our status as a COVID-free area, especially that we don't have the capacity to buy our own vaccine," he said in a phone interview.

The town, which has a population of more than 9,000 spread on its 13 barangays, is considered to be a fifth class with P71 million in income.

According to Norambaba, one possible factor why Jipapad has no COVID-19 case since the start of the pandemic last March, could be its geographical location.

Jipapad is among the far-flung towns in Eastern Samar-16 kms away from its nearest town of Arteche, also in Eastern Samar, and around 10 kms away from its neighboring town of Lapinig in Northern Samar.

Gov. Petilla directs health officers to come up with a survey form as province mulls to inoculate 100,000 Leyteños of the anti-COVID vaccines

TACLOBAN CITY – Leyte Governor Leopoldo Dominico Petilla has directed health officers in the province to come up with their survey forms intended for the vaccination against coronavirus disease (COVID-19) here.

Petilla also said that he projects that at least 100,000 people of the province will receive the vaccine. With the exception of Tacloban City, a highly-urbanized city, Leyte has more than 1.7 million populations.

The governor said that the survey form is necessary so that they could identified those who should

Maasin city government extends cash assistance to 350 abaca farmers to help revive the industry hit by virus

TACLOBAN CITY -The Maasin city government has started this week the distribution of cash assistance to abaca farmers as part of its abaca rehabilitation program.

The abaca cash-forwork financial assistance of the city government aims to revive the abaca industry of the city.

Each abaca farmer will receive P6, 000 cash assis-

At least 350 abaca farmers coming from the villages of Pinaskuhan, Nonok Norte, Sta. Cruz and Sto. Niño are the first beneficiaries of the program.

"The cash to be given will serve as labor assistance for the cleaning/ clearing, weeding and other cultural management practices in raising the abaca plant," Mayor Naccional Mercado said.

Twenty of the city's 70 villages are abaca producers whose dried products are sold to buyers in Baybay City where a big abaca processing plant operates.

In 2019, as part of the city government program to revive its abaca industry, some villages like Lonoy, Cabadiangan and Pinaskuhan, established their own abaca nurseries.

Villages that established their own abaca nursery received assistance from the provincial government which included organic and complete fertilizers to strengthen its own abaca seedlings grown.

Abaca production of the city declined for the past years after bunchy top virus affected the plants.

Bunchy top disease (BTD) is considered the most destructive disease of abaca where infected crops

exhibit 'bunched top' appearance, stunting and yellowing of the leaves, poor fiber quality and significant fiber yield loss.

Other abaca producing towns in Southern Leyte province were also affected by the virus.

Although some villages in the city had started to get back on producing abaca fibers, agriculture officials in the province had cautioned farmers to be vigilant and to adhere to disease management to prevent for the bunchy top virus to its abaca industry.

DBP signs multi-billion credit deal with local ship building firm

State-owned Development Bank of the Philippines (DBP) has granted a P4.17-billion term loan to Megaship Builders, Inc. (MBI) to upgrade and expand its shipbuilding and ship repair complex in Albuera, Leyte, a top official said.

DBP President and Chief Executive Officer Emmanuel G. Herbosa said that the loan proceeds will be used to partially finance the construction of the shipyard's second and third slipways, office building, and other support facili-

> completed, "Once

this shipyard expansion project is expected to increase the capacity of the shipyard from 10,000 Deadweight tonnage (DWT) to 200,000 DWT, thus accommodating an average of 10 vessels per month from the current two vessels per month," Herbosa said.

DBP is the seventh largest bank in the country in terms of assets and provides credit support to four strategic sectors of the economy - infrastructure and logistics; micro, small and medium enterprises; social services and community development; and the en-

MBI started operations in June 2016 and is engaged in shipbuilding, ship repair, design, construction, outfitting and launching of any type of vessels or watercraft.

It is also the first shipbuilding and drydocking company in the Visayas that utilizes marine airbag technology in drydocking vessels - a departure from the traditional common carriage-type method.

DBP Executive Vice President for Development Lending Jose Gabino D. Dimayuga said the project would help address the lack of viable shipyards that could accommodate the growing number of vessels in the country, which presently has a ratio of 204 vessels to one shipyard.

He said as an archipelagic country, it is imperative for the Philippines to enhance its transport infrastructure and logistics facilities to promote physical integration and seamless movement of goods that would create economic opportunities especially those living in the coastal areas.

"There is tremendous potential for the Philippines to unlock the intrinsic value of its shipbuilding industry as the country has both strong demands for smaller vessels in the domestic market and is presently is an exporter of large, commercial ships for the international market," Dimayuga said. year," he said. Parian clarified that these ENROs composed of barangay officials and volunteers will assist in the enforcement of environmental laws in their areas

The DENR director explained that these ENROs shall perform functions like assisting in the issuance of apprehension receipts, seizure orders and notices of administrative hearings; arrest, even without warrant, any person who committed or is about to commit an environmental law violation; deliver the offenders including the apprehended forest products, tools, equipment and conveyances within the period prescribed by law from the time of arrest and seizure and act as witness in court for the speedy prosecution of criminal complaints.

Villar bats for Catanduanes as PH's abaca capital

Senator Cynthia Villar, Chairperson of the Senate Committee on Agriculture and Food, is pushing for the declaration of the Province of Catanduanes as the 'Abaca Capital of the Philippines' in her recently filed Senate Bill No. 1748.

The Philippines is the top producer of abaca in the world and Catanduanes is the top abaca producer of the country and the world also, as it contributes 90 percent to abaca production in Bicol Region. Villar's proposed bill seeks to "promote and support the abaca industry of the province, while safeguarding it from destruction of plant diseases and calamitous events."

Statistics from the Department of Agriculture show that, "from 2013 to 2019, the Bicol Region is the top producer of abaca fiber having produced a total of 22,987 metric ton, which comprises 37% of the national production. The abaca harvested in the province of Catanduanes

is even higher than the production of Ecuador, the second biggest abaca producer in the world after the Philippines.

"It is but proper and apt that we officially name Catanduanes as the abaca capital of our country because it really is ever since. Once passed, the bill will also provide the province with additional government support and allocation. That will help them to further grow and develop the abaca industry to benefit the farmers and all the people who depend on it for livelihood," said Villar.

Abaca is the main source of livelihood of the people living in Catanduanes.

The abaca industry directly benefits nearly 13,000 farmers who are tending over 33,000 hectares of land in 11 abaca-producing municipalities in the province.

"About 97% of all the total abaca produced in the country are exported as pulp,raw fiber, handloom fabric or handicraft. So, it is a high value agricultural commodity and top dollar earner. Demand for it is even increasing during the pandemic because abaca is the main raw materials for masks, PPE and other medical or healthcare-related product," cited Villar.

Abaca is also an important raw material for tea bags, coffee filters, food packaging, textile, clothing, shoes, bags, wall coverings, sheets, and even paper money. Japanese currency notes (Yen) actually contain up to 30% abaca.

According to Villar, "The abaca sector alone contributes Php4.7 billion to country's economy annually, so it deserves all the support it needs. Aside

DOH asks LGUs to strictly follow quarantine rules to ensure region will be free of the new COVID-19 variant



TACLOBAN Health authorities in the region have called on local government units to be more strict in the implementation of the health protocols to ensure that the new variant of the coronavirus disease (COVID-19) would not enter the region.

Dr. Exuperia Sabalberino, acting director of the DOH-8, said that considering that the new variant has a high transmission, this could result to fast transmission and further increase the region's COVID-19 cases.

"That is why, we are calling for all local government units to strictly implement the 14-day quarantine period; conduct swabbing on the fifth day during quarantine; and avoid any visitation of relatives who are in quarantine," Sabalberino

Sabalberino assured the people in the region that so far, the new variant of COVID-19 has not yet been detected in Eastern Visayas based on the specimens that they have exam-

As of Friday, the region 13,816 COVID-19 cases with 178 deaths.

Meantime, several government offices have been placed under lockdown after some of their employees were detected with the COVID-19 virus.

Among these are the regional office of the Department of Education (DepEd) which has been closed since Jan.22 after two of its employees were tested positive.



seems as if China had just waited for the administration of President-elect Ioe Biden to commence, and for the Trump regime to end, which it viewed as the

only deterrent to its expansionist plans in the Southeast Asian region.

As soon as President Biden officially assumed the presidency, in just a couple days, China immediately passed a new Coast Guard Law authorizing its coast guard to fire on foreign vessels in the South China Sea and to destroy the structures of other countries on the islands that it claims.

The reason for the quick action is obvious: China is taking advantage of the seeming neutrality and reluctance of the Biden administration to interfere in this region's maritime disputes. Biden himself acted quite friendly with China during his campaign for the presidency, and China must have found the harmless US president in him.

This new law according to Foreign Secretary Teodoro Locsin Jr. "is a verbal threat of war to any country that defies" it. Aside from the islands owned by the counties in whose territories they are found, China also claims the open sea through which free navigation of all countries has long been agreed upon and traditionally enjoyed by all.

Surely, China's passage of that law is inappropriate and questionable, though it could be the fulfillment of its long-overdue plans of a forceful expansionist aggression in the region. Firstly, many of the islands it illegally claims have rightful owners; secondly, the safety of free navigation in the open sea will be put at risk.

It appears that the only way for China to reconsider this new law is for the Biden regime to take a tougher stand against this aggression. The US should continually strengthen its presence in the region, and nurture its alliances here to ensure a balance of power.

Ex-Speaker Cayetano, ousted House Leader Form **Independent Bloc**

Last week, former Cayetano said. Speaker Alan Peter Cayetano formed a "core group" of congressmen -- another bloc in the House of Representatives; and after waiting for a few days in order to know more about their plans in congress, here's what this Columnist learned --

Ex-Speaker Cayetano (initially) banded together a group of Six (6) congressmen -- all former House leaders who were removed from their posts, after Cong. Lord Allan Velasco took over the speakership last Oc-

The Six (6) Congressmen are (alphabetically arranged) --

Cong. Ranie Abu of Batangas; Cong. Fredenil Castro of Capiz; Cong. Mike Defensor of Anakalusugan Partylist; Cong. Dan Fernandez of Laguna; Cong. Jose Antonio Sy-Alvarado of Bulacan and Cong. LRay Villafuerte of Camarines

Initially calling themselves the "BTS sa Kongresso" (BTS in Congress), in reference to the popular South Korean boy band that also has Seven (7) members.

LRay Congressman Villafuerte clarified that "their group would still support President Duterte's legislative agenda, but we will be critical of certain measures being pushed under Velas-

"If we see something wrong, we'll speak out because at the end of the day, we want what is good for the country. We're still definitely part of the administration and Duterte majority,"

"Maybe you can call us 'independent majority.' We would just be more critical of certain issues and legislation," Villafuerte added.

Political observers declare that this "bloc would pose challenges to the legislative agenda of Speaker Lord Allan Velasco.

and De-Cayetano fensor already declared their opposition to the proposed amendments in the 1987 Constitution pushed by President Duterte; both saying that this is not the right time for any Charter change as the country contends the coronavirus with pandemic.

Already political observers see the future "free-wheeling" moves of this bloc, especially after hearing their planned opposition to the proposed amendments to the 1987 Constitution, since their pronouncement jibs with an earlier announcement of the so-called 'leftist' Makabayan Bloc led by Cong. Zarate and Gaite.

So, it didn't come as a surprise, when supporters of Speaker Lord Allan Velasco called this new bloc led by Cayetano as the "Not-so-Magnificent-Seven!"

At this stage, this Columnist could not help but ask "Whatever happened to Sagip Party-list Rep. Rodante Marcoleta, the group's main spokesman in their relatively successful "battle" for the stoppage of the media giant ABS-CBN.

MORE ON EX-SPEAK-**ER CAYETANO**

It will be recalled that Speaker Cayetano was replaced by Velasco as speaker, after a bittler squabble

over the execution of their term-sharing agreement, forged at the beginning of the 18th Congress in July 2019, known as the 15-21 sharing system.

Duterte mediated and supported the takeover of Velasco.

Cayetano, who is the secretary-general of the Nacionalista Party (NP), is reportedly running for a higher position in the 2022 polls; but has not confirmed such a plan, declaring instead that officials should focus first on pandemic and recovery programs.

Suffice to say that Hu-


mans can adapt too and that we can survive this pandemic and here are some tips to survive with delight;

633 Estehanon youth benefits from SPES program

BORONGAN Some 633 Estehanon youth benefited from the Special Program for Employment of Students (SPES) for the year 2020 in the province of Eastern Samar.

According to Engr. Aleksie D. Abellar, provincial director of the Department of Labor and Employment - Eastern Samar Field Office (DOLE-ESFO), the program is in partnership with local government units (LGUs) through the Public Employment Service Office (PESO).

Engr. Abellar said the program is offered to students who are poor but deserving, out-of-school youth (OSY) or dependents of displaced or would-be displaced workers due to business closures or work stoppages.

"Under the SPES, qualified students must be 15-30 years old and can apply in LGUs and any government office or agency in the province that offers job opportunities," Abellar

The provincial director also said that to qualify, the student applicant needs to submit a birth certificate from the Philippine Statistics Authority (PSA), grades from the last school year or any documents as proof of enrolment.

For OSY, they will submit a birth certificate, original copy of certification as OSY issued by barangay chairman.

And for dependents of displaced or would be displaced workers, they will also submit a birth certificate, a notice of termination issued by the employer, and certification of displacement issued by the concerned barangay, municipal or city social welfare, and development officer of the LGU.

Judith F. Aboy, labor employment officer III, said that SPES applicants were assigned to different offices of every municipality, and provincial offices.

She said the implementation of the SPES program for the LGUs was in June, July, and August while for the province and ESSU was in November and December and each SPES applicant rendered 20 working

Aboy added that the DOLE's percentage share may vary, from 40 percent to 60 percent depending on the LGUs financial capacity to pay the SPES beneficiaries.

For 1st to 3rd class municipalities, the LGU sharing is 60 percent and the DOLE is 40 percent; for the 4rth class the sharing is 50 percent to 50 percent; while for 5th class, the sharing is 40 percent to 60 percent, and for 6th class is 25 percent to 75 percent.

In Eastern Samar, since most of the municipalities are fifth class, the minimum wage rate is P352.18.

Some 15 LGUs, the provincial government of Eastern Samar, and Eastern Samar State University (ESSU) partnered with the DOLE-ESFO for the SPES program.

She further said that municipalities that committed SPES slots are LGU-Eastern Samar Maslog, Jipapad, Arteche, Sulat, San-Julian, Borongan City, Maydolong, Balangkayan, Hernani, Gen. Mac-Arthur, Quinapondan, Balangiga, Lawaan, Salcedo, and Mercedes.

The total amount of DOLE counterparts for this program is P2.4 million.

SPES is a special program of the government under the labor department to help to continue students pay their school fees and for the out-ofschool youth (OSY) to continue school.

in the survey form.

"If this person lives in a village that had never recorded any COVIDd-19 cases and work in a place which also have no cases, maybe we can exclude them on the list of our priority for vaccination," Petilla explained.

Petilla added that the prioritization will also depends of what kind of vaccine the province will procure noting that there are vaccines which are not suitable for those 16 years and below, senior citizens who are 85-year old and above, pregnant women, and those with comorbidities.

"This is voluntary. We cannot coerce them to be vaccinated but the mayors may talk to them and explain the importance of getting vaccinated," he said.

The governor added that from his earlier announcement of procuring 20,000 thousand to 30,000 doses of vaccines, he had order the provincial accountant and the provincial budget officer to look for funds so that the province could increase the number of vaccines to be procured.

The governor said that the new target of the province is to vaccinate around 100,000 residents which means they need to procure 200,000 vaccines for two doses.

With this number, the province will be needing more than 60 million, he

TACLOBAN The mayor of Tanauan town here in Leyte is the latest elected official to acquire the coronavirus disease (COVID-19).

Mayor Pelagio Tecson, Jr. confirmed that he was tested positive of the virus as he designated his vice mayor, Ronald Flores, to temporarily discharge the functions of the office while he is in isolation.

Tecson,53 and now serving on his last term as mayor, disclosed of his current health situation through a post at the Facebook account of the municipal government on Tuesday (Jan.26).

"My dear Tanauanons, I would like you to know that I have been tested positive for COVID-19. I have manifested symptoms over the past few days. All close contacts have been identified already and will undergo testing by today (Tuesday)," he said.

The town mayor, however, did not say how he possibly acquired the virus except to say that everyone

CITY- could get it.

"Upon reflection, this only shows that this pandemic is still around us. There will always be occasions where it can hit us," he said.

Tecson said that it is now more than ever that the residents should be mindful against the virus by strictly following all the health protocols especially that the new variant of COVID-19 has been confirmed to exist in the country.

"I appeal that you heed this call," he said.

Tecson's media affairs consultant, Roy Moraleta, said that Tanauan is the first local government unit in Leyte to come up measures like setting up quarantine facilities and providing food aids during the quarantine period, and livelihood assistance to the people.

"Sir Odon was a mentor to many ballet and jazz enthusiasts in the region and throughout the Philippines and abroad, and truly, one of Samar's pride. Thank you Sir, for sharing your talent to the world, and may you find peace in God's arms," wrote Professor Jhonil Bajado, head of Samar State University Museum and Archives and adviser of the Social Studies Circle.

A native of Calbiga, Samar, Sabarre rose to stardom in the 1970s, along with his late brother Tommy, after he became the first Filipino dance scholar to Russia through then First Lady Imelda Marcos, with the sponsorship of the Cultural Center of the Philippines (CCP).

"We share the sorrow of the family of Sir Odon Sabarre at this difficult time with deep sympathy as they grieve over his passing away. Sir Odon has served our

parish as an Extraordinary Minister of Holy Communion for many years," said Monsignor Erlito Maraya, parish priest of the Sacred Heart Jesus Parish in Tacloban City.

"We will always be grateful for his dedication in distributing the Body of the Christ to the people of our community. Eternal rest grant unto him, O Lord, and let the perpetual light, who is our Lord Je-





sus Christ, shine upon him. May he rest in the loving embrace of our Heavenly Father," added Monsignor Maraya in a statement.

Bajado described Sabarre

as "Samar's Premier Danseur," having trained and studied in Moscow, Copenhagen, Switzerland, Germany, Canada, and New York.

He had several performances together with the Philippines' prima ballerina, Lisa Macuja-Elizalde.

As one of the 10 children of the late Judge Tomas Sabarre and Josefina Salva Sabarre, a pianist and musician, Sabarre had invited

many personalities to his hometown, putting Calbiga on the map, according to Bajado.

"I know you are happy now to be reunited with your brother Tommy. Now that the duo is together again, a dance concert in heaven is surely a sight!" added Bajado.

Known as the first artist in residence of Eastern Visayas region, Sabarre was also awarded as Most Outstanding Samareño and Most Outstanding Taclobanon. He was nominated as National Artist of the Philippines in 1997.

Before his death, Sabarre dedicated his life teaching dance lessons to underprivileged youths in Samar and Leyte provinces aside from performing in the country and abroad.

Sabarre also devoted his time to church works and became a close friend of the late Filipino healing priest Fernando Suarez.
