The 21-year old native of Capoocan town in Leyte garnered 91.40 percent to top reason. the MedTech examination held last January 21-22, this year with the results released last Feb.9, this

While Samante may have the intelligence to pass and eventually top the examinations, the current circumstances made him wary.

PSA office shuts down after one employee tested positive for COVID-19

TACLOBAN The regional office of the Philippine Statistics Authority (PSA), based here, has closed its office after one of its employees was tested positive of the coronavirus disease (COVID-19).

"This measure is undertaken in view of the recently confirmed COVID-19 positive employee who has been isolated and currently under observation in a treatment facility," PSA Regional Director Wilma Perante said.

Perante said that regular operations of their office will resume on February 15.

She assured the public that precautionary measures are in place to prevent virus transmission.

Among these measures include the temporary closure of their civil registry service (CRS) outlet, regional statistical services office (RSSO) and provincial statistical office-Leyte, during the period February 10-14; disinfection of their office and all service vehicles; all employees shall undergo home quarantine and adopt work-from- home arrangement with their respective supervisors or unit heads; and, coordination with their respective barangay health emergency response team (BHERT) or City Health Office for proper monitoring or possible contact tracing.

NPA finance secretary,' another ex-rebel surrender

TACLOBAN CITY-An alleged finance secretary of the New People's Army (NPA) and another former rebel surrendered in Northern Samar following the "continuous efforts" of the authorities against insurgency problem in the province.

The rebel surrenderees were identified only as alias Renz and alias Macmac, both 28 years

Colonel Arnel Apud, director of Northern Samar Police Provincial Office (NSPPO), said Renz is the son of a former NPA commander and designated as finance secretary under provincial white area committee operating in Northern Samar.

The former rebel also handed over a government model caliber .45 with three rounds of live ammunition during his voluntary surrender to Major Edwin Oloan Jr., commander of the 1st Northern Samar Provincial Mobile Force (NSPMFC), Company on Monday, February 8,

Alias Macmac, who surrendered on Tuesday, February 9, turned in one caliber .45,one magazine with six live ammunitions and one fragmentation grenade to the personnel of Silvino Lubos Municipal Police Station led by Captain Joe Lucero and 2nd NSPMFC led by Lieutenant Colonel Rafael Tayaban.

"Again, I am stressing that the doors for the rebels who want to have a new life are wide open. I also urge the public to help in disseminating the

pistol and a magazine benefits offered by the government to those who will surrender," Apud said in a statement.

> Since January 2021, at least six former rebels have reportedly reintegrated to the community through the Northern Samar police.

LPA- induced rains trigger flooding in several Leyte towns

TACLOBAN CITY- The continuous rains brought about by the low pressure area (LPA) has forced several local government units in Leyte to cancel their works and classes on Wednesday

The mayors of Palo, Tolosa, Santa Fe, Alangalang, and San Miguel have issued orders suspending works and classes at their respective areas as they have experienced floodings brought by the heavy rains.

In Palo town, flood waters submerged some houses like in sitio Caloogan of Barangay San Jose.

In Santa Fe town, hunreds of families from Barangay Badiangay were evacuated to the town's gymnasium after their houses were inundated by flood waters.

Heavy rains have also resulted to the isolation of the three barangays of Canisak, Pongso, and Hiagsam, all in Barugo town, also in Leyte, after a bridge leading to these villages overflowed.

Town Mayor Ma. Rosario Avestruz, however, said that no residents from the three villages were evacuat-

Road from San Miguel to its neighboring town of Babatngon was also rendered unpassable due to flooding.

MIPC expects opposition on their mining operations to subside after panel of Leyte SP conducted public hearing

TACLOBAN CITYmanagement of MacArthur Iron Sand Project Corp. (MIPC) is hopeful that their appearance before members of the Sangguniang Panlalawigan would help convince those who are opposing their mining activity is in compliance to existing laws.

On Thursday (Feb.11), the committee on environment and natural resources chaired by board member Mecias Arevalo conducted a hearing amid complaint of an anti-mining group headed by Father Amadeo Alvero, parish priest of MacArthur

Januar Ong, communications officer of MIPC, said that although they cannot answer some issues presented during the committee hearing, they are hopeful that this could pave the way for those who opposes their mining activity that they are into 'responsible min-

Fr. Alvero said that their opposition of the mining operations stem from their fear of the negative impact it will have in their town citing climate change and the experience the town had from the previous mining companies that operated in MacArthur failed to conduct any rehabilitation activities as they have promised.

Ong said that they are not accountable to past sins of the mining companies that previously operated in Macarthur as he asked for their own company to be given a chance

to prove that they are serious on their commitment to conduct rehabilitation on areas that they have mined out.

"In fact, I am thankful that their group is there as it encourages us to be true to our promise and that they are there to check on us" he said.

Ong is also grateful for the presence of Mines and Geosciences Bureau (MGB) as they will be the ones to explain regarding the failed rehabilitation in the area by previous mining companies.

MGB Regional Director Engr. Leo Van Juguan promised that they will recommend for the past companies to fulfill their promise to conduct reha-

Earlier their office issued a memorandum directing the conduct of regular monitoring on the progressive rehabilitation being conducted by MIPC in MacArthur to ensure its proper implementation.

This is because of the issues and concerns brought by various groups in relation to the mining operations of MIPC in Barangay Maya.

Juguan said that the monitoring will be conducted by the technical personnel from the mines management division and social development of their office every 15 days.

The monitoring is on top of the quarterly mine monitoring of mine operations in the region being facilitated by the office and other agencies and the civil society groups,

Samar State University mulls opening medical course to help address lack of doctors in the province

TACLOBAN CITY The Samar State University (SSU) in Catbalogan City is seeking support for the establishment of the Samar Island Institute of Medicine (SIIM) which aims to bridge the gap on lack of doctors in the province.

SSU is seeking support from all sectors to lobby the funding of this endeavor at the national level, Dr. Ronal Orale, the vice president for research and extension services and the chairperson of the technical working group of SIIM, said.

The need for more medical practitioners in the province has become pronounced with the present problem on coronavirus disease (COVID-19) pandemic.

Orale added that there is need to produce homegrown doctors who will be serving the province as data shows the province like Samar do not attract new doc-

By establishing SIIM, the SSU aims to produce medical doctors who are socially accountable, ethically enlightened, and professionally competent physicians committed to deliver primary healthcare, dedicated to advance the field of medicine through further training, research and development, and are devoted to serve the communities of the province.

In the feasibility study conducted by the SSU in relation of their plan to establish the SIIM, funds needed to operate such facility is a big challenge to for them to

SSU will be presenting the proposal and seek endorsement from the Re-



Perspective of the proposed Samar Island Institute of Medicine (SIIM)

gional Development Council (RDC) under its social development committee to seek support from stakeholders for the possibility of receiving funding for the establishment of SIIM in the next five years.

Bulk of the needed funding include for the construction of the SIIM Academic Building, purchase of additional facilities needed, and hiring of qualified doctors to handle classes.

Attractive packages for professors (specialized medical doctors) would be made available to attract experts who will man the proposed school.

Some LGUs already expressed their support and spots for deserving students from their municipalities were also identified.

Students enrolled in the SIIM program will pay very

minimal fees if not totally free, Orale said.

Meantime, the provincial government of Samar passed a resolution expressing support on the opening of the SIIM and stated that the plan is aligned to the provincial government's efforts in making Samar Provincial Hospital (SPH) a tertiary and training hospital. (ROEL T.AMAZONA)

Vaccination roadmap

of this time, the government has not yet entered into any agreement with likely COVID-19 vaccine manufacturers, which means to say that sure delivery of vaccine supply

to the country is not yet in place.

This is according to Secretary Carlito Galvez Jr., the country's vaccine czar, who revealed during a Senate panel hearing that the government is still finalizing this supply agreement with vaccine manufacturers Moderna, Novavax, and Sinovac. He added, moreover, that 50,000 doses of Sinovac vaccines are to arrive on the 20th of this month based on a "term sheet" that he has signed, and another donated 600,000 doses of the same brand coming on the 23rd.

Initially, then, these are the vaccines that we can hope for in our continued battle with this deadly coronavirus. That's too little compared

to the number of our population that's over one hundred million, although the government has been negotiating for more or less 108 million doses of vaccines. But without a supply agreement yet, deliveries would also be unlikely despite the country's need for said vaccines.

Fortunately, the said supply agreement is set for discussions already within days. Another good news is that vaccines are already available and manufacturers are ready to mass-produce them for voluminous orders. Somehow, the expected 50,000 vaccinations this month could already be met with the initial deliveries. 50 to 70 million individuals are targeted to be inoculated within this year.

Before these individuals are served, however, health workers and frontliners from select government offices will be prioritized first, to be followed by senior citizens and other indigents. That's if the government's vaccination roadmap is to be followed.



Poor arts month

While in other places, the celebration of February as Arts Month is marked with several activities, it's not quite clear how it's being observed in Eastern Visayas, in Region 8. I do not say that there are no activities at all;

I say, the observance is not that clear.

It's really up to the organizers to make their celebration felt and seen. They've got to exert some effort in disseminating their planned activities, and not just rely

on selected information outlets. They have to maximize avenues through which they can reach out, first of all, to deserving participants, and secondly, to the potential audiences. If they need to solicit from sponsors, they need to do it ahead of time.

As observed by those who have had chances of taking part in these activities, certain problems are plaguing the celebration activities of organizers, who are normally artists themselves. As a result, the observances hardly make an impact, making no difference at all. Let me mention some of these ills in passing.

In literary arts, that is, among creative writers writing literary pieces in Waray,

there is this seeming monopoly of the writing craft, awards, grants, and literary production by a group that tends to be exclusive only for writers from their shared academic institution. Instead of accommodating members from other groups and individual writers, they formed a clique that is arrogantly discriminatory of others.

Other writers and their works are hardly welcome, then, and even if they make it to the membership, they are made to feel inferior, their works and skills hardly recognized. One has to beg or be a "sipsip" in order to at least find a lowly place in this group that blas-





Amid AFS scare, Mayor Petilla extends ban on selling pork meat in Palo until Feb.17

TACLOBAN CITY -Palo town Mayor Frances Ann Petilla of Palo in Leyte had extend the temporary ban for selling of pork meat and pork products until February 17.

Under Executive Order No. 10 she signed slaughtering of pigs at their slaughter house and in the entire town is also prohibited.

The temporary ban of slaughterhouse operation was first ordered last Feb. 3 to 6 to give way for the disinfection and sanitation, and prohibited its operation for three days after the disinfection period or until Feb 10.

Petilla also prohibits transporting pigs inside and outside of the munic-

Earlier Petilla issued EO No. 5 last Feb. 8 to prevent the further spread of African swine fever(ASF) that was recorded at Purok Banog, Barangy Baras last January 31.

To enforce the EO, the mayor ordered the chief of the Palo Municipal Station, Palo Auxiliary Traffic Office (PATO), and the Municipal Agriculture Office (MAO) to intensify their border control and checkpoints to prevent transporting of live pigs inside and going out of the mu-

DENR-8 to continue processing agricultural, residential free patents issuance this quarter

TACLOBAN CITY -The acceptance of applications for agricultural free patent will be continued for this quarter by the Department of Environment and Natural Resources regional office 8 (DENR-8).

DENR Regional Executive Director Tirso Parian, Jr. said that their office will continue to prioritize issuance of free patents this quarter to qualified applicants under its Improved Land Administration and Management priority pro-

"For the first quarter of this year, we will continue to process the agricultural free patent applications received by the Community Environment and Natural Resources Offices (CENROs) before the deadline set by the law. The office will resume the acceptance of agricultural free patent applications once the bill seeking for its extension will be passed by Congress," Parian said.

The issuances of free agricultural patents have ended last December,2020 pursuant to Republic Act 9176, otherwise known as the Public Land Act of 2002

Parian reported that in 2020, the regional office was able to process and issue 1,210 agricultural free patents with a corresponding area of 1, 231.0553 hectares and 2,200 residential free patents with an equivalent area of 50.2024

The patents issued by the DENR is then transmitted to the Register of Deeds (ROD) for the issuance of title, he added.

"Our aim is to accelerate the issuance of free patents to qualified applicants so that these land owners could finally attain security in their land tenure," Parian said.

Parian explained that through the conduct of Rapid Land Tenure Appraisal (RLTA), the DENR seeks to determine the number of workable lots in cities and municipalities covered by cadastral survey for the issuance of both agricultural and residential free patents.

For 2021, the target municipalities for the RLTA activities are Lapinig in Northern Samar, Villaba in Leyte, Malitbog in Southern Leyte, Culaba in Biliran and Basey in Sa-

Gov. Evardone creates COVID-19 vaccine deployment task force for Eastern Samar

Eastern Samar Governor Ben Evardone has issued an executive order creating a COVID-19 vaccine deployment task force.

The creation of a provincial task force by Evardone, of which he will act as its chairman, is in compliance on a directive of the Department of Interior and Local Government (DILG) for mayors and governors to come up with their guidelines on the vaccination program on the coronavirus disease (COVID-19) as the country prepares for the roll out of the vaccines expected within this month.

Based on Executive Order 02-002 Evardone issued on Feb.11, different provincial officials, to include the Department of Health(DOH), the Philippine National Police, and the Philippine Army will be involved in the program to ensure an 'effective 'vaccination program in the province which is composed of 22 towns and the

city of Borongan.

The Provincial Health Office, under the same order, was designated to lead the provincial vaccine operation center.

In the same order, the governor also directed all local government units in the province to establish their own vaccine deployment task force.

Under the executive order, technical working groups are to be form which will be in charged in the procurement and finance; immunization program; vaccine cold and logistics management; and demand generation and communication which will be in charge in the development of multi-media promotional campaign materials.

Evardone earlier said that during their listing up of individuals from the municipalities and Borongan of the province relative to the COVID-19 vaccination program, there were individuals who expressed that

they would not take the inoculation fearing possible side effects.

The provincial government is setting aside P500 million in the procurement

of anti-COVID- vaccines and other needed equipment and is now in the process of negotiation with AstraZeneca and Moderna. (JOEY A. GABIETA)

AN ORDINANCE REQUIRING PERSONS WITHIN THE TERRITORIAL JURISDICTION OF MAPANAS, NORTHERN SAMAR WITH CONFIRMED CASES OF COVID-19, CLOSE CONTACTS, RETURNING OVERSEAS FILIPI-NOS (ROFs), AND LOCALLY STRANDED INDIVIDUALS (LSIs) TO UNDERGO MANDATORY QUARANTINE AND ISOLATION IN A QUARANTINE AND ISOLATION FACILITIES OF THE LOCAL GOVERNMENT UNIT OF MAPANAS AND PRESCRIBING PENALTIES HEREOF.

WHEREAS, R.A. No. 9271 (Quarantine Act of 2004) provides to protect and promote the health of the people by ensuring maximum security against the introduction or spread of diseases subject to the International Health Regulations, particularly emerging diseases and public health emergencies of international concern;

WHEREAS, it is the policy of the state to protect and promote the right to health of the people and instill health consciousness among

WHEREAS, Paragraph 5, subparagraph xii of Republic Act No. 7160 otherwise known as "The Local Government Code of 1991" states that 'The Sangguniang Bayan, as the legislative body of the municipality," shall "Approve measures and adopt quarantine regulations to prevent the introduction and spread of disease";

NOW THEREFORE, BE IT ORDAINED AS IT IS ORDAINED, by the Sangguniang Bayan of Mapanas, Northern Samar by virtue of the power vested in it by law, in session assembled that:

SECTION 1. Title - this ordinance shall be known as the "Mandatory Quarantine and Isolation Ordinance of Mapanas, Northern Samar"

SECTION 2. Mandatory quarantine and isolation – all persons within the territorial jurisdiction of Mapanas, Northern Samar with confirmed cases of COVID-19, Close Contacts, Returning Overseas Filipino (ROFs), and Locally Stranded Individuals (LSis), shall undergo mandatory quarantine, isolation and treatment in a quarantine and isolation facilities of the LGU-Mapanas until cleared by the Municipal Health Officer or the Attending Physician to prevent the spread of COVID-19 that may endanger public health.

SECTION. Definition of Terms – the following term as used in this Ordinance shall mean:

- a. Isolation refers to the separation of a person or people known or reasonably believed to be infected or contagious of COVID-19 from those who are not infected in order to prevent spread of the disease
- b. Quarantine in general means the separation of a person or people reasonably believed to have been exposed to COVID-19 from others who have not been so exposed in order to prevent the possible spread of the disease.
- c. Close Contact for purposes of this Ordinance it shall refer to a person or persons who may have been in close contact whether first, second or third contact with a suspected or confirmed case of COVID-19.
 - d. ROFs Returning Overseas Filipinos.
 - e. LSI's Locally Stranded Individuals. LSIs can be classified into:
 - i. Workers:
 - ii. Students;
 - iii. Tourist; and
 - iv. Other individuals stranded in various localities while in transit.

SECTION 4. Prohibited Acts

a) Non-coop of the persons or persons with confirmed cases of COVID-19, close contacts, ROFs and LSIs to undergo mandatory quarantine and/or isolation.

b) Non-cooperation of persons or persons who has knowledge with regards as to person or persons with confirmed cases of COVID-19, close contacts, ROF's and LSIs that sould report and/or respond to such cases.

RDINANCE

SECTION 5. Penalty

i. Any person found to have violated this Ordinance shall be penalized with a fine of Two Thousand Five Hundred Pesos (Php2,500.00) and an imprisonment of Thirty (30) days.

If the violator is a government official, he/she shall be subject to disciplinary actions under Sec. 60 (c) of R.A. 7160 otherwise known as "The Local Government Code of 1991", for elective officials and under the Civil Service Law and Rules for non-elective government employees, without prejudice to the filing of appropriate civil or criminal charges as prescribed by law.

SECTION 6. Enforcement – Authority is hereby granted to the Municipal Mayor and his subordinate, Punong Barangays, the Chief of Police in coordination with the Municipal Health Officer, to strictly enforce this Or-

SECTION 7. Separability Clause – If any provision of this ordinance is held invalid or unconstitutional by the reviewing authority, other provision not affected shall continue to be in full force and effect.

SECTION 8. Repealing Clause - All ordinances, resolutions, Circulars,

Memorandum or Rules and regulations inconsistent with the provision of this Ordinance are hereby repealed and modified accordingly.

SECTION 9. Effectivity Clause – this ordinance shall take effect ten (10) days after its approval and posting on conspicuous places.

WHEREAS, in pursuance to DILG Circular No. 2020-087, dated May 21, 2020, relative to the necessary actions for LGUs in the management of Returning Overseas Filipinos (ROF) and Locally Stranded Individuals (LSI) Amid Pandemic;

WHEREAS, paragraph d, Title IV of DILG Circular No. 2020-87, dated May 21, 2020 state that "All receiving LGUs shall not deny entry of LSIs with complete requirements, provided that prior coordination was made through the NTF and/or Regional Task Force (RTFs), and other concerned agencies as deemed necessary, xxx;

WHEREAS, Paragraph 5, subparagraph xii of Republic Act No. 7160 otherwise known as "The Local Government Code of 1991" states that "The Sangguniang Bayan, as the legislative body of the municipality," shall "Approve measures and adopt quarantine regulations to prevent the introduction and spread of disease.";

WHEREAS, due to the limited quarantine facilities of the LGU, there is a need to control the number of returning overseas Filipinos and locally stranded individuals to be able to cater and accommodate the needs of the former and the latter and also the safety of every mapanasnon;

NOW THEREFORE, BE IT ORDAINED AS IT IS ORDAINED, by the Sangguniang Bayan of Mapanas, Northern Samar by virtue of the power vested in it by law, in session assembled that:

SECTION 1. Short title - this ordinance shall be known as the "Mandatory Pre-Travel Coordination Ordinance for ROFs/LSIs of Mapanas

SECTION 2. Scope of Application – this ordinance shall cover all ROFs and LSIs who violated the provisions of this ordinance.

SECTION 3. Definition of Terms - for purposes of this ordinance, the following terms shall have the corresponding meaning:

- **COVID-19** Corona Virus Disease 2019.
- **ROFs** Returning Overseas Filipinos.
- <u>LSIs</u> Locally Stranded Individuals. LSIs can be classified into:
 - i. Workers:
 - ii. Students;
 - iii. Tourists; and
 - iv. Other individuals stranded in various localities while in
- transit. d. LGU-CP – Local Government Unit-Contact Person for ROF/LSI.
- MIATF Municipal Inter-Agency Task Force.
- f. Point of Departure refers to the place where the ROF/LSI departs upon travel.

SECTION 4. Administrative Procedures – the following shall be observed in the implementation of this Ordinance:

- Prior to the Commencement of Travel The ROF/LSI bound to any appoint of destination within the territorial jurisdiction of the municipality of Mapanas shall:
- 1. Ten (10) days before the target date of travel to Mapanas, the ROF/ LSI shall: call or thru informant, (relatives, or friends living in Mapanas) inform the LGU-Contact Person of the details of his/her intended travel to Mapanas.
- 2. The LGU-Contact Person shall make the necessary arrangements of travel coordination keeping in mind the availability of space-accommodation at the isolation facilities for ROF/LSI upon arrival.
- 3. The LGU-Contact Person, shall then advice the ROF/LSI or thru his informant the date the ROF/LSI should arrive in Mapanas, in order for them to make adjustments of schedule of actual travel. "Without such advice the ROF/LSI should not leave or start travel." Observed the "No Advice No Travel Policy". The LGU-Contact Person shall provide the ROF/ LSI or his/her informant with his access/contact number or post the same to any social media platform.
- 4. Should there be changes of travel schedule due to unpredictable circumstances the ROF/LSI or his informant shall immediately notify the LGU-CP of the latest change of travel schedule.

While on travel - The ROF/LSI and LGU-CP shall:

- 1. From time to time call the LGU Contact Person to report his/her whereabouts or status of travel.
- 2. The LGU-CP shall periodically monitor the whereabouts of the travelling ROF/LSI and advice him/her of travel protocols prescribed by

Third and Succeeding Offenses -

the MIATF.

3. The ROF/LSI shall strictly observe travel protocols prescribed by the MIATF i.e., riding on transport facilities duly provided by the Mapanas-MIATF.

SECTION 5. Prohibitions – Any Uncoordinated travel of ROF/LSI and unauthorized transport facilities either by land or by water to transport ROF and/or LSI are hereby prohibited under this Ordinance.

SECTION 6. Penalty Clause – The following penalties are hereby prescribed for violation of this ordinance:

- i. ROF/LSI found violating any provisions of this Ordinance shall be referred to as uncoordinated and unauthorized ROF/LSI shall be imposed a fine of Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of seven (7) days or both upon discretion of the court. The penalty of imprisonment shall commence after completion of the prescribed quarantine period.

WHEREAS, in an effort to lessen or minimize noise pollution in our municipality the Sannguniang Bayan following the directives of the DILG Secretary to pass ordinance prohibiting excessive noises during online classes. To adjust learning system due to COVID-19.

NOW THEREFORE, BE IT ORDAINED AS IT IS ORDAINED, by the Sangguniang bayan of Mapanas, Northern Samar by virtue of the power vested in it by law, in session assembled that:

AN ORDINANCE REGULATING THE USE OF VIDEOKE/KARAOKES AND OTH-ER SOUND PRODUCING DEVICES WHICH TEND TO DISTURB THE COM-MUNITY IN TIMES OF ONLINE AND BLENDED CLASSES OF THE STUDENTS DURING MONDAY TO SATURDAY IN THE MUNICIPALITY OF MAPANAS, NORTHERN SAMAR.

SECTION 1. Title - this ordinance shall be known as the "Regulation of Videokes/Karaokes and other Sound Producing Devices Ordinance".

SECTION 2. Definition of Terms

- a. Videoke/Karaoke any equipment or musical instrument comprising of a television set or monitor, video player, amplifier, speakers microphones, and any sound system used for sing-along whereby lyrics of song with accompanying visual backdrops are seen on a monitor screen.
- b. **Sound Amplifying Equipment** any machines or device that is used for the amplification of human voice, music or any other sound.
- c. Noise Pollution also known as noise disturbance; is the distributing or excessive noise level and that which can still be heard after a distance of at least 50 feet from the source.
- d. Nuisance A nuisance is any act, omission, establishment, business, condition of property, or anything else which:
 - 1. Injuries or endangers the health or safety of others; or
 - 2. Annoys or offends the senses; or
 - 3. Shocks, defies or disregards decency or morality; or
- 4. Obstructs or interferes with the free passage of any public highway or street, or any body of water; or
 - 5. Hinders or impairs the use of property.

SECTION 3. Prohibited Acts - any person or persons, business establishment who cause excessive, unnecessary or unusual loud sound or nuisance through the use of videoke/karaoke and other sound amplifying equipment in the Municipality of Mapanas, which annoys, offends, disturbs, injures, endanger the comfort and safety of people especially during online classes, school work, and other activities of students during Monday to Saturday in this new normal blended system shall be unlawful and punishable under this ordinance.

SECTION 4 Exceptions

- Existing business establishment that are engaged in the entertainment are required to provide effective soundproofing of their establishment to maintain a tolerance noise level outside.
- b. Special occasions such as Christmas, New Year, Fiesta Celebration, Municipal, Barangay and Religious activities and the likes.
 - c. Private occasions such as birthday party, weeding, and other similar

activity, and the above stated paragraph shall be properly complied with.

d. All the exceptions mentioned above shall secure necessary clearance/approval from the Municipal Inter-Agency Task Force (MIATF) to operate and/or continue with the said events.

WHEREAS. Republic Act No. 10601, otherwise known as the "Agricultural and Fisheries Mechanization Law" was enacted on June 5, 2013.

WHEREAS. Section 9 of RA No. 10601 mandates that all owners of agricultural and fishery machinery and equipment to register their agricultural and fishery machinery and equipment with the agricultural offices of the municipal and city government.

WHEREAS, pursuant to Section 19 of RA No. 10601, the Department of Agriculture and the Department of Interior and Local Government (DILG) issued a joint Memorandum Circular (MC) No. 2019-02 dated August 2, 2018 providing for the national guidelines on the registration of ownership of agricultural and fisheries machinery and equipment at the city and municipal government units.

WHEREAS, the purpose of the joint Memorandum Circular (MC) is to establish ownership and create a national database of machinery and equipment for planning and monitoring purposes, in accordance of RA No. 10601.

WHEREAS, the registration of agricultural and fisheries machinery and equipment in the Municipality of Mapanas, Province of Northern Samar would ensure the quality and safety of agri-fisheries government investment and resources.

WHEREAS, the DA, DBM, DILG, and CSC, pursuant to Section 29 of RA No. 10601 issued a joint Memorandum Circular (MC) No. 02, S-2020 mandating all LGUs to strengthen or create their Provincial. City and Municipal Agricultural Engineering Groups, separate from of that CAO/ MOA to undertake, among others the registration of agricultural and fisheries machinery and equipment.

NOW THEREFORE, BE IT ORDAINED AS IT ORDAINED BY THE SANG-GUNIANG BAYAN OF MAPANAS, NORTHERN SAMAR BY VIRTUE OF THE POWER VESTED IN IT BY LAW, IN SESSION ASSEMBLED THAT:

AN ORDINANCE INSTITUTING AND IMPLEMENTING THE REGISTRA-TION OF OWNERSHIP OF AGRICULTURAL AND FISHERIES MACHINERY AND EQUIPMENT IN ACCODANCE WITH THE JOINT MEMORANDUM CIRCULAR NO. 2018-02 BY THE DEPARTMENT OF AGRICULTURE AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT RELATIVE TO THE NATIONAL GUIDELINES FOR THE REGISTRATION OF OWNER-SHIP OF AGRICULTURAL AND FISHERIES MACHINERY AND EQUIPMENT WITHIN THE MUNICIPALITY OF MAPANAS, PROVINCE OF NORTHERN SAMAR

Introduced by: HON. MARCIAL G. BARNOBAL Co-Sponsored by NORA B. BANDILLA

SECTION 1. Short Title - This ordinance shall be known as the "Mandatory Registration of Ownership of Agricultural and Fisheries Machinery and Equipment" (MROAFME) in the Municipality of Mapanas, Province of Northern Samar.

SECTION 2. Scope/Coverage - This ordinance shall cover a one-time registration of ownership of both new and currently used agricultural and fisheries machinery and equipment by any individual owner, registered farmer-cooperatives and farmers association and private entities. which are registered by SEC, DTI, DOLE, or CDA. The said agricultural and fisheries machinery and equipment are used for crop, livestock and fisheries production, harvesting, processing, storage, manufacturer, preserving transporting and distribution research extension and instruction which included but are not limited to the list of agricultural and fisheries machinery and equipment enumerated in "annex A." furthermore, agricultural and fisheries machinery and equipment owned and operated by government entities are likewise covered by this regulation.

SECTION 3. Definition of Terms - For purposes of this ordinance the following terminologies are use and defined as follows:

- a.) Agricultural and Fisheries Machinery refers to machinery and equipment for the production, harvesting, storage, manufacturer, preserving, transporting and distribution of agricultural and fisheries products. These include, but not limited to transfer and their attachment power tillers, seeders, transplanters, windmills, harvesting machines, crop protection and maintenance equipment, irrigation equipment and accessories, greenhouses, and other thermal conditioning equipment, livestock equipment, fishery equipment, slaughtering equipment, meat/fishery and crop processing equipment, post-harvest machines such as milling machines, dryers, threshers, grain and other strippers, agricultural transport machineries and storages facilities including cold storages, reefer vans, slaughter houses, and fishing boats of three (3) gross tons or less. New agricultural and fishery machinery includes newly imported as well as one that has not been used since its date of man-
- b) Processing Complexes integrated system of equipment and facilities for processing of agricultural and fisheries products.

SECTION 4. Registry of Agricultural and Fisheries Machinery and Equipment - The Municipal Agriculture Office (MAO) of Mapanas shall maintain and update a registry of agricultural and fisheries machinery and equipment (AFME). This function shall be transferred to and assumed by the municipal agriculture and engineering office division the moment it will be created and fully operational pursuant to Section 29 of RA No. 10601 and joint Memorandum Circular No. 02-S-2020, otherwise known as the "Implementing Guidelines on the Strengthening and Establishing of the Agricultural and Biosystems Engineering Groups of the Local Government Units."

a.) The Municipal Agriculture Office (MAO) shall hire one (1) trained agricultural and biosystems engineer/s (ABE) to undertake the registration, and if in-case it does not have shall hire at least one (ABE) and have

- b.) The list of newly registered agricultural and fisheries machinery and equipment with complete information shall be uploaded monthly to the server of Philippines Center for Post-harvest Development and Mechanization-Agricultural and Fisheries Mechanization and Engineering Resources Network. Likewise this shall be submitted by the Municipal Agriculture Officer (MAO) to the Agricultural Engineering Division of the Provincial Agriculture Office (PAO) for consolidation report shall be endorsed to the Department of Agriculture Regional Agricultural Engineering Division (RAED) copy furnished the Barangay Office.
- c.) The machinery owner shall report to the Barangay Office when the machinery and equipment that are no longer operational so that these can be deleted from the registries of the municipal agriculture office (MAO).

SECTION 5. Registration of Agricultural and Fisheries Machinery and Equipment Presently Registered by other Concerned National Government Agencies - The registration of agricultural and fisheries machinery and equipment presently being undertaken by concerned government agencies, such as by the Bureau of Fisheries and Aquatic Resources (BFAR) for fishing boats, Philippine Coconut Authority (PCA) on oil mills and other concerned national government agencies shall be included in the registry of agricultural and fisheries and machinery equipment of the municipality.

SECTION 6. General guidelines for the issuance of Certificate of Agriculture and Fisheries Machinery and Equipment Registration (CAFMER) The owner/user of agricultural and fisheries machinery and equipment shall submit to the Engineering Division of the Municipal Agriculture Office (MAO) the following documents:

- a. Certificate of Location/Address of the owner of Agricultural and Fisheries Machinery Equipment from the Barangay Office.
 - b. Duly accomplished prescribed registration Form as per "Annex B" and
- c. Any evidence of acquisition/ownership of agricultural machinery and equipment such as Delivery Receipt (DR), Sales Invoice (SI), Official Receipt (OR), Deed of Donation, Memorandum of Agreement (MOA), Memorandum of Understanding (MOU). In cases that these documents are not available, the Barangay office where the owner resides shall execute an affidavit attesting to the lawful ownership of the machinery or equipment.
- d. The Engineering Division of the Municipal Agriculture Office shall verify and evaluate the submitted documents upon finding that the owner of the machinery/equipment has complied with the documentary requirements and has paid the registration fees, the Municipal Agriculture Office (MAO), shall process and recommend the issuance of (CAFMER) "Annex C" of approval by the Municipal Mayor or his duly authorized representative.
- e. The registration sticker shall be issued by the Municipal Agriculture Office (MAO) after the application form has been approved. The Municipal Agriculture Office (MAO) shall keep the approved CAFMER and ensure that the registration is uploaded to the "Philippine Center for Post-Harvest Development and Mechanization-Agricultural and Fisheries-Mechanized and Engineering Resources Network: (PhILMechERN).
- f. The data of the registered agricultural and fisheries machinery and equipment will be linked to the PhilMech-AFMechERN server upon regis-

SECTION 7. Procedure in case of amendment to the Certificate of Agricultural and Fisheries Machinery and Equipment Registration (CAFMER) The Office of the Municipal Mayor shall issue a Certificate of Clearance and an amended CARFMER in the following instances:

- a. Transfer of ownership of the agricultural and fishery machinery and equipment the documents stated in the proceeding section, the original Office of the Municipal Mayor shall issue a Certificate of Clearance and an amended CARFMER in the following instances:
- a. Transfer of ownership of the agricultural and fishery machinery and equipment the documents stated in the proceeding section, the original CAFMER and Certificate of Clearance shall be required in the application for the amended CAFMER.
- b. Transfer of location of another city or municipality, a new registration form shall be secured which shall be approved by the municipality which the owner has transferred.
- c. The Municipal Agriculture Office (MAO) of origin shall delete the agricultural and fisheries machinery and equipment in the list of registration, of such machinery and equipment in the municipality. Likewise, the machinery owner shall report to the Municipal Agriculture Office (MAO) on any non-serviceable machinery and equipment so that these can be deleted from the registries of the MAO. The issuance of the amended CAFMER will require the owner to undergo another registration process. Thus, as provided for by the ordinance.
- d. In the event that such machinery or equipment are involved in any criminal or civil cases regarding question of ownership as reported by the Barangay Officials, no Certificate of Clearance shall be issued by the Municipal Agriculture Office (MAO).

SECTION 8. Registration Fees - The registration fees of agricultural and fisheries machinery and equipment including livestock shall be "Five Hundred Pesos (Php500.00) inclusive of the coast of the registration plate to be issued by the MAO to the owner. While livestock for "One hundred Ten Pesos" (Php.110.00).

The agricultural and fishery machineries and equipment owned by duly registered under RA No. 6810 (Magna Carta) for Countryside and Barangay Business Enterprises (Kalakalan 2000) and RA No. 6939 (Cooperative Code of the Philippines) shall be exempted from payment of registration fees, pursuant to Section 133 of the Local Government Code of 1991.

SECTION 9. Incentives for the Registration of Agricultural and Fisheries Machinery and Equipment:

- a. Registration maybe used in the availment government incentives
 - b. Registered machinery maybe used as loan collateral:
- c. Registration will facilitate the location of lost agricultural and fisheries machinery units.
- d. Availment of Common Service Facilities (CSF) services in the municipality, and

The Municipal Agriculture Office (MAO) shall coordinate with the Philippine Crop Insurance (PCIC), for the most appropriate insurance packages for agricultural and fisheries, implements in reference to the registry system for basic sector (RSBSA) of the DA-ICTS.

SECTION 10. Public Information Campaign - The Municipal Agri-

culture Office (MAO) in collaboration with Barangays Council and other offices shall undertake information campaign on the implementation of the registration of ownership of agricultural and fishery machinery and SECTION 11. Funding - Funding for the implementation of the regis-

tration of agricultural and fisheries machinery equipment which include the hiring of employee, purchase of registration equipment (QR Printer etc.) and other activities on the registration of ownership of agricultural fishery machinery and equipment shall be incorporated in the annual work financial plan of the Municipal Agriculture Office (MAO) of the municipal government.

SECTION 12. Prohibited Acts - it is unlawful for any person to:

- a. Sell, mortgage, or lease agricultural and fisheries machinery and equipment.
 - b. Operate a testing center without proper accreditation.
- c. Claim of ownership to an agricultural and fishery machinery that has not bee properly registered in his/her name, and
- d. Slaughtering of Livestock's as provided under Section 3 (a) of this

SECTION 13. Penalties - any person who shall violate any provision of this ordinance shall upon conviction of the proper court, be subject to pay a fine of not less than "One Thousand Pesos (php. 1,000.00) but not more than "Two Thousand Pesos (php. 2,000.00) or an imprisonment of Two (2) months but not more than Five (5) months depending upon the descretion of the court of jurisdiction.

SECTION 14. Repealing Clause - All existing ordinances, rules and regulation as well as orders inconsistent herewith are hereby repealed or modified accordingly.

SECTION 15. Separability Clause - Should any of these clauses or parts of this ordinance be declared unconstitutional by any court of competent jurisdiction, all others remaining portions not so declared shall remain valid and effective.

SECTION 16. Effectivity Clause - This Ordinance shall take effect Ten days after its approval and a publication of official gazette of general

WHEREAS, Article 16 of the Family Code further requires couple applying for marriage license, whose ages fall between 18-25 years old, to undergo marriage counseling by a marriage counsellor duly accredited by the Department of Social Welfare and Development (DSWD).

WHEREAS, joint Memorandum Circular (JMC) No. S-2018, Revised Pre-Marriage Orientation and Counseling (PMOC) Program Implementing Guidelines for 2018 was issued by the Commission on Population and Development (POPCOM), Department of Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), Department of Health (DOH), and the implementation of the Pre-Marriage Orientation and Counseling (PMOC) Program at the Icoal government level.

WHEREAS, Memorandum Circular No. 2019-182 Adoption of the Revised Pre-Marriage Orientation and Counseling (PMOC) program Implementing Guidelines for 2018 was issued by the Department of Interior and Local Government (DILG) enjoining all Local Government Units (LGU), to adopt the said JMC No. 1.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF MAPANAS, NORTHERN SAMAR IN SES-SION ASSEMBLED THAT:

AN ORDINANCE STRENGTHENING THE PRE-MARRIAGE ORIENTATION AND COUNSELING (PMOC) PROGRAM IN THE MUNICIPALITY OF MAPANAS PROVINCE OF NORTHERN SAMAR

SECTION 1. Short Title - This Ordinance shall be known as the "Pre-Marriage Orientation and Counseling (PMOC) Program of Map-

SECTION 2. Definition of Term - For purposes of this Ordinance the following term shall mean:

- a. Pre-Marriage Counseling is a counseling session which aims to provides would-be couples with a basis for making informed and responsible decision about to marry or not.
- b. Marriage Applicants are couples who have formally applied for pre-marriage counseling and who intent to live together as husband and
 - c. Couple a mand and a woman, aged of 18 years old and above.
- d. Pre-Marriage Counseling Team (PMCT) a team composed of members from the Municipal Population Management Officer (MPMO) or any designated employee by the Municipal Mayor, Municipal Social Welfare Development Officer (MSWDO), Municipal Health Officer (MHO), Municipal Civil Registrar (MCR) SB Member committee on Women and Family Relation and accredited (NGOs) by the National Sta-
- e. Kasalan ng Bayan/Barangay refers to a mass wedding ceremo-

f. Individual Voluntary Statement Form - a documents duly signed by the marriage applicant, and attested to by the Barangay Captain or incharge of the Barangay declaring their free will to marry each other

SECTION 3. Declaration of Policy - It shall be the policy of the Municipal Government of Mapanas, Northern Samar to:

- a. Recognize marriage as an inviolable social institution and the foundation of the family which turns is the foundation of the nation.
- b. Protect and strengthen the family as a basic autonomous social institution
- c. Ensure couple are fully informed and equipped with the necessary knowledge and skills in their expected rules and responsibilities as husband and wife, future parents and protective members of the society; and
- d. Provides Pre-Marriage Orientation and Counseling sessions to all contracting parties who are about to get married/require all contracting parties who are about to get married to attend Pre-Marriage Orientation and Counseling.

SECTION 4. Adoption and Implementation of Joint Memorandum Circular No. 1, Series of 2018 on the Pre-Marriage Orientation and Counseling (PMOC) Program Implementing Guidelines of 2018 - The current Pre-Marriage Counseling Program shall be strengthened through the adoption and implementation of the relevant provisions of the JMC No. 1, and also by enacting ordinances of the respective LGUs attached hereto and made as an integrated part of this local laws. Accordingly, the program be reorganized as Pre-Marriage Orientation and Counseling (PMOC) Program, which will provides the requisites pre-orientation and counseling sessions to contracting parties applying for marriage license.

SECTION 5. Organization and Mobilization of the Local PMOC Team A local PMOC Team shall be organized to oversee and efficiently perform the functions prescribed in the Joint Memorandum Circular No. 1, S-2018. The PMOC shall be composed of:

- a. Municipal Population Officer/Any Appointed or Designated by the Municipal Mayor as (MPO) act as Chairman.
 - b. Adriano L. Orio (MCR) Vice Chairman
 - c. Annabel E. Aboy (MNAO) Member
 - d. Mary Ann J. Constantino (MSWDO) Member
 - e. Dr. Alvi Kussela B. Tejano (MHO) Member
- f. Hon. Jesusita C. Bernadas SB committee on Children & Family Relation (Member)
 - g. Civil Society Organization (CSO) (Member)

The Municipal Population Officer (MPO) or any designated employee by the Local Chief Executive (LCE) will provides Secretariat support to the local Pre-Marriage Orientation Counseling Team and the implementation of the PMOC Programs.

SECTION 5. Training of the PMOC and the Accreditation of the PMOC Counselors - To equip the members of the PMOC Team with the needed competency to the implementation of the program, all members of the team skill undergo relevant trainings to coordination and collaboration with the national government.

The Local PMOC team shall also have at least one (1) accredited Pre-Marriage Counselor who will provides pre-marriage counselor session pursuant to the family Code (EO 209). Initially, the member from the local MSWDO other members will be supported by the LGU to be able to complete the accreditation of the DSWD.

SECTION 6. Meeting - The Pre-Marriage Counseling Team representatives shall meet once every three (3) months as deemed necessary to discuss matters affecting the PMC Programs, likewise all pre-marriage counselors from different offices shall meet once every semester or as necessary to discuss PMC matter.

SECTION 7. PMOC Protocols - The processes and procedures for the issuance of PMOC certificates shall comply with the prescribed protocols under JMC No. 1, S-2018. It shall be the responsibility of the PMOC Team to inform about the protocols for compliance.

SECTION 8. Kasalan Ng Bayan/Kasalan ng Barangay (KMP) - The following requisites shall observed in the conduct of kasalan ng Bayan/Kasalan ng Barangay Pre-Marriage Counseling.

- a. The Barangay or Church and other organization requesting for Kasalan ng Barangay/Bayan Pre-Marriage Counseling should have at least Ten (10) couple applicants.
- b. Two weeks prior to the activity, the requesting barangay/church and other organizations should send a written communication to the member of the Pre-Marriage Counseling Team stating the venue.
- c. The names of the couple applicants should be submitted to the secretariat one (1) week prior to the PMC for listing.

SECTION 9. Certificate of Compliance - No marriage license shall be issued by the Local Civil Registrar (MCR) unless the applicants present a certificate of compliance issued by the Pre-Marriage Counseling Team. Certifying that they had duly received adequate instruction and information on responsible parenthood, family planning, breastfeeding and infant nu-

SECTION 10. Pre-Marriage Counseling Fee - upon registration for Pre-Marriage Counseling Seminar, couple applicant shall pay to the Mu-

nicipal Treasurer's Office the amount of (php. 22.00) for family planning counseling fees and other marriages related fees as provided for under Section 248 of the Revised Revenue Code of 2019.

SECTION 11. Reporting - The Local PMOC Team shall maintain a PMOC database and regularly consolidate program implementation reports. The said reports of accomplishment shall be submitted to the Local Chief Executive (LCE) and the PMOC Provincial and Regional Technical Working Groups (TWGs) annually.

SECTION 12. Confidentiality of the Database - Personal details of the contracting parties shall be stored and maintained confidentially by the PMOC Team. The PMOC Team must observe and respect the data privacy rights of the contracting parties. The use of any personal information collected, stored and processed under the PMOC Program shall be subject to the rules and regulations provided for by the data privacy Act of 2012 or RA 10173.

SECTION 13. Appropriation - The needed annual allocation for the efficient implementation of the PMOC program shall be proposed under the budget proposal of the local population office. (Or the department where the local population office is attached). Moreover, all local departments and participating in the implementation of the PMOC Program shall allocate in their respective Annual Investment Plan (AIP) the needed funding.

Furthermore, the PMOC Team may prescribed funding strictly for the procurement of the needed supplies and materials for program implementation and connecting trainings of the PMOC Team implementers.

SECTION 14. Administrative Penalty - government employee/s who fail to comply with the provision of this Ordinance shall be penalized in accordance with the Civil Service Commission (CSC) rules and regula-

"I am appealing to the institution benevolent of the Sangguniang Panlalawigan to please stop the mining activity in MacArthur," he said during the hearing that lasted for almost two hours which started at 11:20 am.

During the hearing, the committee through Vice Governor Carlo Loreto asked the two contending parties to submit documents to formally substantiate their respective claims for them to take action.

But Fr. Alvero said that

the ongoing mining activity involving black sand extraction in MacArthur could result to destruction of the environment and affect food security of the town as the mining areas are considered as 'prime agricultural lands' producing

In his pleadings, Alvero said that he is just consistent with one of the advocacies of the Church which is to protect the environment.

He also said that the town has a bad experience with previous mining activities, leaving behind their mining areas widely open and not being rehabilitated.

"MacArthur has experienced irresponsible mining activities. None of these mining companies conducted rehabilitation," Alvero said.

But Januar Ong, communications officer MICP, maintained that they are into 'progressive mining operations.'

This way, the area would remain productive and could still be planted.

"(And) we cannot be held answerable to the sins of the previous mining companies. We are not connected to any of these mining companies. I think it is not fair for us to be labeled as irresponsible. We have just started our operation and in fact, we are now in the process of rehabilitation," he said.

Pamana projects' beneficiaries informed De Mesa some of their concerns that could help increase their income productivity, like the banana producers of Sitio Rizal Farmers Association who informed him that they need a truck to deliver their product to the

At present, they rely to the availability of truck of the provincial government that delivers their crops to Catbalogan City.

The tikog producers of Loog village also sought help from the official on their problem in the marketability and pricing of their products.

Pamana beneficiaries with concerns are advised by the official to make a proposal which they promised to forward to concern agencies like OPPAP.

"What we can commit is we will work for the approval of the project proposal," De Mesa said.

Although most of the Pamana beneficiaries whom he met relayed their concerns, there were also who made a positive impact during his visit, like the Basey Farmer Rainfeed Producer Association, who are recipient of more than P3 million assistance for rice production.

The group with 106 members received the assistance in 2019 wherein the fund was used by the members in rice production. They then expanded their business last year into a small grocery store and bought a truck which they uses in delivering palay to their buyers.

"They can be cited as example for best practice, from a small business, they have now big store and a truck," De Mesa said.

The official added that with the help of other government agencies, OPPAP through Pamana will work together for the peace and development of areas that are benefiting from projects funded by their agency.

"Our approach in the project implementation is through the CSPP or conflict, sensitive, and pace promoting. Meaning it will contribute to the peace process and address issues or the basic needs of the community in the conflict affected areas especially those that are geographically isolated and depress areas, "he said.
