# The region needs at least 3 million doses Gov't conducts dry run on arrival of anti-COVID vaccines in EV

TACLOBAN CITY-A simulation on the transportation and delivery of anti-COVID-19 vaccines was staged by different government agencies on Wednesday (Feb. 17) to ensure a smooth delivery of the vaccines once they actually arrive in the region.

The dry-run started at the Daniel Z. Romualdez (DZR) Airport where assigned officials waited for the 'arrival' of 27,000 doses of unspecified vaccines placed in six plastic vaccine carriers.

From the airport, with the plane supposed to arrive at past 9 am, the 'vaccines' loaded in two vehicles owned by the Department of Public Works and Highways (DPWH) were travelled to the regional office of the Department of Health (DOH), which took 25 minutes travel, where these were temporarily deposited at its storage facility.

Police personnel were also present during the simulation to provide security and ensure free flow of traf-

# Tacloban receives high compliance rating on road clearing ops

TACLOBAN CITY-The city government of Tacloban, thru the leadership of Mayor Alfred Romualdez, has obtained a high compliance rating for the second phase of its road clearing operations, as assessed Thursday (February 18) by the regional validation team.

Tacloban City got a score of 91.60 percent, which is higher compared to the 2019 validation result. To recall, the city garnered 70 %, a substantial passing rate set by Department of Interior and Local Government (DILG).

### Eastern Samar gov't to provide cash aid to COVID-19 patients, families of fatalities

CITY-TACLOBAN The provincial government of Eastern Samar will be providing financial assistance to individuals who were infected and those who died of the coronavirus disease (COVID-19).

Under the financial assistance program initiated by Governor Ben Evardone, dubbed as assistance to individuals in crisis situation (AICS) program, persons who were confirmed to have been tested of COVID-19 will receive P5,000 while the families of those who died due to complications compounded by the dreaded virus will be receiving P10,000.

Evardone said that the financial aid is their way of providing socio-economic relief to those directly affected by the coronavi-

### LGUs in the region readies for impact of Typhoon 'Auring' expected to hit EV this weekend

TACLOBAN CITY -Several local government units here in the region are now preparing for Typhoon 'Auring' which is expected to make a landfall this Sunday, February 21, possibly hitting Leyte and Southern Leyte provinces.

Auring, the first typhoon to hit the country this year, is expected to become under the tropical storm level that may bring heavy winds and heavy rain which could result to flooding and possible landslide incidents.

In Tacloban City, the City Disaster Risk Reduction and Management Office conducted inventory on the capacity of rescue equipment such as speed boats and rain gears such as rain boots, and raincoats.

The equipment were prepositioned for possible rescue operations.

The office has also disseminated a blue alert status order to all barangay disaster risk and management committees (BDRRMCs) in the 138 barangays of the city advising them to take precautionary measures on their respective areas in preparation for impact of Auring.

In Ormoc City, the city government informed their residents that the city-wide siren will be activated once they are placed under Tropical Cyclone Wind Signal (TCWS) No. 1 by Pagasa (Philippine Atmospheric, Geophysical and Astronomical Services Administra-

"This is to provide the general public with advanced warning to take appropriate preparedness measures especially those residents in flood, storm surge, and landslide-prone areas. "We advocate pre-emptive or voluntary evacuation NOT rescue operations," the city government said in a statement posted on their official Facebook Page.

In Sta. Fe town, in Leyte, its local government unit through their municipal disaster risk reeducation and management office (MDRR-MO) announced that they will implement pre-emptive

To recall, the town was hit by heavy flooding on February 10 submerging some of its villages affecting hundreds of residents where some are evacuated.

"All barangay disaster risk reduction and management committee are advice to closely monitor weather disturbance and maintain close coordination with the MDRRMO," MDRRMO Gamaliel Roy Burgos said in an advisory.

Priority on the evacuation are pregnant women, senior citizen, persons with disability, and sickly people.

"Zero casualty is our main goal and Preemptive Evacuation NOT rescue is our principal policy instrument to achieve our goal," Burgos added.

The official also reminded to ensure the minimal health standard are being followed during evacuation.

### Villar pushes to declare San Jose, Batangas as "Egg Basket of the Philippines"

RECOGNIZING the huge number of 7 million eggs it generates daily, Senator Cynthia A. Villar seeks to name the town of San Jose in the province of Batangas as the "Egg Basket of the Philippines."

Villar, chairperson of the Senate committee on Agriculture and Food, filed Senate Bill No. 2044 or "An Act Declaring the Municipality of San Jose in the Province of Batangas as the Egg Basket of the Philippines" in order to support her proposal.

In her proposed measure, Villar cited Philippine Statistics Authority (PSA) report showing that of the 49.09,000 metric tons of eggs coming CALABARZON region, 705 metric tons of eggs are from San Jose, Batangas on a daily basis.

The PSA report also indicated that about 150.29,000 metric tons of eggs were produced from January to March last

The Batangas Egg Producers Association also estimates that San Jose produces 705 metric tons of chicken eggs daily.

As of June 2020, there are more than 342 registered independent poultry in San Jose.

It was reported that egg production in San Jose started as a backyard industry during the 60s. Overtime, egg farmers from this town evolved into agripreneurs through the help of innovative agricultural practices.

Amid the challenges, including the oversupply of eggs in 2009, egg farmers of the town, through the leadership of Batangas Egg Producers Cooperative (BEPCO), developed new products from eggs like liquid and frozen eggs.

In 2017, when the industry was besieged by bird flu infestation, which adversely affected the livelihood of the San Jose egg farmers, a collaboration was entered into between BEPCO, the University of the Philippines Diliman, and the Department of Science

and Technology, under the Collaborative Research and Development Leverage Philippine Economy Program (CRADLE) to figure out what can be done with the surplus of

This collaboration resulted in the development of egg white powder which is ideal for baking cakes and breads. It can also be used in making mayonnaise and meringue.

Through the concerted efforts of the San Jose egg farmers, their egg industry continued to be the source of increased income which generated thousands of direct and indirect jobs.

San Jose, a first class municipality, celebrates "World Egg Day" annually during the month of October to spur egg consumption in the country and to enhance the industry's production and marketing efficiency.

In 2016, the town even attempted to set a Guinness record for the longest line of fresh chicken eggs in trays - around 6,000 eggs were placed along the 2-km stretch of Macalintal

During this time of pandemic wherein we are facing a health crisis due to Covid-19, Villar noted that eggs can help boost our immune system. Eggs are among the most nutrious foods, a very good source of inexpensive, high-quality protein and other nutrients. (PR)



# 3 alleged NPA members surrender before Northern Samar top cop



Three alleged members of the New People's Army have surrendered before Northern Samar police provincial director Col. Arnel Apud, citing difficulties living in the mountains and desire to be with their families as their reasons for their decision to give up. Apud assured the former rebels of financial assistance as they start to live a normal life. (NSSPO)

TACLOBAN CITY-Three alleged members of the New People's Army (NPA) have voluntarily surrendered before the police provincial director of Northern Samar on Feb.15.

The surrender of the former rebels was lauded by Col. Arnel Apud, police provincial director, saying that it was an admission that they have joined the 'wrong ideological organization.

The three former rebels who surrendered were identified as Ka Eldy, Ka Redy, and Ka Justin who decided to give up their arm struggles to be reunited with their respective families and have a normal life.

"I am personally happy with your decisions to return to the government and live a peaceful life far from violent armed struggle," Apud told the rebels during their meeting at the police provincial headquarters in Camp Carlos Delgado, Catarman.

"Their act of surrendering is a clear manifestation that they have come to realize that they joined the wrong ideological organization. With this, I encourage the remaining members of the NPA in the province to make the best decision in laying down their arms, start a peaceful and meaningful lives with their loved ones, and avail of the government's reconciliation program," Apud added.

Ka Eldy was identified as the leader of "Agila Squad" of sub- regional committee (SRC) Arctic operating in Catubig- Las Navas areas.

He voluntarily surrendered one fragmentation grenade and one rifle grenade.

Ka Redy, said to be a member of Prente Squad, handed over a caliber .38 revolver with five rounds of ammunition.

The surrender of Ka Redy resulted for him to be reunited with his younger brother, Ka Andy, who was recruited by the NPA when he was only a minor but was arrested by government troopers in Las Navas, also in Northern Samar, last June 1, 2020 for possession of Improvised Explosive Device (IED), short firearm, ammunition and

Ka Justin was said to be a medical officer of SRC Emporium- sub- regional guerrilla unit Amihan, Squad 2, Team 1.

He turned in one caliber .45 with two magazine assembly and three live ammunition.

Meanwhile, commended the personnel of 1st Northern Samar Provincial Mobile Force Company (NSPMFC), 2nd NSPMFC, and the Silvino Lubos Municipal Police Station for assisting the surrenderees.

Eastern Visayas, particularly the Samar Island, remains a hotbed of insurgency with the continued presence of the NPA, who has been waging a Maoist-inspired guerrilla war since the late 1960s.

"TCPO shall continue the relentless campaign against illegal drugs and other illegal activities while maintaining public safety amidst threats of Covid-19 in Tacloban City," said Colonel Darwin Miranda, city police director.

# P61-B projects eyed for 'Balik Probinsya' in Eastern Visayas

TACLOBAN CITY -Eastern Visayas is eyeing at least P61.14 billion worth of projects to carry out the central government's "Balik Probinsya, Bagong Pag-asa" (BP2) program until 2023.

Priority activities for BP2 are contained in the new action plan approved newly-formed by the Regional Development Council (RDC) - Special BP2 during its meeting on February 11, chief of the policy formulation and planning division of the National Economic and Development Authority (NEDA) 8 (Eastern Visayas), Annielyn Costiniano, said in a phone interview on Thursday.

"The BP2 programs are focused on the livelihood and settlement of the BP2 beneficiaries. Among which are the development and construction of the house and lot packages for BP2 beneficiaries in various locations in Eastern Visayas, to be funded by NHA (National Housing Authority), and various livelihood projects comprising 25 percent of the amount proposed," Costiniano told the Philippine News Agency (PNA).

Another focus is infrastructure and development projects, such as farm-tomarket roads, and the establishment of broadband networks to support agriculture and agri-business ventures of BP2 recipients, she added.

The approval of the action plan came as the BP2 program is expected to go full blast with the easing of movement restrictions due to the coronavirus disease 2019 (COVID-19) pan-



# MGB vows to closely monitor MIPC's promise of rehabilitation

TACLOBAN CITY-A top official of Mines and Geosciences Bureau (MGB) here in the region has vowed to monitor the mining activity of the MacArthur Iron Sand Project Corp. (MIPC) amid mounting criticism in its operation.

"With my remaining time in the region, I have to see that rehabilitation (of the mining area)," said MGB regional director Leo Van Juguan in response to the apprehension aired by anti-mining groups in MacArthur town led by parish priest Amadeo Alvero.

While Juguan admitted that MIPC operation is one of the priority mining projects approved by the national government to help the country's economy due to the coronavirus disease (COVID-19) pandemic, he said that he is also concern with the town's food security.

"Right now, the challenge is to show it in the field. Let's give them a

chance to show it," Juguan told reporters as the MIPC management also nounced its "progressive rehabilitation" plan during a hearing with the provincial board members last week.

Januar Ong, MIPC community relations officer, disclosed that they hope to see the production of crops in the mined out field in their pilot site "by next quarter."

Ong said they have partnered with the farm owners in the rehabilitation of their farmlands.

He reiterated that they will not leave any hole unfilled in their mining area for black sand in Barangay

AN ORDINANCE GRAINING FRANCHISE TO LOVIC COCKPIT ARENA OPERATED BY VICTORIANO PRODERCIADO LOCATED AT BARANGAI BATO, MARIPIPI, BILIRAN TO ESTABLISH, OPERATE AND MAINTAIN A COCKPIT ARENA IN THE MUNICIPALITY OF MARIPIPI, BILIRAN.

Be it enacted by the Sangguniang Bayan in session assembled;
Section 1. A FRANCHISE is hereby granted to LORVIC COCKPIT ARENA operated by Mr. Victoriano Prudenciado to establish, operate and maintain a Cockpit Arena in Barangay Bato, Maripipi, Biliran.

Section 2. SCOPE. The establishment, operation and maintenance of cockpit arena in the Municipality of Maripipi, Biliran shall be for tourism purposes only and therefore this is without prejudice being a traditional Filipino sports and recreational activity.

# 9 nabbed, 'drug den' dismantled in two-day anti-drug operations by law enforcers across the region

TACLOBAN CITY-Nine suspects were arrested and an alleged drug den was dismantled during separate sting operations in Eastern Visayas towns from February 13 to 14, 2021.

In Basey, Samar, elements of Philippine Enforcement Agency (PDEA)-Eastern Visayas, together with Basey Municipal Police Station personnel, arrested five drug personalities and dismantled a drug den around 8:45 pm on February 14.

The suspects were identified as Jhon Cris Amante, drug den maintainer; Jonathan Makabenta, co-drug maintainer; Daniel Del Pilar, visitor; and two minors.

Operatives confiscated five sachets containing suspected marijuana dried leaves with a total net weight of 65.70 grams; three pieces improvised pipe, three pieces cigarette containing suspected marijuana dried leaves with a total gross weight of 8.3909 grams, and various drug paraphernalia.

Based on the chemistry report, the suspected drugs have an estimated market value of P14,818.

In Tacloban City, police arrested 26-yearold waitress Rosemarie Prudinte on February 13.

Purchased from the suspect was one sachet believed to be containing shabu, while confiscated from her possession were four sachets believed to be shabu, one teabag of suspected dried marijuana leaves, a coin purse, and buy-bust money.

The confiscated drug items have an estimated street value of P14,000, police said in the report.

Police also apprehended a 32-year-old cosmetologist in Tanauan, Leyte on February 13.

The suspect, Florencio

Barregon, who is listed as a street-level individual (SLI), allegedly sold a sachet containing suspected shabu to an undercover operative.

Police also confiscated from his possession four sachets believed to be containing shabu with an estimated worth of P5,500 and buy-bust money.

Representatives from the barangay, Department of Justice, and media witnessed during the inventory of confiscated pieces of evidence, according to the report from the Police Regional Office-Eastern Visayas.

On February 14, police in Ormoc City also arrested an 18-year-old

Ormoc City Drug Enforcement Unit, in coordination with PDEA in the region, purchased from the suspect one sachet containing suspected shabu with an estimated weight of 0.8 grams.

While confiscated from his possession were buy-bust money, two sachets containing suspected shabu with an estimated weight of around .48 grams and with Dangerous Drugs Board (DDB) value of P3,264.00, two sachets containing suspected dried marijuana leaves with an estimated weight of around 2.0 grams and with DDB value of P240.00, P320 cash and a wallet.

An alleged watch listed drug personality, identified as Rammy Jacosalem, was arrested in Tacloban City on February 14.

Confiscated during the operation were a sachet believed to be containing suspected shabu, as a subject of sale; buy-bust money; and six sachets of suspected shabu, which was recovered from his possession.

The recovered drug items have a total market value of P30,500, police said in the report.

The suspects will be facing charges for violation of sections 5 and 11, Article II of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2000.

While driving the passenger tricycle with body number 198 away from the Juba residence, the cops entangled him at the national road in Ipil while heading towards the direction going to Albuera.

The director added, "Whether there is exportation or not, the income of fishermen remains the same. The middlemen are getting better income."

During the interview, Director Berino also disclosed some priority programs of the agency for the year 2021. These programs include the focus on expanding aquaculture products such as tilapia, bangus, shrimps, and non-food products like seaweeds and shellfish.

Here, the office targets to provide at least 11 million tilapia fingerlings for the whole year to owners of fish cages in the freshwater, fish pond, or backyard ponds, while 2 million fingerlings are targeted for bangus.

The BFAR Central Office is likewise ready to extend its support considering the current health crisis. The office has also targeted to develop shrimp nursery, particularly in Jiabong, Samar, having a total budget of P4 million.

Director Berida also shared the plan to expand the existing seaweed nurs-

through the rice and fish culture production during the last two years, particularly in the municipalities of Paranas, San Jorge, San Jose de Buan, and Matuguinao, all in the Samar province. Plans are also underway

During the program, some plans related to ecological management, governance, and the welfare of the region's fisherfolks were also discussed, considering that BFAR 8 leads the Fishery Management Area (FMA) 8 comprising the sea areas of San Pedro Bay, Leyte Gulf, Surigao Strait, and the Caraga region. The plans include the livelihood support and capability building for the fishermen, and the control of fishing activities and harvest of the marine stocks.

"We are committed to sustaining fish sufficiency and we are targeting to increase our aquaculture production by 33.6 percent metric tons. With the increased harvest, our place could expect lower prices of fish products," Berida said.

Meanwhile, Director Berino has cautioned the public on Red Tide Poisoning, which according to him, is a natural phenomenon that occurs yearly nationwide, with region 8 having the most number of occur-

"Presently, there are still 10 areas affected by the Red Tide poisoning. These are the Irong-Irong Bay in Catbalogan and Daram, Samar; the Coastal waters of Zumarraga, Samar; Calubian, Leyte; Leyte, Leyte; Biliram Islands; Guiuan, Eastern Samar; San Pedro Bay in Basey, Samar; Matarinao Bay of General MacArthur, Quinapondan and Hernani, all in Eastern Samar; Carigara Bay along Babatngon, San Miguel, Barugo, Carigara and Capoocan, in Leyte province, and; Cancabato Bay in Tacloban City.

He added that during the occurrence of Red Tide, the public is advised to refrain from selling and eating all kinds of shellfishes such as mussels and talaba, among others. Fish, shrimps, and crabs are safe for human consumption, provided they are washed with running water and fish intestines removed.

Moreover, the Director shared some temporary home remedies should red tide poisoning occurs, through drinking at least 1 glass of buko juice coupled with some teaspoons of brown sugar, so as to detoxify the body. Consulting with health experts at the nearest health center or hospital is also advised, according to him.
