LGUs suspend classes, works due to typhoon 'Auring' spares EV of nossible devastation

TACLOBAN CITY-While the region was spared from the wrath of Typhoon 'Auring,' several local governments have cancelled works and classes on Monday (Feb. 22).

Here in Tacloban City, Mayor Alfred Romualdez issued an executive order calling for the suspension of works and classes across the city in anticipation of possible impact of Auring.

However, several private offices to include banks have remained open.

Mayor Rodrigo Arbas of Jaro town, Leyte issued Executive Order (EO) No. 7 calling for the suspension of work in all government offices except those involved in the delivery of basic health services, maintenance of peace and order,

disaster and risk reduction.

Work in private offices and establishment would depend on the decision of their management.

Aside from suspension of work in government offices, Mayor Arbas also declared suspension of online classes for private and public schools.

Provincial IATF steps up preps for upcoming First Mass quincentennial celebration

MAASIN CITY- The provincial inter-agency task force on emerging infectious diseases (PIATF-EID) has begun brainstorming details on how to go about with the 500th First Mass celebration next month without compromising the health and safety of those attending.

In a meeting with the cluster heads Friday, Feb. 19, at the governor's boardroom, it was agreed that the minimum health protocols will still be observed, like the wearing of facemasks and face shields, installation of wash facilities, and social distancing.

During the meeting, the Diocese of Maasin was represented by two priests, Fr. Johnrey Sibi and Fr. Mark Vincent Salang.

For the side of the Church, names of visiting pilgrims from different parishes will be submitted in advance, on March 3 at the earliest, the two priests alternately vowed.

Parishioners belonging to Leyte province that are still part of the Diocese will be securing health declaration from their point of origin, and letter of acceptance signed by Gov. Damian Mercado through Danilo Atienza, provincial disaster risk reduction management officer (PDRRMO).

Government personnel who are going there, on the other hand, will be required to secure a travel order from their respective offices in addition to the health certificate.

The new executive order which will be coming out in March will have a section devoted to the conduct of the March 31, 2021 celebration in the island town of Limasawa, said Geraldine Maquelabit, DILG provincial director.

Last month, during the plenary session of the PIATF, Limasawa Mayor Melchor Petracorta sought guidelines for the quincentennial event, especially in the light of the lingering covid-19 threat.

Petracorta had said only 500 guests will be permitted to be physically present during the March 31 celebration, in which 250 individuals will come from the church, and the other 250 will be from the government, and thus far the number has not changed.

118 NPA members and supporters in Matuguinao town surrendered before town and security officials

MATUGUINAO Samar- Fearing for her safety, 'Thelma', 58, decided to surrender and stop providing support to the outlawed communist armed group, the New People's Army (NPA).

After deciding to surrender, she left Barangay Deit, where she live and stayed at the town proper where she said she feel secure and have a sound sleep.

Thelma surrendered to the government authorities in 2019, along with other supporters of Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF), residing at their village.

Last Feb.19, Thelma renewed her commitment to spurn the NPA, joining 117 other residents of the town who decided to abandon the armed struggle for good.

To recall, town Mayor Aran Boller issued an ultimatum against supporters and sympathizers of the NPAs operating in their town to surrender before Feb.15 or be charged under the draconian antiterror law and declared as persona non-grata.

At least 353 residents were identified by the local government and the military as members and supporters of CPP-NPA-NDF.

But only 195 undergone tactical interrogation, according to Lt. Col. Jasper Pecson, commander of the 19th Infantry Bat-

And of the 195, only 118 attended the mass surrender ceremony, of which 56 were members of the Batakang Organisasyong Pangpartido (BOP); 50 as members of the Yunit Milisya (YM), and 12 as former members of the Organisadong Masa.

"The campaign is still a success because those who surrendered are personalities in their respective villages who have influences because they hold positions in their barangay

councils, like chairman, councilor, treasurer, secretary, and tanods," LtCol Pecson said.

Mayor Boller in his message to the 118 surrenderees encouraged them not to afraid to totally reject the armed group.

"You need to have a peaceful life; free from worry and trouble but rather in focusing on how you will improve the life of your family and the community," he said during the ceremony held at the town's gymnasium.

Boller added that campaign to encourage members and supporters of the communist group to surrender is for the attainment of the local government's goal of making Matuguinao a developed municipality that is free from turmoil and armed-conflict.

He added that the campaign is to ensure that the future generation of Matuguinao will grow under the threat and influence of the

The victim was hit in his forehead which resulted in his instantaneous death, according to the police.

Authorities have yet to determine the motive behind the shooting.

"Nobody claimed his body and no one recognized him during the three days of his wake at the auditorium," Valenciano said in a phone interview Monday.

The rebel died on Feb. 15 in a brief gun battle with soldiers in remote village of Cagbigaho in Pambujan town.

He was one of the three rebels who fought with patrolling troopers. A soldier was injured during the clash. A bandolier and a notebook were recovered after the firefight.

Northern Samar is considered to be the NPA's stronghold Eastern Visayas due to poor road network, thick forest, high poverty incidence, and low level of education in upland communities.

The NPA, which has

been waging a five-decade armed struggle against the government, is listed as a terrorist organization by the United States, the European Union, the United Kingdom, Australia, Canada, New Zealand, and the Philippines. (SARWELL Q. MENIANO)

the amended IRR came at a very opportune time as our agri-fishery sector takes up the challenge of leading the economic recovery amid the protracted health crisis. This would facilitate higher investments by banks in the agri-agra sectors." The essence the Law mandates banks to allot 15% of their loan portfolio for agriculture and the remaining 10% for agrarian reform beneficiaries. The salient points of the amended IRR are as follows:

- 1. Deletion of the accreditation requirements for debt securities,
- 2. Expansion in the modes of compliance with the agrarian reform credit,
- 3. Expansion of agriagra eligible purposes

Also, covers the amendment of the computation of total loanable funds of newly established banks and extension of loans to borrowers for purposes of financing activities including palay housing and farming homestead. Likewise, reduce operational challenges faced by the banks in complying with the provisions of the Law.

I personally suggest that the AMENDED IMPLE-MENTING RULES AND REGULATIONS is reproduced including the mother Law and distributed to all municipalities.

A non-profit mobile library as an alternative reading resource for all First to Third Grade schoolers in the Division of Borongan City

Reading literacy improvement has been an uphill battle for the Department of Education for quiet some time in the country and our Division of Borongan City is no exception.

In the past three years the Philippine Informal Reading Inventory (Phil-IRI) reading program yielded dismal results in literateness, with frustration level of 42% in Grade 3 in 2018 and 39% in 2019.

Similarly, the Programme for International Student Assessment (PISA) measuring school pupils' scholastics performance in mathematics, science and reading, reported that based on the PISA 2018 Database, in the Philippines, 19% of students attained at least level 2 proficiency in read-

These students can identify the main idea in the text of moderate length, find information based on explicit, though sometimes complex criteria, and can reflect on the purpose of the form and text when explicitly directed to do so.

Almost NO student was a top performer in reading, meaning that they attain level 5 or 6 in the PISA reading test. All

these levels, students can comprehend lengthy texts, deal with concepts that are abstract and counterintuitive, and establish distinctions between facts and opinion, based on implicit cues pertaining to the content or source of the information (Source: OECD,





PISA 2018 Database).

Additionally, in a study on Improving Reading Skills by Encouraging Children to Read in School: A Randomized Evaluation of the Sa Aklat Sisikat Reading Program in the Philippines conducted by Ama Baafra Abeberese, Todd Kumler and Leigh Linden, after the program but diminishes to 0.06 standard deviations, probably due to emphasis on reading it showed that a short-term (31 days) reading program, designed to provide age-appropriate reading material, improves students' reading skills by 0.13 standard deviations. The effect is still

present three months after the program. They find that the program also encourages students to read more on their own at home. (The Journal of Human Resources, V49, No3, summer 2014).

The academic literatures would show how much our educational system need to do to improve literacy programs in the country, which prompted the author to initiate a non-profit project named LIBRENG LIBRO PARA KAY BIBO! a mobile library for grades one to three pupils in the division of Borongan City.

The project aims to provide motivating reading books/materials donated by Filipino community based in New South Wales in Australia.

Another objective is to capture the interest of pupils in reading and making it a habit for them to do so. Third one is to sustain the project by rolling the mobile library from one elementary school to another, thus, providing equal opportunity to all, with the guidance of schools' reading readiness (RR) teach-

Children who can read five books on the first weekdays, ten books on the second, fifteen books on the third, and twenty on the last week days, will be awarded with excellence in reading by their reading readiness teacher as a form of motivation, and for the parents as an inspiration.

The target date of launching is on May 2021 as logistics of boxes of books from NSW to the Philippines will take two months due to covid pandemic restrictions. Impact of the project will be evaluated through future administration of Phil-IRI.

DTI-SBC approves P13.3-M to Eastern Samar MSMEs

BORONGAN CITY-The Department Trade and Industry's financing arm, Small Business Corporations (SBC), has approved and released 217 loan applications from micro small medium enterprises (MSMEs) for the year 2020 in Eastern Samar.

Ma. Joy R. Abobo, provincial small business coordinator DTI-Eastern Samar Field Office (ESFO), said that P13.3-M worth of loans has been approved under the COVID-19 Assistance to Restart Enterprises (CARES) program.

Abobo said CARES program is part of the government's economic relief program for MSMEs affected by the COVID-19 pandemic crisis.

The P3 coordinator said that the relief assistance through Bayanihan CARES program is a big help for the MSMEs to recover their businesses especially those whose businesses have been temporarily and permanently closed.

Abobo further said that micro enterprises with an asset size of not more than P3 million may borrow P10,000 to P200,000 while small enterprises with an asset size of not more than P15 million may borrow a higher loan amount but not to exceed P500,000.

Abobo emphasized that the said loans under the CARES program have a monthly interest rate of zero percent and a grace period of six (6) months on principal repayment.

DTI's financing arm does not collect interest from loans but instead charges service fees of 4 percent for loans with a one-year term, 6 percent for two-year loans, and 7.5 percent for three-year loans

The loan requirements include ly-accomplished loan application form; one government issued ID with picture, and proof of permanent business address.

Businesses can use the borrowed funds to update loan amortizations for vehicle loans, or other fixed asset loans, and replacement of working capitals to restart operations.


