70 in 2018, only four out of the region's 11 communist fronts are remaining with around 1,000 regular members or New People's Army have surrendered.

Mayor Romualdez urges public to observe 'self- discipline' to help gov't fight on COVID-19

TACLOBAN CITY- Amid the current threat of the new coronavirus disease (COVID-19) variants, Tacloban City Mayor Alfred S. Romualdez urged the public to exercise self-discipline, as it is the key to win the battle against this pandemic.

"The bottom line is to not let our guard down, as self-discipline is the best solution to help the government in addressing this health crisis," the local chief executive emphasized during an interview on Wednesday, March 17.

Mayor Romualdez continues to appeal to the public to strictly comply with all safety and health protocols such as wearing of face masks and face shields, and observance of social distancing, even as it streamlined and eased its COVID-19 guidelines.

To note, protocols in Tacloban City have been minimized, however mandatory isolation or quarantine of confirmed cases, close contacts, and those with flulike symptoms are still required.

Sen. Go visits EVRMC, led the distribution of financial assistance to personnel and patients

TACLOBAN CITY- Almost 283 patients admitted currently at the Eastern Visayas Regional Medical Center (EVRMC) and 1,944 frontliners, including job order employees, cleaners even security guards, received financial assistance from the Department of Social Welfare and Development (DSWD) worth P 300,000 as part of the program assistance to individual in crisis situation (AICS)

The giving of the assistance was witnessed by Senator Christopher Lawrence Go, committee on health chairperson of the Senate, on Thursday (March 18).

Go also distributed grocery packs, vitamins, facemasks, face shields, and raffled bicycles, shoes and tablets.

The senator's visit to EVRMC is part of his monitoring 'Malasakit Center' which he helped put up.

The Malasakit Center in EVRMC started its operations on May 22, 2018 and served as a one- stop shop

where indigent patients can access financial assistance

for medical needs from Philippine Health Insurance Corp. (PhilHealth), Philippine Charity Sweepstakes Office, and the DSWD.

For the past three years since it started its operation, the Malasakit Center has already provided assistance to 104,565 indigent patients.

According to Go, the malasakit program is not about just patient as it is also health care financing, one of the pillars of the Universal Health Care.

Go pledged P10 million from his office as financial assistance and as additional funds for the Malasakit Center at the EVRMC.

The additional financial aid he pledged is his way to help patients who needs dialysis and those afflicted with cancer.

Go also informed that patient who needs complicated surgical procedures that cannot be performed in EVRMC can ask assistance directly from his office and will shoulder even the fare in going to Manila.

NSSDEO completes 2-km Pinipisakan access road





Department Public Works and Highways-Northern Samar Second District Engineering Office has completed last December 19, 2020 the construction of 2-kilometer additional access road leading to Pinipisakan Falls located at Barangay San Isidro Las Navas, Northern Samar.

The said project has a contract ID number 20II0031 funded under the GAA CY 2020 Infra Project amounting P88 million undertaken by the 5GG Construction, a local construction firm in Northern

The other project items include the installation of metal guardrails with concrete post (left side only) and construction of stone masonry slope protection.

This additional two kilometers access road leads the famous Pinipisakan Falls that attracts local and foreign tourists to the carline municipality of Las Navas in the second district of Northern Samar.

Because of the pristine and romantic nature of the Pinipisakan Falls, this project will not only boost tourism in the town of Las Navas but will also help in the economic development of Northern Samar through faster delivery of commercial goods and services to adjacent commu-

DENR earmarks P75 million for 600 ENGP

family-beneficiaries in Northern Samar

A total of P75 million has been earmarked by the Department of Environment and Natural Resources(DENR) this year's implementation of the Enhanced National Greening Program (ENGP) using the family approach strategy.

DENR-8 Regional Executive Director Tirso Parian, Jr. said that the project will benefit more than 600 impoverished families from the towns of Palapag, Mapanas, Laoang, San Roque, Catubig, Las Navas, Silvino Lobos and Catarman, all in Northern Samar.

Parian said that the amount will be distributed to the family-beneficiaries who are tasked to plant an area covering 3,195 hectares that will be planted with bamboo, agroforestry and indigenous species.

On the part of the family- beneficiaries, they will be given a budget for their seedling production, plantation establishment and for the first-year maintenance activities.

"The National Greening Program (NGP) was conceptualized mainly as poverty alleviation and food security initiative by the government. The welfare of the people is given importance and because the program espouses participatory strategy, they are themselves involved in the advocacy for environmental protection and conservation", Joselito Eco, OIC-Provincial Environment and Natural Resources Officer

of PENRO-Northern Samar during the signing of the Letter of Agreement (LOA) between the ENGP beneficiaries and the DENR.

Eco reported that for example, in Silvino Lobos, a 4th class municipality, 50 families recently signed LOAs with the DENR for the implementation of the ENGP in will have a greater chance their area.

The said family-beneficiaries are under contract with the Department to plant an area comprising

of 131 hectares of bamboo and agroforestry plantation with an approximate total budget of Php2.5 million to be distributed to the family-beneficiaries for year 2021 alone, Eco added.

"This family-based approach will directly benefit the families themselves and the plantation of success because of a higher sense of belongingness coming from the beneficiaries," Eco said. (RESTITUTO A. CAYUBIT)

SEC sets rules in fight vs money laundering

The Securities and Exchange Commission (SEC) is instituting new protocols of transparency as part of its efforts in combatting money laundering and terrorist financing and to keep the country off the gray list of the Financial Action Task Force.

SEC Memorandum Circular No. 1, issued on January 27, 2021, provides the Guidelines in Preventing the Misuse of Corporations for Illicit Activities through Measures designed to Promote Transparency of Beneficial Ownership (BO Transparency Guidelines).

The measure includes the disclosure of the identity of the beneficial owner or the person or persons who ultimately owns or has ultimate effective control of the corporation.

"There are arrangements that allow individuals to assume a management or ownership position in behalf of their principals and in turn hide the identity of the beneficial owner. We can see that this is not ideal because it exposes the corporations to the risk of being misused for illegal activities," SEC-Cebu Extension Office Counsel I Lawyer Giness Marie R. Teves said Tuesday, March 10.

The guidelines provide that no corporation or entity shall issue, sell or offer for sale or distribution bearer shares, as well as bearer share warrants, where the name of owners are not reflected on the physical stock certificate or recorded in the Stock and Transfer Book of the issuing corporation.

"This is to ensure greater transparency in the ownership of corporations and also consistent with the country's commitment to implement international standards and best practices in combatting money

Vice Pres. Robredo condoles family of slain Calbayog city mayor

TACLOBAN Vice President Leni Robredo paid her last respects to the slain Calbayog city mayor Ronaldo Aquino whose remains now lie in state at the Calbayog Sports Complex on Wednesday (March 17) morning.

Raymund Ronald Ricafort, information officer of the Calbayog city government, said that Robredo stayed at least for three hours and personally conveyed her condolences to the wife and children of the slain 59-year old mayor.

"She wanted her visit to be low key as it was a personal visit to condole with the family (of Mayor Aquino)," Ricafort said in a phone interview.

The Aquino family, he added, were said to be 'overwhelmed and grateful' for the visit of the Vice President, who is the chairman of the Liberal Party of which the killed Aquino belonged.

Ricafort said that the Vice President arrived at

the Calbayog Sports Complex at around 9:30 am and stayed until 11:30 am.

"There was no convoy and (additional) security," Ricafort said.

The Vice President, he added, just talked with the family of Aquino and did not issued any statement.

But the Vice President, in an earlier statement, condemned the killing of the Calbayog city mayor.

"We call for a clean, competent, and independent investigation into Mayor Ronald Aquino's death and for his murderers to be brought to justice," she said in the statement with a date of March 9, the day after the mayor was killed while on his way to attend the birthday of his son, Mark.

Aquino is scheduled to be buried on March 24 at the Calbayog Memorial Park. A day before the burial, his coffin will be brought at the City Hall for a necrological service.

The killing of Aquino is now under investigation both by the Philippine National Police and the National Bureau of Investigation. (JOEY A. GABIETA)

NHCP installs marker at the site of Magellan landings

GUIUAN, Eastern Samar - The National Historical Commission of the Philippines (NHCP) installed a new marker in Barangay Pagbabangnan, Homonhon Island, this town, where Portuguese-born navigator Ferdinand Magellan made his landings 500 years ago.

The Homonhon marker is the second marker in the town of Guiuan unveiled by the NHCP in relation to the Quincentennial celebration of the Philippines.

The marker is located at the Magellan Site in Sitio Caltilado, Pagbabangnan where Magellan and his crew stayed for eight days.

The unveiling was attended by top officials of the province led by Governor Ben Evardone and

They feel extremely awkward even talking about it, let alone, finding ways of effectively and correctly developing it.

Further, it aims to prevent scouring of soil beside the river bank affecting



Ormoc City to become a model for resilience through EDC, NRC partnership



In March 1976, Lopez-led renewable energy leader Energy Development Corporation (EDC) was born to help build the country's economic resilience by harnessing power from indigenous sources to reduce its dependence on imported fuels. Ormoc, Leyte was the site where EDC piloted its first ever geothermal project, the 3MW Tongonan power plant in 1977, making Ormoc EDC's first partner in helping build our national

resilience.

Forty-five years later,
EDC is leveling up or elevating its partnership to

pave the way for Ormoc City to become a truly resilient and regenerative community by adopting it through the National Resilience Council (NRC) and the Carlos P. Romulo Foundation's Adopt-a-City program.

In a virtual Memorandum of Agreement signing ceremony held via Zoom today, the four parties vowed to work together and leverage each other's

capabilities and strengths

to help Ormoc City become the country's model city for resilience and disaster preparedness.

"Our work here in this partnership has a lot to do with valuing ecosystems services for climate change mitigation, adaptation, and disaster risk reduction. We are well in line with the statement of EDC Chairman Piki Lopez wherein he outlined a decarbonized and resilient future for the country, using the word

regenerative, which is particularly important as far as ecosystem based services are concerned," said NRC President Ms. Antonia Yulo Loyzaga.

Loyzaga added that they would like to take advantage of the vast experience and knowledge of EDC, the human knowledge and technical capacity of the Ormoc City government, and NRC's work in building this partnership.

EDC President and COO Richard B. Tantoco, meanwhile, committed to keep helping Ormoc City become resilient for the good of the Ormocanons and their neighboring communities. "Climate change is going to worsen and we really need to be more and more prepared, which is why we are proud of this partnership with NRC and Ormoc City."

While Tantoco expressed his excitement for their upcoming activities involving the Ormocanons, which include the formation of a multi-sectoral forest protection task force, the creation of 10 pilot barangay emergency response

teams, the roll out of a citywide disaster risk prepared-

and response information campaign, he offered to expand EDC's role in the partnership even more as the power company that provides 100% renewable energy (RE) to the province of Leyte.

"We'd like our geothermal facilities in Leyte to be THE most robust power facility in the country so 2-3 days after a major disaster, the Ormocanons will look up and see that there's light and know that they can begin rebuilding their lives. If we can help to prevent the Ormocanons from being repeatedly subjected to the attacks of climate change and worsening typhoons, we're here to support and partner with Ormoc and NRC," said Tantoco.

For his response, Ormoc City Mayor Richard I. Gomez said: "Ormoc is vulnerable to natural disasters, that's why planning and foresight are very important, and partnerships like this are vital to us. Thank you, NRC, EDC, Carlos P. Romulo Foundation.

Through this Adopt-a-City program, I know that we will achieve stronger resilience, reduce deaths, and increase development in our city. I want Ormoc to be a model city even if we are just medium sized so that other cities will look up to the things that we do in Ormoc and in Leyte. Thank you for choosing Ormoc as a partner for this Adopt-a-City. I know we will achieve excellence with this program and I'm very excited as a Mayor. Our people are very excited and we can't wait to begin this program."

Mayor Gomez expressed his gratitude once again to EDC for the assistance that it has provided to Ormoc City during the pandemic. "It is not a very good time to be a mayor during a pandemic but to fight this (pandemic), you need to have a strong political will to protect your own people. Communist Party of the Philippines as 'persona non grata?

"I know this problem could not be solved overnight that is why I am asking for the cooperation and the solidarity of all sectors in ending this conflict once and for all," he said.

"With your support and patriotism, I am confident that we will triumph over the challenges ahead of us. Be assured that the entire force pf the Filipino people though the hands of the government os behind you as well to secure a genuine and lasting peace for our motherland," the President added.

He also claimed that the communist party here in the Philippines have lost its ideology and what they are doing is plain banditry.

"The communist has not achieved anything at all, I have not seen any progress in their movement). Rather, it has become a group of bandits solely," the President said.

During the meeting, the President reiterated his order to the military to kill armed rebels and said that not in the million years of fighting that the communist group will succeed in their fight against the government.

Duterte said his administration did its best to have a peace agreement with the Communist Party of the Philippines, but its founding chairperson, Jose Maria Sison, lacked sincerity.

"I cannot fathom the brain of Sison however you prick it, it's gone. He has, I don't know, if dementia or something. He keeps on transferring from one topic to another that finally I thought that peace through negotiation with them is impossible. So I gave up although I tried everything," he add-

Duterte also expressed his sadness that communist rebels continue to stay in the mountains to fight the government troops.

Despite the continuing insurgency in the country, Duterte is happy that the government, through the NTF and RTF ELCAC, made big achievement in fighting the communists.

Duterte also promised

that the government will continue to support the former rebels.

Eastern Visayas is one of the country's poorest regions with the existence of armed insurgency cited as among its reasons.

During his more than one-hour speech, Duterte teased both Sen. Christopher 'Bong' Go and Labor Sec.Silvestre Bello III.

On Go, his long-time confidant, the President addressed as him 'President' while Bello as 'senator.'

Go, in a separate interview here, insisted that he is not entertaining about the 2022 presidential elections saying that his visits around the country should not be misinterpreted that he is seeking the presidency.

shared that the first contact between Suluan people and Magellan is something that should be remembered.


Of the five ships that sailed from Spain that are part of the fleet of Magellan, only three are able to reach the country.

"That encounter is based on the idea of friendship, humanity, solidarity, especially to the Filipino side," Ambassador Sanchez said.

"I think that we are not responsible for what the good and bad things that our ancestors did, but we are responsible for how we remember, and today we are being very responsible for this historical marker underlying what happened 500 years ago," he added.

In an account written by Antonio Pigafetta, a day after dropping their anchor in Suluan, the fleet of Ferdinand Magellan in March 17, 1521 sailed to the Homonhon which early people called Humunu and set put in the island where they tended their sick crew and gather some food.

Magellan named their new found land mass and its neighboring island as the archipelago of San Lazaro as they were discovered on

On March 18,1521, Magellan and his men meet nine men who belong to the early residents of Suluan marking the first encounter of westerners and eastern people in the island which later become part of the Philippine archipelago.

During their stay, Magellan called the island, Acquada de li bouni Segniallu' or 'watering place of good sign' because of two things, the presence of a spring which they described as a clearest and sweet, and their meeting with the Suluan residents who were friendly to them contrary to their previous experience where their ship had been looted

In their account, they described the early residents of Suluan whom they meet in Homonhon as very pleasant and conversable sharing with them names of the nearby islands, and would go back to the island as their promise with provisions of

They also noticed the men have their body painted and their chief wearing gold in arms, heads and earrings.

The fleet of Magellan leaves Homonhon on March 25 and sailed towards the direction of Limasawa, then goes to Cebu.

NHCP places marker at Suluan Island which symbolizes Filipinos being giving and compassion people



Guiuan Mayor Annaliza Gonzales-Kwan led in the unveiling of a marker in Suluan Island on March 17 as part of the Quenticennial celebration of the first ever international navigation of Ferdinand Magellan. Joining her were Defense Undersec. Reynaldo Mapagu, Spanish Ambassador to the Philippines Jorge Sanchez and Rene Escalante, chairman of the National Historical Commission of the Philippines, among others.(ROEL T.AMAZONA)

GUIUAN, Eastern Samar - It was on March 16, 1521 when the fleet of Ferdinand Magellan, a Portuguese navigator working under Spanish flag, saw the island of Suluan, hungry and suffering from illnesses after three months of voyage.

None of them, however, did not set foot on this island and only stayed inside their ship.

But it was the residents of this small island who helped Magellan and his men by giving them food and provisions.

On Wednesday (March 17), the National Historical Commission of the Philippines (NHCP) unveiled a marker to commemorate said historical event, a beautiful gesture of humility and compassion toward fellowmen.

The unveiling of the marker kicked off of the year-long celebration of the Quincentennial Celebration of the Philippines.

"Let the Quincentennial remind all Filipinos that we are triumphant and compassionate people just like our ancestors recorded in 1521," Rene Escalate, NHCP chairman, said.

Escalante added that opening the quincentennial celebration in Suluan aims to lay the foundation for future studies and to ignite interest of young historians and scholars.

At least 34 historical markers in relation to the quincentennial celebration were erected by the NHCP in Palawan, Visayas and Mindanao along the historic route of the first circumnavigation.

"We want our coun-

trymen to appreciate this achievement of humanity as part of the history of a Filipino, part of what they have been taught in school back then in the beginning of Philippine history, "Escalante added.

That simple act of kindness of the early residents of Suluan would later result to a legacy that every resident of the island, and of Guiuan town to always remember and be proud of, according to Mayor Annaliza Gonzales-Kwan.

"We need to remember this lessons from 500 years ago or else this monument of humanity will remain as cold as the stone it is made of," Mayor Kwan said.

"Because we are kindhearted people, we show courage to meet the foreigners who arrived in our land. We are proud of being friendly, and because of this friendliness, the early residents of Suluan are able to save lives of Magellan's fleet who were able to tell and prove that the globe is round,"she added.

The marker in Suluan is one of the three markers erected by the NHCP in Guiuan for the Quincentennial commemoration.

Another marker is located in Homonhon Island where Magellan and his men stayed for several weeks, and in Calicoan Island that represents the enter island of Samar.

Spanish Ambassador to the Philippines Jorge Sanchez in his message said that this event 500 years ago should always be remembered by all as it provided not only knowledge useful to navigation but also the paved way for a forging of




