Amid surge of its COVID-19 cases DOH assigns 16 health workers from the region to NCR

TACLOBAN CITY-At least 16 health workers from the region left on Wednesday (April 7) for National Capital Region(NCR) where they are to be deployed to augment the medical workers there as the area continue to experience a spike of coronavirus disease (COVID-19).

The medical team, composed of one doctor and 15 nurses, were praised by Dr. Exuperia Sabalberino, regional director of the Department of Health (DOH) during a simple send-off held at the Daniel Z. Romualdez (DZR) Airport, this city.

EV posts 92.4% employment rate in January 2021, PSA says

TACLOBAN CITY - she said. The Philippine Statistics Authority (PSA) reported that the region's employment rate in January of this year has reached 92.4 percent which is 3.0 percent lower compare to last year's record of same period.

However, the figure is relatively higher compare to the 87.6 percent level in April, 2020, the start of the quarantine period due to the coronavirus disease(COVID-19)pandemic, Wilma Perante, PSA regional director, said in a statement.

"The region recorded the 7th highest employment rate among the 17 regions in the country and was slightly higher than the 91.3 percent national estimate in January 2021,"

Perante reported that out of the estimated 3.1 million population in Eastern Visayas, 15 years old and over in January 2021, about 1.9 million of them were economically active or in the labor force.

She added that this number translates to a Labor Force Participation Rate (LFPR) of 59.8 percent.

The latest LPFR was 3.6 percentage points higher than the 56.2 percent LFPR in October 2020 and 0.3 percentage point higher than the 59.5 percent LFPR in January 2020.

Perante added that about 144,000 persons in the labor force were unemployed in January 2021.

This translates to an unemployment rate of 7.6 per-

cent, lower than the 14.3 unemployment percent rate reported in April 2020.

Perante also reported that the underemployed persons or those employed persons in the region who express the desire to have additional hours of work in their present job or to have additional job, or to have a new job with longer working hours was estimated at 372,000.

"This translates to an underemployment rate of 21.2 percent, same as the figure reported since April 2020 but higher than the 16.4 percent recorded in January 2020. Eastern Visayas ranked 5th among regions in the country with a high underemployment rate," she said.

stopped the pest from further spreading outside Mainit village in Anahawan town, PCA Eastern Visayas regional manager Joel Pilapil.

> "The impact of the integrated pest management protocol and the reduction of CSI population brought down the pest population at a level that biological control can sustain. We have not reached the point where we have to inject chemicals to the trunk to stop the infestation," Pilapil said in a phone interview.

> The bug population has been reduced through regular harvesting of matured nuts, leaf pruning, spraying of organic chemicals, mass rearing and field releases of biological control agents, and fertilization to hasten recovery of infested trees and eventually increase yield, among others.

> Infested areas in Mainit are declared to be under quarantine to prevent the further spread of the prolific pest.

The official believes that the pest reached Southern Leyte through the transport of whole nuts and planting materials from affected areas in the country.

P36-M evacuation center in Hernani, Eastern Samar now completed

BORONGAN CITY-The Department of Public Works and Highways - Regional Office VIII (DP-WH-RO8) inaugurated and turned-over the newly-constructed evacuation center to the local government of Hernani at the Sitio Pinasu-an, Brgy. San Miguel on March 25, 2021.

The facility is a one-storey reinforced concrete with steel structure having a total floor area of 418.00 sq.m. amounting to P36,589,895.80.

The ceremony was attended by Mayor Amado L. Candido, Rep.Maria Fe R. Abunda, Vice Governor Maricar Sison-Goteesan, DPWH R8 Project Engineer Leonilo Jumagdao, and municipal coordinator of Eastern Samar Provincial Office Jose Omayao.

Town Mayor Candido expressed his gratitude to DPWH and to Rep. Abunda for the project and said that it will help the residence of his municipality to have a safe and disaster resilient place where they can take refuge in times of calami-

ties. closed that DPWH has three ongoing construction of evacuation centers in the province located in Borongan City, and in the towns of Salcedo and Sulat which will also be turnedover to the respective local government units once completed.

Engr. Jumagdao added that Eastern Samar municipalities should have evacuation centers because of the geographical location of the province facing the Pacific and often visited by typhoons every year.

He disclosed that DPWH can implement projects only like evacuation centers to those municipalities who can give minimum requirements to back-up for the budget proposal.

Goma to run as congressman while wife Lucy to seeks as mayor of Ormoc City

TACLOBAN CITY- Ormoc City Mayor Richard Gomez has announced of his plan to run for Congress in next year's elections, coinciding of his 55th birthday celebration last Wednesday (April 7).

The post the actor-turned politician planning to seek is currently occupied by his wife, Rep. Lucy Torres Gomez who is now on her final term.

"Lucy is now on her last term already, will it be ok if we just swap positions? Our congresswoman will run for mayor...," the actor-turned politician said this with his wife among those present during his announcement with the city and barangays officials in attendance in a gathering held at Ormoc superdome. Aside from his birthday celebration, the occasion also served as the launching of the city's vaccination plan.

With this declaration, this shut down earlier speculation of Rep. Torres Gomez running for senator in next year's elections though she figured highly in some pre-election surveys.

The couple are considered to be political allies of President Rodrigo Duterte who both ran under the banner of the PDP-Laban during the 2019 elections.

Mayor Gomez, who is only on his second term in office, said that his wife would make a good mayor of Ormoc as he thanked her for all her works and projects she brought to Ormoc and the rest of the congressional district which covers the towns of Kananga, Albuera, Palompon, Merida, Isabel, and Matag-ob.

Torres Gomez is actually serving on her fourth term as office.

She first ran as a congresswoman in 2010, substituting her husband who was disqualified for lack of residency.

In March 19, 2013, the Supreme Court ousted her from her post though she won on her reelection bid during the May 13, 2013 elections.

She won on her subsequent reelection bids. (LIZBETH ANN A. ABEL-LA)

tives of barangay nutrition scholars (BNS) retroactive to calendar year 2020.

Earlier this year, the Provincial Health Board has approved a similar resolution in recognition of the outstanding performance of the BNS in reducing malnutrition prevalence rate in their respective barangays.

Based on the resolution, a BNS may receive P350 to P700 per month depending on their performance.

With temporary presiding officer board member Joma Vicario, this special session of the Sangguniang Panlalawigan was attended by temporary majority leader Neil Hernandez, board members Golda Ballesta, Chin Dela Rosa, Gina Ong-Silvano, Mary Ann Avalon, ABC president Liza Esidera and PSKF President Elcid Abalon.

The special session was called for by Governor Edwin Ongchuan who has consistently acknowledged the importance of improving the healthcare services especially as the COVID-19 pandemic continues.

This thrust towards nutrition is also in line with the objectives of the First 1000 Days of Life Program (F1KD), one of the flagship programs of the provincial government this 2021, in partnership with UNICEF-KOICA and the Zuellig Family Foundation. (NSPIO) 13 LGUs in Southern Leyte reach blood collection target- PRC

MAASIN CITY- The Philippine Red Cross(PRC) – Southern Leyte Chapter reported that 13 local government units (LGUs) in the province were able to achieve their blood collection target of one percent of their respective population in 2020.

Chapter Administrator Jonas Maco said during the virtual Regional Blood Coordinating Council meeting last March 31, 2021 that more than half of the total LGUs in Southern Leyte reached their targeted blood collections despite the COVID -19 pandemic.

Maco reported that a total of blood collection reached 6,445 blood bags in 2020 which already rep-

resents more than 1 percent of the total population of the province.

The province of Southern Leyte had a total population of 421,750 as of 2015 (PSA Census of Population). This represented about 10 percent of the total population of Region VIII.

"In 2019, the local Red Cross chapter collected some 7,124 blood bags," Maco added.

The 13 LGUs include Maasin City, Padre Burgos, Limasawa Island, Tomas Oppus, Sogod, Libagon, Lilo-an, Pintuyan, San Ricardo, San Juan, Anahawan, Hinunangan and Hinundayan, he said.

2 village executives nabbed for 'sabong,' illegal cutting of trees in Southern Leyte

TACLOBAN CITY-A

barangay chairman and a village councilor were arrested for alleged illegal cockfighting or "sabong" and cutting of coconut trees during separate operations in Southern Leyte towns Tuesday (April 6).

In Bontoc town, police arrested Gerardo Tibon, 54, and a village chairman in one of the town's barangays.

He was facing a warrant dated February 3, 2021, for violation of Presidential Decree (PD) 1602 in relation to PD 449 or illegal cockfighting.

Presiding judge Patrick Espere of Municipal Circuit Trial Court in Sogod, also in the same province, recommended bail of P36,000 for the temporary

liberty of the accused, police said in the report.

Another accused, 58-year-old Arcadio Lora, barangay councilor in Sogod town, was arrested by virtue of a warrant dated March 25, 2021.

He was facing a case for alleged violation of Republic Act (RA) 8048, also known as the "Coconut Preservation Act of 1995", as amended by RA 10593.

Judge Espere also recommended bail of P36,000 to the accused, according to the information released by the Police Regional Office-Eastern Visayas.

The arrested persons were brought to their respective police stations prior to turn-over to the courts of origin. (RONALD O. REYES)

the face of China's stubborn and defiant stand to not remove its 200-ship presence at the Whitsun Reef, which is well within the Philip-

pines' 200-mile exclusive economic zone, the United States finally issued a warning that China ought to take heed.

The State Department spokesman Ned Price told reporters that China's armed attack against our armed forces, public vessels, or aircraft in the Pacific and in the South China Sea could trigger their obligations under the US-Philippines Mutual Defense Treaty. They, according to him, share the concerns of their Philippine ally regarding this massing of PRC maritime militia in that part of the contested waters.

The government maintains that those vessels unlawfully entered our exclusive economic zone. But despite weeks of appeals from the Philippine authorities, China, which claims almost the entire resource-rich West Philippine Sea, refused to leave. This refusal has prompted the United States to issue the above warning, to the advantage of the Philippines which China merely belittles and bullies.

Fears had initially circulated when the Biden regime came to power, knowing that President Biden had been known to be rather friendly with China and so, he could have left the Philippines alone should an armed conflict erupt. But luckily, too, the newly elected US president has just vowed a robust defense of its Asian allies against Chinese assertiveness.

At least now, we are not alone in trying to drive the Chinese vessels away off the country's territories in the West Philippine Sea—we have the unwavering support of the US which, as we know, is the only obstacle that gives China second thoughts in their intention to grab this entire maritime territory.

ICPSS training to help distant villages become conflict-resilient, says Army officer

BORONGAN Some 19 elements of the 78th Infantry Battalion attended a 21-day Integrated Community Public Safety System (ICPSS) Trainers Training at the 801st Brigade in Brgy. Fatima, Hinabangan, Samar.

"Infra projects will not be hampered anymore because the people themselves will be the ones to secure the implementers and heavy equipment."

ORDINANCE NO. 2021-14-04

AN ORDINANCE PROHIBITING THE POSSESSION. SNEAKING-IN AND/OR AIDING ENTRANCE OF CONTRABANDS INTO JAILS. DETENTION FACILITIES AND REHABILITATION CENTERS IN TÁCLOBAN CITY, AND PROVIDING PENALTIES FOR VIOLATION THEREOF

Sponsored by: Hon. Leo O. Bahin

WHEREAS, under the General Welfare Clause of Republic Act 7160, otherwise known as the Local Government Code, every loca government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. WHEREAS, local government units shall, within their territorial jurisdictions, promote health and safety, maintain peace and orde

and preserve the comfort and convenience of their inhabitants among other things; WHEREAS, the existence and/or presence of contrabands in jails, detention facilities, and rehabilition centers is detrimental to public order and safety, and increase the likelihood of escape attempts;

WHEREAS, the identification and control of contrabands in jails, detention facilities and rehabilitation centers is an important part of jail, detention and rehabilitation center administration and sets a precursor for other programs to be established and to realize the goals of rehabilition.

Be it enacted by the Sangguniang Panlungsod, City of Tacloban, Philippines, that: Section 1. Title of the Ordinance - This Ordinance shall be known as "AN ORDINANCE PROHIBITING THE POSSESSION, SNEAK-ING-IN, AND/OR AIDING ENTRANCE OF CONTRABANDS INTO JAILS, DETENTION FACILITIES AND REHABILITATION CENTERS IN TACLO-BAN CITY, AND PROVIDING PENALTIES FOR VIOLATION THEREOF".

Section 2. Declaration of Policy. It is the declared policy of the City Government of Tacloban to protect and uphold the safety of its constituents by promoting an orderly and peaceful city to live in.

Section 3. Scope or Coverage. This Ordinance shall cover all jails, detention centers and rehabilitation centers situated within the territorial jurisdiction of the City of Tacloban. Section 4. Objective of the Ordinance. This Ordinance aims to identify and control the entry and presence of contrabands in jails

detention facilities and rehabilitation centers, and thereby rid them of materials/instruments that may be used by Persons Deprived of Liberty (PDL), Persons Under Police Custody (PUPC)/patients to inflict physical harm to personnel and visitors of other PDL or PUPC, or facilitate the inmate's attempt to escape, as well as to rid them of prohibited drugs and substances and paraphernalia Section 4. Definition of Terms:

a) Contrabands - it is defined as any article, item or thing forbidden by rules of the jails, detention facilities and rehabilitation center that would pose as security hazards or endanger the lives of PDLs, PUPCs such as but not limited to: 1) Illegal Contrabands - are contrabands that are unlawful per se or in themselves and not because of some extraneous circum

stances a) Prohibited and other regulated drugs and paraphernalia

 b) Deadly/Bladed weapons and other potential weapons
 2) Nuisance Contrabands - are those that are not classified as illegal under the law but are forbidden by the jails, detention facilities and rehabilitation centers rules, such as: a) Intoxicating Beverages/Liquors b) Cigarettes, Tobacco and Lighters

c) Cellular Mobile Phones and Other Communication Devices

d) Video Camera/still camera

- e) Money in excess of the jail, detention facility or rehabilitation center's regulated amount
 f) Commodities of exchange such as jewelry, appliances and gadgets

g) Pointed/sharpened objectsh) Glass Bottles and Mirrors

b) c) d)

i) Pornographic Materials j) Gambling Paraphernalia and other products considered as vices

 k) Qualified excessive clothing materials and sleeping paraphernalia I) Yeast and other substances used as ingredients for the manufacture of intoxicating liquor

m) Sim card for mobile phones

Paraphernalia - any instrument or contraption used for the dispensation or intake of harmful substances, especially illegal drugs Personnel - refers to any personnel of the jails, detention facilities and rehabilitation centers. Visitor - a person who enters the jails, detention facilities and rehabilitation centers for a definite period of time to meet an inmate or personnel of that jail, detention facilities and rehabilitation center or conducts business or activity in that

jail, detention facility and rehabilitation center.

a) Postection 6. Prohibited Acts. The following acts are strictly prohibited.
 a) Possession by inmate or personnel of contrabands or other prohibited items or paraphernalia

b) Sneaking or smuggling in of contrabands by visitors of PDL or PUPC or other individuals in jails, detention facilities and rehabilitation centers

c) Aiding or facilitating by personnel or official or by any other individuals the entrance of contrabands into jails detention centers and rehabilitation centers.

Section 7. Penalties. Any violation of the provisions of this Ordinance shall be penalized as follows Fine of Php 1,500 and Confiscation of the illegal and nuisance contrabands and/or other items, and/or imprisonment for 3 months, at the discretion of the court. 1st Offense

- Fine of Php 3,000 and Confiscation of the illegal and nuisance contrabands and/or other prohibited items, and/or imprisonment of 6 months at the discretion of the Court. 2nd Offense
- 3rd Offense
- Fine of Php 5,000 and Confiscation of the illegal and nuisance contrabands and/or other prohibited items and/or imprisonment of 1 year at the discretion of the Court.
- A. If the offender is a minor, he/she shall be subject to Juvenile and Justice Welfare Act of 2006 (R.A. 9344) and other applicable laws of minor offenders.
- B. If the offender is a personnel of the jail, detention facility or rehabilitation center, he/she shall also be

subject to applicable administrative and criminal charges under other laws. Section 8. Implementing Rules and Regulations. The Implementing Rules and Regulations shall be prepared by both the Bureau

of Jail Management and Penology - Tacloban City Jail and Philippine National Police - Tacloban City Police Office for the effective implementation of the Ordinance.

Section 9. Separability Clause - If any provision of this Ordinance is declared unconstitutional or inoperative, the other provisions not so declared shall remain in force and effect. Section 10. Repealing Clause - All laws, decrees, orders, issuances, rules and regulations or parts thereof inconsistent with the

Act or the rules and regulations promulgated pursuant thereto are hereto repealed and amended accordingly Section 11. Effectivity - This Ordinance shall be effective 15 days after its publication. ENACTED, March 3, 2021.

SECTION 1. SHORT TITLE - This Ordinance shall be known as "AN ORDINANCE DESIGNATING THE NATIONAL HIGHWAY WITHIN THE MUNICIPALITY OF SALCEDO. EASTERN SAMAR AS TEMPORARY LANE FOR TRICYCLES AND TRICYCLES-FOR HIRE"

SECTION 2. SCOPE AND COVERAGE. - Only tricycles and tricycles-for-hire operating within Salcedo, Eastern Samar may use the National Highway within the territorial jurisdiction of the municipality at a maximum speed limit of forty (40) Kph. The operation and use of the National Highways by the pedicabs and motorized pedicabs remain prohibited.

SECTION 3. DEFINITION OF TERMS. - As used in this ordinance, the following terms are defined:

a. Pedicab – a non-motorized vehicle composed of a bicycle fitted with a single-wheel side car operated to render transport services to the general public for a fee.

b. Motorized Pedicab - a pedicab fitted with a single-wheel side car but mounted with a motorized engine or motorcycle operated to render transport services to the general public for a fee.

c. Tricycle – a motor vehicle composed of a motorcycle fitted with a single-wheel side car or a motorcycle with a two-wheel cab.

d. Tricycle-for-Hire - refers to a motor vehicle composed of a motorcycle fitted with a single-wheel side car or a motorcycle with a two-wheel cab, operated to render transport services to the general public for a fee and with a valid existing franchise issued by the municipality.

e. National Highway - means public roads kept and maintained by the National Government connecting the municipality to another municipality

SECTION 4. PROHIBITED ACTS.

The wanton travelling of tricycles and tricycles-for-hire through the cen ter lanes of national highways:

b. Non-observance by the tricycles and tricycles-for-hire of the prescribed maximum speed limit of forty (40) Kph.

c. Use and operation of pedicabs and motorized pedicabs on National High ways outside the población area which covers Brgy. 1 to 13;

SECTION 5. PENALTIES – All violators of this Ordinance shall be apprehend ed and meted with the following penalties:

a. FIRST OFFENSE - reprimand

- SECTION 6. EFFECTIVITY This ordinance shall take effect within fifteen (15) days after its publication and shall remain in full force and effect until alternative modes of transportation and appropriate service routes are established.

AN ORDINANCE DESIGNATING THE NATIONAL HIGHWAY WITHIN THE MU-NICIPALITY OF SALCEDO. EASTERN SAMAR AS TEMPORARY LANE FOR TRI-CYCLES AND TRICYCLES-FOR HIRE"

WHEREAS, Section 447 (3) (vi) of the Local Government Code of 1991 confers to the LGUs, through the Sanggunian concerned, to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality, subject to the guidelines prescribed by the Department of Transportation and Communications (DOTC);

WHEREAS, Memorandum Circular No. 2020-036 of the Department of Interior and Local Government dated February 17, 2020 mandates all LGUs to strictly ban tricycles, pedicabs and motorized pedicabs from operating on national highways utilized by 4-wheel vehicles greater than 4 tons and where normal epees exceeds 40 Kph;

WHEREAS, the said Memorandum Circular is a reiteration of the previous DILG MC No. 2011-68 dated May 9, 2011 and MC No. 2007-01 dated January 2, 2007;

WHEREAS, the LGU of Salcedo finds the above-mentioned DILG circulars l lessen hazards and road accidents leading to loss of live and limbs to the riding public and the pedestrians;

WHEREAS, this Sanggunian sees the need however, to give liberties to tricycles and tricycles-for-hire by allowing them to use the National Highways considering that tricycles-for-hire are the primary mode of public transportation in the municipality:

WHEREAS, pertinent provisions of the Guidelines issued by the DOTC to Implement the Devolution of LTFRBs Franchising Authority over Tricycles-for-Hire to LGUs pursuant to the Local Government Code state that "For safety reasons, no tricycles should operate on national highways utilized by 4 wheel vehicles greater than 4 tons and where normal speed exceed 40Kph. However, the SB/SP may provide exceptions if there is no other alternative route."

WHEREAS, the authority of the Sangguniang Bayan to bestow an exception if there is no alternative route was upheld by the Supreme Court in LTO vs City of Butuan (G.R. No. 131512, January 20, 2000);

WHEREAS, in going to the town proper of Salcedo, tricycles coming from Barangay Casili-on on the north and from Brgy. Buabua from the south has no other alternative route, except to pass through the National Highway;

NOW, THEREFORE, BE IT ORDAINED as it is hereby ordained by the Sangguniang Bayan of Salcedo, in session duly assembled, THAT:

of cases like Tagapul-an," Sabalberino said.

"That is why, we are reminding our local chief executives to please follow the prioritization criteria. That our frontliners will be prioritized because they are the ones who are most at risk," she added.

Sabalberino said that more than 22,000 health workers and frontliners have so far received their first doses of vaccines using the Sinovac and AstraZeneca brands.

"We have completed 100 percent for our medical workers assigned at hospitals and rural health units in the region," she said.

But the DOH official said that they have extended their priority list by including those manning the checkpoints and assigned at the barangay response teams reason that their priority list has now increase to over 82,000 from the previous 27,000 individuals who were mostly medical workers.

Sabalberino said that she could not say yet as to how many doses of vaccines Eastern Visayas will receive next time, saying this depends on the number of vaccines received by the national government.

have moral obligation to help those who are in despair. We are ready to respond 24/7," Sabalberino added.

Dr. Shiena Ann Legaspi, the lone doctor of the group, said that she is just happy to respond to the call of the national government for them to help their counterparts at the NCR during this time of pandemic.

"While I am a little bit nervous I am still happy to serve during this time of pandemic," Legaspi, who is from Cordillera Region but assigned at the rural health unit in Basey, Samar for two years now, said.

Sabalberino said that these health workers will be assigned at the Lung Center of the Philippines in Quezon City for a minimum of two weeks to a maximum of two months, depending the COVID-19 situation at their assigned hospital which is among the health facilities which are now in full capacity due to the high number of COVID-19 patients there.

She added that the deployed personnel have received their first doses of anti-COVID vaccine using the Sinovac except for one.

The 32-year old registered nurse said that he was assigned in areas in the region like Tarangnan, Samar, where there were high cases of COVID-19.

"I am ready now. I am already vaccinated and I will just try to be extra careful," he said.

Sabalberino assured the public that despite of the deployment of these 16 medical health workers, there are still medical personnel in Eastern Visayas to answer the need if there will be a surge of COVID-19 cases in the region.

Gov. Petilla gives freehand to LGUs in the province on swabbing requirement for returning residents

TACLOBAN CITY The provincial government of Leyte will not require returning residents to submit a negative RT-PCR (reverse transcription polymerase chain reaction) result.

However, the municipalities, to include Baybay City, which are under its jurisdiction are free to require such requirement, Governor Leopoldo Dominico Petilla said.

"It depends to the mayors. There are mayors who requires that," he said, referring to RT-PCR negative swab result for returning residents.

as possible. Just last month, a man driving his motorcycle with a sidecar came over to our subdivision, selling his sacks of "garden soil". Since I've been into planting various kinds of potted plants, mostly vegetables, I was easily tricked into buying, more so when he cupped the soil in his palm and showed it to me. It really looked like loam soil, the kind of soil that is so fertile.

Unfortunately, it was not fit for planting at all. Because when I placed them 72 hours before they arrive but what if they get infected a day before they are swabbed then it defeat the purpose," Petilla added.

In the absence of RT-PCR test, Petilla said that the returning residents have to follow a provincial ordinance that requires them to personally report to their respective rural health units, city or municipal health offices, or to barangay officials so they could be assess if they have the symptoms of the coronavirus disease (COVID-19).

Petilla said that if they manifest any symptoms, they will be subjected to swabbing and isolation. If the test is positive, they will be quarantined immediately, otherwise, they will be allowed to go home but still

be monitored. Aside from detection through swabbing, iso-

Exec asks Visayas to send medical workers to NCR areas which are experiencing surge of COVID-19 cases

His office is also calling for registered nurses to volunteer for the deployment at NCR. Those who will volunteer, aside from receiving P5,000 cash incentives every month, they will also be provide with transportation, accommodation, and financial package that

amount to around P33,000. On Wednesday (April 7), 16 medical health workers from the region, composed of 15 nurses and one doctor, travelled to NCR where they are to be assigned at the Lung Center of the Philippines in Que-

dettie

zon City.

They are expected to stay there for at least two months, depending on the situation at NCR.

DOH8 Acting Regional Director Exuperia Sabalberino, DOH-8 acting regional director, said that they may still send another batch of health workers if there is a need.

In an interview with Southern Leyte Governor Damian Mercado, he said that the province is willing to send health workers since they have list of applicants who are looking for job at the hospital run by the provincial government.

Leyte Governor Leopoldo Dominico Petilla, on his part, said that he already received such request from Gonzales but he still needs to have a meeting with the provincial health office to determine their response because Covid-19 is not the only health problem that the province is attending.

Metro Manila along with its neighboring provinces of Rizal, Laguna, Bulacan, Cavite are placed by the Inter-Agency Task Force under what they call NCR Plus bubble which are experiencing a spike of COVID-19 cases. (ROEL T. AMAZONA)
