The 11 nurses, all assigned at various rural health units from the different provinces of the region, will be assigned at the Philippine Heart Center.

# EV donates over 1,000 blood units to augment blood needs of COVID-19 patients in NCR

TACLOBAN CITY -Aside from sending volunteer nurses to the National Capital Region (NCR), the regional office of the Department of Health also sends blood units.

Dr. Exuperia Sabalberino, regional director of the Department of Health (DOH), said that they have donated 1,079 units sourced from blood donations made by the Eastern Visayas Regional Medical Center (EVRMC) held last

"As Filipino, we need to help each other especially in times of crisis," Sabalberino added.

From this collection, (20) units of type AB Rh(positive) packed red blood cells, 80 units of type O Rh (positive) packed red "This is very significant blood cells and one unit of type O Rh (Negative) blood will be sent to the Philippine Blood Center.

This is the first time the EVRMC sends blood units to NCR which is a experiencing a spike of coronavirus disease (COVID-19)

Sabalberino said that due to the increasing number of positive cases detected for COVID-19 at the NCR for the past months now, the conduct of mobile blood donation (MBD) campaigns is now quite impossible to do since it would only put the voluntary blood donors at risk of contracting the infection.

Because of this, the blood stocks of the Philippine Blood Center was reported to be in its critical level.

# **DPWH-TCDEO** starts the construction of new evacuation center at Brgy. Kawayan

**TACLOBAN** CITY-The Department of Public Works and Highways (DPWH) Tacloban City District Engineering Office (TCDEO) - started the construction of a 50 m x 28.9 m evacuation center located at Barangay New Kawayan.

The P33.85 million project is funded under the General Appropriations Act of 2021.

The project features the construction of 17 rooms inclusive of a clinic, admin office, prayer room, storage room and kitchen.

The evacuees will also be well accommodated providing them with facilities such as breastfeeding room, conjugal rooms and play room. Furthermore, there are enough comfort rooms for all refugees for the building will have shower stalls and toilet and bath for male, female and persons with disabilities (PWDs).

"Leyte is notably susceptible to natural calamities especially typhoons, thus the project targets to protect these vulnerable communities by providing them with a safe and hazard adaptive place where they can seek shelter and where their safety is considered paramount," said DE Lino Francisco Gonzalez.

Building evacuation centers is part of the DP-WH's program on disaster risk reduction and climate change adaptation but more than that the Department continues to complete its mission to build a safe place for the community responsive to their needs. (PR)

# Region's inflation rate inches up to 2.9% in March 2021

TACLOBAN CITY -The inflation rate of the region inched up to 2.9 percent in March 2021, a report from the Philippine Statistics Authority (PSA-8), based in this city said.

PSA Regional Director Wilma Perante disclosed that the inflation rate is 0.1 percentage point higher compared with the 2.8 percent in February 2021.

"This figure is also 0.7 percentage point higher than the recorded 2.2 percent inflation rate in the same period last year," she

Perante said that in comparison with the national average inflation rate, the regional inflation rate is 1.6 percentage points lower than the national level of 4.5 percent.

She added that among the provinces, only Northern Samar registered a decrease of 0.6 percentage point. Its inflation rate declined to 2.2 percent in March 2021 from 2.8 percent in February 2021.

Leyte, meanwhile, retained its previous month's record of 1.9 percent. Biliran registered the highest increase of 0.9 percentage point, pushing its inflation rate to 3.6 percent in March 2021.

She added that Southern Leyte, and Eastern Samar's inflation rates registered increases ranging from 0.3 percentage point to 0.4 percentage point, settling at 6.5 percent, 4.0 percent, and 3.3 percent, respectively, during the see Region's /page 10 ...

# Sec. Nograles distributes housing units for 'Yolanda' survivors in Eastern Visayas

Cabinet Secretary Karlo Nograles, Task Force Yolanda chief, led the distribution of free housing units in coordination with the National Housing Authority (NHA) to 713 families in Hernani, Eastern Samar on April 14, 2021 as part of the Duterte administration's continuing commitment to provide quality public service to victims of Typhoon Yolanda.

Since assuming the chairmanship of the Inter-agency Task Force for the Unified Implementation and Monitoring of Rehabilitation and Recovery Projects and Programs in Yolanda-affected Areas, Nograles has turned over 18,668 units to different cities and municipalities in Region 8.

The Malacañang official stressed that all the houses have needed basic provisions such as water and electricity, adding the sites

TACLOBAN CITY At least 445 beneficiaries of the of Tulong Panghanapbuhay sa Ating Disadvantaged / Displaced Workers (TUPAD) from the three towns here in Leyte have received their wages during a simple ceremony held this city on Thursday(April 22).

The beneficiaries who each received P4,875 for their 15 days of work were from the town of Tolosa (178), Alangalang (178), and Palo (89).

Among those present during the payout held at the provincial auditorium were Leyte Governor Leopoldo Dominico Petilla, Vice Gov. Carlo Loreto, Tolosa Mayor Maria Ofelia Alcantara, Alangalang Mayor Lovell Yu and Regional Director Henry John Jalbuena of the Department of Labor and Employment (DOLE) which initiates the work-

for-pay program. Labor Sec. Silvestre Bello III was represented

"Our appeal to the beneficiaries, is for them to use the money that they received in good way. Use this for the needs of your family, of your children," Jalbuena said.

TUPAD is a community-based package of assistance that provides employment emergency for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed.

beneficiaries of The rendered their TUPAD work in social community projects, such as repair, maintenance, and/or improvement of common

public facilities and infrastructure such as schools and health centers, debris clearing, de-clogging of canals, debris segregation and materials recovery, stockpiling and clearing; economic community projects like repair, maintenance and/or rehabilitation of farm-to-market roads, bridges, post-harvest facilities, public markets and common service facilities such as production and display centers, fish ports, and agro-forestry community projects, such as tree planting, seedling preparation, and refor-

Prior to deployment to their work, the beneficia-

ries undergoes orientation on health and safety, and they are issued with personal protective equipment (PPE) in the form of T-shirt and hat, enrolled in group micro-insurance, and given a TUPAD ID.

For the beneficiaries from the three towns, they rendered their work in community gardening in public facilities, and street clearing project under the **Emergency Employment** Program for 15 days with a daily wage of P325.

Each beneficiaries received during their payment a total of P4,875 or a total of P2.20 million 445 beneficiaries.

division. The alleged act of Red-Tagging for Ms. Non , because she is leading a volunteer of Community Pantry advocates somehow break my heart. The act defies logic and common



#### **APPLICATION**

APPLICANT, SAMAR I ELECTRIC COOPERATIVE, INC. (SAMELCO I), through counsel, unto this Honorable Commission, most respectfully alleges,

#### **THE APPLICANT**

- 1. SAMELCO I is a non-stock, non-profit electric cooperative, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at Brgy. Carayman, Calbayog City, Samar;
- 2. It holds an exclusive franchise issued by the National Electrification Commission, to operate an electric light and power distribution service in the of Calbayog and nine (9) municipalities in the province of Samar, namely: Sta. Margarita, Gandara, San Jorge, Matuguinao, Tarangnan, Pagsanghan, Sto. Nino, Almagro and Tagapul-an.

#### **LEGAL BASES FOR THE APPLICATION**

- 3. ERC Resolution No. 16, Series of 2009 as amended by Resolution No. 21, Series of 2010 establishes the procedure for the automatic recovery or refund of pass through costs and the confirmation process that would govern the automatic cost adjustment and true-up mechanisms approved by the Honorable Commission, with the objective of ensuring appropriate recovery of the pass through costs in an efficient manner and to put in place a fair and transparent process for the confirmation of the automatic cost adjustments implemented by Distribution Utilities and the true-up of other pass-through charges, involving Generation Rate, Transmission Rate, System Loss Rate and Lifeline Rate Recovery, as the case may be;
- 4. On the other hand, ERC Resolution 23, Series of 2010 adopts the rules implementing the discounts to qualified senior citizen end-users and subsidy from subsidizing end-users on electricity consumption;
- 5. Foregoing resolutions further require the distribution utilities to file their respective consolidated applications once every three (3) years.
- 6. Hence, the filing of the instant application, covering the period of January 2018 to December 2020.

#### **OVER OR UNDER RECOVERIES OF ALLOWABLE COSTS**

- 7. Applying the formulas provided under Resolution 16, Series of 2009 as amended by Resolution 21, Series of 2010 and Resolution 23, Series of 2010, SAMELCO I made calculations of the over recoveries charged or underrecoveries incurred as against its customers, in the implementation of certain automatic cost adjustments and true-up mechanisms, covering the period January 2018 to December 2020;



Meanwhile, Perante said that the purchasing power of peso (PPP) of the region weakened to P0.76 in March 2021.

This PPP implies that the goods and services worth P76.00 in 2012 is now worth P100.00 in March 2021.

She added that compared to their levels in February 2021, PPP Samar Northern strengthened by P0.01, while the rest of the provinces retained their previous month's PPP.

Biliran and Leyte recorded the strongest PPP among provinces in March 2021 at P0.79. Southern Leyte ranked second at P0.78, followed by Eastern Samar at P0.74 and Northern Samar at P0.72. Samar posted the weakest PPP during the reference month at P0.70.




