TACLOBAN CITY-The city government of Catbalogan City has confirmed existence of African Fever Swine (ASF) cases as 17 pigs have been killed and buried in a pit to stop spread of the virus.

Dr. Antonio Cinco, city in a telephone interview. veterinary, said that they have first detected the existence of ASF in Barangay Mercedes, about a kilometer away from the city proper, last May 3.

However, the regional office of the Department of Agriculture (DA-8) based this city, only confirmed the existence of the ASF in Catbalogan last May 14 with the samples submitted for laboratory test from their office, Cinco said.

"We have immediately conducted our depopulation located within the 500 radius where the first cases of ASF were monitored as part of the process," he said

This is the first time that

Catbalogan City has reported of confirmed ASF cases.

Earlier, several areas in the region, particularly in the towns of Abuyog, Javier, La Paz, Dulag, MacArthur, Palo, Pastrana, Burauen, Jaro, Mayorga, Carigara, Tolosa, Tabontabon, Dagami and Tacloban City, all in Leyte; Lope de Vega in Northern Samar; Silago in Southern Leyte; and Calbayog City.

At least 17 pigs, three of them were sows, have been killed and buried in a pit with a depth of 18 feet.

93-year old woman among region's new deaths due to COVID-19 complications

TACLOBAN CITY-A 93-year old woman was among the new deaths of the region due to complications of coronavirus disease (COVID-19) as reported by the Department of Health (DOH).

The woman was from the town of Padre Burgos in Southern Leyte province who died on May 16 who was suffering from hypertension. Her death was only reported by the

DOH last Sunday(May 23). It was learned that the woman was the first COVID case of the town to have succumbed due to complications of the deadly virus.

The DOH in the region also confirmed of the three other deaths relative to COVID-19: a 77-year old woman from Matuguinao town in Samar who died on May 22; a 70-year old man from San Juan, also in

Southern Levte who died on May 21; and a 56-year old man from Jaro in Leyte who also died on May 21.

With this latest deaths, the DOH reported that the region has now 301 number of deaths due to COVID-19 complications.

As cases of COVID-19 continue to increase in the region, several local government units have imposed tighter measures to contain the spread of the virus.

In Biliran, Gov. Rogelio Espina also renewed his directive for those who will attend Church-related activities are to wear face mask at all times and minors and seniors who are suffering with lingering illness will not be allowed to attend Masses.

In Calbayog City, Mayor Diego Rivera reiterated an executive order issued on April 8 limiting travels of the people which is to end on June 4. Non-essential travels

like travel for leisure or tourism purposes among the locals will not be allowed and those going and returning to the city will be quarantined for 14 days.

The total number of COVID-19 cases in the region now stand at 19,960 with 47 new cases reported on Monday (May 24).

Meantime, the number of active cases is now at 754

with 18,905 recoveries. (JOEY A. GABIETA)

TACLOBAN CITY -The city government of Borongan is appealing to the Department of Health (DOH) to allocate more vaccines to their locality as more residents are showing interest to get vaccine shots.

The appeal was made by Mayor Jose Ivan Dayan Agda after the drive-thru vaccination for senior citizens finished early due to lack of vaccines last May 21.

Borongan City is the first local government unit in the region to implement a drive-thru vaccination site which the residents, particularly the seniors, convenient that going to vaccine sites.

About 25 senior citizens, who were willing to get vaccinated, went home with heavy hearts after

the vaccine supply ran out, Mayor Agda said.

"I feel sad that after the city government worked hard to raise the public's awareness and confidence on the vaccine, we could barely respond to their current need or demand for it," the city mayor said.

"I therefore appeal to DOH-8 to grant us, by all means, more vaccines, of whatever brand, because our people in this city are not at all "choosy," he added.

Among the senior citizens who received their first dose of COVID-19 vaccine was Bernardo Palada, 74 of Barangay Canjaway who was in all praises to the drive thru initiative of the city government.

DSWD in the region to start using vacuum-sealed rice for distribution

TACLOBAN CITY-Kilogram of rice being distributed during disaster or calamity by the Department of Social Welfare and Development (DSWD) in Eastern Visayas are now being placed in vacuum-sealed packs.

In fact, during the department's food distribution among victims of Typhoon 'Bising' that hit the region last April, the DSWD started to distribute three kilograms of rice placed in vacuum-sealed plastic though at limited volume.

At present, three kilograms of rice are placed in an ordinary plastic.

But by having rice placed in vacuum-sealed, its quality and shelf-life are not affected, Rey Peñaranda, the agency's head on disaster management division, said.

This also effectively ensures that the rice will be

Poultry business funded by the Leyte provincial government thrives amid COVID-19 pandemic

TACLOBAN CITY The poultry program initiated by the provincial government of Leyte is now doing well despite of the raging pandemic caused by coronavirus disease (COVID-19).

Governor Leopoldo Dominico Petilla said that despite of the current pandemic, the poultry business of the Christian Family Association in Abuyog, which started last February, is thriving. The provincial government extended P1.7 million worth of assistance to the association

which has 37 members. Petilla said that the association is now productive and supplies the

needed poultry products of the town and the nearby communities during this trying times of COVID-19 pandemic.

He added that the objective of the project is to supply the needed poultry products of Abuyog and its nearby municipalities. Petilla said that his office is promoting poultry production as an alternative livelihood of the people of his province.

It was learned that Leyte leads in poultry production in Eastern Visayas.

Records at the Philippine Statistics Authority(PSA) regional office

shows that among provinces in Eastern Visayas, Leyte recorded the highest chicken population at 831,095 birds as of January 2020, comprising more than one third (39.1 percent) of the total chicken population of the region.

Group extends food assistance to villagers in Calbayog City

TACLOBAN CITY Several residents of Calbayog City continues to receive food rice assistance from private groups and personnel from the Philippine National Police.

The People's Outreach Program (POP), together with its program partners, the 125th Special Action Company, 12th Special Action Battalion, Special Action Force; First Samar Provincial Mobile Force Company; Calbayog City Police Station and 3rd Platoon, and 803rd Maneuver Company of the 8th Regional Mobile Force Battalion on Saturday conducted a relief assistance in Hugon Rosales, one of the villages located at the Oquendo district of the city.

At total of 63 households received rice assistance from the group.

Aside from Hugon Rosales, they also distributed rice packs to residents in Tarabucan, Langoyon and Sinantan and food packs to the children.

In Langoyon and Sinantan, aside from rice packs, they also distributed vegetable seeds to residents as livelihood

assistance while everyone is still battling the economic crisis caused by the COVID-19.

A total of 1,000 packs of okra seeds, 600 eggplant seeds, and 2,000 packs of pechay seeds were distributed to the residents of Langoyon, an interior village about 33 kilometers from the city proper.

POP and program partners have been responding to the community for those seeking help including patients needing transport to the hospital and financial assistance to defray their medicine and hospital bills.

They also provide assistance to children of alleged abandonment or child abuse, conducted bloodletting activity.

The group also conducted immediate assistance when Tarangnan, Samar was declared in a hard lockdown when Covid-19 cases spiked last year in the said municipality.

POP and PNP units in Calbayog will continue its partnership to help the community while combatting the corona virus.

These pigs were from Mercedes, where four pigs were first to have been confirmed to have ASF, and the villages of Canlapwas and Munoz.

These three villages have a combined of more than 100 pigs population, the city veterinarian said.

"Right now, we cannot say conclusively what could have been the source as to why ASF entered Catbalogan City," Cinco said.

But movement of people, particularly a technician who visited in Mercedes where the first four confirmed cases were reported, could have brought ASF in the city.

Cinco said that he was directed by Mayor Dexter Uy to immediately contain any possible further spread of ASF in the city.

Among the measures that they have instituted was the establishment of buffer zone where pigs coming from outside the city are prohibited to enter and prohibiting the swelling feeding among hog raisers.

He added that the owners of the pigs depopulated are assured of financial assistance from the DA.

A New Age for Philippine Education amidst a global pandemic: The pros and cons of distance learning

The current pandemic has rendered the world into a "new age". Looking back, no one would expect that 2019 would bring such massive change to our everyday lives and how it affected the things we used to view as normal. Leading that list would be the field of Education. During the height of the pandemic, educational institutions proposed remote learning as an alternative solution.

The immediate action and plan was aimed to minimize the closing by continuing to provide high-quality education. In the midst of these, online learning was one of the first proposed learning mode, as a temporary solution to adapt with the new normal situation which differs from the usual face-to-face classroom setup.

According to a journal article published by Ruel F. Ancheta, Ed.D. (2020), he stated that the sudden shift to online learning created a hot debate in the Philippines citing the poor living conditions of the learners.

It caused debate amongst teachers, learners, parents and other community stakeholders. Each group, voiced out their concerns and opinion as to how they could come up with a solution that could be fair and feasible for everyone. Hence, the De-

600 youths in Leyte avails **DOLE's financial assistance**

TACLOBAN CITY-Some 600 youth beneficiaries from the Sangguniang Kabataan (SK) of Tacloban City, Palo, and Alangalang in Leyte have availed the Tulong Panghanapbuhay Para sa Ating Disadvantaged/ Displaced Workers or Tupad program of the Department of Labor and Employment (DOLE).

"The DOLE never stops working in order to help our workers, including our youths, especially during this pandemic," said labor Assistant Secretary Victor Del Rosario during the payouts to the Tupad workers last May 17, 2021.

Each beneficiary received P3,250 as payment for their services rendered during the 10-day implementation of the Tupad program.

They were also provided with personal protective equipment and micro insurances.

partment of Education introduced the various learning modalities both parents and learners could select from in relation with the concept of distance learning.

Before we unravel these knotted strings of how Philippine Education entered a complex new era of learning let's define what's distance learning first.

Distance education, also called distance learning, is the education of students who may not always be physically present at a school (Kaplan et.al, 2016). When the term was first introduced to the general public, the locales' reactions were mostly a combination between confusion and worry. It was understandable since it was newly introduced concept. Now the divisive reaction among the people enters here where the social standing and financial capabilities are concerned.

Magsambol (2020) cites an obvious gap between those who can and cannot afford the resources to avail the new education platform. With the DepEd's mantra of 'no one left behind,' the overall state of children in the public education system sends a message of injustice.

Yet, both the privileged and marginalized group faced the same major risks and obstacles that comes with remote learning-which was the absence of direct guide and discussion from their teachers. This is just the tip of the iceberg. Such corresponding issues are inevitable especially when introduced to a third world or developing country that takes importance with survival.

Suddenly I remembered a quote from Debasish Mridha an American physician, philosopher, poet-seer, and author. He said, "Stress is nothing but the fear of change." Our country has developed a mindset of mental bias against new ideas. It is the product of our shared experiences with hardships and our culture of striving in spite of social constraints.

Thus, moving forward by taking this small step of cooperating and taking the risk with solution presented by the education department was a promising start amidst such trying times.

Now we finally proceed with the main highlight of this write up which are the pros and cons of distance learning. Builds independence and enhancing focus

on learning. With the absence of a physical mentor when it comes to discussion and explanation of topics, the learner is expected to take initiative with thru selfstudy or seeking their parents' help for certain queries.

Through self-studying, the learner's newly gained knowledge retains longer. Another advantage or benefit of this, is of course, less social interactions with outsiders which is are one of the few reasons why we're having distance learning in the first place.

Coming up are the cons. First, too much independence and isolation diminishes the idea of collaboration since there is less opportunity with interaction to peers. Second, speaking of collaboration some learners finds it hard to adapt with the remote learning situation and the lack of teacher's presence in their education. Some prefers sitting in a classroom and meeting with classmates of friends in order to learn. Hence, environment is one of the determining factors that affects a student's learning performance. These pros and cons could vary depending on which specific learning modality a school chose to use and manage.

Either way whether prepared or unprepared the Filipino people takes pride with resilience.

As one of the famed essays of prominent Filipino writer Ismael Mallari goes, "The Filipino is like the bamboo tree. He knows that he is not strong enough, to withstand the onslaught of superior forces. And so he vields. He bends his head gracefully with many loud protestations." This seeming lack of vitality is, however, only one go his means of survival. He does not allow the world to be too much with him. Like the bamboo tree, he lets the winds of chance and circumstance blow all about him; and he is unperturbed and serene. From our strength with adapting, to our persevering nature, despite falling behind with numerous trends that came with this new age of learning, it's safe to say that the Filipino people would always move forward as the sun rise from the east and sets in the west.

The local government has open the island town that is famous for its rock formations subject to protocols set by the municipal inter-agency task force against COVID-19 during their meeting last May 21.

Tourists within the region who are planning to visit the island town are advice to make reservation and present a negative antigen test result with three days validity before visiting the town.

A letter of acceptance will be issued by the Municipal RHU upon the presentation and verification of the antigen test result. Those with non-verified antigen test are not to be given clearance and will not be allowed by motorboat operators to ride

the transport vehicle to the eral islands located within island town.

Local tourists will also need to present their valid identification cards, wear face masks and face shields and observe physical distancing.

Tourists from outside the region whether fully vaccinated or not will have to present, a negative RT-PCR test with contact details of the examining physician or medical personnel, their valid identification card, which they Macadlaw, Puhunan, Belneed to submit to the RHU for verification.

Those who will be given the go signal to enter the island town are reminded to always follow the minimum health protocols which includes proper wearing of face masks and face shield, physical distancing, sanitizing and hand washing.
