TACLOBAN CITY- In another record-breaking day for the region in so far as new cases of coronavirus disease (COVID-19), the Department of Health (DOH) announced on Thursday (June 10) of 572 fresh cases.

The 572 new cases of the region was part of the 1,855 samples tested by four COVID-19 testing laboratories or a positivity rate of 30.84 percent.

For the past three days alone this week, the region's COVID-19 daily new cases reached to 635 with Wednesday's fresh cases at 361 as one of the highest ever for the region.

The increasing trend for COVID-19 cases of the region has prompted the Regional Inter-Agency Task Force on Emerging and Infectious Diseases to place the entire region to a stricter General Comsee DOH /page 3 ...

# CHO asks priority groups to register for COVID-19 vaccination

CITY-TACLOBAN While the city continues its inoculation of COVID-19 shots to residents in the A1 to A3 categories, the local government here is optimistic to speed up the vaccination rollout as essential and economic workers are now asked to sign up through the online vaccine registration system.

### Vessel containing 'tahong' caught at the red tide identified Carigara Bay

T A C L O B A N disposed. CITY-A fishing vessel was caught illegally transporting 1,200 kilograms of green mussels or 'tahong' on Wednesday (June 9) around 7 am by the personnel of the Bureau of Fisheries and Aquatic Resources (BFAR) and Coast Guard at the Carigara Bay.

The incident happened as BFAR has reported of the presence of red tide toxin in various bays in the region to include the Carigara Bay.

Report from the BFAR office said that the fishing vessel, whose owner was not identified except to say he was the Irong-Irong bay from Villareal, Samar, (Catbalogan, Samar); failed to present a local San Pedro bay (Basey, transport permit from BFR and an auxiliary (Jiabong, Motiong, Painvoice from the origin ranas, San Sebastian, of the mussel transported reason why it was stopped seized.

The BFAR said that they have been receiving reports that despite of the ban to collect green mussels and other fishery products in the area due to the presence of the red tide, such activity had been spotted by local residents.

The seized green mussels, valued at around P60,000, were

The owner of the vessel will be charged for violating Fisheries Administrative Orders (FAOs) 233 and 235 which provides penalty of more than P10,000 and imprisonment of up to one year if proven

guilty. BFAR earlier released its shellfish bulletin No. 16 on May 27, 2021 putting 11 bays and coastal waters in Eastern Visayas under shellfish ban or the prohibition of gathering, transporting and selling of all types of shellfish and Acetes sp. or Alamang.

## Borongan village placed under 14-day hard lockdown

TACLOBAN CITY A village in Borongan City was placed under hard lockdown due to its increasing cases of coronavirus disease (COVID-19).

Placed under hard lockdown by Mayor Jose Ivan Dayan Agda was Barangay Calingatngan which started last June 1 and is to end on June 14.

"There is a need to place Calingatngan under hard lockdown in the order to conduct disease surveillance and contact tracing to account all possible contact in such barangay by reason of the spike of the COVID-19 cases," Agda said.

The city government, however, did not disclose as to the number of COVID-19 cases in the village which has 451 families consisting of more than 2,200 individuals except to say that their cases exceeded the 'tolerable level.'

With the imposition of hard lockdown, only those residents with essential travels are allowed to exit and enter the village, including government employees with official travel, medical and health emergencies and other workers in the private sector.

The affected families received food assistance from the city government consisting of five kilos of rice, one whole chicken and canned goods.

While under lockdown, curfew was imposed in the village, mass gathering is prohibited, tourism sites are closed, and contact sports are prohibited, including drinking of alcoholic beverages, but the operation of public transport within the village will continue.

Delivery of food, basic goods and commodities shall not be hampered however, only a maximum of give personnel including the driver shall be allowed to enter the village.

The mayor also orders personnel at the Barangay Border Control to use QR code scanning persons coming inside and outside of the village and they must present QR code and barangay quarantine pass. (ROEL T. AMAZONA)

TACLOBAN CITY- General experiencing a surge of coronavirus disease (COVID-19), several areas in the province were placed under stricter quarantine status.

Under Resolution No. 24 of the Regional Inter-Agency Task Force (RIATF) issued last June 4, some areas in the province were placed under Modified Communi-Enhanced ty Quarantine (MECQ) while others are under

Community active cases. As Southern Levte is Quarantine (GCQ) and the rest are under Modified GCQ.

The town of Pintuyan was placed under MECQ, while the city of Maasin and towns of Hinunangan and Liloan were placed under GCQ.

The rest of the province is under Modified Community General Quarantine (MGCQ).

As of June 5, Pintuyan has a total of 60 confirmed COVID-19 cases, with 45 recoveries and 15

But again, every bit of victory against the virus seems to be just a temporary triumph since, all of a sudden, trends could change and gains could turn to losses. As vaccines continue to mass-produce and the number of people receiving the vaccines increases, the virus likewise continues to mutate, the new variants becoming more versatile, contagious, and deadly.

In our country, this unpredictability likewise ap-

But never forget that there will come a time when all these qualities start to ebb away, and we start losing things—our memory, our hair and teeth, our hearing, our sense of direction, etc. We can have cognitive decline, and then we lose our life itself!

# A2: on the production of SLMs/LASs

Alangalang II District, Alangalang, Leyte under the supervision of the emulating Public Schools District Supervisor, Dr. Leonides C. Lego schedules the printing of Self-Learning Modules (SLMs) and Learning Activity Sheets (LASs).

The use of these SLMs/ LASs emerged as the most preferred distance learning method for pupils based on the results of the Learners Enrollment and Survey Form. With this, teachers need to reproduce the modules one is to one ratio to all the learners for home schooling.

So, to speed up the printing of these learning materials, Dr. Lego schedules the printing every week from Monday to Friday. Grade Three on Monday; Tuesday, Grade Two; Wednesday, Grade Four; Grade Five is on Thursday

and Grade Six is on Friday. However, Kinder and Grade One do not join the printing since they require colored modules.

Printing of modules uses the risograph machine donated by the Local Government Unit of Alangalang, Leyte thru the very proactive Mayor Lovelle Ann M. Yu.

This machine produces copies of one document which is very essential in this time of pandemic because it expedites the production of contextualized SLMs and teacher-made activity sheets.

The Local Chief Executive believes that this risograph is a great help to the teachers become more efficient.

Teachers report to the district on their scheduled time following the health protocols set by the Department of Health.

Bond papers procured through the Monthly Operating and Other Expenses, supplies from the DepEd Leyte Division and donations from stakeholders are utilize in the production of modules. Every school allocates an amount from their MOOE for the master roll and ink of the risograph machine.

Because of this systematic weekly reproduction of modules, no learners are left behind, and teachers lessen the time spent in printing and can do others tasks like home visitation/monitoring, checking and sorting of retrieved modules and recording.

# Southern Leyte solon hopeful TF-ELCAC bill taken up after SONA

MAASIN CITY- The legislative measure that seeks to institutionalize the whole-of-nation approach in ending the decades-old communist insurgency in the country may be calendared after the President's State of the Nation Address (SONA) next month.

This was expressed by Rep. Roger Mercado, principal author of the said house move, in an impromptu press briefing Wednesday at his residence in this city.

He said he would make a follow up on this matter after the President shall have delivered his annual

address, his sixth and final SONA, on the last Monday of July, this year the date is July 26.

The lone district lawmaker of the province earlier confirmed he had filed a bill to make permanent in the government's agenda matrix the implementation of Task Force - End Local Communist Armed Conflict (TF-ELCAC) and its corresponding counterpart down to the regional and local government levels.

Last month, during a virtual press conference Panindugan anchored by Olive Tiu, PIA regional director, it was Col. Perfecto

Peñaredondo of 8ID who revealed that Cong. Mercado initiated efforts in the lower house of Congress to enact a law integrating TF-ELCAC functions.

With Executive Order 70 as basis for now since 2018, the task force is actually a convergence of several national line agencies including the private sector whose primary goal is to bring various services to vulnerable, distant, and isolated barangays, to let people feel and see how government works.

"We should not be fighting each other. Ever since I have advocated peace and development for our people in the countrysides," Rep.Mercado emphasized.

On attempts to defund the budget of TF-ELCAC, Cong. Mercado was confident it will not prosper.

Meanwhile, two house bills with local application were approved on second reading, and these are HB 9534 and HB 9536, both establishing fish ports in Saint Bernard and Barangay Ichon, Macrohon, respectively, according to Diego Credo, the congressman's info officer, in a message sent to local media. The accused, identified as rank 6 most wanted-municipal level, is facing a warrant dated March 6, 2001, for a rape case in Hilongos, Leyte.

The arrests were also made through the assistance of the police counterparts in the said areas.

Even the high school department has shown great results since research has been included in the curriculum. With such potential from these progressing field of Philippines it seems there's some group of individual that felt they're being left behind.

To shed light and to entice awareness most elementary teachers in the country lags behind these research age. As doing research develops and improves teachers' teaching knowledge and confidence (Borg, 2014), broadens and deepens understanding on their own teaching styles and students learning strategies (Borg, 2014; Hong and Lawrence, 2011; Burns, 2010), and makes them responsible and accountable for the improvement of their teaching practice (Morales, 2016), addressing their needs would uplift the spirit of the teachers to do research in the school.

The schools and other education institutions should also consider that doing research is an additional workload for the teachers.

Thus, teachers should be given sufficient time to do both teaching and doing research. By giving them the support they need, teachers will not only appreciate it but also see the good and the advantages in doing research for their professional development; for themselves, and for their students.

very impossible to survive in Manila where you have to buy everything," said Romenita, who traveled back to Abuyog, Leyte with her husband and two young daughters.

The couple has been applying for BP2 since last year, but it was only last month that their application was approved after thorough evaluation, she said.

On Friday, at least 49 BP2 program beneficiaries, belonging to the second batch, arrived at the airport here. The first batch returned to the province on May 28, signaling the resumption of the program.

Through BP2, the families availed of free airfare, meals before boarding and upon arrival, food packs, and health kits. The local government picked up the families at the airport for a trip back to their hometowns.

Before heading to Leyte, the recipients underwent dispatch procedures that included Covid-19 swab tests at the BP2 Depot in Quezon City on Thursday.

Officials from the Leyte provincial government, Department of Social Welfare and Development, Technical Education and Skills Development Authority, Department of Labor and Employment, National Economic and Development Authority (NEDA), and National Housing Authority welcomed the beneficiaries.
