# DOH renews call to place EV under GCQ

TACLOBAN CITY-The Regional Task Force against COVID-19(RIATF) and the Department of Health(DOH) has renewed its call before the National Inter-Agency Task Force (NIATF) to approve their recommendation to place the region under a stricter General Community Quarantine (GCQ) due to its successive record-breaking daily cases of the dreaded disease.

On Saturday (June 19), the DOH reported of 606 cases which increased further on Sunday (June 20) with 712 new cases, by far the highest recorded in the region since the pandemic started last year.

Currently, the total coronavirus disease (COVID-19) in the region now stands at 27,247 with 2,815 considered as active cases.

Nine new deaths were also reported by the DOH on weekend with the oldest involving a 97-year-old woman who succumbed on June 10 with the youngest involving a 52-year-old man who died on June 8. Both were from the town of Burauen, Leyte.

"In response to this overwhelming spike of cases in the region, the DOH and the Regional Task Force against COVID-19 continues its recommendation to the NIATF to escalate the community quarantine classification of Eastern Visayas from Modified General Community Quarantine to General Community the DOH Quarantine," said in a statement.

The continued increase of coronavirus disease (COVID-19) in the region was attributed by the DOH due to super spreader events like birthday par-

## After more than a week of suspension, vaccination drive in Tacloban resumes

vaccination activities here in the city resumed Monday (June 21) after of more than a week of temporary sumption of the vacci-

The scheduled inoculation drive on June 21 to 25 at the USAID Building in Kanhuraw Hill will be for target barangays 76, 1&4, 50-A, 59-B, 59, and 79.

On June 21 to 24, another vaccination drive will take place at Robinsons North Tacloban Mall in Abucay for the A2 Priority Group or Senior Citizens.

These senior citizens will come from target Barangays 3&3A, 18, 17, 28, 47, 5, 89, 30, and 50-B.

Around 500 elderly citizens of the city are expected to receive the jab at each site on the said dates, from 8a.m. to 11a.m., according to the city government.

Senior citizens scheduled for inoculation are reminded to bring their OSCA ID, ball pen, and QR Code; wear facemask and face shield; and show confirmation text message at the verification area to get a priority number.

"No walk-in will be allowed. Only senior clients who have received the confirmation text will be entertained. Those not belonging to the A2 category will not be entertained,"

Meanwhile, the city government said the renation drive came after a week's pause due to the surge of coronavirus disease (COVID-19) cases which also infected several vaccinated healthcare workers or vaccinators in the city.

Dr. Gloria Fabrigas, acting city health officer, said three nurses, one doctor, two information technologists, and two medical technologists were tested positive for COVID-19.

"However, even before they were infected with the virus, they have been isolated," said Fabrigas.

The infected health workers were discharged last June 19.

## Maasin City to lay down more strict protocols amid COVID-19 surge

**TACLOBAN** CITY-Maasin City Mayor Nacional Mercado reported that they had a meeting with the representatives from the Diocese of Maasin, along with officials from different law enforcement agencies and the Department of Interior and Local Government (DILG), to discuss the strict implementation of health protocols particularly on religious mass gatherings "for the benevolent purpose of slowing down the rising cases of COVID-19 affliction as well as the morbidity rate in our province."

"The city government of Maasin stands behind all our frontliners for relentlessly working under these precarious circumstances just to make the ends meet. Thereby, we fervently urged the public to strictly adhere to our established Covid-19 infection-prevention control measures," Merca-

The mayor's statement came after two incidents of alleged health protocol breach were reported

during the priestly ordination on May 24, 2021 and the first communion event on June 11, 2021 in the Our Lady of Assumption Parish Cathedral in the city.

Monsignor Oscar Cadayona, parish's executive pastor, also issued an apology for the said incidents.

"I would like to emphasize that we have no intention to disrespect our LGU (local government unit) by not following the minimum health protocol mandated by them. There was no intention to betray the trust and confidence afforded to us by our parishioners," Monsignor Cadayona said.

"We are painfully cognizant to the rising cases of COVID-19 in our community, that in our efforts to intensify our prayers by way of Catechisms and Evangelization so that this pandemic will end the soonest, there may be consequences of our actions that could have jeopardize our parishioners," added the priest.

## Eastern Samar mayor gets infection of COVID-19

- The town mayor of Arteche in Eastern Samar has confirmed that he was infected of the virus that causes coronavirus disease (COVID-19).

Mayor Roland Boie Evardone said last June 18 that the result of his RT-PCR test turned positive though he was in self-isolation since June 7 after he experienced flu.

He requested those who had been in contact with him while in isola-

CITY tion to submit themselves ence any symptoms. for swab test and isolate especially if they are experiencing symptoms related to COVID-19.

> Evardone said that even he is in isolation, he had meetings with officials of his town to plan how they can manage to decrease cases and prevent the spread of COVID-19 in the municipality.

The town mayor added that he is thankful that he is already vaccinated because he does not experi-

Mayor Evardone had issued an order to temporary close the municipal hall of the town for disinfection and contact tracing after an official tested positive with COVID-19.

He also issued Executive Order No. MB-16 that places the entire town under Modified General Community Quarantine restricting movements of the town residents and limiting them to only accessing goods and services

from permitted establishments or for work.

The order also prohibits super spreader events such as cockfighting, assemblies, public events, meetings, drinking session in public place.

Operations of tourism related establishments and destinations are also temporary suspended.

The order also directed all returning residents from outside the region

## Vaccination time

fter much waiting for vaccine volumes to arrive, we finally got this development regarding the country's plans to speed up COVID-19 vaccinations and to start inoculating the youth later this year, after signing the biggest supply deal yet with Pfizer Inc. and BioNTech SE.

This was revealed by the government's vaccine czar Carlito Galvez himself. According to him, the 40 million doses from Pfizer-BioNTech are expected to begin arriving by August, bringing the country's total supply to 157 million. That adds to deals for 26 million doses from Sinovac Biotech Ltd., 20 million from Moderna Inc., 17 million from Astra-Zeneca Plc. and 10 million from an agreement with Russia for Sputnik V.

Aside from theses, the country also has a commitment from Covax for 44 million doses, and a further 16 million from Novavax Inc. and Johnson & Johnson are still under negotiation. As of June 18, the government had administered a little more



### **Local treatments**

We can't blame the average Filipinos if they resort to home treatments when they get afflicted with illnesses. That's what they have been accustomed to doing. Hospitalization, to them, is the last recourse. And so, with this coronavirus in progress, we can only

expect them to do the same

Do you think the number of COVID-19 cases nationwide is accurate? I don't think so. First, there are those who are tested positive but, in reality, they are not. Some things have just gone wrong in the process. than 8 million doses and targets ramping up the daily inoculation rate to 500,000 by the third quarter, and at least 740,000 by the last three months of 2021 from a high of about 323,000 on June 15.

At least now, government critics will not anymore be accusing the government pocketing the loan with the Asian Development Bank for the procurement of these shots. The Philippines has the second-highest number of COVID-19 infections in Southeast Asia, with 1.35 million as of June 19 compared to Indonesia's cases approaching the 2 million mark.

The Philippines began vaccinating about 35 million workers this month and is monitoring how other countries inoculate their young population as guidance for about 29 million Filipinos in that age group according to Galvez. The economy, which suffered five straight quarters of contraction after implementing one of the world's longest lockdowns last year, is counting on vaccines for its recovery.

And most of all, there are those who may be positive, with symptoms shown, but are not submitting themselves to swab testing.

Well, aside from the fact that there are fears associated with this testing—like being taken away from home and confined in isolation facilities with no one caring for them-they refuse hospital confinement as they are yet trying their luck at quackery. Call them home treatments if you may. But that's what they do, especially in the provinces, in remote areas, and particularly among the have-nots.

When all home treatments fail and their conditions deteriorate, that's the only time they go to the hospitals, but it's usually

too late already. And as a result, the cure is hardly attained.

Certainly, there must be symptomatic people who are not responding and are in fact avoiding the authorities as regards following protocols beyond social distancing and the wearing of masks and face shields in public. When it comes to cooperating in the trace as to who they got exposed to, and observing quarantine procedures just in case contagion occurred, they hardly cooperate and just keep things to themselves.

Per common knowledge, the coronavirus is not an exception. When

## **Charity always in** our judgments

"Judge not that you may not be judged." (Mt 7,1) We have to understand these words of Christ well. It does not mean that we should not judge at all. In fact, in the succeeding verse of the gospel passage, Christ said: "For with what judgment you judge, you shall be judged. And with what measure you mete, it shall be measured to you again."

In fact, in the gospel of St. John, we hear Christ saying: "Judge not according to the appearance, but judge just judgment." (7,24) It's clear that we have to be most careful in our judgments. We cannot be reckless about them, judging persons and things on the basis of instincts or feelings alone, or on some opinions, personal preferences, social trends, and even sophisticated theories and ideologies.

What is clear is that whatever judgment we make, which is an unavoidable act we do all the time actually, it should be done properly, that is to say, to judge the way Christ himself would judge persons and things. We should shun making rash judgments. Judging is an unavoidable and indispensable operation of our intellect that is meant to know people and things in general.

So, we just have to learn to judge fairly, because that Christian injunction not to judge people refers more to when we judge people rashly or unfairly. It does not mean that we should not judge at all, because that would be impossible and would directly go against our God-given na-

ture. To judge people fairly, we need to see to it that charity always prevails.

And this can begin by always thinking well of everyone. The reason for this is simply the fact that we are all children of God. We are all object of his divine love that goes all the way to saving us from our sin by God becoming man and that God-man, Jesus Christ, accomplishing our redemption by bearing all our sins

on the cross. Christ, who is the pattern of our humanity and the restorer of our dam-

aged humanity, was always judging. He could even read minds of the people. That is why he many times was moved to compassion and mercy when he saw people in some state of misery, and at other times, to anger also when he saw people bristling with self-righteousness. All these reactions of Christ are a result of judg-

We all should strive to be persons of sound judgment. It's an ideal whose importance, relevance and urgency are increasing these days, given the complicating conditions we are getting into.

Let's realize that we can only see, judge and know persons, events and things properly when we have a vibrant interior or spiritual life, a vital link not only with theories and principles, but with God himself.

# Palay production grows by 6.7% in the 1st quarter of 2021

TACLOBAN CITY-Palay production in Eastern Visayas increased by 6.7 percent, from 252,869 metric tons (MT) in the 1st quarter of 2020 to 269,853 MT in the same quarter of 2021. This is attributed to a notable 10.5 percent expansion in the total area harvested for palay from 75,600 hectares (Ha) in the 1st quarter of 2020 to 83,522 Ha in the same quarter of 2021.

Likewise, the hefty increase in production was due to the increase in the production in Northern Samar by 73.5 percent during the reference peri-

The province of Leyte contributed the biggest share in palay production in Eastern Visayas at 139,207 MT during the 1st quarter of 2021.

It comprised more than half or 51.6 percent of the total palay production in the region. Samar came next with 52,865 MT production, accounting for 19.6 percent of the region's total palay production.

Northern Samar followed with 40,228 MT production contributing 14.9 percent share to the total production. Eastern Samar and Southern Leyte shared 7.2 percent (19,377 MT) and 4.7 percent (12,600 MT), respectively. Biliran had the least contribution at 2.1 percent (5,576 MT) of the total palay production in the region.

All provinces except

Biliran and Leyte registered increases in area harvested for palay. Northern Samar posted the biggest increment at 76.7 percent from 8,575 Ha in the 1st quarter of 2020 to 15,155 Ha in the same quarter in 2021. Likewise, area harvested for palay in Eastern Samar, Samar and Southern Leyte increased by 17.8 percent, 2.0 percent, and 0.5 percent, respectively.

Among the provinces, Southern Leyte recorded the highest yield per hectare at 4.36 MT/Ha during the 1st quarter of 2021.

This figure was 1.9 percent lower compared with the 4.45 MT/Ha recorded in the same quarter of 2020.

Biliran followed at 4.32 MT/Ha, 0.7 percent lower than its 4.35 MT/Ha recorded in the 1st quarter of 2020. Leyte ranked third with 4.21 MT/Ha, also a 0.7 percent lower compared with its figure in the same quarter of 2020.

Northern Samar ranked fourth with 2.65 MT/Ha, a decrease of 1.8 percent from 2.70 MT/Ha recorded in the same quarter of 2020. Samar registered a 2.33 MT/Ha in the 1st quarter of 2021, a decrease of 2.1 percent from 2.38 MT/Ha in the same quarter in 2020.

## **DPWH-Leyte 2nd DEO completes P9.55M** road improvement project leading to **Mahagnao Natural and Volcano Park**

**TACLOBAN** The Department of Public Works and Highways (DPWH) - Leyte Second District Engineering Office (L2DEO) recently completed the P9.55-million off-carriageway road improvement leading to Mahagnao Natural and Volcano Park in Burauen, Leyte.

The project involves an additional 1.5-meter of road pavement on both side of the existing road in Barangay San Esteban along Burauen-Mahagnao road section covering a total length

of 519 meters which was completed last May 31, 2021.

MVNP, about 65 kilometers south of Tacloban City, the regional center and proclaimed as a national park in 1937, is endowed with other natural attractions -a lake, falls, multi-colored mud, hot springs, virgin forests, and lagoon.

Mahagnao's summit is a steep-walled heavily forested crater that opens to the south with a peak elevation of 860 meters.

DPWH off-carriageway improvement projects aims to make better access of road that will help enhance the local economy, decrease the volume of traffic and accidents and convenience in travelling.

Aside from this project, the district office is set to implement P550-million slope protection project considering that some portions along Burauen-Mahagnao road section are prone to mudflows and landslides.
