# EV leaders mourn death of PN

TACLOBAN CITY-The sudden death of former President Benigno 'Noynoy'Aquino shocked and saddened officials here in the region as they extended their condolences to the family of the late leader, and extolling his contributions to the development of Eastern Visayas.

Mayor Alfred Romualdez of this city said that he is joining the rest of the country in expressing condolences and grief to the Aquino family on the demise of the former president.

Romualdez said that when he learned about the passing of the former leader, he has to verify the information first saying he was preoccupied in overseeing the ongoing vaccination against coronavirus disease (COVID-19).

"I was unsure whether

it was true because I was busy here,"he said, referring

"But on behalf of the Taclobanons, I express my condolences to the family of the late president Aquino," he added.

The city mayor said that at his age, the former president was still "young" but his health could have been affected due to his duties as president.

"He was just 61.Bata pa.Mahirap talaga ang trabaho ng isang Presidente... it took toll on his health,"

Romualdez said.

## Maasin seeks for more vaccines amid its spike of cases of COVID-19

TACLOBAN CITY -Mayor Nacional Mercado of Maasin City has sent a letter to the National Inter-Agency Task Force, and the Department of Health to assist the city in the fight against its rising coronavirus disease (COVID-19).

In his letter, Mercado requested to the national official for the city government to be prioritized in the giving of vaccines doses and to increase its vaccine allocation.

"We humbly request to be prioritized in the giving of vaccines doses thus allowing an increase of Covid-19 allocation to serve the demand of our beloved constituents who are in dire need of protection," Mayor Mercado said.

The mayor said that Maasin City have spiked to 140 COVID-19 cases with an average daily attack rate of 15.30 per 100,000 population in the past two weeks.

Mayor Mercado also asked health Sec. Francisco Duque for more COVID-19 vaccines.

"As of today, we only received 3, 205 doses of Sinovac and AstraZeneca vaccines," the mayor said.

"Thus, we humbly request to be prioritized in the giving of vaccines doses thus allowing an increase of Covid-19 vaccine allocation

to serve the demands of our beloved constituents," the mayor added.

He also asked Duque to help in the release of their PhilHealth reimbursement to their health facilities and additional provision for medical supplies, personal protective equipment, N95 mask, RT PCR test kits, rapid antigen test kits, ventilators, high flow oxygen and medication such as FDA-approved drug Remdesiver.

"We are hoping for a quick reply since lives are at stake every day and resources and manpower are overwhelmed. Our active cases in Maasin City continue to go up, a lot are already suffering especially our frontliners and we are hoping that this will be given action as soon as possible," he added.

As of June 24, Maasin City, the capital of Southern Leyte has a total of 877 confirmed COVID-19 cases, of which 684 are tagged as recovered, 171 active cases with 22 deaths.

Moreover, the city government had asked the Diocese of Maasin through Bishop Precisio Cantillas to allow them to utilize some facilities owned by the diocese which was immediately granted.

## Town councilor, 6 others nabbed in separate anti- drug stings in the region

TACLOBAN CITY- A municipal councilor and six other suspects were arrested in separate anti-drug operations in the region from June 21 to 22, 2021.

Almar Balais, a councilor of San Miguel town in Leyte, was arrested after he allegedly sold a sachet believed to be containing suspected shabu to an undercover operative in Tacloban City on June 21.

Authorities also confiscated from the suspect's possession two medium-sized sachets of suspected shabu, buy-bust money, and a ve-

The estimated worth of

confiscated pieces of drug evidence was P40,800, police said in the report.

In Dulag, Leyte, the suspects were identified as Albert Tupaz, listed as street-level individual, and Benjamin Raarag, a newly identified drug personality.

They were arrested on June 22 after Tupaz allegedly sold a sachet believed to be containing suspected shabu worth P1,000.

Confiscated from Raarag were two sachets of suspected shabu.

In Calbayog City, police rounded a fish vendor, Abundio Pamad, for allegedly selling a sachet of suspected shabu worth P500 to an undercover operative on June 21.

Also recovered from the suspect's possession were seven sachets believed to be containing shabu, buy-bust money and P500 cash.

Tacloban police, in coordination with the Philippine Drug Enforcement Agency (PDEA), nabbed two suspected drug personalities in Tacloban.

## Man, escaped from jail from Calbiga in 2019, rearrested in Manila

TACLOBAN CITY- An inmate who bolted a jail facility in a Samar town in 2019 was rearrested in Sampaloc, Manila last June

Rodel Mabahin,22 was captured by elements of the National Capital Region Police Office together of the police personnel from Calbiga town in Sampaloc, Manila where he said to went into hiding after he bolted at the Calbiga prison facility last 2019.

The suspect was facing multiple charges like carnapping, serious illegal detention, robbery, theft and homicide, among others.

The rearrest of Mabahin, considered as the number seven most wanted in Calbiga town, was due to the tip received by the police authorities of his presence in Sampaloc, Samar police provincial director Glenn Oliver Cinco

Mabahin, together with his brother, Roel, bolted the Calbiga jail facility last March 11, 2019 by cutting the bars of their cell.

During their daring escape, they carried with them several government issued firearms. Roel remain at large.

Six regional trustees of the Philippine Press Institute (PPI) were re-elected during its annual members' meetings and regional press forums on June 7, 9, and 11 via Zoom. Four Board officers also retained their positions.

Balikas publisher and editor Joenald Medina Rayos from Batangas City and Herald Express's publisher and editor Dexter See from Baguio City were elected for another term by Luzon members as their representatives to the PPI Board.

The Visayas members also unanimously voted MetroPost publisher and editor Alex Rey Pal from Dumaguete City and Leyte Samar Daily Express publisher Dalmacio Grafil from Tacloban City as regional trustees.

Mindanao Times editor-in-chief Amalia Montecillo Bandiola and Mindanao Observer managing editor Adrian A. Amatong were re-elected for another as trustees for Mindanao.

Retaining their positions as Board officers are: Manila Standard publisher Rolando Estabillo as chairman-president, Cabusao as vice-president, Rayos as treasurer, and See as corporate secretary. Joining them as trustees are Philippine Daily Inquirer's associate publisher Juliet Javellana, Al Pedroche for both Pilipino Star Ngayon and The Philippine Star, Malaya



Business Insight's Monica Macasaet, Gus Villanueva from the Journal Group of Publications and Joyce Pañares from Manila Standard who is currently seminar director.

Ariel Sebellino is also trustee, executive director, and head of training operations and special projects.

Both Estabillo and Sebellino lauded the regional trustees and members for "keeping up with the times, especially because the pandemic took a toll on the survival of the newspapers".

They vowed to keep the institute relevant in the age of social media and infodemic, and responsive to the needs of its members through its current programs and digitalization project.



Basketball never stops, even its not us playing. The game is played in our heads, in our banquet with friends and family. The game is vibrant in the confine of our conversations and common interests. We have to develop as early as possible a sense of the sacred in our life. We can develop this sense of the sacred when we remember that in any liturgical act, for example, no matter how handicapped by our human limitations and mistakes, we are actually doing and participating in the act of Christ, the act of the Church with all the saints and angels and the Christian faithful.

It is our most social act,

because it is a concrete articulation of the communion of saints that we are meant to live as Christian believers even while here on earth. We anticipate heaven on earth with the liturgy.

It is communion of life and love, and not just something external, something social or political. It goes deep into our heart where we become one in Christ in spite of our human differences and conflicts.

We have to be more aware of the danger of familiarity with the sacred things and install the necessary defenses against it. More than that, we have to aggressively cultivate the art of always being amazed at God and at all his works. That should be the proper state for us to be in.

We have to understand, though, that this abiding state of amazement that we should try to develop is not a matter simply of sensations. Of course, it would be good if we can always feel amazed and in awe. But given the limitations of our bodily organism, we cannot expect that to happen all the time.

The ideal abiding state of amazement is more a matter of conviction, of something spiritual, moral and supernatural. It should be the result of grace that is corresponded to generously and heroically by us.

It is a state of amazement that sooner or later, of course, will have some external manifestations like an aura of serenity and confidence even in the midst of great trials and suffering It will most likely show itself in the lilt in one's voice, optimism in his reactions to events, a smile, a warm word of praise and encouragementto others, etc.



## SPCR project, done in 51.478%

NSSDEO, Brgy. Burabud, Laoang, Northern Samar-Located in Brgy. Simora, Palapag, Northern Samar, the contractor of one of the high impact projects in the second district of Northern Samar, Samar Pacific Coastal Road (SPCR) has provided the NS-SDEO their latest monthly



accomplishment report.

In its Monthly Progress Report No. 37 covering the period April 26 to May 25, 2021, the project has actual cumulative accomplishment of 51.478% stating though that they are behind schedule.

## Calogcog Elementary School survives amidst pandemic

March 17, 2020 when President Rodrigo Roa Duterte ordered a national suspension of classes due to COVID\_19 and placing the whole country in Enhanced Community Quar-

Calogcog Elementary School teaching personnel sent a communication to all the parents and stakeholders on the suspension of classes. Prior to the said executive order, the teachers were able to conduct the Fourth Quarterly Assessment to all learners. They were able to complete the rating in School Form 9 which is the Progress Report Card and others required school reports while staying at home.

On the last week of May 2020, teachers started reporting to school following an Alternative Work Arrangement (AWA) based on DepEd Order No. 11 series 2020.

The school maintained a skeletal work force on a weekly basis. By July 2020, the school while following AWA attended several virtual pedagogical in-service training conducted by the national office of the Department of Education.

The first wave was for all school heads focusing on Learning Delivery Modality (LDM) in the new normal. This was followed by all teaching personnel.

A month before the opening of classes, the school conducted a Dry Run on Printed Modular Distance Learning Modality. Only 15 selected pupils from Grade Five Class was included. Prior to this activity, series of consultative meetings were done.

It was done successfully. Parents were interviewed on their opinions and inputs to help improve the learning delivery modality.

school was buzzing alive with cluster-parent leaders getting the learning activity sheet and self -learning modules observing strictly the cardinal rules of the Local IATF health & safety protocols. These protocols helped the school keep COVID-19 away from the school personnel and parents from being affected.

## Proposal for limited face to face tutorial for TVL classes in Leyte underway

A proposal is underway in the Department of Education (DepEd)-Leyte Division for the courses under Technical-Vocational-Livelihood (TVL) amid the current health crisis.

While TVL classes are now limited to those that can be done at home, this doesn't hinder the education leaders in Leyte to innovate and find ways to continue the implementation of the program.

Aptly said, the TLE education program supervisor in Leyte has proposed some preparations for limited face to face tutorials for TVL classes in the province.

The requirements include activity proposal to be approved by Schools Division Superintendent; detailed schedule of classes by batch with list of students to be prepared by the Advisers and Department Heads and to be approved by the Principal; budget estimate for the materials, ingredients and other consumables during the activity; and heath protocols procedure/ flow chart to be prepared by Disaster Risk Reduction Management (DRRM) Coordinator and School Nurse to be approved by the School Head.

Along with these documents, the department will also require individual parent's consent and a certification coming from the local Inter-Agency Task Force (IATF) approving the conduct of the activity duly signed by the local chief executive.

Earlier, DepEd Undersecretary Tonisito Umali admitted that the department is faced with a challenge on the implementa-

tion of TVL courses for the enrolled students.

"The way we're doing it right now, with respect to the course offerings in our tech-voc strand, we allow our schools division superintendents to make recommendations based on their experiences, based on the capability of the schools under their jurisdiction," Umali said in February this year.

Thus, the proposed limited face to face tutorial for students under TVL program is an empowering move from its leaders for the sake of the continuation of skills-driven lessons to support the needs of the students and youth in their future workplaces.

> **ORDINANCE NO. 16-301-21** (SPONSOR: HON. BEETHOVEN M. BERMEJO)

ORDINANCE PROHIBITING AND PENALIZING ANY PERSON, NATURAL OR JURID-ICAL, FROM CAUSING OBSTRUCTION/S ON STREETS, SIDEWALKS, AVENUES, AL-LEYS, BRIDGES, PARKS AND OTHER SIMILAR PUBLIC PLACES IN THE PROVINCE

WHEREAS, it may be recalled that President Rodrigo Duterte, during his 2019 State of the Nation Address, made a clear and emphatic directive to all Local Chief Executive to exercise their powers necessary to reclaim public road which have been used for private ends and rid illegal structures therefrom;

WHEREAS, the Department of the Interior and Local Government (DILG) issued several memoranda for compliance by Local Government Units, specifically Memorandum Circular No. 2019-121 dated 29 July 2019, Memorandum Circular No. 2020-027 dated 07 February 2020 and the more recent issuance Memorandum Circular 2020-145 the continuation of road clearing operations;

WHEREAS, Local Government Units are mandated to maintain all local roads within their jurisdiction as a basic service and facility, pursuant to Section 17(b) of R.A. 7160 or the Local Government Code of 1991;

WHEREAS, Section 4 of R.A. 11494 or the Bayanihan To Heal As One Act mandates that COVID-19 response and recovery interventions include among others, "regulation of traffic on all roads, streets, and bridges, and access thereto; prohibit putting up of encroachment or obstacles; authorize the removal of encroachments and illegal structures in public places";

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlalawigan of Samar in session duly assembled

SECTION 1. Title. This Ordinance shall be known and cited as the "Road Clearing Ordinance of the Province of Samar".

SECTION 2. Scope of Application. This Ordinance covers all kinds of obstruction on the streets and other public places in the Province of Samar committed by individuals, entities and companies other than those obstructions committed by persons while driving or operating motor vehicles and all other forms of conveyance.

SECTION 3. Prohibition. It is hereby prohibited and considered unlawful for any person or group of persons, entity or company to obstruct the free flow of people, goods, and vehicles through the Province's road network by using, utilizing or otherwise appropriating any street, sidewalk or pedestrian walkway, avenue, alley, bridge, park and other public place or portion thereof for commercial or personal purposes. The prohibition includes all kinds of obstruction and it not limited to the following;

- To utilize as shop, working area, warehouse, office or for any other purpose related to the conduct of business or otherwise as extension in the conduct thereof;
- b. Vending or selling all types of food item, magazines, newspapers, cigarettes, flowers, shoes and other footwear and such other similar commodities;
- c. Stations for seeking aims or solicitation of funds for whatever activity in any form by individuals or group of persons;
- d. Conduct of family gatherings/celebration, picnics or parties and merry-making activities, and drinking alcohol or such other intoxicating beverages;
- e. Household chores, such as but not limited to, washing and hanging of clothes
  - f. Vehicle garage and/or vehicle repairs;
- g. To utilize for the conduct of other activities related to transport i.e. as temporary terminal for public utility vehicles, tricycles and similar public transport;
  - h. Garbage dumping site;
- i. Setting up of basketball court and/or playing basketball or scheduling a season competition;
- Use of sidewalks to strap/hitch animals, fowls and the like, with or without a
  - k. Storing of junks, motor vehicles and/or parts and other recyclable materials;
- I. Use of sidewalks or any part of a provincial road as storage for construction
- m. House extension or stall/store extension, including installation of roofs or
  - n. Installation of fences;
  - o. Use of sidewalks or any part of the road for plants, trees and plat boxes;
  - p. To place stones/rocks/hollowblocks/cement slabs, tires and palay;
- q. To place wood or iron structure, used as signage for an establishment or a
- r. Sign or signboards of a business placed on or above sidewalks and detached

All items, goods and structures found on or along roads, streets, avenues, sidewalks, bridges, parks and other public places shall be confiscated by the Province of Samar without prior notice. The same shall be treated as common or ordinary garbage and shall be disposed of as such. Provided, that food commodities may be

(P2,500.00)

Third and Succeeding Offenses Fine of Five Thousand Pesos (P5,000.00) or imprisonment of six (6) months or both at the discretion of the Court.

SECTION 6. Separability Clause. If any section or part of this Ordinance is declared invalid or unconstitutional, other provisions or sections not otherwise affected shall remain in full force and effect.

SECTION 7. Repealing Clause. All other ordinances, orders, issuances, rules and regulations which are inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 8. Effectivity. In view of the emergency obtaining, this Ordinance shall take effect immediately after publication as provided in Section 511 of the Local Government Code of 1991. Let copies of this Ordinance be furnished to the two (2) cities and twenty four (24) municipalities of the Province of Samar; the Samar Police Provincial Office.

## Cops probe killing of data analyst in Leyte

TACLOBAN CITY-Police are investigating the death of a 36-year-old data analyst who was killed by still unknown assailants inside his residence in Barangay Monte Alegre, Isabel, Leyte Tuesday (June 22).

The victim, Davin Maurillo, died due to multiple gunshot wounds on the different parts of his body.

Initial investigation disclosed that two unidentified suspects wearing bonnets rushed inside the victim's

They were identified as Marlito Fian, a barangay councilor, and an 18-yearold student.

Operatives bought from them two pieces of suspected shabu worth P20,000.

A watch listed personality, Michael Mergildo, was arrested in Almeria, Biliran after he allegedly sold a sachet of suspected shabu worth P500 on June 21.

Police and anti-drug agents also seized from the suspect's possession and

control two sachets believed to be containing suspected shabu.

The alleged drug evidence has an estimated weight of around one gram and with estimated street value of P6,800, according to the information released by the Police Regional Of-

The suspects will be facing charges for violation of sections 5 and 11, Article II of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002. (RONALD O. REYES)
