This after Mayor Alfred Romualdez rescinded on Friday (July 9) an executive order he issued on July 5 which allowed only vaccination card as a requirement for them to come to the city.

Romualdez, in issuing Executive Order Number 2021-07-27, said that the move to revert back on the need of a negative swab test result as a requirement is due to questions raised on how to verify the vaccina-

verification and validation process of the vaccination cards have been raised by various local government units and such concerns are yet to be properly addressed by the IATF and DOH," the city mayor said on his order on revoking the earlier order.

Contrary to IATF policy Calbayog City will still require returning individuals of a negative RT-PCR result

TACLOBAN CITY -Calbayog City will still require a negative RT-PCR result for those coming in to the city as its coronavirus disease(COVID-19) continue to surge.

This policy of the city's Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID) is in contrary to the policy imposed by the National Inter-Agency Task Force abolishing negative swab results as a requirement for entry.

"Because our COVID-19 cases have not yet decreased, the Calbayog IATF decided that we will still subject returning residents negative RT-PCR tests," the city's IATF statement said.

And those who will present a negative RT-PCR result will qualify for a 14-day home quarantine but failure

Southern Leyte Governor Damian Mercado downgraded the quarantine status of his province from general community quarantine (GCQ) to the lesser strict moderate general community quarantine (MGCQ) for the entire month of July.

The move of the governor was based on the slowing down of the province's COVID-19 cases for the last few weeks.

Farmer shot, decapitated in Samar

TACLOBAN CITY- A 34-year old farmer was shot and killed before he was beheaded in Gandara, Samar.

Authorities identified the victim as Christopher Wahingon of Barangay San Francisco, Gandara whose body was found around 8 a.m. Wednesday (July 7) at the said barangay.

Initial investigation disclosed that Wangihon went to his farmland Tuesday morning, July 6, before he was killed.

At least six persons carrying high powered firearms were also sighted at their barangay before the incident. They were heading towards the victim's farmland, according to the police investigation.

A burst of gunfire was heard at the barangay around 2 p.m. Tuesday, it added.

The family started searching for the victim after he did not return home the following day.

Authorities recovered four empty cartridges of caliber 5.56 mm at the crime scene.

Gandara Municipal Police have launched a manhunt operation against the suspects. (RONALD O.REYES)

Sen Villar further reports that Composters are available from the Bureau of Soils and Water Management (BSWM) and the Department of Environment and Natural Resources (DENR), where she obtained 178 biodegradable waste shredders and composters that were distributed to LGUs, especially those involved in the cleanup and rehabilitation of Manila Bay. It was reported that it can produce 1,000 tons of organic fertilizer in one month.

While Sen Villar's Advocacy is confined in 16 cities and municipalities with watershed covers bounding Manila Bay, does not mean that LGUs not directly involved in the Manila Bay Rehabilitation, cannot avail of the project. Regional, Provincial and Municipal Agricultural and Environmental officials must be

ORDINANCE NO. 04 Series of 2021

"ORDINANCE PROHIBITING LENDERS/FINANCIERS AND PANTAWID PAMILYA PILIPINO PROGRAM (4Ps) BEN-EFICIARIES OF THE MUNICIPALITY OF BIRI, NORTHERN SAMAR FROM ENGAGING CASH AND PAWNING OF ATM CARDS AS LOAN COLLATERAL AND OTHER FALSE REPRESENTATION OR UNDERTAKING AND PROVIDING PENALTIES FOR VIOLATION THEREOF"

Introduced by: HON. SB MEMBER BERNARDA A. BERNALDEZ

WHEREAS, its intention is to prohibit, prevent, eliminate the 4Ps Cash Pawning or Loan Collateral and other false representation which eventually ruin its purpose to improve the quality of life of the people and more importantly for the education of the children;

WHEREAS, this Ordinance is directed to ensure effective and proper utilization of the Pantawid Pamilya Pilipino Program (4Ps) Cash Grant, thus to minimize poverty and hunger in the municipality of Biri, Northern Samar

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Biri, Northern Samar in session assembled that:

Section 1. TITLE - This Ordinance shall be known as "Cash Card Ordinance" of Biri, Northern Samar;

Section 2. DEFINITION OF TERMS:

1. Beneficiaries - active households or families registered and qualified in the Pantawid Pamilya Pilipino Program (4Ps);

2. Cash Grants - Monetary assistance released to 4Ps beneficiaries;

3. Collection of Fees - to collect any amount of money from 4Ps beneficiaries for valid and legitimate purpose;

4. False Representation - a false or wrongly representation regarding a material or fact with the knowledge or belief of its inaccuracy;

5. Fraud - an act of deceit, cheating or trickery made by dishonest individuals in order to receive benefits;

6. Gambling - to bet or play a game of chance or stake using the cash grants released by the Program to a Pantawid Beneficiary;

7. Lender, Financier - is an individual or business establishment engaged in granting loans with interest and collateral:

8. Pawning Cash Card - the cash card of Pantawid Pamilya Pilipino Program (4Ps) given to a financier as security for money borrowed or credit on items/goods;

9. Sanctions - fines and penalties that a 4Ps beneficiary or Lender/Financier will suffer for the commission of offenses as disciplinary actions;

Section 3. PROHIBITION:

1. it shall be prohibited for a 4Ps beneficiary to engage in pawning of his/her ATM Cash Card as collateral in exchange of money or good/items received from a lender or financier. Upon inspection of the ATM Card and found out that the same is not in the possession or custody of the subject beneficiary, the 4Ps beneficiary shall be held accountable and shall be declared a violation of the Ordinance.

2. Those Lenders, Financiers or business establishments are not allowed to accept the ATM Cash Card from 4Ps beneficiaries or as collateral of loans be it cash or non-cash items.

3. The act of gambling is an illegal activity. Any 4Ps beneficiary found engaging in gambling shall be done with accordingly. These Cash Grants from the Pantawid Program is intended for the education, health and food of the household especially the children.

Section 4. PENALTY

Any person found violating any provision of this Ordinance shall be penalized in the following manner:

First Offense	-	Counseling and Community Service for one (1) hour
Second Offense	-	a fine of One Thousand Pesos (Php 1,000.00)
Third Offense	-	a fine of Two Thousand Pesos (Php 2,000.00)
Fourth Offense	-	recommend for the omission or drop from the roll as 4Ps beneficiary

Section 5. Within thirty (30) days from the approval of this Ordinance, the Municipal Social Welfare and Development Office shall formulate the necessary implementing guidelines for the effective and efficient implementation of this Ordinance. The said implementing guidelines shall take effect fifteen (15) days upon review and approval of the Sangguniang Bayan.

Section 6. ENFORCEMENT

The Philippine National Police, its members, Municipal Social Welfare and Development Office, Municipal Link, and other agencies/organizations duly authorized by the LGU, Biri, Northern Samar shall be implementing agencies for the proper enforcement of this Ordinance.

Section 7. REPEALING CLAUSE

Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed, modified and amended accordingly;

Section 8. SEPARABILITY CLAUSE

If any part of the Ordinance shall be declared invalid, the parts not affected thereby remain in full force and effect.

Section 9. EFFECTIVITY CLAUSE

This Ordinance shall take effect upon compliance of the mandatory posting and publication requirement under RA No. 7160 otherwise known as the Local Government Code of 1991.

"ORDINANCE AUTHORIZING THE COLLECTION OF FEES IN THE AMOUNT OF ONE THOUSAND PESOS (PHP 1,000.00) PER KIT FOR THE USE OF ANTIGEN TEST KITS FOR THOSE TRAVELLERS PRIOR THEIR ENTRY TO THE MUNICIPALITY AND REINTEGRATION TO THE COMMUNITY AND PENALIZING VIOLATORS THEREOF"

WHEREAS, Section 15 Article II of the 1987 Philippine Constitution provides that the state shall protect and promote the right to health of the people and install health consciousness among them;

WHEREAS, with the declaration of President Rodrigo Roa Duterte putting the entire country under state of calamity due to the COVID-19 pandemic, the municipality of Biri has been seriously implementing health safety protocols to combat the spread of infection brought about by the corona virus. Thus, the requirement of those travelers entering the jurisdiction of the municipality of Biri, Northern Samar;

NOW, THEREFORE BE IT ORDAINED by the Sangguniang Bayan of Biri, Northern Samar in session assembled that:

Section 1. TITLE - This Ordinance shall be known as "Authorizing the collection of fees in the amount of One Thousand Pesos (Php1,000.00) per kit for the use of antigen test kits for those travelers prior their entry to the municipality and reintegration to the community and penalizing violators thereof."

Section 2. It shall strictly prohibited for those travelers entering the jurisdiction of Biri, Northern Samar especially those coming from places outside the Province of Northern Samar within the Region and places outside the Region without the negative result of Antigen Test with validity of not exceeding three (3) days or 72 hours. Requirement of antigen testing may vary for those travelers coming from different places of origin, when community quarantine classification changes in the Province of Northern Samar:

Section 3. Those travelers who prefer that antigen testing be undertaken at the Rural Health Unit, LGU, Biri, Northern Samar shall be charged the amoung of Php1,000.00 per kit, however, these travelers are required to take special trip of the motorboat on pila at the Lavezares or San Jose ports and directly be transported to the port of Barangay Poblacion, Biri, Northern Samar. The hiring of the motorboat shall commensurate to the seating capacity of the motorboat;

Section 4. The Rural Health Unit shall require the Official Receipt issued by the Municipal Treasurer's Office (MTO) as proof of payment that the traveler has already paid the antigen test kit and after which letter of acceptance shall be issued by the RHU to the incoming travelers;

Section 4. The antigen testing is an alternative way of instead placing incoming travelers to home guarantine, the LGU requires them to undergo antigen testing provided they pay the amount of Php1,000.00 per kit.

Section 5. The proceeds of sales of the antigen test kits then be alloted for another procurement to replenish the stocks of antigen test kits. The collection that be separately deposited in a special trust fund and cannot be used for any other projects except for the procurement of antigen test kits.

Section 6. PENALTY:

Travelers found violating any provision of the ordinance shall be penalized in the followng manner:

First Offense	-	Php 1,000.00
Second Offense	-	Php 1,500.00
Third Offense	-	Php 2,500.00 and 21 days imprisonment or both such fine and
		imprisonment at the discretion of the Court.

Section 7. ENFORCEMENT:

1. The members of the Philippine National Police shall lead in the enforcement of this ordinance;

2. Members of the Sangguniang Barangay, their BHERT's are also authorized to enforce this ordinance;

3. The Rural Health Unit assists in the enforcement of the Ordinance and the personnel from Municipal Treasurer's Office;

where the newly created patrol base is located.

The government forces though were able to retaliate by engaging the rebels to a 20 minute firefight but were overpowered as the NPAs said to have lobbed improvised explosive devices (IEDs) while they were firing at the government forces.

This resulted to the immediate death of one soldier and two Cafgu personnel.

Killed were T/Sgt. Junar Carpila, who acted as the team leader of the group, Mark Donald Lomuntad, and Geremias Etcobanas.

The wounded Cafgu personnel who were wounded due to the attack were identified as Edwin Adamero, Francis Legarse, Manny Maestre, Ronilo Porton, Jeffrey Pajanustan, and Helbert Pajanustan.

Three of them were first brought to the rural health unit in Jipapad while the remaining others were brought to a district hospital at the nearby town of Arteche where it was learned its mayor, Roland

Boie Evardone, nurse by profession, help in attending the wounded Cafgu

> members. The wounded soldiers were later brought to a hospital here in Tacloban City.

The soldiers and Cafgu personnel belong to the 52nd Infantry Battalion (IB) based in Oras town, also in Eastern Samar.

Bloodstains were the rebels positioned were seen which could have indicated that some of them were also injured or killed during the fire fight.

A team from the 52nd IB together with the police of Jipapad immediately conducted their pursuit operations against the reb-

Coffee and cacao farm plantation to rise in Ormoc City; projected to provide supply to the rest of Leyte

ORMOC CITY- A joint venture by the Energy Development Corporation (EDC), the country's leading geothermal producer, entered an agreement with the government to establish a coffee and cacao farm plantation in Barangay Tongonan, this city.

After almost three years of preparation and planning, a 45-hectare coffee and cacao farmstead will rise in Tongonan which is expected to provide livelihood opportunities to the members of the Tongonan Farmers Association (ToFA) and the community.

Aside from providing a steady income for ToFA members, the project is seen as a solution for a dire need for stable supply of coffee and cacao products in the province.

During the online signing of memorandum of agreement held recent-

ly, EDC vowed to provide P1.5 million worth of contributions to cover the expenses for the renovation of the existing facility owned by the ToFA, plantation expansion, and capacity development programs.

The Department of Science and Technology (DOST) with the assistance from Barangay Tongonan and the city government of Ormoc, through its livelihood council, will also provide training support and technical assistance.

The farm is expected to yield 12,000 kilograms of green coffee beans per year, Erwin Magallanes, EDC Leyte CSR head, said.

And this early, similar undertaking is projected to other barangay, he said.

"Now, more than ever, it is important that our host communities become resilient, self-reliant, and regenerative. We are grateful for the strong working relationship we have with the city government of Ormoc and their much valued support and concern they give to their constituents through initiatives such as this," Magallanes said.

ToFA president Thina Parco expressed endless thanks to the government and EDC whose been their partner for the past 30 years now.

DOLE urges business owners to get safety seal

TACLOBAN CITY-The Department of Labor and Employment (DOLE) here in the region urged business owners to get safety seal for their establishments amid the coronavirus disease (COVID-19) pandemic.

DOLE Regional Director Henry John Jalbuena said the safety seal certification program aims to safely reopen the economy and affirm consumers and the public in general of the establishment's compliance to the minimum public health standards.

"We are calling on other establishments to obtain their own safety seals and take part in safely re-opening our economy," Jalbuena said.

On Tuesday (July 6), the labor official awarded its first safety seal to Coca-Cola Beverage Philippines, Inc. in Barangay 75-Fatima Village, this city. DOLE will also be awarding safety seals to three more firms in Baybay City, namely SC Global Food Products, Inc., SC Global Coco Products Inc., and Specialty Pulp Manufacturing Inc.

According to the agency, the safety seal is valid for six months from the date of issuance and shall be displayed conspicuously at all entrance points of the establishment.

DOLE may revoke the certification once there will be valid complaints raised against the company, it added. Per joint memorandum circular number 21-01 series of 2021, the DOLE will issue the certification for establishments in the manufacturing, construction, utilities, information and communication, and warehousing industries.

Department of Trade and Industry (DTI), Department of Tourism (DOT), Department of Interior and Local Government (DILG), and the different local government units are also designated to issue the said safety seal.(RONALD O.REYES)

As directed by the IATF Gov. Petilla lukewarm on vaccine card policy; supports RT-PCR test result as a travel requirement

TACLOBAN CITY – Leyte is not yet incline to follow the policy of the national Inter-Agency Task Force (IATF) allowing vaccinated persons to enter a particular area as a requirement.

This was said by Governor Leopoldo Dominico Petilla who said that the provincial IATF which he heads has yet to act on this policy by the IATF.

Under Resolution No. 124-B of the IATF, fully vaccinated individuals need not present negative swab test results if they want to travel within the Philippines and need only to present their vaccination cards for interzonal travel as well as for intrazonal movement.

Gov. Petilla said that this resolution of the IATF need to a thorough study because it goes against a provincial ordinance that mandates all returning residents to undergo RT-PCR swab test.

Petilla disclosed that he had directed the office of the provincial administrator and the Sangguniang Panlalawigan to study this IATF guideline on how they can include in the provision about vaccinated individuals.

Earlier, the province enacted anti-COVID-19(coronavirus disease) ordinances which orders returning residents to report their arrival and to undergo the mandatory quarantine and testing five days after their arrival.

But this March of this year, the provincial board revised the ordinance to fit with Resolution No 101 that mandates that the quarantine and testing would no longer be a requirement for returning residents, except those manifesting symptoms. However, in May, the

According to municipal link Selle Abenojar, the 11 families have indeed crossed the poverty line to economic sufficiency.

One such family is from Brgy. Carapdapan, the family of Luz Teñoso has raised two members of the Philippine National Police, one is also an employee of the Tacloban City Disaster Risk Reduction Management Council (DRRMC) and another, a teacher. Luz is supporting one grandkid who is now in Grade 7.

Another grantee is Mari Letecia Pajares of Brgy. Concepcion. Before her involvement with 4Ps, she was unemployed with the monthly grant, she pursued her education and is now a teacher. His family also put up a piggery, managed by her husband. Her children are all in school enrolled in Grade 10, 11 and 12.

Still another grantee is Ma. Giget Ramilo of Brgy. Garden who just tends to her children while husband is a driver of a public utility van. Her eldest, who was a Pantawid scholar in college, now teaches at the Arteche National High School.

Another is a fresh graduate and the youngest is in Grade 9. Her eldest now helps the family.

There are still eight more who like Teñoso, Pajares and Ramiro have graduated from the program.

Like the three mentioned, each family has crossed the poverty line through hard work and the grant from the government.

As the town observes health protocols, the graduation was done door-to-door where the municipal officials also celebrated.

Partner agencies like MSWDO Judith Operario-Pombo, TESDA representative Renato Picana, Office of the Municipal Agricultural Services (OMAS) and Mayor Roland Boie Evardone supported the graduates.

Meanwhile, life with other grantees will hopefully roll and the grantees can only wish, one day the Pantawid Pamilyang Pilipino Program will also push them towards economic sustainability.

The 4Ps is a national poverty alleviation program that provides cash transfers to poor families to improve their health, nutrition and education.

Another ongoing project is the 6-lane Ormoc City Diversion Road which will speed up transportation from 30 minutes to 10 minutes between Brgy. San Juan and Naungan Ormoc City, Leyte. This Php 1.45-Billion project with approximately 4.5 km in length is now 84.28-percent completed.

Apart from smoother interconnectivity, the promotion of economic growth through the garment industry in New Era in Alang-Alang, Leyte has also been given importance with the implementation the Divisoria-Lanof git-San Antonio Farm-San Diego-Sto. Niño Road project. Costing Php 404.41-Million, this project involves the rehabilitation of existing substandard concrete road equivalent to 12-kilometer with a thickness of 0.28 meters and a width of 6.70 meters. Currently, the project is 81.31-percent accomplished.

DPWH R8 has also implemented the construction of Php 333.48-Million Maasin City Coastal Bypass Road in Southern Leyte. The completion of this road project will connect Tomas Oppus Street to Maasin City Port and to Bdry. Southern Leyte-Maasin-Macrohon-Daang Maharlika Road. Major scope of works details the construction of four-lane road and bridges with a total length of 4.741 km, including four-lane road opening of 2.341 kilometers with

slope protection works, embankment, drainage system with walkways/sidewalk and bike lane.

For the province of Samar, the Calbayog City Coastal Road Package in Calbayog City is already at 82.76-percent accomplished. Upon completion, this project will minimize traffic congestion in the city proper by diverting traffic to the Coastal Diversion Road. Costing Php 1.25-Billion, this involves the construction of 4.32 lane km gravel road and the construction of a 12,683.01 square meters of slope protection structure. This project has commenced in 2018 and is currently fast-tracked.

Also started in 2018, the construction of San Roque Bypass Road in Northern Samar is now 90.67-percent completed. This Php 206.74-Million project involves the construction of 2.4017 lane kilometer concrete road, 6.419 lane kilometer widening of road and the construction of a 450 square meters concrete bridge. Soon, the people of San Roque and nearby provinces will benefit from the improved mobility of goods and services which

DPWH 8 fast tracks high-impact projects in EV; completes over 500 bridges and 1380-km national roads





BARAS, Palo, Leyte - Public Works and Highways Region VIII bared that 570 bridges and 1380.25 kilometers of national roads have been built and improved in Eastern Visayas in the past five years.

Since 2016, DPWH Region 8 has dispersed great projects nationwide. strides in improving road 'Build, Build, Build" program. A total of 1380.25 kilometers of national roads has been completed encompassing projects on rehabilitation, re-construction, and widening of roads; the construction of by-passes and diversion roads; as well as preventive maintenance of road in the whole region.

The region's interconnectivity between islands and provinces has also been enhanced through

the completion of 570 bridges, which mostly involves bridge widening; major repair of the region's permanent bridges; and retrofitting/strengthening of bridges. From July 2016 to December 2020, Region VIII has the highest number of completed bridge

DPWH Secretary Mark network capacity within A. Villar, leading the infrathe region through the structure grail of the country, has announced during his on-site inspection in Tacloban City in 2018 that part of his priorities is improving the road network in Eastern Visayas, thereby fostering better mobility while ensuring that the people of EV will be protected from calamities.

Tacloban City Bypass Road which has already been alleviating the traffic situation along Daang Maharlika is now reported 93.49-percent completed.

The Php 2-Billion project does not only increase the development potentials in the province but will also reduce travel time from 1 ¹/₂ hours to 30 minutes benefiting more than 1,000 motorists a day.

Soon to complement the proposed international seaport that will be constructed in the town of Babatngon, Leyte is the Php 1.198-Billion Tacloban City Bypass Road Extension. This 6-lane km roadway project with a total length of 33.00 km is envisioned to decongest traffic along Tacloban-Babatngon Road going to Tacloban City Proper, shortening the travel time from 1 ¹/₂ hours to 45 minutes.

Meanwhile, the devastation brought by the super typhoon "Yolanda" drove the government to commence an action for the recovery of local gov-

ernment functions and infrastructure in order to promptly deliver aid to disaster-stricken areas.

Thus, the inception of the 30,858 linear meters Leyte Tide Embankment **Project** which endeavored to protect over 30,000 residences along the coasts of Tacloban City stretching to the municipalities of Palo and Tanauan, Leyte. Implemented in 2016, this project is primarily designed to protect lives and millions worth of properties from the possible occurrence of

communities in Eastern Visayas. The Php 6.138-Billion worth Leyte Tide Embankment Project is now 80.37-percent completed.

Another big-ticket project that is nearly completed is the construction of the Php 703.6-million Palo West Bypass Road project which has diverted traffic in Palo, Leyte, particularly in the junction of Palo-Carigara-Ormoc Road and Daang Maharlika LT Road. This has reduced the travel time from 30 minutes (via Daang Maharlika LT Road) to 15 ported to be at 92.58-percent accomplished.

Also, the construction of 48.20 km. Mahaplag-Hilongos Road has been considered high-impact to the people of the province of Leyte. Now with 25.83-percent accomplishment rate, the Mahaplag-Hilongos road will connect two (2) municipalities in the 5th District of Leyte. In the future, transportation of goods and services will be smoother through this shorter route. Travel time
