MAASIN CITY- City Mayor Nacional Mercado appealed to all Maasinhons not to be COVID-19 vaccine they may want to be jabbed with, saying the best vaccine is the one that is available.

The mayor said he had observed some individuals arriving in vaccination sites but declined to be injected after learning the vaccine on hand was not the one they preferred.

Good that there was a ready substitution list,

thus there was no wastage, Mayor Mercado said at the Kapihan sa PIA.

"During the survey, choosy as to what type of what was asked was whether you want to be vaccinated or not, and not what vaccine do you want," the mayor said, speaking in the dialect.

> There is no other way for now to counter COVID-19 than through vaccination so things may go back to normal, Mayor Mercado said, adding that vaccines work like a shield offering a layer of protection against the mutating virus. While some people are

selective, others are also hesitant, obviously influenced by Facebook posts that border on fake news and unverified sources, but overall, they are outnumbered by those who are very willing and interested to be jabbed, the mayor shared.

Since the vaccination rollout began in March, the city received Sinovac, AstraZeneca, and lately, Johnson and Johnson vaccines from the regional DOH office, and these were readily used to priority groups A1, A2, and A3.

Frontliners belong to A1, senior citizens - A2, and persons with co-morbidities or having existing ailments - A3, and thus far the city's vaccination team hit more than 17% of the over 47,000 population as vaccination target, the see Do not select/

Comelec cancels voters' registration at its satellite offices in Tacloban due to spike of COVID-19 cases

TACLOBAN CITY-The increasing number of coronavirus disease (COVID-19) in the city has prompted its Commission on Elections (Comelec) office to cancel its voters' registration on its two satellite registration sites.

On its advisory, the Comelec said that the registration slated on Saturday (August 14) until September 11 at Robinsons shopping mall and Save More mall were stopped.

"Due to increasing number of COVID-19 cases in Tacloban City, Comelec is constraint, for health and safety reasons, to stop the conduct of its succeeding schedule of satellite registration at Robinsons and Save More,"the Comelec-8 said on its advisory issued on Saturday (August 14).

The Comelec, however, said that the registration is still ongoing at the City Comelec office which is located at the Astrodome.

The registration is for next year's elections.

The Department of Health (DOH) has earlier tagged Tacloban City under alert level 4 due to its spike of COVID-19 cases.

At present, Tacloban City has 4,896 total COVID-19 with 261 active cases and 107 deaths. Dr. Gloria Fabrigas, city health officer, reminded the public anew with the surge of COVID-19 cases in Tacloban considering that the DOH has confirmed of one patient who was detected with Delta variant.

"While the patient is now negative and his close contacts, we should not be complacent. This is a virus. Anybody can be infected, "she said.

The DOH announced on Monday of 92 new COVID-19 cases here in the region, pushing its total cases to 38,513.

The total recoveries of the region is now at 36,862 with 1,216 considered as active cases.

The region has 435 deaths due to COVID-19 complications. (JOEY A. GABIETA)

Hybrid rice seed production key to boost yield

Agriculture (DA), aim to up its rice production from the national average yield of 4 to 5 Metric Tons (MT) to 12 MT hinges on the success to produce hybrid rice seed on the success of the hybrid rice seed production by the Philippine Rice Research Institute (PhilRice). Pilot training by PhilRice in Cagayan Valley and the Cordillera Administrative Region (CAR), in collaboration with DA is expected to include other rice growing provinces. The program plans to target the 15 provinces that

The Department of have demonstrated high yields with hybrid rice reaching 12 MT per hectare.

> DA did not reveal the 15 provinces they have targeted to be recipients of newly produced hybrid seeds by PhilRice, but I hopefully believe should count few provinces in the Visayan Region. Two agencies under DA (Bureau of Plant Industry and the Agricultural Training Institute), will collaborate with PhilRice and initially train participants/seed growers from the provinces of Cagayan, Isabela, Kalinga, and Nueva Vizcaya

TACLOBAN CITY Ormoc City is eyeing Lake Danao as part of its plan to develop an alternative source to ensure a stable water supply to 82 percent of its communities in the next 25 years.

"By year 2045, Ormoc City is projected to have a water deficit of around 26 megaliters per day, which highlights the importance of developing an alternative, dependable and sustainable source of water," Ormoc City Mayor Richard Gomez said in a statement on Friday (August 13).

In the same statement, the city government said officials from the Public-Private Partnership (PPP) Center presented the results of the feasibility study on projects to explore where to draw the water supply.

In a project briefer posted by the PPP Center on its website, bulk water supply will be drawn from Lake Danao and other possible sources, including the Inawasan River.

The lake has been one of the sources of water for six Leyte towns and Tacloban City, but it has not been tapped to provide water for Ormoc.

The project aims to provide an uninterrupted water supply facility with a source, a reservoir, a piped distribution network with an adequate treatment facility, and household taps.

A reservoir will be set up and a new pipeline from bulk water will also be built to augment the interconnection of existing pipelines.

The project will also establish a clarifier and filtration gallery to improve the quality of the water.

It is seen to upgrade the water supply in 28 service areas.

Earlier, the city government said they are eyeing loans from state-run banks to finance the long-term water supply project. The estimated cost is P2 billion. Public bidding is set

next month for interested contractors to work on the Ormoc Water Supply System Project.

...from Page 1 occupy the new building by February of next year.

The new provincial capitol, being built at a cost of P800 million with the construction started last Jan.21,2020, covers half of the 14-hectare property of the province. It is a five-storey building, with a mini-theater inside and a helipad on rooftop.

It will house all offices of the provincial government that are currently located at the current provincial capitol building in Tacloban City and in this town.

The new location, according to Gov. Petilla, is ideal because it is located several kilometers away from the sea, making it safe from storm surge unlike to the old provincial capitol building and his current office located in Barangay Candahug at the Government Center, also this town.

When super typhoon 'Yolanda' devastated Tacloban City in November 8, 2013, parts of the provincial capitol building was submerged to sea water brought by the storm surge.

During the July 2017 6.5 magnitude quake, parts of the building foundation was damaged resulting for the provincial government to order some departments to hold their offices to other buildings owned by the province, including the Governor's Office.

"We need to build something that can withstand calamities like storm surge, typhoon, and it is also designed to withstand strong earthquake," Petilla, who is on his last and third term, said.

Petilla added that they are still finalizing how they will utilized the current provincial capitol building in Tacloban City.

He, however, said that it could be converted into a museum because it is one of the remaining historical buildings in Leyte relative to the World War II.

During the World War II, the building was used as temporary seat of government by then President Sergio Osmeña after Gen. Douglas McArthur and Allied Forces set foot in Leyte in October 20, 1944 when Tacloban was declared as the temporary capital of the Philippines while Manila is not yet liberated from the hands of Japanese Forces.

"But our focus now is to provide offices to our employees because as of the moment the various department of the province is scattered in various places," he said. (ROEL T. AMAZONA)

Leyte province allots over P2 million fund support for Palo NHS- PANNEX

Additional physical improvements would soon be visible around Pawing Annex campus of Palo National High School as the provincial government of Leyte promised to grant the school a funding allocation of P2.6 million.

School Principal Aldrene Urbano disclosed that the provincial government of Leyte would shoulder the amount in the construction of the school's perimeter fencing as it is currently located beside Pawing Elementary School and some residential houses along the road going to the Leyte Provincial Hospital (LPH).

The perimeter fencing project was prioritized by the GPTA officers themselves from which they produced a joint resolution with the municipality of Palo for its realization. The resolution was endorsed to town officials by Barangay Pawing Chairman Virgelio S. Agner. As a result, the municipality of Palo through Mayor Frances Anne Petilla crafted a program of work and forwarded it to the provincial government headed by Gov. Leopoldo Dominico Petilla who in turn responded by allotting more than P2 million fund support.

The provincial government also vowed another funding allocation of P1.6 million for the school's additional line canal construction.

Urbano said this would add up to the school's physical improvements he initiated to include concrete path walks, hand washing facilities, line canal, and a mini-stage.

As part of its innovation, the school has also installed its own QR code system and school pantry program.

90.87 percent of the 534,778 allocated first doses have already been administered.

A total of 61.25 percent of the second doses have already been administered, equating to 245,180 administered doses, it added.

The target population for A1 or the frontline health workers have also met the 100 percent coverage rate.

While 36.11 percent for A2 or senior citizens, 56.12 percent for A3 or adults with comorbidities, and 14.17 percent for A4 or the economic frontliners.

The regional health department reminded the public to coordinate with their respective local government units for vaccine registration following the government's prioritization framework.

As of Monday, the region has recorded 38,513 total number of COVI-Do-19 cases, with 36,862 total number of recoveries and 435 total number of deaths.

The total active COVID-19 cases in the region is now at 1,216.

Eastern Visayas COVID-19 deaths climb to 435

TACLOBAN CITYfrom Capul, Northern Sa-Deaths related to coronamar who died on August 9.. virus disease (COVID-19) On Monday(August 16), here in the region have the region also logged 92 climbed to 435 following new COVID-19 cases and the four new deaths record-125 new recoveries, bring-

ed on Sunday(August 15). "With the high number of cases in Eastern Visayas, the Department of Health continues to appeal to the public to keep following and keep practicing the minimum public health standards all the time and in all settings," the regional health department said.

The new fatalities were identified as a 45-year-old male from Ormoc City who died on August 12,; a 57-year-old female from MacArthur, Leyte who died on July 26; an 84-year-old female from Bobon, Northern Samar who died on July 16; and a 77-year-old male

Over 245K Eastern Visayas residents now fully vaccinated

TACLOBAN CITY -Some 245,180 residents in Eastern Visayas have been fully vaccinated as of Aug. 15 as the region continues to receive more vaccine supplies from the national government.

The number forms part of the 731,110 doses administered to health workers, senior citizens, those with comorbidities, and essential workers in six provinces and seven cities in Eastern Visayas, the Department of Health (DOH) regional office here reported on Monday (August 16).

Some 485,930 doses or 90.87 percent of the 534,778 first doses allocated to the region have already been administered.

The DOH also reported that about 96.95 percent of the available doses have been distributed, equating to 906,576 out of 935,070 doses received. The region has 397 sites conducting Covid-19 vaccination.

morbidities) is still ongoing, both for their first and second doses, respectively," the DOH said in a statement sent to reporters.

"The public is reminded to coordinate with their LGUs (local government units) for vaccine registration and get vaccinated, following the government's Prioritization Framework, in order to get maximum protection against the severe form of Covid-19," it added.

All frontline health workers in the region have been vaccinated. For elderlies and with comorbidities, the vaccine rollout coverage is 36.11 percent and 56.12 percent, respectively.

About 14.17 percent of economic front-liners have also been inoculated.

The deliveries of vaccines in the region are expected to step up the government's Covid-19 vaccination rollout, protecting more individuals from catching severe infections and/or deaths from coronavirus.

The health department reminds everyone, including those vaccinated to continue to adhere to public health measures such as physical distancing, wearing of face masks and face shields, hand and respiratory hygiene, and ensuring good ventilation by opening windows and doors where possible as vaccines do not replace the important prevention measures that are currently being practiced.

As of Aug. 16, Eastern Visayas has already recorded 38,513 confirmed Covid-19 cases, including 36,862 recoveries and 435 deaths. This brings the active cases to 1,216 or 3.16 percent of the total.
