# DOH reports 2 new cases

**TACLOBAN CITY-** A pregnant woman from a Leyte town is one of the two persons from the region who were tested to have the Delta variant of the coronavirus disease (COVID-19).

This was confirmed by Dr. Marc Steven Capungcol, head of the epidemiology and

surveillance unit of the Department of Health (DOH-8), who said that the region has now 14 Delta variant cases, considered to be the most infectious of COVID-19 variants.

He, however, said that one of the two latest cases is still in Manila and in isolation but was counted as a case from the region as he listed his home address as Hilongos, Leyte.

Capungcol said that the eight-month old pregnant woman is from Hindang town, also in Leyte, and is now in isolation at the local government unit-run facility.

"She appears to be as-

ymptomatic. She returned last August 9 from Davao City and travelled to Manila on her way to Tacloban. She was picked up at the Tacloban airport by her brother who was tested negative," the health official said.

Both new cases of Delta variant in the region were returning overseas workers.

# PTF-ELCAC provides relief to 2 conflict-stricken brgy

**BORONGAN CITY-** The Provincial Task Force to End Local Communist Armed Conflict (PTF-ELCAC) in Eastern Samar immediately provided relief operations to the two conflict-stricken barangays of Dolores town.

On August 20, members of the PTF ELCAC traveled to the remote barangays, Jicontol and Osmeña, two of the nearer barangays to the firefight between government forces and the rebels.

The Provincial Social Welfare and Development Office (PSWDO) brought food packs to some 600 families in the barangays.

The Office of Civil Defense (OCD) also provided food packs with almost the same contents of rice, canned goods and noodles, to this, the OCD added a box of hygiene kits for each family.

The hygiene kit revealed towels, toothbrush, toothpaste, soaps, wipes and other health care products.

A civil society organization led by ‘Mayang,’ a former rebel, also delighted the children when Jeff Jalalon, one of the volunteers with some women-soldiers distributed candies and toys.

Children also excitedly claimed colorful slippers that brought smiles

## Peace, development works continue in Northern Samar amid insurgency, governor says

**TACLOBAN CITY-** The provincial government of Northern Samar will continue to be firm on its stance against insurgency and terrorism in the province.

Thus said Governor Edwin Ongchuan amid a series of rebel attacks in the province that killed Army personnel and two other unarmed Civilian Active Auxiliaries (CAAs) over the weekend.

The governor also directed the giving of immediate assistance to the family of the slain government forces.

“The assistance is a way to recognize the efforts of our people in our pursuit for peace and development especially in conflict areas in the province,” Ongchuan said.

Corporal Jason Avestruz of the Philippine Army’s 43rd Infantry Battalion was

killed during the encounter at Barangay Palanit in San Isidro town on Saturday, August 21, 2021.

The government troops engaged in a 15-minute firefight with some 20 suspected rebels.

The two unarmed CAAs were Lito Dauba and Arcito Reyes.

According to the Army, the two CAAs were allegedly “flagged down and executed” by around 10 suspected rebels at Barangay Happy Valley in San Isidro on Saturday while they were about to join the community support program team who were conducting development social works for the community.

“The governor believes that it is only by ending the (insurgency) issue that the province can achieve true progress,” the provincial government said.

**CAPOOCAN,** Leyte – The Department of Public Works and Highways (DPWH) – Leyte Second District Engineering Office (L2DEO) has reported the completion P37.9-million slope protection project in Brgy. Pinamopoan, Capooan, Leyte along the busy road section of Palo-Carigara-Ormoc.

OIC-District Engineer Leo Edward Oppura, said that the slope protection is designed and constructed to withstand the lateral pressure of soil and water during heavy rainfall causing both landslides and mudslides in the area.

“This road portion is susceptible to landslides and mudslides during torrential rainfall, and now that we are in the rainy sea-

## 2 minors drown in separate incidents in Leyte and in Northern Samar

**TACLOBAN CITY-** A 14-year old student and a 17-year-old farmer were drowned in separate incidents in Leyte and Northern Samar Tuesday (August 24).

In Palo, Leyte, police identified the victim as a Grade 9 high school student from Barangay Cavite East.

The victim, along with his friends, was swimming in a river when he was carried away by the strong current around 4:30 pm Tuesday, police said.

While the farmer was drowned after he fell into the river in Barangay Vigo,

Laoang, Northern Samar around 6:40 pm of the same day.

According to the victim’s brother, they were hauling coconuts aboard a boat when the victim suddenly suffered a leg cramp and accidentally fell.

The brother tried to help and search the victim across the river but failed to find him.

The Laoang Municipal Police Station had coordinated with the Philippine Coast Guard for the retrieval operation.

## CPP hailed the 20 rebels killed in Eastern Samar attack as martyrs

TACLOBAN CITY- The Communist Party of the Philippines (CPP) has hailed the 20 rebels who were killed during a 13-hour attack by the military in a remote village of Dolores town, Eastern Samar last August 16.

In a statement sent through its information bureau on Wednesday (August 25), the CPP described those who died in the said ground and air assault as 'martyrs.'

"They were among the best sons and daughters of the people who dedicated their lives to the cause of national freedom and democracy. Their deaths bear hard upon the hearts of the workers and peasants across the country and all the oppressed peoples in the entire world," it said.

"Their martyrdom inspires us to fight with even greater fortitude and dedication to serve the people and their rev-

olutionary cause. The Martyrs of Dolores will forever be remembered," the communist group added on its statement.

The CPP acknowledges that the high death toll in the said attack was a 'big loss' to them but was quick to say that it was just a 'temporary setback.'

"Without a doubt, the deaths of the Dolores martyrs is a big loss. It is, however, a temporary setback and does not negate the overall forward direction of the people's war," it said.

It also issued a warning to the government troops that their guerilla unit in Dolores "will be reorganized with new recruits to continue the work left by their fallen heroes."

Both the military and the Philippine National Police in the region are in full alert for possible retaliations to be staged by the rebels against them.

## Student, 16, nabbed for 13 counts of rape

TACLOBAN CITY- Joint police operatives arrested on Tuesday, August 24, 2021, a 16-year-old student for alleged 13 counts of rape in Saint Bernard, Southern Leyte.

The accused, who is listed as Rank 4 most wanted person (provincial level), was apprehended by around 12:40 p.m. Tuesday by virtue of a warrant dated July 7, 2021.

Presiding judge Jacinto Elle, of the Regional Trial Court (RTC)-Branch 26

in San Juan, did not recommend bail to the accused.

Earlier, police also arrested another 16-year-old student in Dulag, Leyte over an alleged rape case.

The accused was facing a warrant dated July 19, 2012.

A P200,000 bail was recommended for the temporary liberty of the accused.

He was brought to the police station for documentation prior to turn over to the court of origin. **(RONALD O.REYES)**

## NSamar Local Governance Resource Center opens at newly inaugurated DILG building

CATARMAN, Northern Samar - The best practices on local governance and other knowledge resources needed for development planning can now be accessed by local government units in Northern Samar as the Department of the Interior and Local Government - Northern Samar Provincial Office (DILG-NSPO) launches the provincial Local Governance Resource Center (LGRC) last Wednesday (August 25), coinciding with the inauguration of the new DILG office building at Brgy. Dalakit, this town.

The LGRC contains a repository of books, knowledge products, exemplary and replicable practices and audio-visual materials. It can handle public fora, conferences and round-table discussions, and can also provide technical assistance and trainings, as well as give referral service to pool of coaches, local resource institutions and partners.

Guest speaker and DILG Regional Director Karl Caesar Rimando emphasized that the LGRC is not only beneficial to LGUs.

"Pwede nating gamitin [ang LGRC bilang] isang merging place kung saan magtutulongan ang university, ang provincial government, ang DILG at ang lahat ng liga. Lahat po ng capacity development na gagawin sa Northern Samar pwede niyo pong idaan sa LGRC," Director Rimando said.

Rimando also stated that the Local Governance Re-

source Center will be able to provide both guide and coordination for sitting and aspiring government officials.

"Yung galing sa serbisyo na nakikita natin kay Governor Edwin Ongchuan at iba pang elected officials, pwede po nating idokumento at ilagay po natin sa LGRC upang yung mga kabataan at yung mga nangangarap maging lider ng ating barangay, munisipyo at lalawigan ay makikita nila na maraming ginagawang maganda ang ating mga lingkod bayan," he added.

The Local Governance Resource Center of Northern Samar is located at the Valente P. Bajet Room, so-named in honor of the late DILG provincial director and assistant regional director who strongly lobbied for the construction of their office building before his untimely death in October of 2019.

'Informal settler' no more

As the opening of the LGRC was held on the same day of the blessing and inauguration of the DILG-NSPO Building, Provincial Director Danilo Laguitan also thanked, in addition to the late Director Bajet, Governor Edwin Ongchuan, on behalf of the provincial government, for providing additional funding to finish the construction of their office. He also thanked the different leagues of elected government officials in Northern Samar, and their

partner local resource institution, the University of Eastern Philippines, whose president, Dr. Cherry Ultra, was also present during the event.

"Naniniwala po ang DILG Team Norte na maraming magagandang mangyayari sa bagong opisina. Ito ay sumasagisag ng patuloy na pagtataguyod ng mga mahuhusay, matitino at maaasahang serbisyo sa aming kagawaran," PD Laguitan said after recalling how they have stayed for decades at their small office building in Catarman town proper, and for years at the Senior Citizens Building of the same town.

Meanwhile, Governor Edwin Ongchuan was inspired by the provincial government's vision in his message during the event.

"I pray that your new office building be Marigon, Mainuswagon ngan Malipayon, as it houses the hardworking and dedicated DILG Northern Samar workforce. May this infrastructure upgrade inspire

you more to better the lives of our fellow Nortehanons as you fulfill your mandate of promoting peace and order, ensuring public safety, and strengthening local government capability of our LGUs," the governor said.

He also shared his optimism towards the establishment of the LGRC in the province.

"May the LGRC help design and effectively implement the interventions which can be provided by LGUs and other stakeholders, whether they be from the academe, non-government organizations, the private sector and civil society organizations. ## Selective scrutiny

DepEd's Constitutional Mandate RA 9155 & RA 10533 (...the right of all citizens to quality basic education and to make such education accessible to all by providing all Filipino children a free and compulsory education...).

Amid this health crisis, DepEd has been promoting the government's overall initiative to encourage strict adherence to public health protocols while implementing policies that ensure the delivery of accessible, responsive, and quality education. ## Alangalang I District continues to soar education thru learning support aide

Education system is one of the most affected sectors in this trying time. Delivery of learning in the whole country has drastically changed from face-to-face to blended learning.

According to Undersecretary for Planning and Bureau of Human Resource and Organizational Development Jesus Mateo, Learning Support Aides refer to individuals who qualify in assisting teachers to provide learning opportunities using various learning delivery modalities in promoting achievement and progression of learners.

"Teachers remain to be the main facilitators of learning. The engagement of LSAs is DepEd's way of ensuring provision of assistance to our teachers in managing learners and in coordination with teachers ensure that learning is taking in different learning modalities," J. Mateo added.

The local government unit (LGU) of Alangalang through the municipal mayor, Hon. Lovell Anne Yu, extended its advocate by funding P5,000 per learning support aide (LSA). The municipality currently has ten LSA with designated learners to assist with.

Teachers in the district identified learners who lack learning support from their respective homes for varied reasons like learners without parents or adults to guide them, learners who cannot cope with independent learning, parents who are not able to supervise their children in the learning process and those who are living in the far-flung areas who do not have access to information.

Alangalang I Central School is one of the schools in the municipality both elementary and secondary, identified learners needing facilitators to pursue Basic Education - Learning Continuity Plan (BE-LCP) through hiring learning sup-

port aide (LAS). Pursuant to the DepEd memorandum 106, series 2020 otherwise known as Hiring of Service - Learning Support Aides to utilize the remaining teacher-applicants in the Registry of Qualified Applicants (RQA) for the school year who are not given permanent or provisional appointments.

Functions of an LSA include monitoring and tracking learners' accomplishment of the tasks indicated in the Weekly Home Learning Plan following the timeframe set by the teacher/s concerned; Clarify any difficulty or confusion that learners may encounter in the lesson or learning tasks, and coordinate such concern/s with the subject teacher concerned; Guide the learners and/or parents/guardians establishing routines and procedures to manage time properly based on the WHLP; Document and keep record of the learners' progress based on formative assessments and submit the same to the teacher/s for instruction; Communicate with and explain to the learners the learning tasks or activities indicated in the identified intervention, remediation or enrichment strategy prepared by the teachers; Coordinate and communicate with the parents/guardians the periodic feedback of learners' progress.

Hiring of LSAs enables to augment the education sector's ongoing learning continuity efforts in providing quality basic education amid this debacle.

This shows that teachers and those who are in the higher educational system are adaptive to change. We are not shaken. As what former Regional Director Ramir Uytico mentioned, "The Department of Education is the last to surrender."

## Teaching competencies and the strategies employed by the Grade 6 Mathematics teachers in MacArthur I District: Basis for instructional enhancement plan

Competent teachers are necessary for quality education. It is one of the missions of the Department of Education to mold teachers to become highly competent in their job as educators.

Professional competence also includes skills such as subject application, classroom methodology, classroom management, assessment and recording.

The verbal ability, content knowledge, pedagogical knowledge, certification status, ability to use a range of teaching strategies skillfully, and enthusiasm for the subject characterize more successful teachers.

This study focused on determining the teaching competencies and the strategies employed by the Grade 6 Mathematics Teachers in MacArthur I District, Leyte Division.

And it also ascertained the relationships between and among variables include in the study.

Based on the data gathered and statistical analysis, it was revealed that there is no significant relationships exits between two (2) variables which were the profile of Grade 6 Mathematics teachers and the teaching competencies of Grade 6 Mathematics teachers.

## Dulag National High School adopted the modular (printed) learning system and blended distance learning

Dulag National High School adopted the modular (printed) learning system (M) and blended distance learning (BDL) throughout the school year 2020-2021 and currently this school year 2021-2022 to continue the education amid the Covid19 global pandemic.

Teachers, parents, students, local government unit of Dulag (LGU), and the community collaborated to achieve this goal.

The Department of Education (DepEd) downloaded the learning modules (LM) via online Deped link, then printed, book bind and distributed by the teachers to the designated barangays at the ground level.

Dulag National High School administrators conducted orientation on the learning module distribution/retrieval process and workshop to the teachers on blended distance learning making prior to the class opening.

The teachers discussed the modular distance learning distribution/retrieval process to the parents at the assigned barangay with the help of the local government unit throughout Dulag Leyte and also nearby towns such as Tolosa, Mayorga, Lapaz, and Julita Leyte.

The local government unit transported the learning module from school to their barangay or vice-versa during the distribution/retrieval process.

Modular (printed) learning system is a self-learning module wherein the learner is guided with answer key at the last portion of the learning module. Blended distance learning were also adopted such as audio, video clips, google classroom and google meet.



Students do their learning activities by reading, viewing, listening and develop their skills by responding or answering various activities from the learning module and online classes.

The school conducted a portfolio day, card day and Brigada Eskwela every quarter guided with the local Inter-Agency Task Force (IATF) protocols.

Only the parents and guardians allowed to participate the said school activity to avoid the spread of the Covid19 virus.

Despite all the adversities in our education system here in our country due to this global pandemic, DepEd Secretary Leonor Magtolis Briones quoted “Our battle cry is learning must continue.

Adoption of multiple learning delivery modalities with blended learning and distance learning as a major option.”(deped.gov.ph) (June 19, 2020).

Leyte businessman yields agarwood

TACLOBAN CITY- A 59-year-old businessman was arrested for alleged selling of rare agarwood, locally known as 'lapnisan', in Jaro, Leyte.

Authorities were able to purchase 1.360 kilograms of agarwood worth P15,000

The total weight of agarwood was 3.880 kilograms with an estimated market value of P50,000, according

to the police.







## Southern Leyte LGUs sign resolution to protect the Sogod Bay and improve catch of fishermen

**SOGOD,** Southern Leyte – The provincial government of Southern Leyte and local government units located along Sogod Bay expressed their support to the resolution that endorses the Philippine Fisheries and Coastal Resiliency Project or Fish-core Project.

The provincial government and the municipal governments of San Ricardo, Pintuyan, Liloan, Libagon, Sogod, Bontoc, Tomas Oppus, Malitbog, Padre Burgos, and Limasawa, including the municipality of Macrohon and the city of Maasin, joined the Bureau of Fisheries and Aquatic Resources (BFAR) in adapting a resolution to express their



support for the realization of the project.

The resolution is to be forwarded to Bureau of Fisheries and Aquatic Resources (BFAR), and the Regional Development Council, among others.

The project intends to improve the management of fishery resources and enhance the value of fisheries production to coastal communities, and help revitalize a better ecosystem services and engaging and motivating the community to fulfill stewardship for the fishery resource bases.

“We’re not focusing only on a simply livelihood but

this one is gearing on the enterprise development,” Juan Albaladejo, BFAR regional director, said.

On the first year of the project implementation, the private public partnership component of the project will start which includes putting up investment on establishing fish cages, while on the second year will focus on setting up multi-fish hatchery, pit mill, and post-harvest facilities like an ice plant, according to Albaladejo.

“Our investors will come in to invest to the mariculture development of the agri-fisheries business corridor and at the same time, the fisherfolks will be trained to become farmworkers with decent salary and incentives,” Albaladejo added.

The project which will be funded under a loan at World Bank worth \$200

## Catarman imposes restrictions for the town fiesta

**CATARMAN,** Northern Samar- The province’s capital town, Catarman, will have its fiesta restrictions as imposed in Resolution No. 27 by the Municipal Inter-Agency Task Force against COVID-19.

Catarman will be celebrating this year’s annual town fiesta on August 28 and 29 in honor of Our Lady of Annunciation but due to the current surge of confirmed positive cases, the local IATF found it proper to impose restrictions in the movement of people.
