CAMP RUPERTO KANGLEON, PALO, Leyte-The region's more than 12,000 police personnel have a new police regional director in B/Gen. Rommel Bernardo Cabagnot who assumed his post on Wednesday (August 4).

Cabagnot, who was the chief regional staff of the PNP-National Capital Region, replaces B/Gen. Ronaldo De Jesus, who reached the mandatory retirement age of 56.

In his speech during the turn-over rites held at the Camp Ruperto Kangleon in Palo town, Leyte, the newly-assumed police regional director said that he would focus on the solution of criminals and even members of the New People' Army(NPAs).

He also issued a warning to erring police personnel, saying he would 'hunt them down?

In the wake of heavy equipment burning by NPAs in N.Samar Defense Sec. Lorenzana asks Army to ensure safety of projects against rebels

TACLOBAN CITY-Defense Secretary Delfin Lorenzana has directed military officials here in the region on Tuesday (August 3) to provide security to all projects being undertaken against attacks from the New People's Army (NPA) members.

Lorenzana made this directive after rebel members torched heavy equip-



ment in Las Navas, Northern Samar last July 29. The burning of 10 heavy equipment valued at P32 million came after the contractor, which owned the torched equipment, declined to give in to the demand of the rebel group.

Dr. Fabrigas calls on DILG to extend contracts of its 65 hired contact tracers amid presence of Delta variant in the city

TACLOBAN CITY - The City Health Office (CHO) here hopes that the Department of Interior and Local Government (DILG) will renew the contract of COVID-19 contact tracers that it hired.

Dr. Gloria Fabrigas, city health officer, said that the contract of these contact tracers assigned in the city is to expire this Sunday (August 8).

A total of 65 contact tracers were assigned in Tacloban by the DILG on top of the 298 contact tracers that the city government have deployed coming from different city offices like the CHO and the barangay service point officers.

Fabrigas said that while the current number of contact tracers are enough, those hired by the DILG is still needed considering that Tacloban City has a confirmed Delate variant case of COVID-19.

Leyte seawall substantially completed by 2022: DPWH

TACLOBAN CITY Department of Public Works and Highways (DPWH) Secretary Mark Villar has assured the substantial completion of the P9.62 billion Leyte tide embankment project before the end of President Rodrigo Duterte's term next year.

Construction of the structure designed to shield Leyte coastal communities from destructive waves is in full swing and all issues have been settled, Villar said during a brief interview after project inspection late Tuesday.

"This will protect 33,000 residents from big waves based on a 50-year prioritized this project so as not to repeat the damaged caused by calamities similar to Super Typhoon Yolanda," Villar told reporters.

The 43,355-meter project stretches from Diit village in Tacloban to Cabuynan village in Tanauan town.

Sections 1 to 3 are in Tacloban, section 4 are the coastal villages of Tacloban and Palo, section

5 are some areas in Palo and Tanauan, and section 6 in Tanauan town.

In most sections, the four-meter-wide structure is designed as a bay walk and bicycle lane.

It involves the construction of a 30,858-meter flood mitigation structure and a 12,49-meter backwater dike structure.

The project, standing 30 meters from the shoreline, will protect 33.7 square meters area of properties and 33,185 houses and buildings.

As of June 30, the project is already 80.37 percent complete with the release of P6.13 billion funds.

Defense Sec. Lorenzana confident in reducing strength of NPAs; describing them as mere criminals

CITY-TACLOBAN Defense Sec. Delfin Lorenzana said that the Duterte administration is on target in reducing the country's insurgency problem by next year to just a mere 'law enforcement' issue.

Lorenzana said that the under the administration of Pres.Duterte, the strength of the New People's Army (NPA) was drastically decimated.

"Hindi completely but we are going to reduce them to a level of magiging law enforcement (issue) na lang yan. Attainable yan kasi daming nag-surrender, namatay sa enkwentro at nahuhuli," he said during an interview when asked if the insurgency problem in the country could be quell as promised earlier by Pres. Duterte.

"We are at the upper hand," he added.

Lorenzana was in the city to lead in the inauguration of two buildings which will serve as an office and a barrack of the 546th Engineer.

The P48 million worth project was done under the

DND-DPWH collaboration 'Tatag ng Imprastraktura Para SA Kapayapaan at Seguridad (TIKAS) project.'

Also present was Sec. Mark Villar of the Department of Public Works and Highways.

The Defense chief also said that the implementation of the 'whole-of-nation' approach introduced by the Duterte administration is also an effective mechanism to combat the 52 years insurgency problem of the country.

He said that unlike in previous campaigns wherein only the Army and the police were leading in the fight against the rebels, other government agencies are involved under the wholeof-nation approach of the Duterte administration through the National Task Force to End Local Communist Armed Conflict in Eastern Visayas. (NTF-ELCAC).

Rewards looms for those who can give info on the 2 **NPA-instigated incidents**

CITY-TACLOBAN A bounty of P 1 million awaits for those who could identify behind the two separate incidents perpetrated by members of the New People's Army (NPA) in Samar and Northern Samar provinces.

This was disclosed by a high security oficial in the region who declined to provide details on where the funds came from.

The separate incidents he was referring involved an explosion incident in Pinabacdao, Samar involving the service vehicle of the City Health Office of Calbayog City which was escorted by a police car last July 27.

This incident was followed of the burning of the heavy equipment in Las Navas town, Northern Samar last July 29 after the contractor was said to refuse to heed the demand of the perpetrators.

Both the Army and the police claimed that the two separate incidents were perpetrated by the

rebel members.

"Those who can identify or provide information who were responsible on these incidents stand to receive P500,000 each. All they have to do is call the police or the Army," the official said.

He, however, said that any information would still be verified either by the police or Army.

"The giving of rewards is an indication that our people are tired and condemned what the NPAs are doing. That they are anti-development, anti-people," the official said.

Police Lt/Gen.Bernabe Balba, commander, Area Police Command for the Visayas, said he welcome on the giving of reward.

"If this could help provide information as who were behind on these atrocities, then this should be welcome," he said. (JOEY A. GABIETA)

RIATF8 to LGUs: Intensify protocols amid Delta variant cases

PALO, Leyte- The Regional Inter Agency Task Force (RIATF) against COVID-19 in Eastern Visayas has urged the local inter-agency task forces including the local chief executives in the region to strictly implement health protocols in their respective areas.

This, after the Department of Health in Eastern Visayas (DOH-8) confirmed the first 10 cases of COVID-19 Delta variant

In a Virtual press briefing on Thursday, DILG Regional Director Karl Caesar Rimando, RIATF chairperson said an advisory will be sent to all concerned IATFs and LCEs to officially inform them of the presence of

the contagious virus while investigation is being conducted.

The new call by the DILG is in response to the announcement made by DOH Regional Director Exuperia Sabalberino in the said briefing that the new cases of Delta variant in the region were categorized as local cases as infected individuals due has no history of travel outside the region.

The Surveillance and Epidemiology Unit of DOH-8 is conducting forward and backward tracing investigation to determine the origin and extent of the transmission in the affected areas and how the individuals got the virus.

"A surveillance team

from the Regional Epidemiology and Surveillance Unit of the DOH-8 is scheduled to go to Eastern Samar to conduct an investigation in the affected localities to determine if the virus has already spread," Sabalberino said.

With the reported Delta variant cases, Sabalberino urged everyone particularly the local chief executives to strengthen their contact tracing until the 3rd generation contacts, intensify the vaccination rollout in their respective areas and implement the prioritization framework.

DOH-8 immediately disclosed the presence of Delta variant in Region 8 after they received a report from the DOH Epidemiology Bureau that out of the 155 samples sent to the Philippine Genome Center for sequencing, 10 samples turned out positive.

Of the 10 cases, five (5) are from Borongan City, one (1) from Arteche, three (3) from Can-Avid, all in Eastern Samar, and one (1) from Tacloban City.

Out of the 10, nine have already recovered but one died last July 10, a 70-year-old man battling with lung cancer.

Delta variant is considered by experts to be more contagious and is likely to increase the risk of severe diseases and hospitalization, compared to the original strain of COVID-19. (LDL/CBA/PIA-8)



ad this virus that's causing a global pandemic been limited to the original COVID-19 virus, countries all across the world must have been able to recover by now, and things may have already returned to normal.

But the original virus had behaved rather intelligently, evolving and mutating into something else instead of just dying out. As it transformed itself, the variants it eventually formed became more versatile, resistant, and deadly. Scientists and medical experts rushed to develop the vaccines, but their laboratory antidotes had just focused more on the original virus.

Sure enough the vaccines that they developed yielded positive results, thus protecting many from severe symptoms when infected still. Cases had initially dropped in countries that are done vaccinating most of their citizens. But with the rising number of new cases from the variants for which vaccines were not prepared to address, it seems as though the triumphs of advanced countries against the virus were to no avail.

It's like fighting a new enemy, in short, a new battle. And the enemy is more ferocious this time, more lethal, the contagion rapid and faster. If the existing vaccines would have no effects against the spreading variants, then they would have no choice but to develop more appropriate vaccines.

This could be an endless endeavor should the virus continue to evolve into something more. Normalcy in this case could yet be far from being realized. Meantime, as these developments unfold, let us just continue to observe the basic protocols that we have been observing for more than a year now. We don't have many options left, anyway.




Pacman vs Spence **The Game Changer**



Biliran population growth rate shrinks in 2020

NAVAL, Biliran- Latest data on the 2020 Census of Population and Housing (CPH) from the Philippine Statistics Authority (PSA) - Biliran revealed that the population growth rate in the province has shrinked in 2020.

This was announced by Renavil V. Cueva, PSA Biliran chief, during the provincial news conference and data dissemination forum on the results of the 2020 CPH held at the BiPSU Hostel in Naval on August 4.

Cueva reported that the annual population growth rate of the province, based on various censuses, has shrinked to 0.93% in 2015-2020 compared to 1.13% in 2010-2015, and 1.43% in 2000-2010.

She said that as of May 1, 2020, the population of Biliran province is at 179,312, accounting for about 3.94% of the Eastern Visayas population and about 0.16% of the Philippine population.

The 2020 population of the province is higher by 7,700 from its 2015 population at 171,612; higher by 17,552 compared with its population of 161,760 in 2010; and 39,038 more than its population of 140,274 in 2000, Cueva said.

Among the eight municipalities, Naval had the biggest population at 58,187, followed by Caibiran – 24,167, Cabucgayan – 21,542, Kawayan – 20,455, Almeria – 17,954, Biliran – 17,662, Culaba – 12,972, while Maripipi recorded the smallest population count at 6,713, she said.

Cueva added that based on the annual population growth rate in 2020, Caibiran posted the highest at 1.49%, followed by Naval at 1.31%, Almeria at 1.22%, Culaba at 1.08%, Biliran

at 0.95%, Cabucgayan at 0.75%, Kawayan at 0.17%, and Maripipi at -2.42%.

According to Cueva, the 10 most populous barangays in the province are: Calumpang in Naval at 7,063; Larrazabal, Naval – 5,153; P.I Garcia, Naval – 4,666; Caray-Caray, Naval – 4,467; Bunga, Cabucgayan – 4,400; Atipolo, Naval – 3,803; Victory, Caibiran – 3,729; Cabibihan, Caibiran – 3,277; Poblacion, Almeria – 3,223; and Sto. Niño, Naval – 3,023.

The 10 least populous barangays in the province are: Trabugan, Maripipi – 173; Tabunan North, Kawayan – 184; Burabod, Maripipi – 231; Banlas, Maripipi – 237; Habuhab, Culaba – 267; Danao, Maripipi – 302; Casibang, Maripipi – 316; Canduhao, Maripipi – 326; Ol-og, Maripipi – 336; and Salvacion, Culaba – 336. WHEREAS, Art. II, Section 16 of the 1987 Philippine Constitution states that *"The State shall protect and promote the health of the people and instill health consciousness among them";*

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support among other things, xxx, promote health and safety xxx, maintain peace and order, and preserve the comfort and convenience of their ihabitants.";

WHEREAS, DILG issued a Memorandum Circular No. 2021-058, on May 31, 2021, *"Intensifying Regulation/Prohibition of Holding of Activities as Sources of Virus Super Spreaders.";*

WHEREAS, Regional IATF issued Resolution No. 25, on June 4, 2021, "Reminding Local Government Units in Eastern Samar to Intensify the Implementation and Observance of the Minimum Health Standard to Prevent Super Spreader Event."

BE IT ORDAINED AS IT IS ORDAINED BY THE SANGGUNIANG BAYAN OF MAPANAS, NORTHERN SAMAR, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW. IN SESSION ASSEMBLED THAT:

SECTION 1. TITLE. This ordinance shall be known as the "REGULATION OF MASS GATHERINGS ORDINANCE OF MAPANAS, NORTHERN SAMAR"

SECTION 2. PURPOSE. This ordinance seeks to establish strict regulatory and prohibitory measures in the conduct of private and public mass gatherings in the Municipality of Mapanas, Northern Samar in order to control and prevent local transmission of COVID-19.

SECTION 3. DEFINITION OF TERMS. For purposes of this Ordinance, the following definitions shall be adopted:

a. Private Mass Gathering - shall refer to a private event or occasion, either organized or spotaneous that encourages the attendance or being attended by a persons within the territorial jurisdiction of Mapanas.

b. **Public Mass Gathering** - shall refer to a public event or occasion organized for the purpose of extending government services, conduct of authorized humanitarian activities or the observance of religious rites or ceremonies outside the churches, temples and other houses of worship and other events or occasion that requires the attendance of the public.

c. **Fully Vaccinated Person** - shall refer to a person who has more than or equal to two (2) weeks after having received the second dose in a 2-dose vaccine, or more than or equal to two (2) weeks after having received a single-dose vaccine.

SECTION 4. GUIDELINES ON THE CONDUCT OF PRIVATE MASS GATHERINGS.

a. Host/s of private mass gatherings events that secure a clearance from the Barangay in which the event or occasion shall be held not later than forty-eight (48) hours before the said event or occasion;

b. The host/s shall attest in the Barangay the venue and its seating capacity, and shall submit a document containing the names of persons who will attend;

c. The private event or occasion shall only accommodate not more than fifty percent (50%) of the seating capacity of the venue, depending upon the quarantine status or classification of the Municipality of Mapanas;

d. Family members within the second degree of consanquinity and affinity, guardian's of the celebrant and those residing in his/her household are allowed to attend the said event or occasion, provided it shall not exceed with the prescribed number of attendees;

For wedding events, principal sponsors are allowed to attend.

e. For funerals and wakes, only the guardians, persons within the fourth degree of consanguinity and affinity of the deceased and those residing in his/her household shall be allowed;

For funeral marches physical distancing shall at all times be observed.

f. Persons below 21 years old, those 60 years old and above, and those suffering from comorbidities are prohibited from attending such events or occasions unless they fall under the categories provided in paragraphed d and e hereof, and except in cases of birthday celebration and/or baptismal where the above person/s is the celebrant;

g. The Barangay Local Government to which the private event or occasion will be held shall ensure that only those appearing on the list submitted, as provided in Section b, are in the event or occasion;

h. The Barangay Local Government shall ensure that the attendees of the event or occasion are observing the health protocols mandated by the Local Government of Mapanas:

i. Persons residing in an area declared to be under General Community Quarantine, Modified Enhanced Community Quarantine, or Enhanced Community Quarantine are prohibited from attending the event or occasion except in cases falling under paragraph d and e, provided that they shall undergo 14-day quarantine before attending the same.

SECTION 5. GUIDELINES ON THE CONDUCT OF PUBLIC MASS GATHER-INGS.

a. Not later than seventy-two (72) hours from the date of the event or occasion, the head of organizing agency, department, or entity must secure the written consent of the Local Chief Executive (LCE) or Municipal IATF regarding the conduct of such event.

Except in the conduct of mass/religious worship they need not secure the written consent of the LCE or Municipal IATF, provided they must comply with the following:

1. There must be a physical distancing for at least one (1) meter from each person;

2. Strict implementation of health protocols such as wearing of face mask and face shield;

3. Members who are below 21 years old, and those 60 years old above, those with comorbidities, other serious health risks must be excused from attending worship and must be provided with online, radio or television prayer opportunities.

b. The local government unit and the organizing agency, department or entity shall ensure that attendees of the event or occasion are observing health protocols mandated by the Local Government of Mapanas, are adhering to physical distancing and the event or occasion is attended by not more than fifty percent (50%) of the scatting capacity of the venue.

c. Persons below 21 years old, those 60 years old and above, and thos suffering from comorbidities, other serious health risks are prohibited from attending such public event or occasion.

SECTION 6. PROHIBITED ACTS. It is hereby declared that the following acts are unalwful:

a. Holding a private mass gathering without barangay clearance as stated in Section 4, paragraph a;

b. None compliance in the conduct of mass/religious worship as provided in Section 5, paragraph a;

c. Attending a private mass gathering while his/her name is not appearing in the list submitted by the host to the barangay as stated in Section 4, paragraph b;

d. Misrepresenting to be a person induced in the list submitted by the host of the private mass gathering to the Barangay;

e. Holding a public mass gathering without the consent of the Local Chief Executive of the Municipality of Mapanas, wherein the event or occasion is held.

f. Attendance of persons in private mass gatherings residing in an area declared to be under General Community Quarantine, Modified Enhanced Community Quarantine, or Enhanced Community Quarantine without undergoing a 14-day quarantine period before attending the event or occasion;

g. Attendance of persons below 21 years old, those 60 years old and above and those suffering from comorbidities and other serious health risks, except in cases provided in Section 4, paragraph d, e, f, and Section 9 hereof.

SECTION 7. OTHER PROHIBITED ACTS.

a. Other conduct of mass gatherings such as school graduation ceremonies, sport events, sabong, tupada, fiesta, parades, beauty contests and cultural festivals.

SECTION 8. DUTIES AND RESPONSIBILITIES OF PUNONG BARANGAYS. The following are the duties and responsibilities of Punong Barangays:

 Mandatorily organize Barangay COVID-19 Operations Center and Barangay Tanod Health Patrols to enforce surveillance, monitoring and reporting of mass gatherings, according to their local COVID-19 situation and resources;

b. Strictly implement the observance of the minimum health protocols in their areas of responsibility;

c. Provide assistance to public mass gatherings held in their area of responsibility, through the Barangay Tanods and/or Barangay Health Emergency Response Team, provided prior coordination is extended by the organizers and compliance of Section 5 hererof; d. Coordinate with the Municipal IATF, PNP Mapanas, Bureau of Fire Protection for assistance on the enforcement of this Ordinance;

SECTION 9. RULE ON FULLY VACCINATED SENIOR CITIZENS. Persons 60 years old and above may be allowed to attend private and public mass gatherings provided they are already fully vaccinated against COVID-19 and must present vaccination card duly signed by a legitimate vaccinating establishment.

SECTION 10. RESPONSIBILITY FOR PARENTAL, SUBSTITUTE PARENTAL NEGLIGENCE. In case the infraction of this Ordinance is committed by a minor, the liability for penalty of fine imposed under the succeeding section shall devolve upon the parents, grandparents, guardian or person who has custody of minor offender, to be enforced in successive order herein provided, for the negligence in the exercise of parental or substitute parental authority as the case maybe, over the minor offender, provided however that such minor offender shall be proceeded against under intervention program in accordance with the applicable provisions of R.A. 9344.

SECTION 11. PENALTY. Each violator of this Ordinance shall be penalized with a fine as follows:

Second Offense	-	Php1,500.00
Third and Succeeding Off	enses	- Php2,500.00 or Imprisonment of two

SECTION 12. ENFORCEMENT. This Ordinance shall be implemented by the Local Chief Executive (LCE) or his authorized representative, the PNP-Mapanas, Punong-Barangays of their authorized representatives and their Barangay Tanods.

SECTION 13. ISSUANCE OF OFFICIAL RECEIPTS TO VIOLATORS. All payments made for violation of this Ordinance shall be issued with an official receipt. All Payments received shall be accrued by the following activities:

50% to the Barangay who apprehended the violators of this Ordinance; 50% to the Local Government of Mapanas.

SECTION 14. SEPARABILITY CLAUSE. If, for any reason or reasons, any part of provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

SECTION 15. REPEALING CLAUSE. All Ordinances and rules inconsistent with the provisions of this Ordinance are hereby modified or repealed accordingly.

SECTION 16. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval and upon compliance with the posting and publication requirements.

SECTION 17. SUNSET CLAUSE. This ordinance shall cease to take effect upon determination and declaration of proper authorities of that it is already safe to conduct mass gatherings and/or conclusion of the COVID-19 pandemic in the Municipality of Mapanas, Northern Samar.






