With the school opening on Sept. 13 DepEd: over 405,000

so far been enrolled

TACLOBAN CITY-With barely two weeks before the opening of this school year, more than 405,000 students so far have enrolled in all public schools in the region.

The Department of Education (DepEd) is calling parents for their children to be enrolled before the September 13 school opening.

Jazmin Calzita, DepEd regional information officer, said that the current number of 405,459 enrollees covering Kindergarten, elementary, junior and senior high, is expected to increase before the start of

the opening for this school

"This is just initial as other schools have yet to submit their learners' enrollment and survey forms," she said.

Calzita also said that they hope parents and other stakeholders will help on their goal to have more enrollment for this school

The current number of enrollment as of August 31 represents just around 33 percent from the 1.26 million students' enrolled last school year.

TACLOBAN CITY - After almost seven months of vaccination campaign here in Leyte, less than 10 percent of the target population have so far received the jabs.

And with this low number of vaccinated persons, Governor Leopoldo Dominico Petilla is calling the national government through the Department of Health (DOH) for more supplies of vaccines against coronavirus disease (COVID-19).

He also urged local government units to fast track their vaccination campaign for Leyte to achieve its own herd immunity before the end of this year.

Based on the report of the Provincial Health Office (PHO) provided to the Provincial Inter-Agency

Task Force chaired by Petilla, Leyte has only achieved 9.89 percent of its vaccination campaign as of Wednesday (Sept.1).

The 9.89 percent rep resents 107,043 people from the 40 towns of the province and the city of Baybay. The cities of Tacloban and Ormoc are not included being independent administratively from the provincial government.

Leyte has so far received 162,426 doses of vaccines

from the DOH. It was learned that for Leyte to achieve herd im-

munity, at least 70 percent

or 1,082,094 out of its more than 1.54 million population need to be vaccinated.

281 DPWH-NSFDEO employees complete national ID registration

CATARMAN, Northern Samar-At least 281 employees of Department of Public Works and Highways- Northern Samar First District Engineering Office(D-PWH-NSFDEO) have successfully completed the registration process for the Philippine Identification System (PhilSys) at the District Conference room on August 24-25,2021.

As the government continues its rollout of national ID, the Department of Public Works and Highways Northern Samar First DEO have coordinated/requested with the Philippine Statistics Authority Northern Samar for a two-day registration process among its employees.

On day 1 of the registration, a total of 130 office-based employees including District Engineer Mario D. Villena and the newly-designated Assistant District Engineer Agnes C. Lu have registered for PhilSys while a total of 151 field personnel and employees' family members have completed their registration on the second day.

Three steps were followed during the registration. First, the prospective cardholder fills out the PhilID form; second, the PSA staff verifies the information through a valid government ID brought by the PhilID Applicant; and third is the registration of biometrics data in the PSA's database. Once completed, a transaction slip is provided to the registrants which will be presented during the ID rollout.

DE Villena expressed his gratitude to the PSA Northern Samar personnel who facilitated the registration process for the PhilSys. "We are thankful to PSA Northern Samar for granting our request, bringing the registration process here in our office has brought convenience to all of us, it also mitigates the risk of transmission of COVID-19 among employees," Villena stated.

PhilSys aims to establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines. The valid proof of identity provided by the PhilSys shall be a means of simplifying public and private transactions and shall be a social and economic platform that promotes seamless social service delivery and strengthening of financial inclusion for both public and private services. Amid spike of COVID-19 cases, Maasin city mayor renews call for the DOH to give them more vaccines

TACLOBAN CITY – The mayor of Maasin City, Nacional Mercado, has renewed his call for the national government to provide more vaccines to his city.

The appeal of the city mayor is in the light of the increasing number of coronavirus disease (COVID-19) cases in Maasin as it has yet to achieve its goal as to the number of vaccinated people.

"The city government humbly requests to the Department of Health (DOH) and the National Inter-Agency Task Force (NIATF) to be prioritized in the vaccine allocations to serve the demands of our constituents who are in dire need of protec-

tion," Mercado said.

Based on their data, of the 47,650 individuals belonging to the priority groups, only 21.37 percent are fully vaccinated or 10,184 people.

Of the vaccinated individuals, a total of 8,143 people have received their first dose of Sinovac while 5,940 completed their second dose.

A total of 1,310 residents have received their first dose of AstraZeneca while 761 of them have received their second dose.

Some 3,483 residents were inoculated with Janssen vaccine which is only given for one shot.

The need to inoculate more people is important due to the threat of Delta variant which has already directly infected 14 people

in the region.

"With the threat of the Delta variant, the city government of Maasin strongly urges the public to religiously practice the infection-prevention and control measures. Please limit your outside exposure to essential activities. The COVID-19 virus does not take a day off," Mercado said.

The local chief executive also reminded the city residents and the public to strictly adhere to their established COVID-19 infection-prevention and control measures to prevent the further spread of the virus.

TACLOBAN CITY-A new, bigger and sturdier evacuation center was inaugurated by City Mayor Alfred Romualdez who was joined by other city officials on Thursday (Sept.2).

The P35 million worth facility, located in Barangay 101(New Kawayan), was funded by the city government with the help from Leyte Rep. and House Majority Floor Leader Ferdinand Martin Romualdez, Tingog party-list through Rep. Yedda Marie Romualdez, and the Department of Public Works and Highways) DPWH).

Joining the city mayor during the inauguration of the said evacuation center, were Councilors Aimee Delgado Grafil, Leo Bahin, Brian Steve Granados.

Also present were city disaster risk reduction management officer Edilbrando Bernadas and city social welfare, development officer Chona Bahin, and barangay chairman Albert Eviota, among others.

Mayor Romualdez said that the facility, which is equipped with closed circuit television, will be a big help to the residents in the northern part in the city during a disaster.

The evacuation center was built last February 2021 and was completed on July of this year.

It was learned from city engineer Dionisio 'Dony' De Paz that another evacuation center will be constructed near the area.

Barangay chairpersons Maria Leah Altobar (New Kawayan), Eutequio Balunan (Suhi), Caroline Jane Bodano (Old Kawayan), Rachel Lacaba (Tagpuro) and Lito Balangbang (Cabalawan) were also present during the event.

10 new deaths in the region last week due to COVID-19, DOH says

TACLOBAN CITY – The Department of Health (DOH) in the region reported of 10 deaths due to coronavirus disease (COVID-19) complications for this week, pushing the deaths to 462.

Last August 31 (Tuesday), four deaths were recorded involving a 73-year-old man from Dulag, Leyte who died on August 22; an 84-year-old man Calbayog City who

died on July 24; a 78-yearold man from Padre Burgos, Southern Leyte who died on August 3; and an 89-year-old woman from Macrohon, Southern Leyte who died on July 31.

On September 2 (Thursday), three deaths were recorded: an 89-year-old woman from Tacloban City who died on June 11; a 21-year-old man from Sogod, Southern Leyte see 10 new /page 9 ...

P9.8 million farm- to-market road project in Bobon N. Samar now completed

CATARMAN, Northern Samar- Farmers and local residents are now benefiting from the recently completed Farm-to-market road Phase II, in Barangay Jose Abad Santos, Bobon, this province.

OIC District Engineer Mario Villena said that the previously unpaved road was converted into two-lane concrete paved road with Grouted Riprap Slope Protection.

The 0.30-lane kilometer concrete road will give convenience to farmers and locals in transporting their farm products to the market centers, providing the community with the fresher goods for consumption. Motorists utilizing the said road section will no longer be burdened especially during rainy days, when the unpaved road was muddy & slippery posing hazard to their safety during travel.

Spike of COVID-19 in a Southern Leyte town traces to non-following of health protocols

TACLOBAN CITY- A village in Macrohon town in Southern Leyte province is considered to be a hotspot of the coronavirus disease (COVID-19) with the rise of the cases of the dreaded virus blame to the behavior of its residents.

The village of Ichon in the said municipality has 45 active COVID-19 cases, representing more than half of the current 80 active cases of the town, says Dr. Pilar Abaday, the municipal health officer of Macrohon.

Abaday also said that of the 19 deaths due to COVID-19 complications in their town, the village has now logged seven

COVID-19 in our town,

particularly in Barangay Ichon, is not because of presence of any variants like Delta variant but more on the behavior of our people," the health officer said in a phone interview.

According to Abaday, those who have symptoms like fever and cough do not report to their village officials or visit their rural health unit for a checkup.

"And once they are tested positive, they refuses to be place in isolation facility which is almost empty as they chose to stay at their homes, aggravating the situation as they infect their house mates and in the

Several residents of "The surge of cases of the village, Abaday added, openly defies the mandatory health protocols like being imposed by the government like the wearing of face mask and prohibition of mass gathering like parties.

Abaday also disclosed that many of the residents of the village works or visits at the nearby Maasin City which could have also result to possible spread of infection in the city.



Adaptive yet consistent

WE have to know how to be adaptive to the different and changing conditions of our life without losing our Christian identity and consistency. This is one clear lesson we can gather from that gospel episode where Christ was asked why his disciples did not fast while those of John the Baptist did. (cfr. Lk 5,33-39)

"Can you make the wedding guests fast while the bridegroom is with them?" Christ asked. "But the days will come, and when the bridegroom is taken away from them, then they will fast in those days."

The secret, of course, is to become truly like Christ. He is the master of adaptation, flexibility, versality

and consistency. This was shown, first of all, by the fact that out of sheer love for us, in spite of our stupidities, he became man to recover us from our state of alienation from God. Yes, out of this unwavering love, he did everything, including offering his own life, to redeem us.

This truth of our faith should sink deep in our consciousness and should somehow impel us to undertake a process of becoming Christ-like, obviously with the help of God's grace that is actually also provided to us in abundance.

Let's remember that not only did the Son of God become man, he also assumed the sinfulness of man without committing any sin, and as consequence, took on the human condition of being weakened and wounded by sin, including being subjected to temptation and finally death.

In his preaching, he used parables to make his lessons more accessible to the people. He was always compassionate, quick to forgive, slow to anger. He was always thinking of his Father and of the people. Remember him saying, "The one who sent me is true and what I heard from him I tell the world." (Jn 8,26)

He gave preferential

treatment to the children, the weak, the handicapped, the sick, the sinners. He was only allergic to the proud and self-righteous whose sense of right and wrong did not come from God, but rather from their own selves in their great variety of human consensus and other subtle forms of self-assertion. But on the cross, he asked forgiveness for everyone.

He was always adapting himself to the people, being flexible to everyone, and yet managed to accomplish his mission, whatever the situation was. He was not only passively adapting himself to the environment. He was also actively pursuing his goal in different ways. That's versatility for you.

Eventually, he rounded off all these expressions of adaptability, flexibility and versatility by offering his life on the cross. There he made as his own all the sins of men, died to them and rose from the dead. He turned the cross from being a tree of sin and death into a tree of life. His death conquered sin and death, and opened the door to eternal life.

To become Christ-like would indeed require a lifetime effort, but we can always start and develop it anytime. Let us not wait for some so-called opportune moment to be so. Any time, any situation can and should be an occasion to be like Christ. Obviously, we have to know Christ more and more. Thus, we need to be familiar with his life, his teachings and his example.

Let us put our mind and heart into this most important responsibility of ours.



Based on the data Calzita provided to Leyte Samar Daily Express, 226,278 are now enrolled in the elementary; 128,672 in the junior;50,075 in the senior high; and 434 in the non-graded or learners with special education needs.

Calzita said that just like last year, the method of learning in this school year remains to be mostly modular with some schools still adopting online classes.

Meantime, Calzita said that they hope to address the "challenges" that they have encountered during last school year, the first time that the modular and online method of classes were implemented in the country due to the pandemic caused by coronavirus.

Among these issues were poor internet connection, lack of gadgets mostly on the part of the students, errors in lessons featured in DepEd television and modules, and even mental issues affecting both students and even teachers, among others.

National High School (CNHS) is the first beneficiary of the project. The school received the equipment which includes transmitters, antennae and broadcast equipment managed through a laptop or desktop computer. The station runs on the FM band.

Cherry Nobis, a teacher of CNHS and Sierra Falcone chapter president in Northern Samar, said that this alternative mode of learning and teaching is a big help to students for them to continue their studies despite challenges brought by the pandemic.

CNHS has a total of 26 teaching staff who are all trained to handle RBI with about 800 students coming from Barangay Capacujan and nearby villages of Bangon, Osmeña, and Baga-

The school is accessible to teachers by riding a 'habal-habal' from the town proper travelling along unpaved roads while some students from its nearby villages needs to walk for about one hour.

Due to the village location, access to stable telecommunication signal is difficult making it hard for students to contact their teachers using their mobile phones if they have questions regarding their activity sheets and modules.

To have a good signal, students have to climb a hill just to send their text

message. "That is why I really this radio station," Nobis

Nobis added that transistor radio are also provided by Sierra Falcones to students.

"But those who will receive this are students who can't afford to buy a transistor radio," she said.

The operation of the radio station starts from Monday to Friday from 7 am until 5 pm.

"Right now we are still doing a test broadcast in preparation for the actual operation once classes for this school year begin this month," Nobis said.

– The provincial government of Northern Samar and municipality of Lavezares has reopened the Lalaguna Mangrove Eco Park to tourists on Wednesday (Sept.1).

The tourist destination that is run by the Women's Association for Inter-island Development (WAIID) of San Isidro village opened to the public last July 2019 but was forced to cease its operation due to the coronavirus disease (COVID-19) pandemic as the government imposed travel restrictions.

Lavezares Mayor Edito Saludaga and WAID members warmly received Gov.Ongchuan.

The Lalaguna Mangrove Eco Park was trans-

formed into a tourist destination to create livelihood and other social enterprise opportunities to the communities surrounding the Lalaguna Bay while at the same time promote environmental protection and management.

During this time of pandemic, tourists are to be asked to strictly all the health minimum protocols to ensure their safety and stop any possible spread of COVID-19.

2.117 lane kilometer road project will traverse along the road sections in the villages of Calao, Damuloan, and Buenavista.

With a capital outlay of P19.4-million under the current year's regular infrastructure programs, the road project will link and improve the road conditions in the interior barangays.

"Locals will no longer endure the poor road network condition and they will have a better opportunity in their economic activities," Oppura said.

The road project also includes stone masonry works, rectangular concrete lined canal and expansion of the existing spillway to ensure safety with 84.31% reported work accomplishment and expected to be completed this

can do the first and second dose to the remaining 900,000 Leyteños in two months. We can do

two months. We can do that based on the capacity that we have seen and then whatever vaccine is sent to us, we can do that," Petilla said.

The governor also said that a freezer procured by the provincial government to be used in storing the Pfizer vaccines had already arrived in the province with a freezer used to store for Moderna vaccines arrived last July.

The PHO keeps the freezers for these vaccines.

Gov. Petilla said that the freezer for Moderna vaccines has the capacity to store more than 150,000 doses while freezer for Pfizer can store more than 200,000 doses.

With these freezers, Petilla hope that the national government will provide more vaccines to the province to fast track its inoculation campaign against coronavirus disease (COVID-19).

Further, with the cases of Delta variants reported in in the region, the Leyte governor said that the government should consider putting up genome center in other areas like in the Visayas to fasttrack sequencing process in determining presence of variants of concern

Petilla said that in the present situation, it will take several weeks to a month before a COVID-19 patients learn if they are infected with a particular variant.

"I hope na madagdagan nila ang laboratory, if they really want to pursue na maging... ano bang tawag dyan, parang halos labas kaagad ang resulta ng Delta, hindi yung maghihintay ka ng isang buwan or several weeks bago mo malaman, nakarecover na ang pasyente," Petilla said.

In Leyte province, two cases of Delta variants were reported by the Department of Health (DOH), one is in Hilongos town, an OFW who is currently under isolation in Metro Manila, while the other is a pregnant women from Hindang who is currently under isolation in the facility of the municipality.

Leyte province based on the data from the Department of Health Eastern Visayas has a total of 14, 893 confirmed COVID-19 cases as of August 30.

Of which, a total of 14, 073 had already recovered, 696 are active cases with 124 recorded death.

Of the recorded cases 1,973 or 13.25% were mild cases, 329 or 2.21% moderate cases, 129 or .86% were severe cases, and 21 or .14% were critical.
