

Mayor Romualdez called for the special session Tacloban council approves P2.026 billion 2022 budget **JOEY A. GABIETA** All cemeteries in PH closed

TACLOBAN **CITY-** The members of the Sangguniang Panlungsod here has approved the P2.026 billion budget for the city for next fiscal year during a special session on Friday (Oct. 29) as requested by Mayor Alfred Romualdez.

The special session, presided by Councilor and majority floor leader Evangeline Esperas, passed the P2,026,234,767.00 2022 budget without much deliberations.

The 2022 annual budget is relatively higher compared to the current budget of P1.418 billion.

Mayor Romualdez, in his October 28,2021 letter to the members of the council headed by Vice Mayor Jerry 'Sambo' Yaokasin, sought for the councilors to hold a special session to approve and pass the 'people's budget.'

In his letter, Romual-

dez said that there is a pressing need for the immediate approval of the 2022 city budget as it continues to address the health pandemic caused by coronavirus disease (COVID-19).

"The need for the immediate passage of the People's Budget will be of big help to enact formally the prioritized recovery programs. Likewise, this will not only provide positive results for the Tacloban populace but as well better economic opportunities since programs that will attract investors are included in the 2022 people's budget," the city mayor said.

Based on the newly-approved city budget for next fiscal year, the city government continue to rely more of its income from its national share of taxes in the amount of P1,284,084,757.



DPWH Asec. Molano visits high impact projects in Eastern Samar

Department of Public Works and Highways (DPWH) Assistant Secretary for Regional Operations in Visayas Antonio V. Molano, Jr. visited the Catumsan-Arteche-Jipapad-Las Navas- Catubig -Rawis road and the Ca-Can-avid-Dolorolina, res-Maslog-Jipapad road in Eastern Samar on October 22, 2021.

Also joined during the inspection are the division heads of DPWH Regional Office VIII, District Engineer Ma. Margarita C. Junia and other officials of DPWH Eastern Samar.

In an interview, District Engineer Junia said that the visit of Asec. Molano complies to the directive of DPWH Acting Secretary Roger Mercado to personally inspect high impact projects in Eastern Samar especially those with conflict affected areas with peace and order issues.

DE Junia also disclosed that the newly appointed Acting Secretary wanted to prioritize the completion of these high impact projects. The DPWH Eastern Samar head is hopeful that there will be additional re-



quest of fund for the implementation of these projects next year.

Arteche-Jipapad-Las Navas-Catubig Rawis Road is a road project with a total length of 22.581 kilometers that connects Eastern Samar and Northern Samar.

The project started on year 2014 and there still unpaved road of estimated 3.0 kilometers from this year's on-going construction road project to the boundary of Las Navas, Northern Samar.

"The 200 meters of the remaining 3 kilometer-unpaved road is already lined-up to be implemented next year including the construction of slope protecti-

on, while the remaining 2.8 kilometers has no funding yet," said DE Junia.

DE Ma. Margarita Junia also said that the connection of this road project at the Northern Samar side has only 2.5 kilometers of unpaved road away from the boundary of the two provinces.

While, the Can-avid-Dolores-Maslog-Jipapad Road is a road project with a total length of 52 kilometers that connects national highway, remote barangays in Dolores, inner municipality Maslog and Jipapad.

"We have already conducted a feasibility study regarding the road Maslog leading to Jipapad. Once we have concreted all the unpaved road from Dolores to Maslog, our next project is to connect Maslog to Jipapad," added DE Junia.

She also disclosed that the priority project of the district next year is to concrete the unpassable road section between Villahermosa and Hinolaso, to provide convenient accessibility to locals of Maslog that even during heavy rains, the public can still use the said road.

The district engineer also said that district office is currently constructing the

PNP reports drop of crime cases in the region

TACLOBAN CITY-The crime volume of the region has significantly dropped to a total of 1.5 percent compared to last year.

The Police Regional Office 8, through its Regional Investigation and Detective Management Division reported that crime volume for the period of May 7- October 25, 2021 compared to the same period of last year has declined.

Based on their records, from May 7 to October of this year, there were 4,322 reported crimes, a decrease of 86 crimes compared to the 4,408 of same period last vear.

Crime volume consists of index crime, to include murder, homicide, rape, physical injury, robbery, and theft; and non-index crimes or violations of local ordinances and vehicular accidents.

B/Gen. Rommel Bernardo Cabagnot, police regional director, said that the drop is the result of the relentless campaign against criminalities and other forms of illegal activities.

It can also be attributed to the quarantine-related protocols being continually observed by the community, he added.

"The reduction of crimes is the result of the intensified police operations by our men and women in the field amid

Over 9,900 cops in the region now fully vaccinated; 98 others declined for medical reason

TACLOBAN CI-TY-Police personnel who received vaccination against coronavirus (COVID-19) disease here in the region have reached 99.12 percent as the government has ramped up its inoculation drive.

As of Wednesday (October 27), the Regional Medical and Dental Unit 8 recorded 9,975 out of 11,733 total police personnel were fully vaccinated.

Another 1,660 were on their first dose and still awaiting to complete the vaccination.

However, there were 98 personnel who remained unvaccinated due to medical conditions and other reasonable circumstances.



5.0 quake rattles Northern, Samar provinces

TACLOBAN CITY-A 5.0 magnitude earthquake rocked several areas in the provinces of Northern Samar and Samar early morning Friday.

The Philippine Institute of Volcanology and Seismology (Phivolcs) said on its report that the 1:39 am tremor was traced to Catarman, Northern Samar as its epicenter with a depth of 011 km.

The tectonic in origin quake was felt in Catarman and in the towns of Mondragon and Pambujan, all in Northern Samar at Intensity IV.

The towns of Laoang, Allen, San Isidro, Biri, and Lavezares, also in Northern Samar, also felt the tremor at Intensity III.

Meantime, the shaking was likewise felt at Intensity II in the cities of Catbalogan and Calbayog, and in the town of Santa Margarita, all in Samar province.

The quake was also felt as far as Prieto Diaz in Sorsogon and Legazpi City in Albay at Intensity I.

Phivolcs said that while they don't expect any damages due to the tremor, aftershocks are expected.

In 1997, Rosario's husband, Vicente, became a recipient of a certificate of land ownership award (CLOA) covering a 2.9-hectare lot in Barangay Patag, formerly owned by the Larrazabals.

But Vicente, according to Municipal Agrarian Reform Program Officer (MARPO) Artheiriza Manalo, failed to take full pos-

session of the said land due to several agrarian issues and disputes until he died in 2013.

Aside from Rosario, three other widows, Teresita Caliwan (71), Asuncion Agcang (78), and Trinidad Solayao (77) were also installed as they likewise took over the place of their late ARB-husbands during the installation.

The four widows were

among the 33 ARBs, who now take full possession of their awarded lots after having been physically installed following DAR survey teams conduct of a perimeter survey. Many of them waited for this moment for more than two decades.

Manalo disclosed that the landholdings where the ARBs were installed were formerly owned by the Larrazabal, Pongos and Pensergas families.

Meanwhile, DAR Eastern Visayas Regional Director Robert Anthony Yu expressed thanks for the support and cooperation which led to the peaceful and successful installation of ARBs both on September 22 and October 1 this year to Philippine National Police Regional Director PB/Gen. Presently, yellow corn costs from P13 to P15 per kilogram. We are also lacking in corn supply because we are not 100 percent sufficient. And that some stakeholders have long been calling for the reduction in tariffs...as early as the past Pres. Pinoy Aquino administration."





For next year, Tacloban received a higher share of national tax collection, previously known as internal revenue allotment amounting to P33.476 million due to the Mandanas ruling giving local government units a higher share of taxes.

Its other sources include the P5 million from the Philippine Charity Sweepstake Office share and 'other sources' amounting to P102 million.

DOT in the region support plan for mountain resorts to hire watchmen, lifeguards

TACLOBAN CITY -The Department of Tourism (DOT) said that it support the requirements set by the Department of Environment and Natural Resources (DENR) regarding the operations of rivers and mountain resorts.

Karina Rosa Tiopes, the DOT-8 director, admitted that their agency has yet to draw any guidelines in so far as requiring lifeguards in river and mountain resorts.

"DOT concurs to that suggestion / new requirement of DENR. Safety in all tourists as well as tourism service providers in these areas should really be of utmost support," she said.

"DOT does not have any existing guidelines for the operation of river or mountain area tourism sites that require having lifeguards. What that department currently has which requires having trained lifeguards - are the guidelines for the operation of tourism enterprises that have swimming pool or are considered as beach resorts," Tiopes added.

And while the DOT has no existing guidelines yet for operation of river

and mountain resorts, Tiopes said that their office is developing of recreational guidelines for tourism sites and tourist activities.

The pilot project will focus first on caving, spelunking, mountaineering, trekking, kayaking, standing up paddling, canoeing, boating, river cruise, and rappelling.

"Safety considerations ' tourism disaster risk reduction management will be included as part of these recreational guidelines," Tiopes said.

Earlier, DENR-8 suggested that mountain and river resort operators should require to employ at least two life guards and watch-

men who will monitor the prevailing weather condition in the locality.

The suggestion was made by the DENR to local government units in the wake of an incident in Tinubdan Falls, Catmon, Cebu where three people died after they were swept by a raging flashflood.

The DENR also stressed that resort owners should be required to display safety reminders for their visitors in visible areas at all times and suggests to consider other safety measures that may be identified by the local government units as obligatory and part of the conditions in the issuance of business permits.

The agency also orders for strict monitoring of the
