With the creation of 2 congressional districts

South Leyte to vote 2 solons for the first time

TACLOBAN CITY-For the first time of its history, voters of Southern Leyte province will be electing two congressional representatives.

The election of two congressmen is by virtue of Republic Act 11198 reapportioning the lone congressional district of the province into first and second congressional districts.

The law, approved on February 19,2019, was sponsored by Rep. Roger Mercado (Lakas-CMD) who is seeking for a fresh term for the province's first congressional district.

The first congressional district, which has a voting population of 132,114 as of the 2019 elections, covers the provincial capital of Maasin City and the towns

of Macrohon, Padre Burgos, Limasawa, Malitbog, Tomas Oppus, and Bontoc.

Mercado will be slugging it out for the post against two other candidates.

The towns of Sogod, Libagon, Liloan, San Francisco, Pintuyan, San Ricardo, Saint Bernard, Anahawan, San Juan, Hinundayan, Hinunangan, and Silago comprises the newly-created second congressional district which has more than 160,200 registered voters as of 2019 balloting.

Government worker nabbed over 'shabu' in Tacloban

TACLOBAN CITY-Joint police operatives arrested a 39-year-old government worker during a buy-bust operation in Barangay Utap, here in the city, Saturday (October 9).

The suspect was identified as Ryan Ogsimer, a resident of the city, and listed as a high-value indi-

Authorities confiscated from the suspect's possession a sachet believed to be containing shabu, as a subject of sale, and seven other sachets containing suspected shabu, together with the buy-bust money and other personal items and drug paraphernalia.

The recovered drug

items have an estimated market of P30,000 and an estimated weight of 3 grams, according to the police.

The operatives were from the Regional Drug Enforcement Unit led by Major Gaylord Pagala and Tacloban City Police Office-City Drug Enforcement Unit led by Lieutenant Angelo Leo Silvestrece, under the direct supervision of Major Rolando Isidoro, in coordination with the Philippine Drug Enforcement Agency.

The suspect will face charges for violation of Republic Act 9165, or the Comprehensive Dangerous Drugs Act of 2002.

"(The) Philippine Army will provide all necessary equipment and resources for your Division to triumph over the enemy and sustain your unit's milestones for the months ahead," Centino said in his speech.

General Jose Faustino Jr., chief of staff of the Armed Forces of the Philippines, also joined the ceremony via video teleconference.

Mamawag, a graduate of the Philippine Military Academy (PMA) "Makatao" Class of 1989, previously served as commander of 603rd Infantry Brigade and assistant division commander of 8ID.

Diñoso, a member of PMA "Maringal" Class of 1988, assumed the post as the commanding officer of the 8th ID on July,2019.

It was during the term of Diñoso that the government soldiers scored its

biggest victory against the members of the New People's Army (NPA).

Last August 16, 19 NPA rebels were killed in an air and ground assault conducted by the government soldiers against the rebels in Dolores, Eastern Samar.

Samar culinary promotional campaign on hold due to COVID-19 pandemic, says Gov. Tan

TACLOBAN CITY The provincial government of Samar is still waiting for the 'best time' to promote at the national scene the Secret Kitchen of Samar, a program that aims to promote the culinary tourism of the province.

This campaign was supposed to have a national launching March 2of last year but was postponed due to corona virus disease (COVID-19) pandemic.

"As of now, a lot of things had been done in relation to that," Governor Reynolds Michael Tan said.

This preparation includes the documentation for a Secret Samar coffee table book funded by the national office of the Department of Tourism worth P9 million.

The province has also identified food circuit that tourists may visit to try and taste local delicacies and dishes.

These are the Sta. Ri-



ta-Marabut-Basey circuits; Villareal, Calbiga, Paranas-Jiabong with San Sebastian food circuit; Catbalogan City, the San Jorge-Gandara-Matuguinao food circuits; and the Calbayog City, and the Daram-Zumarraga food cir-

Foods being offered in these circuits includes des-

serts, viands, local delicacies, 'pulutan', and 'ponsyon' which is a Visayan word which means meals that are prepared for a feast, banquet, or lavish celebration.

Among foods popular in these circuits are the 'tamalos'of Catbalogan made from tender pork belly with rich peanut sauce on a soft rice flour base.

wrapped in banana leaves and steamed for hours; the 'tinapa' or smoked-fish in Calbayog City; the 'tahong' crackers of Jiabong, and the 'keseo' of Gandara.

Gov. Tan added that they are also conducting trainings of additional areas to be included in the Spark Samar which includes Pagsanghan, Tarangnan, Gandara, and portion of Calbayog City.

Early this year, the DOT had turnover to the provincial government a fund worth P3.06 million as assistance to enhance the culinary attraction of the province which will be used to develop product; capacitate tour guides, waiters, cooks, pasalubong (souvenir) center, and food front liners on gastronomy tourism; produce promotional brochure and video; and develop social media content.

Arming fire personnel aims to protect their equipment, says BFP regional head

TACLOBAN CITY -Firearms issued to personnel of the Bureau of Fire Protection (BFP) will only be used for safeguarding assets of the agency.

This was clarified BFP Regional Director Senior Superintendent Rodolfo Denaga as the government mulls plan to allow firemen to have their own service

Denaga said that providing BFP personnel of

firearms will allow them to protect their equipment and assets against possible attack of enemies of the state.

Although they are capable and have knowledge in using firearms, the official said that they need re-training to enhance their skills.

"When times comes that it is already available, we will train first our personnel as far as gun safety and proficiency is concern. They all have training but they still need enhancement," Dena-

He added that not all

President Rodrigo Duterte signed the Bureau of Fire Protection (BFP) Modernization Act (Republic Act 11589) on September 10 of this year a 10-year modernization period transforming the agency into a modern and world-class institution.

The law also allows the creation of BFP Security and Protection Unit in every cities and municipalities and to be mobilized and provided with equipment "appropriate for self-defense and the defense of others during

exceptional emergencies, especially those related to a disturbance of peace and order where the assistance of the BFP is required or

The law also mandates acquisition of modern fire equipment, expansion of the BFP's manpower and provision of specialized training for firefighters, among others.

Currently, Eastern Visayas has more than 1,400 BFP personnel assigned in 124 fire stations.

5 Leyte candidates are running unopposed, waiting for formal declaration of poll victories

TACLOBAN CITY- Five candidates in Leyte are just waiting for their formal declaration as winners as they are unopposed.

Board member Anna Victoria Veloso Tuazon is unopposed on her bid to become a congresswoman representing Leyte's third district after her father, incumbent congressman Vicente 'Ching' Veloso withdrew his certificate of candidacy on October 8.

Also sure winners are provincial board member reelectionist Ma. Corazon Remandaban and Marie Kathryn Veloso who are both running for provincial seats representing the third district of the province.

Outgoing Vice Governor Carlo Loreto and his cousin former Baybay city mayor Michael Cari are also without opponents for the two provincial seats representing Leyte's fifth district.

Former Energy Secretary Carlos Jericho Petilla has filed his certificate of candidacy to reclaim his old post as governor but has to face three contenders: Eleuteria Agron, Avito Opiniano, and Romulo Gacgacao.

Carlo Pilpa and Leonardo Javier, former mayor of Javier town, are contesting the vice governor position.

Catarman N. Samar-The Department of Public Works and Highways Northern Samar First District Engineering Office has completed another Farm-to-market Road (FMR) project in Brgy. Ligaya, Rosario Northern Samar.

The said project has a contract amount of P9.94M which includes road opening of 530m and road concreting of 388m (w=5.00m, thk=0.23m).

Barangay Ligaya is an island barangay in the municipality with a total population of 1,027. Farming and fishing are the main livelihood of the locals. It can be reach via boat for approximately 20 minutes from the town proper.

In an interview, a resident disclosed that prior to the implementation of the project, residents and farmers had to walk by foot to reach barangay

proper, passing on the slippery and muddy road especially during rainy days, carrying their farm produce and traveling via boat just to reach the town

With the completion of said project, residents can now utilize and experience a more conducive travel from their farms carrying their products faster and hassle-free.

"The newly concreted road will tremendously help ease the burden of farmers in transporting their agricultural products to the market centers, reducing their transportation cost, and promoting development in the area", said OIC District Engineer Mario Villena.

The FMR project is part of the convergence program between the Department of Public Works and Highways (DPWH) and the Department of Agriculture and is funded under FY 2020 (DA-FMR) Bayanihan II.

A visit to the aquatic



Rep. Florencio 'Bem' Noel, the party-list first nominee, said that they could achieve their goal by 'maximizing' the more than 2 million votes of Eastern Visayas alone.

Aside from Noel, the party bared its nominees who include Mayor Allan Contado of Balangkayan in Eastern Samar as first nominee; Ormoc City Vice Mayor Leo Carmelo 'Toto' Locsin as its third nominee; Dr. Jason Alve as its fourth nominee and lawyer Camille Villasin as its fifth nominee.

An Waray started their foray in politics via the party-list system in 2004 and since then managed to secure even two congressional seats.

Noel said that it was always his dream to have three seats in Congress because it will entail more funds for the various programs of the An Waray.

During the 2019 elections, An Waray was able to poll more than 700,000 votes.

Mayor Contado said that aside from securing votes, their mission is to educate the voters about the party-list system.

He said that there is still low understanding of party-list among the people which results to low turnout of voters in the party-list system.

During the 2019

elections, for example he said, out of the more than 338,000 voters in Eastern Samar, only around 150,000 of them cast their votes in the party-list sys-

For next year's balloting, 270 party-lists are to contest for congressional representations.

The party-list is also banking on the votes from all Waraynons not just from all around the country but from other parts of the world.

Locsin, meantime, said that he is honored to be chosen as one of the nominees of the An Waray saying that it has been in service to the people of Ormoc 'for the longest time' providing free medicine, scholarships, and livelihood opportunities.

Meanwhile, the region also logged 47 new COVID-19 cases and 103 new recoveries on Monday, bringing the total number of cases to 49,377 and total recoveries to 47,698.
