Granting amnesty to NPA members

Gov. Petilla endorses proposal to ELCAC-EV

Over 560 inmates at the Tacloban city jail now fully vaccinated

TACLOBAN A total of 563 inmates at the Tacloban City Jail are now fully vaccinated against coronavirus disease (COVID-19).

This after the city's mobile vaccination team conducted the inoculation for the second dose of Sinovac vaccines to the inmates, or persons deprived with liberty, last Oct.1.

The prisoners received their first dose last September 3.

Prior to their inoculation, the mobile vaccination team first conducted last August vaccination among 42 women prison-

The women inmates received their second dose of Sinovac vaccines last September 15.



PNP Eleazar commended 2 cops for saving woman who slipped from a falls in Biliran

TACLOBAN CITY -Philippine National Police (PNP) Chief Police General Guillermo Lorenzo Eleazar commended two policemen from Biliran province who saved the life of a woman who fell from a waterfalls.

"I commend these police officers for risking their own lives to save the victim. Sa kabila ng malakas na agos ng tubig at mga malalaking bato na nakaharang sa kanilang daanan ay hindi nila ito ininda para lang mailigtas ang buhay ng isa nating kababayan," Eleazar said.

"Saludo ako sa ginawa ng aming dalawang pulis dahil ito ay isa sa napakarami nang patunay na handa ang pulis na ilagay ang buhay nila sa alanganin makatulong lang sa ating mga kababayan," he added.

Police Major Michael John Astorga, chief of police of Naval Municipal Police Station, and Major Jefferson Relente of the Police

Regional Office 8 Finance Service were taking photos in the area when they saw a woman falling from the falls as she accidentally slipped.

The victim was identified as 51-year-old Luzviminda Taruyo who lost consciousness due to the impact of the fall from an approximate 30 high.

The incident happened past 11:00 am last October 2 at the vicinity of Ulan-ulan Falls, a 90-feet high waterfalls, a famous tourist destination in Almeria town.

The two police officers suffered bruises while trying to save the victim who was being drifted by strong

After the victim was rescued and saved by the two police officers, their companion, Staff Sergeant Arla Pacencia, a registered nurse, gave first aid to the victim before she was taken to the Biliran Provincial Hospital for proper medical

Comelec Eastern Visayas assistant regional director Felicisimo Embalsado asked voters to register early and not wait for the Oct. 30, 2021 deadline.

"The extension of the deadline from September 30 to October 30 is very welcome to us because we want everyone qualified to be registered for them to exercise their right to vote," Embalsado told the Philippine News Agency (PNA).

The poll body on Wednesday approved the extension of voter registration for more than two weeks from October 11 to 30.



have once again embarked as a nation into another milestone in our political history wherein candidates for various positions are filing their certificates of

candidacy for an upcoming election, that's next year to be exact, and are then preparing for their campaign sorties, even doing it now in subtle ways.

Being in this era of hyper active social media, everything seems to be beyond control, particularly in the area of information dissemination. Things are wide open and transparent nowadays, like open books for all eyes to feast on. One-sided issues no longer have a monopoly of information as it could be digitally accessed in many ways for everyone to know.

And so, whether good or bad, issues that concern political aspirants are being tossed to and fro by both critics and supporters in social media. It's as if the candidates are being placed under a microscope, and people get to know them even before they open their mouths. While the supporters are

posting the good sides of their candidates, the critics are likewise posting the bad sides, thus enabling the readers to weigh the candidates' worth or insignificance.

In social media, too, you get to discover many secrets that historians and mainstream media had omitted and purposely covered up. One such example is the fact that, in the 70's and early 80's, the Philippines was already a superpower in Southeast Asia, and second only to Japan in the whole of Asia. It is because, during this time, the AFP's weapons were already advanced, with their Philippine-made rockets, jet fighters, rocket launchers, tanks, ships, etc. All these were just abandoned and allowed to rot by the succeeding regimes.

Clashes between opposing supporters, then, are already taking place this early. There's a word war going on in various social media platforms as the 2022 election nears. This is not forcing virtues into someone's throat, leaving him with no option but to accept those values. Rather, this is merely narrating what the tale is all about, using a mixture of narration and dialogue.

In the process, as one reads the story, he will discover for himself that some morals are there to pick up. These could be in the form of principles, experience, and other devices that are being uti-

lized in literature for various ends.

You will notice that, in most writing, the aim is to get the reader's attention towards something. It jolts and rouses the reader so that his awareness will focus on something that the writer deems to be very important. This could be done in many ways through commentary, through analysis, through argumentation, and many more.

The great value of spiritual childhood

THE gospel of St. Luke 9,46-50, shows us how being childlike in spirit would enable us to accept Christ as he is as well as to accept everybody else irrespective of how they are. It's a great lesson we have to learn if we want to be truly Chris-

In that gospel, Christ clarified how being simple and humble like a little child would enable one to accept Christ. "Whoever receives this child in my name receives me," he said. "And whoever receives me receives the one who sent me. For the one who is least among all of you is the one who is the greatest."

This clarification of Christ came as a consequence of the apostles talking among themselves about who among them

was the greatest. It can be supposed that they must be feeling important since they realized they had the fortune of knowing and being with Christ.

But that was not enough. The gospel somehow links being simple, humble and childlike with the capacity to be accepting and to be able to have a good working relationship with everyone irrespective of who and how they are, despite the unavoidable differences and conflicts among them. This point Christ established when he said, "Whoever is not against you is for you."

We have to realize that if we want to be with God always and to know the fine points of his mysterious will and ways, we need to be always simple and childlike. Christ may have


Former Comelec commissioner Larrazabal files CoC for Leyte's 4th congressional district



"They are afraid to surrender because they are facing charges," Perito said.

"Do we have a local amnesty to encourage them surrender?" Perito asked.

"We can discuss that matter with the ELCAC if we can suggest that," Petilla replied.

"In ELCAC we have discussed many programs but we never talked about amnesty," the governor added.

He stressed that those who surrenders are provided with livelihood and financial assistance under the enhanced comprehensive local integration program.

"Several of those who surrendered were given assistance under E-CLIP which does not cover relative to the cases filed against them," Petilla said.

He added that aside from discussing the matter at the regional ELCAC lev-

el, this concern should also

be brought to officials in the national level for them to decide.

Giving amnesty to rebel members is not part of the ELCAC program of the national government.

The program which aims to convince rebel members to return to the fold of law to start a new life in normal community mainly focuses on the "whole-of-nation approach" wherein government agencies and their partners provide government services to areas affected by insurgency prob-

Under this partnership, USAID and the DA's Bureau of Fisheries and Aquatic Resources will work together to support the conservation and rehabilitation of habitats for fishery resources; institute reforms to address overfishing and illegal, unreported, and unregulated fishing; and incentivize conservation through private-sector engagement.
