TACLOBAN CITY-A non-commissioned survey conducted by a survey firm has shown a highly satisfactory ratings for Biliran province' top officials.



## DOH says over 109,000 Pfizer vaccines downloaded to the region by the National COVID-19 vaccination operations center

TACLOBAN CITY – A total of 109,980 doses additional Pfizer vaccines arrived in the region on Thursday (October 8) for the continuing inoculation drive against coronavirus disease (COVID-19).

This is addition to the 105,300 Pfizer vaccines that arrived in the region last Oct 5.

The region has now a total of 328,70 doses of Pfizer vaccines downloaded by the National COVID-19 Vaccination Operations Center.

Of the newly arrived Pfizer vaccines, a total of 36,270 doses were pre-allocated and directly transported to the cold storage facility of Leyte; 21,060 doses were directly delivered to Catbalogan City; and 52,650 doses of were transported directly to the cold storage facility of regional office of the Department of Health (DOH) for storage, awaiting distribution to selected local government units (LGUs).

Leyte and the city government of Catbalogan are the only LGUs in the region that has ultra-low freezers, Jelyn Lopez-Malibago, information officer of the DOH, said.

Prior to the delivery of Pfizer vaccines in Catbalogan City, a team from the DOH-8 met with Mayor Dexter Uy discussion and appealed for the use of the ultra-low temperature freezer owned by the city government as temporary storage of Pfizer BioNtech COVID-19 vaccines allocated to the province. The request of the DOH8

was immediately granted by Mayor Uy during the meeting which resulted for the immediate transfer of the Pfizer vaccines to the city.

Pfizer vaccines are now being used in the vaccination campaign in the cities of Tacloban, Baybay and Ormoc, and towns of Palo, Dulag, Kananga, Bato, Albuera, Leyte town, Abuyog, Javier, Mahaplag, Palompon, Hilongos, Alangalang,

# Leyte pastor nabbed over rape, child abuse charges

TACLOBAN CITY-Joint police operatives have arrested a 27-yearold pastor for two counts of rape and child abuse charges in Barangay San Isidro, Mahaplag, Leyte.

The accused was identified as Wennie "Pastor Wennie" Oghayon, single, and a resident of the said barangay.

Authorities identified him as Top 1 most wanted

person in Leyte province. Judge Carlos Arguelles of the Regional Trial Court-Branch 14 in Baybay City, did not recommend bail to the accused for the rape case, while P200,000 bail bond was recommended for each case of violation of Section 5 (b) of Republic Act 7610, otherwise known as "An Act Providing For

ed Stronger Deterrence And ed Special Protection Against Child Abuse, Exploitation And Discrimination, And For Other Purposes."

The operating units were the Criminal Investigation and Detection Group-Northern Leyte Provincial Field Office (CI-DG-NLPFU) led by Major Duane Francis Ducducan, Regional Intelligence Unit-8 led by Major Delfin Tan, Northern Leyte Maritime Police led by Major Glenn Michael Amoyen, Northern Leyte PHPT led by Master Sergeant Amancio Diola Jr, Leyte Provincial Intelligence Unit led by Lieutenant Colonel Dinvir Revita, and Mahaplag Municipal Police Station headed by Captain Rodolfo Renomeron.

Police brought the accused to the station for documentation and was subsequently brought to CIDG-NLPFU for proper disposition prior to turnover to the court of origin. **(RONALD O. REYES)**

In Northern Samar, the vaccines was available to residents of Catarman and San Roque towns.

In Southern Leyte, Pfizer vaccines were used in the inoculation in Maasin City and towns of Sogod, Hinunangan, Bontoc, Hinundayan, and Tomas Oppus.

As of Friday (Oct. 9), the region has now a total of 49,005 confirmed cases of which 47,330 are recoveries; 1, 146 active cases, and 529 deaths.

## 7 most wanted fall in Eastern Visayas

TACLOBAN CITY-Police in the region has arrested seven most wanted persons during a three-day anti-criminality operations.

The accused were identified as Marlon Ecaldre, 40, for 13 counts of statutory rape; Keno Mejido, 27, for rape; Eric Salar, 43, for violation of Republic Act (RA) 7610 or the Special Protection of Children against Abuse, Exploitation, and Discrimination Act; Rolito Pandac Precillas, 47, for lascivious conduct, two counts of qualified sexual assault, and sexual assault; John Rey Baleros, 21, for RA 7610; Carlito Meniano Jr., 25, for statutory rape and two counts of sexual assault; and Randy Evangelista, 41, for rape.

In the information re-

leased by the Police Regional Office-Eastern Visayas, the region-wide operations covering from October 1 to 3 also resulted in the arrest of 33 other personalities who were facing various

crimes and offenses. The arrested individuals

include five wanted persons, 21 illegal fishing violators, five illegal gamblers, and two drug suspects.

## Another school worker yields shabu in Tacloban City

TACLOBAN CITY-Anti-narcotics agents and police operatives arrested another employee of the Department of Education (DepEd) over alleged selling and possession of illegal drugs in Tacloban City Monday (October 4).

Authorities identified the suspect as Banjo Asirit, single, 44, and bookkeeper of Tacloban National Agricultural School (TNAS).

In an initial report, personnel of the Philippine Drug Enforcement Agency (PDEA) and Tacloban City Police Station 2 seized from the suspect one gram of suspected shabu with an estimated street value

of P7,000, as the subject of sale, and one gram of suspected shabu with an estimated worth of P7,000 in his possession.

Operatives also seized P500 buy-bust money, identification cards, and other items.

On September 20, 2021, joint operatives also arrested an administrative assistant at TNAS for alleged illegal drug activities.

Asirit will be facing charges for violation of sections 5 and 11, Article II of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002. (RONALD O. REYES)



## Sen. Lacson vows to stamp out corruption in the government as he seeks presidency

TACLOBAN CITY Senator Panfilo 'Ping' Lacson has officially filed his certificate of candidacy for President in the upcoming 2022 elections. He was joined by his running mate, vice presidential candidate, Senate President Tito Sotto.

Their filling of CoC officially debunks fake news that has been circulating in provinces, saying that Lacson and Sotto are backing out of the national elections. To this, Lacson replies, "Laban kung laban, hindi susuko!"

The two were the first tandem to announce their candidacy last Sept. 8. A week before filling this

third Senate term, said that with his leadership, he will

restore the trust of the Filipino people on the government.

> presidential elections, he promises to end corruption in the Philippines, improve the country's pandemic response, and fight for our territorial rights on the West Philippine Sea.

> He also vows to introduce budget reforms to make it more efficient and corruption-free.

Lacson said that in his yearly review of the national budget, billions of appropriated money were unspent.

Lacson said he and running-mate Senate President Vicente Sotto agreed to reform the budget to give local government units flexibility and autonomy in spending for their locality.

If he will win this election, he vowed to a budget that will prioritize the people's needs.

Moreover, the two candidates agreed not to comment on their political rivals this coming May 2022 election.

## 55 inmates at the Eastern Samar provincial jail receive shots against COVID-19

TACLOBAN CITY-About 55 inmates at the Eastern Samar Provincial Jail in Borongan City were administered of their first dose of the vaccine against coronavirus disease (COVID-19) on Tuesday.

However, four other inmates were not given the Sinovac vaccine on grounds of being minor, medical reason and outright refusal, provincial jail warden Samuel Afable said in a radio interview aired over DyES-Borongan. Of the 55 inmates who were inoculated, four of

them were women. They will receive their second dose on November 3.

The vaccination of the inmates at the provincial jail facility was in response to the call of both the provincial and city governments, Afable said.

He also said that inmates detain at the different

sub-provincial jails will also be given the vaccine.

In fact, the jail official said, 67 prisoners detained at the sub-jail in Oras town were already given their first shot of the vaccine.

Afable also said that based on their monitoring, no inmates from the provincial jail have been tested positive of the dreaded virus.

He stressed that they are strictly complying with

all the mandatory health protocols to ensure that no one will be infected of COVID-19.

Afable also announced in the same radio interview that inmates could now receive visit from their loved ones on the order of Governor Ben Evardone with the protocols to be followed strictly.

Conjugal visit, however, is still prohibited, he said. (JOEY A. GABIETA)



today's rampant proliferation of fake news, it is commendable that Facebook Philippines takes immediate actions in fact-checking the contents of posts that it deems questionable and injurious to some people's reputation, deleting them off the Facebook plat-

form forever. This quick action, however, has been observed to be just selective, and it is zeroing in only on politics. The fact-checkers are just after those posts that tend to attack their political allies, even if the contents are actually opinions to which everyone is entitled in a democracy. They make sure that only the positive posts are allowed so as to build the image of their political friends and masters.

It's alright to fact-check the facts, but if it is opinions that are being fact-checked, it is not quite appropriate. Worse, this fact-checking campaign is only in support of selected fewtheir political allies. It can be noted that Facebook is adulterated with fake news and fake information about the other political figures, but since they are not allies of Facebook fact-checkers, the latter just leave these destructive posts alone.

Herein we see how dirty politics is that even institutions of high repute like Facebook can be used as tools for propaganda and other deceptive and subtle reports. We could have been saluting the credibility of Facebook as a social media platform. But since, in its Philippine version, politics is allowed via politically-biased fact-checkers, the platform is heavily affected to the point of being labeled as a dumpsite of political views.

Had these fact-checkers been fair, balanced, objective, and non-partisan as all media in general should be, Facebook could have been a decent vehicle of information, trusted and well-applauded. Too bad, the reputation and credibility of Facebook Philippines is just being destroyed by its notoriously-biased fact-checkers.



TACLOBAN CITY – The Department of Tourism (DOT) and the Bureau of Fire Protection (BFP) entered into a memorandum of agreement (MOA) for partnership in promoting and ensuring a safe tourism in the region.

The MOA signing was inked by DOT8 Regional Director Karina Rosa Tiopes and BFP8 Regional Director S/ Supt. Rodolfo Denaga.

The MOA aims to strengthen the fire prevention campaign of the BFP and at the same time promote the tourism industry here in Eastern Visayas.

"We look forward for forging a stronger relationship with the BFP as we all work together for a fire safe community and as far as DOT, is concern for paving the way the safe and fun tourism restart this pandemic," Tiopes said.

In implementing the project, the two agencies will jointly identify areas where activities will be implemented.

Prior to the implementation, the BFP personnel will undergo a tourism awareness orientation first for them to have a better understanding about tourism and the industry, the stakeholders and what are needs to be done and why it is need to be done.

The DOT will also

prepare for the list of tourism enterprises and community-based tourism organizations in every province and city where fire safety inspections and drills will be conducted.

An amendment on the no smoking ordinance stipulated that all kinds of leaves that will be used as tobacco outdoors, or outside one's home, is deemed illegal, City Vice Mayor Maloney Samaco announced during the destruction ceremony.

Also disallowed are acts of smoking any kind of cigarette or tobacco within 10 meters from a senior citizen, a pregnant woman, a person with comorbidity, and a minor, Samaco said as reported by Acasio. (LDL/MMP/PIA 8-Southern Leyte)



# Pagasa raises flood alert in E. Visayas

TACLOBAN CITY -Heavy rains brought by Tropical Depression Maring may trigger flooding in major river systems in the Eastern Visayas region, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa) warned on Friday.

In an advisory, PAGA-SA identified several rivers in six provinces that would likely be affected by the downpour -- Sangputan, Palo, Solano, Daguitan, Marabong, Cadacan, Bongquirogon, Salug, Pagbanagaran, Pagsanga-

### han, and Binahaan in Leyte; and Catarman, Bugko, Pambujan, Catubig, Palapag, Mano, and Gamay in Northern Samar.

Other rivers include Dolores, Oras, Ulot, Taft, Borongan, Suribao, Llorente, Balangiga, and Sulat in Eastern Samar; Basey, Silaga, Calbiga, and Jibatan in Samar; Bisay, Himbangan, and Pandan in Southern Leyte; and all river systems in Biliran.

People living in low-lying areas near these river systems have been advised to stay alert for possible flash floods.

Those residing near mountain slopes have been told to watch out for signs of landslides.

The Department of the Interior and Local Government earlier identified 2,433 villages in the region as highly susceptible to flooding and urged their respective local governments to take precautionary measures.

As of 10 a.m. Friday, the weather disturbance was estimated at 495 kilometers east of Catarman, Northern Samar.

## **BFP** in Eastern Visayas braces for arming of members

TACLOBAN CITY – The Bureau of Fire Protection (BFP) regional office said they will conduct training on gun safety and proficiency to firemen this year in preparation for the issuance of guns to some of their members.

While most BFP personnel are trained on gun use, their skills should be enhanced to boost their capability to protect themselves and BFP assets, BFP Eastern Visayas regional director Senior Superintendent Rodolfo Denaga said on Wednesday.

"Most of our firemen are capable since we have training in the past, but we need the assistance of our policemen to further enhance our skills," Denaga told the Philippine News Agency (PNA) in an interview.

The region has more than 1,400 firemen, but the priority for the issuance of firearms are investigators

and those assigned in big cities, according to the BFP official.

On September 10, President Rodrigo Duterte signed into law Republic Act 11589 that will strengthen and modernize the BFP.

The law allows firefighters to carry a gun to help them ward off threats and destruction of government property. Firefighters will be armed

with 9mm pistols. The law permits at least 14

firefighters for every BFP regional office and city station to carry a firearm as members of the security and protection unit.

Arming firemen is both timely and practical in the government's drive against criminality, illegal drugs, terrorism, and violent extremism, according to the Department of the Interior and Local Government.

"The peaceful surrender was a fruit of the effort of the lady's son who is himself a former rebel that vielded earlier to 14IB as well," the Army said.



"I am running as vice mayor because I am not afraid of serving our people," Chua said after he filed his CoC.


He added that his decision to run despite being a close political ally of the Romualdezes was made after seeing the lack of support given by the administration to the Taclobanons, especially during the pandemic.

data on the demographic and socio-economic characteristics of the population particularly on the distribution of employed, underemployed, unemployed population 15 years old and over. The result of the survey aims to provide a quantitative framework for the preparation of plans and formulation of policies affecting the labor market.

The SOF is a nationwide survey that seeks to gather information on Filipino citizens including overseas workers who left abroad during the last five years. This survey aims to obtain data on their socio-economic characteristics including their contribution to the economy using the past six months as reference period. Specifically, this aims to provide estimates on the amount of cash and in kind transfers received by the families and the mode of remittance. The SOF is a rider survey to the October round of the LFS every year.

Meanwhile, the Awareness Survey on PCC and PCA aims

to determine the awareness of households on PCC, its mandate and PCA. Results of the survey will guide PCC in designing strategies to enhance its advocacy and help educate the public on the relevance of market competition in improving consumer welfare.
