TACLOBAN CITY -Leyte Governor Leopoldo Dominico Petilla said that he is not keen on imposing the 'no vaccination card -

no entry' or a 'no vaccination card - no ride policy' in the province.

However, he said that this policy could be enforced by the mayors in their respective areas.

"It has no effect. If you are vaccinated you are protected, you are protected from getting hospitalized," Petilla said.

The soldiers to be deployed on the island, consisting of Samar, Eastern Samar, and Northern Samar, will come from the 3rd Infantry Battalion under the command of Col. Juvenal Mark Tayamen, the Visayas Command said in a statement.

The soldiers, who were assigned in the hinterlands of Davao City for the past six years, are expected to arrive this weekend in Samar, are not only to help in the fight against the members of the New People's Army(NPA) but also to ensure peaceful conduct of elections this May 9.

Aside from the presence of rebels, several parts identified in past elections as among Eastern Visayas areas of concern. The Commission on

Elections(Comelec) in the Major Gen.Edgardo de region, however, has yet to release areas in the region it deems to be areas of concern or 'hot spots' relative to the forthcoming balloting.

Lieutenant General Robert Dauz, the commander of the Visayas Command based in Cebu City, said that the deployment of troops on the island will help quell its insurgency problem.

"The addition of this unit only manifests the sincerity of our government to eradicate the menace of the communist terrorists in this part of the country, and sustain the people's democratic way of life," he said in a statement.

In a media interview, Leon, the commanding general of the 8th Infantry Division based in Catbalogan City, said that the troops will arrive this Saturday and will temporarily be headquartered in Calbayog City.

He added that these soldiers will be deployed in other parts of Samar Island if there is a need.

It was learned that de Leon himself has requested for the augmentation of government troops to the region.

<u>In Northern Samar</u> **Catubig town confirms** presence of ASF infection

TACLOBAN CITY-The town of Catubig in Northern Samar has reported its first-ever case of African Swine Fever (ASF) infection.

Anita Estudillo, municipal agriculturist officer, however, was quick to say that the municipal government immediately imposed measures to ensure that the infection will not spread to the 46 other barangays of the town.

Estudillo, in a phone interview, said that the ASF case in the town was detected in Barangay Guibwangan, about 1.5 kms away from the town proper, on Jan.18 involving one pig.

She said that the infected pig and three others, all of the same backyard owners, were culled as part of the protocol.

The presence of the ASF infection in the village was reported to them just last Jan.25.

"We have yet to really determine what could be the reason why ASF infection entered Guibwangan. But one of the possibilities is that hog sellers from other areas which were ASF-infected could have entered the Guibawangan," Estudillo said.

It was learned from Estudillo that there were 45 pigs being raised in Guibawangan wherein most of these pigs were slaughtered by the owners and sold within the community.

A checkpoint is now in place in the village to ensure that no pigs will enter or exit the area.

She also said that the municipal government has also temporarily banned the selling of other processed meats to ensure that ASF will be contained.

"This is our first-ever AF case," Estudillo said.

Catubig is now the eighth municipality in Northern Samar to have ASF confirmed cases.

The first ASF case in the province was in Lope de Vega reported on March 15, 2021.

Aside from Lope de Vega and Catubig, the other towns which have ASF cases were the municipalities of Mondragon, Pambujan, Las Navas, Bobon, Silvino Lubos, and Catarman, the provincial capital.

As of Jan. 27 of this year, about 374 backyard owners were affected by the infection that infected 801 hogs, the Provincial Veterinary Office (PVO) said.

"We are not yet out of the woods. ASF continues to be a threat to our respective municipalities. But there are things we can do to stop the entry or eradicate the disease in our areas," Dr. Jose Luis Acompanado, provincial veterinarian, said in a statement.

Among the measures instituted by the PVO include the training of barangay biosecurity officers for quick surveillance and monitoring and the distribution of information materials in the villages and the establishment of border control and checkpoints. (JOEY A. GABIETA)

Senate approves on final reading creation of the Samar Island Medical Center

TACLOBAN CITY- The Senate has approved on Tuesday (Jan.31) on third and final reading the creation of the Samar Island Medical Center (SIMC) principally authored by Rep. Yedda Marie Romualdez of the Tingog party-list representative.

Romualdez said the establishment of the SIMC is part of Tingog party-list's mission to improve the delivery of health medical care

system.

"With the goal of improving the health care system in the entire Eastern Visayas, the SIMC is one of the priority hospital bills that Tingog party-list has lobbied in its first term in Congress, along with other bills that have already been passed into laws," she said.

Aside from authoring the creation of the SIMC. as contained under House Bill 8195, Rep. Romualdez has also authored measures upgrading the Eastern Visayas Medical Center, the biggest government-run medical hospital in the region located in Tacloban City, and the Schistosomiasis Hospital based in Palo, Leyte.

The House of Representatives has approved the measure last January 20, 2021.

Romualdez said that with the creation of the SIMC, which is to be located in Calbayog City, peo-

U.S. provides additional P51 Million for Typhoon 'Odette' assistance

Manila-—The United States government, through the U.S. Agency for International Development (US-AID), is providing an additional P51.1 million (\$1 million) in humanitarian assistance to help communities affected by Typhoon 'Odette', bringing total U.S. support for this response to more than P1.08 billion (\$21.2 million).

With this new assistance, USAID will strengthen its partnership with the United Nations World Food Programme (WFP) to provide additional logistics support to communities hit by Typhoon Odette.

"As friends, partners, and allies, we will continue to support the Philippines in its post-typhoon recovery," said U.S. Embassy in the Philippines Chargé d'Affaires ad interim Heather Variava. "This additional assistance will help deliver food and other essential items to communities devastated by the typhoon."

In coordination with the Office of Civil Defense (OCD), USAID and WFP will deploy an additional 300 trucks to transport food and other supplies to typhoon-affected areas. This partnership will also support OCD in delivering relief supplies to remote municipalities and barangays.

Sarah Charles, Assistant to the Administrator of USAID's Bureau for Humanitarian Assistance, announced this additional support at a virtual UN briefing on February 2.

This new funding builds on the U.S. government's assistance of P1 billion (\$20.2 million) announced in December to provide food; water, sanitation, and hygiene programs; shelter assistance; and logistics support to typhoon-affect-

ed communities. As of January 28, USAID and WFP have already provided more than 300 trucks to trans-

port approximately 350,000 household food rations, as well as hygiene kits, kitchen sets, and shelter kits to communities devastated by Typhoon Odette.

Murder charge filed against 2 suspects in the killing of journalist in Calbayog City

TACLOBAN CITY-The murder of journalist Jose Malabanan is now considered as case closed as a case for murder was filed before the Office of City Prosecutors in Calbayog City, Samar Wednesday afternoon.

Police Lt. Aileen Velarde, information officer of the Samar Police Provincial Office, said that the murder rap was filed against the suspects identified as Aries Solomon and Jerry Trinidad.

The suspects, she said, were identified based on the testimonies of the witnesses and the footage from the closed-circuit television cameras located in the area.

Solomon was said to be the triggerman while Trinidad was the driver of the motorcycle. Both remain at-large.

tion, his killing was not related to his being a journalist but due to land dispute that resulted in personal grudge," Velarde said.

She, however, could not say if the two suspects were members of gun-for-hire or personally involved in the said land dispute.

According to her, Malabanan assisted some individuals in Barangay San Joaquin, Tinambacan District who were involved to a land problem.

Velarde said that once the City Prosecutor's Office finds probable cause on the complaint and forward it to the court, a warrant of arrest will be issued against the two suspects.

Malabanan, who worked as a journalist in Pampanga, was gunned down while he was manning their variety store located in Brgy.San Joaquin, Calbayog City last Dec. 8, 2021.

DSWD continues to distribute food assistance to Typhoon 'Odette' victims; asks residents to coordinate with their LGUs

TACLOBAN CITY-The Department of Social Welfare and Development (DSWD) in the region asked victims of Typhoon 'Odette' to coordinate with their respective local governments for them to receive food aids from their office.

The appeal of the DSWD was made as it continues to provide relief assistance to the typhoon victims, particularly in Southern Leyte and parts of Leyte.

It said that their office has released 1,178 family food packs on January 30 as part of their continued relief operations for the people affected by the typhoon.

It further added that from the number of food packs, 500 packs were allocated for Inopacan, Leyte, and 678 packs for Libagon, Southern Leyte.

On Friday (February 4), an additional 1,500 food packs were transported to Bato, Leyte.

And as of February 2, DSWD-8 was able to distribute 185,109 food packs worth more than P107.28 million.

The food packs distributed by DSWD to typhoon victims include six kilos of rice, 10 pieces of canned goods either corned beef, beef loaf, tuna flakes and sardines, five pieces of coffee in a sachet, and five pieces of energy drinks.

As ASF continues to hound the province, N. Samar strengthen measures to contain further spread of hog infections

TACLOBAN CITY -The provincial government in Northern Samar continues to beef up measures against further spread of the African Fever Swine (ASF) as another town confirmed a case of hog infection. The town of Catubig is among the latest area in the province to have a confirmed ASF case.

With this development, a coordination meeting was held headed by the Provincial Veterinary Office (PVO) with the Department of Agriculture Regional Field Office 8 (DA RFO 8), the Bureau of Animal Industry (BAI), and the Philippine Crop Insurance Corporation (PCIC) for heads and representatives of Municipal Agriculture Offices (MAOs).

Recommendations and strategies were made and given to the Provincial ASF Task Force on how to control or prevent the spread of ASF in their respective municipalities.

Among the recommendations made by provincial veterinarian Dr. Jose Luis Acompañado, were the strict implementations of biosecurity measures in the barangays and border checkpoint and monitoring of live pigs and pork products in the municipalities.

"We're not yet out of the woods. ASF continues to be a threat to our respective municipalities. But there are things we can do to stop the entry or eradicate the disease in our areas," he Acompañado said.

Meanwhile, Board Member Albert Lucero, chairperson of the committee on agriculture and food security at the Sangguniang Panlalawigan, assured the local agriculturists and veterinarians that the provincial government will support the programs to combat the threat of ASF against the hog industry.

"The provincial government has allocated P3 million for ASF programs. A proposed ordinance on ASF is now on its latter stages and is currently undergoing review by the Provincial Legal Office," Lucero said.

The allocated fund will be used to indemnify affected farmers and hog raisers.

To date, of the 24 towns of Northern Samar, eight municipalities had recorded cases of ASF.

Aside from Catubig, the ASF-affected towns are Mondragon, Pambujan, Bobon, Las Navas and Silvino Lubos, Lope de Vega, and Catarman, the province capital.

A total of 374 farmers and 801 hogs are affected from 37 barangays as of January 27 of this year. (ROEL T. AMAZONA)


This announcement came with the lowering of alert levels in areas where new COVID cases are decreasing. Accordingly, stay-at-home orders and the implementation of the "no-vaccine, no-ride" or "no-entry" policy now depend on local chief executives. Why is this wise? Well, each locality has virus-related situations that differ from other locations, hence the wisdom of a localized, diversified imposition of protocols.

Majority of people no doubt welcomes this development, knowing that local situations vary and cannot be addressed similarly from the national level. There are places, for instance, where the

he decision of the Department of the Inte- Covid-19 cases are so high, requiring strict quarantine protocols to contain the spread of the virus. But there are also localities where virus infections are rare and should not be subjected to lockdowns.

> To cite examples, we have Metro Manila, Cavite, Bulacan, Rizal, Batanes, Biliran and Southern Leyte that were downgraded to Alert Level 2 from Feb. 1 to 15. But the DILG had earlier suggested for local government units (LGUs) to pass ordinances imposing strict measures in other places where more people are trooping to malls and other public places with the easing of alert levels.

> With the extending coronavirus pandemic, people's mobility has become unstoppable. They have graduated from that lockdown mentality. So it is a better option, that instead of locking down communities, an intensified vaccination be imposed to finally stop the virus from spreading. If other countries had already learned to live with the virus, why can't we?





Plagued with fumes

I have been contemplating on whether I should elevate a complaint to our Barangay Hall or not. Mine is for us and an immediate neighbor to live peacefully, without having to clash every now and then.

Just last year, we came to have this new neighbor who bought the house

Early in mid-January, Guanzon was already rumored at Comelec "to do last-minute maneuvers" in order to disqualify the usual survey topnotcher Ferdinand Bongbong Marcos Jr. to stop him from pursuing his presidential candidacy in the forthcoming May elections; thus opening another possibility for their candidate to do another winning trick.

The rumored plan was for Commissioner Guanzon to get the support of at least one other commissioner -- preferably Atty. Aimee Ferolino -- a woman in their First Division, in order to form the majority decision, so Bongbong Marcos gets disqualified at their level as a presidential candidate.



could pave the way for Vice-President Leni Robredo, the usual 2nd placer in surveys, to eventually win the presidency without the BBM's participation in the May elections.

However, Commissioner Ferolino showed disinterest in the initial talks with Guanzon, so the latter had to resort to drastic measures -- to pressure "newbie commissioner" Ferolino to given in to Guanzon's maneuverings.

Again, failing in this second maneuver, Chairman Guanzon, even before the division handling the case could promulgate its decision, Chairperson · Commissioner Guanzon announced that she is voting in favor of disqualifying Ferdinand Bongbong Marcos, Jr. "so Ferolino would be pressured to follow her decision."

But this maneuver also backfired when Commissioner Ferolino wrote long memorandum Comelec Chairman to Sheriff Abas, with the request that Commissioner Guanzon's "uncalled for announcements" should be investigated; and that was about the time when the Two (2) female commissioners started exchanging harsh words; and this went on until Commissioner Guanzon's retirement February 2nd.

This Columnist researched Three (3) known legal experts; but he found former Mala-Spokesperson canang Atty. Harry Roque's explanation much simpler; and could could easily be understood; so this Columnist has taken the liberty of quoting the important portions of Atty. Roque's column in the Manila Tribune. - ATTY. HARRY

ROQUE'S LEGAL **OPINION** -

"Based on our Constitution, the Commission on Elections (Comelec) is considered a collegial body. It is composed of Two (2) divisions and can sit en banc. Three commissioners decide in each division.

"The Five (5) Important Questions we will answer are --

"FIRSTLY, Can a commissioner publicize her/his vote even before the division has made its decision?

"SECONDLY, Is there really an inordinate delay that prompted Commissioner Guanzon to divulge her vote and broadcast it to the whole world?

"THIRDLY, What can be done in this regard? Does the fact that Commissioner Guanzon will retire have an effect on the final decision of the division? Finally, is her decision to disclose her vote judicious?

"FOURTHLY, Can a dissenting opinion be made public before the division promulgates its decision?

"AND LASTLY, Did Commissioner Guanzon do the right thing by disclosing her vote?

- THE ANSWERS TO THE ABOVE -

"Although only one decision is promulgated by a division, there may be a dissenting opinion.

"When we have a collegial body, the decision is not made by just one member of that group. The decision is made by ALL THREE of them!

"Of course, whichever position gets the most number of votes is what we call the majority opinion. If there is one who disagrees, that is when we have a dissenting opinion.

"When a division decides a case, the decision is the result of the votes of the Three (3) Commissioners; not just one of them.

"Based on my (Atty. Roque's) 32 years of law practice, the decision cannot be publicized before the division promulgates its decision. To do so would be to go against the collegial nature of the decision.

"Every member of the collegial body is equal in decision-making. And, there should be a majority decision. That is the majority decision. If one of them is not in favor.

"If among the Three (3) members, Two (2) of them are in favor of disqualification, that is the majority decision. If one of them is not in favor of disqualification, that is the minority decision.

"Now that Commissioner Guanzon has announced that she is the only one who has a dissenting opinion, the Two (2) are therefore in favor of the dismissal of the petition for disqualification.

"In all collegial bodies, until the decision of the majority is released, the vote of each individiaul member IS CONFI-**DENTIAL -- A SECRET !**

... from Page 1 "Even when there is still no vaccine available, we allow them to enter establishments, and statistics shows

that infection happens not in these establishments but inside the home," the governor added. Petilla further said that there is no need for the province to amend the provincial ordinance on policies that control the spread of coronavirus disease (COVID-19)

in the province. The Leyte governor stressed that if the goal is to prevent the further spread of COVID-19, enforcing of the minimum health protocols such as the proper wearing of face masks, physical distancing, hand washing, and sanitizing must be strictly implemented and observed even at home.

He also said that the vaccination campaign must also be strengthened at the local level to allow more people to have access to COVID-19 vaccines.

Earlier, the Regional Inter-agency Task Force and the Regional Task Force for Emerging Diseases released a joint resolution urging local government units to craft a local law that will encourage more people to be vaccinated and for private establishments to adopt and enforce it.

This policy includes the no vaccination no entry policy which most establishments and local government units in the region and the rest of the country are now implementing.

Several local government units in the region are now imposing the no vax, no entry policy when doing transactions are government offices and in entering private establishments.

The provincial government of Samar, on the other hand, became the first province to enact an ordinance for the enforcement of the no vaccine, no entry policy.

Last month, Leyte experienced a surge of COVID-19 cases with 3,033 cases. A total of 2,314 of which are unvaccinated while 320 are vaccinated based on the data from the Provincial Health Office (PHO).

The PHO added that 2,196 of the confirmed cases are asymptomatic, 676 are mild, 350 are moderate, eight are severe, three are critical, with no recorded deaths.

Moreover, on the ongoing vaccination campaign in the province, of the 1,682,729 target population, at least 873,245 residents of Leyte had received at least one dose of vaccines while 809,304 remains to be vaccinated. (ROEL T. AMAZONA)
