To ensure a peaceful, safe balloting Over 200 cops to be deployed in Samar

TACLOBAN CITY-At least 230 policemen are to be deployed to Samar province for election-related duties and to ensure that the conduct of balloting there will be peaceful and orderly.

This was disclosed by B/Gen. Bernard Banac, the police regional director for Eastern Visayas, who said that the police force will be deployed beginning March 1 and until the election period is over.

"We will deploy an additional number of police in Samar just to ensure that the conduct of the national and local elections in Samar will be safe, orderly, and peaceful elections," he

"So as much as possible, we don't want any untoward incident that will take place between now and until the election period is

According to the regional police director, the presence of the additional police force, who will come from the police regional police headquarters and who just finished their police trainings, will serve as a deterrent for any possible untoward incident relative to the forthcoming May 9 elections.

While the Commission on Elections, together with the Philippine National Police and the Philippine Army in the region, has yet to identify any areas of concern or 'hot spot areas'

in connection with the elections, some parts of Samar province have always been identified in the said category in previous elections.

Among these areas are the town of Santa Margarita and Calbayog City, where the additional police force are to be temporarily headquartered.

Incidentally, several shooting and killing incidents have been reported in these areas in previous weeks though Banac said that based on their initial reports, these were ordinary

PDEA aims to declare entire Leyte as drugcleared before the end of Pres. Duterte's term

TACLOBAN CITY - The Philippine Drug Enforcement Agency(P-DEA) said that they target to declare the entire Leyte as a drug-cleared province before President Rodrigo Duterte bows out from office on June 30 of this year.

And to achieve this goal of declaring the province as drug-cleared before the President steps down from Malacanang, their office will conduct more anti-illegal drug operations and arrest high-value targets, says Sheila Jervoso, barangay drug clearing program of PDEA-Leyte, said.

At least 23 municipalities in the province are under the validation process for an illegal drug clearing operation.

These municipalities cover 938 drug-cleared villages and 365 drug-free villages.

A total of 392 villages from these towns are also targeted for drug-cleared status restoration with about 205 from these villages have presence of drug personalities.

Also, a total of 142 vil-

lages from these 23 municipalities also needs to be restored their drug-free status. It was learned that nine drug personalities are present in these villages.

Last year, six villages in the province were declared with a drug-cleared status.

Meantime, a total of 88 villages from seven municipalities in Leyte are projected to be declared as drug-free.

These villages are from Dulag (32), Palo (31), Macarthur (9), Bato (8), Albuera (5), Dagami (2), and Abuyog (1).

Meantime, Jervoso said that they are planning to construct additional 'Balay Silangan,' a reformation center for drug offenders.

Here in Leyte, only the municipalities of Bato, Abuyog, and Barugo, and the city of Baybay have established their own Balay Silangan.

The towns of Tanauan and Kananga are in the process of constructing their own reformation fa-

'Twas a low turnout on the first day of vaccination for 5-11 years old in Dolores town

DOLORES, Eastern Samar- The vaccination campaign for children 5 to 11 years here in this town is now underway though its

Only 40 children received their vaccines against coronavirus disease (COVID-19) administered by personnel of the Rural Health Unit on Monday (February 21).

Dr. Elizabeth Carpeso, a pediatrician and a volunteer from Mandaluyong City, said that by decorating the vaccination site and distributing loot bags to the children would make their experience less frightening.

"We prepared 100 loot bags for today but we are

planning to continue giving out more loot bags to encourage more children to receive their COVID-19 shots," she said.

Major Gen. De Leon issues order to soldiers not to hamper voters' rights for the forthcoming May 9 balloting

TACLOBAN CITY -Major Gen. Edgardo De Leon, the commanding general of the 8th Infantry Division, has called on all soldiers in the region not to make any acts that could result to disenfranchisement of voters during the May 9 elections.

De Leon said that these soldiers, assigned by the (Comelec) for election-related duties, should instead make sure that voters could cast their votes freely.

"Ang specific instruction ko is make sure na walang madi- disenfranchise. Lahat ng mga botante ay magkakaroon ng pagkakataon na bomoto at pumili ng according sa kaniyang individual desire. So hindi Commission on Elections natin hahayaan na may mg

botante na maha-harash, matatakot," the region's top military official said in an interview.

De Leon also said that he has issued an order to all soldiers assigned in the balloting to apprehend all individuals who are caught carrying firearms without authorization from the Comelec.

"Pagka may nakitang civilian na may armas, accost them immediately. Pakita kaagad ng dokumento. Pag walang maipakita na Comelec document that means illegal, ngayon kung tumakbo siya, we have a reason to believe na illegal siya, and we will pursue them. If they will fight our soldiers, we will disable them," he added.

A village for peace and prosperity only in Leyte

For so long a time, various efforts have been crafted and pursued to encourage members of the New People's Army (NPA) to return to the fold of the government and attain peaceful and harmonious integration in the society. Sharing similar determination, the province of Leyte did what was needed to be done for the same purpose but with minuscule outcomes, until the Leyte EconoMICs Program was implemented.

A brainchild of threetermer Governor Leopoldo Dominico 'Mic' L. Petilla, the program came to light just after the November 8, 2013 Typhoon Yolanda which massively devastated Leyte.

With the province in shambles, poverty reduc-

tion and development efforts in the countryside were of utmost urgency.

Utilizing the soil and the people, farming was deemed to set this program into motion, which to this day, proved to be the most rightful thing to start with. Armed with tested and appropriate package of agricultural technologies on hand and skilled personnel from the Office of the Provincial Agriculture, the Leyte EconoMICs Program started the total human and community advancement journey.

The More Income in the Countryside (MIC) projects, its priority component, consisting of compact farming for high-value crops, hog fattening, hog breeding, egg-laying, tilapia production, vermicomposting, stingless bee farming, wing oyster and seaweeds production, rice production, and forest and fruit trees growing were implemented in upland, isolated and neglected communities where the poor and vulnerable farmers live.

Little by little, favorable feedbacks and affirmations went around the province in terms of socio-economic significance. Thereafter, people from all walks of life joined the MIC bandwagon where organized groups of fisherfolk, women, young people, senior citizens, pedicab operators and drivers, the religious sector, persons with disabilities, drug surrenderees, and former rebels also reaped the benefits of these MIC interven-

Driven by a holistic and convergence approach, these income sources were adequately reinforced with infrastructure support, health and nutrition, disaster risk reduction and management, education and values formation, and youth development and non-agri skills trainings, among others, leading to building competitive, resilient and inclusive community economies.

To date, there are 418 farmers' associations under the program.

A haven for former rebels

A noteworthy outcome of the Leyte EconoMICs Program which incidentally became a model of the national government's End Local Communist Armed Conflict (ELCAC) movement is the Leyte Peace and Prosperity Village. This 119-hectare area owned by the provincial government of Leyte at Sitio Limite, Brgy. Daja Daku in San Isidro town will serve as the permanent dwelling to some 458 former rebels and their families from the municipalities of San Isidro and Calubian, both in Leyte.

This village is our way of turning the dreams of these former rebels into realities by providing them a place which they could call home, income-generating projects to sustain them and where they could create a lasting impression that there is a government ready to help see A village /page 7 ...

War in progress

ussia's military invasion of Ukraine has finally come to reality after it built up massive forces along their border—a gesture of bullying a smaller and weaker nation for reasons that are self-serving, inconsiderate of diplomacy, and destructive of peace and cooperation.

On the surface, Russia justifies its action as self-preservation and defense, knowing that Ukraine is a NATO ally and, probably, a would-be member soon. Russia objects to Ukraine becoming a depository of hi-tech weaponry from its NATO allies, alleging that it endangers their position being in close proximity to these war artilleries. Most of all, Russia vehemently objects to Ukraine's likely NATO membership.

Besides these declared justifications for invading Ukraine, Russia appears to have other reasons that are rather clandestine. For instance, the fact that the Ukrainian president is an Israelite, or a Jew, enrages the Russian president and his people. Russia and Israel had not been on good terms, more so that the former had established military alliances with the enemies of Israel such as Iran, Syria, and others.

The fact, moreover, that Ukraine is so rich with vast mineral deposits gives observers the idea that perhaps, these are what Russia is running after. This in fact could dwarf other alibis that the smaller country, albeit independent, is historically part of Russia, and that they share the same ancestors and language. This parallels the claim of China that Taiwan is but a renegade province that must soon be retaken.

For sure, this conflict takes its toll on the global economy, and the heavily-affected are the smaller and poorer countries. Right now, in fact, prices of crude oil are already sky high, affecting our transport sector, manufacturing companies, and other businesses. Prices of goods will certainly rise, too, as tensions escalate. May we be spared from further crises.



Tale of two countries

Our very own president Rodrigo Duterte must have learned a lesson from Ukraine in advance; or to put it more aptly, he must have foreseen in Ukraine what might have happened to the Philippines had he put up a defiant stand

against another giant bully—China.

Just like Ukraine that Russia has been bullying, our country has been under similar treatment, not by Russia, but by its close ally: China. The issues they raise and the causes of tensions may be different, but the treatments are the same, and that's the use of force to intimidate their neighbor. These are overwhelming forces, military giants as they both are.

In the case of Ukraine, their political leaders had been rather tough and defiant, never giving an inch to the Russian advances. They seemed ready for military confrontation if need be. For months and years, Russia kept sending them a signal that the military buildup on their shared border is not just a threat—it's for real. But Ukraine stood firm in obvious defiance.

But president Duterte could sense danger in our

dealing with China. He knows we could not match the Chinese military might. He avoided bloodshed on our part by avoiding a military confrontation with China. It would be suicidal and stupid clashing with an enemy whose weapons are superior in all areas. So he resorted to diplomacy and softened his stand although he became an object of criticism from his critics.

Actually, the new D A Swine Research arm was the former National Training Center on Pig Husbandry (NTCPH)located in Marawoy, Lipa City, Batangas. The aforementioned Research and Training Center is tasked;

1. " To conduct research and production of extended boar semen for the benefit of small and medium scale breeders as well as research to enhance production performance of Philippine pigs, including development and packaging of relevant technologies such as frozen semen production;

- 2. To conduct continuing performance evaluation of swine breeds under Philippine conditions;
- 3. To support other related activities promoting good husbandry practices such as boar auction, and collaborate and partner with state universities and colleges, other research in-

DepEd Tacloban City okays LNHS conduct of 'in-person' classes

When DepEd Tacloban City Schools Division Superintendent Dr. Mariza Ethel Magan visited Leyte National High School (LNHS) to appraise its preparedness for the regulated Expanded Phase of Limited Face-to-Face Learning Modality, she was impressed and left a huge smile towards the school administrators.

LNHS successfully passed the Division Office's assessment of its readiness towards limited face-to-face classes as it conducted the Presentation of LNHS Operational Guidelines on the Implementation of Expanded Limited Faceto-Face Learning Modality on February 10, 2022.

Considered as the biggest Public Secondary School in Region 8 with over 9,000 student-population, Leyte High, as it is fondly called around the city, has for weeks now prepared classrooms and other school facilities to welcome back students, and has closely followed the mandates stipulated under DepEd Memorandum No. 071, s 2021 in said preparations, which were bases of the Division Office's assessment.

Pending the alert level status of the locale, the limited face-to-face classes for Leyte High is set to start on the February 28, Monday.

During the assessment, the assessing team used the School Safety Assessment Tool (SSAT) that bore the Communication Plan, Contingency Plan, Psycho-Social Help Plan, among others prepared cautiously by the school's administration and its technical working group.

make sure that they will have no more reason to go back to their old ways of fighting against the government. This community is composed of 11 farmers' associations which were recently converted to agricultural cooperatives. As marketing support also and with the volume of vegetables, root crops, and eggs they are growing, I gave them two mini-trucks to transport their farm products to their buyers from the nearby municipalities, to Ormoc and Tacloban cities," he added.

The settlement has the following facilities: duplex-type housing for 458 units, health center, community center, multi-purpose building, evacuation center day care center, children's playground and school

It has also ample spaces for communal and individual farms planted with high-value and market-driven vegetable crops, egg-laying projects consisting of 1,440 heads for each of the 11 cooperatives, seaweeds production at Sitio Tinibgan, Brgy. Biasong in San Isidro all financed by the provincial government of

Road construction from junction national road Daja Daku to Sitio Limite was recently finished courtesy of Senator Christopher 'Bong' Go. The Department of Interior and Local Government (DILG) likewise provided P5million for the construction of a halfway house which is now ready for occu-

Capacity building trainings like organic agriculture production, landscaping, carpentry, dressmaking, baking and pastry, t-shirt printing, computer repair, financial management, among others, have also been conducted by the province, the Technical Education and Skills Development Authority (TES-DA), and Department of Trade and Industry (DTI).

Valuable contributions have likewise been extended by the Philippine Army, the Department of Agrarian Reform, Department of Social Welfare and

Development (DSWD), Department of Labor and Employment (DOLE), the municipal local government units of San Isidro and Calubian, Philippine National Police, Philippine Coconut Authority, the Department of Education (DepEd), Department of Science and Technology (DOST), Cooperative Development Authority, and the municipal government.

Meanwhile, there are now more than a hundred housing units constructed with the first tranche of P75 million released by the National Housing Authority. Very soon, they will each receive their land titles for 2,000-square meter lot in the village.

Jubay both rebel infested, upland, and remote areas to attend the graduation of the compact farming training and mingle with our farmers/former rebels without qualms, it immediately occurred to me that this politician is really a man of his word, a unique breed," Ka Mayang nar-

Likewise, "I was most impressed when staff and personnel from the province's planning and development, social welfare and development, agriculture, engineering, assessor, legal, disaster risk reduction started performing their respective roles for the development of the village. I really felt good," she said.

Members of Sitio Airport and Jubay FAs are among the 11 FAs who will be permanent residents at the Leyte Peace and Prosperity Village.

'This is the first and true embodiment of my dreams fulfilled only in Leyte and I am grateful to Gov. Mic for creating a place for us," she enthus-

To top this all, President Rodrigo Duterte's visit to San Isidro last January 23, 2020 made her realize that the government is there to provide second chances of quality lives to former rebels.

Work in progress

Development and construction on this remarkable project is still underway but "Rome was not built in a day" so is the Leyte Peace and Prosperity Village. Initiating this was not a walk in the park for Gov. Petilla, the implementers and the former rebels them-

As the saying goes, the journey of a thousand miles begins with a single step. The Leyte Peace and Prosperity Village was made with a single yet a gigantic step towards a new beginning.

Immediately after President Rodrigo Duteapproved the COVID-19 jabs for minors last year, the Department of Health began its nationwide roll-out of COVID-19 vaccination chilamong dren ages 12-

17 years old on November 3, 2021.

Because this move is eyed as a major step towards reopening of schools in the country, the Department of Education, in its press release dated January 24, 2022, has urged all its field offices and schools to work hand in hand with the Local Government Units (LGUs) in the continuous national vaccination drive for children and education frontliners.

Meanwhile, teachers at Leyte National High School (LNHS), while working on being fully vaccinated, have started encouraging their learners to take their vaccination shots since the last quarter of 2021.

Citing also DOH Cir-



cular No. 2021-0483, or the Interim Operational Guidelines on Covid-19 Vaccination of the Rest of the Pediatric Population (ROPP) Ages 12-17 Years Old, teachers have also motivated parents and guardians to give their consent.

Indeed, in the January 15, 2022 LNHS N-NTP and Pediatric Vaccination Report of Mrs. Basilisa D. Negru, Secondary School Principal IV of LNHS, it showed that 97.88% of its teaching and non-teaching personnel, while 64.5% of its learners are fully vaccinated. This was very timely for the call of the agency.

In addition, LNHS teaching and non-teaching personnel, together with its stakeholders continue to

express their support in the national expanded vaccination drive for the implementation of safe-returnto-school initiatives.

Seizure of high-powered firearms further weakens NPA in Samar

TACLOBAN CITY - The recent recovery of 34 high-powered firearms from the New People's Army (NPA) in Pinabacdao, Samar on February 9 will further cripple the communist terrorist group, a military official said on Friday.

Capt. Ryan Layug, the spokesperson of the Philippine Army's 8th Infantry Division, said the recovered firearms in remote Bugho village Wednesday was the biggest seizure of firearms in Eastern Visayas.

"In the entire country, we have not heard bigger than this. This will reduce their capaacts like extortion and attack on government troops and civilians," Layug said in a phone in-

The firearms recovered were 24 M16 rifles, two M4 carbine assault rifles, seven China-made AK47 variant rifles, and an M14 rifle.

Layug said the rebels buried the assault rifles since they do not have enough manpower to carry them.

"This a result of reduction of manpower since many of their members have already surrendered to the government," he told the Philippine News Agen-

Troops from the Arbility to do terroristic my's 801st Infantry Bri-

gade scoured the area, acting on tips from residents on the presence of armed men.

The town of Pinabacdao, around 46 kilometers away from Tacloban City, is known for frequent sightings of NPA members.

The Communist Party of the Philippines (CPP)-NPA is listed as a terrorist organization by the United States, European Union, the United Kingdom, Australia, Canada, New Zealand, and the Philippines.

The Anti-Terrorism Council also formally designated the National Democratic Front as a terrorist organization on June 23, 2021, citing it as "an integral and inseparable part" of the CPP-NPA that was created in April 1973.

"For sure An Waray will not get zero votes in my province," he said. (LIZBETH ANN A.ABELLA)


Goma vows to sustain economic progress in Leyte's 4th district


