

# After SB blocked the needed funding requirement Rice aid for 17,500 households in Tanauan proceeds

TANAUAN, Leyte- Despite last week's arbitrary and deliberate obstruction of some Sangguniang Bayan members on the proposed 10 kilos rice subsidy to the 17,500 identified recipient households from this town, the planned rice aid has finally proceeded as scheduled, this after mayoralty candidate Penny Tecson, wife of incumbent mayor Pel, shouldered a substantial amount of the lacking funding requirement.

In an interview, Tanauan Mayor Pelagio 'Pel' Tecson said his wife Penny paid the lacking amount needed in the rice purchase in the amount of P1.3 million.

Tecson said the local government unit (LGU) has only over P2 million appropriated and readily available funds which can be used for said purpose. Penny's help, he said, will compensate for the lacking funding requirement.

The act of kindness will help assure the eventual realization of the food subsistence program, and all households identified recipients will be given 5 kilos of rice each.

It may be recalled that on March 9, during the regular session of the Sangguniang Bayan, Councilors Lauro

### Gov. Mercado bans live poultry products in Southern Leyte against possible entry of Avian Influenza

TACLOBAN CITY-The governor of Southern Leyte has issued an executive order on Monday (March 21) banning the entry of live poultry animals from Luzon and Cordillera Administrative Region to the province amid detection of Avian Influenza in Bulacan and Pampanga provinces.

Governor Damian Mercado, in his order, said that the move is to ensure that the poultry industry of the province will not get the virus.

Affected by the order of the governor are poultry products coming from Regions 1,2,3,4A,5, and Cordillera Administrative Region.

"Whereas, Avian Influenza is a highly contagious viral disease caused by any Influenza A virus affecting several species of food-producing birds..," Gov. Mercado said in his Executive Order 13 he signed Monday.

"Whereas, there is a need to protect the poultry industry of Southern Leyte and the general public from the effects of Avian Influenza," it added, citing the reason for the 45-day temporary ban of the entry of poultry products to the province from areas cited.

However, the same order provided exemption from poultry products coming from Mindanao which will still be allowed to enter the province provided that these products must arrive from the port of Liloan and must exit through Silago town.

Also, these poultry products from Mindanao are tested be negative of Avian Influenza.

Gov. Mercado, in the

same order, does not prohibit the entry of eggs such



### NICA chief expresses concern over report that a presidential bet is being supported by communist group

TACLOBAN CITY- The head of the National Intelligence and Coordinating Agency (Nica), Alex Paul Monteagudo, expressed his concern over reports that the camp of one of the presidential aspirants has been 'infiltrated' by groups identified by the government to be fronts of the Communist Party of the Philippines.

Monteagudo, who is also the head of the situational awareness and knowledge management cluster of the National Task Force-to End Local Communist Armed Conflict (NTF-Elcac), said that the said presidential aspirant should issue a statement for clarification on this report.

"Siyempre, from our end, pag may ganitong information, nababahala tayo kasi ang CPP-NDF-NPA has been designated as a terrorist organization by the Anti-Terror Council," he said in an interview Wednesday(March 23).

"And buong bansa, hindi lang ako, ay gustong makarinig ng paliwanag dahil hindi naman siya accountable sa amin but being a public, doon siya sa ating mga kababayan magpaliwanag kung kinakailangan," Monteagudo added. While the Nica chief did not identify the concerned presidentiable, based on reports, Vice President Leni Robredo is being tagged to have an 'alliance' with groups identified by the government to have ties with the communist group.

Robredo, who is running for president, has denied that she has formed a sort of alliance with any communist-identified groups, calling it an outright lie.

The Vice President is being endorsed by the Makabayan bloc, claimed by various government intelligence units to be the front organization of the communist group.

Monteagudo said that he is personally worried on this alleged alliance considering that the communist group will do everything, including civilians, just to achieve their goal.

He cited the Plaza Miranda bombing incident on 1971 perpetrated by the communist group which it earlier blamed to the Marcos administration.

### DepEd Tacloban announces registration for 2022-2023 school term

TACLOBAN CITY- The Department of Education (DepEd) Tacloban announces early registration for school year 2022-2023 happening from March 25 to 30, 2022 for all incoming learners from Kindergarten and Grades 1, 7, and 11.

All 64 schools under the Division of Tacloban City have started implementing the progressive limited in-person classes this month, which according to its information officer Nilo Eder, has been generally successful as per close monitoring.

With the everyday increase in the number of learners joining the faceto-face classes, the Division ensures that all schools are regularly monitored by the assigned composite teams.

Meanwhile, Eder clari-

fied that DepEd Tacloban preferring the fully vaccinated learners to participate in the progressive limited f2f classes does not intend to discriminate the unvaccinated learners.

He further emphasized how they welcome parents' desire for their unvaccinated children to be included in the list. They consider it an indication that they are one with DepEd in the implementation's expansion.

"We ask for a little more time to really prepare our schools so we can also accommodate the unvaccinated learners. We do not want to commit even minor errors as what is at stake is the health and safety of both the learners and the teachers," says Eder. (TACLOBAN CITY INFOR-MATION OFFICE)

TACLOBAN CITY -Employees of the Department of Agrarian Reform (DAR) shout "Mission accomplished!" after President Rodrigo Duterte finally handed the Certificates of Land Ownership Award (CLOAs) for the former rebels on Thursday in support of the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC).

DAR Eastern Visayas Regional Director Robert Anthony Yu disclosed that 446 individual CLOA covering 89 hectares of land in Sitio Limite, Barangay Daja Daku in San Isidro, Leyte, were handed by the Chief Executive to the 446 agrarian reform beneficiaries (ARBs) during the inauguration of the new Leyte Provincial Capitol in Palo town.

Agrarian Reform Secretary Bernie Cruz, who assisted the President in the distribution of the land titles, lauded the DAR-Leyte employees for a job well done.

Sec. Cruz dropped by the DAR Leyte Provincial Office the day before the distribution, to check on the titles.

The President on January 23, 2020, during his visit to the remote San Isidro town to turnover various government assistance to former rebels, ordered former DAR Secretary, John Castriciones, to provide the former rebels farmlands to till under the Comprehensive Agrarian Reform Program (CARP) where they can start a livelihood.

One year and eight

months after, a collective CLOA covering 91.6 hectares was generated and registered at the Registry of Deeds (ROD). Thereafter on March 19, 2022 the collective CLOA was parcelized into individual CLOAs, which were then distributed by the President on March 17, 2022.

During the same occasion, 326 more CLOAs with a combined area of 487.7 hectares were distributed by the President to the representatives of ARBs from other Leyte towns as well as from the provinces of Northern Samar, Western Samar and Southern Leyte. (PR)

This was disclosed by Sec. Roger Mercado who said that the DPWH will be allocating P105 million as initial fund for the construction of the 63 kms circumferential road.

He added that additional fundings are to be earmarked until the project is completed.

Mercado made this statement during his visit to the island coinciding with the 501st anniversary of the arrivals of Ferdinand Magellan to the island, paving the way for the rediscovery of the Philippines, last March 15.

Public Works and Highways Sec. Roger Mercado said that their department is ready

to release P105 million as initial fund for the construction of a 63 kms circumferen-

tial road at the historic island of Homonhon off Guiuan town.

He said that of the initial fund of P105 million, P45 million is allocated for the construction of the road project that will start in Barangay Pagbabangnan going to Magellan site; P15 million from the Magellan site to the docking area of Magellan crew, and P45 million for the circumfer-

ential road. He added that the existing municipal road on the island will also be converted into a national road.

"I cannot promise you more but the completion of the circumferential road and conversion of the mu- see DPWH /page 7 ...

nicipal road to national road," Mercado said.





# **Serious concern**

hile the opposition leaders are boldly expressing their resolve to stand against bullies such as Russia whose invasion of Ukraine could embolden China into thinking Western powers are scared, President Rodrigo Duterte is extra careful not to provoke or defy these military giants.

To play safe, the president takes a neutral stand relative to the Russia-Ukraine war. That to him is the best position for us to assume-siding with no one. Besides, we have nothing to do with their conflict, and we are not an ally to any of them, although he claims personal friendship with Russian President Vladimir Putin, whom he describes as having a suicidal bent.

Our alliance with the United States, however, could drag us into the conflict the moment it joins the war against Russia and its closest ally, China. Should it happen, Duterte warns that China could invade us like what Russia did to Ukraine, with similar reasons. Since China will not allow the battle to be fought in its homeland, it will bring the war elsewhere, our country being a likely battlefield again.

Even if we maintain a friendly stand, China still has a number of reasons to attack us: first, we have territorial disputes with it; second, we are an ally of the United States; third, it is interested in our natural resources. If we will deal harshly with it in utter defiance like what the opposition leaders suggest, all the more that it will find justifications for a likely invasion.

Good if the United States will come to our rescue, but with its tendency to protect nothing but its national interests, we cannot rely on it. We better think of ways to survive, diplomacy being one of them. At the moment, let's fervently pray that the war in Ukraine would come to an end soon; that China would respect our territorial rights and peaceful, democratic existence.





### SSS reminds delinquent employers of deadline to avail of contribution penalty condonation program

Social Security System (SSS) President and CEO Michael G. Regino today reminded delinquent employers that the deadline for application for its Pandemic Relief and Restructuring Program 2 (PRRP 2), a social security contribution penalty condonation program for business and household employers, will be on May 19, 2022.

"We encourage qualified employers to avail of the PRRP 2 early so that they can avoid the inconveniences of last-minute filing and face the risk of missing the opportunity," Regino said. "This will not only enable delinquent employers to regain their good standing with the SSS but will also prevent the further accrual of penalties on their pastdue social security contributions. It will also help their employees avail benefits and loans," he added.

The PRRP 2, launched last November 19, 2021, covers past-due social security contributions for the months of March 2020 to the present time.

Regino said those qualified to avail of the program are employers who are delinquent in the payment of their contributions for the said period and whose financial positions demonstrate a clear inability to pay their delinquency assessed charges due to economic crisis, serious business losses or financial reverses, natural calamity or man-made disaster without fault on their part.

"By availing of the program, the employers will be able to settle their delinquencies for the said period through one of two payment methods, both with the condonation of accrued penalties," Regino added.

The first payment method is through the full payment of the total assessed contribution delinquency within 15 calendar days from the receipt of Notice of Approval by the SSS, while the second is through installment payments for a period of four to 24 months, depending on the employer's total amount of delinquency.

The schedule of monthly installment payments is as follows:

Total amount of delinquency Up to P1,000,000; Maximum number of monthly installments-4 months, Over P1,000,000 to P2,000,000-8 months; Over P2,000,000 to P5,000,000-12 months; Over P5,000,000 to P10,000,000-16 months; Over P10,000,000 to P20,000,000-20 months; Over P20,000,000-24 months.

A down payment of at least five percent of the amount of principal delinquency is required under the installment payment method. It also has an interest rate of six percent per annum.

To apply for the PRRP 2, employers must submit an Application Form, together with the proposed mode of payment and supporting documents, to the SSS branch or the Large Accounts Department (LAD), whichever has jurisdiction over their account.

Employees' Compensation (EC) contributions and penalties are not covered under the PRRP2, however, the payment of EC contributions and penalties is also a requirement for application to the program.

Pending cases or final judgment of employers involving the collection of contributions and/or penalties incurred from the applicable month of March 2020 and onwards may be withdrawn upon the approval of their PRRP 2 application, without prejudice to its revival or refiling. Those with judgments that have acquired finality, however, are no longer covered by the program.

"This is what we want to convey to all diving enthusiasts here in the Philippines and outside our country that the diving industry will continue here in Southern Leyte and we



"We are assured of continuous supply whatever comes. I am giving our buyers safe, clean, and nutritious food. This is a very good technology," said Martina Reyna, farmer owner of La Granja based in Diit village here, on Thursday(March 24).

Dubbed the Intelligent Green Box (IGB), it is a vertical farming method of cultivating plants stacked upwards, within used container vans, taking less space than traditional farming.

Since this method takes up fewer resources such as water and land, it then becomes a feasible solution for smart cities, according to the Department of Science and Technology (DOST).

"In terms of quality, there's a lot of improvement since the temperature, humidity, and lights are controlled," Reyna told the Philippine News Agency (PNA) during the farm visit of key DOST officials.

"We expect that this technology will help Eastern Visayas achieve food security despite the fact that the region faces the brunt of strong storms every year," DOST Secretary Fortunato de la Peña said.

Leyte Governor Leopoldo Dominico Petilla said the technology will encourage the young generation to pursue modern farming.

"We need to make this technology available for our young generation to appreciate it. This will surely address poverty and improve the health condition of our children," Petilla said.

The 20-footer container van has been cultivating 860 lettuce plants since it was set up last September 2021 in partnership with the DOST, Leyte provincial government, Eastern Visayas State University, and the farmers' group.

"In the past, our lettuce plants were exposed to extreme heat and pests. The quality was not that good, and the value was only PHP200 per kilogram. With indoor farming, we can now sell our lettuce at PHP400 per kilogram," Reyna added.

The IGB technology optimizes indoor farming practices suited to the conditions of the region and allows the growing of high-value crops in a climate-controlled environment.

The quake was felt at Intensity V in Burauen, Ormoc City, Kananga, La Paz, Julita, and Pastrana towns; Intensity IV in Dulag, Santa Fe, Barugo, Abuyog, Palo, Tolosa, Capoocan and Baybay City, Tacloban City in Leyte.

It was also felt at Intensity III in Cebu City and Talisay City, Cebu; Lawaan, Eastern Samar; Leyte, Leyte; Biliran, Biliran; Intensity II in Borongan City and Taft, Eastern Samar; and Naval, Biliran.

Magnitude measures the energy released from the source of the quake, while intensity measures the strength of shaking produced by the earthquake at a certain location. (PNA)
