

TACLOBAN CITY-Police in Eastern Visayas has declared as generally peaceful the first day of the campaign period for those seeking local positions.

Lt.Col. Ma. Bella Rentuaya, regional information officer of the Philippine National Police (PNP), said that they have not monitored any untoward incidents on Friday (March25), the first day of the 45-day campaign period for those seeking local posts relative to the May 9 elections.

"The first day of the campaign for local candidates was generally peaceful. There were no reports of any (untoward) inci-

dents," she said during a media forum "Point Corner' held at the Pacific Point Events Pace and Resort, this city.

Rentuaya said that based on their record that since the start of the election period on January 9, 75 individuals have been arrested due to gun ban enforcement.

And of this number, 70 were civilians while the five others were barangay officials, she said. Also, 28 firearms and 52 deadly weap-

DOT-8 conducts tourism promotion to kick start revival of the tourism industry hit hard by COVID-19 pandemic

TACLOBAN CITY -The Department of Tourism here in the region has gathered stakeholders in the tourism industry on Saturday (March 26) with the aim to help reinvigorate the industry that suffered a slump in the wake of the coronavirus disease (COVID-19) pandemic.

Karina Rosa Tiopes, the regional director of the DOT, said that the 1st Eastern Visayas Tourism B2B (Business to Business) was organized to address the need of local tour operators (buyers) and guides, tourist transports, hotels, community-based tourism organizations (sellers) to firm up the tour programs that they intend to market with the full resumption of domestic and foreign tourism in the country.

"The core function of

DOT is to promote standards and regulation and see to it that everybody, primarily the tourism enterprises, are accredited, and we say that accredited is certifying that all these entities that are accredited abide by the internationally accepted tourism standard for facilities and service," she said.

The local B2B will help link sellers with destination managers and service providers that operate reopened tourism sites/ facilities and provide tourist activities in the region and create and market an array of market-driven, price-competitive tour programs and packages that offer an authentic experience of Infinite Escapes in Eastern Visayas, she added.

As the local campaign starts, DOH reminds candidates to strictly follow all health protocols

TACLOBAN CITY-The Department of Health (DOH) in the region has issued a public advisory on the reinforcement of minimum public health standards as the local campaign period formally started last Friday (March 25).

The health department would like to remind the public of the strict implementation and adherence to the agency's Mask-Hugas-Iwas-Airflow-Bakuna advocacy.

The public is encouraged to continue practicing public health measures such as physical distancing, wearing of well-fitted face masks, hand and respiratory hygiene.

The health department

likewise reminded people to ensure good ventilation by opening windows and doors where possible during in-person campaigns, rallies, caucuses, meetings and conventions, motorcades, caravans, miting de avance, and other allowable election-related activities per alert level.

Individuals with fever, cough, and sore throat are restrained from attending campaign activities. This is to ensure the safety of both citizens and candidates alike.

The DOH has reported on Monday (March 28) that the region has only 27 active coronavirus (COVID-19) cases with a daily seven cases. (LIZBETH ANN A. ABELLA)

DTI finds 'substandard' products in Eastern Visayas

TACLOBAN CITY The Department of Trade and Industry (DTI) has confiscated some P1.5 million worth of products for non-compliance alleged with the country's product standards.

DTI Assistant Secretary for Consumer Protection Group Ronnel Abrenica said on Friday(March 25) that during the four-day monitoring in the region's five provinces, they found violations in 40 out of 58 stores visited by inspectors.

"We will issue a notice of violation. We will evaluate their liability. If we found out that there is a probable cause, formal charges will be adjudicated at our main office," Abrenica told reporters.

From March 14 to 18, the trade department conducted monitoring activities in the provinces of Leyte, Southern Leyte, Biliran, Samar, Northern Samar, and Ormoc and Tacloban cities.

The biggest confiscation was in Catarman, Northern Samar where the team found 600 pieces of alleged substandard steel products worth P400,000.

Other than steel products, DTI also confiscated washing machines, plastic

Diarrhea down Catbalogan City villagers; contaminated water suspected as possible cause

TACLOBAN CITY- At least 20 individuals, some of them were children, were brought to the provincial hospital in Catbalogan City, Samar as they were suspected to have suffered diarrhea.

A report from the City Health Office (CHO) of the Catbalogan city government, said that the affected individuals were residents of Barangays Silanga and Maulong.

It was learned that most of the residents of these villages have spring and a well as their sources of drinking water.

The CHO said that they have already got water samples from these affected villages for testing as they distributed some medicines like hyposols to help prevent the further spread of the disease in Silanga and Maulong, which has a combined population of more than 8,900 residents.

The affected residents were said to have experienced vomiting and frequency of loose bowel movements. They were all confined at the Samar Provincial Hospital based in Catbalogan City.


The diarrhea cases in the villages were first reported to have occurred last Saturday, the CHO said.

NPA ranking member killed in an encounter in Northern Samar

CATARMAN, Northern Samar-An alleged ranking member of the New People's Army (NPA) was killed in an encounter in Catubig town, this province, last Friday (March 25).

While responding to information provided by the local residents, who were said to be fed up with the continuous and deliberate extortion activities of the rebels in their barangay, the soldiers belonging to the 20th Infantry Battalion, encountered a group of 10 rebels at around 8:55 am in Barangay San Francisco, Catubig town.

Meanwhile, at around 10:20 am, soldiers engaged in another exchange of fire with the rebels in Brgy. Calingnan which resulted in the seizure of one M16 rifle, four M16 long magazines, 98 rounds of M16 ammunition, and one bandolier.

Later at around 1:30 pm, the soldiers while conducting hot pursuit operation engaged anew the same group in a five-minute firefight that transpired in the hinterland of Brgy. San Francisco.

Gomez appeals to voters to elect those who will protect, advance their interests

TACLOBAN CITY-Ormoc City Mayor Richard Gomez urged voters to elect those they think will advance their interests and promote their welfare.

Gomez made this comment as he started to barnstorm areas within the coverage of Leyte's fourth congressional on his bid to become the district's representative at the House of Representatives.





"IT is the sabbath, and it is not lawful for you to carry your mat." (Jn 5,10) So said some Jews to a a sick man cured by Christ. This kind of accusation was common in the times of Christ and a reflection of the general mindset of the Jews then whose understanding of the law was still to be purified and perfected.

We need to understand that our laws, both in the civil and especially in the ecclesiastical sphere, should be animated by the spirit of God who knows all things and keeps everything in its proper order. We should not just make our laws, interpret and apply them to specific cases by basing them only on our own estimation of things, inspired only by some cultural, historical, political, social, economic or some ideological ethos.

We need to realize that it is Christ who ultimately gives the real meaning and purpose of our laws. It should be God, his laws and ways that should animate the way we make laws as well as the way we apply and live them. After all, being the Creator of all things, he is the one who establishes what is truly good and evil.

And the will, laws and ways of God are revealed to us in full by Christ. That is why at one point Christ said to the Pharisees and scribes regarding the proper interpretation of the Sabbath law that "the Sabbath was made for man, not man for the Sabbath. So the Son of Man (Christ) is Lord even of the Sabbath." (Mk 2,27-28)

So it is Christ who can guide us as to the content and intent of our laws. He is the one who can interpret our laws properly. He is the one that would give our laws their proper spirit, which in the end is the spirit of charity that summarizes and perfects all virtues and values.

Without Christ, our laws would unavoidably become rigid and harsh in certain instances. They would tend to absolutize certain things that actually should only have relative value. They would hardly recognize their limits, and so would find it hard to accept exceptions.

Without Christ, our laws would only lead us to the path of self-righteousness that will always be accompanied by the ways of hypocrisy. They can tend to rationalize things that actually are against God's laws and our own objective good.

We have to understand that our human laws are meant to lead us to our ultimate goal which is none other than to be with God, to be holy as God is holy, etc. Irrespective of their immediate temporal purpose, our laws should lead us little by little to become God's image and likeness as we are meant to be. They in the end should serve the fundamental religious purpose of our life. That should always be the constant purpose of our laws.

All the other objectives of our laws, let alone their technical requirements, serve only as an occasion, a reason or motive for this ultimate purpose. U.S. provides waste collection vehicles to improve Puerto **Princesa City waste management**

Puerto Princesa City-On March 24, the United States government, through the U.S. Agency for International Development's (USAID) Clean Cities, Blue Ocean program, donated eight waste collection vehicles to increase the capacity and efficiency of "Eco Warrior" waste collectors from Barangay Bancao-Bancao, Puerto Princesa City, Palawan.

These vehicles, which include five bicycles, two motorcycles with sidecars, and one four-wheel multicab, were provided through the program's grant to the Philippine organization Project Zacchaeus, which seeks to address ocean plastic pollution and the critical needs of those working in the informal waste and recycling sectors.

"USAID strongly believes that partnerships, community engagement, and customized solutions are important for the success of our development projects," said U.S. Embassy in the Philippines Chargé d'Affaires ad interim Heather Variava. "We are pleased to turn over these vehicles to the Eco Warriors, who have emerged as local leaders in sustainability and waste management, as we work together in curbing ocean plastic pollution and building sustainable circular economies."

The waste collection vehicles were received by USAID grantee Project Zacchaeus Marketing Cooperative (PZC) founder John Gastanes and Eco Warriors president Lydia Casiano. The vehicles will expand the Eco Warriors' previous collection capacity and provide enhanced waste services to an estimated 3,000 households in Puerto Princesa.

"We are very grateful to USAID for providing our Eco Warriors with these vehicles," said Bancao-Bancao barangay captain Gayjun Dangan. "Truly, these will help improve our city's waste collection system and increase the income of our Eco Warriors."

Coined by Project Zacchaeus, Eco Warrior refers to the informal waste

"My parents and my siblings and my own family motivated me to take the examination again and again until I could pass it. They never gave up on me.Of course, there were times that I'd like to give up. In fact, there were times that I isolated myself from my classmates who are now teachers," she said.


"But God is so good that finally, after 11 years and 14 times of trying, and fervent of praying and novena, I was able to pass it. I cried so much. I could not believe it at first," she said.

Gonzales said that she would like to teach at the Somoroy Agro-Industrial School, located at the town proper of Palapag and where she finished her high school.

She is optimistic that aside from helping her parents and her three siblings that are still in school, she could also help her husband, Michael,38 who works as a laborer, and their six children could have a bright and comfortable future.
