spawned by tropical depression 'Agaton', hundreds of thousands of people trooped to attend the grand rally of presidential aspirant, former senator Ferdinand 'Bongbong' Marcos, Jr. here in the city last Saturday (April 9).

Marcos, in his speech before the mammoth rally, said that he was overwhelmed by the big turnout of his supporters, who many came from other parts of Leyte unmindful of the inclement weather.

By far, the Saturday political rally of Marcos is considered to be the biggest ever witnessed in the region as organizers of the rally, held at the Leyte Sports Complex, said that 210,000

people attended the event. Police, however, put the crowd at 150,000.

He also mentioned his mother, former first lady Imelda Marcos who is from Leyte, of her strong desire to come to the province but he advised her not to due to the continuing threat of coronavirus disease (COVID-19).

The presidential aspirant said that his mother was following the political rally in this city as it was being streamed live through social media.

The Leyte sortie of Marcos also resulted in the formal declaration of former Energy secretary Carlos Jericho Petilla of the clan's support on his presidential bid.

Petilla is running for governor of the province which has 1.3 million registered voters based on the records of the Commission on Elections.

Petilla made his declaration during a rally of Marcos and his Uni-Team in Baybay City attended by provincial officials led by his brother, outgoing Gov. Leopoldo Dominico Petilla, and his cousin, Baybay Mayor Jose Carlos Cari and son, Rep. Nicholas Cari.

The crowd who attended the said rally reached to about 60,000, organizers said.

The support of the powerful Petilla clan was acknowledged by Marcos saying the support meant that there is now unity among Leyte leaders.

The Petillas are considered to be political rivals of the Romualdezes, cousin of the presidential aspirant. During the said rally, Leyte Rep. Ferdinand Martin Romualdez was seen seated next to Gov. Petilla.

In a rare moment, Leyte's most dominant political clans were seen in the same political stage due to their common support of Marcos.

Aside from Baybay, Marcos and his team also held their rally in Ormoc City where they were welcomed and endorsed by Leyte Rep. Lucy Torres Gomez and her husband, Ormoc City Mayor Richard Gomez before the more than 20,000 supporters.

In his speech at

Marcos' son, William Vincent, joined him in the rally.

According to the organizers, the said Tacloban rally draw around 200,000 people with the police saying the event was attended by 150,000 who came despite of the threat of Agaton.

The crowd prior to the main event was entertained by singers and performers.

Among the senatoriables in the lineup of the Uniteam were lawyer Larry Gadon, former presidential spokesperson Harry Roque, Senators Sherwin Gatchalian and Miguel Zubiri, former Public Works Sec. Mark Villar, former senator Jinggoy Estrada, former Quezon City mayor Herbert Bautista and actor Robin Padilla.

The rally was capped with a fireworks display that lasted more than 10 minutes.

His Maasin City sortie, however, was canceled due to bad weather. Marcos earlier visited the Samar Island seeking their votes on his desire to become the country's next president.

Goma monitors situation in Ormoc City amid the threat of 'Agaton'

TACLOBAN CITY- The city government of Ormoc, headed by Mayor Richard Gomez, has been monitoring the bad weather conditions caused by tropical depression 'Agaton' since Saturday.

The local government unit has learned its lessons well since super typhoon 'Yolanda' pummeled the city almost nine years ago, Gomez said.

The city mayor added that the city has gone a long way from the distraught district that it was hit by Yolanda which submerged most parts of Visayas and left hundreds of people dead, wounded and homeless in November 2013.

The mayor has been up with since the typhoon signal warning has been raised in their city with the personnel from the department involved with disaster risk management.

Gomez, who is running as a representative of the fourth district of Leyte, said the metropolis has crept slowly out of the slump and is now a thriving and progressive city on the west coast of Leyte, an inspiring example to its neighbor municipalities that a beautiful relationship between an elected leader and his or her constituents would jumpstart economic recovery.

Ormoc development could be attributed to the good relationship between its leaders and people, says Goma

TACLOBAN CITY-As he is to bow out as mayor of Ormoc, Mayor Richard Gomez said that the city has now grown into one of the most developed urban centers in the country.

And whatever development the city of more than 230,000 inhabitants is experiencing could be attributed to the good relationship between its leaders and constituents, Gomez said.

"Unti-unti na pong nagbubunga ang ating mga sakripisyo at paghihirap. Sa ating paghahawak-kamay ay sama-sama nating napaganda muli ang Ormoc City," he said.

"Our city is showing so much promise not just as a model city of infrastructure but as a safe haven, green thumb, social service-oriented or emergency/disaster management archetype as well in the nearest future," Gomez added.

According to Gomez, since he took over the reins at the City Hall of Ormoc, the city has 'crept slowly out of the slump' and has become a progressive urban center on Leyte's west coast.

Gomez, who is running as a congressman in Leyte's fourth congressional district in the forthcoming May 9 elections, said that whatever development Ormoc has gained could be replicated in the district if there will be a harmonious and good relation between its leaders and constituents.

He stressed that development is easy to achieve if there if both leaders and people have a good relation.

Gomez added that if he will become a congressman of the fourth district, he will push for the approval of infrastructure projects to further boost local economic recovery and provide jobs to people who have lost

their sources of income in the aftermath of the pandemic caused by coronavirus disease (COVID-19).

He also promised to develop sports programs for the youth and press for the recognition of Leyte as a tourist hub for sports and recreational activities, push for the rebuilding of old infrastructure, stop illegal drugs, and other activities.

Baybay City the hard-hit area "Agaton' lashes EV; houses buried in a landslide TACLOBAN

CITY-Eastern Visayas has felt the fury of tropical depression 'Agaton' on Sunday (April 10) with several landslide and flooding incidents affecting many areas.

The weather disturbance, according to the reports from the regional office of the Office of Civil Defense (OCD), has displaced 15,120 families comprising 66,485 persons from the provinces of Leyte, Eastern Samar, and Southern Leyte.

The city of Baybay appeared to have been hard hit by Agaton as multiple landslide incidents were reported coupled with the rising of water due to the rainwater dumped by the typhoon.

As of afternoon on Monday, 14 people were confirmed to have died due to the landslide incidents.

Seven houses were cov-

ered by boulders and mud due to landslide incidents.

In Barangay Can-ipa, victims Delfin Moraga; Carmencita Moraga; Michelle Rulona; Raymart Rulona; and Rey Mitchelle Rulona were trapped inside their house after their house was hit by a landslide.

In Brgy. Bunga, six fami-20 members, whose identities have yet to be known, were also trapped inside their houses. As of noon, two of them were recovered alive though they sustained minor injuries.

Retrieval operations are now ongoing in the affected villages to recover the victims though they could not go on full blast amid heavy rains, sources said.

A report that a son of the president of the Visayas State University, also in

Baybay City, was reported missing who was last seen at a beach in Brgy. Guadalupe last Sunday afternoon.

Aside from Can-ipa and Bunga, landslide incidents were also reported in the villages of Gacat, Mailhi, Kantagnos, Bubon, Villa, and Amguhan.

Mark Unlu-cay, city lies consisting of more than federation president of the Sangguniang Kabataan who sits at the city council as an ex-officio member, said that the several flooding and landslide incidents that hit in Baybay City due to Agaton were its 'worst.'

The extent of damage sustained by Baybay could warrant for the city to be placed under a state of calamity, he added.

Unlu-cay, however, could not say yet the extent of damage in the city as concerned offices like its



city disaster risk reduction management office and city social welfare office have yet to come up with their final reports.

He hopes that national agencies will help the city in the aftermath of the disaster.

In Abuyog town, also in Leyte, several of its barangays were also rendered flooded due to Agaton. Of the 63 villages of the towns,

36 were flooded of which Bito, Buntay, and Loyonsawang, which are located in the town proper with a combined population of more than 5,000 among the hard-hit.

The tropical depression compelled local government units in areas hit by Agaton to cancel works and classes on Monday to ensure the safety of the workers and students attending the in-person classes.

Storms strike back

till fresh from the destructive Typhoon Odette, Southern Leyte was again battered by another tropical storm named Agaton, bringing with it heavy rainfall that had caused flooding in low-lying areas, including the town of Abuyog.

This typhoon may not have impacted with strong winds as the super typhoons did, but the rains it had poured along its paths and the affected areas are equally devastating, especially to agricultural crops and infrastructures. We usually gauge typhoons based on their strength or speed, but we seldom take their accompanying downpours to account, hence our assessment of this present storm disturbance as something negligible.

As a result of prolonged rains, floods occur, and with them is the likelihood of landslides. As of this writing, in fact, some families in the affected paths have been feared buried in the mudslides. Rescue and retrieval operations are underway, but these are usually too late as far as saving lives is concerned. The rescue efforts normally end up as retrieval operations as the victims are already gone.

Whether the destructions are brought about by strong winds or flooding, the needs of survivors are normally the same, though rescuing them from harm may entail different tools and equipment. In case of flooding, water boats and heavy equipment may be needed. If the disaster-response teams in a given locality do not have these, rescue efforts are delayed and hampered until they're at times too late.

But the most immediate needs of survivors are, as usual, food, water, clothing, and shelter. For sure, affected residents are right now in need of these, hence the necessity to come to their aid to ease their sufferings. Concerned agencies should attend to their needs regardless of their political views and support.



Impressive tourist spots

I've had chances of going to different tourist destinations in the country, from Luzon, Visayas, and down to Mindanao, but I could only recall a handful that had really impressed me—the Underground River of Puerto Princesa, the El Nido, Vigan City, Mayon volcano, and the Chocolate Hills of Bohol.

Mine is just to tell the truth, to challenge the people in the tourism industry to do the necessary improvements and perhaps rehabilitation of the age-old tourist attractions that had been worn out by the passage of time, by the destructive interventions of people.

That I mentioned a few is my way of recommending them to both local and international tourists. As far as I'm concerned, these places are yet intact and presentable unless, again, human interventions will ruin them. I have reasons to say they awed me that much, leaving me in a sense of astonishment.

Let me start with El Nido. Wow, it's a world-class natural attraction. The series of islands towering above the crystal-clear seawater provides the visitors with spots for hopping, relaxation, and

adventures. swimming Beaches are rather limited for the many tourists visiting there, but the rock formations scattered around are the best options to hang out. You can swim in the clear waters as much as you want, and at the same time view the seabed with all the beautiful fishes and multi-colored rocks on it. The rock formations carved on the rocky islands, and mixed with stunted trees on them, are spectacular to behold, more so if birds of various types swarm around them.

One source defines virtue signaling as "the action or practice of publicly expressing opinions or sentiments intended to demonstrate one's good character or the moral correctness of one's position on a particular issue." This is meant, of course, to undercut others who differ or contradict their views.

Another source puts it as "a pejorative neologism for the conspicuous and disingenuous expression of moral values with the intent to enhance one's own image." Still another source describes it as taking "a conspicuous but essentially useless action ostensibly to support a good cause but actually to show off how much more moral one is than everybody else." We should try our best to stay away from virtue signaling.

But even more important than avoiding the vice of virtue signaling is the duty to be most honest in our temporal affairs, especially those involving money and other sources of powers. We have to practice a certain kind of detachment to see to it that our heart is not corrupted by them but is made pure and whole for loving God and everybody else.

This virtue of detachment would definitely require us to have purity of intention and to be most transparent in our transactions and eager to practice total accountability before God and also before everybody else. Without this virtue of detachment, there is no way we can keep ourselves uncorrupted, and that's when we can be pres-



Meat trader files P4.5 billion share sale with SEC

One of the Philippines largest pork and beef traders has filed P4.5 billion share sale with the Security and Exchange Commission (SEC) a registration statement for an initial public offering.

The North Star Meat Merchants Inc.,(NSMMI) said "it would offer (starting June 2022), up to 392 million common shares plus up to 58 million secondary common shares at a price of up to P10 each." NSMMI expects to raise up to 3.5 billion to be used for 1) capital expenditures to expand its cold chain infrastructure, 2) increase working capital primarily to lower cost, and 3) to expand the company's product lines.

Based on the initial report obtained from the OCD, of the 15,120 families affected by Agaton, 14,809 families or 65,970 persons were from Eastern Samar; 251 families consisting of 1,274 individuals were from Leyte; and 60 families involving 241 persons were from Southern Leyte.

The Coast Guard also reported that 552 passengers were stranded in the various ports in Southern Levte and Northern Samar provinces.

In the three ports of Sta. Clara, Dapdap, and Balwhartico, all in Allen, Northern Samar, 129 passengers were stranded while 423 passengers were also stranded in the ports of Liloan and San Ricardo, both in Southern Leyte.
