TACLOBAN CITY- For Alex Toongo, Barangay Kantagnos will now just be a part of his life, albeit a harrowing one.

Kantagnos, a farming village with more than 600 residents around 15 kms away from the city proper of Baybay, has been deemed to be not fit for occupancy after it was hit by deadly landslides on April 10.

A top geologist from the regional office of the Bureau of Mines and Geosciences (MGB) said that they have recommended and considered Kantagnos too hazardous for a community to live in.

"I have no intention to return there in Kantagnos. I am afraid what happened to us on that day will happen again as there

are cracks seen at Mt. Mastalisik," Toongo, a village councilor, said.

The heavy volume of mud, rocks, and fallen trees that cascaded down to the houses were from Mt. Mastalisik.

He, however, felt grateful that his family-his wife, and three children- managed to survive the two landslide incidents in the village- the first happened at around 5 am and the second incident almost two hours later.

"We were able to survive on the first landslide incident by going up to a higher ground and exited to the next village of Ambacan," see Authorities /page 7...

Comelec to construct makeshift polling centers hit by landslides and typhoon 'Odette'

TACLOBAN CITY-The regional Commission Leyte. on Elections (Comelec) has assured voters in landslide-hit areas and those recently hit by typhoon 'Odette' could still exercise their right to vote relative to the May 9 elections.

Lawyer Felicisimo Embalsado, the assistant director of the Comelec, said makeshifts will be constructed in areas where affected voters could vote.

1.5K NPA fighters in Region 8 *'return to the fold' in 3 years*

TACLOBAN CITY - At least 1,505 regular members of the New People's Army (NPA) surrendered to the government as of the end of March 2022, a clear indication the communist terrorist group is weakening, an official of the National Intelligence Coordination Agency (NICA) said.

Of the number, 57 of them yielded in 2019 and 415 turned themselves in a year after. Most of them or 1,007 surrendered in 2021 while 26 fighters abandoned the NPA just this year.

NICA Eastern Visayas Regional Director Eustacio Bacabac said many regular NPA members have surrendered through the government's whole-of-nation approach in the past three years.

"They have been weakening since 2019. Many of them surrendered after they realized that it is a senseless struggle. Others also abandoned the NPA through persuasions by those who already surrendered," Bacabac said.

The reduced influence of their organization in other

NICA also reported that 70 members of the terrorist group were killed in clashes with government forces while 54 were captured in operations in more than two years.

"In the last three months, two key NPA central committee personalities were captured in Samar and Northern Samar. The government learned about their presence through information from former NPA members. They have been hiding in Samar because they thought that they are safe here, but they are wrong since the environment is already different," Bacabac added.

Likewise, some 6,222 mass supporters abandoned the communist ideology while 539 members of Batakang Organisasyon sa Partido (BOP) left the communist terrorist group.

members BOP are used by the NPA in intelligence-gathering activities.

The weakening of NPA in Eastern Visayas is a result of a whole-of-nation approach by linking arms between basic service providers from the central government, community participation groups from the local governments, and the security sector from the military and police.

In support of the fight against NPA, several local government units have formed their task force to End Local Communist Armed Conflict (ELCAC) operationalizing Executive Order 70 issued by President Rodrigo Duterte on Dec. 4, 2018.

The directive also institutionalizes a "wholeof-nation approach" to attaining an inclusive and sustainable peace.

Abuyog mayor expresses gratitude for aid in the aftermath of a deadly landslide incident



ABUYOG, Leyte- Mayor Lemuel Gin Traya of this town has expressed his gratitude to agencies and private groups which extended assistance to them in the wake of a landslide incident that severely hit one of its villages.

Among the local government units include the provincial government of Samar which sent a medical team composed of 20 doctors and nurses from the provincial health office and the provincial disaster

risk reduction and management office.

"Thank Goveryou (Michael nor Reynolds) Tan for sending your people to Abuyog, and also to my fellow mayors," Traya said.

At least 1, 012 individuals were affected by landslides that happened in three villages of the town. The most affected residents were from Barangay Pilar, a coastal community that was 95% destroyed due to the landslide.

The local government unit of Silago also helped Abuyog in the conduct of search and retrieval operations augmenting personnel from the Philippine Army, Bureau of Fire Protection, Philippine Coast Guard, and

MGB conducts geohazard assessment in Baybay City in the aftermath of deadly landslide incidents

TACLOBAN CITY Teams from the Mines and Geosciences Bureau (MGB) are now conducting their geohazard assessment in Baybay City in the wake of a series of landslide incidents that hit the city which resulted in the deaths of multiple villagers.

On Wednesday (April 20), six families from Sitio Pamotosan of Barangay Makinhas were forcibly evacuated after cracks were observed in the village, an indication that a possible landslide may hit the village.

The MGB is in Baybay City to conduct geohazard assessment in landslide affected areas as well on its upland villages.

The MGB is assisted by the City Environment and Natural Resources Office (CITY ENRO), City Planning and Development Office (CPDO), and the Department of Geodetic Engineering of the Visayas State University (VSU).

OIC-City Environment and Natural Resources Officer Engr. Gretel Cabrito, who heads the city's environment and natural resources office, advised village officials for them to be included in the geohazard assessment so that their areas will be included in the Rapid Disaster and Needs Assessment (RDANA) Report and be submitted to City Disaster Risk Reduction and Management Officer (CDRMMO).

Cabrito said that it is better for those who will request for geohazard assessment to include pictures of cracks in their village as the basis for geologists in prioritizing in their assessment.

Cabrito also asked residents living in areas with visible cracks to immediately evacuate to safer grounds to avoid an untoward incident. The landslide incidents

in the city have resulted in the deaths of 127 people with 62 still missing.

The landslide incidents came in the wake of tropical depression 'Agaton' that hit Baybay City last April 10.

Philippine National Police. Traya said that personnel who are helping the local government unit in responding to the victims, particularly in the conduct of search and retrieval operations, had already been reduced as recommended by the Office of Civil Defense.

At least 48 bodies from Brgy. Pilar had been retrieved while 55 are still missing.

As the retrieval operations been stopped **Priest proposes memorial to** landslide-buried Pilar village

TACLOBAN CITY- A priest has called on authorities in Abuyog, Leyte to 'respect' a village hit by a massive landslide considering that there could still be people entombed.

The call of Fr. Amadeo Alvero of the Palo Archdiocese who is also from the town, came about as the local government has decided to stop the retrieval operation in Barangay Pilar on Wednesday (April 20), 10 days after it was hit by the deadly landslide.

The landslide incident in Pilar killed 54 individuals of which 101 are still considered as missing, local authorities said.

The decision to stop the retrieval operation was based on the grounds of the 'geological hazard and health risk' that may face the rescuers.

The local government, under Mayor Lemuel Gin Traya, earlier said that he would declare the area as not fit for human occupancy as he vowed to relocate the affected villagers.

"If the operations would bring more dangers to the rescuers, then

it would be right to end the operation as it might bring more casualties than we already have," Alvero said.

"Let us then make sure to let the place be respected because surely there are still a lot of dead bodies under the mud. These dead bodies are sacred. And we continue to pray for the eternal repose of those buried there by the landslide," he added.

The priest said that Pilar must be secured so people may not loiter there as he suggested to make the abandoned village a memorial to pay respects to the people who died.

Meantime, in Baybay City, where multiple landslides hit more than 10 of its villages, the Sangguniang Kabataan in the city has initiated psycho-social intervention activities among children who were affected by the tragedy.

Mark Unlu-cay, city SK federation president, said that since last week, they have visited evacuation centers where these children and their parents and guardians are temporarily housed, to provide them a 'relief' after their harrowing experiences.

During the activity, they provide a 'fun-filled' activity like giving entertainment to the children through the mascots they bring along and giving foods and stuff toys to them.

"The children are still in trauma. In fact, during plays, some would tag along with their mothers as if they are afraid to get separated from them," Unlu-cay said.

"This is our own way of providing relief to the children. And we are happy to see their happy faces. At least they tend to forget, even only

during the event, of the trauma and pain caused by the incident," he added.

Unlu-cay, however, could not say as to how many children in the city were affected by the tragedy with some children were even rendered orphans.

The activity of the SK federation is in partnership with the Department of Social Welfare and Development.



Rallies to blame



hile the various political camps in the country are preoccupied with the "necessity" of supplying their respective candidates with huge numbers of people in the grand rallies being held in various towns and cit-

ies, the World Health Organization sees a different scenario, and that's the resurgence of COVID-19 cases.

It can be recalled that towards the end 2021, the number of new cases in the country was getting smaller, or at least showing such a trend. But after the twin celebrations of Christmas and New Year when people frequented public places and congregated there in big numbers instead of staying at home and observing social distancing, the number of new cases soared high again.

It was a good thing that, by the grace of the Almighty, those high cases went down from tens of thousands to just a few hundred by the month of March. The government of course attributes this significant decrease to the vaccination activities nationwide. But in this so-called political season

The rally organizers first, and then the participants themselves are to blame for acting and behaving as though there is no more virus that spreads around. Just as other countries are experiencing this renewed virus surge, we are likely to have it next when the elections are over.



Why those votes

If Filipino voters will just be honest enough, there are actually many reasons why they vote for certain candidates during elections. It is for this reason that winners can never say they have earned the people's trust, hence their victory. Because in reality, those reasons abound.

The most common reason for voting for a candidate is personal connection or relationship. Under this, a voter casts his vote

for somebody because this transaction, that is-vote candidate happens to be his acquaintance, a friend, a relative, a former classmate, campaign managers in a childhood playmate, a order to buy the people's neighbor, a friend of one's sibling, or a workmate of one's relative, etc. There is some kind of connection between him and the candidate such as their sharing of the same hometown, ethnic group, occupation, or religion. In fact, it is this idea of "connection" or "relationship" that candidates try to exploit during campaign sorties because once this connection is established, it could translate to votes.

Another very common reason for voting for a candidate is a monetary

buying/selling. A candidate releases funds to his votes. Supposedly, this is against election laws, but still, it is rampantly done especially at the local level. In hotly-contested areas, the amounts are too big, and hard-up families could not help but accept the offer as it could mean food on the table for the hungry household members. Also, the uncertainty of hog feed demand is due to the ongoing African swine fever (ASF). Local feed mills are experimenting on replacing wheat with barley due to the rising wheat prices.

Further, USDA estimates the total consumption of wheat is projected to reach 9 million MT in the next market year or an increase by 800,000 MT compared to 2021. Meanwhile corn feed seed and industrial (FSI) consumption is forecast to reach 2.1 million MT.

His family, together with other residents of the village who survived the onslaught, are temporarily housed at the Baybay City Senior High School which was visited by Pres. Rodrigo Duterte last Good Friday (April 15).

The MGB, speaking through its chief geologist Celestina Caranza, said that they have recommended to the city government of Baybay to condemn Kantagos as possible similar incidents may happen again.

Caranza said that the village is among the 87 percent areas of Baybay which have been classified to be moderate to high risk of landslide. The city, which is generally mountainous, has 92 barangays.

"Our recommendation is not to allow the community to reside there because it is now too hazardous. (In fact) our recommendation is for all areas classified to be high risk, even moderate, to a landslide for the city government hindi na pwede tirhan," she said.

"If ever na babalik sila, they should be vigilant on their environment and be observant of cracks and tilting of trees (which are indications of possible landslide)," Caranza added.

She said that the city

with us, to intervene in our life, to govern and lead us to himself.

(Ps 63,1) government should try to 'revisit' its CLUP or comprehensive land use plan to avoid similar incidents and settle villagers away from natural calamities.

Caranza said that the landslide incidents in Kantagnos, considered to be the worst-hit area due to tropical depression 'Agaton' were water-induced due to the sheer big volume of rainwater it dumped.

The Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa) office in Tacloban said that based on their monitoring of the volume of rain experienced by Baybay City prior to Agaton's fury on April 10 was comparatively higher than its monthly average of 131.2 ml.

Mario Peñaranda, Pagasa station chief, said that on that day, the rainfall was registered at 536.2 ml and a day before (April 9), at 173.2 ml.

In fact, he said, from April 1 to 12, when continuous rains were experienced by the city, its rainfall was recorded at 1,081.7 ml.

"It is so way above from its average monthly rainfall. So we can really say that the landslide incidents there in Baybay were water-induced," Peñaranda said.

But for Pacencia Milan, a known environmentalist based in Baybay City, the landslide incidents in the city, affecting over 10 barangays, could also be attributed to almost lack of vegetation which resulted for rainwater to easily topple trees.

Milan, also a former president of the Visayas State University, disclosed that in Kantagnos, illegal poaching has been reported to exist.

"There was continuous rain for three to four days, and there were not enough trees to hold (the rain) water reason why water and other vegetation pushed the houses down," she said.

The Anti-Terrorism Council also formally designated the National Demstatement of Milan on the existence of logging activity in their village.

"There was a concessionaire there. I even worked there as a heavy equipment operator. In fact, one of its backhoes was used in the clearing operation," he said.

He, however, declined to provide more details on this bit of information.

Milan said that she hopes that what happened will serve as a 'wake-up call' for the city government, in particular.

"I hope this will serve as a wake-up call for the local government. Hope they will be conscious of replenishing the trees. There is no forest restoration here in Baybay," she said, amid its various ongoing infrastructures like roads and highways.

For Jose Cala, another local environmentalist, the city government should come up with a multi-sectoral forest protection committee to help preserve the city's vegetation and in the process, could lead to at least minimal impact of future landslide or even flooding incidents.

"Illegal loggers wantonly cut trees leaving only shrubs and trees which could not hold big volume of trees," he said, adding that what happened last week was kind of waiting to happen.

Meantime, it was learned that Mayor Jose Cari is also considering of declaring Kantagnos a 'no man's land' as he asked the MGB to make an assessment of other villages as well hit by the landslide incidents.

As of Friday morning, the city disaster risk reduction management office (CDRRMO) said that the death toll in Baybay now stands at 127 with Kantagnos posting the highest number of fatalities at 66 with 56 still missing.

The retrieval operation in the village will still continue based on the recommendation of the CDRR-MO.

MUNICIPAL ORDINANCE NO. 2018-02-072

AN ORDINANCE PROVIDING FOR THE TRAFFIC FLOW, RULES AND REGULATIONS IN THE MUNICIPALITY OF PALAPAG NORTHERN SAMAR AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

Author: Hon. Gregorio O. Balading

WHEREAS, the number of public utility conveyances and private motor vehicles plying the streets of Palapag has considerably increased thereby necessitating revisions of the existing traffic flow, rules and regulations;

WHEREAS, the municipality of Palapag is on process of establishing the Palapag Integrated Enterprises Terminal Complex (PIETCO) with the effect has centralized the loading, unloading and ticketing of passengers and cargo plying the routes from mainland barangays and other municipalities to PIETCO, as the convergent point and vice-versa;

WHEREAS, Section 447 (a) (5) (v) of Republic Act 7160 otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan shall "Regulate the use of streets, avenues alleys, sidewalks, bridges, parks and other public places xxx; establish bus and vehicles stops and terminal or regulate the use of the same privately owned vehicles which serve the public; regulate garage and the operation of conveyances for the hire xxx;

WHEREAS, pursuant to Executive Order No. 172, issued March 11, 2008 Department of Interior and Local Government (DILG) and Department of Transportation and Communication (DOTC) joint Memorandum Circular No. 01 series of 2008, dated September 10, 2008, provides for the guidelines in the review of Local Ordinance, Orders, Rules and Regulation grant of franchise to tricycle for hire, establishment of transport terminals, and issuance traffic citations tickets.

BE IT ENACTED by the Sangguniang Bayan in session duly assembled that:

ARTICLE I GENERAL PROVISIONS

SECTION 1. TITLE. This Ordinance shall be known by its title as An Ordinance Providing for the Traffic Flow, Rules and Regulations in the Municipality of Palapag, Northern Samar, and providing Penalties for Violations Thereof;

SECTION 2. SCOPE. This Ordinance shall cover all vehicles plying the national, provincial and municipal roads within the Municipality of Palapag, Northern Samar;

In case of tricycle-for-hire, they shall be allowed to use certain portions of the national highway considering the absence of alternative routes as provided under the pertinent provisions of the LTFRB's implementing Guidelines on the Devolution of Franchising Authority over Tricycle-for-hire to Local Government Units (LGU's).

SECTION 3. DEFINITION OF TERMS. The following terms shall be understood as they hereunder defined:

(a) **Tricycle-for-hire** is a motor vehicle composed of a motorcycle fitted with a single wheeled sidecar or a motorcycle with a two wheeled cab (known as a center cab) operated to render transport services to the general public for a fee.

(b) Single Motorcycle - also known as single, scooter or habal-habal, is a motorcycle operated to render transport service for a fee to interior barangays where there is no established road, or if not passable for three or four-wheeled vehicles.

No franchise shall be granted by the LGU to operate such. (c) **Mega taxi** - refers to a van operated to render transport service that convey passengers to Tacloban, Mapanas, Gamay, Lapinig and any other point of destination. terminal to terminal or on a door-to-door basis for a fee.

(d) **Franchise** - is a privilege to operate issued to a person, natural or judicial, allowing him/her to operate a tricycle-for-hire over routes specified therein;

(e) Zone - is a contiguous land area such as barangay or a municipality where a tricycle-for-hire may operate without a fixed origin and destination. (f) "Colorum" Operation - shall mean operation by any motor vehicle without

a certificate of public conveyance or franchise. (g) **Silencer** - is a gadget attached to the exhaust system of a motorcycle to

(h) **Professional Driver** - shall mean every and any driver hired or paid for driving or operating a status.

driving or operating a motor vehicle, whether for private or for hire to the public, with an appropriate professional driver's license. (i) **Out of Line Operation** - shall man operations the second

(i) Out of Line Operation - shall mean operations by any motor vehicle outside of its designated route as indicated in its franchise.
 (j) Owner - shall mean the actual legal owner of a motor vehicle, in whose

name such vehicle is duly registered with the Land Transportation Office (LTO). (k) **Classification** - refers to four (4) classifications of motor vehicles such as" 1. Private

2. For hire

3. Government

 Diplomatic

 (I) Delinquent Motor Vehicle - refers to a motor vehicle whose registration is overdue.

(m) **Highway** - shall mean every public thoroughfare, public boulevard, driveway, avenue, park, alley and callejon, but shall not include roadway upon ground owned by private person, college, universities or other similar institution.

(n) TVR - Traffic Violation Receipt (o) Terminal - either public or private, refers to any building or facility constructed or designated by the local government unit or by a private transport operator respectively, primarily for the purposes of loading and unloading passengers and cargoes by the different modes of public transportation and the necessary repair and maintenance to ensure public safety.

ARTICLE II PARKING PLACES

SECTION 4. Terminal

(a) All trips of public utility vehicles shall commence and terminate at the Palapag Integrated Enterprises Terminal Complex (PIETCO). Exemption to this rule are public utility vehicles, which by the nature of their

service, convey their passengers or cargos on a door-to-door basis, such as the case of Megataxi, poblacion tricycles, delivery trucks/vans and others.

(b) Terminal for tricycles for hire in the Barangays of Destination-there shall be established one (1) terminal for tricycles for hire for every barangay or barangay of destination for every route within the municipality of Palapag. The site and location thereof shall be approved by the Sangguniang Bayan in accordance with the existing zoning ordinance, upon the recommendation of the Barangay concerned

through a resolution to that effect

Where tricycle terminal already exist in a barangay or area, no other terminal may be established except in instances where due to substantial increase of population and for the convenience of the riding public, the Sangguniang Bayan finds it feasible to allow the establishment of other terminal.

ORDINANCE

SECTION 5. DESIGNATION OF PARKING PLACES. The designation of specific parking places at the Palapag Integrated Enterprise Terminal Complex (PIETCO) for tricycles, Jeeps, Megataxi, Buses and Delivery Trucks/Van and such other public utilities and private vehicles desiring to stay overnight shall be as provided by the office of the Mayor thru the PIETCO, subject to the approval by the Sangguniang Bayan;

SECTION 6. REGULATORY FEES AND TERMINAL FEES. The regulatory fees for tricycles, Jeep, Megataxi, Buses and Delivery Trucks/Vans shall be as provided by fees and rentals of booking and ticketing office thereon.

(a) <u>Traffic Flow for Pedicabs.</u> Pedicabs shall convey passengers and goods to their point of destinations.

(b) Traffic Flow Single Motorcycles. Single motorcycles shall park, load/unload passengers and goods and ply along routes and observe traffic flow as may be designated by the office of the Mayor upon recommendation of the Traffic Management Division.

ARTICLE III PHYSICAL REQUIREMENTS OF TRICYCLE

SECTION 7. PHYSICAL REQUIREMENTS OF TRICYCLE. No tricycle shall be allowed to operate and be issued Permanent Body Number unless the herein below applicable physical requirements are complied with;

(a) Clean windshield;

(b) Garbage receptacle

(c) Functional horn that does not emit exceptionally loud or startling sound;
 (d) Functional two signal lights, front and back for turning right or left or for emergency purpose;

(e) Functional tail light, including license plate light; (f) Top chain extending to the rear wheel;

(g) Functional white headlight in front and functional red tail at rear, visible at least 50 meters from the front and rear of the tricycle and functioning under all

weather conditions; (h) Functional light installed inside the sidecar and kept lighted while plying a designated route;

 (i) Functional anti-noise equipment;
 (j) Sticker containing the body number of the vehicle and placed prominently and identifiable from a distance;

(k) Fully operational mufflers (I) Roadworthiness of the tricycle

7.1 Physical Requirements of Pedicab: All operators of pedicabs shall be bound prior to the issuance of permit to the following requirements:

a. Functional horn

b. Make the pedicabs road worthy

c. Equip the pedicabs with flashlights during night time operation d. Garbage recentacle

e. Sticker containing the assigned registration number

ARTICLE IV OPERATIONS OF TRICYCLES FOR HIRE AND MOTOR VEHICLES FOR HIRE

SECTION 8. LOAD/CAPACITY LIMIT. No tricycle shall be allowed to carry more passengers and goods that what it is designed for, or more that what is authorized in the franchise.

SECTION 9. COLOR CODING FOR TRICYCLE. For purposes of identification and convenience of the riding public, and for purposes of traffic management there shall be assigned for every tricycle route one particular color which shall be the prescribed coating for every unit operating within the said route.

The assignment of color for tricycles routes shall be made by the office of the Mayor. Provided, that the routes which already have existing colors shall be given the option whether or not to change the same.

SECTION 10. APPROPRIATE ATTIRE - drivers of all Public Utility Vehicles shall wear appropriate attire and observe proper hygiene during their operation. He/She must wear at least T-shirt, long pants and shoes.

SECTION 11. TRAFFIC ROUTES. All streets and highway within the municipality are two-way streets except those that are declared otherwise by traffic authorities.

SECTION 12. ONE WAY STREET - The following is hereby declared one-way. 1. Justice Romualdez corner Gorgonia Sts. to Carpio St.

SECTION 13. NO LOADING AND UNLOADING ZONES. NO loading and unloading of goods or cargoes shall be done between 6:00 am to 9:00 pm along the national highway within the municipality of Palapag.

SECTION 14. PASSENGER SOLICITATION. Passenger solicitation thru pick-up passenger is hereby prohibited. Passenger solicitation by agents of transportation companies shall be at the blocking area of the Palapag Integrated Enterprise Terminal Complex (PIETCO).

SECTION 15. DISPATCHERS. Dispatchers shall be employed to manage the parking lines of every route. It shall be the responsibility of the drivers and operators association of every route to shoulder the compensation of the respective dispatchers. Dispatchers shall be required to pay a Permit Fee of ONE HUNDRED FIFTY PESOS (150.00) per annum and shall be issued to act such. Dispatchers shall be required to display their identification tags all time.

ARTICLE V PROHIBITED ACTS AND THEIR PENALTIES

Section 16. PROHIBITED ACTS AND THEIR CORRESPONDING PENALTIES. The following acts are hereby prohibited and shall be penalized as follows:

Putting up encroachment obstacle and illegal construction on streets and bridges are prohibited and must be removed when necessary in the interest of public welfare.

In addition to the abovementioned fines, an imprisonment of not less than three (3) days but not more than one (1) month may be imposed upon discretion of the Court, and subsidiary penalty for failure to pay fines not exceeding 15 days.

In apprehending the driver for the violation of this Ordinance, traffic enforces and/or police officers shall issue a Citation Ticket. This ticket shall authorize the driver to operate the vehicle for the period of not exceeding seventy two hours from the time and date of issue of said receipt. The period so fixed in the receipt shall not be extended, and it shall become invalid thereafter within 15 days from the date of apprehension shall cause the Palapag PNP to file appropriate complaint in Court against him/her.

For the purpose of reckoning the Seventy Two (72) hours period herein stated, Saturday, Sundays and non-working days shall be excluded.

The owner operator shall be solidary liable with his/her driver in the payment of penalty imposed.

SECTION 17. IMPOUNDING. More than two (2) violations of the above-enumerated prohibited acts shall cause the police or the deputized traffic enforcer to get hold of the subject motorcycle/vehicles and the same shall be brought to the designated impounding area, which shall be released only after complying with the necessary acts pertaining to his/her violations and after payment of the corresponding fines at the Treasurer's Office.

ARTICLE VI FINES

SECTION 18. ALLOCATIONS OF FINES. Funds derived from fines of violators shall be allocated in the following manner. Twenty percent (20%) of the fines collected shall be divided among the deputized traffic aids as their incentive. Deputized PNP personnel are not allowed to share with the said 20% as they are already receiving their regular salary. Eighty percent (80%) of the revenues/fines shall be used during the monitoring of said operation. The remaining balance of said 80% shall be put in Trust to the Municipal Treasurer.

ARTICLE VII ADMINISTRATION

SECTION 19. AUTHORITY TO HIRE TRAFFIC AIDS - The Municipal Mayor is hereby authorized to hire traffic aids as the need arises and depending upon the availability of funds.

SECTION 20. FUNCTION OF TRAFFIC AIDS - With proper order of the Municipal Mayor and in close coordination with the Chief of Police, the traffic aids shall assist the local PNP in the enforcement of traffic laws, rules and regulations and ordinances.

SECTION 21. LOCAL POLICEMEN AS TRAFFIC ENFORCERS- In the meantime that there are no traffic aids hired, the local policemen shall be the enforcers of the provisions fo this ordinance and all applicable laws, rules and regulations on the matter.

SECTION 22. AUTHORITY OF THE MUNICIPAL MAYOR TO ISSUE EXECUTIVE ORDER - The Municipal Mayor shall issue an Executive Order specifying the assignment and conduct of local policemen and the traffic aids in the enforcement of traffic, rules and regulations and ordinances.

SECTION 23. AUTHORITY TO ISSUE CITATION TICKETS - The traffic aids as assistants to the local PNP are hereby authorized to issue citation tickets to traffic violators in addition thereto, they shall also assist in the implementation and enforcement of the anti-littering, anti-illegal parking and other provisions of this ordinance, applicable laws and regulations whose violations take place in public roads, shoulders and others.

SECTION 24. AUTHORITY OF THE MUNICIPAL MAYOR TO CREATE LOCAL FRANCHISING AND REGULATORY BOARD - The Municipal Mayor shall be create local franchising and regulatory board which shall consist of the following:

ARTICLE VIII FINAL PROVISIONS

SECTION 25. APPLICABILITY CLAUSE - Provisions of such other laws and regulations as they pertain to the subject matters included in this ordinance that are applicable in the Municipality of Palapag are made integral parts hereof.

SECTION 26. SEPARABILITY CLAUSE. If for any reason, any provision, section or part of this Ordinance is declared unconstitutional or not valid by a Court of competent jurisdiction, or suspended or revoked by competent authority, such judgment shall not affect or impair the remaining provisions, sections or parts which shall continue to be in full force and effect.

SECTION 27. REPEALING CLAUSE. All Ordinance, Executive Orders and other issuances whose provisions are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 28. EFFECTIVITY. This Ordinance shall take effect upon completion of its posting and publication.

AN ORDINANCE REGULATING THE OPERATION OF MOTORIZED BANCAS WITHIN THE PALAPAG CHANNEL AND IN OTHER NAVIGABLE WATERS OF THE MUNICIPALITY OF PALAPAG, NORTHERN SAMAR

Author: Hon. Gregorio O. Balading

WHEREAS, with the influx of passengers making Palapag as the convergent point of the Pacific areas and other Municipalities, as amended Ordinance must be created to meet the needs of the changing times both for the bangkeros and the riding public as well;

WHEREAS, the clamor of passengers against exorbitant and excessive fees, overloading had not been heard and acted upon including theft of baggage's and luggage's of the commuters to the detriment of the public over the years, thus the need to amend said Ordinance;

WHEREAS, pursuant to the general welfare clauses as ambodied in Book 1, Title 1, Section 16 of Republic Act 7160, the Sangguniang Bayan shall adopt measures to protect the inhabitants of the Municipality;

NOW THEREFORE,

BET IT ORDAINED by the Sangguniang Bayan in session assembled that:

SECTION 1. The Ordinance shall be known as "AN ORDINANCE REGULATING THE OPERATION OF MOTORIZED BANCAS WITHIN THE PALAPAG CHANNEL AND IN OTHER NAVIGABLE WATERS OF THE MUNICIPALITY OF PALAPAG, NORTHERN SAMAR".

SECTION 2. Scope and Application. The Ordinance shall apply to all types of motorized bancas utilized in carrying or transporting persons or goods or both for profit, operating along the marginal wharf of the poblacion, Barangay Sumoroy, Barangay Pangpang, Barangay Manajao, Barangay Nagbobtac, Barangay Sinalaran and Barangay Jangtud and on different landing stage of our municipality en route to different endpoints.

SECTION 3. Definition of Terms. As used in this Ordinance, the following terms shall mean:

a. Carriers - a person engaged in the business of transporting passengers or goods or both for profit.

b. Bankeros - local term for persons manning the motorized bancas.

c. Motorized Bancas - a unit of sea transportation using motor supplied with gasoline or crude oil to operate.
 d. Marginal Wharf - an identified landing stage to which ships and motorized bancas can be moored for loading and unloading.

e. Barker - person authorized to solicit passengers and guide passengers safety.

SECTION 4. License. No person shall be allowed to operate a motorized banca without first securing a valid license from the office of the mayor and that renew the said license at the beginning of the ensuing year.

SECTION 5. Uniform. All carriers, bankeros and barkers of motorized bancas are required to use t-shirts designed for the purpose as uniform with their corresponding number at the front and back thereof with their respective identification cards both to be issued by the Mayor's Office.

SECTION 6. Signage. Each Unit of transportation shall be painted at the unit body with information bearing the following: Business Permit, Operators Name, Regular Fare, Fare for Special Hire or "Siret". Loading Capacity MDRRMO Hotline and Operators Cellphone Number.

SECTION 7. Rates of Fare. The following rates of fare are hereby imposed as follows:

SECTION 9. Loading Capacity. It shall be unlawful for all motorized bancas operating to and from the marginal wharf of Barangay Sumoroy, Manajao and Barangay Pangpang landing stage to carry more than ten (10) passengers at any given trip. In case of special hire or "serit" a maximum of three (3) passengers only shall be allowed. All other motorboats of similar nature operating within the jurisdiction of this municipality are likewise prohibited to carry/load more passengers and cargoes than what it is designed for.

SECTION 10. Unloading of passengers at designated Area - All motorized bancas shall unload passengers and cargoes only at designated area.

SECTION 11. No carriers or bankeros shall operate a motorboat or motorized banca while under the influence of alcohol or narcotic drugs. It shall be unlawful for carriers or bankeros or any other person to act as barker (solicit passengers). It is the responsibility of the barker for passenger's safety loading.

SECTION 12. Refusal to convey service to the public - No person operating a motorized banca for hire shall deny conveyance of passengers except, when such carrier/banker at appropriate time is going to eat his meal or retire for reasonable cause.

SECTION 13. "Turno" system - When waiting for passengers, all motorized bancas shall observe a "turno" system or as often as their association allows. Any motorboat operator could join the association and should strictly observe the association policies and barangay ordinances on motorized bancas operation.

SECTION 14. Administration. To guarantee that all provisions of this ordinance are properly implemented, the Municipal Mayor is here authorized to issue Executive Order for the creation of task force to this effect.

The office of the Mayor shall also provide a complaint desk with assigned personnel which oversee the dayto-day operation of the motorized bancas, receive complaints from commuters, conduct necessary investigations regarding the acts complained of, and shall regularly provide reports of their actions to file proper committee of the Sangguniang Bayan.

SECTION 15. Extraordinary Diligence - All operators of the motorized bancas shall be bound prior to the commencement of the voyage and during the voyage to exercise extraordinary diligence to:

- a. Make motorized banca seaworthy;
 b. Supply the motorized banca with gasoline needed for the daylong trips:
- c. Properly man the motorized banca by not allowing minors to operate the same;

d. Equip the motorboat with the necessary tools/gears such as, paddle or "bugsay", flashlights, life save device (salbabida), anchor (ankla), and movable bridge or "andamyo".

e. Deliver the passengers and cargoes safely to its destination.

SECTION 16. General Penal Provisions - any person who violate provision of this ordinance not herein otherwise covered by a specific penalty shall be punished by a fine of not less than Two Thousand Pesos (P2,000.00) nor more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than one (1) month nor more than six (6) months or both such fine and imprisonment at the discretion of the court.

SECTION 17. Specific Penal Provision. The following are the specific prohibited acts with its corresponding penalty to wit:

SECTION 18. Procedure upon Apprehension. Bankeros who will be caught on the act violating any provision of this ordinance, shall be brought to the police station and shall be meted the penalty pursuant to Section 15 of this ordinance.

SECTION 19. Failure to pay the corresponding penalty/fines within five (5) days upon apprehension, the unit shall be temporarily impounded until such time the fine is accomplished.

SECTION 20. Clearance. No renewal of license to operate motorized bancas shall be considered by the Treasurer's Office, unless a clearance is first secured from the Philippine Coast Guard.

SECTION 21. Separability Clause. If for any reason, any provision or part of this Ordinance is declared unconstitutional or not valid by a court of competent jurisdiction, or suspended by competent authority, such judgement shall not affect or impair the remaining provisions, sections or parts which shall continue to be in full force and effect.

SECTION 22. Repealing Clause. All Ordinance, Rules and Regulations, Executive Orders, Proclamation and Administrative Regulations or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 23. Effectivity. This Ordinance shall take effect within 15 days upon its approval.

"AN ORDINANCE REGULATING THE ISSUANCE OF AUXILLARY INVOICE AND PRESCRIBING THE FEES FOR THE TRANSSHIPMENT OF MARINE PRODUCTS FROM THE MUNICIPALITY OF PALAPAG, NORTHERN SAMAR PURSUANT TO REPUBLIC ACT NO. 10654 AS AMENDED"

Author: Hon. Pepito A. Laoreno

WHEREAS, it is the declared policy of the State to achieve food security as the overriding consideration in the utilization, management, development, conservation and protection of fishery resources in order to provide the food needs of the population. A flexible policy towards the attainment of food security shall be adopted in response to changes in demographic trends for fish, emerging trends in the trade of fish and other aquatic products in domestic and international markets, and the law of supply and demand;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Palapag, Northern Samar in regular session, that:

SECTION 1. Definition of Terms. The terms used in this Ordinance are hereby defined as follows: 1. **Transshipment** is the transfer of fishery product from one fishing vessel to another to be landed or unloaded at fish landing sites not accredited by the MFPOPAL or in broad terms the unloading of fishery products out of municipal fishery port.

2. **Auxiliary Invoice** is an issued document that contains itemized kind of fishery product subject for transshipment, its quantity, form, weight, value, fees and bill loading after a thorough and actual inspection and verification.

3. Auxiliary Receipt. A receipt issued by the MTO after weighing and inspection of the fishery products.

4. Auxiliary/Transport Permit Fee. A fee charged on fishery products subject for transshipment.
5. Inspection Permit Fees. A fee charged on the inspection and weighing of fishery products subject for transshipment, disposition or distribution by way of sale.

SECTION 2. Mandatory Landing, Unloading, Weighing and Inspection/Weighing Permit Fees of Fishing Products. All fishery products brought into the municipality of Palapag by the Carrier (Paragkawil) shall be landed, unloaded, weighed and inspected at wharf/seaport/seashore either in Barangay Sinalaran, Manajao, Pangpang, Monbon, Talolora, Mapno, Nipa, Binay, Maragano and Cabatuan and shall pay One Peso (1.00) per kilo to the Municipal Treasurer's Office or the authorized collector for the inspection and weighing of fish and other aquatic products before the disposition or distribution by way of sale.

SECTION 3. Auxiliary Invoice/Transport Fee. All fish and other fishery products must have an auxiliary invoice to be issued by the Municipality of Palapag through the Municipal Agriculture Office prior to their transport from this municipality to the point of destination upon payment of One Peso (1.00) per kilo by the Shipper (Nabalyo sa Paragkawil) to the Municipal Treasurer's Office or the authorized collector.

SECTION 4. Issuance and Exemptions. - The municipal government shall issue auxiliary invoices for the transport of fish and fishery products and provide a monthly summary thereof to the Provincial Fisheries Office, provided, that the auxiliary invoice shall be issued to culture pearls, products transported or unloaded by Philippine-registered fishing vessels, products caught or gathered in violation of this Code or declared as health hazard.

SECTION 5. Form of Auxiliary Invoice. The Auxiliary Invoice shall be substantially in the following form as part of this ordinance.

Municipal Treasurer's Office upon authorization by the Sangguniang Bayan shall deputize the Barangay (where landing, unloading, weighing and inspection of fishery products has been done) in the collection of payment and shall be remitted to the Municipal Treasurer's Office on or before the 5th day of the succeeding month.

SECTION 7. Penalty Clause. Any person responsible for the violation of any of the provisions of this ordinance, shall be prosecuted and be penalized by a fine of not less than One Thousand Pesos (P1,000.00) nor more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not less than one (1) month normore than six (6) months or both such fine and imprisonment in the discretion of the court.

SECTION 8. Separability Clause. If any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which is not affected thereby shall continue to be in full force and effect.

SECTION 9. Repealing Clause. Any ordinance or part thereof or any rules and regulations which are inconsistent with this ordinance are hereby repealed.

SECTION 10. Effectivity. This ordinance shall take effect upon its approval.

Eastern Samar DEO completes two flood control projects along Suribao River

BORONGAN CITY-The Department of Public Works and Highways -Eastern Samar District Engineering Office now completed two (2) flood control projects along Suribao River. The first one is situated in Brgy. San Gregorio, Borongan City with a length of 185 meter, amounting to Php 48,067,321.57. The second one is located in Brgy. Sabang Suribao, Borongan City with a length of 86 meter with total project cost amounting to Php 48,017,827.69.

District Engineer Ma. Margarita Junia said that the new flood control structures conform to the standard of DPWH and so the locals can now feel secured and safe because of the newly completed quality infrastructure.

Mrs. Benilda Baje, on one hand, a resident of Brgy. San Gregorio, Borongan City, said that the flood control is a big help for them. Before the construction of the flood control, the water from the river overflows whenever there is typhoon or heavy rain.

Still according to Mrs. Baje, the flood control in Brgy. San Gregorio also serves as a dock for the fishermen, whose source of living is through the river and also to the locals that fetches water in the river during summer and water supply in the barangay is insufficient.

"He kami dinhe karukadak-an parag-uma, mayda naman usa daman nga parapangisda, dire daman ubos. Dako gud it bulig hin nga pagkamay-ada hin nam seawall kay ha akon la, danay ngane kami dire nasabot nga dako na it tubig hit salog ngin makusog it uuran [Most of the locals here are farmers and fishermen. For me, this flood control is really a big help to us because we are not bothered by the flood anymore during heavy rain]," said Baje.

On the other hand, Mrs. Corazon Buenafe, a resident of Sabang Suribao said that they feel uneasy during calamities because big waves rush through their houses during typhoons. Her house is located in front of the open sea, meters away from the newly completed flood control.

"Naglilikas kami han una ngin nagraraot-daot it panahon kay delikado gud kami dinhe kay harani kami hit dagat. Yana nama nga yaadi na in nga sea wall, dire na sugad it am panilikado kay mayda na gud nakakaprotektar haam [Before, we evacuate every time there is bad weather because our house is near the open sea. Now that this see wall is already completed, we already feel secured because we are now protected by it]," said Mrs. Buenafe.

The construction of the two flood control projects along Suribao River started on February 2021 and was completed on September 2021.

NGCP allocates P160 billion in CAPEX until 2025

Power transmission operator National Grid Corporation of the Philippines (NGCP) is allotting P160 billion in capital expenditure filed with the Energy Regulatory Commission (ERC) for the 5th Regulatory Period (2021 to 2025). P111.4 billion of the total CAPEX is for transmission projects, including completed and ongoing projects, those in the pre-construction stage, and those still in the pipeline.

Included in the CAPEX filing for the 5th Regulatory Period are transmission projects within and around Metro Manila such as the Pasay 230kV Substation, Manila (Navotas) 230kV Substation, Marilao Extra High Voltage Substation, New Antipolo 230kV Substation, Taguig Extra High Voltage Substation, Taguig-Taytay 230kV Transmission Line, and Taguig-Silang 500kV Transmission Line.

To meet the forecasted load growth in Metro Manila, three (3) major 500/230kV drawdown substations will be developed around Metro Manila. These will be in Taguig City; Marilao, Bulacan; and Silang, Cavite. These are to be complemented by the development

SSS asks members, employers to keep online login details to themselves

Social Security System (SSS) President and CEO Michael G. Regino today urged members, pensioners, and employers of the state-pension fund to secure their login credentials on the My.SSS portal and other personal information to protect their accounts from fraudulent transactions.

Regino issued the reminder following several complaints from SSS members that their accounts with the My.SSS were being subjected to fraudulent transactions perpetuated by scammers and other unscrupulous persons.

One of the reasons why such fraudulent transactions occur, SSS insiders noted, was the tendency of some members to share their login credentials with unauthorized persons. These login information, Regino noted, should be kept confidential by accountholders to protect themselves from scammers.

Regino likened the SSS login credentials to the Personal Identification Number (PIN) that bank depositors use to access their accounts at the Automated Teller Machines (ATM). An ATM card PIN is a multi-digit number required at bank ATMs for

carrying out transactions these unofficial online and is initially provided by the banks. This PIN can be reset or changed to a new PIN by the card owner but is kept as a strictly confidential information by the user.

"We have asked our stakeholders not to share their usernames, passwords, and other login details on their My.SSS accounts to unauthorized individuals. Giving your username and password to another person is like sharing your ATM PIN," Regino said. "Anyone with this information could use your My.SSS account to avail of monetary benefits without your authorization."

The SSS chief cited a case wherein a member sought the assistance of another person while trying to create and access his My.SSS account on the Internet. It turned out that the person from whom the SSS member sought for help is a fixer and scammer who later drew a salary loan from the account without his knowledge.

Regino also advised members not to entertain unofficial online groups in various platforms, like Facebook, that allegedly offer easier access to SSS online accounts and provided technical assistance for a fee to loan-seekers. "We do not recognize

groups, even those found on Facebook. We consider them illegal, and they cannot facilitate SSS transactions on behalf of our members," Regino said.

He added that online transactions and services offered by the SSS portals are free, except when a member is requesting for a replacement of the Unified Multi-purpose ID Card (UMID), which carries a minimal fee.

Regino said members may visit the E-center in local branches and they will be assisted by SSS employees in their online transactions. "All our branches have an E-center containing several computers connected to the Internet. We have employees stationed there who are ready to help our members in creating and accessing their My.SSS account as well as guide them navigating and using the online portal for their transactions."

Regino said the SSS management also regularly update its online facilities, such as the My.SSS Portal and SSS Mobile App, to better serve its members. In 2021, the Mobile App was redesigned to make it more user-friendly and easier for members to navigate and conduct their online transactions through mobile phone facilities.

He also reminded members, pensioners, and employers that they cannot be held accountable for fraudulent transactions once a member connives with a fixer.

Under Republic Act No. 11032, or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, and Republic Act 11199, or the Social Security Act of 2018, make it illegal for members to engage the services of fixers.

SSS works closely with law enforcement agencies to curb the illegal activities of fixers. "We are determined to file charges against them who are taking advantage of our members and employers," Regino concluded.



TACLOBAN Outgoing Ormoc City Mayor Richard Gomez stressed that the water rate in the city is so low that is among the cheapest in the country, contrary to the claim of his congressional rival.

Gomez, who is seeking a congressional seat for Leyte's fourth district, said that his political opponent is trying to deceive the water concessionaires by claiming that the water rate in Ormoc is expensive.

He said that at present, the water rate in Ormoc stand at P100 per 10,000 liters and not P1,100 per 10,000 liters.

TACLOBAN CITY -The Department of Social and Welfare and Development (DSWD) National Resource Operations Center (NROC) delivered on Thursday thousands of items for landslide victims in Levte.

The DSWD regional office received 5,000 family food packs (FFPs), 1,000 sleeping kits, 2,900 kitchen kits, and 3,500 hygiene kits. These goods are intended for survivors in Baybay City and Abuyog town.

"These are intended to augment the resources of DSWD Eastern Visayas as it responds to the requests of local government units affected by the recent disaster," DSWD regional information officer Joshua Kempis said in a phone interview Thursday.

As of April 20, the DSWD has already distributed 27,925 FFPs in different towns of Leyte province. The total value of released food packs is PHP17.86 million.

Each food pack for one family costing PHP500 contains six kilograms of rice, four cans of corned beef, two cans of tuna flakes, two cans of sardines, five sachets of coffee, and five sachets of energy drink.

Under the Philippine Disaster Risk Reduction and Management Act of 2010, the local governments are the first responders, and the DSWD is tasked to augment the response efforts after disasters.

Meanwhile, the DSWD has already released a total of PHP1.01 million to victims of Tropical Depression Agaton under its assistance to individuals in crisis situations program.
