**TACLOBAN CITY- The Philippine National** Police (PNP) has strongly condemned on the killing of a police operative by the members of the communist New People's Army (NPA) in Samar last Saturday(July 16).

The PNP's officer-in-charge, Lt. Gen. Vicente Danao, Jr. has vowed that justice will be served to the family of Patrolman Mark Monge, 28.

The rookie cop, who belonged to the Regional Mobile Force Battalion (RMFB), was killed in an encounter with at least 10 rebels in between the villages of San Nicolas of San Jose de Buan town, and Brgy.Mabuhay of Gandara town while his group was having their humanitarian mission.

"We deeply express our condolences to the bereaved family of Patrolman Monge. His dedication to fulfill his duty to serve and protect the country will be

remembered. Justice will be served. The perpetrators will be made answer for their criminal actions," the PNP chief said in a statement.

Danao also promised to extend all the assistance to the family of Monge whose remains were brought to their residence in Palo town, Levte.

It was learned that President Ferdinand 'Bongbong' Marcos, Jr. has sent a wreath as a way of sending his condolences to the family of Monge.

About 69,038 family beneficiaries of the conditional cash transfer in Eastern Visayas have been identified as non-poor, an official of the Department of Social Welfare and Development (DSWD) reported.

DSWD 8 (Eastern Visayas) Director Grace Subong said their office initially found the economic status of these families through the National Household

# Overworked, underpaid' Filipino teachers robbed of academic break

'Jess', a neophyte public school teacher, was looking forward to a vacation after spending so much time on the end-of-the-year activities for the school year 2021-2023.

While he was in the middle of planning for their upcoming summer getaway trip, the 23-yearold teacher from Catbalogan City found himself in the middle of bewilderment and disappointment the government's after education department announced that the new school year will open very soon contrary to its tradition of two-month academic break.

"I always thought the busy work would be compensated with enough rest. But never this," Jess, who requested anonymity, told Leyte Samar Daily Express.

"I always accepted the 'busyness' part thinking of having enough rest after the school year," he added.

Like many of the over 900,000 teachers in the country, Jess asked for an explanation.

Despite the clamor of various teacher groups, Vice President and Education Secretary Sara Duterte announced that the classes will open on August 22 and ends on July, 2023.

"This has been approved by [President Ferdinand Marcos Jr] ... so we will proceed with it," Duterte told reporters in Manila last July 14, 2022.

Earlier this week, the Department of Education (DepEd) released the official school calendar of activities, which set the enrollment period on July 25, 2022, and other series of school-related activities that would drag the teachers back to their classrooms.

Benjo Basas, the national chairperson of the **Teachers Dignity Coalition** (TDC), a national organization of teachers formed in 2006, maintained that

the government's decision "will not give teachers enough time to rest."

"While the previous school year officially ended on June 24, many teachers are still reporting to schools for academic duties to date for remedial and enrichment classes and the DepEd's Brigada Eskwela and in-service trainings," he said.

On July 14, Basas said they sent another letter request for a meeting with the Education Secretary "as the group appeals to reconsider the opening of classes."

"The group, earlier asked the Vice President to set the opening of school year 2022-2023 to mid-September in order to comply with the mandated school break and vacation for teachers," he said.

In his letter, the TDC chairperson said that the teachers are still currently in the middle of various paper works, trainings, while other activities "are projected to be accomplished up to August or beyond."

"Being excluded from the sick and vacation leaves granted to other employees, teachers, under the existing Civil Service Commission (CSC) rules are entitled to vacation during school break; teachers, after a taxing school year of multiple teaching and learning modes under the pandemic need sufficient time for proper rest in order to prepare them physically, emotionally and mentally for the coming school year," it said.

"The physical requirements of our schools including the need for classrooms and additional teachers still have to be considered addressed; factors such as public transportation and vaccination status of teachers and children are yet to see Overworked/page 7 ...

# Digitalization of services remains a top priority, says SSS chief

Social Security System (SSS) President and CEO Michael G. Regino announced on Monday that the digitalization of the pension fund's services remains one of its top priorities in the coming years.

PCEO Regino said that as online transactions become the new norm, more notably during this COVID-19 pandemic, the SSS plans to add more services to its online channels such as the My.SSS Portal, SSS Mobile App, Text-SSS, uSSSap Tayo Portal, and Self-service Express Terminals.

"In 2021, out of the 52.62 million transactions we received, excluding inquiries, 43.52 million or 82.7 percent were made using our online channels," Regino said.

Currently, there are more than 30 member services and over 20 employer services that can conveniently be accessed through the My.SSS Portal. These services cover transactions for membership, contributions, loan granting and repayments, benefit disbursements, among others. Some of these services can also be accessed through other SSS online channels.

"Since the My.SSS Portal

is our main online channel, almost all of the new online services are made available here first. However, intensified efforts are also put towards making the services in this portal accessible in the SSS Mobile App for smartphone users, Regino added.

"We are gradually implementing mandatory online transactions for our programs. However, those without the personal means to transact with us online may use the e-Centers in our branches," he concluded.

#### U.S., DepEd launch course on futures thinking for education

Manila-The United States government, through the U.S. Agency for International De-(USAID), velopment partnered with the Department of Education (DepEd) recently to launch a training program on co-creating learning spaces for the future.

The Leaders in Fuof Education tures (LIFE) course will teach teachers and administrators how to collaboratively design and plan for innovative future learning spaces that will maximize children's language and literacy. After the course, participants will develop local prototypes of future learning spaces.

"We are taking this challenge even beyond administration," this said former Education Undersecretary Atty Nepomuceno Malaluan. "Within the overall framework of DepEd's long-term goal for the Basic Education Development Plan 2030, the goal of enhancing the capabilities of our education leaders and movers remains relevant especially within and beyond crisis and uncertain futures."

Fifty school leaders and teachers from the National Capital Region, Calabarzon, and Tuguegarao enrolled in the LIFE course.

Through its All Children Reading Philippines project, USAID aims to improve early grade reading skills for

TACLOBAN CITY Maasin City Mayor Nacional Mercado urged his constituents to help the city government in addressing the rising dengue fever cases in the city by immediately consulting doctors especially if they experience symptoms of the disease and also by practicing the so-called 4s to prevent its spread.

Mercado had called for an emergency meeting last week with several village and health officials of the city after they recorded a dengue-related fatality.

The fatality was from Tunga-tunga Barangay who did not seek a medical help, the city mayor said.

The problem of dengue should be taken seriously to avoid future death due to the disease, according to Mercado.

At present, Maasin City has two active dengue fever cases from the villages of Cabadiangan and Bato II.

"I encourage everyone to ensure cleanliness in their surroundings and practice the 4S," Mercado said

The 4S" stands for "search and destroy" mosquito breeding sites; "secure self-protection measures" like wearing long

pants and long-sleeved shirts, and daily use of mosquito repellent; "seek early consultation"; and "support fogging/spraying."

Last month, Maasin City recorded more than 20 dengue cases and was included in the list of the Department of Health in areas with clustering of dengue cases. (ROEL T. AMAZONA)

# 3K fuel subsidy awaits registered fisherfolks, says BFAR

MAASIN CITY- Fishers who are not yet registered with the Registry System for Basic Sectors in Agriculture (RSBSA) in the municipal or city agriculture offices are encouraged to do so, as government assistance will be prioritized for those who are in the list.

The call was made by Fervina Avorque, provincial director of the Bureau of Fisheries and Aquatic Resources (BFAR), adding that an upcoming fuel subsidy in the amount of P3,000 for fishers will be based on those who were registered.

But what will be given is not outright cash but cards, which will be presented at accredited gasoline sta-

uated from the program and 14,516 families "who have transferred residence without permission."

Also possibly included in the list are the 51,719 families who have been removed from the record as of June 30, 2022 "due to no more eligible children."

"The task we are doing now is also to ensure that there's no duplication in the count," she added.

The DSWD is upbeat about completing the validation of the list of more than 280,000 conditional cash transfer beneficiaries in Eastern Visayas by end of July.

Subong said their people have been mobilized to step up the ongoing validation process in compliance with the directive of President Ferdinand Martions, Avorque clarified at the Kapihan sa PIA program Tuesday, July 12.

The cards must be kept because succeeding benefits in the future will be coursed through it, she added.

When asked when, probably, this can be realized, Avorque said she cannot speculate for its implementation in the province, but in other areas this was began last March 30.

The BFAR office in Brgy. Combado may accept walkin registrants, but this has to be confirmed with the place where the individual lived, as the listing is in close coordination with concerned local government units (LGUs), Avorque explained. (MMP/PIA Southern Leyte)

formation management system that identifies "who and where the poor are," making available a database of poor families as a reference in identifying potential beneficiaries of social protection programs, such as the 4Ps.

The system, according to Subong, is a viable tool to ensure equitable distribution of resources and services to deserving poor Filipino families.

The validation will check if families can afford to buy home appliances and if they have children who finished schooling but continue receiving cash grants.

The 4Ps is the national poverty reduction strategy of the government, as stated under Republic Act 11310

# Baybay City landslide victims receive housing units from OCD

TACLOBAN CITY -The Office of Civil Defense (OCD) and the city government of Baybay has turned over an initial 40 temporary housing units to landslide victims of Barangay Kantagnos.

Kantagnos was the most devastated village in Baybay after a deadly landslide hit the city last April of this year.

The temporary shelters are located in Brgy Maganhan and funded by the OCD worth P10 million.

Present during the turnover were OCD Administrator Usec. Ricardo Jalad and his regional director, Lord Byron Torrecarion, and Baybay City Mayor Jose Carlos Cari.

The beneficiaries also received non-food items like family kits, hygiene kits, malong, blankets, foam beds, portable stoves, and solar lights.

They also received cash assistance worth P10,000 and family food packs from the Department of Social Welfare and Development (DSWD).

The City Social Welfare and Development Office was in charge in selecting the families who would first occupied the temporary shelters in Maganhan.

Among those who were selected were families with senior citizens, person with disabilities, and pregnant women as members.

The 72 units of temporary shelters for those temporary staying at Baybay City Senior High School is

not enough because they have 165 families from Brgy Kantagnos that evacuated in said school

The OCD spearheaded the construction of 72 housing units with the 546th Engineer Construction Battalion, 802nd Brigade personnel, Bureau of Fire Protection (BFP), Philippine National Police Regional Office 8 (PRO8) and some civilian volunteers working to finish the construction of the temporary shelters.

The Department of Public Works and Highways (DPWH) did the site development while the DSWD funded the cash-for-food and work, and the Department of Environment and Natural Resources-Mines and Geosciences Bureau (DENR–MGB) did the site evaluation if the area is safe from hazard.

The landslide survivors are currently staying at the Baybay City Senior High School which will soon be used by the Department of Education for the return of face-to-face classes. (ROEL T. AMAZONA)

# Vaccination not required

espite the resurgence of numerous COVID-19 cases in the country, Vice President and Education Secretary Sara Duterte revealed that vaccination will not be required for the students return-

ing to school for face-to-face classes, ordering all schools nationwide to make the shift by November.

This is contained in her first order as concurrent education secretary, stressing that there are no preconditions set for the return of students to the traditional mode of instruction. Segregation and discrimination against unvaccinated learners should have no place in schools since vaccination is not mandatory and there's accordingly no problem with the mingling of students inside the classroom.

The new secretary justified this stand by saying that outside, like in their respective homes, churches, malls, and public transport vehicles, these students are mingling whether vaccinated or not. She emphasized, however, that physical distancing and other health protocols such as the wearing of masks and washing of hands will remain strictly imposed. Moreover, those who are diagnosed with the virus or unwell students will be exempted from attending classes.

What's important is that the country should now resume in-person classes in schools. Studies show that distance learning is insufficient since students learn less under this scheme. Inside the classroom, students can be made to work on learning activities with direct supervision and monitoring by teachers. In home-based online learning, students may lie down in bed, play gadget games, and ignore the teacher-given tasks. As a result, backlogs accumulate and students eventually get addicted to online games and the like.

Secretary Duterte believes it is high time to resume in-person classes because COVID-19 vaccines are now widely available and Filipinos are already familiar with basic health protocols. Besides, the Philippines is among the very few countries in the world whose schools have not yet fully opened for in-person classes. We can't afford to be behind in this area.

#### Pedagogy of the depressed: Reviewing modular learning and highlighting the need for face-to-face classes

Modular distance learning set forth the continuation of learning amidst the pandemic. However, this modality relies on the knowledge of the adult figures (More Knowledgeable Others or MKOs) in the house to enable learning. Thus, one major factor that would make the learning process a success is the presence of an adult who is knowledgeable and patient enough to teach the students-a challenge for those in lower-income families.

In a home where both parents need to work to make ends meet and other adults are also struggling with distance learning, a young student's learning would be sacrificed. This is one of the realities that most families are facing. In the end, parents would resort to answering the modules themselves rather than teach the student to save time.

Moreover, although some parents are eager to teach their children, their lack of knowledge hinders them from doing so. In fact, this concurs with the result of a study conducted in one of the

#### **Barugo II Central School:** School-based feeding program wrapped for S.Y 2021-2022

Per the DepEd order no. 036, s. 2019 or the Guidelines on the Implementation of School-Based Feeding Program-Milk Feeding Component, the Barugo II Central School wrapped their annual feeding program and marked its third year since implementation. The number of positive feedbacks from the learners and the parents posed an achievement for the Barugo II Central teaching faculty and staff. There is also a significant improvement from the beneficiaries' weight based from records monitored by the school nurse.

Such extended school programs have truly proved itself to be helpful towards the community. The stakeholders also revered the fact that such reach out programs were implemented in the

public schools in the country which assessed the challenges with modular distance learning. The study revealed that one of the main challenges is the parent's lack of knowledge to academically guide their children (Pe Dangle & Sumaoang, 2020). Undeniably, modular dis-

tance learning will still be a part of the modality utilized by DepEd during the pandemic, but it is most effective if it is paired with a face-toface session with the teacher. This would allow teachers to give feedback, which is not effectively done in modular distance learning so that students will be able to know their current progress and pinpoint the areas they need to improve.

Children are already allowed to go out and enter establishments such as malls, parks, and other recreational places. While parents bring them to those places, it is also fair to bring them to schools that will not just give them enjoyment but will also allow them to learn.

As COVID-19 spread and was declared a pandemic, causing the world to briefly stop, every country and its people were severely impacted. teachers and parents are really challenged to attain quality learning as much as possible, especially in making young learners read effectively. Reading must be encouraged from a young age since that is when the brain is developing and must be stored with educational information. However, in order for this to be efficient and systematic, learners must be evaluated in order to meet their needs, be effectively guided, and get attention and focus from the appropriate institution and group of people, which includes their teachers, schools, parents, and others around them.

No child should be left behind; everyone should be given and allowed to experience the education that can empower them for their future and for everyone. In these trying times, our younger generations may be our only hope, therefore we must pay attention to them so that they may dream big and have hope for the future, which can begin with reading and learning.

1.83 million employed persons out of the 1.95 million persons in the labor force.

This was higher by about 90,000 employed persons than the 1.74 million employed persons reported in January 2022; but, lower by around 54,000 compared with the 1.88 million employed persons in April 2021.

Eastern Visayas' unemployment rate has improved at 6.0 percent, lower by 1.0 percentage point compared with the 7.0 percent unemployment rate recorded in January 2022.

This was equivalent to around 116,000 persons in the labor force who were unemployed in April 2022, lower by 15,000 unemployed persons compared with the 131,000 unemployed persons in January 2022.

However, the latest un employment rate was 1.0 percentage point higher than the unemployment rate in April 2021 at 5.0 percent.

The underemployment rate in Eastern Visayas was posted at 14.8 percent or 271,000 persons out of the 1.83 million employed persons in April 2022.

The latest underemployment rate has improved compared with the underemployment rates of 19.8 percent and 15.5 percent in January 2022 and April 2021, respectively. (PR)

# Eastern Visayas posts 94.0% employment rate in April 2022 Eastern Visayas registered a Labor Force Participation Rate (LFPR) of 60.0 percent in April 2022

This placed the region's labor force at 1.95 million persons who were either employed or unemployed out of the estimated 3.24 million population15 years old and over in April 2022.

The 60.0 percent LFPR was higher by 2.0 percentage points than the LFPR in January 2022 posted at 58.0 percent.

This means that the labor force in April 2022 was

stronger by around 75,000 persons than the 1.87 million persons in the labor force in January 2022.

However, the number was lower by around 37,000 persons compared with the 1.98 million persons in the labor force in the same period in 2021.
